In August, 1959, an official of the State Fair of Texas, furnished the following information to a representative of this Bureau concerning A. A. Allen, a Dallas, Texas, evangelist who reportedly was planning to move his religious headquarters from Dallas to Arizona:

In 1958, A. A. Allen rented a building from the State Fair of Texas and held a religious revival. During the course of this revival, Allen claimed that he could heal people by merely touching them and as a result of this claim, many old and underprivileged people with deformities that were medically incurable, came to Allen for help.

Allen would place various individuals in the audience who allegedly had physical deformities. These individuals would "hobble" to the altar where Allen would pray for them and place his hand on their shoulder, at which time they would declare that they were healed. The audience however, was unaware that the individuals who claimed to be healed were "plants" placed in the audience by Allen. According to two people died during the course of these "healing" sermons. termed Allen a "fraud."

On 7/13/65 Sgt. [redacted] Metropolitan Police, advised that ALLEN, born 3/27/11, Sulphur Rock, Arkansas, possessing U.S. Passport No. 2504321, claiming to represent A. A. ALLEN REVIVALS, Inc., of Miracle Valley, Arizona, has been holding evangelistic-type meetings in England for approximately two or three months. Several members of Parliament have received letters of complaint from constituents stating that ALLEN is a "fraud". These letters have been forwarded to the British Home Office, which has requested the Metropolitan Police to obtain background information concerning ALLEN. Reportedly ALLEN left England for Paris, France 6/28/65 with the idea of returning to England to open a "Miracle Center".

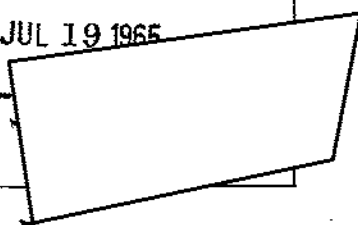

Files of the Passport Office, U. S. Department of State, reviewed by a Special Agent of the Federal Bureau of Investigation on August 10, 1965, disclose that Asa Alonzo Allen was last issued passport No. 2504321 on December 12, 1960, at Los Angeles, California, for proposed six weeks' to two months' trip to Haiti and Venezuela from Miami via Delta and Pan American Airlines for "evangelistic meetings." In his application made December 9, 1960, at Los Angeles he listed his permanent residence as Miracle Valley, Arizona, and a mailing address of Atlantic Villa Motel, 12424 SE Atlantic, Compton, California. He listed his parents, A. O. Allen and Leona Clark Allen, as born in Arkansas in 1871 and 1876 and deceased. [REDACTED]

[REDACTED] He stated that he had been in the Philippines and India from February 2, 1958, to April 8, 1958. He stated that his previous passport was in his car stolen in Hollywood, California, in April, 1958, when he returned from India. His birth, March 27, 1911, at Sulphur Rock, Arkansas, was confirmed by a delayed birth certificate (March 25, 1953) seen by the passport official.

Passport 2504321 was renewed on about November 6, 1963. In his renewal application signed October 30, 1963, he listed permanent address of Allen Revivals, Inc., Miracle Valley, Arizona, and stated proposed travel by TWA from New Orleans, January 1, 1964, to South and West Africa, Nigeria, India, South America, Venezuela, Philippine Islands, Puerto Rico, and Dominican Republic for three months for purpose of evangelistic missionary. He listed absences from the United States in the preceding five years as Philippine Islands, January 1, 1962, to January 25, 1962; London, England, from January 9, 1963, to January 12, 1963; and Ghana from January 17, 1963, to February 8, 1963. 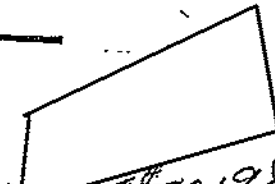

On August 25, 1965, Sheriff THOMAS JAMES WILSON, Cochise County Sheriff's Office, Bisbee, Arizona, which covers nearby Miracle Valley, Arizona, made available to a Special Agent of the FBI the following resume of information in the files of that office pertaining to ASA ALONZO ALLEN:

ASA ALONZO ALLEN and his associates, doing business as A. A. Allen Revivals, Inc., came to Miracle Valley, Arizona, in 1958, having obtained a large tract of land from one [redacted] a religious follower of ALLEN. Miracle Valley is a ranching community located approximately 15 miles from Bisbee, Arizona. ALLEN proceeded to construct a fairly large community, consisting of dormitories for women and men, administration buildings, a church, and various houses. At the present time there are several hundred persons residing in this religious community.

ALLEN maintains a staff of about ten persons as Administrative Assistants. He has a very active press and publicity staff and has Nationwide radio and television coverage.

The Miracle Valley Revival Training Center, operated by ALLEN at Miracle Valley offers a one year course upon completion of which the student is ordained as a Minister.

Sheriff WILSON said ALLEN, due to his extensive travel, is seldom in residence at the establishment at Miracle Valley.

As to ALLEN's personal character, Sheriff WILSON said his files show that in 1962 ALLEN's wife filed a petition to have him committed to a mental institution in Arizona; however, this petition was later withdrawn.

ALLEN's income, most of which is received through the mail in the form of donations from his religious followers throughout the Country is very high, Sheriff WILSON said. He pointed out that on one occasion, ALLEN was involved in litigation in which the United States Government sought to recover approximately \$350,000.00 said to be owed by ALLEN in unpaid income taxes. Sheriff WILSON said the headquarters of A. A. Allen Revivals, Inc., formerly at Dallas, Texas, now is at Miracle Valley, Arizona.

Files of the Bisbee, Arizona Credit Bureau, which covers Miracle Valley, Arizona, were reviewed by a Special Agent of the FBI August 25, 1965. These files contained no data to supplement that set out above concerning ALLEN. ALLEN's credit rating was listed as satisfactory.

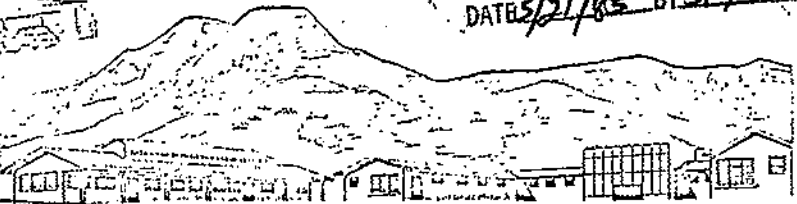

Four years before "MIRACLE VALLEY," as we now know it, became a reality, God spoke to Brother Urbane Leidencker and gave him this beautiful prophecy:

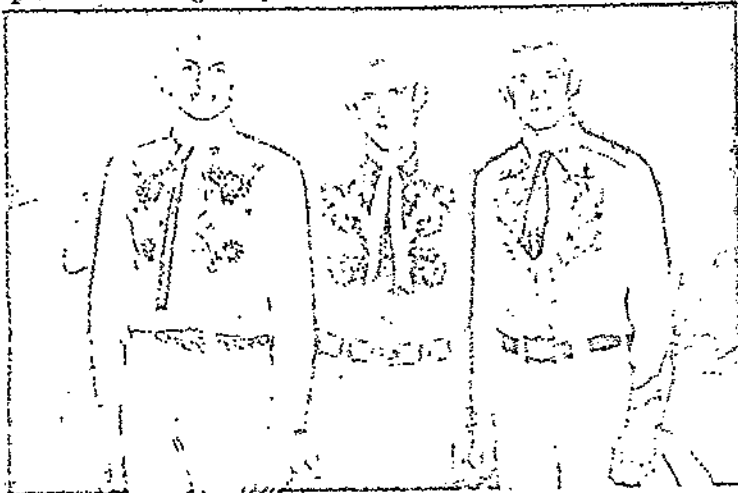

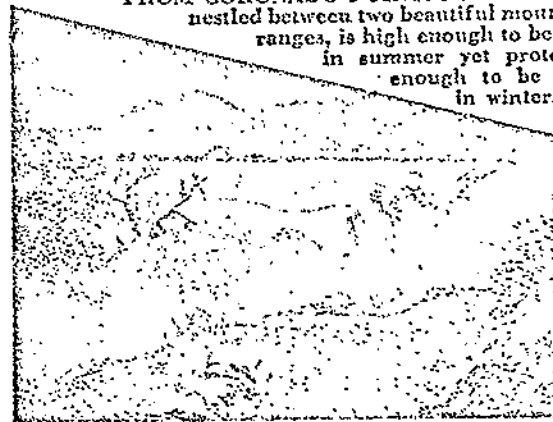

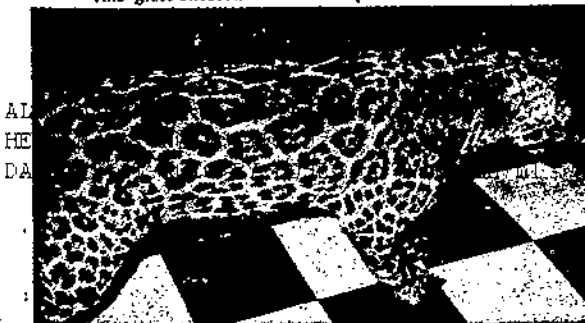

Tells About Church

"Could you tell me something about your Church?" you ask. Then, realizing how silly that sounds coming from a professional writer, you qualify it: "I mean, what exactly goes on here? Sacrificial rapes, or eating babies' entrails, or black masses, or what?"

He smiles easily, sits his huge frame down on a chair, and answers:

- "8—Satan represents all of the so-called sins, as they all lead to physical, mental or emotional gratification!
- "9—Satan is the best friend

church ever had, as he has kept it in business all these years!"

By the time you read it over again and put it down, you realize that, given La Vey's definition, it would be pretty hard for you to point to a man who WASN'T a Satanist!

The High Priest comes back and offers you a cup of coffee.

"Don't be afraid," he says pleasantly. "There's not a trace of hemlock in it."

You chuckle with him, but suddenly you remember that you have a very good reason to be afraid.

"Your... ah... pet," you begin hesitantly. "He won't be... uh... bothering us, will he?"

"You mean my lion? Togare?" He smiles at the thought. "He'd never hurt anyone. But the neighbors raised a bit of a fuss, and now he's in the San Francisco zoo. We visit him quite frequently."

That solves the last of your problems: the lion is gone, the leopard is dead, La Vey hasn't damned you to eternal perdition, and neither the lovely nude girl nor the lovelier clothed one have tried sucking your blood.

It's nitty-gritty time again, and you pull out your pencil and note pad, flick on the tape recorder, and try to earn a living.

My Dear Friend and Partner:

On Thursday, February 7th, at the beginning of the second week of our Midwinter Camp Meeting at Miracle Valley, I received a letter from "Erik", a self-proclaimed Minister of the First Organized Church of Satan! The letter was written on ordinary paper, with black ink, and mailed in a very unusual envelope that had a lining of dark rich blue paper.

In this threatening letter the writer wrote that he was declaring war on me and on my foolish followers - no doubt referring to you!

At first I thought that this strange threatening letter was just a prank, or a harmless letter from some crackpot. But as I read this letter I recognized the language of Satan, the mind of Satan, and the tactics of Satan... and this should not be surprising since the writer claimed to be a Minister of the Black Sabbath of the First Organized Church of Satan!

I decided then that I should read this letter to the large audience that was nightly filling our Miracle Valley Tabernacle. And also that I should share at least portions of this letter with you. Space here will not permit me to quote all of the letter, but these portions of it can give you a general idea of the lies, threats, and bribes that in the Bible are associated with the works of Satan.


This Minister of Satan's Church wrote, "Dear Mr. Allen, before continuing I implore you to cast off any notion that I am a quack or a practical joker. I am a Minister of the Black Sabbath of the First Organized Church of Satan. I have heard a few of your broadcasts on XELO.. and we have found you to be a threat to us and our movement."

He continued, "I am writing to declare "War" so to speak on you and your foolish followers. You are not a healer of the sick nor is the man you call Jesus. You are though a healer of Hypochondriacs - fools who wallow in self-pity and are supposedly cured by magic. You shall know our magic soon Mr. Allen" (then follows some startling threats and evil predictions).

"We have been made aware by our Prince of Darkness that you shall soon go bankrupt. We have some of our people in the Internal Revenue Service so we can say to you enjoy your petty tax exemptions while you can"... (more threats and dire predictions).

The Minister of Satan's Church continued, "I can't truthfully say that I expect you to write and inform us of your intentions to fight, for men like you are cowards who hide behind a cross" (more personal abuse).
