



Reference is made to your teletype of January 25, 1935, requesting information concerning the disposition of the arrest on September 4. 1931 of Edna Murray as Doris Farrell, by the Chicago ... Police Department, their No. C-31722.

This is to advise that Special Agent B. M. Hirsh of this office ascertained at the Bureau of Investigation, Chicago Police Department that Doris Farrell was arrested by officers of the Chicago Police Department in Chicago on September 4, 1931 as an escaped fugitive. She was turned over to Deputy Warden O. M. Livingston of the Missouri State Prison of Jefferson City, Missouri on September 10, 1931. For your further information, the records of the Chicago Police Department indicate that Edna Murray again escaped from the Missouri State Prison on December 13, 1932.

This information is to confirm teletype message of January 25, 1935.

ALVIN KARPIS with aliases - I. O. 1218 et al EDWARD GEORGE ERESER - Victim KIDNAPING

In connection with the above case during the investigation that has been conducted in Miami. Fla., there was recovered a 50 cal. Browning automatic rifle. While the serial number of this gun has been obliterated it appears that this gun is a 1918 model, manufactured by the Winchester Co.

The complete details as to the recovery of this weapon will be reported in a report that will be forth-coming very shortly. However, Joseph H. Adams, the manager of the El Comodoro Hotel at Miami has identified this gun as one that was left with him by subject William Harrison last September and which gun he kept until about December when he turned it over to Duke Randall. Randall has also identified this gun as the one that he got from Adams.

The U.S.Attorney in Mismi intends to prosecute both Adams and Randall for having had possession of this gum in violation of the Mational Firearms Act. For this reason he desires to be advised at the first opportunity the complete description of this gum, that is, the type of weapon, the manufacturer of it, the proper name for it and the serial number of it. Inasmuch as the grand jury will sit at Jacksonville, Fla., beginning Feb. 6, 1935, it is requested that the Division upon receipt of this gum which is being expressed to it today, telegraph the Jacksonville office this information in order that it can advise the U.S. Attorney in Mismi as to this data so he can include it in his indictment.

The U.S.Attorney here has also advised that it will be necessary to ascertain from the Collector of the Internal Revenue whether this weapon was ever registered under the provisions of the Mational Firearms Act. For this reason it is requested that the Division furnish the Washington Field Office with the description of this gun including its serial number in order that it can conduct the appropriate investigation at the office of the Collector of Internal Revenue to determine if the gun was ever registered. That office should also ascertain and advise the Jacksonville office who is the proper person from **Example The Office of the Collector of Internal Revenue to subpoena to testify as to the registration of this gun. It is further requested that the Washington field office commence the usual tracing of this gun from the factory.

Attention is again invited to the fact that the U.S.Attorney desires the information as to the description of the gun at the very first opportunity in order that he can draw up his indictments by Feb. 6, 1955. It will not be necessary to have the gun itself at Jacksonville for the grand jury, but when it has served its purpose in the laboratory it should be returned to the Jacksonville effice pending the disposition of the cases that it is expected will be tried in Miami in the latter part of March or in April 1935.



Upon receipt of telephone call from Special Agent in Charge D.M.,
LAID, of the CHICAGO Division Office, requesting that EDWARD R.BISHOP, famerly
of Bensenville, Illinois, and whose home is now at Tomehawk, Wisconsin, be
interviewed relative to the renting of a private garage by him to some parson
unknown, at Bensenville, Illinois, during the time that EDWARD G.BRESHER was
being held pending payment of ransom, the undersigned proceeded to Tomehawk,
Wisconsin, and located MRS. NOWARD R.BISHOP at 523-5th Street, She stated
that her husband is now at 1659 Gamp Alvin, Iron River, Michigan, which is a
C.C.C.Camp, and that it is located about forty miles from the nearest railroad
and, due to snow storms in that district, he had been unable to return to
Tomehawk for an intended visit, nor sould he be reached at this time. MRS.
BISHOP and her young son, EDWARD, JR., were interviewed regarding the rental
of his garage at Bensenville, and the substance of this interview was set forth
in a statement signed by MRS. BISHOP, which is quoted herein below:

Tomahawk, Wise January 17-1935

My name is Mrs. Edward R. Bishop, residing at 523 Fifth St. Tomahawk.
Wis. I am making this statement voluntarily to John E. Brennan, a Special Agent
of the Division of Investigation, U.S. Department of Justice, for use in connection with an investigation being conducted by that Division.

I resided at Bensonville, Illinois, with my husband, and children, three boys and a girl, my husband & I having lived there for twelve years prior to about May 30 - 1934, when we moved to the above address in Tomahawk, Wis.

We lived at 191 York St. Bensonville for about 5 years preceding our departure for Tomahawk during this time my husband operated a barber shop on Green St., near York.

The house at 191 York Stowas a two story frame building, a house shanged over into a flat a in the rear of which was a frame two-car garage. The entire garage was vacant until about the first of December when Harold Alderton, who lived on Green Stepnear York, two doors from the garage toward the north, rented space in our garage for a car which I hadn't seen him driving before. I had known Alderton for about three years before this time. He lived in a two-story frame building owned by Herman Bauche, a contractor. It is my impression that the car was a LaSalle. He paid a month's rent and kept the car there for that month - and after Christmas 1954, he paid another months rent but only kept the car there a few days or a week. After that I saw the car parked in the front yard of his house & he did not use the garage. During January & February - 1934 - one Barnes - son-in-law of Herman Bauche, had a Nach roadster, old model, which I saw parked in the same yard. During January & February, 1934, Mrs. Alderton, Harold's mother, with whom he lived, was away to Indiana, My son, Edward Jr., delivered magazines to Alderton's during this

time and was not admitted to the house but left the magazines on the porch. Alderton's had two dogs, one large and one small, that were kept in the kitchen, one belonged to Alderton & the other to Mr. Bauche. Mr. Bauchets daughter; whose married name I do not recall, was living on the second floor of Alderton's and during January & February she was taking care of her sister's shildren that is, Mrs. Barnes. I believe at that time they just had the one strike Carroll, about 4 years old, This woman's name I not recall was Free Reed Mochelle, Alderton's moved away about May 1,1964. He mad to hang sys ag Farmers Tavern, Bensonville, It is my understanding from people I know in ton that Alderton was bootlegging in this flat. I have been shown a number of photographs, none of which I recognize as of any person I have ever seen been

Alderton's place is a barn like building situated on an alley, about 2 blocks south of the C.M.& St.P.Ry., near York St., the main St.cars would stop

on Green St. crossing York, which is a block away.

I recall hearing a siren blown every day at moon and at the same time. a steam whistle was blown at the roundhouse, 4 blocks away. I used to hear a ... shurch bell ringing at 6 P.M., on Saturdays, this was at the Evangelical Lutheran Church, and heard it again on Sunday at 9 & 9:30 A.M., at which time, the Methodist Church bell range. I was in Alderton's place after they had moved as ; Mrs. Mochelle called me over to see the condition of the place after they had moved - and know they had stove heat and electric light, the soal being kept in a shed outside the house.

Barnes, who owned the old Nash roadster was there a great deal of the time, and Mrs. Bauche, above referred to, dept on the first floor but the entrance to his room was in the north side while Alderton's entrance was on the southeast side.

My children, three boys and a girl, all of school age, wento the Green St. Public School and used to cut thru Alderton's yard and the one adjoine ing - going to and from school. My son, Edward Trearecalls that Mickey Graeger. about 4, and his friends used to play in the yard of Alderton a.

I have read the foregoing and it is true and correct.

On Jahuary 19,1935, Special Agent J.E.Brennan accompanied KDWARD G.BREMER to Bensenville, Illinois, where he examined a house formerly secupied by HAROLD ALDERTON. After a thorough examination, he stated that he recognized this place as the house in which he had been held pending payers after a ransom, by the following:

The design of the wallpaper in the room in which he was held;
A crack in the wallpaper in a corner of the room;
The position of the window and height of the window sill;
The electric light drop;
The step-up between the living room and bedroom;
That there was a bedroom immediately adjoining the toilet room;
That the toilet handle was broken;
That there was a coal stove in the living room, the grates of which were defective;

That the entrance to the house was through the kitchen;
That there was a door between the kitchen and living room;
That there was a bedroom adjoining the room in which he was held, which bedroom was in the direction towards the kitchen;
That there was a wooden floor in the house;

That there was a wooden floor in the house;
That the sound of cooking was the same as he had previously heard;

That the route travelled from the room in which he was held to the toilet room was the same;

This is in addition to the fact that he heard a whistle and a sirent blowing each day at the same time; that the sound of trains was the same; and that a church bell was rung at 6:00 P.M., on Saturdays and at no other time during the week except Sunday, when another shurch bell also rang; that there were two dogs about the place and that he heard children going to and from school, this house being but one block from school.

Referring to the letter from the Chicago office dated 12-26-34, inquiry was made of the Secretaries of States sovered by this office some cerning Ford V-8 Goach, engine No. 1,130,845; Ford V-8 Victoria Coupe, engine No. 1,142,465; and 1935 model Pontiac Goach, motor No. 955,185, serial No. 815,237, and this office was advised by the Secretaries of States of North Dakota, South Dakota, Wisconsin, and Minnesota, that they had no record of any of these cars and that they will advise this office should an application be made for a license on any of them during the surrent year,

On January 7, 1935, VICTOR SOKOLA, 306 Charles Street, St. Paul, Minnesota, reported to Special Agent 0, G. Hall that he had been speaking to FRANK KELLER, operator of a Shell Oil Company gasoline station directly across University Avenue, St. Paul, from the Republic Finance Company and that KELLER told him that he (KKLLER) was very suspicious of the manager of this finance company in that in the last ten days or so he had seen a considerable number of foreign automobiles driven to that place, these for the most part coming from Illinois and Indiana. KKLLER and SOKOLA wondered whether they were changing license tags at this place and thought probably the automobiles might be stolen.

Acting Special Agent in Charge R. C. Coulter advised that Special Agent in Charge D. M. Ladd has a confidential contact at the Republic Finance Company, which is owned by LEON GLECKMAN, and that MR. LADD, on his return to the St. Paul district, will contact this informant. Agent Hall, while in Chicago on this case, related the above to Mr. Ladd, who advised that he will make the necessary contact with the Republic Finance Company. The Republic Finance Company has in the past dealt in automobiles used by the underworld.

On the 8th of January, SOKOLA again appeared at the office and stated that he observed two automobiles at the Republic Finance Company garage, one a Mash Sedan bearing 1934 Michigan license 44416, one small coupe bearing 1934 Illinois license 1-253767, make unknown. SOKOLA advised that he will continue his contact and report further information as he receives it.

The following memorandum is submitted by Special Agent S.

Fortenberry:
Confidential informant, whose hame is being foregraded to the Director with copies of this memorandum called this agent on January & 1935, and asked this agent to come to his home. This agent did and learned that the individual calling him had been confined to his bed for approximately seven weeks and that he gave him this information: that during the time that he has been confined to bed, MR. C. D. JOHNSTON, better known is JOHNNIE JOHNSTON around St. Paul, had talked to him relative to HARRY SAWYER. MR. JOHNSTON informed this individual that HARRY SAWYER had been contacting DAVE WEINSTEIN, who operates the Old Vienna Cafe on Minnesota Street, between 4th and 5th Streets. MR. JOHNSTON had approached this individual and attempted to secure from him a signed affidavit to the effect that he did not believe HARRY SAWYER had any part in the kidnaping of EDWARD G. BREMER. This confidential informant told this agent that under no circumstances would he want his name to be connected with the giving of this information inasmuch as he had not talked to anyone else about the proposition made to him and he feared it may eause him considerable trouble,

He further informed this agent that MR. JOHNSTON had called on him on several occasions and each time talked about the contact that HARRY SAWYER was having with DAVE WEINSTEIN and himself, leaving the impression with the confidential informant that JOHNSTON was merely getting his information from WEINSTEIN and that he was attempting to have this individual make affidavit on information from WEINSTEIN rather than HARRY SAWYER directly.

This agent assured the confidential informant that his name would not be used in connection with this matter and he in turn assured agent that should any other information come to his attention, he would immediately get in touch with this agent and give him such information as he has.

At the Tri-State Telephone Company, agent secured from the

officials of the Telephone Company the outgoing telephone calls from DAVE WEINSTRIN'S telephone, which is Cedar 0298. This telephone was installed.
December 6, 1934, and since that time there has been one long distance. telephone call from Chicago, Long 1510, the person speaking giving his name as WILLIE. There was also a telegram sent from this telephone number to Chicago, which was signed PAUL.

The remainder of the telephone calls going out from this telephone out of the city, were to Minneapoois; and the list of the telephone numbers is given below, with the length of time talked, price, and hour of conversation:

This memorandum report is based upon the undeveloped lead as set

This memorandum report is based upon the undeveloped lead as set out in the report of Special Agent R. C. Coulter, St. Paul, Minnesota, dated 11-15-54 and is a report on file number 62-888, VERNON C. MILLER, with aliases (deceased), et al. In view of the fact that this lead is more directly connected with the BREMER kidnaping ease, St. Paul file No. 7-50, copies of this memorandum are to be included in that file.

On December S2nd, at Ladysmith, Wisconsin, agent interviewed MR. O. A. GOFFIN, operator of the Phillips Service Station in this city:
MR. SOFFIN was questioned concerning the cabin of FRED GOETZ alias GEORGE
VON ASCHE which was reported being located five and a half miles north of Couderay, Wisconsin. MR. GOFFIN was shown a picture of FRED GOETZ and stated that the picture shown him was the person that he knew at Couderay, Wisconsin, who went by the name of GEORGE VON ASCHE. MR. GOFFIN stated that during 1927 and 1928, VON ASCHE was located near Couderay, Wisconsin, and that he saw him often.

At Raddison, Wisconsin, agent interviewed MR. W. L. GOFFIN who operates a restaurant in that town and who examined the picture of FRED GOFTZ and stated that the picture shown him was the person that he had known as GEORGE VON ASCHE. MR. GOFFIN advised that VON ASCHE during 1927 and 1928 built a summer cabin north of Couderay, Wisconsin, and he understood that VON ASCHE was building this cabin for AL CAPONE. MR. GOFFIN stated that during 1927 and 1928, VON ASCHE was in and around Raddison and Couderay buying materials which were used in the construction of the summer home which he was building.

At Couderay, Wisconsin, agent interviewed CHARLES ALLISON, who is

At Couderay, Wisconsin, agent interviewed CHARLES Allison, who is
the operator of Perry's Tavern in that town. MR. Allison stated that he
was employed by GEORGE VON ASCHE in 1927 and that he then proceeded to the
cabin which VON ASCHE was building and acted as caretaker for VON ASCHE.
MR. Allison advised agent that he commenced working for VON ASCHE during
August of 1928 and that during the month of July, 1932, the summer home which
was owned by GEORGE VON ASCHE was taken over by EDDIE O'HARE. MR. Allison
stated that he was at the cabin of VON ASCHE from August, 1928, to July,
1932, and that during that time, VON ASCHE visited this summer home on a
few occasions and that these visits were of very short duration. MR.

ALLISON stated that YON ASCHE and his wife usually same to this place with some of their friends and did not give him any advance notice that they were coming to the east. MR. ALLISON stated that he was not in a position to see the people who same with YON ASCHE because of the fact that YON ASCHE and his friends did not associate with him during the time they were at the summer home. MR. ALLISON remarked that YON ASCHE was very pesurater in that he had apent about \$80,000 for this summer home and never spent more than twenty days a year at this place. Agent was advised that YON ASCHE seldom stayed over three days at a time when he visited his summer home.

Agent interviewed MRS. CHARLES ALLISON, whose given name is
LOLA. MRS. ALLISON gave the same information as her imstand and stated
that when YON ASCHE and his friends visited the summer home, they usually
temme late at night and unannounced and that she was not in a position to
see the people who accompanied MR, and MRS. YON ASCHE when they came to
the summer home.

MR. and MRS. ALLISON both stated that they had thought that GEORGE VON ASCHE was this man's true name. A picture of FRED GOETZ was shown MR. and MRS. ALLISON and both of these people stated that the picture shown them was the person for whom they had worked and who was known to them as GEORGE VON ASCHE.

MR. ALLISON stated that the cabin of WOH ASCHE was taken over by MIDIE O'HARE during July, 1958, and further advised that he had worked for MR. O'HARE until July, 1934, at which time he was discharged.

Agent was advised that MR. and MRS. VON ASCHE had adopted an Italian boy several years ago and stated that this child should be about ten years old at the present time. These people could give no additional information concerning this child.

Agent interviewed MR. J. H. MOYER, Postmaster at Couderay, Wisconsin, who examined the picture of FRED GOETZ and stated that FRED GOETZ was the person that was known to him as GEORGE VON ASCHE. MR. MOYER examined the records in his office and stated that he was unable to find any forwarding address for GEORGE VON ASCHE.

Agent learned that the cabin belonging to FRED GOETZ is located 7-1/2 miles north of Couderay, Wisconsin, which place is two miles west of the Indian Reservation headquarters.

Agent proceeded to the summer home formerly owned by FRED GOETZ and interviewed MR. FRANK CRANDALL who is caretaker for this place which is presently owned by E. J. O'HARE. MR. FRANK CRANDALL stated that he was employed by MR. O'HARE during July, 1934, as caretaker and had been acting in that capacity since that time. MR. CRANDALL advised agent that prior to his becoming the permanent caretaker for MR. O'HARE he had worked on several occasions for MR. ALLISON who was the caretaker for FRED GOETZ during the time he owned this summer home. MR. CRANDALL stated that he had worked at this summer home on numerous occasions during 1928 and 1929, and 1930, and had noticed that MR. WON ASCHE was seldom at this summer home. MR. CRANDALL advised that at two time while he was working at this location was he able to see any of the people who were visiting with MR. and MRS. VON ASCHE.

MR. CRANDALL advised that MR. E. J. O'HARE is a member of the Mational Jockey Glub at Sportsmen's Park at Chicago, Illinois, and is also a member of the Mismi Kennel Glub, Mismi, Florida. MR. CRANDALL stated that he did not have a forwarding address of MR. O'HARE but stated that his present address could be learned through the National Jockey Club at Cicero, Illinois.

From personal observation, agent found that the sabin which was formerly owned by FRED GOETZ is an expensive summer home which is located on Elusberry Lake. This summer home is isolated and it is not near any farm homes and is located 7-1/2 miles from the nearest railroad or town.

WELL: HVS

Reference is made to report by Special Agent R. C. Goulter, St. Paul, Minnesota, dated 8-25-54. Special Agent C. O. Lawrence conducted the Tollowing investigation at Mankato, Minnesota;

MR. FRANK GUATHER, Superintendent of the Mankato Citizens
Telephone Company, stated that during the latter part of 1955, BELLE BORN'S
sister, whose name is unknown to him, had applied to the company for a
private telephone line to their home located on Route fl of that sity;
that this particular woman had made them the effer to pay all the expenses
of putting up the line, also to pay so much a foot each month for the use
of the same; further, that the company had refused to grant them a private
line and thereafter, a telephone was placed in the home of BELLE BORN in
the name of her annt, MRS. O. R. HEURIFELDT, under telephone number 54408;
further, that she was placed on an eight-party line.

MR. CUATHER stated further that he had known BELLE BORN and her sisters for a number of years and that their maiden name was ANDERSOM, but could not furnish the given names of the sisters; stating further that all, of the sisters, including HELLEXBORN, had moved away from Menkato several years ago and that BELLE BORN is the only one who frequents their home at the present, and when she does wisit Mankato, it is for a very short time and is always alone and drives around in large automobiles. Continuing, MR. GUATHER stated he had seen her in company with a bootlegger, ED TRUSKE, of Mankato, approximately a yearago, but that he has not seen her since. MR. QUATHER stated that in the event TRUSKE was contacted, he would immediately contact some member of BELLE BORN'S family. Continuing, that he had talked to TRUSKE several cays after he had seen him with BELLE BORN and at that time TRUSKE had told him that she was running liquor from Canada to Chicago but would not give him any further information concerning her activities. MR. GUATHER stated he did not know who any of her connections might be and furnished the name of JAKE HILGERS of Mankato who sould possibly furnish information concerning BELLE BORM.

The records of the telephone company concerning long distance calls emitting from \$4408 reflects the following:

December 29, 1935, call made to nurse in charge of CHARLES WHITE,
a patient at St. Joseph's Hospital, St. Paul, Minnesota.
February 7, 1954, call made to KHUMMIEL, Lake Crystal; Minnesota.
June 5, 1954, call made to DR. FEIST, Elkhurst 1902, St. Paul, Minn.
October 24, 1954, call made to HENRY WESTHAL, St. Peter, Minnesota.
November 15, 1934, call made to HOWARD MEYER, St. Peter, Minnesota.

Bank concerning HENRY WESTFHAL and HOWARD MEYER and it was ascertained that WESTFHAL is a young farmer living on a rented farm located nine miles east of St. Peter on Highway No. 99 near Shooktown. Further, that he is in financial straits, etherwise he has a very good reputation. HOWARD METER lives on the adjoining farm to WESTFHAL and operates the Atlas Elevator located at Shooktown. This information was reserved from a MR. LINDRERG, an officer of the bank who stated that the mother of WESTFHAL is employed by his, LINDRERG'S perents.

MR. J. C. WATTS, LeHillier Avenue, stated that he began earrying mail over Boute No. 1, which routs includes EKLLE BORN'S home, in 1907; that she end her two sisters had lived there during that time up until approxe. imately 1926, at which time BELLE BORN began going to St. Paul, Minnesota, regularly and eventually married a soldier at Fort Smelling and later they were separated. Shortly after their separation, she built a home for her mother, now deseased, and in all made the appearance that she was rather prosperous; further, that he had heard runers to the effect that she was running liquor from some point further north to Chicago and that section of the country, but did not know the exact points or who she associated with-MR. WATTS stated further that he did not recall enyone in particular that: she had associated with in Mankato when she returned on short visits for it seemed that a number of strangers always appeared at her home at the same time that she would visit her family, and they would always leave their automobiles parked around the home until she departed and they would leave also. MR. WATTS advised further that he was never very friendly with that particular family and had never heard anyone say much about them except that BELLE BORN was supposedly making her money in the liquor business. MR. WATTS retired from the mail service on October 1, 1955. He sould not furnish the names of BMLE BORN'S sisters or where they are now located, and

JAKE HILGERS, owner of the "JAKES BAR" located on Front Street, stated that he was formerly the Chief of Police of Mankato and had also operated a livery stable at one time; that he had become acquainted with the ANDERSON girls years ago while in that business; further, that he had been better acquainted with HKILE BOHN than he had been with the sisters, and in view of the fact that they, the two sisters, had been away from Mankato a number of years and did not remember their names, except that he recalled one of them being salled "Gold Tooth Annie" or MATHDIA, and that she is supposed to be running a boarding house in Des Moines, Iowa, but did not know the address. HILGERS stated further BELLE BORN had come into his place several months ago and had talked to him for a few minutes at which time the conversation had turned to what she was doing in Chicago, and she told him at that time she was a ticket seller in a theatre in Chicago; and the only reason she had made the money she had was because she was a very good friend of her boss. It was apparent that HILGERS knew more about RELLE BORN and her activities than he cared to disclose the control of the cared to disclose the ca

MR. L. M. ERICKSON, residing at Lewis and Marshall Streets, was contacted who stated that he has been parrying the mail over Route Mo. I since October 1, 1955; that he was familiar with the location of the home of BELLE BORN but did not know any of the occupants living at this place, nor had he noticed snything out of the ordinary while delivering mail at this address.

Sheriff SORDS stated that he had recently contacted his informant; living in the neighborhood of the house in question, and that he had not been able to secure any information of value; further, that he had recently arrested a neighbor of RELLE BORN'S by the name of PAUL ANDERSON who was later sentenced to St. Cloud Reformatory; that ANDERSON had caused RELLE BORN considerable trouble in the past and that they are very bitter against one another. Sheriff CORDS stated further that ANDERSON had lived next door to BELLE BORN'S home for a number of years and that he is of the epinion that he knows considerable concerning her and her activities; further, that he (Sheriff CORDS) believes that ANDERSON will probably disclose what information he might have in the event he is contacted for that purpose.

MR. and MRS. E. S. WILLIAMS of 457 Ashland Avenue, St. Paul, Minnesota, salled at the Division office and stated they knew an individual who they believe is identical with the photograph of ALVIN KARPIS which appeared in a St. Paul newspaper. MRS. WILLIAMS stated that she was formerly a chambermaid in the Junior Hotel, which is operated by one NEFF, who is known to this office to be unreliable, and she stated that sometime in September, 1954, a man same there, who appeared to be about 27 years of age, 170 pounds, close to 6 feet tall, slender build, dark hair, neat appearing, and used the name BERRY when registering; that he had with him a woman 5 feet 5 or 4 inches, very slender, dark brown hair, 87 or 28 years old; that they remained a few weeks and sold a considerable amount of their clothing.

WILLIAMS stated he is employed as a starter at the Ryan Hotel and that on one occasion, BERRY told him that he was going to Florida but was waiting for a friend of his in Minneapolis to dispose of some bonds for each but that this man had sent the bonds to Washington. Both the WILLIAMS stated that BERRY is supposed to have a Ford V-8 and a coupe of some kind. Concerning this, Special Agent R. N. Pranks conducted investigation as follows:

Agent interviewed FRANK THURSTON, an employee of the Junior Betal, 418 Jackson Street, St. Paul, Minnesota; MATHAN HEFF, proprietor of the Junior Hotel; FRANK REILLY of Reilly's Lunck, 4th and Robert Street; and MARIE SMITH, a waitress in the Poodle Dog Cafe on Jackson Street, between 5th and 7th. These four parties furnished information that BERRY is known as a gambler around town. MEFF stated that BERRY and his wife lived in his hotel during sometime in August and September, 1954.

Agent showed pictures of the KARPIS-BARKER growd to REILLY and MEFF and they picked out the picture of ALVIN KARPIS and stated that it resembled BERRY very much, but that they did not think it was BERRY. These pictures were also shown to THURSTON and MARIE SMITH and they advised that BERRY did not resemble any of the suspects.

Through interview with the above people, agent learned that BERRY is living at 614 Central Park Place with his wife, and agent interviewed MRS. BERRY at that address. She stated that her maiden name was MORKIN; that was the stated that her maiden name was MORKIN; that she was born at Letcher, South Dekota; that her husband's name is JACK BERRY, also called BROWNIE; that he was born at Yankton, South Dakota, and that they have been married for fifteen years, being married at Minneapolis. She stated that they have no children; that her father died just recently and she went to Letcher, South Dakota, for the purpose of attending the funeral; that her husband is only a gambler, and that she and her husband were arrested in 1952 by the Minneapolis Police Department for investigation in the robbery of the Third National Bank, in which two police officers were killed. She stated that they had no connection with this case at all and were later released. She stated that her ansband was also arrested in Sioux City, Iowa; for a disorderly sonduct charge. Agent showed her pictures of the KARPIS-BARKER gang and she picked out the picture of ALVIN KARPIS and stated it resembled her husband very much, although it was not he. She stated that her husband was in Duluth and that she had not seen him for the past week; that she would persuade him to some to the St. Paul Division office when he returned. It should be noted here that she was lying to agent as FRANK REILLY stated that RERRY was in town. MAL SUSPOIL PURE CARRI WAS IN SOURCE

On December 27, 1934, agent secured a photograph of JAOK HERRY from the Minneapolis Police Bepartment, their Mo. 26740-I-2. They have him under the name of LEAMON A BERRY, alias LEAMON A ANTHONY, alias LONNIE BERRY. His description as disclosed by their files is as follows:

On December S1, 1954, JACK BERRY came to the St. Paul Division office personally and stated that he was in town and did not save to be picked up as he was just in a gambling game and had won a lot of money; that when he heard that the authorities were looking for him, he figured that it might have been regarding this gambling game, so he thought he would lay low for a day or two. JACK RERRY does resemble ALVIN KARPIS in some details.

A photograph of JACK BERRY, together with a tracing of his handwriting which was obtained at the Junior Rotel, are on file in the St. Paul Division office.

On January 11th, a telegram was received from the Birmingham effice requesting information regarding the character, reputation, and description of the parties to whom 1934 Minnesota license No. 66985 on Chevrolet Sedan were issued. It was determined that the above license was issued to JAMES WILLIAMSOM, 706 Winth Street South, Minneapolis, Minnesota, for 1933 Chevrolet Sedan bearing motor No. 5,675,146; further, that said car was purchased from the Bolton Swanbee Company, 601 East Superior Street, Duluth, Minnesota, on June 80, 1954.

At 706 Winth Street South, Minneapolis, Minnesota, MRS. FRAME NOWAK, manager of the flat building, on interview advised that JAMES W. WILLIAMSON and wife and child stopped at the above place during the period of July 6 to 15 at a weekly rental of \$7.50. During this period, they were visited by their father and mother, a sister and a younger brother who were also driving an automobile; and that a few days later, both parties of people left for unknown destinations.

The above was communicated to the Birmingham office by telegram. advising that further investigation would be senducted at Duluth; and a reply was received requesting the St. Paul office to disregard further investigation,

Following the conference in Chicago, held by agents from several offices, Special Agents Brennan and Hall of the St. Paul office interviewed the mother and the sister of DOLORES DELANEY, consort of ALVIN KARPIS, to determine the whereabouts of DOLORES DELANEY. Nothing of value was obtained as to the whereabouts of DOLORES DELANET, both slaining that they had not heard from her for several months and did not know her present whereabouts.

Investigation of this matter is being continued by this office,

Beforence is made to your letter of January 16, 1935, transmitting twelve photographs and five lifts of latent prints taken from objects in spartments at 5920 Pine Grove Avenue and 432 Surf Street, Chicago, Illinois, in connection with the case entitled Alvin Karpis with aliases, I.O. #1218, et al; Edward George Bremer, Vistim; Kidnaping.

On the five photographs marked \$2, of which four are duplicates, there appear three latent fingerprints of value. One of these has been eliminated as being identical with the left thumb print of Special Agent F. G. Tillman, fingerprints of whom are on file in the Division. One of the remaining two latent prints has been searched through the single fingerprint file without effecting an identification.

The one latent impression on photograph #3 has been identified as that of the right middle finger of Clara Gibson, our #878417.

Photograph #4 reveals one excellent latent palmar impression. No palm prints of suspects in this case are on file in the Division which would enable any comparisons to be made with this impression.

One latent print appears on the three photographs marked #5, and it has been determined to be that of the left index finger of Clara Gibson.

The latent impressions appearing on lifts marked #7 and #8 are of the same finger. The lifted latent print marked #11 is very tragmentary, but does contain a few similarities with the left thumb print of "Doc" Barker. However, the number of similarities does not permit the exeminer to establish an identification.

Latent prints #6, #9, and #10, are too fragmentary and indistinct to be of any value.

Please refer to previous correspondence in connection with our efforts to obtain possession of 1935 1 1935 Model Buick Two Door Coach, Motor #4949155, which was recovered by the Atlantic City Police from the Coast Garage, where same had been abandoned by Karpis.

I conferred with U.S. Attorney Besson, and Assistant U.S. Attorney Arrowsmith, in connection with this matter, both of whom informed me that Federal Judge Philip Forman did not feel disposed to approve an order similar to the order approved by Federal Judge Wilkerson in Chicago, directing that the Ford V-8 Coupe, Motor #1836196, recovered in the Vernon C. Miller Case, be turned over to the Division, basing his refusal apparently on the fact that the car was not at this time in the possession of the Division but rather in possession of the Atlantic City Police Department.

Mr. Besson suggested that it would be perfectly proper for me to file an application for a petition, requesting a search warrant, and on which a search warrant would be predicated, and that in this manner the Division could obtain possession of the car in question. Therefore, Mr. Arrowsmith was directed to draw up this petition for search warrant and said warrant will be approved by the U.S. Commissioner at Trenton, N.J., on January 31st, when same will be forwarded to this office, and after which I will have an agent go to Atlantic City in company with a Deputy U.S. Marshal for the purpose of obtaining possession of this car, which will then be transferred to Philadelphia. MEMORANDUM FOR THE DIRECTOR

Pursuant to your instructions, I attended the conference at the Chicago Division Office on January 9 and 10, 1935, called by you for the purpose of considering all possible angles of the investigations looking to the location and apprehension of members of the Barker-Karpis gang. This conference was presided over by Special Agent in Charge E. J. Connelley and Assistant Director Harold Nathan and was attended by Special Agents in Charge R. E. Vetterli, Dwight Brantley and William Larson and Special Agents W. F. Trainor, Paul Hanson, Orville Dewey, O. G. Hall, R.D. Brown, S. K. McKee and John Madala.

For the benefit of those Agents not assigned to the Chicago Office, Mr. Connelley reviewed developments leading up to the logation and apprehension of Arthur R. Barker and his paramour, Mildred Muhlman and the killing of Russell Gibson while resisting arrest. Mr. Connelley emphasized the importance of first locating women associates of fugitives sought by the Division, placing them under continual surveillance and eventually the fugitives will contact them. It was pointed out that it would be better to drop the surveillance if it appeared that the person under surveillance had become aware of that fact and to take a chance on again picking up the surveillance at another time. Mr. Connelley explained that recent observations made in the Chicago District, discloses that members of the Barker-Karpis gang in going from one address to another in their automobiles, upon reaching their destination, would circle the block two or three times and then park their cars a short distance from the address, leave the car and proceed down the street a short distance, and at the same time, keep an eye on their car to see that no one approached it or made an examination of it. Mr. Connelley also explained that although several men were observed visiting the apartment of Russell Gibson, they were not all in the apartment at the same time; that when it was observed that attempts were being made to move from the apartment, it was then deemed expedient to take immediate action and apprehend those who were then in the apartment. After stationing Agents around the apartment at advantageous points, he communicated with the apartment in question through the speaking tube and identified himself and instructed the occupants to come out of the apartment, one at a time and with their hands in the air. The results obtained under this procedure, needless to say, were very satisfactory.

The question of what persons are now being sought by the Division was discussed and it was the consensus of those present that Fred Berker, Alvin Karpis, Volney Davis, Harry Campbell, William Weaver, Willie Harrison, Harry Sawyer and Edna Murray should be immediately taken into custody should they be located. All the other individuals mentioned as associates of the foregoing should be placed under continual surveillance, in the event they are located and the Chicago Office should be notified immediately. Although Alvin Karpis is the only individual specifically named in the indictment now pending at St. Paul, Minnesota, it was the consensus of the gathering that it would not be necessary to return a new indictment specifically naming the remaining individuals now being sought in connection with this case.

The question of confidential informants was discussed at some length and I advised those present that the Division would authorize the payment of a sum of money up to \$1,000.00 on each of the principal subjects now being sought, but that some discretion should be exercised and if an informant could be induced to furnish information for a sum less than \$1,000.00, such an arrangement should, of course, be made with the informant. It was pointed out that to some informants \$1,000.00 would not be a sufficient inducement and on the other hand, it was pointed out that informants who have produced the best results in the past, have asked for little or nothing in the way of money. This is especially true of the informant at Toledo, Ohio, who furnished the information leading up to the location of Arthur R. Barker and Russell Gibson. He is reported to have even declined expense money.

Those present were instructed to take immediate steps in their respective districts to review the file in the case and submit a brief summary of the more important contacts of the Barker-Karpis gang in their districts and it was suggested that in those districts where valid, basic leads are located that there be exclusively assigned to the case an Agent who is more or less familiar with the background or modus operandi of the gang. It was appointed out that an Agent thus assigned, would not only develop information of value with respect to this particular gang, but should also develop information concerning other criminals who will likely become subjects of other Division investigations, such as bank robbers, it being noted that any contacts of the Barker-Karpis gang will be contacts for criminals in the same

Another question of interest to all was the tracing of automobiles, it being noted that cars traced into the possession of members of the Barker-Karpis gang have later been disposed of by sale and that inquiries have been made of the dealer who originally sold the car in question without this fact becoming known to the Division. It was, therefore, suggested that all field offices be instructed to specifically request automobile dealers to notify the Division Field Office in the event an inquiry is received respecting the car previously sold by them to a member of this gang. An appropriate bulletin will be prepared and furnished to all Special Agents.

Some discussion was had on the Division requirement that a report be submitted within fifteen days after the receipt of an undeveloped lead. It was pointed out to those present that the purpose of this requirement was to expedite the investigation being conducted of the more important cases.

Mr. Waters suggests that Art Burdette is willing to proceed to Philadelphia in order to interview his sister believeing that he might obtain some information from her.

I advised Mr. Waters that we would keep this suggestion in mind, and if we feel that the Burdette woman is not telling us the full truth, we might consider having her brother interview her in a room in which a dictophone has been placed.

This is in accordance with telephonic arrangements made with Mr. F. J. Flexer of the State Department, who communicated with the American Embassy at Havana, Cuba.

Mr. Hanson advised that they had interviewed Dr. John E. Hall, who identified the photograph of Karpis as an individual who had until January 15, 1935, or shortly before January 16, 1935, been receiving daily treatments for gonorrhea, which appears to have been a recurrence of an old malady. Dr. Hall advised that Karpis had stated he owned a Buick car, which is in Cuba, and also a home located in the Viboro Section near Mariano, Havana,

Mr. Hanson also stated, in connection with the information he furnished Mr. Tamm yesterday relative to a Colt Monitor, that he has since found that it is not a Colt Monitor but a Browning automatic rifle which Joe Adams of the Propagato Hotel in Miami had in his possession. FEB 1 1935 INDEXED

In view of the statement of Dr. Hall that Karpis would continue to require daily treatments for his malady, I telephoned Mr. Larson at the Detroit Office, at 5:50 P.M., and furnished him with this information. Mr. Larson stated Mr. Connelley was at that time in the office and that he would relay this information to the Chicago Office for its consideration.

During my conversation Mr. Larson stated they had located the individual named Cash, referred to by Byron Bolton as residing at Detroit, Michigan, where he is alleged to have exchanged some of the Bremer money, and it has been ascertained that Cash is also reported to be a harborer of fugitives. Therefore, Larson contemplated raiding Cash's home last night and thereafter continuing on to Toledo, Ohio with a view to contacting the hospital where this gang is reported to have a contact in that it is the place where Winona Burdette was taken last summer to have an operation performed.

Pyles took off of each of these bodies certain diamonds which he turned over to the Department of Justice, and that the operatives for the Department of Justice also obtained some fourteen or fifteen thousand dollars in currency.

in the completion of the responsibility of the complete contraction of the contraction of Mr. Pyles does not desire to become involved in any proceeding regarding the matter, but it appears to me that unless this money is earmarked or the diamonds are claimed by some one else, that there can be but little question about the payment of his bill for services.

As the matter has been quite expensive to him I should like to know what position you will take regarding it, as otherwise I shall be forced to the appointment of an administrator to try to collect this money. I thought probably there would be no objection money. I thought probably there would be no objection to the settlement of this claim, leaving the remainder of it in abeyance for future consideration.

MEMORANDUM TO MR. R. A. ALES

Attached is a letter from Mr. H. M. Hampton, Attorney at Law, sensorning the funeral supenses of Fred Barker and Kate Marker.

We are acknowledging the receipt of this letter with advice that the matter is being given considerations

This is just another engle concerning the disposition of the effects of these deceased individuals and I would suggest that you take this matter up with your superiors in Washington, so that the Attorney General's office may have full knowledge of all the compliance tions, different claims, etc., and direct the disposition of these personal effects.

I have discussed the case some with Mr. Holland and you may state that it is our view that the money, after it has served its purpose as evidence for prosecution purposes, should be returned be the County Judge of Marion County, to be administered under the lasts of the State of Florida. Already an attorney representing the hasebend of Kate Barker, who, I understand, is also the father of Fred Barker, has indicated that his elient will claim the personal effects. Now somes this letter from the undertaker. The owner of the house in which the Barkers were killed has also indicated that he would like to be reimbursed from the estate for damage to the house by gume fire.

I don't believe that any one would make any serious objection to the taking ever by the Government of the fire arms or the
automobile. As to the diamonds, you may state that it is our view
that these too should eventually be returned to the County Judge, before whom any one in position to satablish a claim could make proof.

As a matter of fact, even if the money could be established as belonging to premer or some kidney victim, it is our opinion that, after

Judge before whom proof of comercia could be made.

The statute requires the County Judge, when acting as a coroner, to take over and administer the personal effects of the deceased, and makes him civilly liable for failure to perfore that duty. 



Brown advised that he had located a house, a mansion, at Vadero Beach, about one hundred twenty-five miles from Havana. This house was rented on or about September 20, 1934, under a lease, until February 15, 1935, at a rental for the period of \$300; that investigation at Vadero Beach disclosed that Karpis and Delaney, alone, lived in this house; [4] they left hurriedly on December 11 or 12, 1934; while residing there they employed three servants. In the arrangements whereby this house was rented by Karnis and Delaney they were assisted by Nathan Heller, a Jew who is connected with Joe Adams in Mismi. Florida, in mome way and who manages the Park View Hotel in Havana. Agent Brown is of the opinion that Heller knew full well who Karpis Agent Brown learned that Kate Berker called on Karpis

and Delaney at this house and visited part of December, 1934, and remained for three or four days; she appeared to be interested in a place nearby, stating that she wanted it for Merself and two sons; however, she returned to Hayana without securing a blace.

Heller, Manager of the Park View Hotel in Hayana,

sent Karpis and Delaney to the owner of the house aforementi med in Vadero Beach. He gave them the name of the lady who was the owner and appears to have assisted them in obtaining a lease on the place.

In the vicinity of this house at Vadere Beach me one until a few days after Karpis and Delaney left knew who they were. A lady there saw a picture of Karpis in a magazine, after which she wrote the American Vice-Consul at Mantanzas. This was the day after Karpis and Delaney left. He apparently took me interest in the report and in replying to the lady's letter he told her to get in touch with the new Ambassador in Hawma. Agent Brown stated that if desired Cuban authorities would immediately deport Heller, being an American, to the United States; that he contemplates interviewing Heller during the morning of January thirty-first and believes that he can give valuable information if he will. Heller appears to be as responsible and as much a connected as is Joe Adems with the harboring of these fugitimes.

When Karpin came to Havana and contacted Heller he had a card of Joe Adams on which Adams had written a note to Heller. During the time that they lived in this house they had no visitors except Kate Barker for three or four days, as aforementioned, and George Harris and wife, the American salcon-keeper in Havana. After Karpis and Delaney left this house, Heller called at the place, driving a ford sedan that Delaney purchased, which was mentioned in my memorandum to the Division on January thirtieth. This car may be still in Heller's possession; however, Agent Brown has been unable to locate it. Agent Brown is of the opinion that Heller knows where Willie Harrison and Harry Camper are presently located.

The above information was furnished to Mr. Tamm of the Division at eight PM on January thirtieth and was furnished to Special Agent in Charge Hanson at Mismi at eight twenty-five PM on the same date for his use in further questioning of Joe Adams in Mismi. Agent Hanson stated that Adams had informed him that he might have given Karpis a card to present in Havana to identify himself; also that Heller was seen in Mismi in November on about the fourteenth, with Doloras, at the Kl Comodoro Hotel; further that it has been definitely determined that McDonald made two trips to Havana from Mismi on September 6, 1934, and that it is the intention of the United States Attorney at Mismi, to file a harboring complaint against McDonald in the event he is located. It appears, according to Agent Hanson; that McDonald changed hot money in Havana, and requested that Agent Brown in Havana make

appropriate investigation, obtaining witnesses to show that Me-

Donald helped Earpis and Delaney to hide out in that pity.

noted in connection with the points of suspicion, namely 3912 Pine Dr Avenue and 458 Surf Street, the latter address being the location of MILDRED KUHIMAN, and the former address being the address where spin fently WILLIE HARRISON had reated an a partners for himself and others, under the name of J. B. Bolton. At this time theywere apparently contacting each other, that is, the party later identified as Russell G. Gibson and irthur. Labarker, and there was considerable activity in connection with the use of a Ford V 8 bedan, license 266231, Illinois, for 1934, which had been under suspicion, and which had been previously purchased under the name of J. S. Bolton. While it had been noted that apparently one or two men had been contecting both of these addresses, no definite conclusive identification had been made of any of the subjects from the pictures available, and on the morning of January 8, 1934, together with Agent Brown, the writer observed from a plant located at 722 Sheridan Road, Chicago, being maintained by Agents R. C. Suran and J. L. Madala, a party who was undoubtedly with the control of the cont RUSSELL G. GIBSON, and his wife Clara Gibson, in the above indicated automobile, it being apparent that there was more than one man at 5912 Pine brove Avenus, that is, in the apartment at this address located at what would be 3920 Pine Grove Avenue, but all in the same flat building; also undoubtedly there was one or more momen living at this place in addition to the woman living at 432 Surf Street. Subsequent observations on this date, perticularly those of the writer and agent R. D. Brown, indicated that apparently the maximum number of persons the would be available in both of these addresses, was presently occupying such addresses; that in view of the rather definite identification of Russell Gibson, the party with Mildred Kuhlman was undoubtedly ARTHUR R. BARKER, blthough as will by noted from his most recent photograph, identification would be difficult. from the photograph available of him, he having taken on considerable :

After this observation of both places by the writer, and the noting of the presence of these individuals at the apartments; arrangements were made to immediately reinforce the setups at both addresses, an apartment having been maintained in 309, at 432 Surf Street to observe Kildred Kuhlman, who was located in Apartment G-1, and also in apartment 5916 of the apartment flats at 3912 Pine Grove Avenue, as well as the room to the rear of 3912 Pine Grove, facing the alley, located in the address 722 Sheridan Road, in order that in an emergency a sufficient number of men would be available to take either place, and also in order to observe when the subjects in question had all assembled in either or both of these two addresses.

for the assistance of additional agents to conduct a raid immediately apon It becoming evident that both places were apparently fully cocupied about F.H. on this date arrangements were made for the secessary detail of men. the Agenta assigned to the squad to ving previously been lastrapted in detail as to what would be done in raiding both places, and the particular definite assignment of each man concerned. The new agents received from the Chicago office were assembled and assigned to their respective posts as to both addresses and instructed as to what action was to be taken, and who it was expected to apprehend, the agents of this detail of course having already been fully aware of who might be expected at each entrance. Thereafter there was assembled at 3912 Pine Grove Avenue..., Agents Suran, Madala, McLaughlin, Sullivan, Barber, White, Boardman, Welles, Kehegan, Bicks, Abbaticchie, Myers, & Williams, Brown, McKee, McIntire, and the writer. There was assembled at 432 Surf Street - Agents Jones, Walsh, Campbell, Ryan, Muzzey, Chaffetz, Gillespie, McDade and Lorry. The plan of operation was to take first the occupants of 5920 Pine Grove Avenue, inasmuch as it was expected there would be possibly. two or more men at this address, to be followed thereafter by a raid upon 432 Surf Street, with the understanding hovever, that should the occupants of 452 Surf St. leave such address, they were to be taken into custody, in order to prevent their escape, or warning of the people at 5912 Pine Grove was divided into two groups, in order to command both the front and rear and of the building, Agents Jones and Campbell being assigned to command the two squads, due to their prior Police experience. La will be related here. inafter by memorendum, by the agents covering same, the party who later proved to be Arthur R. Barker, and Mildred Kuhlman, left the address 452 Surf Street at about 6.30 P.M. and were taken into custody.

As most of the occupants of 3920 Pine Grove Avenue apparently were absent from this address at the time it had been contemplated to conduct the raid, action was deferred and surveillance continued until approximately 10.45 P.M., when Russell G. Gibson and his wife and another woman who belonged to one of the other apartments, entered the front door of 3920 Pine Grove to go to their apartment, and at practically the same time, Agents Madala and Suran, who were observing the alley, noted a man enter the rear apparaintly of this same apartment. Thereafter, with Agents Barber and Milte stationed at the corner of the building, supported by other agents in the rear where it was expected Gray would emerge if he did not come out of the front, the writer, together with Agents Brown, Makee and McIntire entered the front of the building and arranged to take these people out of the apartment. At this time the writer and the other agents was stationed at the door to the small vestibule. Through the speaking tube at the entrance to their apartment, which was up about one half flight from the ground floor,

the writer directed these people to leave the apartment by the front catrance individually, tith their heads appunarmed, they being adviced of Agente 1 dentity. Clara dibson enswered into the tuber and in order to verify definitely shether we had the right a mirtment it request was made in speak to Mr. J.V. Bolton, and Clara Sibson advised that he was not in , and in enswer to further questions, advised that he would be in the latter part of the week, after which the necessary commands were given for these people? emerge. Clara Gibson emerged first with her Chow dog, followed after a 🛬 slight in erval by Ruth Heidt. Thereafter, a men emerged who later proved to be William Bryan Bolton, alias Monty Carter, previously identified with this case, and just shortly prior to the time he appeared on the stairway, some shooting was heard, which resulted when Russell Gibson emerged from the back entrance of the apartment in his shirt sleeves, and no bat, wearing a bullet proof vest and carrying and firing a Browning automatic 80.06 caliber rifls. which fire was directed at Agents White and Barber. Thereafter in the return fire Russell Gibson was wounded, he having fired what apparently was four shots from the Browning automatic rifle. Be later threw off his 💉 bullet proof vest after having been wounded, and dropped a 32 celiber Colt autometic pistol, fully loaded. Immediately upon the occurrance of the above shooting, arrangements were made with the jenitor to reassure all of the people in the apartments that no one would be barmed, and also to call the Police if they were not on their way to this address, and advise them as to what was occurring, he being advised to have the Police officers immediately contact the writer upon arrival, and shortly thereafter the Police did arrive, and were contacted by the writer. The Police offered their cooperation in following up the necessary work in connection with determining definitely that no one else was in the apartment, before entering same. Also in this connection, immediately after the shooting had occurred the writer emerged from the place where the siege was still being maintained \odot at the entrance to the apartment, and advised all of the occupants of the different apartments, many of whom were looking out of the windows, at Agents! identity and what had occurred, and that for their own safety they should immediately close their windows and lock their doors, which was complied with by all the occupants of the building.

Thereafter as will be related in various activities of the Agents reported in this connection, the two women and Bolton were taken to the Chicago Division office. Russell Gibson was taken to the hospital, where he died; the apartment was entered; the various guns later enumerated herein were found and placed where no one might disturb them until they could be examined for fingerprints, etc.; a suitable number of agents was left in the apartment to guard same until the necessary action could be taken in connection therewith, it being locked and no one allowed to enter. A guard was maintained at 432 Surf Street in order to take care of

anyone who might appear at this address who did not know of the apprehension of Barker. All of the persons concerned were suitably incercerated in the Division office and arrangements made to fingerprint them. Arrangements safe to fingerprint them.

There was found on Mrs. Stark Gibson a receipt dated January 5, 1935, made out to Mr. J. A. Reed, which was the name under which the mail box as listed at 3920 Pine Grove Avenue, showing she had rented an apartment for \$42.50 per month for January 10 to February 10, 1935, at 5522 Suff Street, Bubsequently, at about 7 A.M. this apartment was reided with a number of other agents from the office, and the janitor, Micholas Rill, and manager of the apartments at 522 Surf Street was interviewed and indicated that a party who from his description was indicated as Clera Gibson, at 13 noon on January 8, 1935, had rented this apartment, and at 6 P.M. had called for the keys is order to take in certain boxes, in preparation apparently of moving into this address. The articles moved in were examined and nothing of interest found, same being mostly groceries, kitchen utensils, etc. The apartment was locked, with orders that no one was to enter same and arrangements made with the janitor to call this office should anyone make inquiry the earter.

Place, previously mentioned in reports as the home of Barbara Lonquest, which is run as a call house for various women; and associates of Mildred Kuhlmah, and also at 641 Cakdale Street, the home of Fillis Lonquest, mother of Barbara Lonquest and Patricia Lonquest. The various inmates of this place, were brought to the Chicago Division office for questioning, and nothing material developing from such inquiry these women, namely: Barbara Lonquest, Patricia Lonquest, Tillie Lonquest, Frances Lonquest, Grace Lonquest, Regine Mordock, and Marjorie Harrison, were released, and their background, statements, etc. will be covered in subsequent report.

Thereafter, at about 6 A.M. Agents proceeded to 958 M.Hamlin St.

the home of John Borcia, previously mentioned in connection with activities at the Commonwealth Hotel, Chicago, Illinois, but he was not found at home. He subsequently appeared at the Chicago Division office, and indicated that he John Borcia, alias/Borcy, is now living at room 808 Lincoln Hotel; that he was a gambler, that he had been arrested in 1914 or 1915 on a burg-k lary charge and acquitted; that he was 38 years of age and was born in Chicago; that he did not know Russell Gibson alias Slim Gray, or the members of the Karpis-Barker gang, he viewing various pictures of this outfit. He stated he had met Russell Gibson but did not know his name, either in the saloon or ciger store at Clark and Diversey streets, some time in the past; that Patricia Lonquest was his girl friend; that she had brought a girl named Mildred to his room at the Common ealth Hotel one night two or

three weeks ago, and that this girl had said she was from a little town news.

Boreia was evidently lying as to his knowledge regarding the members of this gang, but at this time there is no definite information which would justify holding him in connection with a possible harboring charge, and it is believed that due to his connections here he might be available as an informant later on in connection with activities here in Chicage, although his reliability would be a doubtful proposition.

The following section of this report is being dictated by Special Agent R. D. Brown.

It will be noted from the report of Special Agent Browns, which cago, Illinois, dated 1/8/35, thes Mildred Kuhlman, alleged paramour of Arthur R. Barker, had been seen entering and leaving the address of 439 Arlington Place. It will also be noted that on 12/87/34, Special Agents F. G. Tillman and D. P. Sullivan followed Mildred Kuhlman from the Surf Lane Apartments, It will also be noted that on 12/86/34 Special Agents R. D. Brown and J. L. Madala, upon examination of the spartment house at 432 Surf Street, noted the name on the mailbox to apartment to be A. R. Esser. It had previously been learned that Mildred Kuhlman had been using the name of Esser while in Chicago, and it was also noted that subject "Doc" Barker's first initials are "A. R."

Inquiries were made of the apartment manager at this address and it was found that a Mrs. A. R. Esser had rented apartment C-1 en 12/15/34 for one month. On that date, 12/28/34, Special agents Sullivan, Barber and Gillespia were stationed in apartment 300 at this eddress, in order to place a surveillance on apartment C-1. It was noted that Mildred Kuhlman left and entered this spartment frequently alone. On 1/4/35 Special Agents Madala and Brown noted a 1934 model Ford V-8 tudor sedan, bearing 1934 Illinois license No. 1-255-231, parked on Surf Street in Front of the Surf Lane Apartments. This is the same automobile seen by Special Agent R. C. Suran at 641 West Oakdale Avenue, which car was found to be registered in the name of Bolton.

Brown, W. C. Ryan, C. O. Hurt, C. G. Campbell, J. L. Madala and A. A. Muzzey noted from apartment 309 at this address, two men leaving the entrance to apartment G-1. These two men entered the Ford V-8 aforementioned. This car was followed by Special Agents Burt and Muzzey together with Agent Ryan in a Division automobile and they observed the car stop in front of an apartment building at 3912 Pine Grove Avenue.

On 1/5/35 Special Agents S. K. McKee and J. L. Madala learned Trom apartment manager J. Migdal, Pine Beach Apartments, 3912-5928; Pine Grove Avenue, that one J. B. Bolton rented apartment No. 1 North, 5920 Pine Grove Avenue on 11/20/34. After viewing photographs, Mr. Migdal identified the photograph of William J. Harrison as that of the person who rented the apartment. An apartment was then obtained at 3916 Pine Grove Avenue, from which point Agents could view the persons entering and leaving the entrance leading to apartment No. 1 North. Special Agents R. C. Suran, J. L. Madala and S. K. McKee maintained a surveillance over the Bolton apartment on January 5 and 6, 1935. On January 6, 1935,

Special igents 7. McLeughlin and R. 5. Suran maintained the surveillance in this apartment. On 1/7/35 Special Agents J. L. Madels and H. G. Suran obtained a room in the spartment of Mrs. B. Carmen, second floors. 221 Sheridan Road, where it was possible for these two Agents to view the rear entrance of the Bolton apartment. Special Agents B. P. Sullivan and J. T. McLaughlin then maintained a surveillance in apartment P. at 3916 Pine Grove Avenue, where Agents could view the persons entering and leaving the entrance to apartment 1 Borth. Agents could also observe from apartment 2-W, through the front windows, some of the activity there in and on rare occasions, when the curtains would be raised, sould make out figures inside the apartment.

The observations of persons entering and leaving apartment 1 North at 5920 Pine Grove Avenue by Special Agents J. L. Madela, R. G. Suran, J. T. McLaughlin and D. P. Sullivan are being set forth at another point in this report as a result of memoranda aubmitted by these Agents.

Special Agent in Charge E. J. Connelley and Special Agents
R. D. Brown called at the room at 722 Sheridan Road, where Special Agents
Madala and Suran were stationed, at about 11:00 A.M. on 1/8/35. Agents
Madala and Suran reported that they had seen a woman leave the rear
entrance to apartment 1 North at 3920 Pine Grove Avenue just prior to
Agents' arrival. At 11:15 A.M. Agents observed the woman returning with
a Chow dog, which, according to Agents Suran and Madala, was the same
woman that had left a short time before. She was driving the before
described Ford V-8 sedan, bearing Illinois license No. 1-266-251. In
viewing her from a distance, it was noted that she resembled in height
and facial expression Clara Gibson. Agents then observed a tall slender
man who answered the description of Russell Gibson alias Slim Gray come
out of the apartment, step into the car, and drive away with the person
who answered the description of his wife Clara Gibson.

Upon returning to the Chicago Division office at 39 South LaSalle Street, Special Agents McKee and Brown were advised by Special Agent in Charge Connelley that Special Agents Suran and Madela had reported that the occupants of apartment 1 North at 8920 Pine Grove Avenue appeared to be moving articles from the apartment. Before returning to the LaSalla Street office, Agents had previously noted, at about 12:30 P.M. that Ford V-8 bearing Illinois license plates No. 1-266-231 was parked on Pine Grove Avenue on the corner of Pine Grove and Surf Street.

Upon receiving this information from Special Agent in Charge Connelley, he directed Agents (McKee and Brown) to proceed to the apartment at 3916 Pine Grove Avenue and join Special Agents McLaughlin and Sullivan, as Mr. Connelley had decided that apartment 1 North at 3120 Pine Grove Avenue should be raided. Special Agents McKee and Brown arrived at 3916 Pine Grove Avenue at approximately 6:30 P.M., and were

advised by Special Agents Medala, Suran, McLeughlin and Sullivan that the Ford V-8 bearing Illinois 1934 license No. 1-266-251 had made another trip to the rear of apartment 1 North and had taken toms boxes into the apartment. At approximately 7:45 P.M. this ear again left the fear of apartment 1 North. At about 10:00 P.M. Special Agent in Charge Connelley and Special Agents McKee, McLaughlin and Sullivan noted the tall slim man answering to the description of subject Sibsan and two women enter the entrance to apartment 1 North. Mr. Connelley then placed various Agents in the rear of the building, the details of which will appear elsewhere in this report.

It was decided that Special Agent in Charge Connelley and Special Agents McIntire, McKee and Brown would anter the Trout entrance to 5920 Pine Grove Avenue, the entrance to apartment li North, and at approximately 11:15 P.M., after all Agents had been properly stationed in the rear and at the sides of the apartment building, Special Agenta McIntire, Brown and McKee took up their places at this entrance, while Mr. Connelley, dso at this entrance, went to the speaking tube to apart ment 1 North. The speaking tube was answered by a women and Mr. Connelley asked this woman if Mr. Bolton was in. She replied that he was not in and would not be in until about the end of the week. Mr. Connelley then advised this woman that he was a Government officer from the United States Department of Justice, and that the building was completely surrounded. He ordered all occupants of the apartment to come down the front staire one at a time, with their hands up. Special agents Mckee and Brown were stationed at the foot of the stairs, equipped with Thompson sub-machine guns. Agent McIntire was equipped with his service 38 super-automaticit as was also Special Agent in Charge Connelley. After the first order to come down, Agents waited and received no response. Mr. Connelley again. called through the speaking tube and again demanded that all persons occupying the apartment come down immediately or the place would be gassed? Agents again waited for approximately three minutes, but there was still no response and for the third time Mr. Connelley again demanded that all persons occupying the spartment come down. He also warned the persons in the apartment that no escape should be attempted through the rear, as the apartment building was completely surrounded and anyone attempting to escape would be killed.

After this order two women came down the stairs and approached Agents Brown, McKee and McIntire. These women were later identified as Mrs. Clara Gibson and Ruth Heidt, wife of William J. Harrison. Mr. Connelley Commanded these women to lie down on the floor with their hands forward, in order that no attempt could be made to assault Agents. The two women were searched by Special Agent McIntire for concealed weapons, with no results. Approximately a moment later a man came down the stairs

Byron Bolton alias Monty Darter. He was likewish commanded to lie on the floor with his hands out. No weapons were found on him. At this time Mrs. Gibson admitted her identity and she was asked if any others were in the spartment and she admitted that her husband was in the apartment. At that moment several shots were heard in the year of the building, at which time Mrs. Gibson screames with they have not be in the apartment, after having been shot, Special Agent McIntire took Mrs. Gibson to the speaking tube, at which time she attempted to parsuade her husband to come down and surrender, but she received no response.

At this point Special Agent in Charge Connelley called to Special Agent Sullivan, who was near the front entrance of the building, to shoot gas shells into the apartment, and there followed three reports from the gas gun. Just after the gas projectiles were fired police arrived at the front entrance, at which time igents identified themselves. About ten minutes later the janitor of the building, Paul Lenco, arrived with a key to apartment 1 North, at which time Special Agent in Charge Connelley, and Special Agents S. K. McKee and R. D. Brown, accompanied by three police officers, went into apartment 1 North, the rooms of which were found to be filled with gas. At this time several cuns and other equipment were located, the description and number of which will be reported at another point in this report. Previous to entering the apartment the two women and Byron Bolton were taken to the Chicago Division office.

been found on which was written the eddress "522 Surf Avenue, Mrs. J. A. Reed, Jamuary 8, 1935". Details relative to the raid on this apartment will be reported by Special Agent in Charge Connelley.

The following memorandum was submitted as to the activities of Special Agent S. K. McKee on January 8, 1935:

Agent 7. 1. Redain telephoned at 1:30 P.M. in your absence and advised that a woman had come to the spartment at 3912 Pine Grove Avenue, a few minutes prior to his call in the Ford sedan, bearing 1934 Illinois licenses fl-266-251. This woman was wearing a black tem, a mink soat and was said to jet semble Clara Gray, wife of subject Slim Bray. Agent Madala, also, stated that another woman had come from the apartment a short time before with a chow dog, and had taken the animal for a walk. Madala advised that he plans to follow the Ford sedan, when it is taken away from the apartment, that is, in the event the same woman who came in it drives it away.

The following memorandum was submitted by Special agent S. X. McKee as to his further activities on the evening of January 8, 1935;

on the evening of January 8th, 1985, Special Agents R. D. Brown and S. K. McKee joined Agents J. T. McLaughlin and D. P. Sullivan in Apartment 2W, 3918 Pine Grove Avenue, Chicago, Illinois, for the purpose of maintaining surveillance on the occupants in apartment 1M, 3920 Pine Grove Avenue, with the idea of raiding this apartment later in the evening.

At this time Agents R. C. Buran and J. I. Medala were conducting a similar surveillance from a room which overlooked the rear entrance of the apartment under observation. Prior observations had indicated that Russell Gibson, Clara Gibson and another woman and man were living in this apartment.

At about 6:45 P.M. a man and woman left the apertment via the rear entrance and departed in the Ford sedan bearing 1934 Illineis license No. 1-265-231. They had some luggage with them at this time. Due to the fact that appropriate arrangements had not bean effected at that time, no effort was made to stop these people. It was also thought that they would return later in the evening.

Special Agent in Charge E. J. Commelley and eight other Special Agents joined the Agents who were conducting surveillance on this apartment at about 7:45 P.M. and eight Agents were stationed at points in the alley behind the entire apartment building for the purpose of covering the rear entrance. The surveillance from Apartment 2W, was continued, as well as the surveillance on the rear of the apartment from the room occupied by Agents Surar and Madale.

At about 10:45 P.M., Agent Sullivan noticed a man and women some into the entrance of the apartment at 5920 Pine Grove Avenue. These people were thought to be Russell Sibson and his wire. A few minutes later Agent Medala advised that a man had entered the apartment under abservation from the rear.

At approximately 11:15 P.M., while the apartment was covered by Agents in the rear, Special Agent in Charge E. J. Connelley and Agents E. R. McIntire, R. D. Brown and B. E. McKee entered the vestibule of the apartment under observation and Special Agent in Charge Connelley communicated with the apartment through the lobby speaking tube and advised the occupants that the apartment was surrounded by Department of Justice Agents; that they should come down one at a time with their hands up and if they did not do so the apartment would be gassed and they would be forced to leave. They werefold that they would be given five minutes in which to come down.

Agents Brown and McKee were covering the vestibule door leading to the apartment in question with machine guns.

After three warnings had been given a woman shouted down the stairs that she was coming down and almost immediatelythereafter a women, who was later learned to be Clara Gibson, descended the stairs with a brown chow dog. She was forced to keep her hands raised and to lie face down on the floor. A few medonds later approximately seven shots were heard, the sounds of the shots coming from the rear of the apartment. At about the same time as these shots were heard, a second woman came down the stairs with her hands raised. It was later learned that this woman was Ruth Heidt. She was likewise forced to lie face down on the floor. Shortly thereafter, an individual, who was later learned to be Byron Bolton, came down the stairs with his hands raised and he also, was placed in a prone position on the floor with his hands over his head.

As it was thought there might be other people in this epartment, all three persons who had come to the vestibule were questioned but they informed that the only other person in the place at the time of Agents'arrival was Russell Gibson and Bolton claimed that he had run out of the back door with a gun and had been shot as he went down the steps. At this time, on the orders of Special Agent in Cherge Connelley, tear gas was shot into the apartment from both the front and rear, in order to force any other occupants from the place.

Shortly after the tear gas had been fired, one witchell, resident of apartment IW, 8922 Pine Grove Avenue, came on to the small roof over the English basement, which fronts on the wine dows of the apartment under investigation, and shouted that he surrendered. The Agents in the vestibule had been joined at this time by four Chicago Police Department detectives, who were armed with shotguns, and these efficers forced Twitchell to jump from the roof to the courtyard. He was then placed in the vestibule with the other persons.

After a sufficient length of time had gone by for additional occupants of the apartment to have been forced from same by the tear gas, the apartment was entered by the agents who had been in the vestibule and was found to be vecent.

Clara Sibson, Ruth Heidt and Byron Bolton were taken to the Chicago Division office. The apartment which had been occupied by these people was occupied during the remainder of the night of January 8th and until approximately 4:00 P.M. on January 8th by agents McKee, Suran, Barber and Jones, along with police detectives McDonald and Kessick from the Town Hell Police Station. This apartment was occupied in order to keep anyone from fingering anything therein which might contain latent fingerprints of the late occupants; also in order to apprehend any associates of the late occupants who might return to the apartment.

Various firearms, quantities of ammunition and personal effects of the occupants of this apertment were packed into suitcases and brought to the Chicago Division office.

Shortly after the shooting, Lieutenant William V. Blaul of the Town Hall Police Station came to the spartment and turned over to agent McKee a bullet-proof vest covered with blood which he stated he had found at the foot of the rear steps. He also turned over a .32 calibre folt automatic pistol which he said he had found beneath the vest.

The rear steps and the ground immediately adjacent thereto was examined by Agent Lickee and the following articles were found:

2 keys on ring, apparently belonging to a Ford automobile; 1 exploded 30.06 shell. The bullet-proof vest was examined and was found to have been pierced from the front between the second and third buttons from the top. The bullet in question had then apparently passed through Gibsonand lodged in one of the rear plates. This bullet was extracted from the vest and was found to be a .851 calibre lead-nosed bullet:

The apartment under investigation contained three bullet holes through the front windows. Two of these bullets had lodged in the floor boards on the west side of the apartment, while one had struck a small table leg and lodged therein. One bullet was extracted from the floor board and was found to be a 38 calibre lead-nosed bullet.

A bunch of keys was found on the person of Russell Gibson and turned over to Agent McKee. These keys will be found attached hereto in an envelope appropriately marked, as will the other objects mentioned above.

A "Turler Zurich" watch, along with a thin, white gold chain, containing a small knife on the other end, was found in the hall closet of this apartment. This watch was later identified by Blara Gibson as the property of her late husband. It willbe found, along with the property of Mrs. Gibson, at the Chicago Division office.

During the search of this apartment, a penciled note bearing the name Edna and the 'phone number 4482, was found in one of the dresser drawers in the bedroom. This 'phone was found to be listed in the name of Irene Funk, Apartment 2, 2303 East 70th Place, and it will be the subject of further investigation.

As stated above, the Agents who were detailed to occupy Apertment IN, 5920 Pine Grove Avenue, remained in the place until approximately 4:00 P.M., January 9th, 1935, at which time they returned to the Chicago Division office, bringing with them Ford seden, bearing last year's Illinois license No. 1-266-251 and all of the personal effects from the apertment.

Exhibits referred to in the above indicated memorandum of Special Agent S. K. McKee are retained in the Chicago office until determination is had as to what disposition is to be made of same in the further interests of this case.

The following is submitted by Special Agent E. McIntire as to his activities on the night of January 8, 1935.

This will advise you that be the hight of January 8, 1935, I was instructedby Special agent in Charge E. J. Connelley to sequre a Division car and proceed to a point la the vicinity of 3912 Pine Grove Avenue, Chicago, Illinois, At this time it was anticipated that Agents of the Chicago Division office would apprehend Russell Gibson, with aliases, since he had been identified as a party occupying an aparty ment at 3912 Pine Grove Avenue. At approximately seven o'clock P.W., January 8, 1935, this Agent, together with Mr. Connelley, proceeded to S912 Pine Grove Avenue, where we first visited Special Agents Brown, McKes and McLaughlin in an apartment being used for the surveillance of Russell Gibson. It was determined that the raid would not take place immediately and Mr. Connelley instructed this agent to proceed to a point where the alley behind the apartment located at 3912 Pine Grove Avenue joins Irving Park Boulevard, and to swait the arrival of Special Agents Abbaticchio, Myers and Williams. It had been ascertained that the car being used by Russell Gibson had left the apartment at 3912 Pine Grove Avenue and it was decided that all agents would await the return of said car to the alley behind 3912 Pine Grove Avenue before making the raid. Mr. Connelley instructedthis Agent to tell Agents Abbaticchio, Myers and Williams to remain in a somewhat concealed position and to swait the arrival of the car used by Russell Gibson before blocking said alley with a Division automobile to prevent the escape of Russell Gibson by that route. Agent gave these instructions to Agents Abbaticchio, Myers and Williams and remained with said Agents for perhaps two hours; Agent Brown then joined the above mentioned Agents stating that it would be advisable to move our car to a position approximately two blocks distant from the elley in which the Russell Gibson car was to return. This was done and said Agents were informed that they should await further instructions from Mr. Connelley.

At approximately 11:00 o'clock, Mr. Connelley approached the car occupied by Agents Abbaticchio, Myers and Williams and this Agent and advised that Russell Gibson had returned and this Agents mentioned, except Agent McIntire, should proceed to all Agents mentioned, except Agent McIntire, should proceed to the alley adjoining Irving Park Boulevard for the purpose of the alley adjoining Irving Park Boulevard this Agent that he blocking any escape. Mr. Connelley advised this Agent that he should join him in hitting the door of the apertment occupied

by Russell Gibson. It was intended that those hitting the door should be Mr. Connelley, and Special Agents, Brown, McIntire and McKee. Accordingly, this Agent proceeded to S912 Pine Grove Avenue with Mr. Connelley, at which place we were joined by Special Agents Brown and McKee, who were equipped with submachine guns. This Agent was equipped with Division owned super-38 automatic, while Mr. Connelley was also equipped with the same type of gun.

The apartment accupied by Russell Gibson and his wife was observed to be registered in the name of Reed on the mail box located in the vestibule of the apartment house. When this was ascertained, Agents Brown, McKee and McIntire were stationed in front of the glass door, which is the only egress from the front of the building, for the purpose of apprehending those who should come down; who were in any way connected with Russell Gibson. At this time Mr. Connelley phoned through the tube phone to the apartment occupied by Russell Gibson, whereupon the phone was answered by a woman. Mr. Connelley asked this woman if Mr. Bolton were in. She replied that he was not in and would not be in until perhaps the end of the week. Mr. Connelley then advised this woman that he was a government officer from the Department of Justice and that the building was completely surrounded by Agents of said department. He ordered her to come down with her hands 1988 1888 up, and all other persons in the apartment to do likewise, order ing them to come down one at a time. He also asked if there were any more in the apartment, to which she replied that there were not. After the first order to come down, Agents waited and received no response. Mr. Connelley again called through the tube phone and again demanded that all persons occupying the the apartment with Russell Gibson come down immediately or the place would be gassed. Agents again waited, with no response, and for the third time, Mr. Connelley again demended that all persons occupying that apartment come down, with their hands high in the eir, one at a time and surrender. Mr. Connelley warned parties in said apartment that no escape should be attempted through the rear, in view of the fact that the place was surrounded and that those attempting to escape would certainly be killed. After this order and warning two women came down the steirs and approached agents Brown, McKee and McIntire. These women were later identified as Mrs. Russell Gibson and Ruth Heidt. This Agent, upon instructions from Mr. Connelley, commarded the said woman to lie down on the floor with their hands forward so that no attempt would be made to assault Agents. At this time Agent searched each woman carefully to be sure that neither had any concealed weapons. Shortly thereafter a man came down with his bands in the air. He was also taken into

custody and placed on the floor as the women were placed. No weapons were found on him. At this time Mrs. Gibson admitted her identity as Clera Gibson and Agents asked her if there were any others in the apartment. She admitted that her husband who was known to this office as "Slim" Gray, was in the apartment, and admitted his identity under that name. Almost to incidental with her statement that her husband was in the apartment, this Agent heard shots fired from the rear of the building, at which time Mrs. Gibson acreamed "Oh, they have shot my husband." In the belief that Russell Gibson might yet be in the apartment after having been shot, Agent permitted her to go to the tube phone and attemptto persuade him to come down and surrender. She received no response after several frantic attempts to reach her husband through the tube phone:

At this point agent heard Mr. Connelley eall to special Agent Sullivan. He then ordered Agent Sullivan to gas the place. This Agent did not see the gas gun exploded by Agent Sullivan, but he did hear the shot and smelled the gas thereafter. In the belief that the Agents in the rear of the apartment located at 5912 Pine Grove Avenue had the situation well in hand as far as Russell Gibson was concerned, and in the further belief that no other subjects were present in the spartment of Russell Gibson at that time, Mr. Connelley instructed this Agent and Agent Sullivan to take Mrs. Russell Gibson and Ruth Heidt to the Chicago Division office. This was dome.

The following is submitted by Special Agents J. C. White and
A. P. Barber as to their activities on the night of January 8, 1935:

As per your instructions on the night of January 8, 1935, Agents were stationed at the Korthwest corner of the apartment house at 5912 Pine Grove Avenue. About 11:15 P.M. Agents noticed a man come to the window in the first floor apartment and adjust the window, putting a tin ventilator in and pulled the window shades down and turned out the light. About 11:20 P.M. some one came out of the rear door of the apartment on to the platform and shook a mop and reentered the apartment and shut the door behind him. At this time agent White took a position at the westerly end of the garage, which is just north of the spartment building and directly apposite the rear stairway and in back of the property line partition fence and Agent Barber took a position on the easterly corner of the same garage. About 11:30 P.M. Agent White noticed some

one turn the light but in the rear of the speriment and a few seconds later he began fumbling with the door latch, opening the door and coming slowly and cantiously down the stairway in the rear. When he came down within a few feet of the bottom of the stairway, agent white noticed that he wascarrying a gun in his hand which appeared to be a shot gun and that he was wearing a blue or black vest, white shirt and was beautheaded, and upon sellingto him to stop, he pulled the gun and and fired and agent white fired on him, firing six shots in all. Agent white is of the opinion that Gibson fired at least two or three shots, one of his bullets sounded as if it hit the fence which was immediately in front of agent white. It sounded like some one falling on the pavement at the foot of the stair-

Agent Barber immediately fired a gas shall through the apartment window. Later when Agents White and Barber looked over the fence, there was noticed a Browning automatic fifle lying on the bannister at the foot of the steps leading from the rear of the apartment. This rifle was picked up by Agent Barber and an empty shell was ejected from the chamber. A magazine containing several cartridges was taken from the gum. Later Agents Barber and White heard growns coming from near the foot of the stairs and on looking out into the alley saw a man lying prone on his face wearing a white blood-stained shirt.

After Agents assured themselves that the man was mortally wounded, Agents approached him and upon asking him his name he stated that he was Russell Gibson. Immediately subsequent to this he was placed in a Division car and accompanied by Agents Abbaticchic and Myers was taken to the nearest hospital. The Browning automatic rifle that was picked up at the foot of the stairway was brought to the Chicago Division office and identifying marks were placed on this rifle by both Agents.

Agent Barber fired two more gas projectiles into the Northwest window in an attempt to cause anyone else still remaining in the apartment to come out. Due to the position taken by agent Barber at the Southeastern corner of the garage on the premises just North of the apartment, he was unable to observe anyone leaving the rear kitchen door of the apartment, his observation being concentrated upon the two windows on the northwest side of the apartment.

Agent Barber, upon exemining the rear stairway and law mediate area in that vicinity the following morning discovered that Gibson had fired four shots from the Browning sutmenties rifle. One of these shote was fired on a horizontal streetsen about five fest shows the ground; striking the partition fence. penetrating the fence, striking the brick wall of the garage, and ricocheting directly East toward the position where igent Barber was stationed. The second bullet struck the corner of the apartment which is extended out to make room for the rear stairway and was fired in the same direction at about the same distance from the ground. The two other shots were fired through the lower first and second steps of the rear stairway and penetrated the cement sidewalk, which serves as a foundation for these stairs. The lead pellet of a 351 calibre rifle stripped of its middle jacket was removed from the railing of the rear stairs by this agent at this lime. Particles of one of the pellets fired from Gibson's gun was also removed from the cement beneath the bottom step as well es a discharged .351 calibre cartridge which was found on the cement walk just north of the wooden partition fence. These articles were brought to the Chicago Division office and placed in an envelope with proper identifying data and turned over to Special Agent in Charge E. J. Connelley:

The following is submitted by Special Agents A. D. Mehegan and Hicks as to their activity on the evening of January B. 1935;

"Special agents R. H. Hicks and A. D. Mehegan, under instructions, proceeded to 5912 Pine Grove Avenue, arriving on location at about 8:00 P.K., Tuesday, January 8, 1935. The post assigned was at the Southwest corner of the spartment building located approximately at the dead end of alley running north and south in the rear of the building.

At about 9:30 P.M. word was received to return to our Division car, which was done. Aposition wasthen taken up with the car on Pine Grove Avenue, south of Sheridan Road,

At about 11:00 P.M. word was received from Mr. Connelley that the apartment of "Slim" Gray was about to be raided. Thereupon, agents Hicks and Mehegan returned to their original post.

At about 11:30 P.M. a heavy intonation was heard, followed by firing of smaller calibre ammunition. Seeing no one trying to escape past Agents' post they proceeded carefully

into the alley and noted a man on the ground near the northwest and of the apartment building. He appeared to be wounted to be a ser be brought around to pick up the wounded man. Agent Mehegan asked igent Hicks to get the hivsion car and bring it to the alley. Hicks departed for this purpose. A few minutes thereafter, however, another Division car appeared in the alley driven by Special Agent R. J. Abbaticchio, Jr. The wounded man was then placed inthis car and driven away. After the car left, igent Mehegan took up a post at the northwest corner of the building for a period of about thirty minutes. Agent Hicks did not again appear in the alley.

At about midnight division Agents were noted in the apartment of "Slim" Gray. Agent Mehegan followed in the apartment shortly thereafter, and discontinued duty at about 1:00 A.M. January 9, 1935, aron instructions.

By Agent Hicks: After leaving Agent Mehegan I proceeded to the front of the apertment building at 5912 Pine Grove Avenue and was there instructed to transport prisoner Monty Carter, who was in the custody of Agents J. T. McLaughlin and A. P. Barber. The prisoner was taken to 1900 Benders Building, in company of Agents McLaughlin and Barber. Agent Hicks was then instructed to return to 3912 Pine Grove Avenue, which he did, in company with Agent John Madala. Various articles were picked up in the apartment of Slime Gray and brought to 1900 Bankers Building, and placed in the custody of Earry Wild. This was about 2:30 1.M., January 9, 1935. From that time until about 7:30 1.M., 1/9/35; Agent Hicks engaged in guard duty at the office, after which he discontinued upon instructions.

In the above described operations Agents Hicks and Mehegan were armed with shotguns."

The following is submitted by Special Agents J. L. Madala and R. C. Suran as to their activities on January 84 1935;

Pspecial Agents R. C. Suran and J. L. Madala, on January 1935, while maintaining a surveillance of the rear of the apartment located at 3920 Pine Grove Avenue, Chicago, Illinois, from the second floor apartment located at 722 Sheridan Road, observed at about 9:45 A.M. a light brown Chow dog in the alley, which dog was recognized by these agents as being the one which had been frequently seen coming from the apartment of J. B. Bolton. At this time agents saw a man who appeared to be dressed in a bathrobe standing on the porch of the Bolton apartment. For an instant he looked around the corner, and Agents observed that he had a thin face and medium brown hair. However, no identification could be made in view of the distance between him and Agents.

After the man entered the apartment, Agents contacted Paul Lenco, janitor at Soll Pine Grove Avenue, who had passed him while the party in question was standing on the porch, and he selected the phobgraph of Russell Sibson elias Slim Gray as elosely resembling the man whom he had seen on the porch.

At 11:00 A.M. the same day Agents observed a dark haired woman wearing a brown mink cost leave the spectment.

woman wearing a brown mink coat leave the apartment in question with the above mentioned thow dog and proceed Borth down the

At 11:15 A.M. Agents observed this women return to the spartment, at which time she was driving a 1934 model Ford Vel seden, bearing Illinois license plates No. 1-266-251. This car had been frequently seen in the vicinity of 5980 Pine Grove Avenue as well as 432 Surf Street, at which place Mildred Kuhlman, paramour of "Doc" Barker, was residing under the name of Mrs. A. R. Esser. Upon arriving in the rear of the apartment agents observed a tall, slender man, who answered the description of Russell Gibson alias Blim Gray come out of the apartment, step into the car and drive ever with the dark heired roman above mentioned.

At 1:20 P.M. the above Ford V-8 returned and Agents observed

that the dark haired woman was alone at this time.

At 3:00 P.M. the dark haired woman and another goman, who had blonde hair and was dressed in a blackcloth coat with light fur collar left in the Ford V-8.

At 4:05 P.K. while Agent Madala was on Sheridan Boad, he observed the instant Ford car stop on the West side of Sheriden Road and observed the dark heired woman leave the car and proceed Hoad and observed one to a tailor shop located at 715 Sheridan Road. She remained in this shop for about ten minutes and returned to the car, after which they drove away. While the car was parked on Sheridan Road. Agents passed the same and noticed that the blonde woman above mentioned was in the driver's heat and that there were two large pasteboard boxes which appeared to be empty lying on the rear seat of the care

At this time Agents telephoned E. J. Connelley at the Chicago Division office and advised him of the above and that it appeared that the people in the Bolton spartment were going

At 5:45 P.M. Agents observed two men leave the apartment and drive evay in the Ford V-8 weden. One was a tall, elender man answering the description of Russell Gibson. The other was a shorter, heavier set men. Both were dressed in dark costs and derbies.

To further individuals were observed until 6:05 P.M. when the man answering the description of Russell Bibson returned alone in the car previously described. At 6:45 P.M. this individual, together with the dark haired woman, loaded some boxes and suitcases into the Ford, after which they drove away.

Agents did not observe anyone again until 11:00 P.M. when a man was seen walking down the alley towards the epartment. Due to the darkness, Agents were unable to determine in what manner this individual was dressed. He disappeared into the areaway located on the north side of the building, and a few seconds later Agents observed the kitchen light go on in the Bolton apartment.

Agent in Charge Connelley by Agent Madala, who was at that time stationed in an apartment located at 3916 Pine Grove Avenue. Agents Madala and Suran were instructed to remain in their apartment at 722 Sheridan Road and to cover the rear of the Bolton apartment from that point, as at that time Mr. Connelley advised that the place would be immediately faided.

A STANDARD AND SOLD AND A STANDARD A few seconds prior to 11:35 P.M. Agents observed other agents surrounding the apartment from the rear. At about 11:35 P.M. agents heard a sharp report of a gun, and shortly thereafter they heard what seemed to be machine gun fire end also heard the falling of broken glass. A few minutes later Agenta heard a loud groan, which appeared to come from the areaway located on the North side of the building in question. Immediately thereafter a tall men in shirt sleeves was seen staggering across the alley through a gate into a vacant lot.
Upon reaching the gate, agents called "Halt", as did several other agents stationed in the vicinity, This individual was told to go back to the alley, which he did, falling immediately outside of the gate through which he had previously entered. Special Agent McLaughlin then approached the individual and asked him if he were Alvin Karpis, and he replied "No, Russell de Gibson". About five minutes later a Division car appeared in the dley and Gibson was removed from the scene. Agents Madala and Suran then left the apartment and went to the alley and maintained a watch of the rear of the apartment until Division Agents were observed in the Bolton apartment.

The writer, with Special Agent L. V. Boardman, was detailed to cover the open space directly in the rear of the

tailed to cover the open space directly in the rear of the spartment building at 5912 Pine Grove, this spot being one from which all the windows on the west side of the apartment occupied by Russell Gibson sould be plainly observed. There was a small garage about 40 fest from these windows and the was a small garage about 40 fest from these windows and the writer and Agent Boardman stood behind this garage. Between this garage and the apartment was an alleymay and there was a board fence about four feet high between Agents and the alley.

At approximately 11:30 P.M. the hight of Jamusry 6. 1935, a woman's voice was heard in the apartment which sounded rather loud as though she were talking through a speaking tube. At this time all the lights were on in the apartment. and all curtains were drawn but there was a slight space between the curtains and the lower sill of the window in the kitchen and people sould be seen passing this window. It soon as the woman's woice was heard on the inside of the aparts ment, man without a cost or hat peaked out around the curtain in the kitchen. At that time this agent took aim at this window. This person left the window and went into what apperently was a sittingroom, this window being the one further south in the apartment and at that time tried to open the window. This was the same man who looked out the kitchen window and the one whom Agent now knows was Russell Gibson; The although it was not certain at that time who the person was. As he tried to open this window Agent took aim at his head, but did not fire as his identity was not certain and it seemed. best to wait until he actually tired to get out of thewindower It was apparent that this person could not get the window open more than ten inches and he then went into the kitchen and the lights were turned out in the kitchen. Almost immedlately thereafter agent heard a door open, this door being on the north side of the building and out of view. It seemed a considerable time after the door opened before any shocking started and the writer felt that possibly the man had sneaked out of the building. However, there was soon a volley of shots

fired, the loudest one secuing to come first and knowing the i tion of Agents Thits and Barber, whe were on that side of the builded in and knowing the guas that they carried the writes was bost-tipe that the long report came from another gun than theirs at almost the same time this lond report sounded there was a vol of shots which did not make as much noise. It that time some parson started groaning very loadly. It seemed possible that one of the Agents had been injured but as it had been reported that there were three men in the apartment it seemed best for this Agent to remain at his post; after approximately two minutes, during which time the moening was going on, a man in a white shirt, without a hat, staggered around the corner of the building across the alley and out into the yetant lot which Agent and Igent Boardman were covering. Aim was taken at this man's head, but it was rether obvious that he was very badly wounded and he was not carrying any weapon at that time. Command was given him to get back in the alley and lie down, This he did. The writer did not feel at that time as though he should move from his post for fear other persons would appear from the apartment. However, after a period . of a few minutes some Agent yelled at the man lying in the alley and asked if he was Russell Gibson. He replied that he was. Shi Agent then approached the spot where Gibson was lying, at all times keeping a watch on the back door and windows of the aparte ment in case any other person should appear.

At this time agent Barber fired gas into the apartment and soon thereafter Special agent in Charge E. J. Connelley and detectives from Chicago Police Headquarters entered the apartment. Gibson was loaded into an automobile and sent to the hospital.

Avenue and Irving Park Boulevard, at approximately 7:30 P.M. on Jenuary 8, 1955. Just prior to the shooting, that is, about 11:50 P.M., Agents placed the ser scross the south of the alley and covered the alley on foot with two riot guns and revolvers. During the whooting several squad cars, containing thicago police, arrived at the mouth of the alley Agents immediately informed them of our identity. There was no difficulty with the police, who alighted from their tark and remained behind them near the mouth of the alley during the shoting. No one came out of the mouth of thealley during the period that Agents were there.

At about 11:40 P.M. several of the Agents who were at this time in the alley in the rear of Sol2 Pine Grove Avenue, called to us to bring the car down to them. Agents Myersand Abbaticchio drove the car down the alley and observed a man lying on his right drove the car down the alley and observed a man lying on his right aids in the alley. Agents were told that this was Russell Gibson, alias "Slim" Gray, who had been shot and to take him to a hospital accordingly, Agents placed Gibson in the back of the car and together with officer John Maturi of the Seth District, Chicago Police, drove him to the American Hospital, located at 850 Irving Park Boulevard. Agents placed him in the hospital at approximately light giving his name as Jack Schwartz.

Gibson's clothing was removed and he was treated by Dr. J. L. Dismond, the doctor on duty in the emergency room, the latter immediately summoning the shief hospital staff surgeon. Dr. Homer S. Warren, Jr. Dr. Warren; upon arrival, advised Agents that Sibson appeared to be mortally wounded, apparently by a 445 calibre bullet, which had entered his back, piercing the right side of his liver and the lower portion of his right lung, and coming but dia rectly in front of his abdomen. Gibson was conscious during the ride to the hospital and, in fact, until his death at 1:40 A.M., January 9, 1935. He was repeatedly questioned by Agents with the assistance of Dr. Warren, relative to the Bremer kidnaping and all of the subjects therein; however, he denied knowing Bremer, either of the Barkers, Karpis, Volney Davis and would answer no questions relative to this case. Gibson was informed by the doctor that he was probably dying, and in response to the doctor's request that he enswer questions relative to the Bremer case, he replied Tell you nothing

The only admissions made by Gibson prior to his death, which were made shortly after entering the hospital, were that he was "Slim" Gray, that his wife was named "Clara" and that he had no people anywhere. He later admitted that his real name was Russell Gibson and that his wife's name was Clara Gibson. He was under the

impression during the treatment by Mr. Warren that the doctor was not trying to save his life and repeatedly stated to the socior that he was not doing anything for him. Sibson was pronounced dead by Dr. Marren at 1:40 i.M., he pefore stated; and this included formation was immediately telephoned to Mr. Burvis at the Chicago office.

Upon Mr. Purvis instructions, Agents, in Division car, followed the morgue wagon which transported Gibson's body to the Gook County Hospital morgue, where it was received at 2:30 1.M. The body was transported by police officers Oscar Ellison and Edward Flannery of the 38th District. The body was given the number "January, 45" at the morgue, and Agents were advised that the coroner's physician at the morgue, Dr. Jerry Kearns, would perform the autopsy at approximately 9:30 A.M., January 9. Agents left a note for Dr. Kearns requesting that he await the arrival of a representative of the Division before performing the autopsys

The following is submitted by Special Agent E. H. Williams as to his activities with special agents abbaticohie end hyere on the evening of Jamery 8, 1985;

*Agent, accompanied by Special Agents B. J. Abbatlechie and

T. E. Myers, was ordered to proceed to Irving Park Bonlevard, Schingson on January 8, 1935, at about 7:00 P.W. and there to Chicago, on January 8, 1935, at about 7:00 P.M. and there to block the alley which runs in the rear of 3912 Pine Grove Avenue and which joins Irving Park Boulevard

Agents, in a Government owned automobile, arrived atthis place at about 8:00 P.M. and remained in the vicinity until about 10:30 P.M. Shortly thereafter Agent received orders to be ready to block thealley and shortly thereafter this was each Agent took a position to cover said alley in the event that the party or parties in the apartment at 5912 Pine Grove Avenue should resort to the alley as a means of escape. At about 10:45 or 11:00 o'clock Agent heard a number of shots fired in the vicinity of the apartment at 3912 Pine Grove Avenue. It seemed as though there were about six or eight shots. varying from a rifle to a shotgun. Shortly thereafter agent was called to bring the car down the alley to the apart - 187 ment. The car was driven by Special Agent Abbaticchio, accompanied by Special Agent Myers. Agent proceeded to the apartment on foot and arrived there just before the body of Russell dibson alies "Slim" Gray was picked up and put in the car

Upon the arrival of agent, he observed Gibson lying in the middle of the alley about opposite the arraway alongside of the apartment at 3912 Pine Grove Avenue. From appearances agent abserved that Gibson was shot through the head and through the body, and possibly through his left arm. Gibson was removed from the alleyway and placed in the Division car, which had been driven there by agent Abbaticchie, and upon being informed by a police officer that the nearest hospital was the American Agents Abbaticchie ami Myers drove with the body of Gibson to the American Hospital.

Agent went into the apartment recently occupied by Gibaca and observed numerous weapons, including a machine gun, high-powered rifles and ammunition. The apartment was filled with tear gas and very shortly thereafter Agent was ordered to return to the office.

The following is submitted by Special Agent R. C. Buran as to his activities together with Special Agent B. K. McKes, particularly with reference to their recovery of Ford Victoria automobile and Ford V-8 sedan automobile observed in the possession and use of Russell Gibson, at al. These two automobiles, as has been noted, have been taken into Division custody and are now stored at the garage with other ears of the Chicago Division office. Suitable arrangements will be made in the near future as to a court order confiscating such equipment and turning same over to the Division for official use, both being automobiles in good condition:

During the course of the search on January 8, 1935, of the apartment previously occupied by Russell Gibson and others, 5912 Pine Grove Avenue, Chicago, Illinois, Special Agent R. C. Suran found in the desk drawer in the living room of this apartment. A Sertificate of title of a motor vehicle #1289927 issued to Andrew Allen, 57 East Harrison Street, Chicago, Illinois, for a 1934 Ford Victoria, engine #1142465, together with an invoice of the Vrba Motor Company, 5100 West 25th Street, Cicero, Illinois, and a receipt from Edward J. Hughes, Secretary of State, deted November 26, 1934, for license plate #1289927.

agent Suran also found in this desk two receipts made out to J. B. Bolton, one bearing date December 1, 1934, and the other

The transfer of the contract of the first of the first of

January 1, 1935, each being for the amount of \$8.00 for the rent of a garage. The receipts are signed by \$1. Lipsietz and were up the receipt alips of Charles Lipsietz, Real Estate, 5936 pine Grove Avenue, Chicago.

Charles Lipsicts at 3936 Pine Grove Evenue and he stated that on or about December 1, 1934, he rented a garage to 7, B. Bolton which garage was located in the group of garages at the rest to 53936 Pine Grove Avenue. The photographs of various individuals in this case were exhibited to Mr. Lipsictz and he stated the one of Willie Harrison was a likeness to the person renting this garage. Mr. Lipsictz said this individual did not pay the rent January 1, 1935, but the same was paid by a blond beaded woman. Mr. Lipsictz pointed out the garage to Agent, and through observation by the rear window, Agent determinades that the garage contained a Yord Victoria bearing 1934 Illinois license plate No. 1289927.

On the night of January 8, 1935, Special Agent A. P. Barber found a key, which expected to be the garage key, near the bottom of the stairway where Russell Cibson was wounded. Exected Agent S. K. McKee found at this place a set of keys which appearently belonged to the Ford car. After the discovery of the Ford Victoria located in the above described garage, it was determined that the key found by Agent Barber was akey to the garage in which the Ford Victoria was located, and the key found by Agent McKee and Suran at the Clark-Van Buren Garage on January 10, 1935.

On the night of January 8, 1935, Agents McKee and Buran provided coeded to the Paddington Garage located at 702 West Irving Park Chicago, as previous observation by Agents Suran and Madala had revealed Ford sedan \$1266231 was apparently stored in the near vicinity of 5912 Pine Grove Avenue, it was determined by observation of the cars in the Paddington Garage that the car in question was stored that evening by a tall alim man accompanied by a black haired woman. He advised that the car had been stored on previous days, but always by a woman and January 8, 1935, was the first time the tall slim man had brought the car into the garage.

In the dash compartment of this car Agents McKee and Suran found a leather case containing State of Illinois certificate of title of a motor vehicle, bearing #1266231, issued to J. B. Bolton, Harrison Hotel, Chicago, Illinois, for a 1934 Ford sedan,

engine \$1150845, and invoice of the Pros Motor Company \$200 West 25th Street, issued to J. B. Bolton, Harrison Hotel, Shicago, Illinois, which invoice was for a Ford Buluxe four door sedan, black, motor No. 1150843, indicating that \$717.00 was received for the above car on September 27, 1954. The invoice was signed by H. Johnson.

Also found in this leather case was a repair bill from the Litsinger Motor Company, 913 West Jackson Boulevard, Chicago, Illinois, made out to J. B. Bolton, Harrison Hotel, Chicago, Illinois, dated August 5, 1934. The car on which the repairs were made bore license \$1-266-251, and motor No. 1130845, speedometer mileage 1385. It will be noted that the date of this repair bill is prior to the date of the purchase invoice for the same car. In additional invoice for repairs was found in this leather case from the Shanesy Motor Co., Inc., 2881. Sheffield Avenue, dated November 19, 1934.

A vehicle license from the City of Chicago issued to J. B.
Belton, 57 Rast Harrison Street and a photographic copy of
a certificate of ownership issued to J. B. Bolton Harrison
Hotel, for the previously described Ford medan was also found in the leather case. This car was stored in the Clerk-Van
Buren garage on January 9, 1935, by Special Agents McKee and
Suran

January 10, 1935, there was also found in the seat by Special Agents McKee and Suran a set of Illinois license plates, 1934, 3310-949 which plates were wrapped in a newspaper. Inquiry at the Secretary of States office, Chicago, Illinois, revealed that these were issued to Marvin Melson, 1815 Heith Avenue, for a Ford, motor No. A5312366. Inquiry at the Auto Theft Detail of the Chicago Police Department revealed that these plates were reported stolen on October 27, 1934, at 18:55 P.M. by John Mhitlock, 613 South Marshfield Avenue, Chicago, it being noted that oral inquiry at the Secretary of State office that they were issued to Marvin Nelson, it was ascert tained, however, that they were in reality issued to John Whitlock.

The above cowers in substance the activity in the vicinity of 3912 Pine Grove Avenue, on the night of January 8 and the early morning of January 9, 1935. Hereinafter will follow the activity of the various agents assigned to cover 432 Surf Street, which resulted in the apprehension of Arthur H. Barker and Mildred Kuhlman.

The following is submitted by special agent

o his activities on the might of January 8, 1935.

"On the afternaon of January 8, 1935, the writer and agent W. S. Ryan, who with Agent Campbell, had been mainball. ing a surveillance over the apartment in the southwest wing the the Surf Lane Apartment Building at 452 Surf Street, Chicago Illinois, and which apartment was occupied by Mildred Languest and a man supposedly "Doc" Barker under the name of Mr. and Mrs. A. R. Esser, from a third floor spartnent in the Northeast sorner of the building observed two men leaving the apartment entrance to Mildred's spartment. The writer and agent Ryan were both agreed upon the identity of the teller man of the two as being "Slim" Gray and the shorter man as being "Doc" Barker.
The writer telephoned Special Agent in Charge E. I. Con-

nelley and informed him of this, and was told that a raid had been planned on the apartment located at 5912 Pine Grove Avenue, and directed the writer to cover Mildred's apartment from both; rear and front. The writer was further told that in the event anyone left the apartment before the contemplated raid on 432 Surf Street was staged, to take into custody any persons who left Mildred's apartment.

Igents Jones and Walsh came to the spartment from which Agents were maintaining surveillance and were expecting Agents Lorry, McDade and Gillespie as added reinforcements. Prior to the arrival of these latter named agents, agents Jones and Ryan placed themselves in the storage roomin the basement below Mildred's apartment to cover the rear entrance to Mildred's apartment. Agent Chaffetz was left in the apartment occupied by igents to guard the guns and the writer and igent Campbell went to the front of the apartment building and covered the front entrance to Mildred's epartment.

At approximately 6:50 P.M. the writer and Agent Campbel 1 observed Mildred leave the apartment by way of the front entrance. in company with the shorter man who had been living at the apart.
ment for the past five or six days, and whom agents believed to
be "Doc" Barker. They came out on Surf Street and started to walk west on Surf. The writer and Agent Campbell alighted from the car in which they had been covering the front entrance and followed Mildred and "Doc" Barker for a distance of approximately fifty feet, being about fifteen feet behind them. "Doc" Barker

suddenly turned around and stood for a few seconds, looking master on Surf Street and directly towards the writer and agent Composition the moment he turned, the writer phouted, "Stick them up, so re rederal officers. Barkey immediately attempted to ran ecross. Surf Street between two parked sutomobiles and had taken a couple of atops when he slipped on the lay curb and fell Tlat on his face. The writer, agent Campbell and agent Jones, who from his becoment vantage point had seen "Doc" and Mildred go by, followed by the writer and agent Campbell, covered Barker with their side arms and Mildred, who had taken a couple of steps west on Burf Street, was grabbed by agent Gillespie, who had arrived on the scene, being part of the reinforcements sent out by Special Agent in Charge Connelley. Agent Jones placed handcuffs on "Doc" Barker and he and Mildred were taken to the apartment occupied by agents on the third floor of the Surf Lane apartment building. There

The Chicago Division office was called, and Special Agent in Charge M. H. Purvis was told that "Doo" Barker had been taken into custody and was being held in the apartment occupied by agents at the Surf Lane Apartments and agents were directed to bring "Doo" into the office, 1900 Bankers Building, which agents Campbell Jones, Chaffetz and the writer did.

Barker was asked as to his identity; and he replied, wou know who I am, you know who you're picking up", and refused to may who he

A key was taken from "Doc" Barker while he was held at the Surf Lane Apertments, and Agents, upon entering Mildred's apartment, found therein an automobile trunk which sontained a Thompson submachine gun, a bullet proof west and two clips for a monitor raftle.

submachine gun, a bullet proof vest and two clips for a municur rafte. The following is submitted by Special Agent W. R. Walsh as to his activities on the night of January 8, 1935;

"On January 8th, at about 6:30 P.M., Agent R. L. Jones and B. Talah reached 452 Surf Street. Chicago, to assist

*On January 8th, at about 6:30 P.M., Agent R. L. Jones and Agent W. R. Walsh reached 452 Surf Street, Chicago, to assist in the possible apprehension of Arthur R. (Doc) Barker, I.O. Mo. 1219. Upon arriving here Special Agent Walsh was assigned to a squad made up of Agents Campbell, Muzzey and himself and detailed to watch the front of the building. After several minutes a man and women left the building and Agent Walsh tried to call the attention of Agent Campbell to these people to identify them, but he and Agent Muzzey had seen them and signalled to Agent Walsh that they were the wanted parties, although

Barker at this time was walking west on Eurf Street and was about 50 feet from the entrance to the apartment where he had been living and geemed to be suspicious of being followed and he stopped and turned part way around while his woman companion later identified as "Millie", kept on far about 10 feet more and then stopped.

Agent Campbell had a Thompson sub-machine gum under his overcoat and Muzzey and Agent Walsh had pistols. They approached Barker, identified themselves as Federal officers and ordered him to surrender. He slowly raised his hands and apparently then became frightened, tried out and turned as if to fiee. He was ordered to halt and at that instant he slipped and fell in some mud between the walk and the curb after taking not more than two steps and upon being ordered not to move any further, upon severe penalty, he said he would not. Agent Campbell then assisted Barker to his feet and by this time Agents Ryan and Jones, who were covering the rear entrance and who were concealed in a room in the basement about 15 feet from this action, heard our orders to Barker and arrived on the scene and Jones handcuffed him.

All the above named Agents and Berker and his compension and Agent: Gillespie, who arrived from the office just as the apprehension took place, end who detained the woman, went to apartment 509 at 432 Surf Street, where this plant had been maintained, until arrangements were made to transport them to 1900 Bankers Building.

Although Barker had been "frisked" for weapons while on the street another search was conducted at the apartment without revealing any on him or his companion.

Agents Lorry and McDade, who had arrived from the effice went with Gillespis to search Barker's apartment, G-2 at 435 Surf Street, on the same court with 432, and maintained under the name of Esser. Here, among other things; a Thompson, submachine gun and two loaded drums were found and these articles were brought to the office by Agents Jones and Campbell and Muzzey when Barker was brought in. Agents Ryan and Walsh guarded "Millie" until she was transported to the office.

Later the same Agents brought Millie to the office.

Surveillance was maintained by Special igents Eyan,
Muzzey and the writer from apt, 4509, 432 guit street of apartment in the same building for a period of approximately one week. The apartment under surveillance was escupied by Mr. and Mrs. A. R. Esser, later ascertained to be Arthur R. (Doc) Barker and Mildred Kuhlman, These parties were observed entering and leaving the building at various? times in company with a man later known to be Russell Gib-

son alias Slim Gray.

On the night of January 8, 2935, the writer received instructions from Special Agent in Charge Connelley to select & squad of men and to cover the outside of the sparts ment building and to apprehend any persons leaving the aparta ment under surveillance, Agent Jones, in charge of a second aquad, in company with agent Ryan; secreted themselves in the the basement of the building. The writer with Agents Muzzey and Walsh proceeded to the opposite side of the street directly across from the apertment entrance.

This Agent does not remember the exact time, but after remaining in the positions as above described, a short while, a man and women (Mr. and Mrs. Esser) came out of the aparts ment and walked toward the sidewalk. This agent crossed the street and walked in the apartment court entrance, meeting the man and woman as they came out. Identifying them as the parties wanted, Agent turned and started west on Surf Street. following the couple. Agent Muzzey, who was in a Division car in the street, stepped onto the sidewalk and said "Are we want going to take them?" The writer answered "Yes", walked to the end of the apartment building about twenty feet behind the man and woman, stepped into a small alleyway leading to the basement and took a gun from under his coat. At this time? Agents adverced upon the subjects and when a few feet away the man (later found to be Barker) turned as if to run, but fell on the parking.

Agents immediately covered him with guns and Agents Jones, Ryan and Walsh came up and the subject was handcuffed. The women was taken into custody by Agent Gillespie who was walking east on Surf Street and both subjects were taken to Agents'

This agent accompanied Special Agent in Charge Connelley and other Agents on raids of two houses said to have been fracturented by members of the Barker-Karpis gang, and brought occupants of these houses to the Chicago Division office for questioning.

Special Agent W. C. Ryan reports as follows as to his activity on the might of January 8, 1955: And Advantage of Tanaary 8, 1955: And Advantag

"Following the receipt of instructions from you that the front and rear of the apartment of Mr. and Mrs. A. R. Esser should be covered with a view of seeing that no one left the spartment, pending the outcome of the raid at 5920 Pine Grove Avenue, the writer accompanied Special Agent R. L. Jones to St. the storeroom in the basement of the spartment for the purpose of covering the rear. Shortly after the writer and Agent Jones had taken a position overlooking the rear entrance, the writer noticed Special Agent Campbell, who with Agents Muzzey and Walsh was covering the front entrance, take his machine gun from beneath his overcoat and proceed west on Surf Street 🕾 at almost the same moment the writer heard the voices of Agents on the outside commanding some one to put their hands up. The writer and Agent Jones immediately ran from the besement to the sidewalk and assisted Agents Campbell, Muzzey, Walsh and Gillespie (Agent Gillespie having arrived on the scene at the moment of the arrest) in bringing "Doc" Barker and his lady friend to the apartment occupied by Agents at 452 ... Surf Street. The writer immediately called Special Agent in Charge E. H. Purvis and informed him of the arrest.

"The writer and Special Agent Walsh remained at the apartment with Mildred Esser until Agents Jones and Campbell returned to take her to the Chicago Division office, after which the writer went to the apartment formerly occupied by "Doc" Barker and Mildred where the writer remained until the following evening awaiting the possible appearance of other members of the gang."

THE RESERVE OF THE PARTY OF THE At approximately 7,50 P.M. on January 8, 1935, I was instructed to proceed, in company with Special Agents W. B. Lorry and T. M. McDade to 452 Surf Street. The proper amount of guns and emmunition was secured, and we proceeded to the corner of Suff Street and Cambridge Avenue, which is about one block from the plant being maintained at 452 Surf Street According to instructions, Agents McDade and Lorry remained in Face the dar and I proceeded to the apartment to deliver instructions that Special Agent Jones was to take a sufficient number of the men and cover the front, and Special Agent Campbell was to take the belance of the men and cover the rear, leaving at least one man in apartment 509; which was being occupied by Agenta; The instructions were to cover the place and allow no one to leave the apartment then being occupied by Mildred Lonquest but to take no aggressive action in raiding the place until further instructions were received.

After parking the car, I proceeded east on the north side of Surf Street and when crossing Pine Grove avenue, which is about one-fourth block distant from the apartment building, I observed Mildred Lonquest and her companion, whom it was later learned was Arthur R. "Dos" Barker, emerge from the apartment building at 432 Surf and turn west. A short distance behind them were Agents Muzzey and Walsh, who had apparently come from the street. I then observed Special Agent Campbell a short distance behind them, Barker and the woman looked around twice, and after looking eround the second time, they turned and faced Surf Street, as though to board a taxicab or a car, At this time Special Agent Walsh was within about three or four feet of him and I was approx imately ten steps west. Special Agent Welsh drew his gun and process dered Barker to put up his hands. Barker began to put up his hands, at which time he appeared to see Agent Campbell approach. ing with a machine gun, and he made a whimpering sound and turned toward the street, starting to run. However, he took only about three steps when his foot slipped, and he fell in the Mud., putting up his hands while he was lying on the ground. Special Agents Jones

and Ryan had by that time expeared from the areaway of the building and also covered Barker. Handsuffs were then placed on Barker.

At the time igent Walsh erdered Barker to put up his hands I drew my gun and stood where I was. Mildred Lonquest backed down the street in my direction and I caught her by the arm and instructed her not to move.

Mildred Lonquest and Arthur R. Barker were then taken to the apartment occupied by Agents. Barker was searched for weapons and Mildred Lonquest's coat and pocketbook were searched. Special Agents Jones, Campbell and Muzzey then proceeded to the Chicago Division office with Barker.

Immediately after they left, Agents Lorry and McDade entered the front door of apartment G-1, which was the apartment being occupied by Barker and the Lonquest woman, and I covered the rear door. Special Agent Ryan later came to the apartment and the four of us stayed stayed in the apartment until 5.00 P.M. the following afternoon.

After entering the Barker apartment a thorough search was made, at which time Special Agent Lorry and I found a large leather bag containing onemodel 1928 Thompson submachine gun, together with two loaded drums and five clips for a machine rifle. Special Agent McDade found a .380 Automatic pistol in a handbag. During the time this apartment was occupied, no one attempted to enter the same and the doorbell was not rung by anyone.

The following is reported by Special igent M. Chaffebr as to his activities on the evening of January 8, 1969:

The following to an account of my activities at 432 Sure Stroot on January 8, 1935.

I arrived at loartment \$509 at about 11:00 L.M. in accordence with your instructions to maintain a surveillance of Mildred Ruhlman. At about noon Mildred left her apartment, at which time I attempted to follow her but she had disappeared completely by the time I got outside the apartment.

Shortly after this I accompenied you in attempting to locate the car used by "Slim" Gray earlier in the day. While waiting for you while you were making a phone call a party sho enswered the description of Fred Barker was seen by me, coming down the street from the vicinity of 5912 Pine Grove Avenue, who entered a bus which was proceeding east on Sheridan Road. This party who was seen by me answered the following description:

the party who had been previously seen with Mildred returned alone to the apartment.

According to your instructions the men at the apartment mere by up into two squads, and under instructions of Special Agent Re-Jones, who had charge of the squad to which a satisfied, I remained in the epartment to mep a surveillance over the apartment of Mildred, and also, in accordance with his instructions, hear machine gun ready should it have provennesseary to have one for any reason. I remained in the apartment alone, patching the entrance to Mildred's apartment, and at approximately 7.30 I noticed Mildred and a man who later proved to be "Dog" Barker leave the apartments. Just as they reached the sidewalk I saw Agents Campbell and Muszey come up behind them from across the street. Shortly after this, in response to a knockon the door, I admitted Agents Jones, Campbell Muzzey, Walsh, Ryan and Gillespie, who had in their custody Mildred Kuhlman and Doc" Barker.

maintained a surveillance of the entry to the apartment house, whi these two people were being searched; then, under instructions of Agent Jones, I accompanied him and Agents Campbell and Muzzey to the Chicago Division office, where I fingerprinted "Doc" Barker, and " established his identity from his identification order.

I also fingerprinted Mildred Kuhlman andlater, the other parties taken into custody by this office, in the course of the night.

In accordance with your instructions, I proceeded to the County Morgue where I fingerprinted the body of "Slim" Gray and established his identity with his fingerprint impressions appearing on his identificationorder.

Fingerprints of HUSSELL GIBSON alias Slim Gray referred to the above memorandum by Special Agent Chaffetz, were forwarded to the Division, and one copy is retained in the Chicago office.

The following is reported by Special Agents 7. M. Madade and

R. Lorry as to their activity on the night of Jamary 8, 1935:

"Special Agents M. G. Gillespie, W. R. Lorry and T. M. MoDede proceeded to 432 Surf Street at about 5,30 P.M. January B. 1955, in a Hudson automobile, to join other agents in a serveillance of the apartment occupied by "Doc" Barker and Mildred Kuhlman, agents had with them three Thompson sub-machine guns and a gas gun. The car was parked around the corner from the apartment and Agent Gillespie went to the apartment to determine the plans for the surveillance, leaving Agents Lorry and McDade in the car to watch the equipment. Shortly thereafter Agent Muzsey returned to the car, informing Agents that "Doc" Barker had just been taken, and the car was driven to the front of the building, where the equipment was removed and the car was used for the purpose of re moving "Doc" Barker to the office.

Agents proceeded to Apartment 309, occupied by the Division for surveillance, and there obtained from Mildred Ruhlman the key to Apartment G-1, which she was occupying with "Doc" Barker. Agents Lorry and McDade them entered this apartment from the front door and admitted Agent Gillespie, who had come up the rear stairway. No persons were found to be present in the apartments although several lights were burning and food was on the stove;

S. Navy, Model of 1928, from which the numbers had been removed. Agents immediately marked this gua for identification by inscribing the initials"T.L." and the date. *1-6" on the bottom of the trigger clip. Also found in this case \$ were two loaded drums for the machine gun, a bullet proof west. several empty elips for a Browning automatic rifle, and a short length of red rubber hose.

In a small black Gladstone was found a Colt .380 automatic pistol, bearing No. 115483, which had a clip and a bullet in the chamber, and, in addition, two extra loaded clips for this weapon.

In Agent Lorry's presence Agent McDede placed a mark of identifies tion on the rear part of the frame of this gum by placing two Tile marks thereon. He other weapons were found on the premises.

Agents were then joined by Special Agent W. C. Ryan and maintained an all-night vigilance in the hope that some other member of the gang would make his appearance, as it was knewn that Willie Harrison and Russell Gibson had also visited this apartment.

Under instructions from Special Agent in Charge E. J. Connelley, all the wearing apparel and household articles belonging to the occupants of this apartment were packed in the bags am suiteases which were found in the apartment and removed therefrom at 4.50 P.M. to the office. When the apartment was vacated the key was returned to the manager.

The following is submitted by Special Agent R. D. Brown, as to activity on January 9, 1935, in connection with the inquest to be held as to death of Russell C. Gibson:

"In compliance with your instructions, the writer, together with Special Agents R. J. Abbaticchic, Jr. and T. E. Myers, called at the Cook County Coroner's office this morning and interviewed Chief Deputy V. L. Schlaeger,

The facts relative to the slaving of Russell Gibson were briefly presented to him and at the conclusion he requested the names of the parties who were in the apartment at the time Gibson was shot. The names of Byron Bolton and Clara Gray were furnished him, and he was told that the name of the second woman in the apartment was not known to Agents. He then stated it would positively be necessary that Bolton, Clara Gray and the "unidentified woman" appear at the inquest at his office at 9.50 A. M. on January 10, 1935. Agent attempted to induce Mr. Schlaeger to conduct the inquest without the presence of the three above named witnesses, but he respectfully declined. He also advised that it would be necessary for Special Agent Abbatichio to be present in order to testify that he, Agent Abbatichio, was present when Russell Gibson admitted his identity.

Agents then proceeded to the office of Dr. J. J. Kearns, Coroner's physician, Cook County Morgue.

The body of Russell Gibson was brought to the autopsy room and the autopsy conducted in the writer's presence.

Dr. Kearns rendered his wordist to the effect that a bullet through the abdomen, entering just below the sostal cartilage from the right side, passed through the right lobe of the liver and out the back at the level of the eleventh ris from the right side. He are plained the cause of death to have been a homorrhage of the liver, approximately one-third of the liver having been destroyed by the bullet. He also found a gaping laceration of the scalp on the left side, causing a superficial fracture of the temple bone and numerous homorrhages in the cortex of the temporal lobe and frontal lobe of the left cerebral hemisphere saused by a bullet wound, probably "buckshot" from a shotgun. He also found pox markings on the skin of the face on both sides of the nose and on the left side of the forehead, also probably buckshot wounds. He stated these markings were not taused by a fall as had been previously suggested.

Dr. Kearns made a very thorough autopsy of the body and found no

Dr. Kearns made a very thorough autopsy of the body and found no indications that the deceased was suffering from a venereal disease, or that he was a chronic user of mercotics. He examined the lungs carefully and advised of finding a slight trace of arrested tuberculosis. He reported that the deceased's organs were sound and he would have probably lived a matural life had it not been for the bullet wounds above described.

In this connection the writer, sogether with Mr. Harold Mathan, Assistant Director, conferred with Frank J. Walsh, Coroner, Cook County, Ill. and his Chief Daputy, V. L. Schlaeger, and it was agreed that it would be sufficient if only Mrs. Russell G. Gibson testified at the inquest on James ary 10, 1935.

On January 10, 1935, at 9.58 A.M. inquest was held at the County
Morgue by Deputy James Whalen. At this time Special Agents R. D. Brown and
R. J. Abbaticchic, Jr. testified as to the activities of the Government Agents
in endeavoring to apprehend Russell Gibson, and his firing upon Agents, resulting in the fire of the Special Agents killing Russell G. Gibson. Mrs.
Gibson also testified, as to the identity of this subject and there was forwarded to the Division under date of January 11, 1935, photostatic copy of
the inquest record as to the death of Russell Sibson, setting out in detail
all testimony, and the findings of the Coroner's jury, indicating that the

I telephoned Special Agent in Charge Ladd at the Chicago office with reference to the letter which was addressed to the United States Attorney at Philadelphia, Pennsylvania by John *Karpavicz, 2842 North Franciscan Avenue, Chicago, Illinois, who is the father of Alvin Karpis. Mr. Karpavicz desired information relative to Dolores *Delaney and requested that she be advised that he will be glad to take care of her and the child when it is born. He mentioned in his letter the name of Louise Graham. I have not noticed this name in press dispatches, although it is the name under which Dolores Delaney was instructed by Karpis to register at the Danmore Hotel, Atlantic City, New Jersey and from this it appears that Alvin c Karpis may have been in contact with his father, instructing him to write the letter in question. I instructed Mr. Ladd to have the father of Karpis interviewed openly with a view to obtaining his assistance in bringing about the apprehension of his son. It is to be noted that efforts have been made by the mother through the Chicago press to have Alvin Karpis surrender himself. Mr. Ladd advised that Agents Melvin and Walsh have not yet started for St. Paul; that Helvin is presently with Special Agent in Charge Connelley at Toledo and Walsh is on a "plant" in Chicago in connection with the Bremer case. Mr. Ladd stated that it is the intention of Mr. Connelley to send both of these agents to St. Paul as soon as he can possibly do so. Mr. Ladd also stated that he desired to talk with Mr. Tolson concerning his return to the St. Paul office, inasmuch as Special Agent in Charge Purvis has now returned to Chicago. In connection with William Weaver, No. 51, it is noted that K photo number 4450 was to be used, and it is noted that beneath this designation there appears, "and Chicago P. D. No. 25452 in the lower right hand corner". I have inquired of Mr. Houser, our chief photographer, as to why the photograph appearing on the print No. 25452 was not placed in the lower right hand corner of the photograph bearing K 4450. Mr. Houser states that he did not understand the meaning of this notation and in his haste he did not call it to my attention. Mr. Houser has been advised that he must consult me concerning anything which is not clear to him.

In connection with this oversight it is not believed that the information furnished in connection with the preparation of this perticular photograph is at all elear. It is noted that P. D. No. 23452 is the arrest number of the St. Paul Police Department and not the Chicago Police Department, as indicated. The sheets in connection with these two photographs are attached. The entire Pocket I. O. was transmitted to the Identification Unit for proofing.

Dear Sir:

In connection with the conference held with various Special Agents and Special Agents in Charge at the Chicago Office in the matter of the search for members of the Barker-Karpis gang, I expressed the orinion that in all those jurisdictions where there was any amount of active work current on this case, one agent should be assigned to said case, devoting his entire time thereto. I am of the opinion that this is the only manner in which a major investigation should be handled in any office. It developed then that possibly the agents so assigned could not be kept on this work and an instance was called to my attention connected with the assignment of Special Agent Paul Hanson, a member of the conference and attached to the Oklahoma City office, to a judicial office investigation in the State of Oklahoma.

It is in connection with this matter that I am writing the Division. Agent Hanson is a splendid criminal investigator. It seemed to be a mistake to take Hanson off a case like the Berker-Karpis hunt and put him on a judicial office investigation when there are meny others who could undoubtedly be used on this type of work without injury to either the Brener kidnaping investigation or the judicial office examination and without utilizing the services of an individual like Agent Hanson, who is particularly adapted for the criminal class of investigation. I am inclined to think that these assignments are perhaps made at times without consideration being made to the committments in the individual offices of agents like Paul Hanson and their particular adaptability for certain classes of work. Although I, of course, may be entirely wrong with reference to the foregoing, at any rate I am of the opinion that Agent Hanson should be taken from any judicial office assignment that he is on in Oklahoma and returned to the bremer kidnaping investigation. Agent Hanson was assigned to the Bremer


