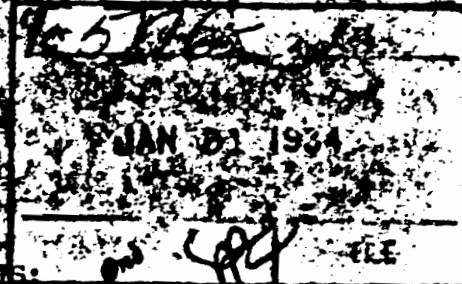

Dear Sir:

Reference is made to today's telephone conversation between Special Agent in Charge Frank J. Blake and the writer, wherein Mr. Blake advised information had been received in St. Paul that Pat Crowe, reformed kidnapper and racketeer, possessed pertinent information relative to the above entitled case.

For your information, Special Agent J. F. McDavitt located Pat Crowe, who is now residing at the Salvation Army Hotel, 706 North Broad Street, Philadelphia, at which address Crowe will remain until the end of the week, at which time, he stated, he intends to return to Chicago. Crowe advised that he had dispatched a wire to E. F. Sweeney, Sweeney Detective Bureau, Inc., 426 First National Bank Building, St. Paul, Minn., Crowe stating that Sweeney is an ex-captain of detectives in St. Paul and is the only man with whom he (Crowe) will attempt any negotiations. Crowe advised that he is aware of the identity of the kidnappers in the instant case; that there are five in number, one of whom is an ex-Deputy United States Marshal and an ex-convict (2) an ex-St. Paul policeman; the other three persons consist of pimps and bootleggers. Three of the five are old timers; the remaining two are younger men and are related, being either brothers or nephews of one of the older men.

Crowe's proposition is briefly this: If satisfactory to Sweeney, he will contact Sweeney and make necessary arrangements for the ransom money to be paid and the victim returned to his family, claiming that the victim is now alive on a farm (exact location not divulged). He further stated that as a reward for his services he desires 5% of the ransom money recovered, claiming that

his part will consist of placing "the finger" on the guilty parties, and that he (Crowe) will figure neither in the trial nor will his identity become known. In the event that no ransom money is recovered, Crowe stated he receives nothing for his services but is working purely on the 5% basis of the ransom money recovered.

Crowe refused to divulge any further information, reiterating that he preferred to deal with Sweeney, who was absolutely reliable and was acquainted with Crowe. He further advised that the motive in the instant case was the same as that in the Hamm case, which, according to Crowe, was a desire on the part of ex-bootleggers to establish themselves in the liquor business.

Crowe was questioned at length both by Special Agent M. Devitt and the writer at this Division Office, but the above information comprises all that Crowe would divulge. He is very valuable and takes great pains to impress upon his listeners his achievements of the past in kidnaping cases.

Crowe also stressed the fact that if knowledge becomes public that he is involved in this case, the gangsters responsible for this crime will immediately put young Bremer to death.

It looks like another of those "unsolved cases." Why wouldn't it be possible to trick them by finding some man to impersonate Edward Bremer. Let the papers publish what they wish. Let them publish in headlines that Edward Bremer has returned, escaped from his captors. Create and build up a story of his escape. Let him step into the life of the real Edward Bremer, let his family welcome him and let him live in this home with his parents. Create a story and atmosphere that would be easy with the wealth of intelligence and resources at your command. I realize the difficulties that are bound to arise, but as a last resort why wouldn't it be possible to do this?

The success of the entire plan is to make the kidnapers think that some other gang is trying to "pull a fast one" on the family. This may lead them to take chances they would never take if they thought the public and the police were still looking for them. Let the man you pick out appear in any pictures in the papers, Pathe news etc (of course they must look somewhat alike). Think of the chances that the real captors may see his picture and hear him talk and surely they will try to find out what it is all about. Their curiosity will most certainly exert itself.

Lead them to believe that this new Edward is meeting confederates some place. Have a well known character of gang land (friendly with the police) confer with him in out-of-the-way places in the city. Let them think that the fake Edward and Pale are trying to swindle the Bremer family (of course the Bremer family will know that ~~he~~ is not their real son). All this time the police may pick up some clue that will unravel the whole case. They may capture the fellow who tries to shadow the fake Edward. Let the fake Edward give an address

or talk on his adventure in a public place (advertised before time) free of charge. He bet that one of the kidnapers will be in the crowd. They will have to hear his story thinking that the police have forgotten them as they will wonder what the other fellows game is.

Think of it! Why couldn't a camera be placed at the door just inside to take pictures of the scoundrels as they entered and later studied by police officials and detectives in hopes that they might pick up some information concerning the captors. Wouldn't it be worth the trouble if you found the real Edward Bremer? Think of his family! Think of your department! You could even arrest suspicious characters at this public appearance. It would be the biggest thing in police history.

The kidnapers took a chance. Don't let them think that you are not game. If you fail, what is the difference? What have you to lose? You at least - tried.


This entire idea probably sounds crazy to you more educated and ... men, but that may be

the most important part of the entire case. It should mislead the kidnapers as to the motive of the whole plan.

Please don't mention this letter to anyone or my name. It took a lot of nerve to write this, but I feel very sorry for his family and I hope to God that this suggestion may be of some help to you.

The attention of the Division is invited to letter addressed to the St.Paul Division Office by the Philadelphia Office, A.Schroeder, Acting, under date of January 30,1934, in the above entitled matter.

I am of the opinion that CROWE should be forcefully informed either by a representative of the Philadelphia Office, or someone from Washington, that the Division will not tolerate the withholding by him, CROWE, of any information of any kind, or nature whatsoever, that he may possess relative to the BREMER kidnaping case. It is not believed that any action should be taken here in the matter, nor that M.F.SWENNEY of St.Paul, referred to by CROWE, should be taken into the confidence of this office. It is not believed, of course, that CROWE possesses any information relative to the BREMER case and in this connection it should be noted that the original communication from the kidnapers instructed that no negotiations be held in response to any communication other than that bearing the signature of the victim. It is CROWE'S desire to gain either notoriety, or possibly money. However, it would appear intolerable that this old man, who is probably senile, should inject himself into this case and presumably, or, according to his own statement, withhold information from this Division.

MEMORANDUM FOR THE DIRECTOR

Supplementing my recent memorandum in regard to the whereabouts of fugitive Verne Sankey, I wish to submit the following additional information which I received from my brother in Fargo, North Dakota.

He advises that a Special Agent investigated the lead I submitted but that he believed the proper way to have followed it would have been under cover rather than openly investigation in such a vicinity. His reason for this belief, he states, is the well known clannishness of Railroad men. Part of his letter goes on to state:

"He is the dope: Sankey was out there, and he had some pals out there, as close as I could find out was that his pal was a fellow named Frank (Shoem) Derr, now this Derr has a cottage at the lakes and I wouldn't be surprised if that isn't where Sankey has been hiding out. This cottage I believe is some place in the vicinity of Frazee, Minn. Now Frazee isn't very far from Minneapolis and it might be that Sankey is in on that Bremer kidnapping ***** and to carry the acquaintance of a man by the name of Garfield Stenberg, he was a part time bar tender in the saloon Sankey was supposed to have been in, and he said it was Sankey, he is easy to get acquainted with as he likes hunting and fishing and will talk to anybody about it."

The above information is not submitted as being my own or in any way sanctioned by me I do feel that any possible lead which may help to solve the Bremer case in which the Division is interested should be at least offered for what fruits it may bear.

MEMORANDUM FOR MR. CLEGG

Mr. Harry Gusack of the Universal Service telephoned to inquire concerning a story to the effect that "Bremer's kidnapers were sore at the family due to the fact that they were to put a blue eagle in the window signifying they were ready to pay the \$200,000 and one of the kidnapers passed by the house, noticed that the blue eagle was torn in half, which was an indication that they were willing to pay only \$100,000, and therefore they were quite peeved." This is apparently the same story that Mr. Gusack related to you Monday evening. I told him that I knew of no basis for such a story. Mr. Gusack asked me to let him know when the case breaks, and I told him that I would.

One Arthur Pedersen, who is described as 33 years of age, 5 feet 8 inches in height, 150 pounds, medium brown hair, partly bald, blue eyes, and ruddy complexion, on January 29, 1934, attempted to make a connection with Walter Magee, contact man in this case. He was arrested by the police at Minneapolis, Minnesota; and on questioning, admitted that his purpose in attempting to make connection with Magee was to obtain small sums of money from time to time from Magee on the pretext that he was endeavoring to solve this kidnaping.

Pedersen stated that for the past year, he worked in the diet kitchen of the Metropolitan Hospital, New York City, and that he resided at 434 East 34th Street, New York City.

It is respectfully requested that this information be checked in New York City and the St. Paul Division office advised at the earliest possible date. Pedersen is being held in jail at St. Paul, Minnesota.

Reference is made to my letter of January 26, 1934, in connection with the latent prints developed on the series of extortion notes in connection with the case entitled UNKNOWN SUBJECTS; EDWARD G. BREMER, VICTIM. The search of such of these latent prints as could be classified has been completed in the single fingerprint file with the exception of one print of a delta formation which will necessitate search through the entire file.

Additional identifications of these latent prints with the fingerprints of persons known to have handled the letters have been made as follows:

- 2 fingerprints of Dr. Wippert have been found on the envelope bearing the typewritten address "To Walter Magee, Adolph Bremer, very important".
- 2 latent prints appearing on the envelope addressed "Dr. H. F. Wippert personal, please deliver at once", have been identified as those of Thomas Dahill.
- 2 latent prints appearing on the handwritten letter beginning "Dearest Pat, Please do not worry", have been identified as those of Edward G. Bremer, the victim. One latent print on this same letter has been identified as that of Thomas Dahill.
- 10 of the latent prints found on the handwritten letter beginning "Dear Walter, I'm sorry", have been identified as those of the victim, Edward G. Bremer.
- 1 of the latent prints appearing on the envelope which accompanied the last described letter has been found to be that of Walter W. Magee.

The fingerprints of Mrs. Edward G. Bremer have been compared with the latent prints with negative results.

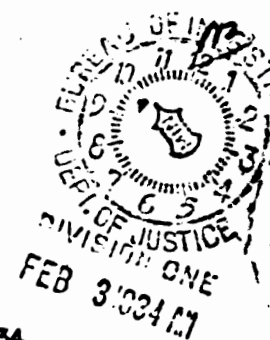

Reference is made to your letter dated January 26, 1934 relating to the case entitled UNKNOWN SUBJECTS, EDWARD G. BREMER, VICTIM, KIDNAPING, with which were transmitted copies of a letter addressed to the Attorney General under date of January 19, 1934 by Mr. A. J. Hertz, 6011 Plankinton Building, Milwaukee, Wisconsin.

Please be advised that Special Agent V. W. Peterson interviewed Mr. A. J. Hertz on January 30, 1934 in his office located in Room 6011 Plankinton Building, Milwaukee, Wisconsin.

Mr. Hertz advised that he was formerly an attorney and was engaged in the practice of law in St. Paul, Minnesota. Several years ago he was retained to represent one, Leon Gleckman, who is alleged to be the dominating figure of the St. Paul underworld. Leon Gleckman was indicted for violation of the National Prohibition Act and on the advice of A. J. Hertz, his attorney, a plea of guilty was entered. It is alleged that Gleckman and former Assistant United States Attorney William Anderson, who was representing the Government in the case, were very friendly and that after William Anderson was released from his duties as Assistant United States Attorney he entered the employ of Gleckman in the latter's loan office. It is stated by Mr. Hertz that the Government later filed a confession of error in the case and that because of the influence of Leon Gleckman he, A. J. Hertz, was disbarred.

Mr. Hertz further advised that after his disbarment he moved to Milwaukee, Wisconsin. Subsequent thereto he went to St. Paul, Minnesota for the purpose of instituting a civil suit against Leon Gleckman for damages. On this occasion he was accompanied by one, P. J. Dunham, and they registered in the Lowry Hotel, St. Paul, Minnesota. Apparently Gleckman became aware of the intention of A. J. Hertz to file a civil suit against him for damages. Within a short time after arriving at the Lowry Hotel in St. Paul, he, Mr. Hertz, received a telephone call from some man who informed him that he would meet the same fate as some other men who had been taken for "rides" in St. Paul. A few minutes later three or four

men came to the Lowry Hotel and without knocking entered his room and began threatening him. Mr. Hertz stated that he became extremely frightened and that he is unable to furnish a description of the men who entered his room on this occasion but he is confident that they were sent there by Leon Gleckman. Mr. Hertz is alleged to have reached for the telephone and the men left the room, after raising a disturbance. Mr. Hertz immediately left St. Paul and did not dare to attempt to return.

According to A. J. Hertz, Leon Gleckman is the Al Capone of the St. Paul underworld, and that it would be almost impossible for gangsters to commit a kidnaping without the knowledge and consent of Leon Gleckman. Leon Gleckman is alleged to have served a term in the United States Penitentiary, Leavenworth, Kansas for violation of the National Prohibition Act and it is stated that he is now under indictment for evasion of the Federal Income Tax.

Mr. A. J. Hertz advised that he is well acquainted with Edward G. Bremer, for whom he has a high regard and also knows the father of Bremer. Mr. Hertz expressed a firm conviction that Leon Gleckman is implicated in the kidnaping of Edward G. Bremer.

Examination of Lincoln Sedan, bearing Minnesota State License B 74-619 for 1933, property of EDWARD G. BREMER, now being held at the McGee Garage in St. Paul, Minnesota, revealed that the front seat and upholstery of same had been drycleaned, whereby all bloodstains alleged to have been contained thereon had been removed.

OSCAR HYDAL, foreman of this garage, stated that the front seat had been taken to Sweeney's Clothes Cleaners, 115 West 7th Street, on January 19, 1934, by Frank Way, a mechanic of McGee's Garage, and the other upholstery, which was apparently stained with blood had been cleaned by Way and himself, all of which was done upon instructions of Mr. McGee. He stated that McGee did not want MR. ADOLPH BREMER to see the stains on this car.

At Sweeney's Clothes Cleaners, the writer was informed that an automobile seat had been cleaned on January 19, 1934, and what appeared to be blood stains had been removed; that no instructions had been given them to wash the stains out, whereby they might be preserved and analysis made, and it was not known until they were informed that the cleaning job was to be charged to McGee that this seat was from the BREMER car.

MR. H. M. SCHUBERT, bacteriologist, and director of the laboratory of the Department of Public Health, St. Paul, Minnesota, stated that he had made an examination of the BREMER car at McGee's Garage and found that stains on the upholstery had been removed by dry cleaning, although on the side of the cushion running to the floor, adjacent to the driver's seat, he found several streaks which, upon chemical examination, proved to be blood; that he also found a spot on the edge of the cushion leading to the floor, which, on chemical examination, proved to be blood. MR. SCHUBERT explained that due to the insufficient amount of blood available for chemical analysis, he was unable to determine whether or not it was human blood.

Chief of Police Thomas E. Dahill, furnished photographs, taken by the St. Paul Police Department, of the above described car, on 1-18-34.

The photograph marked "A" shows blood stains on the seat adjacent to the driver's seat on the floor mat immediately beneath and spots on the upholstery of the right door.

The photograph marked "B" shows the same stains on the seat adjacent to the driver's seat, and several spots on the back of this seat.

The photograph marked "C", is taken from the driver's side of the floor seat and shows two marks which were found to be grease left from the extension cord used in making photographs.

The photographs marked "D", "E", "F", and "G", are photographs of the exterior of the car. The apparent smears shown in the photograph were made by fingerprint powder in the search for fingerprints. Chief Dahill stated that no fingerprints were found on the car.

Pursuant to your instructions, I interviewed ARTHUR PEDERSON, who had been arrested by Detectives CHARLES TIERNEY and TOM BROWN of the St. Paul Police Department at room 234, Majestic Hotel, Minneapolis, today.

PEDERSON telephoned WALTER MAGEE and stated he had some important information for him and that MAGEE should come to see him at the Majestic Hotel alone.

MAGEE did not inform the Police.

When first interviewed, PEDERSON stated that from 1927 to 1929 he was an inmate of the State Penitentiary at Waupun, Wisconsin, doing a two-to-five-year sentence for larceny. He stated that while there he made the acquaintance of a man whose name he can not recall, which person had prior to his commitment to Waupun served a sentence at Stillwater, Minnesota. PEDERSON stated that he (PEDERSON) was a trusty at Waupun.

He advised that last Thursday, he left Chicago by Greyhound bus for Minneapolis; that the bus was crowded and that there was but one vacant seat, which was also occupied by a girl named HARRIET TAYLOR of Park Rapids, Minnesota. PEDERSON stated that when he smoked, he did so at the rear of the bus and there met the ex-convict previously referred to, who was also riding to Minneapolis. He claimed he got into a conversation with this man, the substance of which was that this person was not working but was plenty busy and was proceeding to a place 50 miles north of Duluth without stopping over in Minneapolis.

The BREMER case was discussed and PEDERSON remarked that the kidnapers were asking a lot of money. A minute or so later, the ex-convict remarked that in a few days he would be in big money.

PEDERSON described this individual as 38 years of age, 5 feet 5 inches tall, 155 to 160 pounds, medium complexion, brown hair.

PEDERSON was questioned as to whether he had attempted to shake down MAGEE for expense money to locate a mythical person, but he denied that this was the case.

After this interview, which was conducted by Chief of Police TOM DAHILL, Chief of Detectives CHARLES TIERNEY, Detective TOM BROWN, and agent, PEDERSON was placed in the jail and his fingerprints and photograph were taken.

He was interviewed later on the same date and he then admitted the following:

Monday morning, after he had been reading the various newspaper stories about the BREMER kidnaping, he conceived the idea that if he could call MAGEE and induce MAGEE to come to the Majestic Hotel, PEDERSON might be able to convince MAGEE that he could assist in solving this kidnaping, thereby making it possible for him to secure a few dollars in advance and possibly a few more dollars from time to time as he was ostensibly working on the solution of the kidnaping. He admitted that he had no means whatever of solving the case and that he had no idea as to who had done the kidnaping, knew nothing about it, and in all probability would receive no information other than that reported in the newspapers. It was his impression that since the newspapers had repeatedly carried stories to the effect that the police and other officials had adopted a "hands off" policy, he could easily work this confidence game on MAGEE without police interference.

He stated that while he had ridden on the bus from Chicago to Minneapolis, as previously stated, the only person he spoke to on the bus was MISS HARRIET TAYLOR of Park Rapids, Minnesota, and had not spoken to an ex-convict as he had previously stated.

Concerning his past, he advised that he was born at Peshtigo, Wisconsin; that he has a wife and two children living at Merrill, Wisconsin, from which place he had been sent to Waupun for embezzling \$200 from the Shoe Department of a department store, this being in 1927. He advised that he has a brother, OTTO J. PEDERSON, railway engineer, residing in the 1700 block on Dayton Avenue in St. Paul. For about the past two years he has been living in New York City, being employed in the diet kitchen of the Metropolitan Hospital for over a year and residing at 434 East 84th Street, New York City. In that connection, a letter is being written to the New York City Division office to check on this last information. He has never resided in Chicago but has resided in Milwaukee and in Marinette, Wisconsin.

He attempted to justify the attempted extortion by stating he thought it would make the old man BREMER feel better if MAGEE had an ex-convict assisting him in the case. He freely admitted that he had no plans for solving the case and that his only connection with same would have been to obtain a few dollars from WALTER MAGEE on a pretext of being able to supply some information.

The Police are holding PEDERSON until the solution of this case.
His photograph and fingerprints are available at any time.

With further reference to OTTO HELLEBRUE, State Representative, whose residence is 1819 Fifth Avenue South, Minneapolis, and who, as my previous memorandum will show, claimed he received a ransom note in this case, which at the time of the last interview he was unable to find but promised to find in a few days, please be advised that today Special Agent R. G. Coulter and myself interviewed him at his residence. He stated he remembered both Agent Coulter and myself; that he is very ill; that he was expecting the doctor to visit him; that he was too weak to work or walk; and that his neighbor in this rooming house had been taken on the day before to Glen Lake Sanatorium and that his room and the whole house had been fumigated for tuberculosis. His room had considerable of the belongings of the person who was taken to the Glen Lake Sanatorium; hence, because of this confusion, his illness, etc., he was unable to find the alleged ransom note.

It is my recommendation that this spurious lead be abandoned.

On the evening of Monday, January 29th,

[REDACTED] had information which he believed might be of value in connection with the recent kidnappings in St. Paul but that [REDACTED] is not desirous of gaining any publicity in connection with the kidnappings and accordingly was withholding the information. I assured [REDACTED] that I could promise [REDACTED] that any information given by [REDACTED] to this Department would be held in strict confidence; [REDACTED] stated he would endeavor to arrange an interview for me with [REDACTED] which he did yesterday.

[REDACTED] stated that the information he had in mind had come to him through [REDACTED] so he requested [REDACTED] to furnish me with the story.

[REDACTED] that sometime during April, 1933, Colonel JACK MORANZ, registered at the St. Francis Hotel, stayed for several days and later returned with his two brothers ART and LEO MORANZ, HARRY KOHL, AL BACKOWITZ, also known as AL SACKS, and DOUGLAS BROWN; that Colonel JACK MORANZ had some agreement with the Daily News, St. Paul, Minnesota, and during a period of some few weeks there appeared in the Daily News the picture of some prominent St. Paulite, together with information concerning his business, social standing, etc.; that it was somewhat in the nature of a personality contest; that it was his understanding that this Colonel JACK MORANZ received about \$50 from each person for whom a story was run in the paper; that at least, this was the information which Colonel MORANZ had conveyed to him; that it seemed quite strange to him that it was necessary for JACK MORANZ to have so many helpers in this enterprise; that it seemed as though he did all of the work himself and the others in this party merely stayed around the hotel gambling, drinking beer, and entertaining women, among whom were the BOSWELL sisters, and one of the men in the party claimed that he was engaged to one of these sisters; that the party had two automobiles, a 1931 or 1932 Brewster green LaSalle with black fenders and a Cadillac; that they spent money very freely while at the hotel and it appeared strange to him that they were able to live in such high fashion when apparently the income of JACK MORANZ was but approximately \$50 a day.

[redacted] stated that the thing which aroused his curiosity most was the fact that one day while the group was standing in the lobby of the St. Francis Hotel near the cigar counter, either LOU or ART MORANZ stated that he had just interviewed one of St. Paul's big shots, WILLIAM HAMM, who had told him all about himself both from a social and a business standpoint and that this man related that he must be a very wealthy man; that someone in the group said it was a wonder someone had not taken HAMM for a kidnaping, and that a stranger in the group remarked that it would not be an easy task since WILLIAM HAMM's father was well known in underworld circles, had many connections, and it would be difficult for anyone to pull such a job without being detected; that one in the group in a most sarcastic manner remarked, "Oh yeah" and shortly afterwards the crowd dispersed. It is the belief of [redacted] that possibly the group above referred to were using the picture-taking and personality racket for the purpose of making entree into the homes and offices of St. Paul's leading citizens so that they could obtain information with reference to their financial standing, hobbies, connections, etc., which would be of value to them in the event they planned to kidnap any of the individuals.

The records of the St. Francis Hotel disclose that Colonel JACK MORANZ and wife registered in the St. Francis Hotel April 2, 1933, and checked out April 5th; that Colonel JACK MORANZ registered in again on April 8, 1933, and checked out May 28, 1933. When he registered on April 8th, he indicated his address as some boulevard (unable to decipher handwriting), Youngstown, Ohio; and on April 9, 1933, he indicated his address as 2702 Sturtevant, Detroit, Michigan.

ART MORANZ, LOU MORANZ, HARRY KOHL, DOUGLAS BROWN, and AL BAKER checked in April 9th and checked out May 24, 1933, all registering from Detroit, Michigan.

[redacted] that when the party left the St. Francis Hotel, it was his understanding that several of them went to Winnipeg by train and others in the group motored to Winnipeg where they met these persons, and part of the group went south, destination unknown, by automobile.

[redacted] was unable to give any very definite descriptions of these men but stated that Colonel MORANZ was about 35 years of age, of medium height, and his brothers ART and LOU were between 25 and 30, also of medium height and stocky build; that Colonel MORANZ had black hair streaked with gray and had medium dark complexion; that the brothers ART and LOU had sandy complexions; that these men were very well dressed and always appeared to have plenty of money.

He described HARRY KOHL as being tall and thin, around 6 feet, with Roman nose, sharp features, black hair, and dark complexion. He could not give any description for AL SACKS but stated that this man received mail under the names of SACKS and SACKOWITZ.

[redacted] that the betting in the underworld is two to one that EDWARD BREMER will not be returned either dead or alive; that rumors have it that he has been knocked off because he was to have been a witness against some confidence man who obtained \$300,000 from a [redacted] by the name of [redacted] in some sort of a race horse deal; that he also had heard in the underworld circles that EDWARD BREMER had obtained something like \$400,000 in a similar deal and had been knocked off because of this.

[redacted] advised that in a recent conversation had by him with LEON GLECKMAN, local St. Paul underworld character, MR. GLECKMAN informed him that he had gone to MR. ADOLPH BREMER and offered him \$25,000 to assist him in raising the ransom money being demanded by the persons who kidnaped his son EDWARD BREMER.

[redacted] made mention of one C. A. VON SKIN alias WHITIE who he advised had been a permanent resident at the St. Francis Hotel for more than a year; that this man had been in the gambling racket and apparently had been making plenty of money; that on the afternoon of January 15th, this man checked out and at that time owed a bill of \$40; that he informed the house manager he was broke and was unable to pay the bill; that, however, the manager of the hotel managed to get \$10 from him, leaving a balance of \$30 unpaid; that VON SKIN stated he was going to Mankato but would return the following week, but to date, this man has not returned to the St. Francis Hotel. It is rumored that before leaving St. Paul, this man obtained quite a large sum of money from various gamblers in St. Paul. This man is described as being middle aged, about 5 feet 10 inches, 180 to 190 pounds, light hair, medium fair complexion, stoop shouldered and walks with a limp, and makes a good appearance.

In connection with this MR. VON SKIN, [redacted] advised that on the same date, one THOMAS J. FILBIN, St. Paul underworld character, who is in the slot machine racket, checked out; that FILBIN is considered to be a permanent guest at the St. Francis Hotel. Besides being in the slot machine racket, he deals in "hot" diamonds and automobiles and has his headquarters in Aberdeen, South Dakota.

It is the opinion of [redacted] that possibly MR. FILM [redacted] specifically requested this room so that he might be in a position to over-
hear any possible conversation concerning the BREMER kidnaping since he no
doubt has knowledge that the BREMER and the BENZ families are closely related;
that THOMAS FILM could very easily be connected with the BREMER kidnaping.

[redacted] expressed the opinion that one ABE GINSBERG, an under-
world character in Minneapolis, should be overlooked in this case; that it
seems as though this man appears on the scene whenever any crime of conse-
quence is committed in the Twin Cities; that one KINA SWENSON, a lady who
lives in the house next to the one in which ABE GINSBERG owns in Minneapolis,

Left Beaumont in May or June for Chicago. May now be in Chicago or Kansas City. Her mother and acquaintances deny knowledge of her whereabouts since she left Beaumont.

DETAILS:

It was ascertained at Beaumont, Texas, that Paula Harmon had lived at 994 Center Street with one Theo Riley, a burglar and bootlegger. Theo Riley now is staying in Galveston, Texas but was in Beaumont on January 29, 1934, and upon being located and interviewed stated that he and Paula Harmon lived together for about nine months where they operated a bootlegging establishment on Center Street, Beaumont; that Paula Harmon left Beaumont about a month, as near as he can recall, before he read in the papers of the massacre of officers in Kansas City; that when he took up with her, she had about \$2000.00, obtained as a result of an automobile accident in which she was injured in Louisiana, and that he spent most of that for her and in addition thereto wrecked her Buick automobile two or three different times; that she went to Chicago on one trip for the purpose of having her nose operated on as there is a noticeable scar across

the bridge of her nose and that her cheek bones are sunken as a result of the automobile accident; that when she left Beaumont she did not take all of her belongings with her; and after she had gone he took them to the home of Velma Turk who was a very close friend to Paula Harmon, and that he would furnish Agent with a photograph of Paula Harmon, which would be an old one, as he does not believe she ever had any photographs taken of herself after the automobile accident. He stated that her first husband, Dennis Woods of Port Arthur, Texas, might know something about Paula's whereabouts.

Later in the day Theo Riley left a photograph of Paula Harmon at the Police Station for Agent, and this photograph, which evidently is an old one, is submitted herewith to the St. Paul Division Office.

Theo Riley claimed that he took Paula Harmon to the air field when she left Beaumont the first time, and she went to Chicago by airplane; that he never received a letter from her after she left but she was only gone about a week and returned and then left a second time and said she was going back to Chicago; that he heard from her once or twice by long distance telephone after she left Beaumont the second time; that she merely called him up and asked him if he was getting along all right and whether or not he needed any money, and on one occasion she sent him \$50.00 by mail; that he has tried to find her address since then but has never been able to ascertain where she is.

Mrs. Velma Turk, who resides at 2540 Magnolia Avenue, Beaumont, Texas, stated that she has known Paula Harmon for a number of years and that Paula and her former husband, Charlie Harmon, who was killed in a bank robbery at Menomonee, Wis., or Duluth, Minn., she could not recall which, had at one time lived with her (Mrs. Turk) prior to Charlie's death; that she had known Harmon and his family all her life as they were all reared around Nacogdoches, Texas; that at the time Paula Harmon left Beaumont she called her up and asked her to come over to her house and that she and her husband, Mr. Turk, went over to see Paula Harmon one night and Paula told her she was leaving for Chicago, and as her mother was then living in Georgia she would be writing to her and she desired that Mrs. Turk forward her mother's letters to her and that after her arrival in Chicago she would furnish Mrs. Turk her address there for this purpose, but that no letters ever came for Paula nor did Paula ever send her an address in Chicago; that just before Christmas Paula's mother, Mrs. Brannon, who now resides in Port Arthur, Texas, came to see her and asked her if she could give her Paula's address; that she was unable to do so.

Levi Delotti, a pool hall operator at Beaumont, Texas, where Theo Riley hangs out, stated that he knew Paula Harmon while she was living with Theo Riley and that she was around his place some with Theo while both were drunk when they were living together, but he has never heard where she went when she left Beaumont and all he knows is that Paula left Theo Riley and that Riley has

tried frantically to find where she is; that a magazine is delivered to the pool hall addressed to Paula Harmon regularly, as also are bills from the printing company but that he has no forwarding address and, therefore, just destroys the letters and magazines.

Lena Lee Landry, [redacted] was interviewed but very little information could be obtained from her as she is not very intelligent. She stated that she saw Paula Harmon about three months ago in Port Arthur with her former husband Dennis Woods. This information, however, is discounted as Dennis Woods is living with another girl at this time known to the police at both Beaumont and Port Arthur, Texas.

Dennis Woods at Port Arthur, Texas, was interviewed and stated that all he knows about Paula's present whereabouts is that she told Theo Riley and Mrs. Turk that she was going to Chicago; that she has, to his knowledge, lived around Chicago some, especially when Charlie Harmon was alive; that she also has lived around Kansas City and that she may now be in Kansas City or Chicago; that he has neither seen nor heard from her since she left Theo Riley and wants, apparently, to Chicago.

Mrs. D. B. (Annie) Brannon, 137 DeQueen Blvd., Port Arthur, Texas, was interviewed and stated that if she knew Paula's address she would not hesitate to furnish same to Agent, but that she positively has no idea where Paula now is; that when Paula left Beaumont she (Mrs. Brannon) was living in Georgia, and about nine months ago she had a letter from Paula which was mailed on a train some place in Kansas, and that she has not heard from her since that time.

The Identification Bureau Records at both Port Arthur and Beaumont, Texas, were checked for photograph of Paula Harmon, but she has never been photographed or fingerprinted as far as could be determined.

The last address at the Post Office at Beaumont, Texas, for Paula Harmon, was 994 Center Street, and Levi Deloti's Pool Hall.

Roney Etie, 795 Harrison Street, Beaumont, Texas, a bootlegger friend of Theo Riley, stated that he knew Paula Harmon when she was living with Theo but he knows that Theo Riley does not know where she is or he would have gone to her; that he understood Theo took a trip to Chicago trying to find Paula.

Mrs. Turk, 2540 Magnolia Avenue, Beaumont, Texas, was again interviewed and stated that she went with Paula Harmon and a tramp by the name of Doyle Benton, in July 1932 just after she got her money from the insurance company as a result of the automobile accident, to Lake Charles, Louisiana, where Paula and Doyle were married; that she witnessed the marriage ceremony and signed the certificate as a witness; that she believes this ceremony was performed by Minister Oliver of Lake Charles; that Charles Harmon's sisters live in Houston, Texas; one Mrs. Ruth Larson lives on North Boulevard; her husband works for the Humble Oil Company. Another, Mrs. Phillip (Mora) Maubar, address 1614 Walker Street, Apartment #5, Houston, Texas. These sisters were friendly with Paula Harmon and may hear from her; that another sister Mrs. J. A. Bryan, whose husband is a barber, and another sister Mrs. Marvin Treadwell, lives on Chartres Street in Houston, but she does not know their exact addresses; they were not so friendly with Paula; that Mr. Charlie Face and his wife Frances Face may know the whereabouts of Paula Harmon, but aside from the fact that they reside in Houston and Face was formerly a car salesman for the Ford Agency there, their whereabouts are unknown.

Jesse Hamilton, Deputy County Court Clerk, Beaumont, Texas, brother-in-law to Paula Harmon, stated that in his opinion none of the family know Paula's present whereabouts and that he is satisfied that his mother-in-law, Mrs. Brannon, would not tell him or anyone else if she knew.

At Mrs. Turk's place Agent obtained permission to look through the effects still in her possession which belong to Paula Harmon, but nothing was found therein of value in this matter except possibly a photograph of some unknown lady which was in a photographer's paper folder bearing the address 541 Diversey Parkway, Chicago; also the cover of a memorandum book with addresses and names of what appeared to be telephone numbers written thereon. The following names appear:

Roy O. White (author of letter) came to Springfield, Mo. in the winter of late 32 or early 33. I became acquainted with him and, borrowed money which, we used to establish the above business. (the business is now defunct.)

Upon Whites insistence that, his wife owned a large share of her brothers farm, near Barret, Minnesota. I borrowed more money and, took he and his family to Barret, for the purpose of converting Mrs. Whites share of the farm into cash, to finance the business.

After remaining a few days with the relatives, White suggested that, he and I return to Kansas City, and sell some hand painted menu boards, while his wife was selling her property.

In Kansas City, I left White and, returned to Springfield, to look after the business which was in bad shape and, within a few days, on May 19th. I received the enclosed letter from White. Thus ended my connection with White.

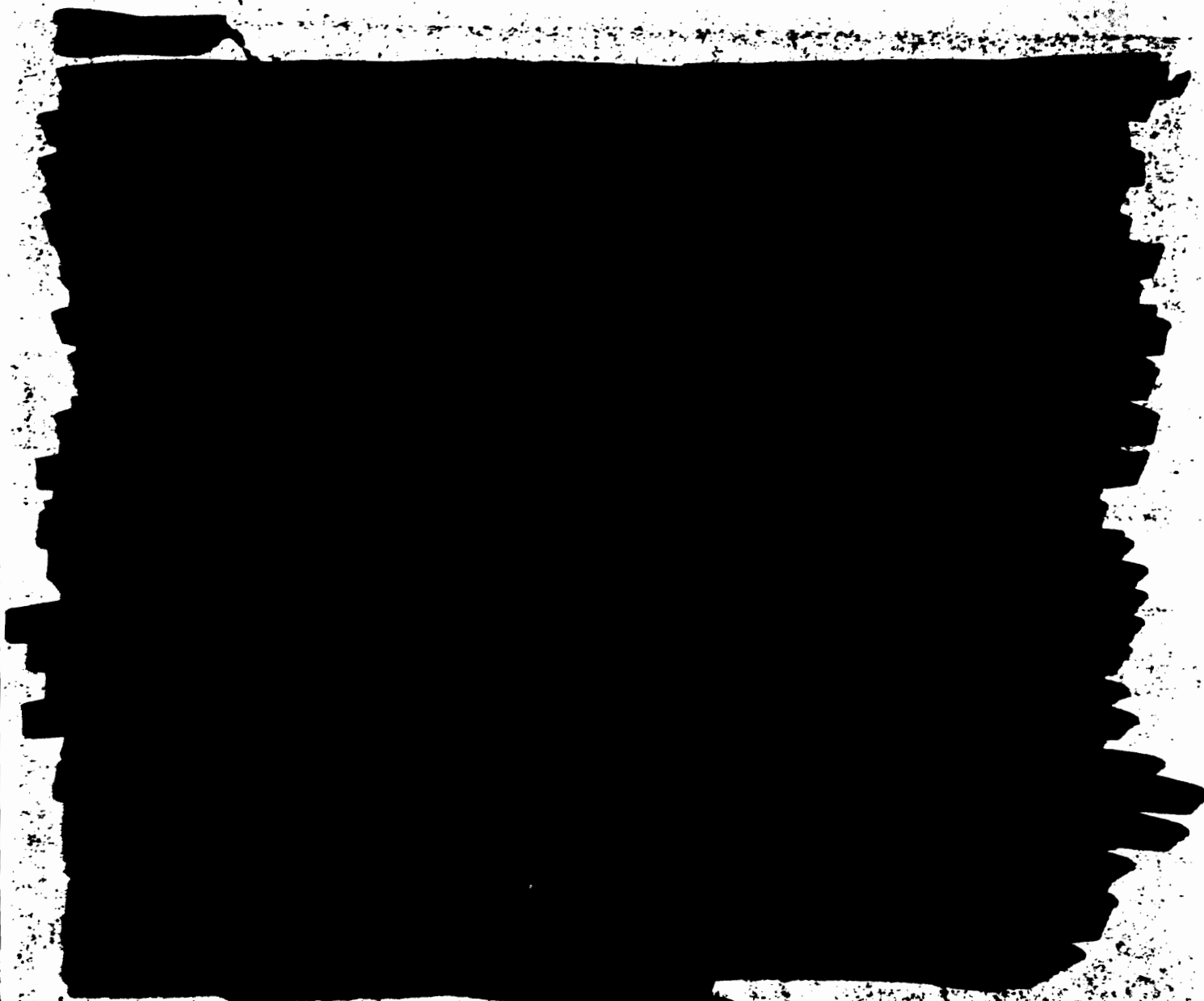
In case White proves to be your man, I will furnish as much information as possible. White has two brother-in-laws residing on farms about 9 miles from Barret, Minnesota. one Pete Kohn and Andrew Kohn, White also has a very good friend at Baron, Wisconsin, by the name of Ray Higenmeister.

White while in Springfield, preached several sermons and seemed to be quite an evangelist around Barret, which may account for the kidnaper message being written on the Union City Mission letterhead.

A letter dated January 27, 1934, written to ADOLPH BREMER by Sylvester Urbany, Carroll, Iowa, was turned over to this office by MR. BREMER. This letter sets out information that MR. URBANY is proprietor of the Commercial Hotel, Carroll, Iowa, and that a party stayed at that hotel on January 25, 1934, and registered as JACK RAY of St. Paul, Minnesota; that MR. URBANY's daughter compared the handwriting on the register of this party with that of the note written to the BREMER family shortly after the kidnaping signed, "One of the gang", and advising that BREMER was dead and his body was in the vicinity of Ancker, Minnesota. The letter also states that during this party's absence from the hotel, MR. URBANY's daughter inspected the room and found a blood stained shirt, also a blood stained hat lining and kid gloves. The register sheet covering the date of January 25, 1934, was forwarded with this letter and photostatic copies have been made.

At the Commercial Hotel, Carroll, Iowa, MRS. FRANK J. BUCHHEIT was interviewed. She is the daughter of SYLVESTER URBANY and her husband is the brother of FRANK BUCHHEIT, Sheriff of Carroll County. On the night of January 25, 1934, she stated that two men came to this hotel and looked at the rooms and decided the location and the rooms were just what they wanted so they went outside and then sent in a party who registered as "JACK RAY, St. Paul, Minn." She assigned him to room 12, but when he got to the room and noted that the lock was broken on the door he insisted on having a room, which could be locked at all times and stated he wanted no maid to enter the room during his absence. He was, therefore, assigned to room 11. MRS. BUCHHEIT observed the license number on the car which she was driving, a green coupe, same being B112-970, Minnesota 1933. (This number was checked through the Motor Vehicle Department by S.A.C. Hanni and was determined that same was issued for a Hudson Coupe, motor number 8447, licensed to C. F. REDLICK COMPANY, 305 Lincoln Building, Minneapolis, Minnesota. The Minneapolis Directory shows CHARLES F. REDLICK to reside at 16 South 4th Street, which address is the Russell Hotel.) MRS. BUCHHEIT advised that she called the Sheriff shortly after this registration by the party giving the name of "RAY", and he also compared it with the handwriting on the note above referred to, this being available from a newspaper she had saved wherein this note had been printed. The Sheriff was of the opinion that the handwriting was similar so requested her to call him the next day when this party got up. She called the Sheriff and as soon as this party left the hotel, the Sheriff accosted him on the street. She stated that as soon as this party left the hotel, she went up stairs and made an inspection of the room and opened this man's suit case and found therein

Agent inspected this room, number 11, at this hotel, and found that there are a number of red spots on the floor, believed to be

RAY frequented Carrell doctors the past year or so. They have attempted to get narcotics from various doctors, but are always refused by the doctors. The Sheriff and the Sheriff stated that in order to get rid of them and get them out of town he would suggest to the doctors that they give them enough to keep them quiet. RAY appeared in Carrell about three weeks ago and the Sheriff in this manner sent him to Dr. MURKIN and suggested to Dr. MURKIN that he give him a little if he thought it was necessary. This was the last of RAY in Carrell until a few days ago when he was seen in Carrell again. RAY was seen above.

After following RAY a short ways from the hotel, the Sheriff stopped him for questioning and recognized him as the same party who had been in Garrell two or three weeks ago. He then went to RAY's room with him and examined his suit case and found only what has previously been stated by MRS. FRANK J. BUCHHEIT. When they came down from this room the narcotic agent ELIZZARD and also another narcotic agent, both of whom presented credentials, stated that they had picked RAY up in Omaha and that he was working for them as a "steal pigeon". RAY, at the time, explained to the Sheriff that the various blood stains were caused by injection of the dope in his arms with needles.

At the Burke Hotel under date of January 25, 1934, Agent found the register of H. E. ANDERSON of Minneapolis, assigned to room 323, and H. E. BRADLEY, Des Moines, the same date immediately following ANDERSON's registration assigned to room 310. F. A. BENTLEY, Clerk, at the Burke Hotel, stated that he knew ELIZZARD, who had been there before and knew ELIZZARD had registered as BRADLEY, and further saw ELIZZARD send out official mail from that hotel under the name of ELIZZARD. BENTLEY also understood ELIZZARD was a Narcotic Agent. S. A. C. Mann called the Narcotic office in Minneapolis and determined that Agent ANDERSON of that office had been in Carroll, Iowa and vicinity on January 25, 1934.

On January 31, 1934, ALBERT LEE, a member of the Wisconsin State Conservation Commission, usually referred to as a Game Warden, with headquarters at Luck, Wisconsin, reported that on January 25, 1934, about 1:00 p.m., he was in a restaurant at Amery, Wisconsin, and overheard a conversation. A party was in a booth and another party came in and greeted this person as "BILL"; the party coming in being greeted as "JOE", both being strangers in the town of Amery. The party referred to as "BILL" asked during their conversation what he thought about the BREMER case, to which the party called "JOE" stated that it was not what he thought but what he knew that counted; that the police and the Federal agents were "barking up the wrong tree; that they should watch MACKER". This party was heard to say that MACKER and BREMER had made a trip to Chicago just before the kidnaping and that they had both been gambling considerably and and they lost money and BREMER failed to make good on I.O.U's. That was about all the conversation that MR. LEE overheard.

The party known as "JOE" left the restaurant and went to a pool hall, staying only a few minutes, then entered a drug store, came out with a magazine, returned to the hotel and read the magazine for a short time before taking a brief bag and boarding the train shortly after 8:00 p.m., going west. MR. LEE observed the movements of this party during that time. He described the party named "JOE" as follows: Age, 45 years; weight, 190 to 200 pounds; height, 5 feet 8 or 9 inches; dark brown eyes; dark hair streaked with gray; prominent Italian features; well dressed; carried no luggage except a brief case.

The party referred to as "BILL" is described as follows: Age, 40 years; weight, 170 pounds; height, 5 feet 6 or 7 inches; ruddy complexion; were light gray hat and brown overcoat.

This information is submitted for whatever purpose it might serve.

On this date, Agent interviewed [REDACTED] at her office. She was much concerned lest what she told might not be treated confidentially, but was assured that such would be the case.

She stated [REDACTED] that about two weeks ago, she cannot say whether on Thursday or Friday, a man 'phoned her office during her absence but would not leave his name nor telephone number, as is customary with persons 'phoning her office when she is out.

On the Friday after the Kidnaping of MR. BREMER, a man called just at 5:00 P. M. and wanted to see her immediately, in fact he said he must see her. She stated that it is her custom to take a bus at 6:00 o'clock on Friday afternoons to her mother's home in Wisconsin, and not caring to miss the bus, she asked the nature of the business and the man said [REDACTED] as it was very important.

[REDACTED] she told him that he would have to see her the following Monday at 8:30 P. M. as she was preparing to leave town and could not change her plans. She said that she had not heard from him since that time and did not expect to hear.

Pursuant to telegraphic request by you on 1/27/34, I am transmitting herewith two copies of report of Special Agent C.B. Winstead in the case of Vernon C. Miller (deceased); et al - Obstruction of Justice, pertaining to the investigation of A. CARTER.

Detective Ed Weatherford of Fort Worth, Texas, has advised this office that ALFRED THOMAS BLAKE, EDWARD BENTZ, EDDIE DOLL, alias EDWARD LARUE, and possibly BERNARD PHILLIPS, might be in on the Edward G. Bremer kidnapping case.

Detective Weatherford stated that Blake, who escaped from jail at Winnipeg, Canada, is a running-mate of George Kelly, Albert Bates and Verne Miller; and through a grapevine source in a previous conversation with Kathryn Kelly the names of Blake, Doll, Bates and Phillips were mentioned as planning bank robberies and kidnappings at St. Paul - and if so, the victim would be taken to one of the cottages on the lake (which lake was not known) near St. Paul.

I am attaching hereto fingerprint classification card and description of Alfred Thomas Blake. A photograph cannot be secured at this time; however, efforts are being made and it will be transmitted to your office if secured.

Detective Weatherford, through his under-world connections, has learned that the men named in this letter have formed a new gang since the breakup of the old gang headed by Frank Nash. Special Agent in Charge Blake will be able to give you any information required relative to the value of the information submitted by Weatherford.

Upon receipt of your telegram dated January 29, 1934, concerning the ownership of Missouri 1933 license No. 29365, believed issued to Chester L. Byron, Route 5, Reda, Jasper County, Missouri, for model T Ford Sedan, please be advised in confirmation of my wire dated January 29, 1933 to you that the Kansas City Division Office ascertained that the above noted license plates were issued to Rose Brueggemann, 3819a Hartford Street, St. Louis, Missouri, on February 13, 1933, for an Oldsmobile Sedan, motor No. E-6013.

Special Agent B. L. Dameron, of this office, on the evening of January 29, 1934, ascertained from the Auto Theft Bureau of the Metropolitan Police Department at St. Louis, Missouri that the license referred to above had been issued to the individual noted.

The current city directory verified the address of Mrs. Rose Brueggemann at 3819a Hartford Street, St. Louis, Missouri, it being further developed that the first floor at this address is occupied by one John D. Edwards, a city employee.

Inquiry of the desk sergeant and detectives of the Seventh District Police Station at 2800 South Grand Blvd., St. Louis, by Special Agent Dameron, was without results as to the identity of the Brueggemann family.

Mr. and Mrs. John D. Edwards, 3819 Hartford Street, advised Agent Dameron that Mrs. Rose Brueggemann is their landlady; that she is a widow and the mother of one daughter; that she has a good reputation and has been under a doctor's care for several weeks, and therefore confined to her home; however, that Mrs. Brueggemann is the owner of a 1929 model Oldsmobile Sedan, and has taken no recent trips in this car.

Mrs. Brueggemann was then interviewed by Agent Dameron, and permitted an examination of her automobile, which disclosed that 1933 Missouri license No. 29365 was attached to both the front and rear license plate holders of the car. She verified the information provided.

by Mr. and Mrs. Edwards, and stated that the automobile and license plates had been in her possession continuously from the date the license plates were issued to her, and that she had never driven to Minnesota in this car.

Reference is also made to the letter emanating from the St. Paul Office under date of January 28, 1934, in the instant case, requesting an examination of any written documents of subjects at large, particularly such who might be involved with any notorious gang or in kidnaping cases, and that these written instruments be examined for incorrect spelling and for the guidance of this office attention was called to numerous misspelled words which apparently appeared in the ransom notes received by members of the Bremer family.

An examination of all kidnaping and extortion cases in this office was made, and all ransom notes or other communications involved therein were examined closely for misspelled words similar to those set forth in the reference letter, without affirmative results.

The St. Paul Division office has requested this office to locate one PAULA HARMON, who formerly resided in Beaumont, Texas. Our investigation at Beaumont indicates that Paula Harmon left there in May or June, 1933 for Chicago. In June or July, 1932 she married one DOYLE BENTON at Lake Charles, La.; her first husband was DENNIS WOOD. Since her last marriage she has lived with Dennis Wood and THEO RILEY. The purpose of her trip to Chicago was to have an operation on her nose, which was disfigured in an automobile accident in Louisiana sometime in 1931. She has not been heard from in Beaumont since her departure in May or June, 1933. Mr. Hardin, an attorney with the firm of Pugio, Bell & Hardin, Lake Charles, La., represented Paula Harmon in a suit against a surety company in connection with her accident. It is believed that possibly information might be obtained from Mr. Hardin which would reveal the present whereabouts of Paula Harmon.

It was further learned that Paula Harmon's face was so disfigured in the automobile accident that she could not be now recognized; however, photographs were taken for her attorneys in Lake Charles, La., and if possible one should be secured showing her present appearance. 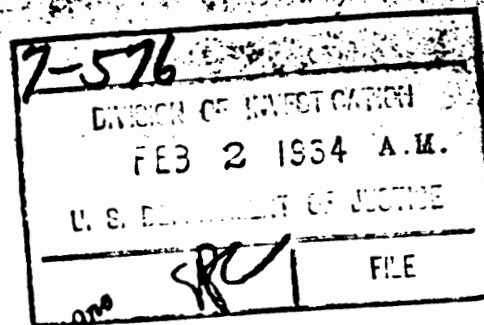

In compliance with telephonic request from the Chicago Division Office, I communicated with Lieutenant Van Loomis in charge of the Detective Division of the Michigan State Police at East Lansing, for the purpose of securing the original log used by the individuals who robbed the First State Bank at Holland, Michigan, on September 29, 1932, which log gave directions of the roads to follow and was found in the abandoned automobile following the robbery.

Lieutenant Loomis who is very familiar with this matter informed me that as far as he knew the State Police had never been in possession of the original log which was typewritten, and also he did not know of any carbon copies of same. He stated that his office did have several photostatic copies, and that one had been forwarded to the Division in compliance with the request of Special Agent Metcalfe of the Chicago Office on January 28, 1934.

Lieutenant Loomis stated that he was of the opinion that the Burns Detective Agency in Chicago, who was interested in this case perhaps would be in possession of the original log. He was informed however that this organization had been contacted by our office at Chicago and it was their thought that the original was in the possession of the State Police.

Lieutenant Loomis made several inquiries throughout his organization regarding this particular matter and later again notified me that he was unable to secure any information as to the possible whereabouts of the original log.

With reference to the crank letters which are being received from the St. Paul Office in connection with the Bremer case, I have discussed them with Mr. Cowley who advised that he believed it the intention of the Division to institute investigation as new extortion cases any letter containing a threat in itself. Accordingly, I am having photostatic copies prepared immediately of all the previous letters and will submit them to Mr. Cowley with the request that after considering them he indicate which, if any, are to be treated as new extortion cases, in order that the usual fingerprint examination may be made here.

With reference to the letter dated St. Paul, January 31, 1934, four crank, information and anonymous letters were received, which are listed below for record purposes. Photostatic copies of these are being made and will be forwarded to the Division. The originals are being retained here and all of them will be examined as to handwriting with a view to determining if the handwriting is identical with any previous notes received in connection with this case. Upon receipt of information as to which will be treated as new cases, the usual fingerprint examination will be made.

1. Anonymous letter postmarked Minneapolis, Minn., Jan. 29, 1934, addressed to Mr. Frank J. Blake and signed "L", the first sentence of which reads "The gray goose garage is on 9th St. between 3rd & 4th Avenues So., Mpls., or 314 -".
2. Anonymous letter postmarked Minneapolis, Minn., Jan. 30, 1934, addressed to Mr. Adolph Bremer, the first sentence of which reads "Now that this case has left the headlines we will give you a chance."
3. Anonymous letter postmarked St. Paul, Minn., Jan. 25, 1934, addressed to U. S. Secret Service Dept., the first sentence of which reads "Three or four mysterious people at 666 Laurel Ave 2nd floor".
4. Letter postmarked Springfield, Missouri, Jan. 25, 1934, addressed to Mr. C. H. Varley, Chief of Bureau of Investigation, Kansas City, Mo., and signed G. K. Weed.

Reference is made to my letter of February 3, 1934, concerning the above-captioned case.

Prior to telephonic conversation with Mr. Clegg on this date, the writer again interviewed Pat Crowe, who called at the Philadelphia Division Office, and he advised that if Mr. Nathan obtained assurance from the Victim's father that he (Crowe) would receive 5% of any ransom money recovered, he would then turn the information over to me or to Mr. Nathan. I then telephoned Mr. Clegg, who advised that I inform Crowe that the necessary arrangements were perfected. Crowe informed me that he would not turn any information over unless he was permitted to go to Washington where he would turn the information over to Director Hoover if he had a witness, with whom he was acquainted, present, or in lieu thereof unless Detective Sweeney of St. Paul, Minn., would assure Crowe that the Government will lay down and make no arrests in the Bremer case until the ransom money is paid and the Victim is returned.

I spent two hours arguing with Crowe, but without result. Finally, he stated that if I would call a Catholic priest and have him present he would give the information by telephone to Mr. Nathan. In the next breath he informed that he had not made the statement to me when I reiterated his remark. He variously stated that he would give the information if Captain Creedon or Inspector Duffy were present in the office, and then denied that he had said this.

Crowe became very incensed when informed on several occasions that his refusal to divulge information, which he admitted he had in his possession, would place him in serious difficulty inasmuch as a

penalty is provided under the Federal laws for failure to disclose information concerning a Federal offense. His only reaction to such statements was to remark that he did not care whether he lived and would welcome going to jail. During the course of conversation, Crowe informed me that he had known the identity of the Pennagrove, N. J., bank robbers before the police made arrests. This is just another of his haphazard statements which mean nothing, in my opinion. The Pennagrove case concerned the robbery of a pay roll by several desperadoes, which took place on Thursday, February 1, 1934, and concerning which the police made arrests on February 3rd.

Crowe is an old reprobate, and in my opinion would not receive the confidence of any criminals—certainly not criminals of the type that kidnapped Bremer. He uses what change he can beg or borrow to buy liquor.

I telephoned Mr. Nathan at St. Paul, and he informed me that he would not dignify Crowe by talking with him inasmuch as he feels as I do that Crowe possesses no information. Mr. Nathan informed me that in the event Crowe would agree to furnish the information without taking into our confidence any outsiders, he would talk with him, but otherwise Mr. Nathan felt that it would serve no good purpose to talk with Crowe.

I conferred with United States Attorney Charles D. McAvoy today and advised him of Crowe's refusal to divulge information, which he alleged he had in his possession concerning the identity of the kidnapers, and he informed me that he was thoroughly convinced that Crowe is a publicity seeker, and he did not desire to take any action against him because to do so would give Crowe publicity. In addition thereto, Mr. McAvoy said he can place no significance in the information allegedly in Crowe's possession.

I am transmitting to the St. Paul Office for its information a copy of my letter dated February 3, 1934, to the Division.

Mr. Stewart's residence and place of occupation were ascertained through further inquiry by the above mentioned agents at the office of Swan Lorish and Caspers, Inc., 1959 East 71st Street, Chicago. He would like to have the chart returned to him when it has served its purpose.

Reference is made to long distance telephone call received from your office last night requesting that this office determine whether Geo Verne Sankey, subject of Detroit File 7-2 entitled Geo Verne Sankey with aliases - Fugitive, et al., Charles Boettcher II, Victim, Kidnaping, had registered at the Field Hotel in Detroit under the name of "W. E. Clark and wife" at any time during the past six months and especially between January 15 and 19, 1934.

Please be advised that Special Agent L. D. Sweeney personally checked the registration records at the Field Hotel, which is located at 445 Field Avenue, Detroit, from June 1, 1933 to the present date and was successful in locating the following registrations of W. E. Clark:

Registration card #727 reflects that Mr. and Mrs. W. E. Clark of 3746 Sheffield, Chicago, checked in to said hotel on 8/1/33 and were assigned room 401, rate \$3.00; that they remained at this hotel for two nights. Mr. J. Moore, Manager of the above hotel, registered these people in on this occasion. For identification purposes at the hotel, their folio number is 4945.

Registration card #798 dated 8/15/33 reflects that W. E. Clark, address Council Bluffs, Iowa, registered in and was assigned to room 201 at a rate of \$2.00. He remained at this hotel one night. This registration may be identified at the hotel through folio #5135.

Registration card #1179 dated 10/24/33 reflects that J. W. Clark and wife of Chicago, Illinois registered in and were assigned room 150 at a rate of \$2.00 per day. They remained at the hotel one night. The hotel folio number of this registration is 6512. [Note: While the initials of this party are "J.W." instead of "W. E." Clark, a comparison of the handwriting would indicate that they are one and the same person.]

Registration card #2950 reflects that W. E. Clark, address Chicago, registered in said hotel on 1/16/34 and was assigned room 206 at a rate of \$1.50 per day. He remained at the hotel one day. The hotel folio representing this registration is 7462. Clark on this occasion was registered in by Mr. W. R. Warren, night clerk.

Mr. W. R. Warren, night clerk, Field Hotel, who registered Clark in on January 16, 1934 informed Agent Sosey that he does not recall whether Clark was driving an automobile on this occasion or not. He did state, however, that since the register reflects only Clark's signature and the fact that he was assigned to a single room, he could fairly definitely state that the latter was not accompanied by a woman or other person.

Upon viewing the photograph of Reo Verne Sankey, Mr. Warren advised that he would be unable to definitely state whether W. E. Clark and Sankey are one and the same person. He did state, however, that the facial characteristics of Sankey are very familiar to him and that it is possible that the latter had been seen by him at the hotel within the past few months.

Mr. J. Moore, Manager of the Field Hotel who had registered W. E. Clark on a previous occasion, when interviewed stated that he does not recall the matter. He was also unable to identify Sankey's photograph as that of anyone known to or observed by him at the Field Hotel.

Gilbert Woods, bellboy at the above hotel, was also interviewed and upon reviewing the photograph of Reo Verne Sankey advised that he is quite definitely certain he saw the latter although he cannot recall where or when. He is of the opinion, however, that it was at the above hotel, since he has been employed there regularly for the past year.

In pursuance of the telephonic instructions received on January 28, 1934, from Assistant Director H. H. Clegg, interview was had on the same night with Chief of Police Peter Lievens, by Special Agent J. J. Metcalfe of this office.

Mr. Lievens after searching all his records advised that he believed he had turned over the original plans of escape that were left by the bandits at the scene of the robbery of the First State Bank in Holland, Michigan in September, 1932, to the Michigan State Police at East Lansing, Michigan. Mr. Lievens communicated with the Michigan State Police to determine if these plans were in the hands of Sergeant H. I. Marmon, and was subsequently advised that the plans were at that place. Agent Metcalfe then conversed with Detective Harold Mulbar of the Michigan State Police, and requested him to forward the original plans by Special Delivery, Air Mail, to the Division, with instructions on the inner envelope that they were to be transmitted to the laboratory. Mr. Mulbar advised that these papers would be forwarded immediately. Chief Lievens was informed as to the necessity for these plans being sent to Washington, but this information was not communicated to the Michigan State Police, as it was deemed inadvisable and unnecessary after conversation with Chief Lievens. Accordingly the title: re Bremer kidnaping case, will not appear on the envelope containing these plans which is being forwarded to the Division. Chief Lievens requested that the plans be returned to him at Holland, Michigan after they have served their purpose in Washington.

Chief Lievens stated that the plans which are being forwarded by the Michigan State Police are original carbon copies. He said that he believes that there were two copies of these plans found at the time of the bank robbery, and that one of them was the original plan and the other an original carbon copy of the plan. He was not certain as to this however, and stated that it is possible that both copies were original carbon copies. With reference to the other copy he said that he believed that to be in the hands of either the Burns Detective Agency in Chicago, or in the hands of Mr. Stewart, who was formerly employed by that detective agency.

At the William J. Burns Detective Agency, 10 South LaSalle Street, Chicago, interview was today had by Special Agent Metcalfe with Mr. A. R. Lapitz, and one of the Burns Detectives, a Mr. Crowe. Mr. Lapitz searched his files but could find no original plans. However, he did discover a photostatic copy of these plans, and this photostatic copy is being transmitted to you herewith. Mr. Crowe said that he understood that there was only one original copy of these plans, and that that was the copy in the possession of the Michigan State Police. He did not know whether this was the original copy or an original carbon copy but he called attention to the fact that the records of the Burns Detective Agency show that these plans which were at one time in the hands of Mr. Stewart, consisted of "typewriting on half sheets of 8½ by 11 yellow second sheets, devoid of any water marks, and of common stock paper obtainable anywhere." Mr. Crowe said that it is very possible that the fact that these plans were on yellow paper may have led some persons to believe that they were original carbon copies instead of originals. Mr. Lapitz and Mr. Crowe stated that if there exists any other original copy such copy might be in the hands of Mr. Stewart, who is C. M. Stewart, and whose last known address was 6102 Jeffery Street, Chicago, Apartment 303.

Mr. Crowe expressed some concern over the inquiry being made regarding these papers, as he thought that the Chicago office was endeavoring to investigate the Burns Detective Agency. He explained that there has been considerable friction between this detective agency and the Chief of Police at Holland, Michigan, and that the Chief at Holland was of the opinion that the Burns Detective Agency was endeavoring to conceal the identity or whereabouts of the persons who perpetrated the crime of robbing the First State Bank at Holland. He said that there existed some jealousy on the part of the Holland Police, owing to the fact that the plans of escape, and the bullets of the robbers, were originally discovered by Mr. Stewart of the detective agency, and that the Chief of Police at Holland had claimed that these articles were in fact found by the Holland Police, and subsequently turned over to the Burns Detective Agency, who then attempted to take credit for the discovery of the articles. Mr. Crowe stated he understood that the matter had also been referred to Senator Vandenberg of Michigan. In this connection it may be noted that the same information was furnished Agent Metcalfe by Chief Lievense, who said that Stewart failed to appear at Springfield, Illinois at the time extradition proceedings were taking place for the purpose of removing a suspect to Michigan, and that Stewart appeared at the last minute, on behalf of the suspect instead of on behalf of the Burns Detective Agency, as he should have. Chief Lievense also stated that in view of the fact that the plans and bullets which were obtained by Stewart were given to him by the Holland Police on the theory that he knew more about matters of that kind, and that these articles were never returned

to the Holland Police, he was of the opinion that possibly the Burns Detective Agency was not endeavoring to solve the case, but was attempting to shield the criminals. The Chief also expressed considerable criticism of the Chicago Police Department, for its lack of cooperation in solving the case, and helping to extradite suspects, and he said that he had referred these matters to Senator Vandenberg, who replied that he was very much interested and would have the matter looked into.

Agent Metcalfe assured Mr. Crowe of the Burns Detective Agency that this Division was in no sense investigating the Burns Detective Agency, but merely desired the typewritten charts to make laboratory comparisons.

Efforts to locate Mr. C. M. Stewart were unavailing. The Real Estate company of Swan, Lorish and Caspers, Inc. 1959 East 71st Street, Chicago, advised that Mr. Stewart moved from the premises at 7102 Jeffery Street, about one year ago and left no forwarding address. The South Shore Station of the Post Office, 2207 E. 75th Street, Chicago, advised that they had no removal address on file for C. M. Stewart as of 7102 Jeffery Street. The telephone company advised that telephone number Butterfield 0682, which was formerly the telephone number of C.M. Stewart, is no longer in operation, and that they now have no telephone number listed in the name of C.M. Stewart. In this connection your attention is again respectfully invited to the fact that Mr. Crowe was very firm in his belief that only one copy of the plans of escape was ever in existence, and that this is the copy which the Michigan State Police are forwarding to you.

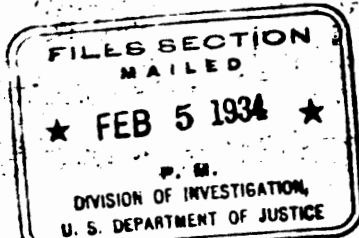

Investigation conducted at the time of the apprehension of Verne Sankey disclosed that he had had a brokerage account at the E. A. Pierce Company in Chicago. The salesman with whom he dealt there stated that Sankey advised him on January 15, 1934, that he would be out of town for a few days. Sankey did not appear at the brokerage house from January 15 to January 19, 1934. Edward C. Brewer was kidnaped on January 17, 1934. Sankey has stated that he has made several trips to Detroit, Michigan, and that when there he and the girl with whom he has been living, Angeline Sindzenki, alias Helen Hatten, stayed at the Field Hotel, which, according to Sankey, is a short distance off of Jefferson Street. At this hotel they registered as Mr. and Mrs. T. E. Clark.

As requested by telephone last night, it is desired that you conduct investigation at this hotel to determine the dates on which Sankey may have stayed at this hotel during the last six months, and especially to determine whether he was there around January 17, 1934.

Receipt is acknowledged of the records of all released prisoners from the St. Cloud, Minnesota State Reformatory forwarded by your Office to this Office upon our request. Please be advised that Special Agent J. T. Martin, of this Bureau Office, interviewed [redacted]

[redacted] advised Agent Martin, while he was incarcerated at the Minnesota State Penitentiary at St. Cloud he became acquainted with several of the prisoners who were committed from St. Paul, and that he played on the baseball team and associated with these prisoners while he was in that institution. He stated that in the summer of 1932, about June or July, a prisoner by the name of Blackfelner was committed to this Reformatory, receiving a sentence of from five to forty years for a bank robbery and a shooting. He stated that right after Blackfelner came from the institution he associated [redacted] the other prisoners whose names will be set out below, and that on several Saturday afternoons Blackfelner [redacted] the others got together on the baseball diamond of the Reformatory and Blackfelner told the other prisoners that he had observed Bremer's young daughter, about seven or eight years of age, being taken to school by the private chauffeur every morning about 8:30 A.M. He told the other prisoners that this young lady's people were worth a lot of money; that her father was a president of a bank in St. Paul, and that she would, undoubtedly, be a very good victim in a kidnapping case; and that he discussed the possibility of snatching her in front of her home. Blackfelner knew that these other men were being released in a short time on parole, and it was his desire that they kidnap Bremer's daughter and obtain money for her release, and they were to use the same to try to obtain the release of Blackfelner.

In regard to the letter from the Chicago Division Office to your Office, dated January 26, 1934, indicating that an informant had supplied information that Charles O. Connors, with aliases, and possibly one William Sullivan, alias Crab, had been connected with this case, a picture of Crab-Sullivan has been obtained.

This picture is Chicago Police Group Picture #700, and in addition to the picture of William Sullivan, there is also a picture of Frank "Porky" Dillon. Both Sullivan and Dillon are known associates of Connors, Banhart and other notorious members of the so-called Porky Gang. Dillon, at least, is suspected of implication in mail robberies with Connors.

There is no detailed description of Sullivan. He is now forty-five years of age, and that his height is about 5' 3/4". His fingerprints were taken at the Chicago Police Department and he was assigned classification:

17 1/2 0 1/2

A copy of these fingerprints was not forwarded to the Division at Washington, D. C., since Sullivan was arrested merely as a suspect and was never charged with a crime other than disorderly conduct. The records show that Sullivan forfeited his bond on the disorderly charge on 1/16/33. At the time of his arrest Sullivan gave the address 853 North Ridgeway Avenue, Chicago, Illinois.

The city directory lists the following individuals as residing at this address:

As the city directory indicates that Frances is employed as a bookkeeper for the Americus Watch Company, Mr. E. H. Rosenberg, Secretary and Treasurer of the Americus Watch Company, was interviewed at 606 Metropolitan Building by Special Agent D. L. Nicholson under the pretext of ascertaining the identity of Jack Moranz in order that he could be contacted in relation to an acquaintance of his. Mr. Rosenberg advised that Frances Moranz has been employed by the Americus Watch Company

as bookkeeper for several years and is considered to be very reliable and efficient; that she has a brother, Jack Moranz, also known as Colonel Moranz, although Mr. Rosenberg does not know the origin of this title; that Jack Moranz during the World War was a war correspondent and presently is engaged in writing feature articles and is also a cartoonist. Also that another brother, Arthur Moranz, is a musician and artist, and is presently in the company of Jack somewhere in the east where they spend a greater part of their time. Further that Jack Moranz is married and the father of one child, his wife and child being with him in the east. Mr. Rosenberg further advised that the Moranz family is Jewish and from his association with them considered them to be very reliable and dependable.

All of the above inquiries were made without disclosing the nature of this investigation, or the name of the case in connection with which these inquiries have been made.

Confirming our telephone conversation of last evening relative to information received at this office about the Bremer kidnaping case, you are advised that Mr. J. P. Power from the Public Defender's Office, Criminal Courts Building, Chicago, Illinois, called at this office and advised that on February 2, 1934, one of the members of his office advised him that [REDACTED]

[REDACTED] told his man that he had, possibly, important information concerning the Bremer kidnaping case.

Mr. Power stated that when he was advised of this by his man he went to the County Jail and interviewed [REDACTED]. Mr. Power stated [REDACTED] was formerly a prisoner in the penitentiary at St. Cloud, Minnesota, and was released from that institution on [REDACTED]. Mr. Power stated [REDACTED] told him that while he was incarcerated in the penitentiary at St. Cloud, he, together with several others, formulated a plan to kidnap the young daughter of the present victim in the Bremer case. [REDACTED] was released from the penitentiary at St. Cloud on [REDACTED] and immediately left there without contacting or conferring with the other prisoners regarding their conspiracy to kidnap Bremer's daughter. He stated that he recalls one of the prisoners names who was doing time with him; namely, Blackfeler.

According to Mr. Power, [REDACTED] that Blackfeler had been committed to the St. Cloud institution from Harris, Minnesota for a bank job. [REDACTED] that he would be able to identify the other prisoners in the institution who were in this conspiracy with him if the names and addresses of the prisoners committed to the St. Cloud institution from St. Paul who had been

The word concerning is spelled conserning. the word penalty is spelled penelty.

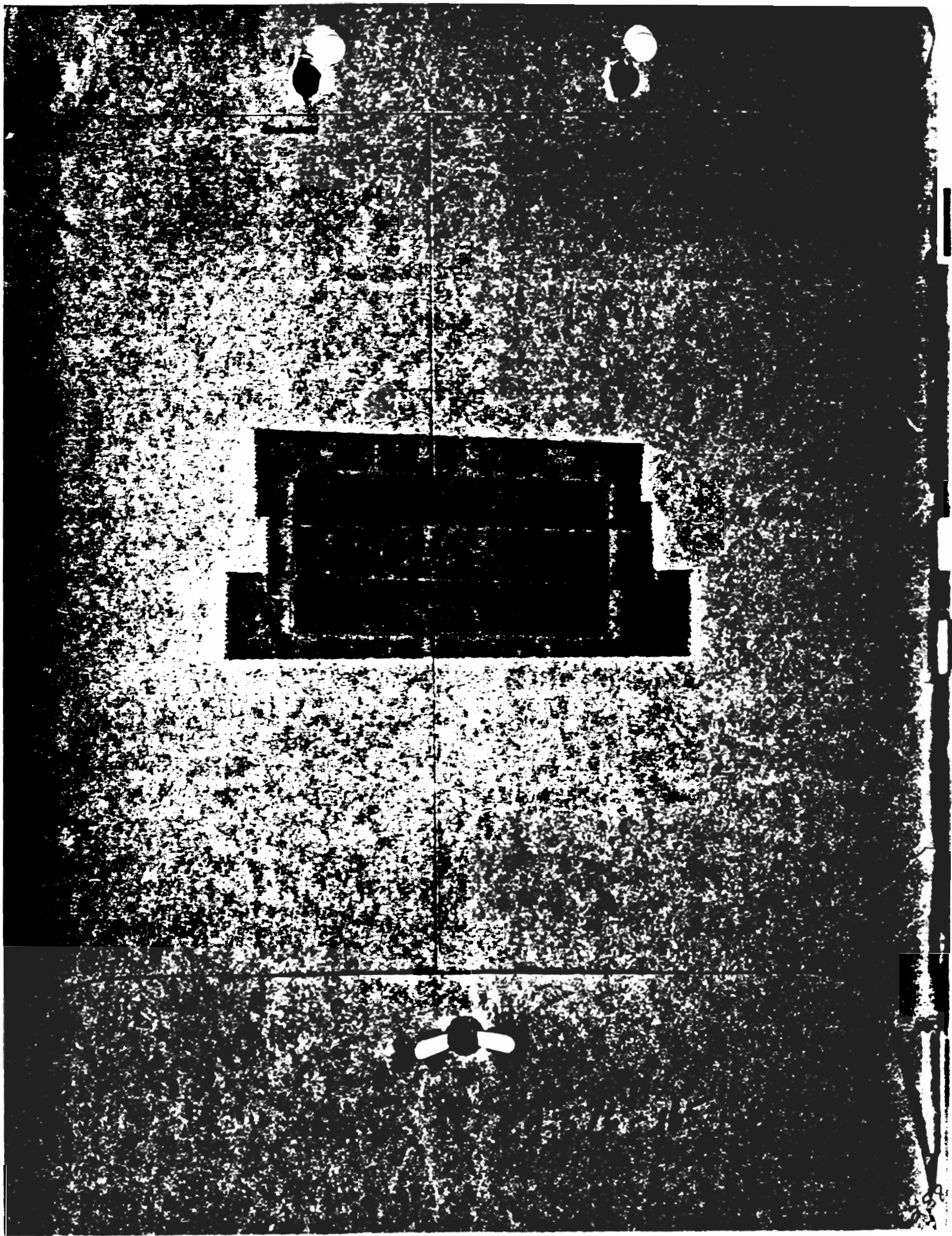

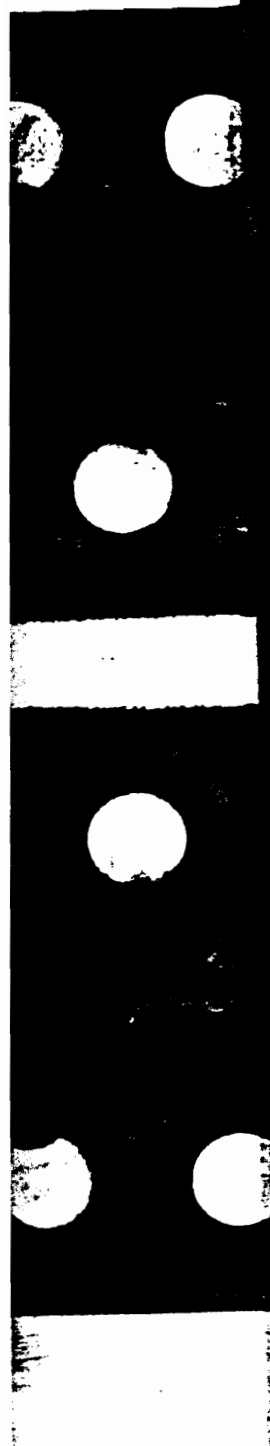

At the C.W.A. camp, whose men are now employed at various points on the Highland Park Golf Course, the Foreman GEORGE KANE and Assistant Foreman C. E. SPENCER and HERB BJORKLAND were contacted to determine whether or not employees of the C.W.A. project were in a position to notice the transfer of the victim, EDWARD BREMER, to the kidnapers' car on Edgumbe Road. MR. KANE suggested that more satisfactory results would be obtained if general inquiry were made among the men by the foremen rather than direct contact by this agent.

The above foremen were again contacted on February 2nd and they stated that none of the men employed on any of the park projects had actually seen the transfer although one man, HERB LUNDQUIST, had stated that he noticed a parked car in the vicinity of the THORNTON home at about 8:30 on the morning of January 17th.

MR. LUNDQUIST was interviewed by agent and he advised that on the morning of the 17th of January, about 8:30, he noticed a large sedan parked on Edgumbe Road; that there was no one in the immediate vicinity and he looked into the car but observed no blood; that when he returned again to the automobile some time later, the car was still there.

On February 3rd, agent accompanied LUNDQUIST to the spot where the car had been seen by him and it was noted that this car was parked near the THORNTON home and not in the position where victim's car was found, which was west of the THORNTON home. After considerable questioning, MR. LUNDQUIST stated that about 7:05 on the morning of January 17th, when he came to work he noted this car, which he now believes to have been a Hudson Sedan, standing about half a block east of the THORNTON home and facing west; that the top of the car was ajar, and believing that someone was out of gas or needed assistance, he looked into the automobile and then proceeded on to the C.W.A. project down near the Highland Park Golf Course; that about 8:30 a.m., while looking for wood with which to build a fire, he saw the car in the same position but that it had been turned around and was then facing east.

Because of the position of this bar and the fact that it was removed, according to LUNDQUIST, at about 9:30 on the morning of the 17th and was not in the position where the victim's car was found, it is not believed that this automobile had any connection with this case.

MR. LUNDQUIST described the car as being dark blue and, to the best of his recollection, a Hudson Sedan.

Further inquiry among the men of the C.W.A. project failed to find anyone who saw either of the cars in which the victim and the kidnapers drove on Edgumbe Road or the transfer of the victim to the kidnapers' car.

MR. KANE, the foreman, however, advised that practically all of the men had during the course of the day noted the victim's automobile parked in the position in which it was later found and that they believed this car to be that of some real estate agent inasmuch as real estate men were accustomed to park their cars at various points in the subdivision and leave same for considerable periods of time.

MR. LUNDQUIST, who is a truck driver of the C.W.A. project, resides at 913 Rustis, St. Paul, and is on duty during the mornings at the C.W.A. works. Foremen C. E. SPENCER and HERB BJORKLAND can be reached by telephone Midway 1346 and Dale 5669.

Upon arrival here I consulted FRANK WHEKLOCK, Assistant Chief of Police, and learned that there is no 931 Cecelia St., in Sioux City, which was verified by personal inspection in company with MR. WHEKLOCK. There are numbers 925 and 927, the latter being the end of the 900 block. EARL MORGAN, former Chief of Police and at the present time on the auto theft detail, lives at 1025 Cecelia St., and thru him a check on most of the residents in the vicinity was made. It was found that his wife was still better acquainted with the persons living nearby. However, the parties living at the above two numbers, 925 and 927 are not known to the MORGANS. The old inhabitants of these houses either sold or moved out and rented about a year ago. There is also a house located in the rear of these two places which might bear checking. Inquiry of the druggist, FRED BARNY, who is in the same block as these two houses, revealed that he did not know who resided therein but felt sure he would be able to find out shortly. A party by the name of SMITH has been residing for about a year in the house located in the rear of these two, and is not considered intelligent enough to engage in any criminal work that required some brains.

In the 1100 block there is a suspicious couple, supposed to be insurance agents, man and wife, who have a Nash Sedan about 1931 or 1932 model, large, dark colored, in some respects resembling a Lincoln, bearing Iowa 1933 plates 97-19852. They give the name of MURPHY and the car is said to be registered under that name but nothing is known about them and they appear to be strangers in the town. They have been there since a week ago last Monday. Arrangements are being made so that I may enter their room tomorrow in their absence and try to find out something about them, although it is said that they have no luggage or belongings that are not locked in two suitcases and a brief bag.

MEMORANDUM FOR S. A. C. WERNER HARRY;

Regarding the information given to you by [redacted] to the effect that FOSTER WEATHERBY, 770 North First, had been informed at one time by an individual that this individual would kidnap EDWARD BREMER if he could induce someone to join with him, please be advised that Agent Jack Brennan and myself interviewed FOSTER WEATHERBY and he stated that RICHARD MALCOMSON in September, 1933, had informed WEATHERBY that he would like to kidnap EDWARD BREMER if someone would join with him in the kidnaping. WEATHERBY stated that he suspected that MALCOMSON was such a person who would do the kidnaping. WEATHERBY mentioned that on a previous case, he had given information to the Burns Agency which resulted in apprehending some bank robbers in South Dakota. With reference to this case, he had nothing further to offer except to inquire whether he would be taken care of in the event a reward is given for the apprehension of the kidnapers.

RICHARD MALCOMSON was located at the U. S. Hotel, Third and Robert Streets, and was taken to the Division office and questioned. He stated that sometime last year he had remarked to persons whom he could not now remember except that one was his landlord at 213 West 5th Street when he lived there that since WILLIAM HAMM had been kidnaped, he presumed that EDWARD BREMER would be the next one as BREMER also came of a wealthy brewing family.

A specimen of his handwriting was secured and compared with the letter received by the Postmaster at Minneapolis, which letter stated that EDWARD BREMER'S body could be found in Anoka. There is no similarity in the handwritings.
