Reference is made to the various communications relative to the appearance of the twelve witnesses from Havana, Cuba, at the trial of this matter in St. Paul, Minnesota.

Under date of January 4, 1936 Consul General C. R. Cameron at Havana, Cuba, furnished to Special Agent S. K. McKee \$1030.00 to cover allowances to the various witnesses, same being allowances in lieu of outfits necessary for the trip from Havana, Cuba, to St. Paul, Linnesota, and return.

Transmitted herewith will be found receipts taken by Special Agent McKee from the individual witnesses, along with receipts returned by the witnesses for the expenditures made by them. In several cases small balances existed, and these are being accounted for by the personal check of Special Agent McKee, made payable to the Treasurer of the United States in the sum of \$2.40.

The following is a statement of the sums advanced the various witnesses, the amounts spent by them, and the balances which they returned:



I have the honor to refer to the Department's instruction of Desember 28, 1935 (file No. 102.5), relating to the matter of obtaining witnesses from Cuba for use in the trial of the case of United States V. Harry Sawyer, Cassius McDonald, et al.

I take pleaure in reporting that, in accordance with the blanket authorization for allowances contained in that instruction, the Consulate General, in conjunction with Special Agent McKee, has made the following arrangements with the individual witnesses:

At the time of the purchase of the tickets the local travel agent suggested that fifteen day excursion tickets be purchased at the rate of \$129.88 per ticket, including Pullman accommodation, advising that should the witnesses for any reason be required to remain in St. Paul beyond the period of the validity of the tickets, the tickets might be turned in for six months round-trip tickets by the payment of the difference. Inasmuch as Mr. McKee indicated that he understood the witnesses might be able to leave St. Paul before the expiration of the fifteen day excursion tickets, this is believed to be the proper procedure in the interest of economy. The local agent advises that the six months round-trip ticket would cost \$148.28, a difference of \$18.40 per ticket.

In view of the fact that certain of the witnesses are not in a position to finance their trip out of their own pocket, and in view of the authorisation for an advance in the individual case of Juan P. Ruis, as contained in the Department's instruction of December 20, 1935 (file 102.5/1171), it has appeared proper to make a seven day advance to each of the twelve witnesses of their per diem in lieu of expenses and per diem as compensation. This has totaled \$609.00.

As regards the allowance in lieu of an outfit, the Consulate General has borne in mind the statement contained in the Department's instruction of December 28, 1935 (file No. 102.5/1178), that all expenses to be insurred must be kept at the absolute minimum. As the result, wherever possible the witnesses have been required to borrow what heavy elothing they will heed. Where this has been impossible, it has been arranged with them that they purchase the needed elothing in Miami, Florida, rather than in Habana, inasmuch as prices in Miami are reported to be lower than here for such apparel. Unfortunately, however, exact prices are not available, and so that the witnesses might not obtain the idea that they are expected to spend the total of the alloweness as itemized above, it has appeared advisable for the Consulate General to deliver these sums, totaling \$1050.00, to Mr. Samuel K. McKee, special Agent of the Department of Justice, assigned to escorting these witnesses to St. Paul, quest that he supervise the necessary purchases in Mismi, sollecting merchants' receipts wherever possible, he to account to his own Department for the portion spent, refunding any balance. Consulate General believe that there will be a defimite unspent belance, but liberal allowances have been made in each instance to insure that Mr. NeKee will ... have on hand sufficient cash. The Consulate General will submit an assounting to the Department as soon as possible, but in advance the Department is advised that funds have been expended as follows: (a) \$1,558.56 for 12 round-trip tickets (15day excursion) between Habana and St. Paul, Minn, at \$129.88 per ticket. (b) \$609. for 7 day advances for per diem in lieu of expenses and per diem as compensation, as itemized above. (e) \$1030. advanced to Mr. McKee as allowances in lieu of cutfits for the twelve witnesses as itemized above, making a total of \$5,197.56. The witnesses will leave Habana on January 5, 1936, by the P. & O. Steamship Company for Mismi. From there they have been routed via Jacksonville, Florida, Albany, Georgia, Atlanta, Georgia, Cincinnati, Ohio, and Chicago, Illinois, to St. Paul, Minnesota, all witnesses to travel in one Pullman ear which will make the entire trip, thus removing the necessity of the witnesses making any change between Miami and St. Paul. 



BUMMARY REPORT

This report is being submitted for the purpose of setting forth known data as to Alvin Karpis for the information of all field offices. It is intended to deal with his early life, oriminal records available photographs, present description, relatives, correspondents, associates, informents, former places of residence, and other data which should be of value in conducting future investigations looking toward his apprehension. Carlo San

Interviews with the parents and sisters of subject Alvin Karpis revealed that he was born in Montreal, Canada on August 10, 1907. The parents were born in that portion of Russia which is now Lithuania, and have never became acturalized citizens of this country. try.

After coming to North America Karpie parents lived for short times in New York City and Grand Rapids, Michigan before moving to Montreal, where their only son was born, The family moved to Topeka, Kansas when subject was about two years old and the elder Karpavicz was employed by the Santa Fe Railroad for a number of years as a painter. In about 1925 the family moved to Chicago, Illinois and Alvin worked in various bakeries for over a year. He was not strong physically and was told by a doctor that he had leskage of the heart and should reste

Alvin Karpis went back to Topeka, Kansas to live with his eldest sister, Mrs. Albert Grooms, 1234 Monroe Street, and it was during

this period that he became involved in his first difficulty with the law. He was sentenced to the State Industrial Reformatory at Hutchinson, Kese. February 25, 1926 to serve ten years for the crime of burglary. He escaped from this institution on March 9, 1929 and joined his parents in Chicago, Illinoise He remained at the home of his parents for about ten months and during this time, according to them, he was employed in some capacity by a medical concern the name and location of which they would not divulge. The relatives have stated that they knew Karpis was an escape but also stated that they never had any intention of notifying the authorities of his location. While in Chicago, Illinois Karpis was joined by Lawrence DeVol, and the two of them made trips out of Chicago, being gone approximately two weeks at a time. During one of these trips Karpis was arrested in Kansas City, Missouri, the date being March 23, 1930, for auto larceny and as a safe blower. He was returned to the State Industrial Reformatory at Hutchinson, Kansas as an escaped prisoner. On May 19, 1930 he was transferred to the Kansas State Penitentiary at Lansing Kansas to serve the belance of his term, a manage the serve and the serve and the serve the belance of his term,

Following his release from the Kansas State Penitentiary, Karpis was arrested on June 10, 1931, at Julsa, Oklahoma on a charge of burglary. He was delivered to the authorities at Okmulgee, Oklahoma and on September 11, 1931 was sentenced to four years in the Oklahoma State Penitentiary. He was paroled from this institution.

While confined in the Kansas State Reformatory and Penitentiary and in the Oklahoma State Penitentiary, Karpis became acquainted with such characters as the Barker brothers, Harry Campbell, Volney Davis and others with whom he later became involved in criminal enterprises. Some time shortly after he was released from prison in Oklahoma, Karpis married one Dorothy Slayman of Tulsa, Oklahoma. They visited his parents in Chicago, Illinois during October, 1931 at 1141 North Francisco Avenue, and during this visit Karpis went away for a trip. The wife received a letter from him dated West Plains, Missouri advising that he was sick, and she went to join him. During this period, or on December 19, 1931 Sheriff C. R. Kelley of West Plains, Missouri was killed.

Upon returning to the Karpavics family in Chicago, Illinois
Dorothy Slayman advised that when she was in West Plains, she learned that
Karpis had been living with Fred Barker, Mrs. Kate Barker, and a paramour of Mrs. Barker, who was a man named A. W. Dunlop, and who was later found
dead in the vicinity of Webster, Wisconsin. Dorothy Slayman was taken
into custody for questioning by the authorities at West Plains, but she
was later released. It is not known that this woman has had any association with Karpis since the West Plains, Missouri affair. She divorced

him at Tulsa, Oklahoma on November 19, 1935.

The family of Karpis claims not to have seen him since October, 1931, and state that he never communicates with them by mail, telephone, or by "next friends". They are frank to state that they will not cooperate in any way with the Government in efforts to cause his apprehension. They state they would rather see him in the penitentiary for life rather than have him killed, but still hold the position that they will not aid the Government in apprehending him.

Because of the recent friendship between the Karpavicz femily and the Delaney family, of which Karpis' most recent consort, and mother of his infant son -Dolores Delaney, is a member; also on account of the apparent good financial condition of the father, and the fact that he is caring for the illegitimate son of Karpis, very little if any credence is placed in the statements of the family that they are not in contact with this subject.

NOTE: Information supplied by Volney Davis after his arrest is that Karpis, the last time he saw him, had prominent scars on his face extending downward below the ears, as a result of an operation by Dr. Joseph P.Moran. Davis said that Karpis' ears were originally without lebes and that he had a portion of ear flesh cut away in order to form lebes and change his appearance. According to Davis, Dr. Moran attempted to lift one of Karpis' eyebrows, and in so doing cut the flesh on the hairline, with the result that a scar is now visible under the hairline. Davis did not know which eyebrow Doctor Moran attempted to lift. Mrs.Leonora Bermedez of Varadero Beach, Cuba has informed that the scars on Karpis' face run downward from the base of his ears, and are very noticeable in that they have a reddish color and protrude from the normal akin line, the protrusion being of the type caused by an infection during the process of healing. Volney Davis has also stated that the operations on the face of Karpis did not cause any visible change in his facial appearance with the exception of the ear lobes which were created at the time.

#### CRIMES KNOWN TO HAVE BEEN COMMITTED BY ALVIN KARPIS

On February 25, 1926 Alvin Karpis was committed to the State Industrial Reformatory, Hutchinson, Kansas for the crime of burglary. This offense consisted of breaking into a store at Notawoka, Kansas and was committed with two other boys.

Alvin Karpis was arrested at Kansas City, Missouri on March 22, 1930 for auto larceny and safe blowing, the result being his return to the Kansas State Reformatory, from where he had escaped, and his later transfer to the Kansas State Penitentiary.

Alvin Karpis was arrested on June 10, 1951 with Fred Barker and Sam Coker by the Tulsa, Oklahoma Police on a charge of investigation.

He was turned over to the Okmulgee, Oklahoma Police on June 11, 1931, and on September 10, 1931 was convicted of burglary and sentence ed to the Oklahoma State Penitentiary, from where he was shortly paroled. This offense was a jewel burglary at Hemstetta, Oklahoma.

On December 18, 1951 Alvin Karpis and Fred Barker robbed a store at West Plains, Missouri and merchandise taken at the time was found in a cottage occupied by them, Kate Barker, and A. W. Dunlop, near Theyer, Missouri.

Alvin Karpis and Fred Barker killed Sheriff C. R. Kelley of West Plains, Missouri on December 19, 1951 as he attempted to questioned them about the store robbery on the previous day, after recognizing the car they were driving.

On April 26, 1932 the body of A. W. Dunlop was found on the shores of Lake Frenstead, near Webster, Wisconsin. This man was living with Kate Barker at 1051 Roberts Street, St.Paul, Minnesota, and Karpis and Fred Barker were also living in this house. They had to leave upon receipt of information that the place was to be raided by the Police, Rumors from the underworld have it that Dunlop was killed by them because of being suspected of informing the Police of their location.

On June 17, 1932 Alvin Karpis, Fred Barker, Francis Keating, Thomas Holden, Harvey Bailey, Larry DuVal and Bernard Phillips robbed the Fort Scott, Kansas Bank. Karpis was living with Fred and Ma Barker at 4804 Jefferson Street, Kansas City, Missouri at the time and the loot was split at this place.

On July 26, 1932 at Concordia, Kansas, the Cloud City Bank was robbed of approximately \$240,000,000 in bonds and cash by six men. Alvin Karpis, Fred Barker, Larry DuVal, Jess Doyle and Earl Christman were five of the participants.

On August 18, 1932 the body of J. Earl Smith, an attorney from Tulsa, Oklahoma who had represented Harvey Bailey in regard to the Fort Scott Bank robbery was found near the Indian Hills Country Club, Tulsa, Oklahoma. Underworld rumer is that he was killed by Fred Barker and Alvin Karpis, for his dilatory tactics in handling Bailey's case.

On December 16, 1952 the Third Northwestern Bank, Minneapolis, Minnesota was robbed by seven men of \$15,000,00. Two police officers and a private citizen were killed during the getaway. The participants in this robbery were Alvin Karpis, Jess Doyle, Fred Barker, Dos Barker, Larry Duval, Verne Miller and William Weaver.

On April 4, 1935 the Fairbury, Nebraska Bank was robbed of \$25,000,000 in cash and \$100,000,000 in bonds by eight men. The participants according to information, were Alvin Karpis, Fred Barker, Volney Davis, Earl Christman, Eddie Green, Frank Nash, Jess Doyle and Doc Barker.

On June 9, 1933 the State Bank of Ihlen, Minnesota was robbed. Alvin Karpis is wanted by the Sheriff's office at Pipestone, Minnesota for this robbery.

On June 15, 1955 William A. Hamm, Jr. was kidnaped at St. Paul, Minnesota by four men. He was released on June 19, 1955 after \$100,000 had been paid as ransom. The actual kidnapers were Alvin Karpis, Doc Barker Charles J. Fitzgerald and Bryan Bolton. Additional conspirators were Fred Goetz and Fred Barker.

On August 50, 1953 six bandits staged a payroll robbery at South St.Paul, Minnesota in which \$30,000 was taken. Two police officers were shot during this robbery. The participants were Alvin Karpis, Fred Barker, Dos Barker, Charles J. Fitzgerald, Harry Campbell and Babs Moran. Fitzgerald was shot in the hip during the getaway.

On September 22, 1955, two bank messengers were held up at Jackson Boulevard and LaSalle St. Chicago, Illinois and two sacks of valueless registered mail were taken. Officer Miles Cunningham was shot to death during the getaway. The participants in this robbery were Alvin Karpis, Fred Goetz, Harry Sawyer, Bryan Bolton, Fred Barker and Doc Barker.

On January 17, 1934 Edward George Bremer was kidnaped at St. Paul, Minnesota. He was released on February 7, 1934 after \$200,000,000 ransom had been paid. Active participants in this kidnaping were Alvin Karpis, Fred Barker, Doc Barker, Volney Davis, Harry Campbell, William Weaver, Bryan Bolton and Fred Goetz. Many other persons were involved in various phases of this crime.

On November 7, 1935 a mail robbery was staged at Garrettsvills, Ohio by five or six men. Information is that Alvin Earpis may have participated in this robbery.

Listed hereinafter in alphabetical arrangement will be found data as to persons who have been associated with Alvin Karpis in way of eriminal activities, harboring, contacts, friends, associates and relatives.

Informant, Toledo, Ohio. This individual has proven himself to be a valuable informant, especially in connection with this case. Information as to his identity and means of contacting him can be secured through the Special Agent in Charge of the Cleveland Bureau office. At the present time the matter of maintaining contact with him is being taken care of by Special Agent C. E. Smith of the Cleveland office.

ABEL, PAT, Pueblo, Colorado. Refer to report of Special Agent C. D. White, Los Angeles, California, dated November 16, 1955. Information originating from one George A. DeMoss is that Pat Abel, while confined in the Los Angeles County Jail, informed he had been closely associated with Alvin Karpis. DeMoss stated Abel was to be removed to Pueblo, Colorado for trial on a bank robbery and that he could be located care of a brother, Jim or Herb Abel, 419 West 7th Street, Pueblo, Colorado.

ADAMS, JOSEPH He: Il Commodoro Hotel, Mismi, Florida. Adams is under indictment in United States District Court, Mismi, Florida for harboreing Karpis and for violation of the National Firearms Act. During the fall of 1934 and until the time of the Bureau raid at Oklawsha, Florida he was furnishing a haven for Karpis, the Barkers and Campbell. He is manager of the hotel where he resides and is also interested in the Biseayne Kennel Club at Mismi, Florida. On account of his present inevolvement it is extremely doubtful if Adams will have any further contact with members of this gang, but data as to him is being set out for imformative purposes.

AIGEO HOTEL, Toledo, Ohio. During September, 1934 when the Barkers Karpis gang were fleeing from Cleveland, Ohio, Karpis instructed Delores Delaney to register at this hotel and he later made contact with her there.

ALDERTON, HAROLD, 1215 East Jefferson Street, Kokomo, Indiana, This man maintained a hideout in Bensonville, Illinois where Edward George Bremer was held. He was convicted at St. Paul, Minnesota during Maye 1935 for his part in the kidnaping conspiracy and is now confined at Leavenworth penitentiary.

AMERSHACH, TONY, Gleveland, Ohio. This man is a bodyguard for Art Hebebrand; also a guard and doorman at the Harvard Club. Information is that he was very friendly with Karpis and because of his nearness to Hebebrand he is considered a probably contact for Karpis and Campbell.

ANGUS, BERT, Toledo, Ohio, This man, along with a brother Ted Angus, operates the New Casino Club in Toledo. He was one time a partner of William J. Harrison in a saloon at Calumet City, Illinois, Investigation has shown these brothers to be intimately acquainted with all of the major subjects of this file, in that during the spring of 1934 they harbored the entire gang in Toledo. After the flight of Karpis and Campbell from Atlantic City, New Jersey in 1935 they went to Toledo and were again furnished refuge by the Angus brothers. Bert Angus is reputed to have political connections and is known as a "fixer". The activities of this man should be closely checked for the possibility of a contact by Karpis and Campbell; also because of future prosecution against him on a harboring charge.

ANGUS, MADRIINE, Toledo, Ohio, This woman is the wife of Bert Angus and a sister of Rene Holst, She is acquainted with all of the members of this gang and is a logical contact in Toledo,

ANGUS, THEODORE - "Ted, 4209 North Lockwood Avenue, Toledo, Ohio. This men operates the New Casino Glub in Toledo, Ohio along with his brother Bert Angus. See information set out under the name of Bert Angus as the same applies to this individual.

AUSTIN, BRUNO. This man is well acquainted with the major members of the Barker-Karpis gang. During the latter part of 1934 he was living with the gang in Chicago, Illinois. At the present time he is serving a life sentence at Joliet Penitentiary, Joliet, Illinois on a murder charge.

BAILEY, HARVEY. This individual was a former member of the Barker-Kerpis organization. His speciality was bank robbery. He was convicted in the Urschel kidnaping case at Oklahoma City, Oklahoma and is presently confined at Alcatraz Island penitentiary, San Francisco, California.

BALL, JOHN E., 8126 Ellis Avenue, Chicago, Illinois. This men is intimately acquainted with Eddie Donovan and both of these men are described as known contacts for the Barker-Karpis mobe. Ball was formerly connected with the Green Lantern Tavern, a hangout used by the gang. His criminal record and photograph are available at the Chicago Bureau office.

EANKS, THOMAS, Minneapolis, Minnesota. This man is an underworld contact in the Twin Cities and has been intimately associated with Harry Sawyer for a number of years. Through his associations with Sawyer he became acquainted with the various members of the Barker-Karpis gang, and there is no doubt about him being a contact for the outfit. Information in possession of the Bureau is that Banks participated in the proceeds of the Hamm kidnaping inasmuch as this crime had originally been planned by him and Jack Pfeiffer and Jack Davenport.

BARRY, EDITH. 524 Emilia belows, Toledo, Ohio, telephone Adams 4612. Taformation through informants is that Edith Berry harbored Karpis and Gampbell in her tall house at the above address formwing their escape from Atlantic City, New Jersey on January 20,1935. She is likewise supposed to have lived with them and a prostitute named Lillian Pool for a short time during the summer of 1935 at Codar Point, Ohio, a lake resort east of Toledo, Ohio. Her connection with the matter is attributed to her relationships with Bert and Ted Angus of Toledo. Ohio. This women also approached

on account of the failure of the Barry woman to produce Karpis and Campbell. See reports of Special Agent J. L. Madala, Chicago, Illinois, dated 10-16-35 and Special Agent R. D. Brown, Chicago, Illinois, dated 11-7-55.

BARKER, ARTHUR R., "Doc". This man become one of the leaders of the Barker-Karpis gang. His conditional pardon from the Oklahoma State Penitentiary was secured for him in September, 1932 by his brother Fred Barker, and after that date he took part in all crimes perpetrated by the gang. He participated in the Hamm and Fremer kidnapings. He is now serving a life sentence at Alcatras Island penitentiary, San Francisco, California following conviction at St. Paul, Minnesota in the Bremer Case.

BARKER, FRED. This men was an intimate associate of Alvin Kerpis and participated in the numerous bank robberies, murders and kidenapings which were perpetrated by the Barker-Karpis gang. See report of Special Agent J. L. Madala, Chicago, Illinois, dated 5-30-35. He was killed by Bureau Agents at Oklawaha, Florida on 1-16-35 while resisting arrest.

BARKER, KATE. This woman was the mother of Fred, Arthur, Lloyd and Herman Barker. Investigation has shown that she fostered the criminal activities of her sons and participated in them. She was a leading figure in the Bremer kidnaping case. She was killed at Oklawaha, Florida on 1-16-35 by Bureau Agents while resisting arrest.

BARTEL, MR. AND MRS. ARTHUR E., 2839 North Rielmond Ave., Chicago, Illes telephone Belmont 10058. These people have co-operated in maintaining a surveillance on the Karpavicz family who reside at 2842 North Francisco Avenue, Chicago, Illinois.

BARTHOINEY, EDWARD Co. 222 South York Street, Bensonville, Illinoise. This man is Postmaster at Bensonville, Illinois. It is known that Bryan Bolton and Bruno Austin lived at his home in September, 1934; that his home was used as the hideout in the Hemm kidnaping case. Bartholmey is a very close friend of Elmer Fermer and is a contact for the Barker-Karpis gange

BECKER, CHARLES, 204 Suder Avenue or care of Pittsburgh Steamship Company, Toledo, Ohio. This individual was a former bartender at the Casino Club in Toledo and is a possible subject or witness in a harboring case at Toledo, Ohio involving the Angus brothers and others. See report of Special Agent D. E. Hell, Detroit, Michigan, deted 2-25-35.

BELPASH, WALTER, Bert Angus' cottage near Tabernal, Sand Beach, Toledo, Ohio. This man was manager of Middle Island during the summer of 1934 being employed by Joe Roscoe who owns the island. He is intimately acquainted with Bert and Ted Angus and during interview admitted seeing Doc Barker and others at Middle Island during the summer of 1934. See report of Special Agent RaDaBrown, Chicago, Illinois, dated 3-23-35.

BERG, OLLIE. This man participated in the Bramer conspiracy, being involved in the exchange of a portion of the ransom money. Et is presently serving a life sentence at Joliet Penitentiary, Joliet, Illinois on a murder charge and is under a similar sentence in the Bramer case.

BERGYL, JOSEPH, 5342 Cermak Road, Cicero, Illinois. This man operates the Cicero Chevrolet Sales Company at this address. Information is that he supplies automobiles to well known hoodlums in Chicago and vicinity. He is known to have furnished both stock and armored cars to members of the Barker-Karpis gange.

BOLIVAR, RENE, Havana, Cuba. This individual is employed by the Cuban Tourist Commission in Havana. He speaks both English and Spanish. He has been very co-operative both in connection with information and as an interpretor. He is in a position to receive data of value as to persons going to Havana and any Agent in Havana for official purposes should contact this man.

BOLTON, WILLIAM BRYAN. This man was arrested by Bureau Agents in an apartment at 3920 Pinegrove Avenue, Chicago, Illinois on 1-8-35 and subsequently furnished information which led to the location of Fred and Kate Barker. He entered a plea of guilty to the Bremer indistment at St. Paul, Minnesota and has furnished most valuable testimony in the two trials of this case. He has not been sentenced as yet as further testimony is expected from him when Karpis and Campbell are located. Bolton has also supplied information relative to the Hamm kidnaping which implicates himself and other members of the Barker-Karpis gang in the conspiracy. Bolton is a seasoned criminal and is in possession of almost unlimited information as to crimes and underworld characters in Chicago, Illinois and vicinity.

BORLEY, MARIE, 3912 Detroit Street, Toledo, Ohioa This woman is amployed as a cook at the New Casino Club in Toledo by the Angus brothers and was so employed during 1934 when members of this gang were frequenting the old club. She can undoubtedly furnish valuable information in a harboring investigation and for that purpose she should be kept in mind.

BORN, BELLE, Manksto, Minnesota. This woman has been the persmour of Charles J. Fitzgerald for many years. There is no doubt as to her being well acquainted with all of the major figures in this case. Arrangements should be made to be kept advised of her movements.

BRADFORD, CARSON, Mismi, Florida. This man was the owner of the house at Oklawahe, Florida in which Fred and Kate Barker were residing at the time of their deaths on 1-16-35 while resisting arrest by Bureau Agents. He is interested, along with Joseph H. Adams and others, in the Biseayne Kennel Club at Mismi, Florida. Information is that Bradford has been aligned with gambling interests for many years and would not hesitate to make an easy piece of money.

BROWN, THOMAS, Police Department, St. Paul, Minnesota. This man was formerly Chief of Police at St. Paul, Minnesota and is presently connected with the Detective Bureau of the same Police Department. It is known that he is a crocked Police Officer and has worked on a tip-off basis with underworld characters for years. It was recently established that he received \$25,000.00 for advising the Barkers Karpis gang of law enforcement developments during the course of the Hamm kidnaping case. A check on the activities of this man should be maintained.

BUCHALTER, LOUIS, New York, N.Y. This man is variously known as Buchalter, Buckhouse, Saffer and Lepke. He operates in New York City and is reputed to be one of the heads of the underworld there. During the first stages of the Kammo case he furnished refuge for Verne Miller; and Vivian Mathis, the paramour of Miller, was living in his home. Information from Vivian Mathis is that Buchalter is the contact in New York for the Barker-Karpis gang. Information as to his whereabouts should be kept by the New York office and arrangements should be made to be kept advised of his activities.

BUCKLEY'S EATING PLACE, 7825 North Avenue, Chicago, Illinois, This place was formerly frequented by Alvin Karpis and Delores Delaney.
On one occasion they invited Eddie and Bessie Green of St. Paul,
Minnesota to have dinner with them in this restaurant.

BURDETTE, WYNONA, U. S. Detention Farm, Milan, Michigan. This woman is the former paramour of Harry Campbell. Through her associations with him she became intimately acquainted with Karpis and is possibly in a position to supply information of value in apprehending both Campbell and Karpis. It is not believed, however, that she will furnish any data which would tend to injure Campbell as she is still very much infatuated with him. She is serving a five year term at Milan, Michigan on charges of harboring both Karpis and Campbell. Repeated interviews with her by Agents with whom she has become friendly may result in obtaining information of value.

BURKE, JAMES, 8114 Kllis Avenue, Chicago, Illinoise This man is an intimate associate of Eddie Donovan and Johnnie Ball and formerly worked as a bartender at the Green Lantern Taverne Prior to this employment he worked as a bartender with William J. Harrison in Calumet City, Illinois. He is known to be acquainted with the Barker-Karpis erowd and is regarded as a likely contact for Alvin Karpise

CAMPAGNI, TONY, Chicago, Illinois. This man is reputed to be one of heads of the Capone syndicate. He was very well acquainted with Tred Goetz and Gus Winkler and is a potential contact for Karpis.

CAMPBELL, HARRY - FUGITIVE. This individual is one of the remaining members of the Barker-Karpis gang who is at large. He was a participant in the Bremer kidnaping and is a fugitive in the case. Active investigation is being conducted to effect his capture and that of Alvia Karpis, it being the belief that the two of them are operating and traveling together at the present time. This man originated in the vicinity of Tulsa, Oklahoma and his parents now reside there. Wynona Burdette, whose name has been prominent in this file, was the paramour of Campbell.

CAPEZIO, TONY, elias "Tough Tony", Chicago, Illinois, This man is a well known hoodlum and is connected with the Capone syndicate, He is regarded as one of the toughest underworld characters in Chicago, Capezio is a likely contact for Karpis, with whom he is undoubtedly acquainted.

GASINO CLUB, NEW, Toledo, Ohio - operated by Ted and Bert Angus.

A similar establishment run by the same men during the spring and summer of 1934 was frequented by most of the major subjects of this file. See names of the Angus brothers for additional information.

CERNOCKEY, LOUIE, Fox River Grove, Illinois. This man, now deceased, formerly operated the Crystal Ballroom at Fox River Grove. The place was frequented by members of the Barker-Karpis mob during 1935. In 1934 members of the Dillinger gang hung around this place and had "meets" there. Cernockey's wife is running this place at the present time.

CHEATHAM, CHARLES, Larned, Kansas - possible contact of Karpis.

See report of Special Agent A. J. Norstrom, Kansas City, Missouri,
dated 12-29-35.

CHRISTMAN, EARL. This man was formerly an associate of the Barker-Karpis gang. His speciality was bank robbery. Helen Ferguson was his paramour. He was shot during the robbery of the Fairbury, Nebraska bank by the gang on 4-4-33 and subsequently died in the home of verne Miller at Kansas City, Missouri, being buried by members of the gang.

CICERO CHEVROLET SALES COMPANY, 5342 Cermak Road, Cicero, Illinois, Operated by Joseph Bergyl, is a place where boodlums secure automobiles.

CLARK, EDWARD S., 1053 Leader Building, Cleveland, Ohio. This man is District Director for the Pinkerton Detective Agency covering the offices of the Agency at Cleveland, Cingisnati, Indianspolis and Detroit. He has an informant who claims to have been in touch with Karpis. See report of Special Agent R. D. Brown, Cleveland, Ohio, dated 7-27-34. It is to be noted that Clark's informant, whose name is Gummoe, has been interviewed by Bureau Agents, at which time he stated that Clark exaggerated the information which was supplied to him.

COCHRAN, FRANK B., 241 South Virginia Street, Reno, Nevada. This individual operates the Air Service Garage on South Virginia Street in Reno. At the present time he is confined in a Federal institution for having harbored Baby Face Nelson. It is known that he is well acquainted with Alvin Karpis and other members of the mob which bears his name. Contact should be had with him upon his release from prison in order to obtain any information of value he may possesse

COHEN, MRS. MAURICE J., 4108 Columbus Avenue, Minneapolis, Minnesota. This women resides across the street from Jack Davenport and his wife, who occupy the premises at 4109 Columbus Avenue. She is co-operating with the Bureau to the extent of watching the Davenport home and advising as to activities and is especially checking the license numbers of automobiles which come to the house.


COKER, SAM, Nowata, Oklahoma or 230 East Tyler Street, Tulsa, Oklahoma. This individual originated at Nowata, Oklahoma where Mrs. E. J. Goker, his mother, and W. P. Coker, a brether, still reside. He was sentenced to the Oklahoma penitentiary, Mealester, Oklahoma in 1924 for bank robbery and paroled on 1-10-31. While out on parole he was arrested

at Tulsa, Oklahoma with Karpis and Fred Barker. His parole was revoked shortly thereafter and he remained in prison until 9-3-35 when he was again peroled. The address furnished to his parole officer is 230 Rest Tyler Street, Tulsa, Oklahoma, however, inequiries have developed the fact that he has recently been hanging around Nowata, Oklahoma with one George H. "Burrhead" Keady, a Bureau informant. Information is that Sam Coker has been running with Karpis and Campbell since his recent parole. His photograph has been reported identified by Post Office Inspectors as one of the robbers in the Garrettsville, Ohio mail robbery on 11-7-35 in which Karpis and Campbell are thought to have been implicated. This man should be kept track of as it may become desirable to take him into custody for questioning at any time.

CONRAD, ALICE, 601 South Ninth Street, Minneapolis, Minneaota, This woman is an intimate friend of Gladys Sawyer and has nursed her on occasions when she has gone to pieces nervously as a result of over drinking. In view of the recent conviction of Harry Sawyer it is possible that a close association may spring up between this woman and Gladys Sawyer and that data of value originating in the St. Paul and Minneapolis underworld may be obtained by her from the Sawyer woman.

is regarded as a valuable informant by the Chicago Bureau office. Arrangements to contact him will have to be made through the Special Agent in Charge. He never comes to the Chicago office and extreme caution should be used in effecting contact with him if and when such a contact is authorized.

COROLLA, CHARLES, Kensas City, Missouri, Reputed head of the undergorld in Kansas City and the successor of John Lazia, decessed. This man is undoubtedly well acquainted with the major subjects of this file, including Alvin Karpis.

OUSINS, EAROID, Toledo, Ohio. This man is also known as Harold Nig and he has an interest in the R & K Cigar Store, Toledo, Ohio, a bookmaking establishment frequented by hoodlums. He is a close friend of Charles J. Fitzgerald and for that reason is regarded as a likely contact for Karpis and Campbelle CURLEY, JOHN, Chicago, Illinois. This man is a clerk for the I.C. Railroad at Chicago, Illinois and is reported to be on very friendly terms with Eddie Donovan and Johnnie Ball who are known contacts of the Barker-Karpis gang. It is possible that an arrangement might be effected whereby information of value might be secured through Curley.

DANLOR HOTEL, Atlantic City, New Jersey. This is the place from which Kerpis and Campbell escaped from the police on 1-20-35. It is operated by Daniel Young and William Morley, both of whom are friends of Duke Randall. See report of Special Agent J. R. Sharp, Philadelphia, Pennsylvania, dated 2-25-35.

DAVELPORT, JOHN B. - "JACK", residence 4109 Columbus Avenue, Minneapolis, Minnesota. This man operates the Third Street Buffet, 301 Hennepin Avenue, Minneapolis, Minnesota. It has long been established that he has been intimate with many leading criminals and was possibly a contact for them. During January, 1936, in connection with the surveillance being maintained on Charles J. Fitzgerald at Los Angeles, California, data was obtained as to the mailing of a letter by him to Krs. A. B. Gilbertson, general delivery, Minneapolis, Minnesota. This letter was called for by Mrs. Jack Davenport. This fact would seem to definitely show that Davenport and his wife are contacts for Fitzgerald and possibly for Karpis and Campbell. Information is also at hand that Davenport participated in the proceeds of the Hamm kidnaping. A definite set—up should be effected for the maintainance of a surveillance on these people. The residence telephone of Davenport is Locust 9948 while the number of a pay telephone located in his tavern is Main 9458.

DAVERPORT, MRS. JOHN B. - "MARY BIANCHE", 4109 Columbus Avenue, Minnesota. This woman is the wife of John B. Davenport. See data appearing under his name for information as to here

DAVIS, HOMARD, 8201 Grand Avenue, River Grove, Illinois. This man operates an automobile agency at this address. He is reported to be a contact for Alvin Karpis. He has a brother Kip Davis who is employed as a policeman at River Grove and who is likewise reported to be a Karpis contact.

DAVIS, VOILEY. This man was a member of the Barker-Karpis gang and participated in the kidnaping of Edward George Bremer. He is now constined at Alcatrax Island penitentiary, San Francisco, California for life following his plea of guilty at St. Paul, Minnesota, Edna "Rabbits" Murray was the paramour of Davis. Since his confinement Davis has furnished very valuable information to the Bureau, and it is possible that he can still supply data of value. He should possibly be re-interviewed for that purpose.

Decourcy, JACK, St. Paul, Minnesota. This man is an attorney at St. Faul, Minnesota and represented Doc Barker during the Bremer trial in April-May, 1935, at which time Barker was sentenced to life imprisonment. He appears to be the shyster type of lawyer and it has been suspected for some time that he has acted as a contact for this gang. Efforts should be made to make contacts through which the activities of this man can be checked.

DETANEY, DELORES, United States Detention Farm, Milan, Michigan, This woman is the former paramour of Alvin Karpis. She consorted with him from that time of their meeting at St. Paul, Minnesota in 1932 until her arrest at Atlantic City, New Jersey on 1-20-35, She is the mother of an illegitimate child by him, She is presently serving a five year term at Milan, Michigan for harboring Karpis and Harry Campbell, having been convicted at Miami, Florida in April, 1935 along with Wynona Burdette. At the present time she is beginning to furnish information as to the details of her associations and travels with Karpis and it is anticipated that data of value in securing the apprehension of Karpis may be obtained from her.

DELANEY, MRS. HELEN, 1039 Lawson Street, St. Paul, Minnesota. This woman is the mother of Delores Delaney, paramour of Karpis; Jean Deleney, paramour of Tommy Carroll; and of Helen Reilly, wife of Pat Reilly. She has another daughter named Frances who is an immate of an insane institution at Faribault, Minnesota, and a son Robert Delaney living in Chicago, Illinois. She is separated from her husband. This woman has visited the Karpavicz family in Chicago and was quite friendly with John Karpavics during the trial in this case at St. Paul, Minnesota commencing 1-6-36. John Karpavicz came to St. Paul and attended the trial on several days in company of Mrs. Delaney and Helen Reilly. It is possible that an intimacy has arisen between Karpavicz and Mrs. Delaney. This woman has pretended to furnish information in the past. Letters from her to Delores Delaney at Milan, Michigan have been of a tenor to indicate that she would not approve of her daughter doing anything which might result in the capture of Karpis. Regardless of past experiences it is believed that action should be taken to secure from Mrs. Delaney any information she might have or could obtain which would be helpful to this investigation.

DETANEY, FRANCES, State Institution for the Insane, Faribault, Minnesota. This girl is a daughter of Mrs. Helen Delaney and a sister of Delores Delaney. Her name and location are being included herein in order that references to the Delaney family may be complete.

DELANEY, MARCARET JEAN- "MUGS". This girl is a sister of Delores Delaney and also the paramour of the late Tommy Carroll. During the fall of 1935 she was living at 4554 Malden Avenue, Chicago, Illinois with one Robert Conroy. She was visited at this place by her sister Babe who is Mrs. Helen Reilly. This girl moved away from the above address during December, 1955 and her present address is not known, however, through a telephone tap on the Karpavicz family it was recently learned that she is working as a check girl at the Club Silhouette, 1555 West Howard Street, Chicago, Illinois, telephone Briargate 6356. Arrangements should be made to locate her place of residence and receive information as to visitors, etc., as the matter of Karpis contacting his family or Delores Delaney through her is not too far remote.

DEIANEY, ROBERT, 6045 Kimbark Avenue, Chicago, Illinois. This individual is a brother of Delores Deleney. He is a young man around twenty years of age. He has been interviewed a number of times, both as to this case and in the Jodil case, but was never in a position to supply data of value. On several occasions since Delores has been confined at Milan, Michigan he has visited the Karpavicz home to see her baby and has then written to Delores. His mother and Mrs. Helen Reilly visit him from time to time. A periodic contact with this individual should be maintained.

DONOVAN, EDDIE, 2010 Hopkins Place, Chicago, Illinois, telephone Cedarcrest 3107. This man, according to Byron Bolton, is the chief contact for the Barker-Karpis sand in Chicago. He is the former owner of the Green Lantern Tavern, 79th and Dobson Streets, which is known to be a hangout for members of this mob. Donovan is also an official of the Motion Picture Operators Union, which is hoodlum controlled. Intensive investigation and surveillance of this individual might result favorably.

DORSEY, IRENE, Wilmington, Illinois. This women was the consort of Fred Goetz, alias George Ziegler, and lived with him until his death on March 21, 1934, at Chicago, Illinois. After his death she became demented for a considerable period and was an immate of an asylum at Aurora, Illinois. Information was supplied by her to Bureau Agents which was in line with other data already obtained, but during the second Bremer trial she took the stand on behalf of Harry Sawyer and repudiated in part the substance of her statement. This woman is now operating a dress shop at Wilmington, Illinois, along with a mister.

DOYLE, JESSE. This man was a criminal associate of Alvin Karpis. See report of Special Agent J. L. Madala, Chicago, Illinois, dated March 30, 1935. He is presently serving a tem-year sentence in the Nebraska State Penitentiary, Lincoln, Nebraska, for his part in the Fairbury, Nebraska, bank robbery on April 4, 1935.

DUVOL, LARRY. This man was one of Karnie' earliest criminal associates. Their crimes consisted of burglaries and bank robberies. He was a party to the robbery of the Third Northwest Bank of Minneapolis, Minnesota, on December 16, 1932, and is presently serving a life sentence in the Minnesota State Penitentiary, Stillwater, Minnesota, Tor this robbery. The robbery was staged by the Karpis-Barker gang, and two officers and a civilian were killed during the robbery.

EATON, MYRTLE. This woman was the consort of William Weaver, one of the participants in the Bremer kidnaping. She originated in Des Moines, Iowa, and was formerly the consort of Clarence "Doc" Eaton, an ex-convict now operating a tavern at Burlington, Wisconsin. She and Weaver were apprehended by Bureau Agents at Harbor Oaks, Florida, on September 1, 1935, where they were living on a small farm. She is to be presecuted for harboring Weaver, being under indictment at Orlando, Florida. Her criminal specialty is shoplifting.

ELEANOR MANOR APARTMENTS, 7160 Cyril Parkway, Chicago, Illinois. This is a place where members of this gang have lived at various times.

The name and location are incorporated herein for reference purposes.

ELMER'S TAVERN, 126 East Green Street, Bensenville, Illinois. This place is owned and operated by Elmer and James Farmer, brothers. It is actively managed at the present time by James Farmer due to the fact that Elmer Farmer is an inmate of Leavenworth Penitentiary, following conviction in the Bramer case. It is known as a former hangout spot for the major subjects of this file.

ELVADA APARTMENTS, 234 West Liberty Street, Reno, Revada. Alvin Karpis and Dolores De Laney resided at this place during the latter part of 1932 and for part of 1933 under the names Mr. and Mrs. E. L. Burns.

FARMER, KLMER. This man was convicted at St. Paul, Minnesota, in May, 1935, as a co-conspirator in the Bremer kidnaping, and is presently confined at Leavenworth Penitentiary. During the kidnaping he procured the hideout and in other ways furthered the conspiracy. At that time he operated Elmer's Tavern in Bensenville, Illinois, along with his brother Jim, and has been described by Bryan Bolton as one of the main contacts for this gang. Helen Conliff was the paramour of this man.

FARMER, HERBERT A. This man was an associate of the Barker-Karpis gang. He owns a farm near Joplin, Kissouri, where he has made his home for some time. He was convicted furing January, 1935, at Kansas City, Kissouri, as a co-conspirator in the Kansas City Massacre case, and this matter is now pending appeal.

FARMER, JAMES, 194 Addison Street, Bensenville, Illinois, is a brother of Elmer Farmer and joint operator with his brother of Elmer's Tavern in Bensenville, which was a contact point for the Barker-Karpis gang.

FERGUS, WILLIAM, 10117 Clifton Boulevard, Cleveland, Ohio. This individual is an affiliate of Messrs. Hebebrand, Patton, and Mitchell, who operate the Harvard Club at Cleveland, Ohio. During the summer of 1934 he traveled to Rumania and other points in Europe in the interests of a syndicate composed of the above men and others in connection with slot machines. He gave the address listed herein at the time of securing his passport. On account of his associations with the Harvard Club crowd investigation at Cleveland should include the activities of this man. For obvious reasons he has never been interviewed.

FERGUSON, HEIEN. This woman was a former informant in this case, whose services are no longer desirable. She was the paramour of Earl Christman, now deceased, and of J. J. Ryan, presently an inmate of Sing Sing Penitentiary, Ossining, New York.

FILHEN, TOM, St. Paul, Minnesota. This men was last known to be residing in Room 250 at the St. Francis Hotel in St. Paul. He is a close friend of Harry Sawyer and the other members of the Barker-Karpis gang. During the recent trial of this case at St. Paul, Minnesota, during January, 1936, it was rumored that Filben had been killed in an auto

wreck, but this rumor was not verified. If he is still living he is a potential contact for Alvin Karpis.

FITZGERALD, CHARLES J., \*CHUCK\*, 512 South Hobart Boulevard, Los. Angeles, California. This men is an old time bank robber. He is described by underworld sources as the "daddy" of the Barker-Karpis gang. Information is that he participated in the Hamm kidnaping; also, that he received a cut of the ransom money in the Bremer kidnaping. Following the kidnaping of Bremer he was in touch with the various members of the gang. He was forced to be inactive during the period of the kidnaping because of a hip wound received during a payroll robbery at South St. Paul, Minnesota, in August, 1935. For many years he has associated intimately with Belle Born, of Mankato, Minnesota. Through investigation he was located at the los Angeles address set out herein under the alias J. C. Foster, and it was determined that he is keeping company with one Imogene Robertson, 521 South Hobart Boulevard. On assount of his intimate association with this gang and the fact that he has participated in many serious crimes with them, it is believed that Karpis and Campbell will ultimately contact him or will be contacted by him. For that reason - complete surveillance is being maintained on Fitzgerald with the hope of him leading us to Karpis and Campbell; also, because he is to be taken into custody for prosecution when he has served our pur-

FOSTER, FRANKIE, Apartment 15D, Hotel Maurice, 145 West 58th Street, New York, M. Y. This man is reputed to be a contact for Alvin Karpis. He is without occupation except gambling. During the season of 1934-1935 he lived at the Fleetwood Hotel, Miami Beach, Florida, along with his wife. Surveillances were made on him at his address at New York City but without results. Arrangements should be made to be kept advised of his movements and activities.

FRAZIER, L. N., c/e Woble Motel, Jonesboro, Arkansas. This individual travels the state of Arkansas for J. I. Case & Company, manufacturers of farm machinery, and at his request he was furnished with a photograph of Alvin Karpis in order that he might be on the lookout for him during his travels and report any information to the Little Rock Bureau Office.

GAILAGHER, DAN, Cleveland, Ohio. This man is reported to be manager of the Harvard Club in Cleveland. Because of this connection he is intimate with the owners of the establishment and is without a doubt well acquainted with the major subjects of this case. Inquiry should

be made to secure his residence address and telephone listing in the event future investigation is desirable as to him.

GALLECHIO, JOE, Chicago, Illinois. This man frequented the apartument of "Doc" Barker, 432 Surf Street, Chicago, Illinois, shortly before Barker's arrest. It is reported that he is acquainted with most of the members of the Karpis-Barker gang, and according to Bruno Austin he did business with the outfit in way of supplying guns. He is reported to frequent the neighborhood of South Paulina Street and Roosevelt Road. He is regarded as a likely contact for members of this mob not yet apprehended.

Agents in this case and is considered to be a good contact.

GIBSON, RUSSELL. This individual was a member of the Barker-Karpis gang, having started his association with the outfit sometime prior to the money changing operations at Chicago, Illinois, in the spring of 1934, although it is known that he was acquainted with some of the members prior to that time. Gibson was a desperate criminal. He was shot to death at Chicago, Illinois, on the night of January 8, 1935, while resisting arrest by Bureau Agents. His wife, Clara Gibson, has furnished information to the Bureau, but her good faith is doubted.

GLYNN, JACK, Leavenworth, Kansas. This individual operates a private detective agency in Leavenworth, Kansas, and has been suspected for some time of being engaged in the business of securing paroles for convicts at the United States Penitentiary, Fort Leavenworth, Kansas, the Kansas State Penitentiary, Lensing, Kansas, and the Oklahoma State Penitentiary, Echlester, Oklahoma. He is acquainted with all of the major figures in this case. He has been approached by a Bureau agent with the proposition of turning in Karpis and Campbell for a consideration but has declined same with the statement that he had to shoot square with the boys. Arrangements should be made by the Kansas City Bureau Office to keep informed of the activities of this man.

COETZ, FRED, alias George Ziegler. This man was formerly a member of the Barker-Karpis gang. He was also a member of the Capone syndicate in Chicago, Illinois. He was one of the active participants in the Bremer kidnaping, also in the Hamm kidnaping. He was generally known under the alias of George Ziegler. Irene Dorsey was the paramour of Goetz. Goetz was shot to death by unknown persons in Cicero, Illinois, on March 21, 1934. It has been rumored in the underworld that he was killed for having talked too much about the kidnaping of Edward George Bremer.

This individual has been used by the Bureau as an informant but has never produced information of value.

GOTTLIEB, LOUIS, 2241 South 52nd Avenue, Cicero, Illinois. This man is proprietor of the Gottlieb Furniture and Carpet Company. While Alvin Karpis and Dolores De Laney were living at 7137 Yates Avenue, Chicago, Illinois, they purchased furniture from this individual. At one time he tried to attach the furniture, claiming he had a lien against it, but it was shown that he had no claim against the furniture. He has promised to cooperate with the Chicago Bursau Office if Karpis connects with him, but his sincerity is doubted. The proprietors of the Yates Apartments are holding the furniture in lieu of rent owed by Karpis.

GRAHAM, WILLIAM, Reno, Mevada. This man is known as one of the principal contacts for hoodlums visiting the state of Mevada. He is acquainted with the various members of this mob, having met them during visits to Reno in 1933 and 1934. Karpis was among the members with whom Graham became acquainted.

GREEN, BESSIE SKINNER, now living at 5301 Minnehaha Avenue, Minneapolis, Minnesota, under the neme of Mrs. J. L. Garrett. This woman was the consort of Eddie Green, now deceased. She was convicted on a harboring charge in the Dillinger case and served a term at the United States Industrial Reformatory for Women, Alderson, West Virginia. Following her arrest she furnished considerable information of value to this case and is believed to be a good contact at the present time see far as the Twin Cities are concerned.

GREEN, EDDIE. This man was a former member of the Barker-Karpis gang during the time the gang was engaged chiefly in bank robberies. During the course of the Dillinger case Bureau Agents were attempting to arrest him for questioning, and he was killed while resisting arrest. His paramour at the time was Bessie Green, alias Skinner. His death occurred on April 5, 1934, at St. Paul, Minnesota.

GREEN LANTERN TAVERN, 79th and Dobson Streets, Chicago, Illinois. This place was formerly operated by Eddie Donovan and Johnny Ball, It is known as a former hangout for the entire Barker-Karpis gang.

GREENWALD, FRANK, 463 - 4th Street, Toledo, Ohio. This man is proprietor of the Private Cab Company in Toledo and maintains cab stands at 520 Cherry Street and the Navarre Hotel. Information is that he is strictly "racket" and obtains most of his business from hauling prostitutes to and from call houses. He is said to have driven Karpis and Campbell after their flight from Atlantic City, New Jersey. His service is used constantly by Edith Barry, a prospective defendant in this case, and they apparently know each other intimately. He has a paramour, "Apple Annie" (Annetta Smith), a check girl at the New Casino Club.

GROOMS, ALBERT, 1234 North Monroe Street, Topeka, Kansas, brother-inlaw of Karpis. Formerly employed at Topeka but now unemployed. Has pretended to cooperate with Bureau Agents at times but sincerity is doubted. Has never supplied any information of value.

GROOMS, AMELIA, 1234 Worth Monroe Street, Topeka, Kansas, is eldest sister of Karpis. During interview supplied data as to early life of her brother, but declined to assist Government in any way in causing his apprehension. It is not believed that any information of value can be secured from this woman, but arrangements should be made through neighbors to be kept informed of possible visits to her home by Karpis.

GROSSCURTH, CHARLES, Country Club Hotel, 6950 South Shore Drive, Chicago, Illinois. Fred Goetz met this man in Havana, Cuba, in 1951, while he, Grosscurth, was operating the Mill Creek Distillery. They later associated in Chicago after Grosscurth came to this city in January, 1934. See report of Special Agent R. D. Brown, Chicago, Illinois, dated October 1, 1934. It is known that Grosscurth was given an Auburn 12-cylinder sedan to put in storage for Fred Goets, and that this car was formerly owned by Alvin Karpis. See report of Special Agent J. R. Welles, Chicago, Illinois, dated June 22, 1934. There was a close association between the wife of Grosscurth and Irene Dorsey, the paramour of Goetz. Additional interviews with both Grosscurth and his wife may prove desirable.

GUNDER, EVA, 750 Dorr Street, Toledo, Chio. This woman is the mother of Lillian "Lou" Poole. a former inmate in the call house of Edith Barry.

recently she has been interviewed and has supplied information as to Karpis and Campbell having been harbored by Edith Barry in her house at 524 Southard Street, Toledo, Ohio. This woman is supposed to be a valuable source of information at the present time.

GUST'S PLACE, 5800 West lilth Street, Chicago, Illinois, telephone Oak Lawn 236. This place is an old dwelling house which has been remodeled and is being used now as a saloon and bawdy house. A card advertising this place was found in the house occupied by Alvin Karpis at Veradera Beach, Cuba. Interview has been had with the proprietor of this place but he could not or would not identify the photograph of Karpis. He identified the photograph of Campbell, however, stating he had been to the place in about March, 1935.

HARMON, CHARLES. This man was a member of the Barker-Karpis gang prior to his death on November 19, 1931, during the getaway from the robbery of the Kraft State Bank at Menominee, Wisconsin. He was the husband of Paula Harmon, mentioned herein, who later became the paramour of Fred Barker.

HARMON, PAULA, Texas Hospital for Insene, Rusk, Texas. This woman was the paramour of Fred Barker, and prior to her associations with him was the wife of Charles Harmon, a member of the Barker-Karpis gang. She became deranged shortly after the death of Fred Barker and was committed to the Texas Hospital for the Insene at Rusk, Texas, on January 20, 1935. Contact with the hospital authorities has indicated that she is steadily improving and should be rational again within a short time. She was interviewed at Chicago, Illinois, in September, 1934, following her arrest at Cleveland, Chio, and furnished valuable data in the Bremer case. It is anticipated that she will be interviewed again in the near future for what information she may be able to furnish as to the Hamm kidnaping, it being our information that she was living with Fred Barker in St. Paul, Minnesota, during the period of the kidnaping.

HARRIS, C. D., alias Clyde Nimerick, alias Dutch, whereabouts unknown. This man is a well-known bank robber, and during the early stages of the Bremer case was wanted for questioning. He is said by Bessie Skinner to be an associate of the Barker-Karpis gang.

HARRIS, GEORGE, 22 Zueleta Street, Havana, Cuba. Harris operates the American Bar at this address and resides in quarters located over the

Bar premises. He claims to be English by birth but has been in Cube for a number of years. In September, 1934, when Karpis went to Havana, Cuba, to live he had a card of introduction to Harris from Joseph H. Adems of Miami, Florida. Thereafter he frequented the American Bar, and Harris and his consort visited him at Veradera Beach, Cuba. Harris also acted as reference for Karpis at the National City Bank in Havana where a safety deposit box was rented. Arrangements should be perfected to receive advice as to the activities of Harris and regarding people who frequent his bar.

HARRISON, WILLIAM J. This man was a former subject in this case and a former member of the Berker-Karpis gang. He was active in the kidnep conspiracy, also in the exchanging of the ransom money. His body was found near Ontarioville, Illinois, in September, 1935, and it was established that he was killed by members of the gang on January 5, 1935, his body having been subsequently burned. Identification was effected through a watch repair and serial number.

HARVARD CIUB, 5111 Harvard Avenue, Newburgh Heights, Cleveland, Ohio.

This place is a large gambling club located in suburban Cleveland.

It is patronized by all types of people, and it has been estimated that an average of 2500 persons visit the place nightly to gamble. It is also open during afternoons. Definite information has been obtained that members of the Barker-Karpis outfit frequented this place and it is believed that the owners are contacts for the mob. The place is owned by Arthur Hebebrand, James "Shimmy" Patton, William J. and C. W. Mitchell. Constant investigation through informants and otherwise should be conducted as to this establishment as it is felt same may result in data of aid in locating Karpis and Campbell. Unpublished telephones located in this place are Michigan 6735, 6736, and 8230.

HEBEERAND, ARTHUR W., 5909 West 158th Street, Cleveland, Ohio, telephone Clearwater Ol71. This man is one of the owners of the Harvard Club, which place is his business address, and he is stated by Bryan Bolton to be a main contact for members of the Barker-Karpis gang. The file contains his telephone number as Clearwater Ol71, also as Clearwater 1071. This apparent discrepancy should be checked. He was formerly in the contracting business in Cleveland. In addition to the gambling club, Hebebrand also heads the Arthur W. Hebebrand Real Estate Corporation, 971 Dennison Avenue, Cleveland, Ohio. It is through this firm that Fred Barker rented the premises at 4419 West 171st Street, Cleveland, Ohio, during the summer of 1954. Because of

his apparent close connection with this gang it has not been deemed advisable to interview him. Investigation as to his activities should be continued.

HEBEBRAND, CLARENCE F., Cleveland, Ohio. This man is a younger brother of Arthur W. Hebebrand, one of the owners of the Harvard Club. He was recently in Bucherest, Rumania, and other European points with William J. Mitchell and William Fergus making a survey with the idea of setting up a slot machine syndicate. It is understood that the slot machine undertaking fell through, and that these persons returned to the United States in December, 1935. Appropriate inquiries should be made at Cleveland to determine the residence of this man, also his activities and possible contacts with Karpis and Campbell.

HEENEY, WILLIAM, 16th Street and Austin Boulevard, Northwest Corner, Cicero, Illineis. This man is a well-known hoodlum and a member of the Capone syndicate of Chicago. Information emanating from Bryan Bolton is that Heeney is a most important contact for the Barker-Karpis mob. He was well acquainted with such persons as Fred Goetz and "Big Homer" Wilson, now deceased. It should be noted that Heeney's wife is a sister of the wife of Jack Devenport of St. Paul, Minnesota. Intensive inquiries as to Heeney should be considered.

HEIDT, JACOB, 6000 - 5th Avenue, Gary, Indiana. This man is the stepfather of Ruth Heidt, ex-wife of William J. Harrison. He runs a gas station at this address, and it is known that Karpis and Fred Barker made several "meets" at this place during the fall of 1934. See report of Special Agent R. D. Brown, Chicago, Illinois, dated January 8, 1935.

HEIDT, HUTH, 1562 Sibley Street, Apartment 25, Hammond, Indiana. This woman is the ex-wife of William J. Harrison. She was residing in the apartment at 3920 Pine Grove Avenue, Chicago, Illinois, with Russell Gibson and his wife and Bryan Bolton in January, 1935, when Gibson was killed while resisting arrest. She has remarried, her present name being Mrs. Frank Jackson. This woman is uncooperative toward the Bureau.

HELLER, NATHANIEL H., Parkview Hotel, Havana, Cuba. Heller is manager of the Parkview Hotel in Havana, Cuba, and is under federal indictment at Miami, Florida, for his activities in harboring Alvin Karpis. He was formerly a hotel manager in Miami, Florida. Arrangements should be made to be kept advised of his activities, although it is doubtful if he will receive additional contacts from Karpis on account of his present difficulties with the law. Karpis was referred to Heller by Joseph H. Adams of the El Commodoro Hotel, Miami, Florida.

HI-HO CLUB, 2242 South Cicero Avenue, Cicero, Illinois. This place is operated by hoodlums and is reported to have been frequented by members of the Barker-Karpis gang. Joe O'Brien and Claude Maddox are said to be the owners of this club.

He is an ex-convict and is personally acquainted with all of the major subjects of this file. For some time he has been considered as a confidential informant by the Oklahoma City Bureau Office. He has stated that if Karpis and Campbell visit him he will offer them a "cooling off spot" and will then notify either Deputy. Sheriff Gene Haverfield of Nowata, Oklahoma, or Special Agent Paul Hansen of the Oklahoma City Bureau Office. He has expressed an unwillingness to deal with any officers except those above named. It is believed could produce valuable information in this case. It should be note that was recently convicted in state court at Independence, Kansas, but the matter of his sentence is not known.

HILLSIDE CLUB, North Canton, Ohio, a restoling house in the general vicinity of Canton, Ohio, where Subjects may go if in that vicinity. See report of Special Agent D. R. Hall, Detroit, Michigan, dated April 9, 1935, Page 10.

HOLDEN, LILLIAN, 1002 West 63rd Street, Chicago, Illinois. This woman is the wife of Thomas Holden, a prisoner at Leavenworth Penitentiary. Holden, Francis Keating, Harvey Bailey, and others were formerly close associates of the Barker-Karpis mob, and information has been received from varied sources that his wife is a potential contact for the remaining members of the mob. Arrangements should be made to receive advice as to her activities.

HOLDEN, THOMAS. This man was formerly associated with the Barker-Karpis gang in bank robberies. Refer to report of Special Agent J. L. Madala, Chicago, Illinois, dated March 30, 1935. He is presently an inmate of Leavenworth Penitentiary on a mail robbery charge. Lillian Holden, whose name is contained in this report, is the wife of this individual.

HOIST, RENE GRACE, Point: Place, Toledo, Ohio. This woman is a sister of Madeline Angus, wife of Bert Angus. She is acquainted with all of the members of the gang and used to keep company with Willie Harrison. She has always been regarded as a sister of Thelma Holst, but recent investigation disclosed these women are not related. She has been a

close friend of Mildred Kuhlman for some time. At the present time she is operating a new night club at Point Place, Ohio, for one Ludy Fleming, a former state prohibition agent. Inquiry should be made to secure the residence address of this woman and to be kept advised of her activities. She is well acquainted with

and data with respect to her can be obtained through him.

HOLST, THELMA, R.F.D. #1, c/o E. M. Rowley, Fredericktown, Ohio:
This woman was living with Mildred Kuhlman at the time "Doc" Barker
took the latter to Chicago. She is acquainted with most of the members of this gang. She has always been described as the sister of
Rene Holst, but investigation has shown this to be untrue. Her mother is Louise Wilson, 1424 Broadway Avenue, Toledo, Ohio, and Thelma's true name is Zelma Wilson. She was married during the fall of
1935 to one Howard Emerson and is living with him at the Fredericktown
address. The possibility of securing information from her by interview should be considered.

HOMESTRAD INN, 9650 South Western Avenue, Chicago, Illinois. This place is operated by Joseph Flannery. Telephone calls from William J. Harrison, also from the Green Lantern Tavern in Chicago, have been traced to this place. Bryan Bolton has informed that members of the Barker-Karpis mob frequented this place, and that he looked upon it as an important contact point. See report of Special Agent K. R. McIntire, Chicago, Illinois, dated February 11, 1935.

HOWARD, JOE C.. Information is that this man was arrested with Alvin Karpis, Fred Berker, and Sam Coker on June 10, 1931, at Okmulgee, Oklahoma, for robbery of a jewelry store at Henrietta, Oklahoma. He is identified through Tulsa, Oklahoma, Police Number 7916 and Kansas City, Kansas, Police Number 1451. Intensive investigation should be made to determine the full identity, location and activities of this individual, as it is possible he has resumed associations with Karpis.

HULL, HARRY. This man was a former member of the Barker-Karpis gang. He is now serving a fifteen-year sentence in the Texas State Penitentiary

at Huntsville, Texas, on a robbery charge. In January, 1933, while in Reno, Nevada, it is alleged Hull stole some clothes from Jesse Doyle, and that Doyle and "Doc" Barker were subsequently gunning for him.

HUMMER, L. E., 305 Lawrence Street, Topeka, Kansas. This man is an ex-convict, having been at the State Industrial Reformatory, Hutchinson, Kansas, during the same time as Alvin Karpis. Correspondence records of the institution reflect that he is the only person with whom Karpis corresponded except relatives. Hummer was interviewed and advised that he had no information as to Karpis; further, that he would turn him in for a reward if he could do so. This interview occurred in September, 1934, and Hummer was then employed by the Crane Company in Topeka, Kansas. See report of Special Agent M. C. Spear, Kansas City, Missouri, dated September 27, 1934.

IMBURGIO, LAWRENCE, "The Hindu," Melrose Park, Illinois. Information has come to the Chicago Bureau Office from Informant George Bougadis that this individual can put his finger on Alvin Karpis if he so descres. It should be stated, however, that this statement was an expression of opinion from Bougadis and was not based on any facts.

JAMES, EDDIE, 408 University Avenue, c/o Charles Smith Auburn Company, St. Paul, Minnesota. This man formerly worked as a mechanic at the Westlund Carage, located at Annapolis and South Robert Streets, St. Paul, Minnesota, and is reputed to be well acquainted with the major subjects of this file through having taken care of all repair work on their cars when they were operating in and out of St. Paul. Members of the gang referred to him as "Eddie the mechanic."

JIMENEZ, JUAN R., alias "The Chink," Havana, Cuba. This man is a leading figure in the underworld at Havana, and is a close friend of Cassius M. McDonald. He is well informed on criminal matters in Cuba but is hostile toward law enforcement officers.

KARPAVICZ, ANNA, 2842 Worth Francisco Avenue, Chicago, Illinois, mother of Subject Alvin Karpis. Lives with husband at above address and spends her time caring for home and infant son of the subject. Very seldom leaves her apartment. Speaks very little English, her native tongue being Lithuanian. She is being covered by a telephone tap on which an interpreter is being used, also by a mail cover and surveillance of the apartment building in which she lives. Former places of residence of the Karpavicz family are as follows: 1441 West Adams Street, Chicago,

Illinois; 5010 Addison Street, Chicago, Illinois; 1114 North Richmond Street, Chicago, Illinois.

KARPAVICZ, JOHN, 2842 North Francisco Avenue, Chicago, Illinois, Telephone Belmont 7899, father of Subject Alvin Karpis. He is employed as janitor at the address where he lives with his wife and the illegitimate son of Subject and Dolores De Leney. Recent purchases for the baby and money seen in his possession when purchases were made indicate money came from some source other than his employment. Karpavicz owns some realty in Topeka, Kansas. The Karpavicz family is friendly with members of Dolores De Laney's family and they visit the baby at the Karpavicz home. The father attended a portion of the trial of this case at St. Paul, Minnesota, which commenced January 6, 1936, and he was accompanied by Mrs. Helen De Laney and Mrs. Helen "Babe" Reilly. In interviews he has stated he would not assist in causing the apprehension of his son. Offi tplephone, mail and personal surveillances are being maintained on his home in Chicago, Illinois. He is being contacted periodically by Special Agent R. C. Suren, and in this connection it should be stated that he related to Agent Suran the datells of an interview had with Philip Newbold by Special Agent R. D. Brown, which interview Newbold had promised to treat confidentially.

KARPIS, RAYMOND ALVIN, 2842 North Francisco Avenue, Chicago, Illinois. This is the infant illegitimate son of Karpis and Dolores De Laney. He is one year of age and has been cared for by the parents of Subject Karpis since his birth. Possible attempts on the part of Subject to visit the child are being covered by a surveillance on the apartment in which the grandparents reside.

KATHRENS, JUNE, Kathrens Warehouse, Linwood and Main Streets, Kansas City, Missouri. This man is an intimate friend and business associate of Francis Mulloy. He is also acquainted with the major members of the Barker-Karpis gang and is regarded as a contact for the gang. Arrangements to keep informed as to his activities should be perfected by the Kansas City Bureau Office.

MEADY, GEORGE H., "Burrhead," Nowata, Oklahoma. This man is an informant of the Oklahoma City Bureau Office. In the past he has supplied data as to the activities of Campbell, and in view of that he is valuable as Campbell and Karpis are thought to be together at the present time. Keady may be of assistance in the near future if he is associating with Sam Coker at Mowata, Oklahoma, and all indications are that Coker is in touch with Karpis and Campbell.

KEATING, FRANCIS. This man was formerly associated with the Barker-Karpis gang in bank robberies. See report of Special Agent 7. L. Madela, Chicago, Illinois, dated March 30, 1935. He is presently an inmate of Leavenworth Penitentiary on a mail robbery charge. His wife was Marge Keating, and he originated in Chicago, Illinois.

KERSCH, MATT, Fox Gardens, Aurora, Illinois. This man owns the Fox Gardens and the Riverside Hotel at Aurora, and was a frequent contact of Volney Davis. It is possible that the remaining fugitives in this case may know him and may contact with him.

KOEHLER, MRS. PAUL, 2846 North Francisco Avenue, Chicago, Illinois, telephone Spaulding 2798. This woman has cooperated in maintaining a surveillance on the Karpavicz family. Her home is located across the street from the Karpavicz apartment, and at times when a surveillance is not being maintained by Bureau Agents she informs the Chicago Office by telephone of any movements of the family she notices.

KONVALINKA, EDWARD S., 2439 - 50th Avenue, Cicero, Illinois. This man was a former associate of Fred Goetz and Willie Harrison. During the summer of 1933 Karpis and Dolores De Laney rented his summer home at Long Beach, Indiana. This man is also perforted as a contact for other notorious characters. See report of Special Agent R. D. Brown, Chicago, Illinois, dated November 12, 1934.

KUHLWAN, MILDRED, 1308 Savra Road, c/o John A. Carbin, Toledo, Ohio.

This woman is the former paramour of "Doc" Barker and was living with him at 432 Surf Street, Chicago, Illinois, at the time of his arrest. She is acquainted with most of the members of the Barker-Karpis mob. She is a close friend of Rene and Thelma Holst, likewise of Bert and Ted Angus, who operate the New Casino Club. She is a prostitute and formerly worked in the call house of Edith Barry. At the present time she is living in the home of John A. Carbin, proprietor of the Recreation Night Club, 929 Phillips Avenue, Toledo, Ohio, and is also working at the night club.

This person has furnished alleged information as to the movements of marpis and Campbell. Contact should be followed with him for what information of value he may be able to produce.

LASKO, WALTER, 6225 South Komensky Avenue, Chicago, Illinois, Telephone Hemlock 8295. On January 29, 1956, Chief of Uniformed Police Prendergast, Chicago, Illinois, telephoned Special Agent in Charge D. M. Ladd and advised he had an informent who stated Alvin Karpis is in and out of Chicago and may contact the above address. It was requested that no inquiries be made by Bureau Agents at this time.

man making mang LETT, MILTON, Route No. 1, Wann, Oklahoma. For a considerable period of time Milton Lett has been regarded by the Oklahoma City Bureau Office as an informant and has been thought to be located in and around the district covered by that office. He is thought to be the person who drove Harry Campbell to the home of Mildred Jones, near Tubley, Oklahoma, in April, 1935, at which time Campbell left \$50.00 with Mark Whinnery. Recently, however, it has been definitely learned that Lett has been working at the Harvard Club in Clevelend, Ohio, and that he purchased the Plymouth Sedan which was used in the Garrettsville, Ohio, mail robbery on November 7, 1935. The purchase date of this car was October 25, 1935. Lett was arrested at Akron, Ohio, under the alies Thomas J. Shaw and his identity was established through a previous fingerprint record. In view of the above the location of this men is greatly desired, as it is felt he can supply information as to the location of Karpis and Campbell if the questioning of him is properly handled.

LETTUCKS, STEVE, 3236 West 110th Street, Chicago, Illinois. This individual is of Lithuanian extraction and is a friend of John Kerpavics. He is on relief at the present time. It is possible that he is a contact between Subject and his father. See report of Special Agent J. L. Madala, Chicago, Illinois, dated December 10, 1935.

LORRAINE HOTEL, Toledo, Ohio. This hotel bears a poor reputation and Is a place where "Doc" Barker and Russell Gibson are known to have stayed. See report of Special Agent K. R. McIntire, Chicago, Illinois, dated January 25, 1935.

LUCIANO, CHARLES "LUCKY", New York, N. Y. This man is one of the underworld leaders in New York City. During 1935 when rumors were rife that Karpis was in New York City, Special Agent in Charge R. Whitley was contacted by a newspaperman named Ike McAnally, who informed that Luciano wanted to meet him and that it was possibly in connection with Karpis. Luciano is associated with Louis Buchalter and could undoubtedly furnish valuable information. Data as to his contacts and activities would prove to be of unlimited value.

is being contacted at the present time by Special Agent C. E. Smith of the Cleveland Office. Data as to his identity and means of contacting him can be secured through the Special Agent in Charge of the Cleveland Bureau Office.

McANALLY, IKE, New York Post, New York, N. Y. This individual is a reporter for the New York Post and has approached Special Agent in Charge R. Whitley on several occasions with respect to knowing persons who could put the Bureau in contact with Alvin Karpis. Some negotiations were conducted as to Lucky Luciano, but nothing ever materialized as to this.

McDONALD, CASSIUS M., 500 Trombly Road, Grosse Pointe, Michigan. This man was convicted in United States District Court, St. Paul, Minnesota, on January 24, 1936, of participation in the conspiracy to kidnap Edward George Bremer. His part in the conspiracy was the exchanging of \$92,000.00 of the ransom money at Hayma, Cuba. He was acquainted with the various major figures in this case.

McFARLAND, DANNY, 523 N.E. 17th Street, Miami, Florida. This man is a gambler and an underworld character from Chicago, Illinois. He has furnished information as to William J. Harrison, and it is possible that information of value regarding Karpis may come to him. In Chicago he can be reached through his sister, Mrs. McElroy, 8004 South Paulina Avenue, telephone Triangle 8400.

McGINTY'S SALOON, 2801 Detroit Avenue, Cleveland, Ohio. This place is reported to be frequented by "Shimmy" Patton of the Harvard Club, a known contact for Karpis; and is a probable contact point for Karpis and Campbell.

McGURN, JACK, "Machine Gun," Chicago, Illinois. This individual is a well-known underworld character and has been described by Vivian Mathis, paramour of Verne Miller, as the foremost contact for the Barker-Karpis mob in Chicago. He was an intimate associate of "Doc" Stacci, who is under federal sentence in the Kansas City Massacre case. Information is that McGurn is now operating a "bookie" and gambling joint in the former Citizens State Bank Building, Melrose Park, Illinois. This building is located near the railroad tracks.

McKAY, JAMES C., Reno, Mevada. This man is known as a contact for hoodlums visiting in Reno. Various members of the Barker-Karpis gang frequented Reno in 1933 and 1934, and information is that they had the protection of McKey and his partner, William Graham. Karpis has been in Reno on numerous occasions. It is also the information of the Bureau that the proceeds from the Hamm kidnaping were exchanged at Reno In July, 1933, through McKay and Graham.

McLAUGHLIN, JOHN J., (deceased). This man participated in the Bremer conspiracy to the extent of engaging in the switching of a portion of the ransom money. He was sentenced to five years in Leavenworth Penitentiary in May, 1935, and died while in the institution.

MADDOX, CLAUDE, alias Johnny Moore, Chicago, Illinois. This man is a well-known hoodlum in Chicago and is known as a member of the Capone syndicate. Information from one George Bougadis is that Maddox is a men who can put his finger on Alvin Karpis. This man is reputed to have participated in the St. Valentine's Day Massacre.

MANDERBAUGH, IRA, Chief of Police, Canton, Ohio. This officer is reported to be highly reliable, but due to conditions existing in Canton has asked that he be contacted only at his home. He is endeavoring to learn through his confidential informants if Subjects in this case are located in the vicinity of Canton.

MANNO, SAM, 825 South Marshfield Avenue, Chicago, Illinois. This man, with Joe Gallechio, was a visitor at "Doc" Barker's apartment, 432 Surf Street, Chicago, Illinois, shortly prior to Barker's arrest. The name of "Pat Manno, 825 South Marshfield Avenue," was found on a piece of paper in the Barker house in Oklawaha, Florida. Information from Bruno Austin is that Manno and Gallechio supplied the gang with gums.

MANSON, HARRY, Police Department, Toledo, Ohio. This man is a detective with the Toledo Police Department, but is assigned to duty at the office of Mr. Frazier Reams, County Attorney. Both he and Mr. Reams are considered as fully reliable end have furnished valuable information to Bureau Agents in the past. Manson has been an officer in Toledo for many years, has a wide knowledge of the underworld setup in that city, and is one of the few honest officers in the police department.

MARENO, MIKE, Melrose Park, Illinois. This individual has been mentioned as a possible contact for the Barker-Karpis mob in Chicago, Illinois, and vicinity. He is a cousin of Tony Mareno. His photograph is available in the Chicago Bureau Office.

MARENO, TONY, Melrose Park, Illinois. This man is an associate of Elmer Farmer and is a possible contact for the Barker Karpis gange. It is to be noted that Volney Davis advised that the car he was driving at the time of his arrest was a stolen car furnished to him by this individual. Investigation has not substantiated this statement, however. Photograph of this man is available in the Chicago Bureau office.

MARINO, "SOAP", San Francisco, California. This men, according to Bryan Bolton, is the leading contact for the Barker Karpis gang in San Francisco. See statement of Bryan Bolton in report of Special Agent K. R. McIntire, Chicago, Illinois January 25, 1935.

MASSNER, JOHN W., West Flagler Kennel Club, Mismi, Florida. This man has been in the dog racing business since the inception of the sport, and knows practically everybody in the country connected with the game. He has expressed a willingness to furnish information to the Bureau, particularly during the season at Miami, Florida; and he should be contacted for this purpose.

MATHIS, VIVIAN, Brainerd, Minnesota. This woman was the consort of Vernon C. Miller, one of the actual killers in the Kansas City massacre. She is now on probation following her plea of guilty and sentence in the massacre case at Kansas City, Missouri in January, 1935. She has furnished valuable confidential information to Bureau Agents in connection with the Kanmo and Brekid cases; and for that reason, it is not believed she will resume associations with members of the Barker Karpis gang, although she is intimately acquainted with them all. At the present time she is either living with her parents at Brainerd, Kinnesota or working for Robert Kennedy at Sioux Falls, South Dakota.

MERKINS, GLADYS, St. Paul, Minnesota. This woman was the paramour of Tom Filben, underworld character in St. Paul, and in view of the recently reported death of Filben, it is possible that she may be located and interviewed for information of value in this case and in the Hamm kidnaping case. See report of Special Agent John L. Madala, Chicago, Illinois October 50, 1934a

MICKEY, (last name unknown), Chicago, Illinois. This man is a bartender at the Pioneer Tavern, Grand and Western Avenues, Chicago, Illinois and is reported to be a friend of Russell Gibson and Doc Barker. He is undoubtedly acquainted with Alvin Karpis and other figures in this file. See report of Special Agent W. C. Ryan, Chicago, Illinois February 19, 1935.

MIDDLE ISLAND, Ontario, Canada. This island is located across the international boundary line in Canadian waters of Lake Erie, and is accessible to Lakeview and Port Clinton, Ohio. According to Walter Belpash it is owned by Guy Tibbels, Joe Roscoe and a man named Stacey. Members of the gang frequented this place during the summer of 1934. It would afford an excellent hideout spot in the winter time as it is very little frequented.

MILLER, VERNON C. This man was a criminal associate of the Barker Karpis outfit. He was known as a bank robber and killer, and participated in several jobs with the gang. He was a principal in the Kansas City massacre. Vivian Mathia was his paramour. His body was found on the roadside near Detroit, Michigan late in 1935.

MILLIGAN, OPAL, St.Paul, Minnessta. This woman is a prostitute operating in St.Paul, Minnessta. She has been closely associated with Pat Reilly and Homer Van Meter, and was responsible for turning Reilly in to the Bureau. She is in possession of considerable information concerning the underworld of St.Paul, including the Police; and if the proper contact is made with her it is believed that information of value generally, and possibly as to Karpis can be secured.

His relationship with Bureau Agents who have dealt with him has been of the closest confidence, and he should not be contacted except upon specific instructions of Special Agent in Charge E. J. Connelley.

All negotiations thus far have met with negative results, but he is still hopeful of results. Constant contact should be maintained with him in order that full information as to developments of this angle may be available and followed.

MITCHELL, WILLIAM J., 3077 West Boulevard, Cleveland, Ohio. This individual is one of the owners of the Harvard Club. He also operates the William J. Mitchell Realty Company, 15029 Loraine Avenue, Cleveland, Ohio. It was through this organization that the premises at 18109 Flamingo Street were rented to Alvin Karpis and the Delaney girl during the summer of 1934. Information is that the rental was handled by Mitchell's son, C. N. Mitchell. This man went to Europe in 1934 with William Fergus and Clarence Hebebrand in connection with a slot machine syndicate. He has never been interviewed on account of his clese affiliation with Art Hebebrand and "Shimmie" Patton.

MORAN, JOHN RUSSELL alias "BABS" St.Louis, Missouri and Chicago, Illinois. This mem is an underworld character whose exact address is unknown, and is a criminal associate, according to Volney Davis, of the Barker Karpis outfit. Information in possession of the Bureau is that Babs Moran participated in the payroll robbery at South St.Paul, Minnesota during August 1933, in which Charles J. Fitzgerald was wounded. It is also reported that this man was intimate with the late Gus Winkeler, and was at one time employed by him as a body guard. No direct relationship of this man with Alvin Karpis is known of.

MORAN, DOCTOR JOSEPH P. - Fugitive. This man was a member of the Barker Karpis gang. He was active in the exchanging of the ransom money, in furnishing medical aid and in performing operations in the way of changing the fingerprints and facial appearances of the Barkers, Karpis, Davis and others. Information is that he was killed at Toledo, Ohio in May of 1934 by Doc Barker and Russell Gibson and his body disposed of in Lake Erie, but no body answering his description has been recovered. There has been no trace of him since the time of his reported death.

MORIEY, WILLIAM A, Danmor Hotel, Atlantic City, New Jersey. This man is part owner of this hotel, where Karpis, Campbell, Dolores Delaney and Wynona Burdett were residing when Karpis and Campbell escaped from the Atlantic City police under suspicious circumstances on January 20, 1935. Morley is a close friend of Duke Randall, who is under indictment at Miami, Florida for barboring Karpis. He referred the fugitives to Morley.

MORTENSEN, DOCTOR NELS G. 2252 Fairmount Avenue, St.Paul, Minnesota. This doctor was investigated in the Dillinger case for furnishing medical treatment to John Dillinger and John Hamilton. It is to be noted that his name was given as a reference by Alvin Karpis and Fred Barker when they rented the house at 204 Vernon Avenue, St.Paul, Minnesota on May 27, 1935, said house being occupied by them at the time of the Hamm kidnaping.

MOTION PICTURE OPERATORS UNION, 504 South Wabash Avenue, Chicago, Ille, telephone Harrison 5352. This organization is controlled by hoodlums. Eddie Donovan a known contact for the gang is an officer of this union. Report of Special Agent J. H. Hanson, Jacksonville, Florida February 20. 1935 reflects a long distance telephone call to Harrison 5352 from room 1005, El Comodore Hotel, Miami, Florida on Hovember 2, 1934, this room being occupied by Harry Campbell and Fred Barker. This same number was likewise found on a piece of paper in the house at Oklawaha, Florida there Fred Barker and Ma Barker were killed while resisting arrest. These calls were undoubtedly made in contacting Eddie Donovan. A telephone tap should be considered as to this telephone.

MULLOY, FRANK B. ("FRITZ"), 14 E. 56th Terrace, Kansas City, Missouri, This man is under sentence to Leavenworth Penitentiary following his conviction in January, 1935 for conspiracy in the Kansas City massacre case. His case is under appeal at the present time. He is a bootlegger and tavern proprietor. He is well acquainted with various members of this gang and has been known for a long time as one of their chief contacts. It is believed that arrangements should be made by the Kansas City Bureau office to be kept informed as to his movements and activities.

MUNRO, COLIN, address Bert Angus cottage, near Tabernal, Sand Beach, Toledo, Ohio. This man tended bar at Middle Island during the summer of 1934 and later at the Casino Club in Toledo, Ohio. He has been interviewed and some data of value in a harboring investigation was supplied by him. See report of Special Agent R. D. Brown, Chicago, Illinois March 25, 1935.

MURRAY, EDNA,. This women was the consort of Volney Davis, one of the participants in the Bremer kidnaping. She was alrested with him, and subsequently returned to the Missouri State Penitentiary, Jefferson City, Missouri as an escaped prisoner, following her acquittal in the first Bremer trial as a co-conspirator. After her return to the Missouri institution she was interviewed by Bureau Agents and supplied data-which was later the basis of valuable testimony furnished by her in the second Bremer trial, which resulted in the conviction of Harry Sawyer and William Weaver. She has also been of assistance to the Bureau in the Hamm kidnaping case.

MASH, FRANK. This man was a criminal associate of the Barker Karpis gang, his specialty being bank robbery. He was killed on June 17, 1935 at the Union Station in Kansas City, Missouri, during efforts of Vern Miller, Pretty Boy Floyd and Adam Richetti to effect his release from officers. Four officers, including Special Agent Raymond Onffrey were slain at that time.

NEWBOLD, EMILY, 2840 North Francisco Avenne, Chicago, Illinois. This woman is a sister of Alvin Karpis, and wife of Phillip Newbold. She has stated she would not assist the Government in any way in locating her brother. The parents are being covered and telephone conversations between the parents. She and her husband reside in the same apartment building as the parents.

MEWBOLD, PHULIP, 2840 North Francisco Avenue, Chicago, Illinois. This man is a brother-in-law of Alvin Karpis. He is employed at the round house of the A.T. and S.F. Railroad as a machinist, the round house being located at 18th Street and Wentworth Avenue. He was interviewed by Special Agent R. D. Brown on November 18, 1935 - see report of Special Agent John L. Madala, Chicago, Illinois December 10, 1935, page 28. He received Agent Brown cordially, stating he had no sympathy for Karpis; that he wished he would be apprehended, and that he did not want to see him killed. He advised he did not believe the relatives had any knowledge of Karpis' whereabouts. He stated he had never fully made up his mind as to whether he would "turn in" Karpis if the opportunity arcse. It is not believed that any information of value will be secured through this man, for the reason that the above conversation between him and Agent Brown was later repeated to John Karpavicz.

NIELAND, MRS. CECILIA, 6000 West 5th Avenue, Gary, Indiana. This woman and her husband reside at this address and are employed by Jacob Heidt at his gasoline station at the same address. She has been interviewed and furnished information that Fred Baster and Alvin Karpis frequently stopped at the gas station during September, 1934 and had long talks with Ruth Heidt. This gasoline station was undoubtedly a prominent contact point for Karpis. This woman has promised her cooperation, and contact should be maintained with here. See report of Special Agent R. D. Brown, Chicago, Illinois January 8, 1935, page 17.

NITTI, FRANK, Chicago, Illinois. This man is reported to be the leading figure in the Capone syndicate at the present time. He was a close friend of Fred Goetz and is possibly close to Alvin Karpise

MOONAN, FRANK J., 1900 Euclid Avenue, Cleveland, Ohio. This man operates a private detective agency at this address under his own name. He is intimate with the operators of the Harvard Club and supplies guards for the place. Although he has been pretending to act as a confidential informant for the Cleveland office, it is believed he is acting in bad faith and has been coming to the office in an effort to secure information. Information from Dolores Delaney is that Karpis was in possession of an identification card of Noonan's detective agency, bearing a photograph, which he used on several occasions when stopped by police officers. Future investigation as to him and a thorough interview may become desirable.

O'BRIEN, JOSEPH alias Aluppa, 2242 South Cicero Avenue, Cicero, Illinoise

This man is part owner of the Hi-Ho Club at this address. He is a hoodlum and was a friend of Doc Barker, and Russell Gibson, deceased. Bruno Austin stated that O'Brien referred him to Elmer Farmer in November, 1934 and that he was closely connected with the Barker Karpis gang. O'Brien according to rumors, is a killer for the Syndicate in Chicago.

O'BRIEN, W. W., 6842 Paxton Avenue, office 77 West Washington Boulevard, Chicago, Illinois. This man is a well known criminal attorney in Chicago, and is known as a man who is not overly bothered with ethics. William J. Harrison was very friendly with him and gave his name as a reference in the renting of the apartment at 3920 Pine Grove Avenue, Chicago, Illinois where Russell Gibson was killed while resisting arrest. The close connection of Harrison and O'Brien is considered significant, and he is undoubtedly a possible contact of Karpis and Campbell.

O'CONNOR, DORIS, 206 East Adams Street, care of Harry C. Stanley, brother, Pittsburgh, Kansas. This woman is a sister of Edna Murray and paramour of Jess Doyle, former member of the Barker Karpis gang. She is well acquainted with most of the persons connected with the gang, and would be a likely contact for the remaining fugitive subjects.

OLDS, B.B., 4207 North Lockwood Avenue, Toledo, Ohio. This man lives next door to Ted Angus in Toledo, and is in a position to secure information as to the activities at the Angus house. He is not acquainted with any of the geng. Contact should be effected with him away from his house as he does not desire his wife to know he is supplying information to the Government.

O'NEILL, JAMES "TIP", Logan Apartments, No.19, 11835 West 117th St. Lake-wood, Ohio. This man is an intimate friend of James Patton of the Harvard Club. He is an ex-convict, having served sentences in both Leavenworth and Atlanta penitentiary on mail robbery charges, having been released from the former institution only in 1935. He has a long criminal record and is a potential participant in any major mail robbery. It is felt that he might be a contact for either Karpis or Campbell, as information indicates he is an informant of Post Office Inspector S. K. Hetterick, Cleveland, Ohio in the matter of the Garrettsville, Ohio mail robbery. Active investigation is being pursued as to this man at the present time.

O'NEILL, TDMOTHY, East Chicago Police Department, East Chicago, Indiana. This man is well acquainted with the underworld in East Chicago and Cary, Indiana, and is regarded as being very reliable. Information of value has been obtained from him in the past.

OSWALD, HERMAN E., 2015 East 71st St. Chicago, Illinois. This man is a notary public and executed the jurat on an application for auto license for Big Homer Wilson at one time. He is well acquainted with Eddie Donovan and Johnnie Ball, former proprietors of the Green Lantern Tavern, and in light of this situation it is possible that he is friendly with Karpis, and others connected with the gang which bears his name. See report of Special Agent R. C. Suran, Chicago, Illinois November 12, 1934.

PATTON, JAMES A. "SHIMMIE" 3532 West Boulevard, Cleveland, Ohio, telephone Clear Water 4777. This man is one of the owners of the Harvard Club and according to Bryan Bolton is acquainted with and is one of the main contacts for the major subjects of this file. He has never been interviewed, same having been deemed inadvisable to date.

PATTON, JOHN, Mayor, Burnham, Illinois. This man was a former close friend of William J. Harrison, and played golf with him on the Municipal course operated by the city of Burnham. Patton is reported to have been a former member of the Capone syndicate. He is interested in the owner-ship of Sportmans racetrack and in the deg tracks at Miami Beach and Tampa, Florida. See reports of Special Agent R. D. Brown, Chicago, Ill. November 12 and December 17, 1934. This man is a potential contact for Karpis.

PTEIFFER, JACK, St. Paul, Minnesota. This individual has been an intimate associate of and contact for all members of the Barker Karpis gang for a good many years. He has operated the Hollyhocks Inn in the Twin Cities for a number of years. Arrangements should be made to secure data as to the activities of this man, both at his place of business and residence. Information in possession of the Buream is that Pfeiffer was one of the leading conspirators in the Hamm kidnaping.

PHILLIPS, BERNARD. This man was a former connection of the Barker Karpis mob in the robbing of banks. He was with Thomas Holden, Francis Keating and Harvey Bailey on July 7, 1932 at the Mission Golf course in Kansas City, Missouri at the time of their apprehension, but he evaded arrest. Underworld rumors have been that he was subsequently killed in gangland fashion and buried in an unknown grave, because of the belief that he "fingered" his friends for the authorities.

PIONEER TAVERN. 2352 Grand Avenue, Chicago, Illinois. This tavern is a hoodlum hangout and has been frequented by members of the Barker Karpis outfit.

POOLE, LILLIAM, ("Lou"); this woman formerly worked as a prostitute in the house of Edith Barry, 524 Southard Street, Toledo, Chio, Telephone tap on the house indicates that she hates the Barry woman, and might furnish date as to her.

Karpis and Campbell were harbored in the Barry house after their flight from Atlantic City, New Jersey in January, 1935, and during the summer of 1935 lived with Lou and Edith Barry at Cedar Point, Ohio.

Woman resulted in information of value, and in a setup which may result in the location of subjects Karpis and Campbells

RANDALL, DUKE, Miami, Florida, Randall is under indictment at Miami, Florida for having harbored Karpis there. His present employment is unknown, but during the 1934-1935 season he was employed by the Rolf Armored Service as a guard at the Biscayne Kennel, Club. It is doubtful if Randall will further implicate himself by contacting Karpis and Campbell, but arrangements should be made to be advised of his activities and he should be contacted periodically.

REAGAN, CHARLES A., 7133-37 Yates Avenue, Chicago, Illinois, manager of Yates Apartments at this address, where Alvin Karpis and Dolores Delaney lived in May, 1934 as Mr. and Mrs. Willism J. Lohman. The furniture of Karpis is being held for back rent. Arrangements have been made with Mr. Reagan to notify the Chicago Bureau office if any attempt is made to secure this furniture.

REILLY, MRS. HELEN "BABE" 1039 Lawson Street, St.Paul, Minnesota. This woman at times visits with her brother Robert Delaney at 6045 Kimbark Avenue, Chicago, Illinois. She is the daughter of Mrs. Helen Delaney, and the wife of Pat Reilly, immate of Leavenworth Penitentiary on a charge of harboring John Dillinger. Reilly worked for Harry Sawyer in his St. Paul saloon prior to the closing of the place, and is well known to all members of the Barker Karpis gang. At the present time (January 24,1936)

this woman is visiting her brother in Chicago, and has been at the home of John Karpavicz on several occasions. It is anticipated that she will return to her home in St. Paul shortly, and arrangements should be made to receive advice as to her activities.

REILLY, PAT United States Penitentiary, Leavenworth, Kansas. Pat Reilly was a former bartender and messenger for Harry Sawyer during the time the Barker Karpis gang was operating in and out of St.Paul. He was convicted in the Jodil case for activities in harboring fugitives. He is the husband of Helen "Babe" Reilly, a member of the Delaney family. Reilly was recently transferred to Leavenworth Penitentiary following the denial of his application for parole. During recent interview he stated that he would be willing to "finger" Karpis after his release from prison, and felt confident he would be able to do so. This statement on the part of Reilly should be borne in mind.

REPUBLIC FINANCE COLPANY, St. Paul, Minnesota, This organization has been the medium through which members of the Barker Karpis gang have purchased cars through the help of one Herb Wilds.

RIVERSIDE INN, near Edward Hines, Jr. Hospital, Hines, Illinois. This is a place formerly patronized by all members of the Barker Karpis gang for meals. This information was supplied by Bessie Skinner Green. See report of Special Agent R. C. Suran, Chicago, Illinois December 4, 1935.

ROBERTSON, IMOGENE, 521 South Hobert Boulevard, Los Angeles, California. This girl resides with her mother in an apartment at this address. She formerly worked as a telephone operator in another apartment house in Los Angeles. At the present time she is posing as the secretary of Charles J. Fitzgerald, and it is presumed that the usual intimacy exists between them. The surveillance being maintained on Fitzgerald covers this woman. Recent developments indicate that one Murray Cook of Ashtabula, Ohio is going to Los Angeles to marry this girl, and for that reason it is possible that there may be some change in the setup as to Fitzgerald, which might cause him to abandon his present arrangements and possibly hasten contact with Karpis and Campbelle

ROSCOE, JOE, Toledo, Ohio. This individual is an underworld character: in Toledo, Ohio. He is a business associate of the Angus brothers. He is said to own Middle Island in Canadian waters in Lake Erie, where information has it, members of the gang visited during the late spring of 1934.

Information through informants is that Roscoe is a contact for Karpis and Campbelle

ROSELYN HOTEL, Los Angeles, California. The name of this establishment is possibly the Rosslyn Hotel. Dolores Delaney has informed that Karpis made a trip to Los Angeles with her and registered at this hotel; and that during their two days stay he remained in his room, it being her belief to he was awaiting a contact of some sort. Inquiries should be made to ascertain if Karpis is known and if he has been frequenting this place of late.

has been acting as a confidential informant for the Cleveland Bureau office in connection with the activities at At the present time to be not active as the result of a raid by the County Attorney's office; but it is anticipated that the place will reopen in the near future. Contact should be maintained in order that data on the activities of Hebebrand and his associates may be obtained.

RYAN, J. J. alias Yen Yen. This man was an associate of the Barker-Karpis gang and was particularly close to Vern Miller. Helen Ferguson, former informant and paramour of Earl Christman, was living with Ryan under his alias of Burke at the time of her arrest in 1934. Ryan is presently an immate of Sing Sing Prison, Ossining, New York, he having been returned there in 1935 as an escaped prisoner following his arrest in Chicago.

SALTIS, JOE, Hayward, Wisconsine This individual owns a large home in the vicinity of Hayward, and rumors have been received that Karpis may be using this place as a hideoute

SAMSKY, HARRY, 1332 South Kedzie Avenue, Chicago, Illinois, telephone Crawford 1661. This man operates the Acorn Express and Van Company at the above eddress and also resides there. During the fall of 1934 he cooperated fully in efforts to locate Russell Gibson, and at that time demonstrated the fact he had numerous underworld connections. His connection with the Bureau would be that of an informant. It is to be noted that Samsky at one time operated outside of the law, and for that reason has hoodlum connections.

SARGEANT, GEORGE, Toledo, Ohio. This man is a well known hoodlum in Toledo and formerly resided at the Hillcrest Hetel. He is intimately acquainted with Mildred Kuhlman, and became very bitter when she began consorting with Dec Barker. On account of his underworld connections it is doubtful if Sargeant would supply any information, but the possibility should be borne in mind. Recently Sargeant was being held in jail at Akron, Ohio on a mail robbery charge. The disposition of his case is not known.

SAWYER, CLADYS, St.Paul, Minnesota, This woman is the wife of Harry
Sawyer who was convicted at St.Paul, Minnesota on January 24, 1936 for
conspiracy to kidnap Edward George Bremer. When in custody at the
Chicago Bureau office in September, 1934, following her arrest at Cleveland, Ohio, she furnished a signed statement of her knowledge of the activities of the Barker Karpis gang, and of the participation of her husband in the Bremer kidnaping; but she later returned to her husband and
is regarded as hostile to the Bureau at the present time. St.Paul office
should arrange to be advised of her movements and activities, as she may
become active with other members or contacts of the mobe

SAWYER, HARRI. This man operated saloons at 541-545 Wabasha Street, St. Paul, Minnesota for many years, and during that period became intimately acquainted with all members of the Barker Karpis gang. He has been a contact for the mob, and has been often referred to as the boss of the underworld in St.Paul. He has also participated in numerous crimes with the gang; and, on January 24, 1936 was sentenced to life imprisonment, in United States District Court, St.Paul, Minnesota for his part in the Bremer kidnaping.

SHERWOOD, ALVIN, South Coffeyville, Oklahoma. This man is an ex-convict from the Kansas and Oklahoma State Penitentiaries, his number in the latter institution being 19472. He originated at Shawnes, Oklahoma but for some years has been located in South Coffeyville, Oklahoma and Coffeyville, Kansas. He is a close associate of Tom Hill and it is well established that he knows all of the major subjects of this case, including the two remaining fugitives. It is believed that appropriate action should be taken to be kept advised of the activities of this individual, and that the possibility of making an informant of him should be considered.

SHORTY and DUTCH, Joplin, Missourie Statement was made by Wynora Burdett (see report of Special Agent S. L. Fortenberry, Detroit, June 27, 1935), that two men known to her only as Dutch and Shorty had at various times hidden out Karpis and Campbell at a little farm located some seven or eight miles south of Jopline

SKIDMORE, BILLIE, Chicago, Illinois. This man is reputed to be one of the present heads of the Capone syndicate. Because of Karpis contacts with other syndicate men, it is possible that this man is acquainted with him.

SLAYMAN, DOROTHY, 212 Kast Brady Street, Tulsa, Oklahoma. This woman is the former wife of Alvin Karpis. She married him during the fall of 1931 and lived with him only a short time. She divorced him at Tulsa, Okla. on November 19, 1935. Information at hand is that she has not been in contact with him since the fall of 1931 or immediately preceding the murder of Sheriff C. R. Kelley of West Plains, Missouri in December 1931. This woman has corresponded with members of the Karpavicz family from time to time and is still regarded in a friendly fashion by them. She is said to be operating a hot dog stand in Tulsa, Oklahoma at the present time. A check on her possible contacts with Karpis is being maintained through Special agent in Charge Dwight Brantley of

me oklanoma City Bureau office.

SOUTHMOOR HOTEL, 67th and Stony Island Avenue, Chicago, Illinois. This is the place where various members of the Barker Karpis gang, including Alvin Karpis, stopped from time to time.

SPANISH CLUB, Manheim and Roosevelt Roads, Hillside, Illinois. This place is operated by Louis "Doc" Stacey or Stace; a well known contact for hoodlums and a known acquaintance of members of this mob. One George Coraseo is a joint owner of this place and is engaged in the active operation of same.

STACEY, LOUIS "DOC", 609 South 7th Street, Maywood, Illinois. This man formerly operated the O.P. Inn, Maywood, Illinois, and is one of the owners of the Club Spanish, Hillside, Illinois. He has been a prominent contact for members of the Barker Karpis gang for a number of years. He was convicted at Kansas City, Missouri in January, 1935 as a conspirator in the Kansas City massacre ease, and is under sentence to Leavenworth Penitentiary. His case is under appeal at the present time, "Doc" Stacey has been connected with the Chicago underworld for years, and is an intimate friend of "Machine Gun" Jack McGurn. Members of the gang frequented the O.P. Inn while Stacey was operating it.

STEINHART, "FRISCO DUTCH" St.Paul, Minnesota. This man is undoubtedly a contact for Alvin Karpis. According to information, he may have participated in the proceeds of the Hamm kidnaping. It is believed he

operates a resort in the Twin Cities known as the Boulevards of Paris,

TAMBINI, LOUIS "BONEST San Francisco, California, is alleged to be a contact in San Francisco and vicinity for Alvin Karpis. He is a bartender for "Soap" Marino. The San Francisco office should obtain the address of this man and arrange the necessary contacts, to be kept advised of his activities.

THOMPSON, JOE, Fort Meigs Hotel, Toledo, Ohio, This man is known as a lobbyist and business racketeer in Toledo. He is apparently the paramour of Edith Barry, When the harboring investigation is gone into at Toledo, this man is to be considered.

TIMENY, GEORGE, Toledo, Ohio. This individual is a Captain in the Toledo Police Department. Investigation has shown he associated with various members of the Barker Karpis gang at the Casino Club during the Spring of 1954, and that he was aware of their activities. He also furnished his motor boat to members of the gang for their use. There is nodoubt as to this man being a contact of the gang. Any investigation in Toledo, Ohio or vicinity should be made with Timeny in mind.

TUBBS, RED, Sallisaw, Oklahoma, has a log cabin and small farm about four miles from Sallisaw on the road to Stillweil, Oklahoma, Information is that Alvin Karpis has been frequenting this place recently. See letter from the Denver office to the Oklahoma City office dated January 27,1936.

TWILLEY, MRS. ESTHER, 1401 Elm Street, Coffeyville, Kansas. This woman will furnish information as to any fugitives who appear in Coffeyville, Kansas, South Coffeyville, Oklahoma and vicinity. She is the mother-in-law

of Earl Morris, a friend of James White of Washington, D.C. She recently stated Morris is working for another son-in-law, namely Ted Thornton who operates a tavern on the highway between Fort Scott, Kensas and Nevada, Missouri. Contact should be maintained with this woman for what information of value she may obtain.

UNCIE, MERIE, Police Department, Toledo, Ohio . This man is a Police Detective at Toledo, Ohio and is assigned to duty with Detective Harry Manson. (See details under Manson's name for further information). Uncle is regarded as thoroughly reliable.

VALLEJO GENERAL HOSPITAL, Vallejo, California. This institution was formerly operated by Thomas C. "Toby" Williams. Karpis and Charles J. Fitzgerald have been petients at this place. Williams is now serving a sentence at McNeil Island Penitentiary for having harbored Lester J. Gillis.

VAN BORRIES, DOCTOR OTTO, Chicago, Illinois. This man is a plastic surgeon at Chicago who has possibly treated Alvin Karpis. An advertisement bearing his name was found among the personal effects of Karpis at Miami, Florda. (See report of Special Agent J. H. Hanson, Jacksonville, Florida February 20, 1935).

VENUTE, CLARA, 525 North Wood Street, Chicago, Illinois. This woman is a sister of Karpis. She has been interviewed and asked to cooperate with the Bureau in efforts to locate her brother, but has stated positively that she will have nothing to do with the case. I will cover is bracked by in operation as to here

WRBA MOTOR COMPANY, 5100 West 25th St. Cicero, Illinois. Russell Gibson purchased two Ford cars from this place, one in the name of Mrs. Clara Gray and the other as Andrew Allen. Both were bought in 1934. (See report of Special Agent R.D. Brown, Chicago, Illinois January 8, 1935). William J. Harrison also bought one car here under the name of J.B. Bolton.

Information and official experience with this concern indicates it camters to hoodlums, and is non-cooperative toward the Bureau.

WALMSLEY, WALTER, 528 Southard Street, Toledo, Ohio. This negro is employed as hendy man in the call house of Edith Barry, which is located immediately adjacent to the house in which he lives. He is to be considered as a defendant or witness when the harboring investigation at Toledo is gone into.

WALTERS, PAUL A., 500 South Virginia Street, Reno, Nevada. Alvin Kampis has rented automobiles from this individual, using the name Burns or Burnes in the transactions.

WEAVER, WILLIAM. This man was a member of the Barker Karpis gang and took part in the Bremer kidnaping. On January 24, 1936 he was sentenced to life imprisonment for his part in this crime at St.Paul, Minnesota. The true name of Weaver is Phoenix Donald. His paramour was Myrtle Eaton.

WILDS, HERBERT, St. Paul, Minnesota, operator of a known hoodlum garage called Herb's Garage, through which members of the Barker Karpis gang are known to have purchased automobiles.

WILLETTS, FRANK, 818 North Kensas Avenue, Topeka, Kansas. This man operates a feed store in Topeka, Kansas and is said to be a close friend of John Karpavicz. It is possible that arrangements might be made with him to obtain information from the father of subject Karpis. (See report of Special Agent A. J. Norstrom, Kansas City, Missouri August 9, 1935).

WILLIAMS, THOMAS C. "TOBY", Vallejo, California. This man formerly operated the Vallejo General Hospital. He is well acquainted with Alvin Karpis and Charles J. Fitzgerald, and both men have had operations performed at the hospital. Williams is now a prisoner at McNeil Island Federal Penitentiary; and in recent interview disclaimed knowledge of means of locating Karpis. Upon his release from the penitentiary he should be re-interviewed.

WILSON, HOMER J. (deceased). This man was a notorious bank robber and was intimately acquainted with the various members of the Barker Karpis gang. He died at Chicago, Illinois during November, 1934 following an appendicitis operation. Interview was had with his widow Margaret Wilson but she denied knowledge of the Barker Karpis gang.

WILSON, JAMES J., a former associate of the Barker Karpis mob, now serving a five year term in the United States Industrial Reformatory at Chillicothe, Ohio, following conviction in the Bremer case during May, 1935 at St.Paul, Minnesota. He was intimate with Doctor Joseph P.Moran, took part in the money changing activities, and acted as nurse for several of the major figures in this case after Doctor Moran had performed operations upon them.

WINKELER, CUS (deceased); this man was formerly one of the most notorious criminals in Chicago and was one of the heads of the Capone syndicate. He was shot to death in Chicago, Illinois in gangland fashion. He was an intimate of the Barker Karpis gang. His wife is Georgette Winkeler.

WITTKOP, DOCTOR CONFAD, 51 Avenue de la Républica, Havena, Cuba. This doctor treated Karpis for chronic inflemation of the urethral track, during October, 1934 while he was in Havena. This person is to communicate with the American Embassy should Karpis again appear for treatment.

WOODEN SHOE TAVERN, 117th Street, Cleveland, Ohio. Information has been received by the Cleveland Bureau office from Post Office Inspectors at Cleveland, Ohio that Karpis and Campbell have been frequenting this place. This should be the subject of appropriate investigation.

WOODS, C. W., Toledo, Ohio is an aliam of ELWOOD S. YONKER. (See data set out under that name).

YONKER, ELWOOD S., 2525 Georgetown Avenue, Toledo, Ohio. This man is acquainted with Ted Angus, Bert Angus, Joe Roscoe and others at Toledo, Oe and through them met the various members of this gang. Charles J.Fitz-gerald and Belle Born lived in his home intermitently during 1934. Yonkers, who is also known as C. W. Woods, promised to secure information for the Bureau, but he has not as yet produced.

YOUNG, DANIEL, Atlantic City, New Jersey. This man is part owner of the Danmor Hotel, from which Karpis and Campbell escaped on January 20, 1935. He is a friend of Duke Randall, who is under indictment at Miami, Florida for harboring Alvin Karpis.

This report was prepared for the use of all field offices in referring to connections of ALVIN KARPIS, and in conducting investigations in a particular district. A similar report is being prepared by Special Agent D. P. Sullivan at Chicago, Illinois with respect to Harry Campbell. The two reports are correlated in that contacts common to both subjects are contained in both reports. The attention of each field office is called to this fact in order that the last contained therein will be jointly considered.

It is requested that each field office review this report and renew investigation as to persons named therein, or initiate such investigation. Where contacts appear to be active, or are such that information of value might be obtained as to the location of Alvin Karpis or Harry Campbell, it is desired that constant investigative activity be maintained, and reports submitted at least twice per months

Reference is made to your teletype message dated February 6, 1936, in which this office was advised that Fitzgerald and party departed from Los Angeles at about 11:15 A. M. that day; that surveillance was being maintained by Special Agents of the Los Angeles office and that this office was requested to assist in the surveillance should Fitzgerald and party stop in this district.

In view of the fact that on a previous visit to Phoenix Fitzgerald and party stopped at the San Carlos Hotel, arrangements were made with the management of that hotel to have an agent listen to any telephone conversations made by Fitzgerald or members of his party should they again stop at the San Carlos Hotel.

Fitzgerald and his party arrived at the San Carlos Hotel at about 10:45 P. M., February 6, 1936. Fitzgerald registered as J. C. Foster from Los Angeles, California, and was assigned room 520. Other members of the party registering at that hotel at the same time were J. C. Archer, Los Angeles, California, room 718, L. J. Haley, Los Angeles, California, room 514; Mrs. W. H. Holmes, Amarillo, Texas, room 714.

Shortly after registering the entire party proceeded to the Adams Hotel Bar and Buffet, about one block distant from the San Carlos Hotel, and were there kept under surveillance by Special Agents H. F. Small; Arthur C. Rutzen, and M. A. Snow, of this office, until 12:45 A. M., February 7, 1936, at which time they returned to the San Carlos Hotel and proceeded to their respective rooms. Fitzgerald party consumed a considerable amount of liquor. Special Agents Snow and Small occupied room 512 at the San Carlos Hotel immediately adjoining the room occupied by Haley. All members of the Fitzgerald party requested to be called at 7:00 A. M., February 7, 1936. Haley also called Mrs. Holmes at about 12:55 A. M., advising that they would depart at 7:00 A. M. and bade her goodnight. A long distance teleral phone call was also made by Haley from his room at 1:00 A. M. to Exposition 1271, Los Angeles, California, and that conversation was listened to by Agent Snow through the hotel telephone switchboard. Halay talked to a Mrs. Bear at that number and advised that he had driven all the way from Los Angeles to Phoenix and was at that time taking a bath and asked her whether she could hear the water running in the tub. Mrs. Bear replied yes and cautioned him to be careful in driving on the following day and to call. her as soon as he got "there". She also advised that she had been in since about 9:00 P. M. and had been reading since that time. \*\*

No more telephone calls were made by any members of the party. Haley could be heard reading or otherwise moving papers about in his room until about 2:30 A. M.

Beginning at 6:30 A. M., Agents Snow and Small remained in or near the lobby of the San Carlos Hotel and observed the party go into the San Carlos Coffee Shop at 7:50 A. M. where they had breakfast. The entire party then left the San Carlos Hotel at about 8:45 A. M. in Mrs. Holmes's car and it was noted that Agent J. S. Bugas, of the Los Angeles office, followed in the Bureau Hudson. Agents J. J. McGuire, A. B. Leckie, and F. E. Wright, of the Los Angeles office, followed in the Bureau Buick shortly.

A search of all rooms occupied by members of the party made by agents Snow and Small after their departure revealed that an unfinished letter evidently written by Mrs. Holmes to her husband, addressed "Mr. W. W. Holmes, Box 571, Amarillo, Texas" had been torn up and left in the wastebasket of room 714 which she occupied. The unfinished letter, which is written on the stationery of the San Carlos Hotel, is quoted as follows:

"Dear Walter - Stopped at Covina on way out to get my mail and received your air mail - Our leases surely are in a hot spot and look like a sure shot. Glad you acquired the additional acreage - Surprised that you are another Dr. Hill - "

No other items of interest were noted to have been left in any other rooms although Fitzgerald evidently left a small hairbrush.

The unfinished letter written by Mrs. Holmes is being transmitted herewith to your office. The way you want

Reference is made to file titled UNKNOWN SUBJECTS; (Einn-Cantwell Jewelry Company, Hutchinson, Kansas.), National Stolen Property Act, particularly a letter from the Kansas City Office dated January 29, 1936, to this office which indicates that an informant of the Sheriff's Office at Hutchinson, Kansas, would appear in the Oklahom City District in connection with his efforts to obtain some of the property stolen in this robbery and to furnish information which would result in the apprehension of those responsible for the robbery. This informant is an ex-convict, who is working with the Sheriff at Hutchinson. Last week Sheriff George Allison of Hutchinson appeared here with Mr. Cantwell, the victim of the robbery, and stated that was in Shawnee, Oklahoma and desired the cooperation of this Bureau Office. Agent J. R. Welles was assigned to the case and contacted in Shawnee, who was supposed to put him in touch with members of the mob, but an all day and all night investigation was unproductive of any results did not ask Welles for any money but said he was broke and Leent Telles gave him a small/sum. stated that those participating in the robbery were H. Sa/Swafford; Gus/Hill of South Coffeyville, Oklahoma; Alton Crapo, of Kichita, Kansas; Charlie Bradford, ex-convict of the missouri Penitentiary; Maurice Martin, Pawhuska, Oklahoma; and a man by the name of Clampett or Clampitt of Hutchinson, Kansas. 0

made the statement that he had recovered two of the watches that were stolen in this robbery and that he had mailed them to the Sheriff at Hutchinson, but so far as is known they have not been received there. It is not believed by me that his statements in this connection are true.

Agent Welles told that if he received any further information as to the whereabouts of any of the gang or jewelry to contact him.

Oklahoma since he last contacted Agent Welles and on the night of February 5, 1936 he was at the Noble Hotel, Enid, Oklahoma and saw members of the gang mentioned above and that Subject Alvin Karpis was there and that he had some drinks with Karpis and he feels certain that Karpis left the State of Oklahoma last night but does not know where he went; that members of the gang proposed to dispose of the jewelry obtained in the Hutchinson robbery through a man by the name of Cabool, a Syrian, who operates the CC Dry Goods Company at O'Donnell, Texas on either February 7, or 8, 1936 that efter the jewelry is disposed of, the gang proposes to rob a bank at Roswell, New Mexico and he is to case the job for them and that thereefter they propose to rob a bank at McPherson, Kansas, information concerning which has already been furnished the officials at McPherson, according to stated that Karpis will be in O'Donnell with the gang and will perticipate in the robbery of the bank at Roswell.

Asked whether he knows Karpis. stated that he does and that he met him when he was in the Hutchinson Reformatory at a time when He stated that Karpis has had his face lifted and that he has a long scar from his right eye to the corner of his mouth on the right hand side, which is the reason Government Egents have not been able to apprehend him Kerpis stops at the Chase Hotel at Ninth and Holmes Streets and the Marquette Hotel at Twelfth and Holmes, both of Kansas City, Missouri and that it will be a very simple matter to effect his apprehension. He stated that he could cause his apprehension in 48 hours. He also stated that he knows Harry Campbell and met him in 1928 at a time when Campbell was running whiskey in Kansas. He stated that he could contact Campbell any time he desires and that he stops at apartment 203 at the Chase Hotel, Kensas City and goes with a girl named Mary Ann Mulhall of Pittsburgh, Kansas.

stated that he now has a wife living at Arkansas City, Kansas and he spends some of his time there. He stated that he is an ex-soldier and a member of the Masonic Lodge; that he has served in the U. S. Army and has served a term in the Penitentiary at Lansing, Kansas. He displayed papers indicating that he has stopped at the transient camp in Oklahoma City and had been in a CCC Camp at Newkirk, Oklahoma. He is described as follows:

It is requested that the interested offices be furnished with the known criminal record of as reflected by the files of the Identification Division of the Bureau.

It is believed possible that is and has been connected with some thieves. I am not inclined to believe that he is insane, but I do consider him a monumental liar. His stories concerning Campbell and Karpis, in the opinion of the writer, are fanciful and perhaps creatures of his imagination.

This situation was discussed with SAC Connelley at Cleveland and it was agreed between him and me that should contact the Dallas Office, which should dispetch an Agent with him to O'Lonnell, Texas, in an effort to ascertain whether he contacts anyone there, and that the Dallas Office should have another Agent in O'Donnell, not to be seen by in order that his movements there can be checked to determine whether there is any truth in anything he has related. SAC Blake of the Dallas Office was furnished the substance hereof by telephone on the night of February 6, 1936. Francis left Oklahoma City, February 6, 1936 and stated that he will report at the Dallas Office on the morning of February 7, 1936.

Mr. Blake of the Dallas Office was requested to furnish the Bureau any pertinent developments in this matter.
