EDWARD GEORGE BREMER - Victim Location of Andrew Gurante not established at Miami, Florida. Bill Huntley and John Maessner have no information to indicate presence of fugitives or suspects in vicinity of Miemi this season. Willie/Heeney, alleged contact of fugitives Karpis and Campbell, located at Mismi, associating with one Louisilver, a local hoodlum. Henry/Townsend and Bob Strange, acquaintances of Campbell, Hollywood, Florida, offered no information of value concerning possible contacts of Campbell in Oklahoma. One J. F. Gates, West Palm Beach, Fla., claims to have observed Karpis in woman's attire, accompanied by William Dainard, fugitive in a similar matter, at West Palm Beach during December 1935. 
DETAILS: AT MIAMI, FLORIDA:

James E. Scurry, Manager of the Halcyon Hotel, Mismi, Florida, stated that he has no information to indicate the presence of Andrew Gurante in Mismi this season. Mr. Scurry expressed the opinion that Gurante did not visit Mismi this season, since he has failed to contact him or anyone in the Hotel; that when in Mismi he invariably stays there receives his mail there, and meets his friends at the Hotel. Mr. Scurry further stated that he has not engaged in conversation with any of Gurante known associates, who have indicated in any manner that Gurante has been observed in Mismi during the present season.

Through inquiry of Mr. Harry Smith, Secretary to the Postmaster, Miami, Florida, it was ascertained that Gurante does not receive mail through general delivery, and he has registered no local or forwarding address. In this connection reference is made to the letter of reference from the New York Office dated 2-5-36, in which it is stated that Special Agent W. J. McNulty, who had formerly interviewed Albert Gurante, brother of Andrew Gurante, at 2808 35th Street Astoria, Long Island, under pretext, on January 30, 1936, and from whom Agent McNulty ascertained that Andrew Gurante was at that time in Miami, Florida, and was receiving mail through general delivery. Mr. Smith searched the complete Post Office records and it does not appear that Gurante has received mail under his true name at any time during this season.

W. L. (Bill) Huntley, President, West Flagler Kennel Club, 1108 Congress Building, Mismi, Florida, was re-interviewed for the purpose of ascertaining whether he had observed Karpis and Campbell or any of the known suspects in this matter, as having frequented the West Flagler Kennel Club during the season. Mr. Huntley stated that he has been on the alert throughout the season in that connection, since the West Flagler Kennel Club opened on February 11, 1936, and he has at no time observed either Karpis or Campbell, or other suspects. Mr. Huntley stated that the Fest Flagler Kennel Club will remain open until April 10, 1936, that he will continue his surveillance, and in the event he should observe any one who resembles the fugitives or other suspects, he will immediately communicate with the local resident agent or the Jacksonville Office.


John W. Maessner, Ponce de Leon Hotel, Miemi, Florida, and who is also associated with Huntley in the operation of the West Flagler Kennel Club, stated that he has obtained no information to indicate that Karpis and Campbell or other suspects in this matter, have visited Miami this



In this connection reference is made to the letter from the Jacksonville Office, dated December 7, 1935, to the Boston Office, concerning a previous interview with John W. Maessner, in which it was stated that Maessner on that occasion had advised that in an interview with Special Agent in Charge C. D. McKean of the Boston Office, Maessner had understood that the Bureau was interested in the location of one "Kokomo Joe", an employee of dog race tracks. In response to the letter to the Boston Office heretofore mentioned, the Jacksonville Office was advised by letter, dated December 19, 1935, that Special Agent in Charge McKean had no recollection of the interview in question, and that the files of the Boston Office do not reflect any such interview.

When Maessner was questioned again concerning "Kokomo Joe" and the nature of the interview he is said to have had with Special Agent in Charge McKean, he replied that he was not familiar with all the details of the interview in question, but he recalls that Mr. McKean had mentioned the fact that the Bureau was interested in obtaining information concerning the location of Kokomo Joe, who Maessner was given to understand by Mr. McKean, formerly trained dogs for Big Homer Wilson, now deceased. Mr. Maessner stated that Mr. McKean gave no further indication to him as to what possible information he desired to obtain from Kokomo Joe.

Maessner further stated that Kokomo Joe was employed by the Biscayne Kennel Club, which was operated by Joe Adams, a subject under indictment in this matter, at Miemi, Florida, until the Biscayne Kennel Club closed on or about February 1, 1936. Maessner stated that it is his recollection that Kokomo Joe thereafter went to the Hollywood Kennel Club, Hollywood, Florida, but that was merely a presumption since Mr. Maessner had no definite information to indicate that Kokomo Joe was employed by the Hollywood Kennel Club.



Various attempts, have been made to interview Danny McFarland an acquaintance of Willie Harrison, deceased, but he has not been located at his residence 323 N. E. 17th Street, Mismi, Florida, on the occasions of Agent's visits. However, further attempt will be made to locate and interview Danny McFarland, for such information as he may offer concerning the possible location of other suspects in this matter.

letter Reference is here made to the/to the Jacksonville Office, from the St. Paul Office dated February 3, 1936, indicating the receipt of a Western Union Telegram or night letter by Mrs. Jack V. Davenport, 4109 Columbus Avenue, Minneapolis, Minn., which is said to have originated at Miami Beach, Florida, on January 28, 1936. Through the cooperation of J. E. Johnson, Office Manager, Western Union Telegraph Company, Miami, Florida, the records of that Company were searched from January 26, to January 29, 1936, both dates inclusive, the search including all messages filed at Miami and Miami Beach, Main and Branch Offices, but the message in question was not located. It was suggested by Mr. Johnson that the St. Paul Office determine, if possible, through officials of the Western Union at Minneapolis, the wire numbers and Branch Office initials of the sending office, together with the date appearing on the original message. and the classification of service. Upon receipt of this information a further search will be made of the records of the Western Union at Miami and Miami Beach, in an effort to locate the message in question, and obtain, if possible, the local address of the sender. Upon receipt of this information the St. Paul Office was advised accordingly by letter of reference dated Jacksonville, Florida, March 4, 1936.

In the letter to the Jacksonville Office, dated at Chicago, Illinois, 2-4-36, having reference to the above mentioned telegram, it was stated that the telegram in question, which was signed "Flo", was thought to have been sent by Mrs. William Heeney, a sister of Mrs. Blanche 2 Devenport, and that Flo leeney's husband, William Heeney is a known contact for Alvin Karpis, and it was suggested that efforts be made to determine whether William Heeney is located at Miami, and possibly in contact with Karpis.

Through inquiry of a confidential informant, whose name and address has been furnished to the Bureau by letter, it was ascertained that William Heeney, best known as Willie Heeney, was reported to be at Miami this season, however, on the occasion of the first interview with the informant, he had not seen Heeney or received any definite information

As to his possible location in Miami, however, on the occasion of this interview the informant stated that Willie Heeney originally came from St. Louis, Mo., where he was associated with gamblers and other underworld characters, particularly those who frequent race tracks. The informant stated that he first saw Willie Heeney in Chicago about ten years ago at Sportsman Park, and that since that time he has had occasion to observe Willie Heeney numerous times in and about Chicago and Cicero, Illinois. The informant stated that Heeney was connected with the Capone? Syndicate; that his name was always mentioned prominently in connection 💝 with gangster activities and particularly in gnagster killings; that Heeney has a reputation of being vicious with a gun. The informant stated that he recalls definitely that Heeney was mentioned in the McSwiggan killing in Chicago several years ago, but he was unable to recall whether Heeney had been arrested or definitely charged with murder in that connection. However, it was his opinion that Heeney has escaped conviction in Chicago in the numerous cases in which his name was mentioned.

Inasmuch as Heeney was definitely associated with the Capone Syndicate, the informant expressed the opinion that since Ralph Capone had returned to Miami, and was thought to be residing in the Capone home on Miami Beach, that it was possible that Heeney might be in contact with Ralph Capone. The informant stated that Heeney does not appear in public very often, but usually manages to associate himself with underworld characters. The informant stated that he would make further efforts to ascertain whether Heeney was in Miami, and if successful he would immediately communicate with this Agent. He further stated that he knows Heeney on sight and was positive that he would readily recognize him.

On the evening of March 2nd, 1936, Agent was advised by his informent that he had observed Willie Heeney at the Coliseum during a prize fight at Mismi on that date. Agent immediately proceeded to the Coliseum and Willie Heeney was pointed out to him. No attempt, of course, was made to contact Heeney, or to cause him to become suspicious in any manner. However, it was observed that he was in company of one Lou Silver, known in Mismi ask Jake, The Plumber*, a local hoodlum, who operates a cigar stand in connection with the Arena Bar at 732 Biscayne Blvd., Kiemi.

Later that seme evening, and at the termination of the prizefight. Low Silver, accompanied by Willie Heeney, approached Detective
Sgt. Melchen of the Miami Police Department, and to whom Low Silver is
well known, and he introduced his companion to Detective Melchen as Willie
Heeney. On the following morning this information was furnished to the
Special Agent in Charge of the Jacksonville Office, who communicated, by
telephone, with Special Agent in Charge E. J. Connelley, who advised that
no attempt should be made to contact Heeney or make any surveillance

such as might cause him to become suspicious. It may be stated that in the event a surveillance of Heeney and his activities is desired, and particularly in an effort to establish his residence location at Miami, that same may be obtained by surveillance of the activities of Lou Silver. For the information of the Bureau and interested offices, it may be stated that Lou Silver has been associated for several years with one Anna Carszewska, alias Billie Dove, alias Betty King, alias Betty Kane, a notorious madame of prostitution, who operates a bawdy house at the Marianna Hotel, 104 N. E. 7th Street, Miami, Florida. Lou Silver is reputed to be a procurer for Anna Carzsewska, and lives with her at the above address. It is possible that Willie Heeney may also reside at that address. However, no inquiry was made at this time because of the possibility that Heeney would be informed of any inquiry made at that Hotel.

Through inquiry of Harry Smith, Secretary to the Postmaster at Miami, Plorida, it was ascertained that neither Willie Heeney nor Flo Heeney, has registered a local or forwarding address and they do not receive mail through general delivery under those names.

AT HOLLYWOOD, FIORIDA:

In compliance with the leads suggested in the summary report of Special Agent D. P. Sullivan, Chicago, dated 2-17-36, Special Agent E. J. Gebben and this Agent interviewed Henry Townsend, cock fight promoter. and tavern operator, located at the Jungle Club, Hollywood, Florida. Mr. Townsend stated that he recalled fugitive Harry Campbell only by reputation: that he had heard of him particularly during the time that Townsend was Warden of the Oklahoma State Penitentiary. He denied that Campbell had been an inmate of his institution during his term of office. When questioned as to the identity and location of possible contacts in Oklahoma and elsewhere, Mr. Townsend stated that in all probably Campbell would contact one "Blackie" Thompson, one "Whitey", whose last name Townsend claimed not to recall, and one "Curly" Johnson, who were escapes from the Oklahoma State Penitentiary and according to Townsend were still at large. Townsend suggested that "Blackie" Thompson was probably now located in Texas and he further stated that Thompson, Whitey and Curly Johnson had been arrested at Mismi during the Spring of 1935, and had been taken back to Texas. Townsend further suggested the name of Sam Holmes, who, he stated was residing somewhere in Fort Lauderdale, Florida. He stated that Holmes is addicted to the use of intoxicating liquors to such extent that his

brother who operates the Holmes Brothers Grocery Company, with stores in Tulsa and McAlester, Oklahoma, and Wichita, Kansas, pays Sam Holmes to keep away from home. Mr. Townsend suggested that Sam Holmes probably knows Campbell, but he did not offer any definite information as to the possible connection between Sam Holmes and Campbell. He further stated that one Jim/Fitzsimons, a former inmate of the State Penitentiary at McAlester, who served three years for the alleged murder of one Happy Corrigan, was thought to be located at Miami Beach, although Townsend did not know the exact location of this individual, and he stated that Fitzsimons might be possessed of information concerning Campbell and his possible contacts in Oklahoma.

er bleke littlefat i til frakke fra During the course of the interview with Townsend he was questioned concerning the location of one Bob Strange, also mentioned in the summary report of Special Agent D. P. Sullivan above mentioned, and who it was suggested should be interviewed for information as to the possible contacts of Campbell in Oklahoma and elsewhere. Mr. Townsend stated that although Strange had been associated with him in the operation of the Jungle Club during the 1934-35 season, he was no longer associated with Townsend, but presently was employed at the Plantation Club located near Hollywood, Florida. Mr. Townsend suggested that Strange might offer information of value and in this connection Mr. Townsend stated that he did not know where Strange lived in Hollywood, but suggested that he could be located at the Plantation Club, any day after 2:00 o'clock in the afternoon, and that if Agents advised Strange that Townsend had suggested the interview with him that he was assured Strange would be willing to cooperate with the Bureau and offer such information as he might possess concerning Campbell and his possible contacts.

On the afternoon of March 5, 1935, Agent inquired at the Plantation Club for Bob Strange, and was advised that he was not there; that he had reported for work but because of illness had returned to his home. Attempt was made to ascertain the location of the residence of Strange in Hollywood, but Agent was advised that he lived "near the ice house". Accordingly an attempt was made to locate Strange in the vicinity of the ice house but he was unknown in that locality.

On the afternoon of March 6, 1936, accompanied by Special Agent B. J. Gebben, another visit was made to the Plantation Club, and inquiry was made for Bob Strangs. Agents were advised that Strangs had not reported for work. At this point Agents were approached by a one armed individual, one Herb Yaughn, who inquired concerning the nature of Agent's visit. Mr. Vaughn was advised that inquiry was being made to locate Bob

Strange. Mr. Vaughn stated that Strange was not at work that day, and that he did not know where Strange lived. As Agents were leaving the Plantation Club, Bob Strange came in and was pointed out by Mr. Vaughn. At the request of Agents Strange accompanied them to the Bureau automobile which was parked in front of the Plantation Club and was interviewed. On that occasion Strange offered no information of value and stated that Campbell would contact one Charlie Johnson, who owned a ranch located about ten or twelve miles southeast of Pawhuska, Oklahoma. He further stated that he last saw Campbell in Tulsa about five years ago; that he knew him only by sight and reputation and had never associated with him. When the photograph of Campbell was exhibited to Strange he claimed that it was not a likeness of the individual known as Campbell.

During the course of this interview Agents inquired of Strange concerning his residence address, and stated that it was possible further interview with him might be desired. Strange stated that he was residing upstairs over the Broward Building, Hollywood, Florida, and suggested that Agents might interview him at any time they desired either at his place in the Broward Building, or at the Plantation Club. He definitely stated that he had no objections to being interviewed at the Plantation Club.

In view of subsequent contact had with Strange by Special Agent in Charge Connelley and Agents working directly under his supervision at Miami and vicinity, further contact will not be had by the Jacksonville Office with Strange or Townsend in the absence of instructions from the Bureau or Mr. Connelley.

DETAILS: AT WEST PAIM BEACH, FLORIDA:

In accordance with the suggestions set forth in the Bureau letters of reference, interview was had with one Jesse F. Gates, 415 42nd Street, West Palm Beach, Florida, who had communicated with the Bureau on several occasions indicating that he had information of value concerning the fugitive Karpis.

Mr. Gates stated that he came to West Palm Beach on October 24, 1935; that he was formerly in the employ of the Sales Tax Unit, Bureau of Internal Revenue, but had been retired about two years because of a physical disability. In connection with this matter, Gates stated that he had read a lot about "Alvin", who hestated was Alvin Karpis, and that Gates had no idea that Karpis was in West Palm Beach until on or

about December 10, 1935, while parked in his automobile on Clematis Street, which is in the business section of West Palm Beach, he observed an individual near the vicinity of Garners' Fruit Store, who was dressed in feminine attire, and who in the opinion of Gates was identical with the fugitive Karpis. Gates stated that Karpis on this occasion had blonde curly hair, was about 5' 10" or 11" in height, had a definite woman's gait, and wore a number five shoe. He further stated that Karpis on this occasion was carrying a white basket weave pocketbook in which was contained a machine gun. After having observed this individual in passing, Cates stated that he immediately concluded that it was Karpis that the individual walked towards Flagler Park, and apparently felt that Gates had recognized him and immediately entered Woolworth's Department Store. Gates claimed that he followed the individual into the Woolworth's Store, but apparently he had escaped through a rear door. Following this observation Gates claims that he notified Detective Thompson of the West Palm Beach Police Department of his observations and Detective Thompson accompanied him to the Woolworth Store, but apparently made no further effort to trace the individual believed by Gates to be identical with

On Sunday, December 22, 1935, while parked in his automobile in the vicinity of the Florida Theatre, Gates stated that he observed William Dainard, in company of Alvin Karpis; that on that occasion Karpis was again dressed as a woman, but what appeared peculiar and convincing to Gates was the fact that Karpis although dressed as a woman was walking on the outside of the street, when she should have been on the inside. Gates stated that Dainard and Karpis apparently entered the Florida Theatre and he immediately left his automobile and inquired of the Management of the Theatre concerning the individuals but was unable to obtain any definite information in that respect. He further stated that he remained in his automobile for approximately two hours thereafter but did not observe Karpis and Dainard to come out of the Theatre, and he, therefore, concluded that they must have left the Theatre through a rear entrance, Gates stated that he again communicated with Detective Thompson and advised him of his latest observations; that Detective Thompson accompanied him to the Florida Theatre, and they also made observations in Flagler Park, which is a gathering place for visitors, and where recreation facilities are provided. However, it does not appear that Karpis and Dainard were located in the park. Some few days thereafter, Mr. Gates claims that he was parked in his automobile on Clematis Street, near the Western Union Telegraph Company, when he again saw Karpis dressed as a woman, and that on this occasion his hair had been trimmed and he looked five or six inches shorter. On this occasion he again entered the Florida Theatre. Two weeks thereafter Gates claims that he saw Karpis, about three o'clock in the afternoon, on which occasion he was dressed in a white satin dress and was wearing a white turban hat. Apparently, according to Gates, he had come across from Palm Beach on the Ferry Boat, and again, according to Gates, probably having sensed that Gates was watching him he went into Hatcher's Haberdashery on Clematis Street, and again disappeared. In this connection Gates stated he was positive that Karpis on this last occasion must have come from Bradley's Club on Palm Beach, since those who ride the Ferry Boat from Palm Beach always come from Bradley's Club. This, however, is untrue because the Ferry Boat is operated as a common carrier and not for private gain.

During the course of this interview, Mr. Gates stated that he is suffering from "hardening of the eyeballs" and that his observations are not very distinct. However, he expressed himself as positive that his observations of the individuals believed by him to be Karpis and William Dainard were correct.

Gates was unable to indicate the possible location of the individuals he had observed and in this connection stated that they must have left West Palm Beach. He further stated that West Palm Beach was filled with gangsters until recently when, in his opinion, they suddenly disappeared.

It is quite obvious that Mr. Gates is not possessed of information of value in this matter. His face has been severely burned, as a result of an accident, and probably this is the physical disability upon which he claims he was retired from Government Service. He spends his time at Flagler Park associating with the visitors who frequent that place, and appears to be somewhat mentally deranged.



THE JACKSONVILLE OFFICE at Mismi and Oklawsha, Florida, will complete investigations suggested in the letter of reference dated Chicago, Ill., 2-19-36, and the report of Special Agent John L. Madala, dated Chicago, 2-6-36.

Barry's call house, was invited by the writer to his hotel room, at
which time she was interrogated in the presence of her husband and
Special Agent B. M. Hirsh. MAR 23 1938

In was questioned relative to Edith Barry's contacts and she advised that Edith was very close to Joe Broadway, who operated the 42nd Street Cafe. She explained that she knew Joe as "Broadway" for the reason that he had married one of the Broadway daughters, however, Joe's real name is Joe Roscoe. Continuing, In stated that since she had been questioned by Special Agent in Charge B. J. Connelley (Mr. Conrad to her) she had spent considerable time thinking of Edith's operates and now recalls that when Joe would call at Edith's there was a good deal of "pussy footing" going on and it is her recollection that Joe generally appeared at Edith's house immediately prior to any visit of Karpis or Campbell to the house. In also stated that on one occasion a police officer had entered Edith's place looking for a man, and Edith and the policeman had a very wordy battle in which the police officer told Edith he was "all cop" and didn't give a heng if she was "Ring", or words to that effect, over Kayor Klotz. Edith took the police officer's manber and called Captain Fruchi of the Police Department, and

that was the last time she was bothered. In was unable to recell the police officer's name but said he was Polish, rather large, and really was "all policemen."

With reference to visits paid by Kerpis and Campbell to Edith Barry's house, In was prompted by her husband relative to the period in January, 1935, and she advised that about one month after Christmas, 1934, Karpis and Campbell were at Edith's house for a period of about three or four days and she recalled parking a Ford V8 coups which belonged to them in front of the Jarvis Apartments. In further stated that "Doc" oved her \$20.00 and owed Edith \$90.00 and Edith would continually call Ted Angus and raise hell with him because he had D.K.'d "Doc" to her, until Ted finally intimated to Edith that she was out her \$90.00 as "Doc" was on his last roundup. In stated from them on when the "Last Roundup" was played she was always kidded about her \$20 "Last Roundup."

In further stated that during the summer of 1934 an old white-haired man with a white mustache, who was known only to her as "Ded" and accompanied by a young reddish-haired man known as "will" started to call at Edith's house, and take the girls on parties at the Casino Club, where both appeared to be rather well known. In further stated that the old man was pretty wild when he became intoxicated and would take his came and knock everybody's drinks off the tables and the young man would generally end up with nothing but his trousers left on. Street, Peoria, Illinois, and likewise conducted a Road House known as the 101 Ranch at his residence during the summer.

The records of the Illinois Bell Telephone Company reflect that telephone number 4-6725 is issued to Frank Kraemer at the 101 Club in Peoria, Illinois, and that telephone number 51-J-4 is issued to this individual at his residence on Farmington Road.

Curley West, Carrier, serving 302 N. Adams Street in Peoria, Illinois, stated that James Kenny, a notorious confidence man formerly operated the Band Box at that address, and continues to receive mail there, although Ziek Lowe now operates the Band Box, and apparently has charge of the apartments above 302 N. Adams and 304 N. Adams Street. He stated that he did not deliver mail to these apartments, inasmuch as he had been requested to leave all letters for this address in the Band Box. He stated that he was certain that James Kenny, Ziek Lowe and Harry Snodgrass received their mail at this address, and he agreed to maintain a record of each person receiving mail at that address during the next month.

It should be noted that Curley West heretofore examined a large group of photographs of this mob, without making an identification.

West was subsequently interviewed, and he stated that a letter addressed to D. H. Noonan, postmarked Benton, Michigan, had been delivered to 502 N. Adams Street; that one addressed to J. P. Lee, postmarked Moberly, Missouri, and one addressed to Mrs. Hazel Wrolstad, bearing return address 945 Lucas Street, Muscatine, Iowa, had likewise been delivered to the Band Box.

The records of the Illinois Bell Telephone Company fail to reflect information with reference to a telephone in the apartments at 308 and 504
N. Adams Street; however, these records do reflect that telephone number 4-6667
is issued to James Kenny at the Band Box, located at 502 N. Adams Street, Peoria,
Illinois.

Harold Brown, at his suggestion, was contacted at the Churchill

Harold Brown, at his suggestion, was contacted at the Churchill Hotel in Canton, Illinois on March 6, 1936, and thereafter furnished the following information. He stated that Jack Summers participated in a drunken fight approximately ten days ago, and as a result thereof is now confined in a hospital in St. Louis, Missouri. He stated that these circumstances had to some extent prevented him from making the desired contact at Peoria, Illinois, and he likewise mentioned that the present political campaign required his presence in Havana, Illinois. However, after mentioning the above excuses, he related that during the latter part of February, 1936, he had an opportunity to enter into a private conversation with his cousin, Gerald Brown, after a few sociable drinks, at which time he obtained the following information:

He contended that he reminded Gerald Brown that Volney Davis had been captured by Government Agents in Chicago, Illinois, and that prior to this event he, Harold Brown, was in a position to collect a large reward in the event he furnished the information which led to the arrest of Volney Davis, and he likewise informed Gerald Brown that with his cooperation it would have been possible for him to secure this information and collect the reward. He continued to relate that at this point in the conversation Gerald Brown stated "Those agents won't pay you any money and in the long run you will be in a spot"; however, after convincing Gerald Brown that this was not the case he related that Gerald Brown stated that he was never in a position to furnish definite information with reference to the exact location of Volney Davis after he escaped from Government agents at Yorkville, Illinois.

Harold Brown advised that the conversation continued and that he mentioned as a pretext that he had indirectly heard that Alvin Karpis was dead, whereupon Gerald Brown inquired as to whether he had any information with reference to a place or lake named STICKNEY.

In this connection it should be noted that Harold Brown contended that Gerald Brown inquired either about a place named STICKNEY or a lake named STICKNEY, and in an effort to continue the conversation he questioned Gerald Brown with reference to what he had said, whereupon Gerald Brown stated "forget it." Harold Brown stated that judging from the conversation it was his opinion that Gerald Brown mentioned STICKNEY in a manner that indicated that this spot was in all probability the present hideout for the starpis.

Harold Brown further advised that he subsequently had a similar opportunity with Gerald Brown, at which time Gerald Brown brought up this subject of his own accord by inquiring "Are you still interested in that number one", whereupon he informed him that it was possible for them to split a large reward in the event they furnished information leading to the arrest of Karpis, at which time Gerald Brown informed him that he was not interested in any part of such a reward but was in a position to definitely ascertain whether Karpis was dead by driving to Wisconsin and visiting a very close contact that Karpis had in that State. Harold Brown suggested that it might be possible for him to persuade Gerald Brown to make the above trip sometime in the future, at which time arrangements could be made to tail him from Havana, Illinois to the spot in Wisconsin that Karpis is alleged to visit.

In this connection it should be noted that Harold Brown is of the opinion that his cousin would not furnish definite information with reference to Karpis, but might occasionally mention facts that would be of assistance in locating this individual, and he stated that he would renew the above conversation when the opportunity presented itself in the future. Harold Brown will be recontacted in the near future with reference to any additional information he might have secured in connection with this case.

In this connection, it should be noted that he consented to visit 516 North Adams Street and 210 Hamilton Street in Peoria, Illinois, when the opportunity presented itself, and to subsequently report what he observed or overheard at these places.

Detective Joseph Kelley, Peoria Police Department, was contacted upon numerous occasions during the period of this report, and he stated in substance that his informant

Peoria, Illinois, had visited Havana, Illinois on three occasions in an effort to determine whether Alvin Karpis is now or has in the past used that town for a hide-out and he related that this informant now advises him that he was unable to develop any information which indicated that Karpis had been visiting Havana, Illinois, and he explained his previous information in this regard by stating that James Myers in all probability furnished him unreliable information in the first place.

Detective Kelley further stated that advised that James Myers resided with his brother, Lester Myers, at 508 4th Avenue when he was in Peoria, Illinois, and could usually be located at the St. Elmo Tavern, 210 Hamilton Street, or the Band Box at 302 N. Adams Street in Peoria, Illinois, and mentioned that in the event Myers left Peoria, Illinois, he would in all probability contact Melvin Peak at his Tavern in Canton, Illinois, or Gerald Brown at his Tavern in Havana, Illinois.

It should be noted that Detective Kelley is being contacted from time to time; however, it appears that there is no indication that is in a position to furnish any reliable information with reference to this case, inasmuch as he now states that he is of the opinion that the original statements made by James Myers are false.

The records of the Illinois Bell Telephone Company reflect that telephone number 4-4275 is issued to Lester Myers at 508 4th Street, Peoria, Illinois, and an examination of the Peoria City Directory reveals that Lester Myers and Robert Anderson reside at this address with their wives.

In connection with the present investigation, it should be noted that the following automobiles bearing out of town licenses have been observed from time to time at one or more of the addresses mentioned in this report, and the information with reference to the same is being included herein for future reference.

A green 1936 Studebaker coupe, bearing 1936 Illinois license No. 279-524, was observed on February 25, 1936, at 210 Hamilton Street, 516 No. Adams Street, and 502 No. Adams Street in Peoria, Illinois. These licenses, according to the records of the Illinois State Police, were issued to Sverre Harpsted. 626 Court Street, Ottawa, Illinois.

A green 1935 Hudson Sedan, bearing 1936 Illinois license No. 669-179, was observed at 302 N. Adams Street and 516g N. Adams Street on March 10, 1936; however, the records of the Illinois State Police at Peoria, Illinois do not at the present time contain information with reference to this automobile. (ADDENDUM BY S.A.C.; The records of Illinois license tags, maintained in the office of this Bureau at St. Louis, reflect that Illinois 1936 License No. 669-129 was issued to Iola M. Reference is made to your communication dated January 5, 1936, to the effect that R. Prince Slaven, 709 South Seminary Street, Colesburg, Illinois, informed that it was possible that he had recently conversed with Alvin Karpis in Celesburg, Illinois.

In this connection, you are advised that Special Archt 8.

5. Mostetter interviewed Mr. E. Prince Slaven, and ascertained that the alleged conversation took place in the Station of the Chicago, Burlington and Quincy Railroad on the night of Depender 27, 1935, and lasted for approximately three hours. Mr. Blaves partially identified this individual as being identical with the photograph of Alvin Karpis, but was certain that the unknown individual was not more than five feet, six inches in height, and had black, curly hair.

It should be noted that kr. Paul Nolmes of Galesburg, Illinois was likewise present, and entered into the three-hour conversation with this unknown person, and upon being interviewed he furnished a description which did not correspond with that of Alvin Karpis.
A group of photographs, including one of Alvin Karpis, was exhibited
to him, and he failed to select or identify the photograph in question.

In view of the above information, a further investigation was not conducted in regard to this alleged identification.

Special Agent C. H. Carson contacted Mr. Dennis Fogarty, Chief of Dectives, Knoxville, Tennessee, and Chief Fogarty advised that the Knoxville Police Department does not have any confidence or "bunco" squad; that all of his men contact hotels, night clubs, road houses, and known and suspected bookmaking establishments in the course of their ordinary investigations. Photographs of Mead as well as the complete description of this individual including a list of aliases and also a complete description of Mead's wife, were furnished Chief Fogarty after it was ascertained that the Identification Bureau had no photograph or information concerning Mead and his wife. Chief Fogarty stated that he will have all of his detectives view this photograph and will request them to ascertain whether Mead is known at the hotels and bookmaking establishments in Knoxville, and that he will promptly advise Agents of the Nashville Bureau office in the event he obtains any information. Chief Fogarty was subsequently contacted at which time he advised that efforts on the part of his department to obtain information concerning Mead in Knoxville have been fruitless to date.

Mr. Joe Kimsey, Detective Sergeant, Knoxville Police Department; advised that he knows all of the "bookies", fight promoters, etc., in Knoxville and vicinity, and that he is making an investigation among them in an effort to obtain information concerning Mead.

Special Agent E. C. Dorris contacted Mr. Elkins Lewis, Chief of Detectives, Nashville, Tenn., and Mr. Joe Dixon, Identification Officer of the Nashville Police Department, and they advised that that department has no regular confidence or "bunco" squad; that the entire force of detectives handle investigations of this kind. They were furnished with photographs of Mead and descriptions of him and his wife, and Chief Elkins Lewis stated he would have his men check the hotels and other places frequented by confidence mem.



Williams, Identification Bureau, Memphis Police Department, who searched his records and advised that a stop order in the form of a circular bearing Mead's picture and fingerprints had been placed in his files at the request of the Chief of Police, Denver, Colorado. According to this circular Mead is wanted for bond forfeiture in Jacksonville, Fla., and a reward of \$50.00 is offered for his arrest. Sergeant Williams also edvised that his office's records indicate that Mead is a former member of the Denver Bunco Cang. Sergeant Williams advised that three members of this gang had been handled by the Kemphis Police Department on Dec. 31, 1925, as suspected confidence men, their names being Charley L. Cook, Memphis P. D. #8567, Thomas Clarke, Memphis P. D. #8568, and Charles. Edward Smith, alias Denver Smith, Memphis P. D. #8569. The records indicate that the investigation made at Memphis indicated that these men were not residents but were stopping over in one of the leading hotels. They were fined in the police court for vagrancy and since that time have not been arrested in Memphis. The records indicate that the above three individuals had been fingerprinted and photographed, and the same had been forwarded to the Bureau.

Agent Morton contacted Inspector W. T. Griffin, Detective Division, Memphis Police Department, and he advised that he was familiar with the famous "Denver Bunco Cang" and its members, but that he has no information relative to the whereabouts of Mead. He assured Agent Morton that he would order the detectives of his division to be on the lookout for Mead and to make inquiries about him. Inspector Griffin stated that he could not recall any contacts that Mead had in Memphis, Tennessee. In view of the fact that the pictures of Mead furnished by the Bureau are more up to date than those of the Memphis Police Department copies of these pictures were furnished to Inspector Griffin.



Reference is made to the letter from Special Agent in Charge E. J. Connelley dated at St. Paul, Minnesota, January 24, 1936, which calls attention to the summary report submitted by Special Agent R. Zimmer, dated at Salt Lake City, Utah, January 14, 1936, has been associated with WILLIAM ELMER MEAD and also with LEON FELIX; and further advised that upon one occasion he called upon SHAW at Salt Lake City and discussed with him various confidence men with whom they were mutually acquainted could not, at the time, recall the names of any such individuals mentioned by SHAW.

R. (BOB) DAY, who is presently confined in Atlanta Penitentiary, and he advised that he would communicate with DAY, making general inquiry regarding past associates of DAY with the possibility in mind that DAY might make some mention of LEON HOWARD or of WILLIAM EIMER MEAD.

Stated that he specifically recalls that in a conversation with DAY in Chicago a year or so ago DAY told him when he came to Los Angeles to get in touch with a KELLYNGCORMICK who was well acquainted with all the gang and that McCORMICK would help him out. In the letter written to DAY, specifically asked about McCORMICK and a reply was received from DAY in which he referred to McCORMICK as "Sergeant" and stated that he supposed he was still on the force and that he was a good fellow to get acquainted with. DAY made no mention in his letter of other individuals of interest in connection with this investigation.

Agent made inquiry of Captain HARRY A. DOYLE, who is in charge of the Bureau of Records, Los Angeles Police Department, and he advised that no one by the name of McCORMICK was presently a member of the Police Department and after checking the records, advised further that no one by the name of McCORMICK had ever been employed on the Los Angeles Police force.


Reference is made to the report of Special Agent C. V. Doherty, Buffalo, New York, dated February 6, 1936, wherein several names and addresses are set forth which were evidently secured from WILLIAM R. DAY and JOHN H. PORTER, which names are of confidence men or contacts for confidence men. It is noted that the name of ROY HUNTSMAN is listed and it is assumed that this individual is identical with RAY HUNTSMAN, mentioned above.

In connection with STANLEY ROSE, 6661 Hollywood Boulevard, Hollywood, California, who it is stated is a "fixer" and mail connection for confidence men, attention is called to the report of this Agent dated at Los Angeles, California, March 19, 1935, in connection with the case entitled JOSEPH RAPLAN alias JOSEPH WEST, Assaulting Federal Officer, Los Angeles File No. 89-1, in which is set forth an interview had with STANLEY ROSE. It will be noted that ROSE advised that a few days previous to Agent's call, Postoffice Inspector BOOTH and Police Officer W. L. ROBERTSON had arrested one ROBERT DAY, a confidence man, and that they were endeavoring to apprehend F. J. MURRAY alias FRED PITTS, an accomplice of DAY in confidence schemes. It is further reported that Detective W. L. ROBERTSON advised that DAY and MURRAY were known to have previously associated with GRAHAM and MCKAY of Reno, Nevada. Agent recalls that at that time Detective ROBERTSON advised that the STANLEY ROSE Book Shop was well known as a mailing address for hoodlums and confidence men. Several attempts have recently been made to contact Detective ROBERTSON without success. However, he will be contacted in the near future and will be interviewed regarding information in his possession as to the whereabouts of LEON FELIX as well as of WILLIAM ELIER MEAD. Thirthm Bright Bear

mentioned above, advised that he was not acquainted with STANLEY ROSS out left that he would have an entree to him by mentioning the names of LEON FELIX and BOB DAY. Accordingly, on February 17, 1936 that he STANLEY ROSE and talked with him regarding LEON FELIX. ROSE advised that he had not heard from FELIX since the latter's release from the penitentiary and was certain that he was not in Los Angeles or he would have called on him. ROSE further advised that few of the old-timers were calling at his place of business because Detective ROBERTSON had "put the heat on" since the arrest of BOB DAY. ROSE further stated that if any confidence men were in town they would undoubtedly stop at the Biltmore Hotel.

A cover was placed on all mail addressed to 66612 Hollywood Hlvd. and the mail received was so voluminous that the same was canceled after it had been in effect only a few days. Typewritten lists were furnished his office of the mail received at this address and it was not possible to determine which of said letters, if any, might be of interest in connection with this investigation.

It was ascertained through the Postoffice Sub-station, which would normally cover 3823 West 65th Street, Los Angeles, that there is no such address. Information was received to the effect that both West 65th St., and West 65th Place end in the 2000 block. It is noted that this address was set forth in the abovementioned report of Special Agent Doherty as being a place known to be frequented by confidence men. Following this address in said report was the name, "RED" FITTS



With respect to L. A. HARRY, 7850 Sunset Boulavard, mentioned in the report of Special Agent Doherty, Miss BEVERLY CASE at this address advised that she and her mother had managed this apartment for the past two years and that L. A. HARRY had not been a tenant during that period and that he was unknown to them. The recent photographs of WILLIAM ELMER MEAD were exhibited to Miss CASE and she advised that to her knowledge she had never seen this individual. The Hollywood Postoffice Sub-station did not have a removal order for this individual and Informant, advised that L. A. HARRY was unknown to him.

The address of 1825 North Cahuenga, Apartment 403, Hollywood, California, was set forth in the report of Special Agent Doherty as being a mail address for persons in the confidence racket.

Mr. R. E. DARBY, Postoffice Carrier for this address, advised that Mrs. J. A. MELTON had received mail at this address for the past two or three months, but he could supply no information regarding Mrs. MELTON or the mail delivered to her. He advised, however, that Mrs. E. R. MOORE is manager of the apartment building and in his opinion is thoroughly reliable.

Agent contacted Mrs. MOORE and she advised that Mrs. MELTON has occupied Apartment 403 for about two and one-half months; that she is an elderly woman and is supported by a son who is an employe of one of the motion picture studios. She was certain that Mrs. MELTON was respectable and reliable and that she could not possibly have questionable connections. Mrs. MOORE advised that prior to the time Mrs. MELTON moved into this apertment it was occupied by a woman and her daughter who went by the names of ADELOTTE and DRENNAN and who resided in the apartment for about six weeks, being requested to leave because they were found to be entertaining men in the apartment. Mrs. MOORE stated that these women are now living at 1921 Whitley Street, Los Angeles, California. Prior to the time these women occupied the apartment it was occupied for a period of about two years by Mrs. GEORGE AMES who is presently residing at 301 South Kenmore Ave., Los Angeles, California. Mrs. MOORE could supply very little information regarding Mrs. AMES, but stated that she appeared to be of good character while she resided in the apartment building. During the time Mrs. AMES resided there she was studying beauty culture and Mrs. MOORE doubted that she could have questionable connections. Ars. MOORE definitely stated that none of the above parties received a large amount of mail and that her suspicions were not aroused through the amount of mail received by any of them. In the absence of more definite information regarding the identity of the individual supposed to be a mailing contact for confidence men at this address, no further investigation will be conducted by this office.

Reference is made to the letter from SAC E. J. Connelley dated January 27, 1936, wherein it is requested that the Bunco Details of the principal Police Departments in this territory be contacted and their cooperation solicited in locating WILLIAM ELMER MEAD. Agent contacted Captain L. G. CANTO, Bunco Detail, Los Angeles Police Department, who advised that he was well acquainted with WILLIAM ELIER MEAD, having seen him at the time of his arrest in Denver, Colo., several years ago, and that should MEAD put in an appearance in this territory he is quite sure that it would come to his attention. Captain CANTO was furnished with copies of the three latest photographs available on MEAD and was requested to exhibit these to each of the men assigned to the Bunco Detail and request their cooperation in locating MEAD.

Special Agent E. K. Merritt attended the races at Santa Anita Racetrack, Arcadia, California, on February 15, 1936, and observed the persons attending in an effort to locate WILLIAM EMER MEAD. Three copies of the photographs
of MEAD were left with Captain G. A. KALIMAN of the Pinkerton Detective Agency
at the track and he stated that he would place the photographs on the bulletin
board of the office and request his men to be on the lookout for MEAD. He stated
that in the event MEAD was seen in attendance at the track he would immediately
advise this office. Subsequently on February 25th and 29th, 1936, Agent attended
the races at Santa Anita Racetrack and left a quantity of identification orders
on MEAD with Captain KALIMAN and also with the officials of the California Horse
Racing Board. Agent also observed the people in attendance on those days, but
was unable to observe WILLIAM ELMER MEAD as being present.

It will be noted in this commection that W. C. GRAHAM of Reno, Nevada; J. B. SCARLETT alias JACK SULLIVAN alias SCARFACE SULLIVAN, and NICK the GREEK were present at the racetrack on these days, but it was not observed that MEAD was present with them, nor that these individuals contacted the other Subjects of this case.

On February 28, 1936, Captain G. A. KALIMAN of the Pinkerton Detective Agency telephoned this office and advised that he had been informed by Mr. R. E. CHAPML, Inspector, California Horse Racing Board, that on the previous evening he had exhibited the identification order on WILLIAM ELMER MEAD to Mr. C. T. DIFFENBACK, salesman for Ahrens Motor Company, 285 West Colorado Boulevard, Pasadena, California, and that DIFFENBACK had stated that an individual closely resembling MEAD had called at the salesmoom of the above company a few days previously.

Special Agent J. S. Bugas interviewed Mr. DIFFENBACK who resides at 4467 Sunnycrest Drive, Los Angeles, California, telephone Albany 5833, who stated that a few days previously a man came in to the showroom, walked around and looked at cars and asked the price of one car. When he was approached by Mr. DIFFENBACK he stated that he was merely shopping to kill time. According to Mr. DIFFENBACK this individual was in the showroom approximately ten minutes and DIFFENBACK noticed that the right side of his face was noticeably affected and partially paralyzed and that this side of the mouth was longer than the left side and barely moved when the individual was talking. This individual had a very dark mustache with a few grey hairs, were horn-rimmed glasses, a dark hat, dark overcoat and

was neatly dressed. DIFFENBACK stated that this man was about sixty years of age and was slightly taller than DIFFENBACK, who is 5'8" in height. Mr. DIFFENBACK did not give a sales talk to this man and secured no information whatever regarding him. An identification order was left with all employes and this office will be notified in the event this individual returns to the Ahrens Motor Company.

has been questioned in detail regarding all Informant possible, contacts of WILLIAM EIMER MEAD and he has stated that he recalls hearing JOHN GRADY, whom he knew in Chicago, Illinois, talk about MEAD who was referred to as the Ochrist Kid. stated that the latest conversation with could give no in-GRADY about MEAD was in Chicago, Illinois, in 1933. formation regarding the present whereabouts of GRADY, our stated that he is well known to Captain ALCOCK, Chicago Police Department, and that GRADY was arrested in May of 1934 or June, 1934, at Chicago, Illinois, for defrauding some woman employed in the Courthouse in that city of about \$6,000. He further stated that GRADY has in the past resided at the Secor Hotel, Toledo, Ohio, which hotel was also the residence of SAM HESLER who is reputed to be the payoff boss in described GRADY as being about 36 years of age; 5'll" in height; 165 lbs. in weight and as having brown hair and brown eyes. He also stated that BILL CAFFNEY is a personal friend of CRADY and has also operated with him in conwas arrested in 1933 or 1934 at fidence rackets. GAFFNEY, according to Minneapolis, Minnesota, for attempting to derraud a woman who operated a millinery store at Mankato, Minnesota. He described CAFFNEY as being about 47 years of age; 6! in height, 150 lbs., in weight, with black hair, of skinny build and as being a depe fiend. He also stated that a disbarred attorney by the name of 1. GINS-BERG was in this deal at Mankato, Minn., with GAFFNEY, but that he was never arrested in connection with the crime. According to GINSBERG was disbarred about 1929 at Minneapolis, Minn. He described GINSBERG as being 35 years of age; 5'52" in height; 160 lbs., in weight and having brown hair and eyes. **有关的人员的是不是我们的人员的人**

With respect to noted hangouts for confidence men, stated that these men invariably followed the racetracks and that when the racing season was open at West Palm Beach, Florida, they would undoubtedly hangout at the Florentine Club. When the racing season is open at Savannah, Georgia, the Whitney Hotel is usually the hangout for confidence men. The Breakers Hotel in Daytona Beach, Flausually the hangout for confidence men. In connection with the latter is also reputed to be patronized by confidence men. In connection with the latter place, stated that he believes a Mrs. HARRISON is manager and that she offers protection for hoodlums and racketers patronizing the hotel. Stated that Tampa, Florida, was a likely spot for confidence men and that they received protection in that city through Chief of Police BUSH. Stated that in 1933 he was at the Prince of Wales Hotel in Montreal, Canada, and that at that time, which was during the Summer racing season, there were approximately 125 con dence men either stopping at the hotel or using it as a headquarters.

Attention is called to the report of Special Agent S. W. Hardy St. Paul, Minn., dated December 20, 1935, wherein attention is called to the telephone number Gladstone 6944 and the name HOWE, which were found in a notebook of C. J. FITZGERALD who is being kept under surveillance by this office. This report points out that WILLIE HARRISON used the name of HOWE and that (2004) this telephone number may have some connection with HARRISON. It was ascertained through the Southern California Telephone Company that this number, Gladstone 6944, was listed on June 6, 1934, to LORRAINE WELCH, 7732 Norton Avenue, Los Angeles, California, and that it was presently listed in her name. MR. SWARTZBARTH, Postal Carrier, Hollywood Sub-Station, advised that he had delivered mail at the above address for the past two years during which time a family by the name of WALCH had resided there. He stated that they appeared to be quiet, had few visitors and received very little mail. He stated that he had seen Mr. WELCH leave the premises on several occasions, dressed in a service station attendent's clothes, but he could furnish no information regarding the place of employment of Mr. WELCH. He stated that he believed all of the neighbors were reliable, but could supply no definite information regarding them.

Agent observed this address for a period of about two hours and during that period noted a woman drive to the house in a 1935 Ford Roadster, bearing 1936 California license No. 1-M-4548. It was ascertained through the Division of Motor Vehicles that this license is registered to LORRAINE WELCH for a 1935 Ford V-8 Roadster. Motor No. 18126625. The records of failed to reflect any information or record on LORRAINE WELCH. In view of the fact that C. J. FT ZCERALD is presently under surveillance by this

In view of the fact that C. J. FT ZGERALD is presently under surveillance by this office, it was not deemed advisable to make any open inquiry regarding LORRAINE WELCH or to personally interview her. After FITZGERALD has been placed under arrest this woman will be openly interviewed.

Reference is made to the leads set out for this office in the report of Special Agent A. R. GERE, Denver, Colorado, dated February 2, 1936, to ascertain from Miss HELEN MUHRER, 3870 West Sixth Street, if she deposited a letter in the mail box at Sixth and Serrano Streets, Los Angeles, California, on secondar 28, 1935, addressed to R. C. RAYBURN, 1216 West Pike's Peak Avenue, Colorado Springs, Colorado. Miss HELEN MUHRER advised that she recalls writing to her sister, Mrs. RALPH C. RAYBURN at Colorado Springs, Colorado, shortly after Christmas, 1933, but could not recall the exact date the letter was mailed. She did recall, however, that she personally deposited the letter in the mail box located at Sixth and Serrano Streets, which is about half a block from her place of employment. Miss MUHRER believed that the letter was addressed to Mrs. R. C. RAYBURN but stated that she might possibly have addressed it to Mrs. R. C. RAYBURN inasmuch as her letters toher sister and brother-in-law are usually intended for both of them.

The following investigation was conducted by Special Agent E. K. Merritt on February 14, 1936, at Pismo Beach, California;

"Based on information contained in the report of Special Agent
J. A. Cimperman, San Francisco, California, dated September 3, 1935, stating
that a Mr. HOWARD COLWELL, operator of a beer parlor at Eureka, California,
and a HAROLD McBETH, operator of a General Notions Store in that city, believed
that they had seen a person who resembled Subject KARPIS in Eureka during August of 1935 and that Officer ARCHIE KIRKPATRICK of the Eureka Police Department had been told by a brother officer that he had information to the effect
that KARPIS had been in town, and further information set out in the report of
Special Agent L. K. COOK, San Francisco, California, dated October 25, 1935,
concerning a banquet for KARPIS which was supposed to have been given at the Tom
Tim Club at Eureka in May of 1935, which affair was supposed to have been attended by a number of persons including a JOHN HUHLEY and his woman named JERRY CALDNER who were believed to be from Pismo Beach, California, Agent conducted the
following investigation:

"Chief of Police W. B. HOLLINGSHEAD, Santa Meria, California, which is a small town near Pismo Beach, was contacted and informed that Pismo Beach was policed by the Sheriff's Office at San Luis Obispo and that the officer stationed at Pismo Beach was RICHARD ELLIS. Deputy Sheriff. He stated that ELLIS was very reliable, had shot it out with criminals on many occasions and was well informed as to who was in or about the town of Pismo Beach. Chief HOLLINGSHEAD stated that he intended to attend a boxing show at Pismo Beach that night and invited Agent to accompany him. Agent took advantage of this invitation and attended the above boxing show which was staged at the Pismo Beach Arena, which had a capacity of approximately one thousand persons. There were about four hundred persons present on the occasion, all of whom were observed by Agent during the evening, but none appeared to resemble the Subjects of this case.

"Following the boxing show, Deputy Sheriff ELLIS was contacted and informed that he had never heard of a JOHN HURLEY or MERRY CARDNER and doubted that they resided in the town. In connection with the Subjects of this case, ELLIS stated that as a result of rumors which were in circulation during the past Summer he had been on the alert for any information that Subjects might be in town and had kept a sharp lookout for persons who might resemble them, but that nothing of value had developed. ELLIS stated that he would dontinue to be on the alert for information regarding Subjects and that in the event he obtained anything of value he would immediately communicate with the Los Angeles office.

"Chief Hollingshead accompanied by Agent visited several local barrooms in the town immediately following the Fights and made discreet inquiries
as to the presence of a JOHN HURLEY or JERRY GARINER in the town but they were
unknown to the individuals contacted."

Reference is made to the report of Special Agent J. T. McLaughlin, Salt Lake City, Utah, dated February 18, 1936, wherein it is reported that WILLIAN GRAHAM, JAMES McKAY and J. B. SCARLETT alias JACK SULLIVAN alias SCAR-FACE SULLIVAN and Chief HOLNES were presently in Los Angeles, California, attendwas furnished ing the races at Santa Anita Racetrack. Informant with this information and was requested to secure all information possible regarding the activities of these individuals in Los Angeles and to verify the fact that they were attending the races at Santa Anita. contacted FRANKIE HARRIS, a bookmaker at the Cecil Hotel, whom he knew to be acquainted with leading racketeers of Reno, Nevada, and HARRIS advised him that McKAY was not here. but that GRAHAM was here and was attending the races with an individual known as "Sacramento Butch". HARRIS stated that he was not acquainted with ."Scarface" Sullivan, but advised that to the best of his knowledge GRAHAM was stopping at the Biltmore Hotel.

On February 21, 1936 attended the races at Santa Anita and contacted GRAHAM whom he had previously met at Reno, Nevada, through MOE BARNETT. talked with GRAHAM regarding various underworld characters with whom they were mutually acquainted and finally mentioned the names of KARPIS and CAMPBEIL. GRAHAM advised that he had heard nothing from these men for the past year, but that he believed they were operating in and around Kansas City, Missouri. attended the races on four different occasions and did not notice that Grantal was contacting anyone of interest in connection with instant investigadvised that in 1934 he talked with TRISCO DUTCH who had recently returned from Reno, Nevada, and this individual, advised that KARPIS had been in Reno in the company of PATTY HOGAN and CLARENCE WILLARD. PATTY HOGAN is well known in Kensas City, Missouri, and that he is a good contact for Subject KARPIS. According to HOGAN has also used the name of BURLESON and has a brother, whose name is unknown, confined in the penitentiary at Jefferson City, Missouri, on a charge of murder, having killed a policeman.

was able to get an introduction to Chief HOLMES through FRANKIE HARRIS, mentioned above, and in conversation with him, as well as with GRAHAM, he received the impression that HOLMES and GRAHAM were on the "outs" then discussed various underworld characters with HOLMES and upon mentioning the names of KARPIS and CAMPBELL, HOLMES stated that he hoped they staved a long way from him inasmuch as they were "too hot". On February 25 and 29, 1936, Agent attended the races at Sinta Anita Racetrack and through the cooperation of Captain G. A. KALINAN, Pinkerton Detective Agency, was able to locate WILLIAM GRAHAM. Captain KALINAN advised that GRAHAM had been at the track for about two weeks and that he had been in the company of NICK the GREEK and SCARFACE SULLIVAN. According to Captain KALINAN, NICK the GREEK is well known in New York in connection with the Rothstein murder. Agent kept these parties under surveillance during the entire time the races were in progress on these dates and failed to notice that they contacted any parties of interest in connection with this investigation. They were followed at the conclusion of the races to their automobile and it was noticed that they entered a 1936 Buick Sedan, carrying 1935 Michigan license G-62835. The automobile was driven by a man described as follows:

About 30 years; 5'll"; 240 lbs., light brown hair; very ruddy complexion; Jewish in appearance.

The identity of this individual is unknown, but it is possible that he is R. T. ZELLAR referred to in the reference report of Special Agent J. T. McLaughlin who is reported to be a member of the Purple Gang of Detroit, Michigan.

KANSAS CITY OFFICE, at Kansas City, Missouri, all determine the identity of the individual who corresponded with J. R. HUNTSMAN, 587 North Vermont Avenue, Los Angeles, California, giving the return address of 321 North Cardesty Street, Kansas City, Missouri. It will be kept in mind in connection with this lead that Mr. and Mrs. RAY FUNTSMAN are friends of LEON FELIX alias LEON HOWARD, who is a likely associate and contact for WILLIAM ELMER MEAD.

Will also endeavor to secure information regarding PATTY HOGAN and CLARENCE DULLARD, who are referred to on Page 11 of this report, to determine if they are in contact with Subjects KARPIS and CAMPBELL.

CHICAGO OFFICE at Chicago, Illinois, will contact Captain ALCOCK to secure information regarding JOHN GRADY who was reputed to be a contact and former associate of WILLIAM ELMER MEAD.

CLEVELAND OFFICE at Toledo, Ohio, will endeavor to establish informants in and around the Secor Hotel to determine if WILLIAM ELMER MEAD is patronizing that place.

Will also endeavor to secure information regarding SAM HESLER in order that it might be determined whether he is in contact with WILLIAM ELMER MEAD.

ST. PAUL OFFICE at Minneapolis and Mankato, Minnesota, will endeavor to ascertain the present whereabouts of BILL CAFFNEY and A. GINSBERG, in order that they might be interviewed regarding WILLIAM ELMER MEAD.

JACKSONVILLE OFFICE at West Palm Beach, Florida, will endeavor to develop Informants in order that that office might be informed in the event EM. ELMER MEAD patronizes the Florentine Club during the racing seasons.

At Daytona Beach, Florida, will endeavor to make the same arrangement with respect to the Breakers Hotel.

ATLANTA OFFICE at Savannah, Ga., will endeavor to develop informants at the Whitney Hotel in order that that office will be informed in the event WILLIAM ELMER MEAD patronizes that hotel.

BUFFALO OFFICE at Montreal, Canada, will conduct appropriate investigation with respect to the Prince of Wales Rotel, which is reputed to be a hangout for confidence men and will endeavor to secure appropriate informants in
order that information will be received in the event WILLIAM ELMER MEAD calls at
that hotel.

SAN FRANCISCO OFFICE will supply police officers and racetrack officials at Tanforan Racetrack with identification orders on WILLIAM ELMER MEAD, as well as Subjects KARPIS and CAMPBELL. When investigations are conducted at this track it should be kept in mind that W. C. GRAHAM, SCARFACE SULLIVAN, NICK the GREEK and CHIEF HOLMES will probably be at the track and arrangements should be made for the San Francisco office to be advised in the event contact is made by these individuals with WILLIAM ELMER MEAD or the other Subjects of this file.

MEMORANDUM FOR THE DIRECTOR

Re: ALVIN KARPIS, with aliases, Fugitive, I.O. #1218, et al; Edward George Bremer, Victim -Kidnaping.

With reference to the investigation being conducted at Miami-Beach, Florida, and other points in the State of Florida, information has been received from Mr. Connelley to the effect that nothing has been learned in the case that either Karpis or Campbell have been in Miami or vicinity this season. Carter's at Miami Beach has been closed for the season and the indications are that the balance of the gambling joints will be closed.

Mr. Connelley has also advised that the lead at St. Petersburg, Florida, will bring no results, and in accordance with developments, the Agents who have been concentrated in Florida have been instructed to return to their respective headquarters. Mr. Connelley will proceed to either Cleveland or Cincinnati, Ohio, where he will direct investigations being conducted.

With reference to the information furnished by Attorney William Brandenburg, of Little Rock, Arkansas, advising that Richard Tallman AGalatas was ready to furnish information regarding the location of William E. Meade in return for leniency of some kind, an interview with Galatas resulted in the definite conclusion that he will be of no assistance to the Bureau and that any negotiations on the part of the Bureau for the purpose of postponing his serving of the penitentiary sentence which will begin March 27, 1936, will not be entertained.

Charles Fitzgerald, who has been in a hospital at Glendale, California, has returned to his apartment and has paid rent for an additional month.

agent also contacted Mr. C'Farrell, manager of Becks Hot Springs, about five miles north of Salt Lake City on the road to Ogden, who advised his institution furnished no treatment in connection with baths afforded. Hr. C'Farrell assured his cooperation in an endeavor to locate Campbell and was furnished with Identification Order for such individual:

In donnection with investigation being made to locate louis Royal in the Weynap case, who was reported to have Seen Dainard, Royal was located at his residence, 327 West North Temple, Salt Lake City, and came to the Salt Lake City Bureau office on the morning of March 17, at which time he advised that while he was at the intersection of South Temple and 2nd West streets loitering, he noticed a man parked on 2nd West near the intersection headed north. This man was driving a dark green colored roadster, with the top down, and Royal was not certain of the make but believes the same may have been a Plymouth. He advised he is positive the car carried an Oklahoma license; however, he did not make any notation of the same. According to Royal he had a couple of small children with him playing and remained with the children five or ten minutes, during which time he was in close proximity to the car that was parked. After being there about ten minutes the lone occupant of the car, a man, called to him and asked the road to Pocatello, and he stated he informed the driver that he should proceed north on the street he was on. According to Royal, the man appeared to be writing a postal card and as he approached to within about six feet of the car the man asked where he might buy some stamps and Royal advised he suggested that he stop at a drug store further down on Second West on the way to Ogden, and probably he could secure some: ...

from his position of about six feet from the car, Royal advised he could see into the same, and noticed a peculiar looking gun lying across the lap of the driver, with the barrel pointing to the left door. Royal described this gun as being about three feet in length and having a stock on the same. He also stated it had what appeared to be the drum resembling a film container; he advised this drum was crosswise to the barrel of the gun and described it as being about an inch and a half in thickness and about seven or eight inches in diameter. He stated he had never seen this type of gun before and did not know what it was, but suspected it was some type of high powered automatic. Royal stated he had ample opportunity to note the features of the driver of this car and stated he had a very good memory for faces. He was unable to furnish a description of the man, inasmuch as he did not get out of the car and was wearing a heavy overgoat, but he stated he was light complexioned. Other than the inquiries as to road directions and the purchase of stamps, the driver made no other statements to Royal and he advised he had not reported the incident to any law enforcement officer. Royal was shown several photographs of various individuals wanted by the Bureau, including photographs of Dainard and two photographs of Alvin Karpis, one of them being a full length photograph and the other a prison photograph of Karpis bearing No. 8008. From the photographs shown Royal, he discarded all but the two photographs of Karpis and stated without hesitation that they very definitely resembled the man he saw in the automobile.

On receipt of the above information from Royal, conference teletype was immediately sent to the Bureau and Cincinnati, Bufte, Chicago and St. Paul offices, advising them of the information furnished by Louis Royal,

AT EVANSVILLE, INDIANA

On March 13, 1936, while at the Evansville Police Department, Detective Sergeant Sherman Hamsley informed Agent that on March 5, 1936 a letter was received by that department from the Indianapolis Bureau Office, stating that efforts are being made by the FBI to effect the apprehension of William Elmer Mead, with aliases, and enclosing a full length photograph of Mead. Detective Sergeant Hamsley stated that the Evansville police immediately began a search of the city of Evansville to see if Mead was there. He said that contacts were made at leading hotels, and that it was reported from reliable sources that Mead had been at Evansville, Indiana, a few days prior to the investigation made by them. Hamsley said that Mead had been reported as visiting the McCurdy Hotel at Evansville and had attempted to sell the manager and others in the hotel some pearls, face powder, and subscriptions to magazines. Hamsley said that he thought that a report of these findings had not been made to the Indianapolis Bureau Office as yet. Based upon this information, Agent made the following investigation:

Mr. Earl Knouf, assistant manager of the McCurdy Hotel, Evansville, Indiana, upon viewing the photograph of Mead, informed Agent that he
was positive that it was the photograph of a man who had contacted him at
the McCurdy Hotel on or about March 6, 1936 and had attempted to sell him
some pearls, powder, perfume, and magazines. Mr. Knouf did not remember the
name of this man but said that the latter represented the Crowell Publishing
Company, Springfield, Chio. Mr. Knouf said that this man talked with him for
possibly twenty minutes; that during that time he noticed that there was
something wrong with the speech of this man and that his words were "sort of
cut short" as if there was an impediment in his speech. This suspect is described by Mr. Knouf as follows:

Mr. Knouf stated that he did not buy anything from the suspect; that he did not see the suspect's credentials and does not know under what name this man operated. Mr. Knouf was furnished with Agent's telephone number and was requested to immediately contact Agent, should he again see this suspect, or to call the Evansville Police Department.

Frank Shumater, Doorman, McCurdy Hotel, Evansville, Indiana, immediately recognized the photograph of Mead as that of a man who visited the McCurdy Hotel during the first week in March 1936. He stated that this

man came to him and wanted to sell him face powder, perfume, pearls, and subscriptions to two magazines. He said that suspect showed him credentials from the Crowell Publishing Company, Springfield, Ohio, but he does not remember what name was on the credentials. Mr. Shumater stated that he is positive that suspect is identical with the man in the photograph of Mead. He gave the same description of this individual as Mr. Knouf. Shumater stated that suspect was selling Collier's Magazine and the Forum Magazine.

Clayton Start and Emit Bullock, bellboys, McCurdy Hotel, Evansville, Indiana, informed Agent that they were positive that the person who was in that hotel recently selling powder, perfume, and pearls was identical with Mead. Neither of them knew whether or not suspect sold any of his wares at that place. They stated that they would immediately contact Agent at the Vendome Hotel, Evansville, Indiana, should anything be learned in regard to suspect.

Taylor Comway, License Department, City Hall, Evansville, Indiana, informed Agent that on or about March 10, 1936 the suspect entered his department and said he was a peddler of toilet articles and wanted to know the amount of license fee for that city. Mr. Comway told him that the fee was \$125.00, whereupon suspect made some remark to the effect that the city of Evansville did not want a man to make a living. Mr. Comway is positive that suspect is identical with Mead, judging from the photograph of the latter. He further stated that suspect stated that he represents an Atlanta, Georgia, firm. Comway said that suspect did not obtain a license, and he did not learn the name under which suspect was operating. The description of suspect given by Comway is the same as that given by Mr. Knouf.

Elmer Bosse, manager of the New Acme Hotel, Evansville, Indiana, was contacted by Agent, and he tentatively identified the suspect as Mead. He stated that suspect had checked out of the New Acme Hotel about one hour before Agent's visit. Mr. Bosse described the suspect exactly the same as did the other persons interviewed and stated, in regard to suspect's speech, that he did not lisp but would "jerk his words out of his mouth the same way as if a person were holding his tongue and lip stiff." Mr. Bosse said that suspect punched his punchboard several times and laughed oddly each time he punched.

Mrs. C. W. Veitch, clerk at the New Acme Hotel, informed Agent that she is sure that Mead was one of two men who stayed at that hotel on the night of March 12, 1936 and checked out about one hour before Agent arrived. Mrs. Veitch gave Agent the name of J. Nimblack as that given by the suspect. She stated that suspect did not sign the register, but that his companion registered for both of them. Mrs. Veitch gave a description of suspect similar to that given by the other persons interviewed in regard to this matter.

Agent went to Room No. 7 in the Acme Hotel with Mr. Bosse to see if suspect had; left anything of value in determining his identity when he departed from the room. The room had been cleaned up and the waste basket emptied before Agent's arrival. Agent and Mr. Bosse questioned the maid who cleaned the room, and she said that the bed had not been slept in that night, and that there was no waste paper in the room, nor did she have to clean the room except for the usual dusting. The main stated that she did not see the men who occupied Room No. 7. Agent inspected the room and attempted to locate latent fingerprints, but none were found. No scraps of paper or clothing were found in the bureau drawers.

Upon returning to the lobby of the New Acme Hotel, Agent was informed by Mrs. Veitch that she thought that the suspect had been writing at the desk. Agent obtained from the wastebasket by the writing desk a piece of paper which may have been used by the suspect. On that paper, which was the stationery of the hotel, was written in pencil, "Carl L. Thornhill", some scribbling, and several roughly drawn pictures of a cow and a man. This piece of paper was handled by Agent. It is being forwarded to the Technical Laboratory under cellophane cover for comparison of the handwriting thereon with the known handwriting of Mead and for fingerprint processing to learn if any latent fingerprint impressions found thereon are those of Mead.

Agent searched the telephone book and city directory of Evansville, Indiana, for the name, Carl L. Thornhill, without results.

Frank Wilson, colored bellboy, New Acme Hotel, Evansville, Indiana, informed Agent that he packed the baggage of the men mentioned above as staying in Room No. 7, but he could not state positively that either was the same man as in the photograph of Mead. He said that these men had one suitcase and a brief case. He removed the bags from their room and left them in the lobby, as they had said that they would come by later and pick them up in their car. Frank Wilson did not know what kind of car they were driving but thought it was a Ford V-8. He further stated that there was another bellboy by the name of Frank who would work on Saturday night at 7:00 P. M., and that the latter individual should know more about these men, as he was on duty when they arrived.

Agent immediately made known the above information to the Indianapolis Bureau Office by telegraph and requested that inquiry be made of the Crowell Publishing Company, Springfield, Ohio, to see if Head is one of their representatives and if J. Nimblack is a representative of the company.

Agent contacted each hotel in Evansville, displayed the photograph of Mead, and requested that if suspect was seen that Agent be notified by telephone or that the Evansville Police Department be notified that this man was wanted by the Federal Bureau of Investigation. The results of this investigation are as follows:

At the Imperial Hotel, Evansville, Indiana, Mr. D. C. Maicolm identified the photograph of Mead as that of the man who visited the Imperial Hotel about March 1, 1936, selling pearls and magazines.

At the Brown Hotel, Evansville, Indiana, a Mrs. Brown stated to Agent that she is sure that Mead is the man that stayed at her hotel about a year ago. She stated that he represented a firm in Georgia and was selling pins and novelties.

Agent contacted the Evansville Police Department and advised them that various persons at Evansville, Indiana, had been contacted by Agent and had been requested, in the event suspect should come to their notice, to notify the police department and inform them that suspect was wanted by the Federal Bureau of Investigation. The police department agreed to respond to such a call and stated that the man would be placed in jail without booking him, so that the press would not be advised of his arrest.

On the night of March 14, 1936 Agent proceeded to the New Acme Hotel in response to a telephone call, and was informed by Mr. Bosse, manager, that he had learned that suspect and his companion had first engaged Room No. 7 on the occasion of their visit to that hotel, but that later that night they had moved to Room No. 33. Mr. Bosse said that the men registered as Fer. I. Ahman and Charles Levi, the former being suspect. Agent and Mr. Bosse inspected Room No. 33, which was occupied at that time, but found nothing of significance. The colored maid who cleaned the room said that there was nothing in the waste basket except some apple peelings.

Frank Hosendove, bellboy, who showed the suspect and his companion to Room No. 7 and later to Room No. 33, said that he thought the picture of Mead resembled the older of the two men. He gave the following descriptions of the two men who occupied Room No. 7 and later Room No. 33 on Thursday night, March 12, 1936:

Frank Hosendove said that he distinctly remembered the men, for they had a 1932 Ford V-8 four-door Sedan which was loaded with suit cases and packages,

and hat.

indicating that they were salesmen. The men wanted him to carry all of the suitcases and bags up to their room, but Hosendove told them that they could lock their car in a garage and take out whatever bags they needed, which they did. The car was dark blue or black and was very muddy. Frank Hosendove stated that he did not notice the license plates on the car.

Agent contacted the various business houses about the place where suspect had been seen, with the result that Elmer Foltz, of the Foltz Service Station, Evansville, Indiana, informed Agent that on March 13, 1936 a man whom he believed to be suspect visited his place of business and attempted to sell him some business cards. Foltz stated that he did not learn this man's name or the company which he represented, but he is positive that this man is identical with Mead, judging from the photograph of the latter. Mr. Foltz described the suspect exactly the same as the other persons interviewed, even to his dress. Mr. Foltz was furnished with Agent's telephone number with the request that he contact Agent should this man be seen by him again, or if Agent could not be located, he should call the Evansville Police Department and inform them that the man is wanted by the Federal Bureau of Investigation.

Henry M. Meyer, Postmaster, Evansville, Indiana, informed Agent that he had no mail for Fer. I. Ahman, Charles Levi, or for William E. Mead or aliases. Agent requested that Mr. Meyers make a note of these names and in the event anyone inquires for mail at the General Delivery window under these names, to refer to Identification Order 1354 to ascertain if that person is Mead. Mr. Meyers agreed to do this and, in the event Mead appears, to take steps to effect his apprehension.

Agent telephonically contacted all printing establishments in Evansville, Indiana, to inquire if they had a salesman filling the description of Mead, but only negative information was obtained from this inquiry.

On March 17, 1936 information was received from Special Agent in Charge J. A. Dowd, of the Indianapolis Bureau Office, to the effect that L. B. Emrick, 311 Herndon Drive, Evansville, Indiana, is the local representative of the Collier Publishing Company, and that contact should be made with him for information concerning Mead and suspect.

L. B. Emrick, 311 Herndon Drive, Evansville, Indiana, informed Agent that he is the representative of the Collier Publishing Company at Evansville, Indiana; that whenever salesmen come into his territory and make sales, they must contact him to have the sale verified. Mr. Emrick viewed the photograph of Mead and said that he is positive that Mead has not contacted him. He further stated that he does not know of any salesman for the Collier Publishing Company by the name of J. Nimblack, Fer. I. Ahman, William E. Mead, or any of the latter's aliases. Mr. Emrick stated that it was possible that a salesman could be in his territory and not have contacted him, but that in that case the salesman could not have sold any subscriptions.

Mr. Emrick informed Agent that, if Mead should appear at his office, he would immediately contact the Indianapolis Bureau Office and furnish all information in his possession.

Police departments in all major cities in Indiana having "Bunco Squads" have been contacted by Agents of the Indianapolis Bureau Office and asked to be on the lookout for Mead.

Agent of his cooperation in this matter, and further stated that he would not reveal any information he might secure to any of the local officers, expressing the belief that they were incompetent, advising that he would contact the Denver Office directly. Welch, upon being questioned by Agent as to the reliability of Dan Tubbs, advised that Tubbs would not cooperate with the Bureau in this matter, and advised Agent against again contacting him. He stated that while Tubbs was himself legitimate, he had been mixed up with the old bootleg ring, and therefore would keep his mouth shut. Agent brought up the Subject of securing some one who was close to Tubbs and who would cooperate with the Bureau in an endeavor to secure information from Tubbs, and also check Tubbs' activities and be in a position to know whether or not any contacts were made by Campbell with him. Welch advised that Tubbs was very close-mouthed, that most of his associates could not be trusted and was unable at this time to name such a party. However, he advised he would keep this thought in mind and requested Agent to contact him in the future relative to this matter.

George Stine, C.B.&Q.R.R. Special Agent, who resides at 436 West 12th Street, was contacted by Agent. Stine is well acquainted with Henry Goad, whose wife and mother-in-law were neighbors of Campbell in Oklahoma, and Stine is in a position to secure any information from Henry Goad that the latter might possess, Stine advising that he had "something on" Goad. Stine stated that although he had contacted Goad frequently, Goad was unable to offer him any information and stated that he would continue his contacts with Goad.

Agent contacted Mr. and Mrs. Henry Goad, 137 North Beech Street, but they stated that they had not heard anything concerning Campbell, and assured Agent of their cooperation in this matter. Both advised that they would communicate directly with the Denver Office should they hear of any information of value rather than with the local officers.

Agent contacted Officer J. P. Jonen of the Casper Police Department, who a few years ago had been quite active in instant case at Casper, but Jonen possessed no information. However, he stated that at the time Campbell was in Casper last, one Earl Colley, who is employed at the Gent Hardware and Supply Company, North Center Street, had contacted him with the information that Campbell was in town.

Agent contacted Earl Colley, who advised that his wife and her parents had lived in the same vicinity with Campbell when the latter resided in Casper; that he and his wife had seen Campbell when he visited Casper last at the Riverside Inn north of Casper, and that he had immediately contacted Officer Jonen and advised him of the fact. He further stated that he would not give any further information to the

local police in this matter as his name had been mentioned in the above case as a result of the above information, and he stated that he would communicate directly with the Denver Office in the future should he learn of anything. The Denver Office telephone number was given to Colley.

Agent also contacted Mrs. Shirley Vroman, 1131 East C Street, sister of Mildred Campbell, Subject Campbell's first wife. Mrs. Vroman's residence is situated on the highway from Evansville to Casper, which is the main highway to the east from Casper. She advised that the last time Campbell was in town he had visited her husband in her absence at their former residence, which is directly across the street from her present home. She advised that her sister had not secured or tried to secure a divorce from Campbell and that her sister would have nothing to do with him, her feelings toward him being anthing but sympathetic. She stated that Eula Bee, Campbell's daughter, a picture of whom was shown Agent, was living with her sister and that Eula Bee had spent Christmas with Campbell's parents and that it was planned to have her sister, Eula Bee and her mother come to Casper to spend the summer of '36 there. Mrs. Vroman stated that Campbell had been very friendly to her husband and her sister, Helen Fuller, who is now residing at 218 West 18 Street, Cheyenne, Wyoming, but stated that as a result of Campbell's depredations, they would not attempt to shield him, believing that their cooperation could be secured. Mrs. Vroman believed that should Campbell attempt to contact his old friends around Casper that they would turn the information over to the law, but expressed the belief that Oscar Felt and Den Tubbs would not do so. She advised against Agent contacting Dan Tubbs or relying on his cooperation in this matter. Mrs. Vroman assured Agent of her. cooperation and the telephone of the Denver Office was furnished her. She requested Agent to contact her husband in the future, he being absent and in Sheridan, Wyoming, at the time of Agent's visit.

Mrs. Daniel Sullivan, the Postmistress at Evensville, Wyoming, was contacted by Agent. Mrs. Sullivan is strictly reliable and is a close personal friend of Post Office Inspector in Charge C. T. Hansen of Denver, Colorado. Mrs. Sullivan advised that she had not heard anything concerning Campbell; that Oscar Felt had a Post Office box at her post office and expressed the belief that he was getting all his mail there. She advised that at present Felt is not regularly employed. he had his car taken away from him last fall, as he was unable to keep up the payments thereon and uses Dan Tubbs' truck when he is able to secure any trucking work. Dan Tubbs at present is running a card game at the Rialto Pool Hall on North Center Street. Relative to Tubbs, Mrs. Sullivan verified the opinions of Mack Welch and Mrs.

Vroman concerning his doubtful cooperation, although he personally was honest. Agent discussed with Mrs. Sullivan the problem of securing some one in Evansville, who was in a position to know what " was going on around the home of Felt, and a person whose cooperation would be assured. After some thought, Mrs. Sullivan recommended a Mr. and Mrs. S. A. Reimer, who lived directly beside Oscar Felt. Mrs. Sullivan contacted Mrs. Reimer by phone and requested her to come to her home, which Mrs. Reimer did. Mrs. Reimer appears to be very intelligent, is quite young, and she advised that her home is directly beside that of Felt and that she is in a position to maintain a constant surveillance of his residence. Mrs. Reimer was asked to cooperate with the Bureau by keeping a watch over the activities around the residence of Felt, especially with a view of determining the presence of out of state people and cars. Mrs. Reimer stated that she personally knows Campbell and assured Agent of her cooperation. She advised that she would notify Mrs. Sullivan of any suspicious activities about Felt's place and she in turn could notify the Denver Office. She advised that she and her husband were quite friendly with Felt and had been living in Evansville for several years and that Felt would not suspicion their interest in any way.

Agent discussed with Mrs. Sullivan the problem of securing the cooperation of some one who was quite friendly with Felt, whose cooperation could be secured and who knew Felt to such an extent that
any inquiry concerning Campbell would not arouse suspicion on Felt's
part. Mrs. Sullivan recommended James Sandison/who operates the
Sandison Market in Casper and who formerly was a business associate
of Felt and who was still friendly with him.

Agent contacted James Sandison, after Sandison's reputation had been werified by Sheriff R. John Allen. Sandison resides at 114 North-Lincoln Street and operates the market at East 2d Street which is one of the largest markets in Casper. Sandison advised that he was very intimate with Felt and that at the present time Felt was employed by him in doing some cleaning and painting around his store. He stated that he had done several favors for Felt in the past and believed that Felt considered him one of his best friends. Sandison was asked whether he would cooperate with the Bureau in an effort to bring about the apprehension of Campbell and he stated that he would do so, if his efforts were kept strictly confidential, and such was assured him. Sandison agreed to endeavor to secure from Felt any information concerning Campbell and further stated that he would endeavor to determine whether or not Felt was endeavoring to arrange any hideout for Campbell and check his other activities. Sandison stated that Felt did not have many contacts outside of Casper but stated that Dan Tubbs, who was very close to Felt, was well acquainted with the different

ranches and cabins through the county. Sandison doubted Tubbs' cooperation in this matter, he being very close-mouthed and having himself been mixed up in the old bootleg racket in Casper. Sandison stated that he would communicate directly with the Denver Office should he secure any information, the telephone number being given to him. The question of securing some one to endeavor to secure information from Tubbs was discussed with Sandison and he stated that he would keep this matter in mind and asked to be contacted in the future relative thereto. Sandison stated that the past summer Felt and Gubbs had gone prospecting together in the section around Atlantic City, Wyoming, which is en inaccessible place in Sweetwater County, south of Lander and Pinedale, Wyoming, and said that it was probable that they would again go there this summer, Tubbs' having a small claim there which they use as a camping ground while placer mining, more for recreation than profit.

While agent was interviewing Dr. L. D. Johnson, offices in the America Theatre Building, North Center Street, on a War Risk Insurance case, it was believed by Agent that Dr. Johnson would be the type of doctor that a person such as Campbell might contact in Casper should he need medical treatments. Dr. Johnson was asked whether he had ever treated a Harry Campbell and after an examination of his records, it was found that Harry Campbell was treated by Dr. Johnson in 1931, reason not given, Campbell having called at the office. The card showed Campbell as being 25 years of age at that time, born in Missouri, single, occupation, office worker, and had had a previous operation for hernia. Dr. Johnson's reputation around Casper is that of an abortionist and dope peddlar and he has been in trouble with the Narcotic Bureau about dope previously. Dr. Johnson came from Chicago around 1920, his previous assistant, Dr. Allan McLellan, advising that he also had trouble over narcotics there and that was the reason for his departure from Chicago. It is believed that Dr. Johnson would not cooperate with the Bureau in this matter, but his information should be kept in mind.

THE DENVER OFFICE: At Casper, Wyoming will keep in contact with Mack Welch, Mrs. Sullivan and contact James Sandison and Mr. Vroman as set out in body of this report; will endeavor to secure an informant who is friendly with Dan Tubbs in an effort to determine whether at any time Tubbs would attempt to secure any hideout for Campbell, it being believed that should Campbell directly contact Felt or Tubbs at Casper, the Denver Office would be immediately notified.

MEMORANDUM FOR THE DIRECTOR

Re: CHAFLEC J. FITZGERALD, with aliases; BILLIAM HAWA, Jr., Victim. Kidnaping.

This investigation is progressing satisfactorily to date. Numerous leads which here decided upon by Mr. Tamm and Mr. Connelley are gradually taking shape.

The St. Paul office has advised that the cottage at Eald Eagle Lake, White Bear, Minnesota, which was occupied by Karpis in June of 1933, has been located; however, the exper is unable to make any pertinent identifications. Persons residing in that vicinity have partially identified Peiffer's photograph as that of the man seen at the cottage. Investigation further discloses that this cottage was occupied by Morris Roisner, St. Paul hoodlum, following the kidnaging and that it was frequented by him during the kidnaping period. koisner has been identified by several neighbors. Other neighbors in the vicinity are unable to identify any of the subjects but they all recall the Japanese servent employed by Karpis at the cottage. At the present time, investigation discloses, the Hollyhocks Inn is not being operated by reiffer but is cored for by the Japanese servant, San Tenaka.

You will recall that Bryon Holton stated he took a trip with Peiffer and a somen from St. Paul to Chicago, Illinois, on July 23, 1933, and that while on this trip he saw Hamm and an Agent of this Bureau. - A statement has been taken from Agent Goulter who was the Agent accompanying Hamm on this journey, and through the manifest records of the Northwest Airways, Incorporated, investigation discloses that Bryan Bolton's statement that he having noticed the Agent and Hass on this plane, left the plane at Madison, Wisconsin, was verified. Further investigation at Madison, Wisconsin, has resulted in his identification.

Photographs of Fred Barker and Paul Harmon have been identified by neighbors, owners and tradespeople as occupants of the 204 Vernon Avenue, St. Paul, Mindesota, residence, which was occupied by these persons during the kidnaping period. Leads have been set out to interview additional. persons relative to this. In this regard, rusidences which were maintained by various subjects prior and subsequent to the kidnaping have been located in Caicago, Illinois, and vicinity.

Charles J. Fitzgerald, Isabel Bourne, Kate Barker, Fred and Arthur Charker, Alvin Kerpis, Dolores belancy, Fred Cods, Treno Corsey, Volney Duvis, at Ednay Murray vacated their various apartments short Whatter the Golouse of the victim and established themselves in other places ander various aliases. Also, persons in the vicinity of these verious redicesces have been interviewed

and identifications have been effected.

It has also been ascertained that Bartholomy has resided at 222 South York Road, Bensonville, Illinois, for approximately the past six years. This place is indicated by Bryan Bolton as the hideout. Pictures of this hideout have been obtained and are maintained in the files.

Francos Nash, who is presently residing at Aurora, Minnesota, has identified the Barker brothers, Karpis and the Harmon woman as occupants of the 204 Vernon Avenue apartment in June, 1933. You will recall that in June 1953, were identified as those of Frankflush and later other photographs of latent prints were received by the Bureau which were developed from certain articles at the same address, one of which was identified as that of Paul Harmon. It also appears that during the investigation of the Bromer kidnaping, Agent Noonan of the St. Paul office recalled that Werner Hanni secured the fingerprints of Thomas Brown of the St. Paul Police Department among others and forwarded them to the Bureau for elimination purposes. It is further believed that the original prints were returned to Brown. However, a sourch of the Brekid file in the St. Paul office fails to reveal the date these prints were forwarded. Fue to the implication of Brown in this case, a search is being made of the fingerprint records in the Identification Division for the purpose of locating the fingerprints of Thomas Brown, and if located, they will be compared with latent prints still unidentified developed from articles taken from 204 Vernon Avenue, St. Paul, Hinnesota, in June, 1933.

Came in contact with a Dorothy Flournoy of Casper, a prostitute, who resides on the Sand Bar and is well known in Casper. Flournoy's husband was killed several years ago in either Kansas or Oklahoma in an attempted bank robbery and is reputed to be in contact with those who hit Casper. Flournoy's pimp, Roy Harmon, also is incarcerated in Rawlins for a stick-up and kidnaping in Wyoming a few years ago, and according to Jonen, as duped into assisting Harmon and Flournoy in an attempt to Tree Harmon.

Jonen advised that he had not been able to secure any further information concerning W. E. Mead. In the fall of 1934, Roy Wrinkles Villiamson had gone to Riverton, Wyoming, and Jonen sent Verne Ford of the local police department to Riverton in an attempt to learn whether or not he, Williamson, was contacting Mead, as he had gone there with Mead a year or so prior on a hunting trip; however, Ford was unable to obtain any information, and in an interview with Williamson, Ford was advised that Mead had gone to China; that his face had been lifted; that he received letters from Mead which werein code. Williamson obviously would not give Ford any information.

Williamson has been interviewed in Arkansas as is noted in the report of Special Agent B. L. Damron, Little Rock, Arkansas, dated February 8. 1936. A lead is being set out to the reviewed in the report of the second sec

Thomas Neighbors has previously been interviewed by Agent, andhe has denied any knowledge of Mead and also was unable to identify Mead's picture. Neighbors was a member of the old bootleg ring in Casperalong with a Dave Davidson and the former Sheriff Gil Housely and has a son, D. C. Neighbors, who is also a confidence man, and it is not believed that Neighbors would give any information concerning Mead or other con men, being afraid that he might involve his son and also in view of his past connections with the liquor ring.

Neighbors has lived in Casper practically all of his life and has always operated a saloon and gambling establishment. Among the local officers, he is considered a legitimate operator but one who will refuse to offer any information concerning persons such as Mead.

B. J. McCafferty has not been in Casper since Agent's last visit, according to Sheriff R. John Allen and is now in Nebraska, evidently at O'Neil, which is his home town. McCafferty frequents Caper and

is a confidence man and gambler, and according to reference report, is an alleged associate of Mead. McCafferty's home is in the above town in Nebraska, and according to Officer Jonen, he has been arrested in Fort Worth, Texas, several years ago on some charge unknown. His visits to Casper have been frequent, staying for different perfods of time at the Arcade Rooms and at time at the Gladstone Hotel, and during those periods runs card games at the Grand Central Ber, which is owned by Thomas Neighbors.

UNDEVELOPED LEADS:

THE CMAHA OFFICE: At O'Neil, Nebraska, will locate and interview B.

J. McCafferty relative to any information he may possess concerning
W. E. Mead. Mead, according to Jonen's informant and Roy Williamson,
was in Casper during the fall of 1933 and went on a hunting trip with
Villiamson to Riverton, Wyoming. Williamson and McCafferty are well
acquainted, and McCafferty is himself a con man.

THE DALLAS OFFICE: At Fort Worth, Texas, will determine whether or not the above McCafferty possesses any criminal record at the Fort Worth Police Department and any information concerning him there, in an effort to determine what his associations are.

THE DENVER OFFICE: At Rawlins, Nyoming, will interview informant of Officer Jonen, and determine what information he possesses concerning W. E. 

Assistant Inspector Tierney stated that he has known Bill Hildebrandt for some time and would like to know where he is at this time as Hildebrandt is wanted as a wite ness in connection with the recent police investigation in St. Paule

He stated that he is well acquainted with Sam-Laff who operates a tailor shop in St. Paul as a front, but is generally known as a fence; that he has a means of obtaining information from Laff and will ascertain whether Laff knows where MEAD is at this time, if he knows him.

It is recalled that some time ago a fence for stolen bonds who handled some \$12,000 worth of bonds for Eddie LaRue alias Eddie Doll in Chicago, and was arrested and confessed, stated that he came to St. Paul to see Hildebrandt in an effort to locate LaRue; that Hildebrandt put him in touch with Sammy Laff who told him he could get in touch with LaRue who was then in Florida. Laff, having been something of a post office for thieves in the past, may know something as to MEAD at this time. Tierney stated that nothing would be gained by talking to Laff at this time though he will advise further on this after his inquiry.

Special Agent John V. Anderson interviewed Chief of Detectives R. E. Donaldson of the Duluth, Minnesota Police Department, furnished him with photos and description of MEAD and advised him that MEAD is a "con man" who is wanted for questioning by the Bureau. Mr. Donaldson stated that the Duluth police do not have a special squad working on con games but would furnish the information to his detectives.

Mr. Ed. Hansen, Chief Deputy Sheriff at Duluth, was also advised of the above facts.

United States Attorney John W. Holland, Jacksonville, has advised that he has received a letter from Special Assistant to the Attorney General Walter L. Barlow, to the effect that it is planned to go to trial on two indictments against Joseph H. Adams and Duke Randall, at Miami, on May 25, 26 and 27, 1936. At that time it is planned that Federal Judge Akerman from Tampa, will hold Court in Miami.

The communication which Mr. Holland received indicates that it has been determined in the Department not to further prosecute the indictments against Nathaniel Heller and Cassius Mc-Donald, and it has also been determined not to proceed in connection with the indictment charging a violation of the National Firearms Act. This latter decision being based on the opinionthat the Act is not constitutional. The indictments upon which prosecution is contemplated, are those numbered 4608 and 4609.

I assume that the Bureau has been advised of the decisions reached by officials of the Department, but I am furnishing this information in the event it has not been previously received.

Re: ALVIN KARPIS, with aliases, Fugitive, I.O. #1218, et al; EDWARD GEORGE BREMER, Victims; Kidnaping.

The Bureau is in receipt of a communication dated March 21, 1936 from the Jacksonville Bureau Office Advising of the receipt of a letter by United States Attorney John W. Holland, Jacksonville, Florida from Special Assistant to the Attorney General Walter L. Barlow, to the effect that it is contemplated the trial of Joseph H. Adams and Henry "Duke" Randall will commence at Miami on May 25. 26, and 27, 1936. It is planned that Federal Judge Akerman from Tampa will hold court at Miami.

The communication which Mr. Holland received further indicates that the Department has determined not to further prosecute the indictments against Nathaniel Heller and Cassius McDonald, nor is it intended that any prosecution be had in connection with the indictment charging a violation of the National Firearms Act. The Departmental interpretation with reference to the Firearms Act is to the effect that the Act is not Constitutional.

SYNOPSIS OF FACTS:

Subject Karpis reported identified in connection with a jewelry store robbery, Greenville, Ohio, March 4, 1936, but witnesses to robbery unable to identify any subjects of this case.

P.

DETAILS: On March 9, 1936, the Cincinnati Office was notified by a representative of the Times-Star newspaper at Cincinnati, Ohio, of a report that witnesses to jewelry store robbery which occurred March 4, 1936, at Greenville, Ohio, had identified Alvin Karpis as one of the participants.

Agent proceeded to Greenville, Ohio, and contacted Sheriff Linn Browne, who stated that none of the witnesses to his knowledge, had identified Alvin Karpis' picture, although his picture had been shown, with a number of others, to the various witnesses.

Agent displayed numerous pictures of the persons involved in this case to the following witnesses to the above robbery: R. O. Wieland, Roland Gray, Ralph Snyder, L. J. Sharrett and Bert Marker. None of the above could identify any of the members of this gang from the pictures, descriptions as obtained of them, by Agent, being dis-similar.

Three men participated in this robbery, two of them entering the Jewelry store operated by R. O. Wieland located at the S.W. corner of 5th and Broadway, Greenville, Ohio, one remaining in the car, which is reported to have been a 1935 model, Oldsmobile Sedan. The two robbers, who entered the store are described, as follows:
