There are attached hereto the logs for December 30, 1936 covering the taps on telephones listed to Chief of Police, City Jailor, and Mayor's Office, all located in the City Hall at Hot Springs, Arkansas.

The calls recorded at 11:08 A.M. and 11:29 A.M. over the police telephones indicates that "Pug" Dickson, a prisoner, was transferred from the City Jail to the Garland County Jail.

The "Billy" mentioned in conversation recorded at 11:25 A.M. is a prostitute call girl in Hot Springs, Arkansas.

Chief Wakelin made his usual nightly call to Grace Goldstein at 6:25 P.M. and he wasted no time in telling her the latest news received at the Police Department.

You will note in the log covering the tap on the Mayor's telephone that he invited Federal Judge ~~Martineau~~ Martineau to his New Year's Eve Party at the Club Belvedere. Tomorrow's log will reveal that Martineau accepted the invitation.

MEMORANDUM FOR INSPECTOR E. J. CONNELLEY:

Re: Brekid.

There are attached hereto the logs for January 1, 1937 covering the taps on telephones listed to the Chief of Police, City Jailor, and Mayor's Office, all located in the City Hall at Hot Springs, Arkansas.

In this day's log, as well yesterday's log, frequent mention was made of a 1936 Model Ford V-8 Sedan which was stolen from the garage of Joe McRae, the owner of the said car. At the time this car was recovered, considerable blood stains were found on the running board and on the inside of same. "Dutch" Akers believed that a wounded man was carried in this car, and worked on that theory in his investigation of this case. It later developed that a local boy, age 17, named Jimmy Melton stole McRae's car, and went joy-riding with it. Melton explained that the blood splotches found on the car were caused from a cut which he received over his left when kicked by the crank as he was attempting to start the car. The Melton boy plead guilty to the theft of the car, and received a two year sentence by Judge Verge Ledgerwood.

Note the reaction of the above news article in the conversation between Captain Bob Moore and his sister had at 6:40 A.M.

With reference to the conversation recorded at 10:14 A.M., it is possible that the Bureau may develop a National Stolen Property Act out of this.

The call at 4:08 P.M. shows that Cecmli Brock secured work at the Belvedere Club ~~on~~ New Year's Eve.

In the conversation recorded at 6:12 P.M., note Grace Goldstein's reaction to the news article which appeared in the morning local paper.

In connection with the tap on the Mayor's telephone #648, you will note the conversation recorded at 8:05 A.M. between the Mayor and John Jones who is Clerk of the Circuit Court, Garland County, Arkansas. The "Emory" mentioned in this conversation undoubtedly is Houston Emory, the Prosecuting Attorney at Hot Springs, Arkansas.

You will note in the conversation had at 9:25 A.M. that Federal Judge Maxine Martineau apparently accepted Mayor McLoughlin's invitation to the latter's New Year Eve's party.



MEMORANDUM FOR INSPECTOR E. J. COENELLEY:

Re: Brekid.

There attached hereto the logs for January 2, 1937 covering the taps on telephones listed to the Chief of Police, City Jailor, and Mayor's Office, all located in the City Hall at Hot Springs, Arkansas.

Also attached hereto please find a newspaper article which appeared in the Hot Springs Sentinel-Record newspaper on January 2, 1937. The same is self-explanatory. It is suggested that this article be made part of the file.

Attention is directed to the conversation recorded at 12:55 A.M. A subject named John "Sharkey" Gorman, who is alleged to be a prize fighter, and who probably will be indicted for harboring Alvin Karpis at Cleveland, Ohio, is at present under investigation by the Bureau at Cleveland, Ohio. There may be a possibility, that the "Sharkey" Gorman fled from Cleveland, Ohio and came to Hot Springs, Arkansas, and that the "Sharkey" mentioned in instant telephone conversation is identical with this subject.

Reference is made to the conversation recorded at 10:48 A.M. There is only one Dr. Davis listed in the Hot Springs Telephone Directory, and he is Dr. Louis Davis, a dentist, with offices at 631½ Central Avenue. It appears that the conversation at this time is related to the call made at 1:12 A.M. between Attorney D. Swain and "Dutch" Akers. It is, however, not known what the subject of their conversation is about.
