The reference made by Hazel Marsh, secretary to Mayor McLaughlin, of "someone plugging in" on telephone 648 in the conversation at 9:25 am. on Feb. 5, 1937 over 648 probably refers to some person located at the City Health Department which has an extension phone on this same number plugging on the line. Her statement apparently has no reference, possible "tapping" of telephone number 648, and apparently she has no suspicion that this telephone is ~~being~~ tapped.
