## Bremer Kidnaping Trial Set for Nov. 12

ST. PAUL, Sept. 6 (I.N.S.). William Weaver and sweetheart, Myrtle Eaton, will be tried for the \$200,000 kidnaping of Edward C. Bremer, St. Paul banker and heir to brewery millions, at the next session of the U. S. District Court, which opens here November 12. They are being held in the Ramsey County jail under bonds of \$100,000 each. Weaver is charged with being one of the eight men who actually kidnaped the banker, his sweetheart with maintaining an apartment here which served as headquarters for the Barker-Karpis gang and with aiding in the preliminary arrange-

## HOOVER LEADS G-MEN HUNT FOR KARPIS

Refusal of \$50,000  
Radio Contract  
Also Bared

J. Edgar Hoover, chief of the Bureau of Investigation of the Department of Justice, has personally gone into the field to "get" Alvin Karpis, America's Public Enemy No. 1, The Times learned exclusively today.

Mr. Hoover, whose life recently was threatened by the gang leader, has been away from his office for two days, supposedly on a vacation. But it was learned that when he left his office he made the cryptic remark:

"Karpis must be taken."

Attired in a natty gray suit and wearing a Panama hat, Mr. Hoover left his office and has not been seen there since. It was learned, however, that he is heading a picked squad of crack agents who are out to get the kidnaper and killer.

Kidnaped Bremer

It was the Karpis-Barker gang that kidnaped Edward G. Bremer,

wealthy St. Paul banker and held him for \$200,000 ransom. But the G-men have captured or killed every member of the gang except the leader.

While Mr. Hoover was on the hunt for Karpis, it was also learned that he has turned down a \$50,000 radio contract.

A large automobile manufacturer, it was understood, offered him a 26-week radio contract at a salary of \$2,000 for each appearance, to make a three-minute talk on "How To Prevent Crime."

A spokesman for the Department of Justice, commenting on Mr. Hoover's refusal to accept the contract, said:

"G-men are opposed to commercializing their work."

### MOVES KEPT SECRET

Secrecy covers the moves of Mr. Hoover and his picked squad since they started out on the trail of Karpis.

One of the most dangerous criminals in the world, Karpis was named Public Enemy No. 1 after John Dillinger was slain in Chicago by the G-men. Arthur "Doc" Barker, his companion, was captured several months ago. Kate "Ma" Barker and another son, Fred Barker, were shot to death in a gun battle when the agents surrounded their Florida hang-out.

Karpis was captured early this year and staged a daring escape, hurling a glass of beer in the face of the agents after their plane had been forced down. Later he was trapped in Atlantic City, but escaped following a gun battle.

#### HELD FOR U. S.

Woman Is Acquitted of Bank Rob-  
bery Charge

PRENTISS, Miss, Sept. 6.—(AP)—  
Although acquitted today of the  
capital charge of robbery with  
firearms in connection with a bank  
robbery, Mrs. Bergie Johnson, 42-  
year-old mother of five children,  
was remanded in jail for federal  
investigation.

Mrs. Johnson was tried and ac-  
quitted in the state circuit court of  
Jefferson Davis county on the rob-  
bery charge as an accomplice of  
the late southwest desperado, Ray-  
mond Hamilton, in Hamilton's  
holdup of the Bank of Blountville  
here last March.

The jury found her innocent of  
the charge, but on instructions from  
federal agents, Mrs. Johnson was  
placed in jail by Sheriff W. H.  
Mathison to face a government  
charge of harboring a fugitive from  
justice.

The federal agents came here, it is believed, after the arrest of a man and woman in Florida, in connection with the Bremer kidnaping.

Karpis is the most sought man in America today. Leader of the Barker-Karpis mob, he and Harry Campbell comprise the two major fugitives at large. Under indictment in the kidnaping of Edward G. Bremer, St. Paul bank president, Karpis is wanted in St. Paul by the federal government, where Harry Sawyer and William Weaver, alias Phoenix Donald, now await trial.

Last winter Karpis with his aid, Campbell, shot his way out of an Atlantic City hotel. His most recent escapade was a penned threat to J. Edgar Hoover, head of the federal bureau of investigations.

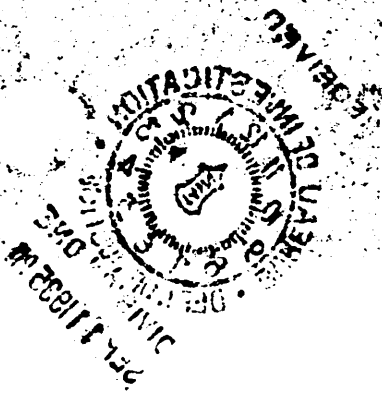

The count is a smoothie. Well-groomed and wearing a little mustache which gives him a European air.

Last week the count was locked up in the Federal House of Detention in New York, where Federal prisoners are kept while awaiting trial. He was on the top, or third floor. Windows there are protected only by a heavy wire grating.

# **ENGINEER IMPLICATED IN BREMER KIDNAPING**

ST. PAUL, Sept. 9 (AP).—A Federal Grand jury convening here Tuesday will be asked to indict a Montana engineer as a "money-changer" in the \$200,000 ransom kidnaping of Edward G. Bremer, millionaire St. Paul Banker, Jan. 17, 1934, it was learned from an authoritative source today.

Department of Justice agents will appear before the grand jurors with information allegedly connecting the engineer with the "peddling" of \$107,000 Bremer ransom notes in Havana, Cuba.

The Federal men will charge that the Montana resident worked with Alvin Karpis, the nation's No. 1 public enemy, in disposing of the "hot" money in the Cuban city.

## Gets Judgment Against Barker

### Brewery Given Verdict For Bremer Ransom.

A default judgment for \$219,010.95, representing the Edward G. Bremer ransom, interest to date and costs, was obtained in Ramsey county district court today against Arthur (Doc) Barker, Bremer kidnaper serving a life term in Leavenworth.

The judgment was obtained by the Jacob Schmidt Brewing Co.

When Ma and Fred Barker, mother and brother of the kidnaper, were slain in Florida last winter, they left, respectively, \$10,000 and \$4,000 on which probate proceedings are to be started soon in Joplin, Mo.

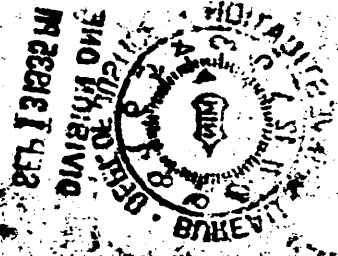
Although a new federal grand jury is scheduled to convene in St. Paul Tuesday, the Bremer kidnaping case will not be heard by that body until Monday, it was learned today.

Several alcohol tax violation, narcotic and secret service cases will be considered by the jury this week.

It is understood that additional indictments in the Bremer kidnaping case will be sought by the government.

The fall term of court will get under way in Minneapolis Sept. 24 and in St. Paul Nov. 5.

## NEW BREMER CASE INDICTMENT SEEN

U. S. Grand Jury to Sift  
Charge Against Montanan  
as "Money-Changer."

The Federal grand jury which convenes here Tuesday may be asked to indict a Montana engineer as a "money-changer" in the Bremer kidnaping case.

While no official statement could be obtained, it was learned that preparations have been made for appearance before the grand jurors of Department of Justice agents said to have information connecting the engineer with the "peddling" of \$107,000 of the \$200,000 ransom paid for the release of Edward G. Bremer, St. Paul banker.

The suspect is alleged to have co-operated with Alvin Karpis, kidnap gang leader, in "peddling" the sum in Havana.

Awaiting trial on a charge of harboring Karpis in Florida is Casius McDonald of Wolf Point, Mont., now at liberty under bond.

### JUDGMENT ENTERED AGAINST DOC BARKER.

A default judgment for \$219,010.95 was entered today in Ramsey District court against Arthur R. (Doc) Barker, now serving a life term for the kidnaping of Edward G. Bremer, in a civil action brought as a result of the kidnaping.

The amount covers the \$200,000 ransom paid to the Barker-Karpis gang for Mr. Bremer's release in February, 1934, after 22 days of captivity. The action was brought by the Jacob Schmidt Brewing Co., through which payment of the ransom was made. The default judgment was entered when Barker failed to contest the action.

Originally, a number of others were named with Barker as defendants in the action, but he was the only one on whom service was obtained, and so the judgment was entered against him. Service was obtained in May in the county jail here when he was on trial for the kidnaping.

The judgment was entered today as a preliminary to attaching Barker's share of an estate of approximately \$14,000 left by his mother and brother, Kate Barker and Fred Barker.

## RENO-BANKERS FACE SECOND U. S. JURY

NEW YORK, Sept. 9 (AP).—Within one hour a federal jury was selected today for the second mail fraud trial of William J. Graham and James C. McKay, big-time gamblers of Reno, Nev. Opening for the government, George Pfann, assistant U. S. attorney, told the jurors in the court of Judge Robert McMillan that McKay and Graham might be likened to the "executives" of a large-scale ring of swindlers.

### CHARGES "PAY-OFF"

"Pay-off men of the confidence operators brought their victims to the Reno headquarters of McKay and Graham," Pfann declared.

He gave an involved explanation of how various confidence games are conducted. He talked of "steerers" and "pay-off" men.

Graham and McKay, he continued, took a percentage from the loot of the ring of swindlers.

Victims were brought to Reno, he said, and the defendants introduced them at the Riverside Bank and arranged for the transfer and conversion into cash of their securities.

### S. F. ATTORNEY

The Riverside Bank was described by Pfann as a place where "they asked no questions—they put the deals through."

Government prosecutors are Pfann, J. Howard Carter and Irving Kaufman of the New York district attorney's office, and E. P. Carville, U. S. attorney from Nevada.

John Taaffe of San Francisco and Moses Polakoff of New York are defense attorneys.

The name of Roy Frisch, missing cashier of the Riverside Bank, was brought up by Pfann.

"Frisch will not be a witness at this trial, unfortunately," said Pfann, "and the government will show you why he won't be."

At the first trial of McKay and Graham, which ended in a jury disagreement, a witness said he thought Frisch "was taken for a ride."

NEW YORK, Sept. 9 (AP).—A big, red-faced rancher from Victoria, B. C., Canada, testified today in the mail fraud trial of William J. Graham and James C. McKay how the alleged "steerers" of an international swindle ring played the old lost wallet confidence game on him.

The rancher, Alistaire Forbes, was the first witness called by the government. He stood up when he testified, explaining this was court procedure in Canada.

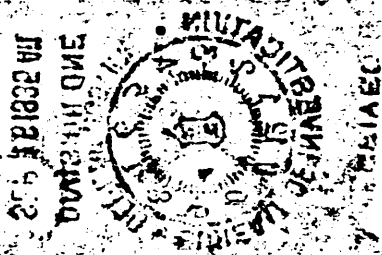

## 6 GAMBLERS TOO NICE FOR JAIL CELLS

While there were no indications of ill-health or fainting spells or other ailments when they admitted before Common Pleas Judge Alva R. Corlett yesterday that they were gambling operators or employees, six men from the Harvard and Thomas Clubs soon learned they could serve their County jail terms in comfortable wards usually reserved for sick and mental patients.

Arthur Hebebrand, Dan Gallagher and James (Shimmy) Patton of the Harvard Club were placed in what was formerly the women's psychopathic ward. Sam (Game Boy) Miller and his brothers, Dave and Alky, of the Thomas Club, were confined in the jail hospital ward.

Sheriff John M. Sulzmann explained that there was a very simple reason for selection of these quarters in his "humanized" jail.

"I adhere religiously to the advocacy of segregation, keeping the hardened criminals segregated from the first offenders," he said.

Three of the six had challenged the right of the county grand jury last December to force them to answer questions "which might tend to incriminate" and carried their contempt of court convictions to the State Supreme Court before winning their fight.

Yesterday the trio, through their attorney, William J. Corrigan, admitted they were gambling operators.

These three are Hebebrand, Gallagher and Sam Miller. Dave and

Alky Miller, Corrigan told Judge Corlett, were merely employees. Patton, he said, had sold his interest to Gallagher a year and a half ago, and if Patton had been at the Harvard Club it was to get "his money out of it."

Three Counts Nailed.

All six, however, pleaded guilty to a count of the indictment which charged them with unlawfully keeping a room for gambling purposes.

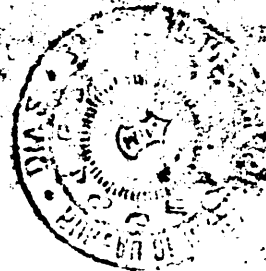
**2 CONVICTED OF 'PASSING'

# G-MAN REPORTS KARPIS IN MAINE

## LAUNCHES HUNT FOR OHIO AUTO

Highways Watched After  
U. S. Official Tells of  
Four in Car.

Augusta, Me., Sept. 11.—  
(AP) — State police were  
watching Knox county roads  
early today for an Ohio car  
containing a man reported  
to them as resembling Alvin  
Karpis, much-sought "public  
enemy No. 1," police head-  
quarters reported.

State police said a Federal official, whose name was not disclosed, told Sheriff Hiram O. Burgess of Waldo county he saw the car, containing four men, one resembling Karpis, near Belfast, proceeding toward Rockland.

Karpis, missing since he shot his way out of an Atlantic City hotel in January, is wanted in connection with the Bremer kidnaping in St. Paul, last year.

### GANGSTERS' CONSORT TRACED IN RANGE PLOT.

Virginia, Minn., Sept. 11.—Evidence that Beulah Baird, consort of Clyde Barrow, "Pretty Boy" Floyd and Ray Hamilton, notorious South-west killers, was in Virginia August 12 with two Texas gangsters planning the robbery of a Virginia bank was disclosed by Virginia police.

Axel B. Dahl, Virginia detective, and G. D. Cusson, chief deputy sheriff here, are in possession of women's apparel believed to have belonged to Miss Baird, 24-year-old fugitive wanted in Kansas for the alleged killing of a policeman while she was traveling with Floyd, slain outlaw. She is said to have been the first sweetheart of Barrow.

The women's clothing, described in detail by Jess King of Fort Worth, Texas, who was sentenced in District court last week to an indeterminate reformatory sentence, was found in the gang's hideout in a shack between Duluth and Virginia, off the Miller trunk highway.

Information that the raid was planned was obtained from King, a drug addict arrested at Moorhead before he was sentenced here. King told authorities that he and Bob Easton, escaped Texas penitentiary lifer, accompanied Miss Baird and that a machine gun was part of their equipment.

Plans for the robbery were discarded, according to King's story to officers, when he was arrested at Moorhead where the trio went to meet a fourth person, known only as "Curly", to talk about the bank holdup.

King disclosed that he met Miss Baird and Easton in St. Paul a few days before they came here a month ago. King said Easton and he formerly worked together on railroads before the latter was sentenced to a life term in Texas for several bank robberies.

Police were told the gang planned to leave the car at the Gilbert "Y" and steal a car at Virginia to be used in the holdup. Then they were to go from Virginia south on the Miller trunk highway, changing to their own car at the "Y" and thence to the hideout.

King told Virginia police that Hamilton spent three weeks on the Iron Range and at Duluth, planning a bank robbery prior to the time he was caught in Texas.

## GRAHAM TOOK SWINDLE 'CUT,' WITNESS SAYS

Ex-Aide on Stand Against Reno  
Gamblers; Tells How Gang  
Got \$18,000 From Farmer

NEW YORK, Sept. 11.—  
(AP)—A confessed and con-  
victed swindler, Noble John  
Moore, testified today that  
William J. Graham, Reno,  
Nev., gambler and political  
power, once took a 15 per  
cent "cut" from \$18,000  
swindled out of a Canadian  
farmer.

Moore, who is serving a term of  
four years and nine months for  
swindling, was a government  
witness in the second mail fraud  
trial of Graham and James C.  
McKay.

The defendants are accused of  
having taken percentages from  
the loot of an international swin-  
dle ring for facilitating the sale  
of prospective victims' securities  
at the Riverside Bank of Reno.

### TESTIMONY OF PAYOFF.

Noble testified that as "steerer"  
he and a confederate, "Mr. Mad-  
den," took the swindle victim,  
Peter Muckenbern, to Reno after  
banks had been reluctant to sell  
his securities.

"Madden told me the River-  
side Bank was a 'right jug',"   
Moore testified. "No questions  
were asked there."

After obtaining \$18,000 from  
Muckenbern, the witness said he  
was directed to take the money  
to Graham.

"I gave the money to Mr.  
Graham in one of his night  
clubs—either the Rex or Bank  
Club," he testified.

"Later, after we pulled the  
racetrack game on our victim,  
we went down to see Graham.

### "DIVIDED BALANCE."

"He gave Madden the \$18,000,

In the \$21,000 swindle of Fred-

# **Daily News Locates Baby Boy In Apartment Over Drinking Place At 949 W. 7th St.**

The hiding place of blue-eyed, golden-haired Bobby Hawkins, adopted by Gangster William Weaver and his "moll," Myrtle Eaton, was uncovered today by The Daily News. The chubby little boy, 2, going on 3, is held by Andy Rothmeyer, saloon proprietor, in a stuffy, dark apartment over a drinking place at 949 W. 7th st.

Rothmeyer for several years was an intimate friend of Mrs. Eaton, prior to the time she and Weaver—parole-jumping Oklahoma murder convict—set themselves up in an apartment at 565 Portland ave. to plan, the federal government charges, the kidnaping of Edward G. Bremer, Commercial State bank president.

Mrs. Eaton is the wife of Clarence ((Doc) Eaton, freed several years ago from a long term in Stillwater prison, when another man confessed to the "job."

Information as to the whereabouts of the child—deserted by his parents in Florida, and "adopted" by Weaver and Myrtle Eaton as a "blind" to

throw G-men off their trail—was turned over by The Daily News to Charles P. Hoy, deputy Ramsey county probation officer. Mr. Hoy immediately took steps to get possession of the child, now wanted by authorities of De Land, Fla., who are reported to believe that the "adoption" was illegal.

Meanwhile Thomas F. McMeekin, attorney, was to confer today with the Eaton woman in Ramsey county jail where she and Weaver are held waiting trial in the \$200,000 kidnaping.

"I knew nothing about this child," Mr. McMeekin said, "until I read The Daily News Sunday. While I have not yet been retained by Myrtle Eaton, I probably will represent her, and I will talk to her today about the boy."

Mr. McMeekin has been legal adviser to Rothmeyer for many years.

Florida authorities are expected to arrive in St. Paul Tuesday to claim the boy and to return him to whatever suitable home can be found for

## Child Taken From Place Vacated by 2 Suspects

**Bobby Hawkins, Adopted Son  
of Weaver and Myrtle  
Eaton, Put in Home.**

Tow-headed Bobby Hawkins was playing today in a boarding home maintained by the Ramsey County Child Welfare bureau.

The 2-year-old "adopted" son of William Weaver and Myrtle Eaton, Edward G. Bremer kidnap suspects, was taken Monday afternoon by bureau executives from the Andrew Rothmeyer home, 949 West Seventh street.

Bobby had been living in the Rothmeyer home, above a drinking establishment, since Weaver and Mrs. Eaton were flown here from Florida by federal agents to face charges of conspiracy to abduct the St. Paul banker. Rothmeyer, said to be a friend of Mrs. Eaton, operates the drinking place and resides in an apartment on the second floor of the building.

The Rothmeyers, a bureau representative asserted, "were glad to co-operate with us toward the best interests of the child" and "did not object to our taking him from them."

Rothmeyer was not available for comment today, and Mrs. Rothmeyer was reluctant to discuss the child.

Bobby's true surname is Hawkins, although Mrs. Eaton and Weaver were known as Mr. and Mrs. E. J. Osborne to Florida friends prior to their arrest.

The youngster was not legally adopted by the kidnap suspects, bureau officials said. His mother, whose full name is not known here, permitted Weaver and Mrs. Eaton to take the child last May.

Bureau executives are checking Florida officials toward determining the future residence of Bobby.

REDRESS AT LAST

WELFARE authorities are taking some action in the case of the young boy "adopted" by Myrtle Eaton and William Weaver, gangsters charged with a part in the Bremer abduction.

Ever since these two were brought back here to face trial the youngster has been sequestered and Monday was located by The Daily News living over a saloon owned by a man to whom, we feel sure, the Ramsey County Welfare board would never have turned over the custody of the child.

How Florida authorities ever permitted these two underworld characters to obtain an orphan for adoption, if they did, will remain a mystery. The most casual investigation would have revealed some of their past history. The child obviously was being used to give an appearance of respectability to their "chicken ranch" hideout.

Nor are the federal operatives entirely without some responsibility in this matter. Their first step upon bringing the child to St. Paul should have been to turn him over at once to the custody of the Ramsey welfare authorities.

Heaven knows we have gangsters enough in this nation without starting them off at the cradle.

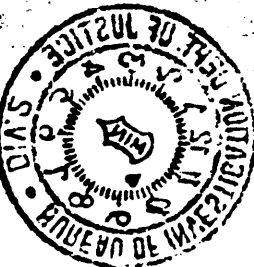

That was true of W. A. Rorer, who captured the notorious "Machine Gun" Kelly.

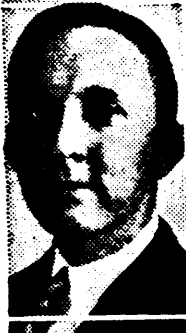
Although supposed to be a bad actor, Mr. Kelly was taken without a struggle.

The fact that "Machine Gun" failed to put up a fight seemed to impress Mr. Rorer, who also has been known as "hard to get."

Consequently, Mr. Rorer, without a struggle, has given up to Miss Genie Davis Black, 22-year-old niece of the late Eugene Black, governor of the Federal Reserve Board.

He was captured without a fight and is now on the way to Yellowstone National Park, manacled for life.

McDonald, who gave his occupation as an engineer, was arrested at his isolated lake front villa in Grosse Pointe village last night and was immediately arraigned before U. S. Comr. Frank Q. Quinn, who fixed bond at \$100,000 and set the removal hearing to St. Paul, home of the victim, Edward G. Bremer, for Oct. 8.

McDonald has been at liberty since February under \$10,000 bond after he was indicted at Miami, Fla., for harboring Alvin Karpis, credited with having negotiated the kidnaping or Bremer. Authorities say that McDonald had no part in the kidnaping plot, but arranged to have the money passed in Florida and Cuba.

McDonald's father died in Chicago, Aug. 9, 1907, leaving an estate of \$1,000,000. The son's part is said to have been appreciably dwindled during the 1929 stock market crash.

McDonald's stepmother, Mrs. Nora Bradley McDonald, was involved in the sensation murder of Webster S. Guerin, Chicago artist, a few months before her husband died. She later was acquitted.

# LINK POINTE RESIDENT TO KIDNAPING

U. S. Holds Detroit  
Man as Ransom  
Passer

Cassius M. McDonald, 52, a resident of Grosse Pointe Park for 19 years, is a federal prisoner today, in the county jail.

He is charged with having \$104,000 of the \$200,000 ransom Edward G. Bremer, St. Paul banker, paid for his freedom in January, 1934.

McDonald was arrested last night by federal agents and held under \$100,000 bond.

Local department of justice officials declared they knew nothing of the charge against McDonald and said he was registered by the United States marshal merely on the charge of having violated the United States code.

## IMPORTANT ARREST

The amount of the bond, however, was taken as an indication of the importance which the government attaches to the arrest.

The information that McDonald had been arrested in connection with the Bremer kidnap case came from St. Paul, where it is alleged he cashed \$104,000 of the \$200,000 ransom paid for the banker and brewer's release.

St. Paul advises associated McDonald's name with that of Alvin Karpis, public enemy No. 1, and his first lieutenant, Harry Campbell.

McDonald has been at liberty under \$10,000 bond set by Florida authorities, police here were told. The bond was fixed after McDonald had been arrested in Florida on suspicion of having knowledge of the harboring of Karpis and Campbell, fugitive suspects in the kidnaping.

This occurred shortly before the spectacular slaying of "Ma" Barker and her son, Fred Barker who shattered the widely-sought gangster. Both the Barkers died in a machine gun battle with federal agents.

## FOUR FACE TRIAL

The arrest of McDonald brings the number of those awaiting trial in St. Paul in November to four. Harry Sawyer, William Weaver and Myrtle Eaton are the other three.

Arthur "Doc" Barker, Volney Davis and Oliver Berg are now serving terms following their convictions at St. Paul in March. Harold Alderton, Jimmy Wilson,

John J. McLaughlin and Elmer Farmer, also convicted with Davis and Berg, are serving terms of from 5 to 20 years each. Byron Bolton, who pleaded guilty and turned state's evidence, is awaiting sentence.

Residents of Grosse Pointe Park in the vicinity of Trombley road and Lakeview drive where McDonald and his wife lived in a handsome eight-room house built along Spanish architectural lines of stone and plaster, saw little or nothing of their neighbor.

Hidden from view by trees and thick shrubbery, two snarling police dogs kept trespassers and itinerant salesmen at a distance from the house. The district is rather a lonely one and up to a year ago

there was no other habitation within a quarter mile.

## UNKNOWN TO POLICE

A Grosse Pointe Park official said police had never any trouble with the McDonalds.

"They kept to themselves," he said, "I, myself, only saw McDonald once—that was back in 1928 when he was coming out of his house."

"I recall him as a tall, lanky man and wouldn't know him again if I met him face to face."

The Detroit City directory lists McDonald as a civil engineer.

Shades were drawn inside the house last night and police hesitated to enter without a court order. Except for a Negro who attends to the grounds, the McDonalds have no domestic help.

## G-Men Seize Alvin Karpis Acquaintance

Arrested at Lake Cottage,  
Accused of Changing  
Money

FACES EARLIER CHARGE  
OF HARBORING OUTLAW

Bond Fixed at \$100,000—  
May Come to St. Paul  
for Trial

The federal government sprung its trap on another suspect in the Edward G. Bremer kidnaping case today and caught Cassius M. McDonald, a mining engineer and acquaintance of Alvin Karpis, at Detroit, on a charge that he made arrangements for exchange of \$72,000 of the \$200,000 ransom paid over to the Bremer kidnapers.

McDonald was arrested at his isolated lake front cottage in Grosse Pointe village at Detroit and immediately arraigned before United States Commissioner Frank Q. Quinn, who fixed his bond at the prohibitive figure of \$100,000 and set a removal hearing for October 2. It was expected McDonald would be brought to St. Paul at that time to face trial in federal court on conspiracy charges.

### Faces Earlier Charge

The charge against McDonald is similar to that on which John J. "Boss" McLaughlin, Chicago politician, was convicted in the Bremer case.

McDonald was arrested in February at Miami, Fla., and charged with harboring Karpis, the current public enemy No. 1. It was charged then he had helped Karpis escape from the Florida hideout where federal agents later shot and killed Fred Barker and his mother. At the time of his arrest in Florida, McDonald was released under \$10,000 bond. He is still awaiting trial on the charge.

It is specifically charged that McDonald contacted Karpis in Havana, Cuba, and made arrangements for exchange of \$72,000 in ransom bills in the Cuban city. A large sum of this money has been recovered by federal men, who also recovered most of \$57,000 in ransom bills which were exchanged by "Boss" McLaughlin in Chicago. The balance of the ransom money has not yet been traced.

### Indicted in St. Paul

McDonald was named in a secret indictment returned by the federal grand jury in St. Paul last week. District Attorney George Sullivan, acting on information gathered by department of justice agents, requested District Attorney William G. Comb of Detroit to bring about McDonald's arrest in that city.

McDonald was accompanied by two attorneys upon his arraignment before the United States commissioner.

### Two Still at Large

More than a score of persons were indicted by the government in the Bremer case. Only two major suspects remain at large, Karpis and his lieutenant, Harry Campbell.

Three suspects are now held in the Ramsey county jail awaiting trial. They are Harry Sawyer, alleged "finger man" in the case; Myrtle Eaton and Willie Weaver, who were captured a month ago in Florida.

McDonald originally was a mining engineer at Wolf Point, Mont. For several years he has been a resident of Detroit, maintaining a lake front home, a shooting lodge at Watersmeet, Upper Peninsula, and memberships in several fashionable Detroit country clubs.

McDonald denied knowledge of the case at all. He said he was engaged in forestry work for the Michigan state conservation commission at the present time.

Federal authorities said McDonald at one time inherited a fortune of several million dollars, but most of it was wiped out in the market crash. He at one time was a lumber expert for the federal government.

# McDonald Indictment In Bremer Case Seen Today

## Allege He 'Cooled' Part Of Ransom

### Charge Wealthy Detroit Politician Handled \$72,000; May Fight Removal To St. Paul.

An indictment charging Cassius McDonald, wealthy Detroit politician, with conspiracy in connection with the kidnaping of Edward G. Bremer, St. Paul banker, Jan. 17, 1934, is expected to be returned by a federal grand jury in session here today.

Arrested in Detroit late Thursday and held under \$100,000 bond, McDonald has indicated he will fight extradition to St. Paul and a removal hearing has been set in Detroit, Oct. 8.

The grand jury has been in session since Thursday morning. Its findings are ready for submission this afternoon to Federal Judge M. M. Joyce.

#### Linked With Karpis.

McDonald first came into the limelight as having connections with the Barker-Karpis gang, Bremer kidnapers, when he was arrested at the exclusive Breakers hotel in Palm Beach, Fla., Feb. 7. At that time he was charged with harboring Karpis. His bond was set at \$15,000 and later reduced to \$10,000.

Said to be the son of Michael McDonald, who operated the "Bloody Bucket" a well known Chicago gambling house in the '20s, McDonald is reported to have inherited more than \$1,000,000.

#### In Exclusive Suburb.

McDonald is 52 years old and has been living for the past several years in the exclusive Grosse Pointe park district, a suburb of Detroit, Mich. With his wife and a Negro servant.

McDonald lived in his \$100,000 home constantly guarded by two police dogs.

The suspect is charged with "cooling" \$72,000 of the \$200,000 ransom paid for the release of the St. Paul banker. However, federal government authorities allege that he actually cashed more than \$100,000 of the money.

The United States commissioner's warrant served on McDonald Thursday charges that he committed an overt act on Sept. 10, 1934 when he exchanged \$72,000 in Havana, Cuba.

#### 27 Involved In Case.

McDonald's arrest brings to 27 the total of persons mentioned in connection with the snatching.

Karpis, Harry Campbell, Willie Harrison and Dr. Joseph P. Moran, the latter believed to be dead, are the only ones at large.

Arthur (Doc) Barker, Volney Davis, Oliver Berg, John J. McLaughlin, Jimmy Wilson, Elmer Farmer and Harold Alderton were found guilty in a trial here last spring and are serving from five years to life in federal penal institutions.

Edna Murray, Jess Doyle and Bruno (Whitey) Austin, had charges dropped against them. William Vidler and Philip Delaney were acquitted by a jury here.

#### Three Facing Trial.

Held in Ramsey county jail to go on trial here during the November term of court are Harry Sawyer, William Weaver and Myrtle Eaton.

Byron Bolton, who pleaded guilty and later turned state's evidence, is at Ramsey county jail awaiting sentence.

Kate (Ma) Barker, Fred Barker, Slim Gibson and Fred Goetz were either slain by federal agents or by gangland foes.

The remaining two indicted are a John Doe and Richard Roe.

Weaver, Sawyer and the Eaton woman are to be arraigned Nov. 5, the opening day of the fall term of federal district. They are expected to go on trial during the following week.

Charges Political Intrigue.  
McDonald, interviewed in jail, charged his arrest was a

political intrigue. An International News Service dispatch stated,

"I hold the concessions from the Cuban government for the race track at Havana, for all prizefights, tennis tournaments and other sporting events in Cuba," he said. "The concession has 14 years to run and I suspect this fact is causing my present trouble."

"I don't know Karpis," he said. "The only Karpis I know is a football player. I had hoped to see the world series but it looks now like I'll have to take a federal marshal with me if I go."

He revealed he was once arrested in Cuba in connection with the case and claimed the president of that country ordered his release. Later, he said, he was arrested in Miami, Fla.

McDonald said he had attended both Notre Dame and Purdue universities but was forced to leave school in his junior year because of the death of his father, Michael C. McDonald of Chicago.

He stated since he came here in 1919 "I have done considerable timber engineering work for the government."

"As a matter of fact," he concluded, "I just returned from upper Michigan where I surveyed approximately 30,000 acres in a national forest for the United States government."

# RICH DETROITER HELD AS AIDE TO KARPIS

DETROIT, Sept. 27 (I.N.S.). Charged with passing \$72,000 of the \$200,000 ransom paid in the Bremer kidnaping, an aristocratic-appearing owner of an exclusive Grosse Pointe Park home here was being held in Wayne county jail for Federal authorities.

Cassius McDonald, 52, alleged associate of the fugitive Alvin Karpis, was arrested last night by Federal men and was being held in \$100,000 bond.

## Posed as Engineer

Having lived here for years and said to have posed as a wealthy business man, McDonald is charged with passing the \$72,000 in Havana, Cuba, in September, 1934.

McDonald, Combs revealed, was immediately arraigned before United States Commissioner Frank Q. Quinn here in the night. The commissioner set McDonald's hearing for October 8.

At the same time it was revealed that McDonald, known to his neighbors as a wealthy, respectable business man, is under indictment in Miami on a charge of sheltering Alvin Karpis, the national public enemy No. 1.

McDonald said:

Among the many rooms is one containing numerous mounted trophies, barracuda from Florida waters hanging alongside mounted deer heads from the North Michigan woods, where McDonald maintains a hunting and fishing lodge.

Mrs. McDonald, an ardent golfer and horsewoman, termed the charge ridiculous and said, "This is all a huge mistake."

## MCDONALD IS JAILED IN KIDNAPPING CASE

Detroit Man Is Charged With  
Disposing of \$72,000 of  
Bremer Ransom Fund.

### HELD AN AID TO KARPIS

Prisoner, Seized in Fine Home,  
Said to Have Harbored  
'Public Enemy No. 1.'

DETROIT, Sept. 27 (AP).—Cassius M. McDonald, who for years has maintained a fine residence in one of Detroit's fashionable suburbs, sat in a jail cell here tonight on a charge that he arranged for disposal of \$72,000 of the \$200,000 ransom money paid to the kidnapers of Edward G. Bremer, St. Paul banker.

McDonald, 52, gray-haired and expensively dressed, is held in default of \$100,000 bond. He was arrested yesterday after Federal agents here had been notified that a warrant for his arrest had been issued in St. Paul. A removal hearing was set for Oct. 8 by a United States Commissioner.

Last January, a year after the Bremer kidnapping, McDonald was indicted in Miami, Fla., by a Federal grand jury on a charge of harboring Alvin Karpis, now "public enemy No. 1." Karpis and his lieutenant, Harry Campbell, are the only principal suspects in the Bremer case now at large.

Edward N. Barnard, one of two attorneys with McDonald when he was arraigned, said that the St. Paul warrant is simply another phase of the Miami indictment. McDonald was free under \$10,000 bond pending trial next month on that charge.

Mr. Barnard said McDonald operated a race track last year at Havana, and that if any ransom money did pass through his hands "McDonald was not aware of it." He also said his client was at one time a lumber expert for the government and that a large fortune left McDonald by his father, described as a Chicago political leader, was wiped out by the 1929 stock market crash.

McDonald declined to comment, saying only he was a consulting engineer and had spent the last four years at Havana.

His wife, Mrs. Edith McDonald, remained in seclusion at the residence, assessed recently at \$50,000.

Bremer Case Suspect Also Dis-  
avows Acquaintance With  
Karpis.

DETROIT, September 28.—Cassius M. McDonald, held in default of \$100,000 bond on a charge of arranging the disposal of \$72,000 of the ransom paid the kidnapers of Edward G. Bremer, described himself today as a business man whose extensive interests precluded any possibility of implication in underworld affairs.

McDonald, soft spoken, meticulously attired resident of a fashionable Lake Shore suburb here, was arrested Thursday by Federal agents. He also is under \$10,000 bond, pending trial on a charge of harboring Alvin Karpis, slippery public enemy No. 1.

In an interview with the Detroit News at the county jail, McDonald said he did not know Karpis and that "when they said Karpis was in Miami, I was in Cuba," where he said he has a concession to operate tropical race track for the next 13 years.

"Samuel Insull once worked for my father, Michael C. McDonald," he was quoted as saying. "My father founded the Peoples Gas, Light & Coke Co., the Lake Shore Elevated Railroad and the West Chicago Street Car Lines, all in Chicago. He left me an estate of \$1,300,000 when he died."

## Barker Spends One-Third Of Cash Left by Outlaws

Joplin, Mo., Sept. 28.—(U. P.)—George Barker, who fathered a family of outlaws, came home Saturday with the bodies of Kate (Ma) Barker, his wife, and Fred Barker, his son.

# Karpis, Enemy and 3 Others Hunted

## Flashlights and Gasoline Can Put the Government on Trail of Gang in \$200,000 Abduction

By JOHN M. CARLISLE

When Edward G. Bremer, his eyes still smarting from the tape that had covered his eyes for 23 days, stumbled out of a taxicab in St. Paul, Minn., last February, there did not appear to be an existing clue to the identity of the kidnaping gang from whom his relatives had purchased his release for \$200,000.

It looked like a perfect crime until someone found three neglected flashlights with red bulbs in a roadside ditch near Rochester, Minn., and an empty gasoline can at the side of the road outside Portage, Wis.

Three flashlights and a gasoline can.

They didn't seem to lead to much in the beginning, but they solved the Bremer kidnaping case, and they were the only loopholes the Karpis-Barker mob left behind it.

Walter Magee, the St. Paul contractor who acted as the contact man for the Bremer family in the kidnap negotiations, recalled that the kidnapers had signaled him from the roadside with red flashlights. On their signal, he threw \$200,000 into the dust for them and departed.

On the flashlights were the fingerprints of Alvin Karpis, now Public Enemy No. 1. On the gasoline can was the thumb print of Arthur R. (Doc) Barker, a co-leader with Karpis.

### GIRL IDENTIFIES KARPIS

In St. Paul a shy sales girl engaged to a choir singer identified photographs of Karpis as the purchaser of the flashlights.

With this information, the G-Men went to work, and through the months that followed they erected a pyramid of facts which incriminated 22 persons for alleged activities in the kidnaping of Bremer, harboring the actual kidnapers, and in the exchange of the ransom money for other money.

The Government's score in the Bremer case thus far is:

- Eight persons convicted of kidnaping or of conspiracy.
- Three gangsters pleaded guilty.
- Three mobsters killed resisting arrest.

- One accomplice returned to prison on another charge.

- Another kidnaper killed by his own gang to keep him from "squawking."

- Two awaiting trial.

- Four others still being sought.

The most recent arrest in the case was that of Cassius M. McDonald, 50 years old, who was taken into custody here Thursday night in his fashionable \$50,000 home at 500 Trombley road, Grosse Pointe Park.

### A COLLEGE GRADUATE

McDonald, a striking contrast to other suspects in the case in his manner of living and background, a college graduate and son of a wealthy race track owner, is charged with harboring Karpis and arranging for the transfer of \$72,000 of the ransom money.

While he waits in the County Jail for his hearing Oct. 8 before U. S. Commissioner J. Stanley Hurd, a hearing which will determine whether he will be returned to St. Paul for trial, McDonald tells an interesting story of his life.

McDonald's is the autobiography of an heir to a fortune of \$1,300,000 who was nurtured in luxury, who knew his father as once the employer of Samuel Insull; of a college lad who worked his way up in his father's lumbering companies, traction interests, and race tracks, who was a Government aircraft official during the war, and who went through the Cuban Revolution to win the lucrative Havana race track concession from the Cuban government.

### G-MEN ARE SILENT

"I don't know anything about Karpis or the kidnaping money," McDonald says.

The Department of Justice agents are silent. They merely say "wait

**DR. JOSEPH P. MORAN**, Chicago physician, who is accused of trying to obliterate the fingerprints of Karpis and the late Freddie Barker.

**WILLIS HARRISON**, former tavern keeper of Hammond, Ind., accused of harboring the mob after the kidnaping.

Bremer was kidnaped the morning of Jan. 17 a few minutes after he had driven his 8-year-old daughter Betty to school. As he stopped at a highway for a moment as a cautious driver, someone opened the left door of his car and pointed a revolver at him.

"Don't move or I'll kill you!" the kidnaper said.

### AN ANONYMOUS CALL

Bremer tried to get out of the car. He was hit over the head with a blackjack. He kept on struggling. But the loss of blood made him weak and dizzy. He gave in. They put adhesive tape over his eyes, and goggles over the adhesive tape. They transferred him to another machine. Then the kidnap car disappeared.

Two hours later, Magee received an anonymous telephone call:

"Well, we've got your friend Bremer and if you are not careful, we'll get you, too."

The kidnapers had a wealthy victim.

Bremer was the son of Adolph Bremer, the majority owner of the Jacob Schmidt Brewing Co. Adolph Bremer was a friend of President Roosevelt.

Otto Bremer, an uncle, was chairman of the board of the American National Bank and head of the Minnesota Home Owners Loan Corp. Otto and Adolph Bremer were prominent Democrats.

Edward Bremer was president of the Commercial State Bank of St. Paul, prominent in Democratic political circles, and a millionaire at 37.

### FINGERPRINTS TELL

Five times the kidnapers entered negotiations with Magee, until the ransom finally was paid. Then the Department of Justice took charge of the case. The fingerprints on the flashlights and on the gasoline can told them the Karpis-Barker mob had engineered the kidnaping.

The mob was well known to the police and feared in the underworld. The gang had operated in Missouri, Kansas and Oklahoma. It had collected loot of \$1,000,000 in a long series of killings, bank raids, and kidnapings. It was charged with having perpetrated a previous St. Paul kidnaping, that of William Hamm, another brewer. Hamm was

kidnaped as the kidnaping case was reconstructed by the Government and through confessions Bremer was taken captive by Karpis and Karpis.

Wilson, a former Northwestern University medical student, likewise went to jail. He was charged with having taken Karpis and Doc Barker to a physician for an operation to change their fingerprints.

Petite Wyona Burdette, former radio singer, is serving five years in prison for having kept Karpis in hiding.

Another young woman, Rabbits Murray, was sent to prison for having been in Doc Barker's company, and Slim Gibson, a Chicago hoodlum, who had acted as a guard for the ransom money until its division, was shot to death in his Chicago rooming house by Department of Justice agents.

Gangsters, gamblers, politicians; gangsters' molls and gangsters' friends have been caught in the Bremer net.

"We are going to get them all," J. Edgar Hoover, head of the Department of Justice, said. "We are going to make kidnaping something to be avoided in the underworld."

From the Government's score in the case, it is something to be avoided.

## CONVICTS TO FIGURE IN KIDNAP TRIAL OF 4

Farmer and Alderton Will Face

Elmer Farmer and Harold Alderton, convicted of conspiracy in the kidnaping of Edward G. Arraignment and trial of Weaver, Sawyer, and the Eaton woman are slated for the opening of the term of Federal court here November 5. The government will attempt to bring McDonald to St. Paul for trial at the same time, it was reported. A removal hearing for McDonald has been set for October 8 at Detroit.

## Gas and Guns Rout Chicago Outlaw Band

**Women Among Victims  
of Battle; Guard Near  
Death; Policeman Saves  
Car From Fugitives**

Chicago, Ill.—(AP)—Four men and a woman were wounded, two critically, when seven gunmen were driven off by tear gas in an attempted robbery Monday at the University State bank on the south side.

Seriously injured were William Fleming, 58, bank guard, who was shot twice in the chest, and Mrs. Dorothy Gregory, 29, a bank customer, in whose spine a bullet lodged after striking her in the right hip.

Thorne Deuel, 45, a University of Chicago professor, and Carl Ruether, 40, a paper manufacturer, both bystanders, were shot in the right ankle and leg. When a police sergeant attempted to flag down the fleeing gunmen about six miles from the bank they exchanged shots with him, wounding Chester White, 23, negro.

### Had Scar Like Karpis

Led by a man who police said bore a scar on his right cheek and might have been Alvin Karpis, "public enemy No. 1," said to have a similar disfigurement, three of the gunmen invaded the bank while four others waited outside.

Miss Astrid Olson, a teller, stepped on a tear gas release and Fleming reached for his pistol as the men entered. Fleming, shot in the first volley, continued to exchange shots with the gunmen. The three customers fell wounded.

Blinded by the tear gas, the gunmen fled. Six miles northwest of the bank they forced to the curb an automobile driven by Police Sgt. Maurice Flynn, who said their car was accompanied by a second automobile bearing Texas license plates, in which a woman and a small boy rode.

### Open Fire on Policeman

Flynn drew his revolver and the gunmen fled. He chased them and they opened fire. He returned the shots and White, a bystander, was wounded. The gunmen distanced Flynn, who returned and took White to a hospital. Flynn's car was riddled with 20 bullet holes.

Police at first believed "Midget" Fernekes, desperado who recently escaped from the Illinois state prison at Joliet, might have led the raid, but named Karpis as a more likely suspect when they obtained a description of the leader from witnesses.

# **KARPIS' GANG SHOOTS FIVE**

CHICAGO, Sept. 30 (By International News Service).—A bank policeman and four other persons, including a woman, were wounded today in a typical Wild West gun battle following an attempted robbery of the University State Bank by a gang believed to have been led by Alvin Karpis, hunted kidnaper and Public Enemy No. 1.

The seven gunmen opened fire with three machine guns on police squads while escaping. Teaser gas was used by police.

A description given by one of the bank employes of the leader, a foot 8 inches tall, 140 pounds, about 35, with a scar over the right eye, fits generally with the description of Karpis.

# FOUR WOUNDED IN BANK HOLDUP

Gang Believed to Be Led by  
Karpis Routed in Chicago.

CHICAGO, Sept. 30 (U. P.).—A gang of bank robbers believed to have been led by Alvin Karpis, public enemy No. 1 were frustrated by tear gas and bullets today when they attempted to rob the University State Bank. Four bank employees, including two women, were wounded.

The general description of the leader of the gang answered that of Karpis. He had a scar on one cheek and the bravado that characterizes Karpis. The gang was armed with three machine guns and shotguns.

As six gangsters entered the bank a clerk stepped on a button which released a flood of tear gas. William Fleming, bank guard, simultaneously engaged the sextet in a gun duel.

Fleming was struck beneath the heart and may die. Two women and a man were less seriously wounded.

The gang retreated empty handed and leaped into their cars. One contained a woman.

A short time later the two machines drove a police car into the curb. Two of the gang leaped out, apparently intending to steal Flynn's car, but he fired at them and they fled. The policeman gave chase for several miles, and in the exchange of shots an unidentified negro was hit in the leg.

Police squads were notified and immediately bottled up the main roads.

Department of Justice agents were expected to join the manhunt.

Karpis is wanted by Federal agents as the leader in the Edward G. Bremer and William Hamm kidnappings at St. Paul, Minn., with which he has been identified by other participants who confessed.

He also is charged with many murders, including those of John Lazia, Kansas City politician; A. W. Dunlap, father-in-law of his one time pal in crime, Fred Barker, serving a life term for the Bremer kidnaping, and C. R. Dunlap, West Plains, Mo., sheriff.

Karpis also was an occasional member of the Dillinger gang, and is believed to have been in the gang when Agent W. Carter Baum was slain in the battle at Little Bohemia, Wis.

Harry Campbell, probably Public Enemy No. 2, always has been at Karpis's side in recent years and was with him in their gun fight at Atlantic City, N. J., last January when the two shot their way from a police trap and fled.

Woman Teller Who Steps on  
Tear Gas Release Foils  
Chicago Holdup.

Chicago, Sept. 30.—(P)—Four men and a woman were wounded, two critically, when seven gunmen were driven off by tear gas in an attempted robbery today at the University State bank on the South Side.

Seriously injured were William Fleming, 58 years old, bank guard, who was shot twice in the chest, and Mrs. Dorothy Gregory, 29, a bank customer, in whose spine a bullet lodged after striking her in the right hip.

Thorne Deuel, 45, a University of Chicago research department professor, and Carl Ruether, 40, a paper manufacturer, both bystanders, were shot in the right ankle and leg. When a police sergeant attempted to flag down the fleeing gunmen about six miles from the bank they exchanged shots with him, wounding Chester White, 23, a Negro.

### May Have Been Karpis.

Led by a man who police said bore a scar on his right cheek and might have been Alvin Karpis, public enemy No. 1, said to have a similar disfigurement, three of the gunmen invaded the bank while four others waited outside.

Miss Astrid Olson, a teller, stepped on a tear gas release and Fleming reached for his pistol. Fleming, shot in the first volley, continued to exchange shots with the gunmen. The three customers fell wounded.

Blinded by the tear gas, the gunmen fled. Six miles northwest of the bank they curbed the car of Police Sergeant Maurice Flynn, who said their car was accompanied by a second automobile, bearing Texas license plates, in which a woman and a small boy rode.

### Escape After Volley.

Flynn drew his revolver and the gunmen fled. He chased them and they opened fire. He returned the shots and White, a bystander, was wounded. The gunmen distanced Flynn, who returned and took White to a hospital.

Flynn's car was riddled with twenty bullet holes.

'Midget' Fernekes Also  
Identified as Being  
In Bank Holdup

CHICAGO, Sept. 30 (I.N.S.).  
A bank policeman and four other  
persons were wounded today in a  
typical wild west gun battle after  
an attempted robbery of the  
University State Bank by a gang  
believed to have been led by Alvin  
Karpis, hunted kidnaper and  
public enemy No. 1.

The murderous audacity of the  
seven gunmen, who opened fire  
with three machine guns on  
police squads while escaping, con-  
vinced authorities that the raid  
was staged by a well-organized,  
daring band of robbers.

## Karpis Believed Leader

A description given by one of  
the bank employes of the leader,  
5 feet 8 inches tall, 140 pounds,  
about 35, with a scar over the  
right eye fits generally with the  
description of Karpis.

At the same time police specu-  
lated whether the attempted rob-  
bery represented the blow they  
have expected from Henry J.  
'Midget' Fernekes, desperate

Tear gas routed the robbers

Later, during the pursuit of the  
men by Sergt. Maurice Flynn,  
Chester White, 23, colored, was  
shot in the right leg.

## Gunmen Invade Bank

The opening of the drama of  
gunfire occurred when two auto-  
mobiles carrying seven men, and  
bristling with machine guns,  
stopped on a street just south of  
the bank, near the University of  
Chicago campus.

Four men took posts as guards  
and look-outs outside as three  
men, two carrying machine guns,  
dashed into the bank behind the  
leader, a man wearing a leather  
jacket and dark glasses. Police  
recalled that Fernekes always wore  
a leather jacket and dark glasses  
on his bank raids and that he wore  
dark glasses when he calmly  
walked out of prison a month ago.  
As the men rushed into the  
bank, the leader shouted:

"This is a stickup! Hands up  
everybody!"

Fleming, taken by surprise,  
reached for his gun. Several em-  
ployes, including Miss Astrid Ol-  
son, a teller; William Sutherland,  
Edward Gibbons, and A. M. Frale,  
simultaneously stepped on but-  
tons releasing tear gas.

## Robbers Flee

In an instant the bank was the  
scene of pandemonium and flying  
bullets, the roar of machine guns  
and pistols and blinding gas.

Fleming was struck by two bul-  
lets in the volley, each going into  
his chest without touching any  
vital organs.

Police squads were notified of the robbery and immediately bottled up the main roads in an effort to trap the gangster believed to be Karpis. Department of Justice agents were expected to join the manhunt.

The possibility that Alvin Karpis, public enemy No. 1, might have been a member of the gang was discussed by police but D. M. Ladd, Chicago chief of the Bureau of Investigation, Department of Justice, said a description furnished him was not that of Karpis.

At the same time Miss Astrid Olson, a teller, and other employes stepped on tear gas releases, filling the bank with blinding fumes.

A few minutes later, six miles northwest of the robbery scene, the gunmen, accompanied by a woman and either a boy or a small man riding in a second car, tried to curl the auto of Sergt Maurice Flynn of the South Parks police.

In the exchange of shots which followed Chester White, 23, a Negro

State, Federal Officers Attend Burial of 'Ma' and Her Son Fred.

## Domestic Weapons Replace Revolvers and Sub-Machine Guns for Friends of Gangsters

MILAN, Mich., Oct. 3 (AP)—Mops and brooms have replaced revolvers and submachine guns in the hands of a group of "gun molls" who roamed over the country a few months ago with gangs of criminals.

Behind the brick walls of the new federal detention prison here are the erstwhile girl friends of some of the nation's most notorious desperadoes, many of whom have come to grief in their encounters with the law.

Among the inmates are Evelyn Frechette, companion of the late John Dillinger; Kathryn Kelly, wife of George (Machine Gun) Kelly; Winona Burdette, 21-year-old radio entertainer who became the consort of Alvin Karpis, current public enemy No. 1, and Dolores Delaney, 22, companion of Harry Campbell, one of the Karpis mob.

Little word from the outside world reaches the isolated prison, and little comes out. Most of the barred windows of the quadrangular prison look out over 2,000 acres of bleak farm land, but from one side the housetops of the sleepy little village of Milan can be seen.

The Burdette and Delaney women, captured when Karpis and Campbell shot their way out of a police trap in Atlantic City last January, were brought here secretly April 1 from Miami, Fla., where they had been sentenced to serve five years for harboring Karpis.

Supt. John J. Ryan, former school teacher who became a penologist 28 years ago, said he would not announce to what duties they would be assigned, except that they would be subjected to the usual discipline of the prison.

The prison was built in 1933 at a cost of \$360,000, and is constructed around a hollow square. The cell blocks are light and well ventilated.

Ryan's objective is to restore his prisoners to a useful place in society, and he tries to keep them busy in the fields as much as the weather permits.

"A little fresh air will often do more than a lot of preaching," he once remarked.

The strong walls and intricate machinery of the prison do not encourage the gun molls to dream of freedom. The place is considered escape proof.

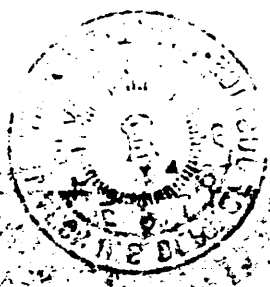

Close friend and associate of Campbell, rated as public enemy No. 2, Carpenter was found in the home of Bert Daugherty, brother of the late Jess Daugherty, slain bank bandit, at 8 o'clock this morning.

**Gun Near His Bed.**

A force led by Sheriff Paul Liles, Anderson and Capt. Hugh Edwards of the Kansas patrol overpowered Carpenter before he could reach a shotgun loaded with buckshot, which he had kept near the head of his bed.

At the Newton county jail here, Carpenter signed a waiver, officers said, to return voluntarily to Sedan, Kan., to face three robbery charges in which Campbell is alleged to have participated in 1932.

Carpenter declined to discuss his association with Campbell, but Anderson, who has been working on the case for months, said he is virtually certain that Carpenter had been with Campbell, and possibly with Alvin Karpis, public enemy No. 1, within the last four months.

The investigators said they believe Campbell and possibly Karpis have been in the vicinity of Neosho in recent months.

Reared on a farm near Berryville, Ark., where his parents still live, Carpenter had been "hanging out" principally in Tulsa and at Coffeyville, Kan., Anderson said. He told Anderson he came here last night by freight train from Tulsa.

Satisfied that Daugherty had no connection with the gang, but merely had taken Carpenter in for the night, officers did not arrest him in the raid. He is employed at a condensed milk plant here.

**Wanted in Kansas Robberies.**

Anderson and Captain Edwards said Carpenter is wanted on warrants at Sedan for participating in the robbery of a jewelry store, a clothing store and a drug store, and the kidnaping of a night watchman. Campbell, Glen Leroy Wright, Jimmy Lawson, Melton Brooks and the late Gene Johnson also were alleged to have participated in the Sedan robberies.

The Kansas troopers also said that Carpenter is wanted on a charge of robbing the Union Gas Company at Coffeyville; the gas company at Hutchinson, Kan.; rob-

Anderson said Carpenter is not accused of having been with the gang when it staged the spectacular R & S Motor Sales Company robbery in Joplin in 1932.

Of the gang members, only Campbell now is at liberty. Johnson was slain, Lawson and Wright are serving penitentiary sentences and Brooks is awaiting trial at Sedan.

Other officers who assisted in the arrest this morning were Night Officers Sam Smalley and Tom Cunningham of Neosho and Trooper George Kahler of the Missouri highway patrol.

**Mother Visits Him.**

At Carpenter's request, Sheriff Liles brought his mother here from Berryville this morning to visit him. She said she had not seen her son in many months.

Reports reached the county jail here this morning that Carpenter was Campbell. Told of the reports, his mother said with emphasis: "I can tell you his name isn't Campbell; it's Carpenter, and he's my son." Officers said he does not resemble photographs of either of the latter two criminals.

Carpenter was fingerprinted at the jail. Officers said he probably would be returned to Sedan late today.

Tulsa, Okla., Oct. 5.—(P)—Tommy Carpenter, arrested at Neosho, Mo., today, is a Tulsa taxicab driver and associate of Alvin Karpis and Harry Campbell, notorious outlaws, Police Captain Bill Bassham said today.

The fugitive pair and Carpenter often were together during the days when Karpis and Campbell made Tulsa their headquarters, Bassham said.





## Campbell's 'Pal' Nabbed for Theft

Neosho, Mo. —(U.P.)— Thomas L. Carpenter, described by officers as a pal of Harry Campbell, public enemy No. 2, was en route to Sedan, Kas., Saturday to face robbery charges there.

He was captured shortly after midnight at the home of Bert Daugherty, a friend with whom he was spending the night after coming here from Tulsa, Okla.

Officers received a tip that Carpenter was in the Daugherty home, waited until he was asleep and raided the house, capturing him without resistance. Daugherty was not implicated.

NEOSHO, Mo., October 5.—A prisoner arrested here early today and reported by officers to be Harry Campbell, public enemy No. 2 and a pal of Alvin Karpis, later was said by Deputy Sheriff John Brock to have been definitely identified as Thomas L. Carpenter, an alleged associate of Campbell.

Carpenter is wanted in Kansas on charges of robbing three stores at Sedan and mistreating a night watchman. He also is wanted in connection with robberies at Coffeyville and Hutchinson.

After a careful check of identification records, all officers who participated in the capture, including J. W. Anderson, Kansas highway patrolmen, agreed the prisoner was Carpenter and not Campbell, who is wanted for the Edward G. Bremer kidnaping in St. Paul.

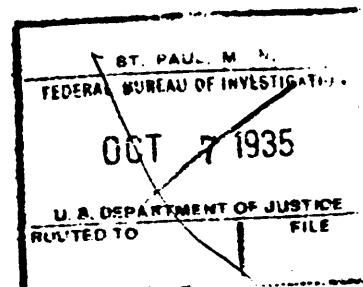

## Bruno Austin Is Given 'Life'

### Chicago Bridegroom and Three Pals Sentenced for Hold-Up Killing

Chicago, Ill.—U.S.—Found guilty of murder, Bruno Austin, 23, who was arrested first in January at his church wedding, and three companions Saturday were under sentence of life imprisonment.

A criminal court jury returned a guilty verdict after six hours' deliberation. Motion for a new trial will be argued Oct. 25.

Austin's 19-year-old bride, Marie, was not in court when he was sentenced although each time he was arrested since their marriage she pledged her undying loyalty. The last time police found him hiding in the home of another woman.

Co-defendants charged with the murder of Anthony Benidetto, 51, in a grocery hold-up July 15 were David Sinnenberg, 18; Maurice Jacob, 21, and Alex Shapiro, 21.

At the time of his wedding Austin was arrested as an automobile thief. He was freed two months later and in May was tried and acquitted in federal court at St. Paul for the kidnaping of Edward G. Bremer. He was arrested several times later on minor charges, but released each time until the murder charge was placed against him.

## Gets Life Term

## BREMER SUSPECT GETS LIFE IN KILLING

Austin, 'Bridegroom Prisoner,'  
One of 4 Convicted in Fatal  
Illinois Robbery.

Bruno (Whitey) Austin, 26-year-old "bridegroom prisoner" freed in St. Paul as a defendant in the Bremer kidnaping case, was convicted of murder last night by a jury in Chicago, the Associated Press reported today.

Convicted with him were three confederates, Dave Sinnenberg, 18 years old, and Maurice Jacobs and Alex Shapiro, each 21. The jury which heard the case fixed the penalty of all four as life imprisonment. The Associated Press reported that the jury returned its verdict after deliberating six and one-half hours.

The four were accused of slaying Antonio Benedetto while robbing a grocery store last July 15 in Maywood, a Chicago suburb. All admitted the robbery, but each denied firing the fatal shot.

Austin received his nickname of "bridegroom prisoner" when he was arrested on a robbery charge last January 20 as he left Holy Trinity cathedral after being married in an elaborate ceremony. He was acquitted of that charge March 22 but held in custody as a defendant in the \$200,000 kidnaping of Edward G. Bremer, St. Paul banker.

When the other kidnaping defendants were put on trial here last spring, Austin was brought here and held in the county jail. He was not taken into court, however, and the indictment against him was nolle at the end of the trial.

He then was returned to Chicago, where he still was facing such charges as bond forfeiture and automobile larceny. He has been at liberty only a few days since his wedding—and in those few days he took part in the grocery store robbery which resulted in the murder conviction last night.
