This man, whose identity has not been revealed, is sought on a "John Doe" warrant issued by Assistant United States District Attorney Frank Weideman at Cleveland. The man is believed to be with Harry Campbell, Karpis' first lieutenant.

Meanwhile Federal authorities released three persons held in Warren for questioning on the activities of the Karpis gang. They were Albert and George Hunter. brother and father respectively, of Fred Hunter, captured with Alvin Karpis Friday night in New Orleans, and Mary Yoho. Police indicated no charge would be filed against the three.

Relentless questioning by grim Department of Justice officials in St. Paul, Minn., left Karpis pale and shaking today and facing arraignment on a charge of kidnaping William Hamm Jr.

ALVINKARPIS DUE TO MAKE **GUILTY PLEA**

Will Be Arraigned Tomorrow in Hamm Kidnaping Case

ST. PAUL, May 4. (I.N.S.) -A cowed and cringing Alvin Karpis is expected to plead guilty tomor-

row when arrainged on charges of conspiracy in the \$100,000 ransom kidnaping of William Hamm, jr., wealthy St. Paul brewer.

All his swagger and bravado gone, Karpis was locked up in the Ramsey County jail today after a severe 48 hour grilling by Federal agents.

The thoroughly tamed badman talked freely, it was learned, concerning the bank robberies, mail robberies, kidnapings and murders with which he is charged.

As a result, it was learned, a sensational roundup of followers of the Karpis-Barker gang is in the offing and it will include prominent politicians and police executives. executives.

Karpis was particularly questioned, it was learned concerning "leaks" during the investigation of the Hamm abduction and the \$200,000 ransom kidnaping of Edward G. Bremer, St. Paul banker. Federal men were constantly balked in their investigations, it was learned, because of information as to their movements related to the kidnapers.

One official said Karpis, who dropped his bravado with alacrity when he looked down the muzzles of Federal men's shotguns in New Orleans Saturday, told his captors he was "glad it was over," that he was "tired" of being constantly hunted.

HOOVER HITS LACK OF AID FOR G-MEN

"Rotten" Co-operation Held Rule in Some Places in Middle West.

By the Associated Press.

NEW YORK, May 4.—J. Edgar Boover, here after delivering Alvin Karpis to St. Paul authorities for prosecution on kidnaping charges, said today that co-operation with his men in some Middle West communities is "rotten."

"Corruption or inefficiency among police authorities is the cause of notorious lack of co-operation with the department in many communities," declared the director of the Justice Department's Bureau of Infectionalism.

"It is rotten in some places. I won't name them. But they are in the Middle West. Nationally—in general—co-operation is excellent. We will co-operate with officials anywhere there is not a lot of politics, crookedness of the officials are publicity crazy."

Planned Raid.

Hoover disclosed that he was preparing to lead personally an armed assault on the front entrance of the gangster's New Orleans apartment when the desperado appeared Friday night with two companions and was

Hoover said other groups of agents and been posted to guard three other exits to the building. The Hoover party was driving a half block past the structure preparatory to returning on foot for the frontal attack, to be prefaced by a surrender demand and gas bombs.

"We'd have killed him if he'd tried to shoot it out, but he didn't get a chance," Hoover said.

Hoover expressed regret that word of Karpis' personal threat against his life had ever gone out of the department, because "all enforcement officials get threats and pay no attention to them."

He declined to say whether he intended his raid leadership as a reply to the desperado's boastings. Hoover said the raid in New Or

Hoover said the raid in New Orleans, conducted in a district of heavy late afternoon traffic, would certainly have resulted in deaths had agent peen forced to atorm the dwelling as they expected. But they dared not wait because Karpis "was quick on the move," he eaid. Mr. Nathan

Karpis Inquiry On Kidnapings

Public Enemy No. 1. May Be Arraigned Today in Hamm Case.

By the Associated Press.

St. Paul, Minn., May 3.-A secret interrogation of Alvin Karpis, "Public Enemy No. 1," was continued today by Federal agents determined to draw from the gangster's own lips a list of those who aided his twoyear flight from the law.

A heavy guard barred the Federal court building doors behind which Karpis was hustled after being flown here from New Orleans to enswer kidnaping charges.

The department's determination to make a decisive mop-up of the Kar-pis-Barker mob's camp followers was announced by J. Edgar Hoover, investigation bureau chief. Before leaving for New York he predicted

eaving for New York he predicted arrest of some Karpis friends.

How soon the captured public enemy would be turned over to the United States marshal for arraignment was still undetermined, although Hoover had said arraignment on the William Hamm, jr., kidment of the William Hamm, jr., kidment on the William Ha

naping case might be tomorrow.

Karpis was questioned in the Department of Justice office, where other members of his notorious gang previously had faced their captors, some to talk and others to be shunted along to Alcatraz prison for

of more than two score persons originally indicted in connection with the kidnapings of Hamm and Edward G. Bremer, members of two of the wealthiest families in the Northwest, only one man remains free—Harry Campbell, lame outlaw last seen with Karpis in Atlantic City.

In addition to the kidnapings, which he is alleged to have engineered, the Federal agents questioned Karpis on more than a dozen spectacular bank robberies, several daring mail robberies, and a number of killings.

Missouri officials attempted to have the mobster taken to Wast Plains, Mo., to stand trial for the killing of Sheriff C. R. Kelley on December 19, 1931. They pointed out that Karpis could be executed on this first-degree murder charge, but would escape with a life term at most for either the Bremer or Hamm kidnapings. Hamm kidnapings,

KILLER KARPIS, Public Enemy No. 1, having been taken alive without a shot, William Mahan, the Weyerhauser kidnaper, assumes the uneasy crown of his successor.

The Karpis capture sheds new luster on the Justice Department's capable agents, known as the G-Men. One after another the big shots of America's gangdom have crumpled under their unrelenting drive. Seldom has this country seen such efficiency as J. Edgar Hoover's Federal policemen are displaying. All will join in wishing more power to their good right arms.

This sensational record for crime detection only emphasizes more glaringly the weaknesses in our law-enforcement system that make much of their work futile. We refer particularly to our medieval reformatories and prisons where young men are schooled in crime, to the misuse of the "unwalled prisons" of probation and parole, to the social sink-holes where the seeds of lawlessness spawn.

Karpis was an alumnus of both a high school and college of crime. At 16 he was sentenced to 10 years in a reformatory for stealing auto tires. There he is said to have learned safe-cracking and the other arts of his craft. In Kansas State Penitentiary he was tutored by one of the criminal sons of "Ma" Kate Barker, specialist in robbery, kidnaping and murder.

It was after he was paroled, however, that he made his reputation. Facing a four-year sentence in 1931 for burglary, he was paroled by a kindly, but misguided Oklahoma judge. A month later he had committed a murder and was well along on his career as bank robber, kidnaper and killer.

Karpis, it happened, was not a child of the American city slums, but most of his fraternity are—and with them he fraternized.

No program of crime suppression will succeed that does not deal with the things that go with extreme poverty—malnour-ishment, illiteracy, child neglect, the hovels and tenements that millions of families must call homes. It is an amazing paradox that the Federal arm may reach unhindered into states and cities, there to detect and capture criminals, but when this same Federal arm seeks to improve those social conditions in states and cities that grow the seeds of crime it is estopped by the courts as an unconstitutional invasion of states rights.

EXPERT MAN-HUNTERS

THE long, crooked trail has practically ended for ALVIN KARPIS. Gratification over the capture of one of the last and worst of the gangsters who were so dangerously active and so plentiful a few years ago, must be mingled with approval for the federal agents. The gangster and his associates, knowing of other captures and slayings and knowing how determined the officers were to make the capture of the biggest rat still moving around, were very careful. Under all the circumstances, it is remarkable that the federal agents were able to move across the country on a call from New Orleans and to accomplish the job without bloodshed. It is remarkable there was not a "leak" somewhere.

Three years ago the criminal tide was running high. There seemed to be little prospect of subduing the kidnapers, murderers and bank robbers, all of whom had many protectors and many advantages. The formidable protection of gangsters has been effectually broken down. Kidnaping has been made so hazardous that it is rarely attempted now. Crime of the smaller sorts may be on the increase, but the major crimes, wherever and whenever they come within the purview of the G-men, are usually solved. It is not, of course, done by superhuman cunning or by luck or magic; it is done through the use of common sense, enormous industry and the use of scientific methods. It costs a great deal of money, but the country is highly pleased; it is spending which brings results. Had this country remained the criminals' bonanza it appeared to be in 1933, it would probably have reached anarchy by this time. The modern man-hunters of the better type are doing admirable work for all of us. The capture of Karpis was a particularly fine and important piece of work. Mr. Nation

Close on the heels of Director Hoover's successful fight for the restoration of \$225,000 in the appropriation bill for the bareau of investigation came the perfunctory, overly-modest announcement of the capture of Alvin Karpis, successor to the late John Dillinger and "Baby Face" Nelson as are public nemy.

I IS APARTMENT HOUSE NEIGHBORS in New Orleans knew him as a mild, pleasant man, interested in fishing.

But a score of G-men from as many angles drew beads on this mildest mannered man that ever slit a throat or scuttled a ship—and Alvin Karpis, Public Enemy No. 1, found himself in the toils of the law. It was the undramatic end of a major crime career.

It was a job well done. It was a better job than that which marked the end of Dillinger. Karpis was taken alive. Not a shot was fired. In the eyes of gangsterdom Karpis is no hero. If he dies at the hand of the law he will die the ignominous death of a criminal.

Reports in New Orleans indicated that Ruth had "talked" to the Federal men Sunday, according to Associated Press dispatches from

that city.

The slim, modishly dressed woman was questioned by Federal agents there for two days and two nights, according to the stories. Following the grilling, the droning voice of an agent, punctuated by short remarks from the woman, could be heard by reporters in the hall.

This was taken to mean that the woman had dictated a statement to the Federal officers, and that it was being read back to her for Trying Karpis in Missouri for the

murder of Sheriff Roy C. Kelly in December, 1931, would open the way to give the death penalty even though he were convicted of the kidnaping charges in Federal court. Federal Power Cleans Up Arrogant Criminal Gangs

HIS APARTMENT HOUSE NEIGHBORS in New Orleans knew him as a mild, pleasant man, interested in fishing.

But a score of G-men from as many angles drew beads on this mildest mannered man that ever slit a throat or scuttled a ship—and Alvin Karpis, Public Enemy No. 1, found himself in the toils of the law. It was the undramatic end of a major crime career.

It was a job well done. It was a better job than that which marked the end of Dillinger. Karpis was taken alive. Not a shot was fired. In the eyes of gangsterdom Karpis is no hero. If he dies at the hand of the law he will die the ignominous death of a criminal.

Karpis, "Old Creepy" to the underworld, was captured after a three-year hunt. He is the last of the Karpis-Barker gang of bank robbers, kidnapers and murderers. His capture followed the relentless course of the Federal Bureau of Investigation, which since June, 1932, has broken up fifty-two major kidnaping gangs and convected 136 of the snatchers.

No State or local police organization could possibly do this job. The big-time criminals operate on an interstate basis. Only a centralized organization unhampered by jurisdictional lines and backed with the resources of the Federal Government could do what J. Edgar Hoover's men have done. And they are keeping everlastingly at it.

The record affords full justification for the Cummings laws giving the Federal Government police power in major interstate crimes, including bank robberies and kidnaping.

RELAYS OF G-MEN KEEP QUIZZING "ENEMY NO. 1"

Alvin Karpis is talking, activities at the St. Paul office of the Gmen indicated today. Relays of federal agents con-

tinued questioning Public Enemy No. 1, 48 hours after he was brought here by airplane from New Orleans. The agents refused to say whether Karpis had any rest, but added

"we haven't caught up on sleep." As the ceaseless grilling went on, agents made a series of telephone calls to various parts of the country.

Teletype messages were sent out and received continuously on the system that connects federal bureau of investigation offices throughout the nation, and a machine that appeared to be a portable teletype set for field work was brought to the St. Paul office by an agent and an operator.

*ROTTEN CO-OPERATION." Meanwhile, J. Edgar Hoover, chief of the federal bureau of investigation, charged in New York that coeperation of municipal law enforcement authorities with his men in some Midwest cities is "rotten." He declined to name the cities.

"Corruption or inefficiency among police authorities," he told the Associated Press, "is the cause of notorious lack of co-operation with the department in many anomal munities.

"It is rotten in some places. I won't name them. But they are in the Midwest. Nationally—in general—co-operation is excellent. We will co-operate with officials anywhere there is not a lot of politics and crookedness or where the officials are publicity crazy."

Karpis was caught Friday by federal agents in New Orleans and brought here to face charges of kidnaping William Hamm. St. Paul brewer, and Edward G. Bremer, St. Paul banker, for a total of \$300,000 ransom.

ransom.

The erstwhile "bad man" is re-ported to have confessed and is said to be talking freely of his crimes

and associates. George F. Sullivan, United States district attorney, asserted he has an air-tight case against Karpis and is not interested in whether he pleads guilty or confesses.

TO TRY HAMM CASE.

"It makes no material difference whether Karpis pleads guilty or not," Sullivan said. "We will have to try the Hamm case anyway in the fall and one more defendant more

fall and one more defendant more or less will not matter."

Others facing trial next autumn in the Hamm case are John P. Peifer. St. Paul night club proprietor; Edward Bartholmey, Bensenville, Ill., postmaster, who owned the house where Hamm allegedly was held, and Charles J. Fitzgerald of Los Angeles, alleged to be one

of the ctual kidnapers. All are charged with conspiracy.

The capture of Karpis may bring freedom to Leonard Hankins, now serving a life term in Stillwater prison for complicity in the Tviry Northwestern National bank holdup in Minneapolis. in Minneapolis.

BELIEVED INNOCENT.

Melvin C. Passolt, superintendent of the Minnesota bureau of criminal apprehension, announced today he had submitted a report to the state pardon board expressed the belief that Hankins was innocent of that crime.

Some of the gang are dead and some in prison. Devol, serving a life term in Stillwater, was reported today to have been transferred to the St. Peter state asylum under

the St. Peter state asylum under heavy guard as the result of having become "tin cazy."

Andrew Crummy, chief investigator for the Hennepin county attorney's office, attempted this morning to have the bank robbery witnesses view Karpis, but federal agents said they were not through questioning the desperado and deferred the show-up. Passolt said he intends to ask an interview with Karpis. Karpis.

NEW PICTURES TAKEN.

New Bertillon pictures were taken of Karpis in a pause between questions. He was quizzed concerning the crimes of kidnaping, murder, robbery and jailbreak, of which he is accused.

One phase of the grilling dealt with his activities in Toledo, Ohio, where he reputedly established headquarters for a time after the Bremer ransom had been paid.

Bremer appeared at the federal building for a brief interview with Clinton W. Stein, chief of the St. Paul office of the federal bureau of investigation, but he declined to re-peat the conversation.

Jokingly, he said, "I came down to see how much of my ransom money I could get back from Kar-

money I could get back from Karpis." (The desperado charged \$200,000 for Bremer's release.)
"He only had \$80 when he was
arrested," reporters told the banker.
"That's not even enough to throw
a party, is it," Bremer replied.

PALS ALSO QUIZZED.

While the pumping of Karpis progressed in St. Paul, other agents in New Orleans questioned Fred Hunter, mail robbery suspect, and red-haired Ruth Robinson, 21 years old, who were arrested with the gang leader in New Orleans.

The Associated Press reported that a federal agent was heard to tell Hunter:

Hunter:

"Now we'll boil down all these facts into a concise statement which you will sign." Hunter did not reply.

The agent's remark came on one of Hunter's trips through the corridor of the federal building where he was being questioned.

The "facts" were interpreted to mean that Hunter had "talked" fixely, after morethan 48 hours questioning. questioning.

CAPTURE OF KARPIS.

Society's open account against major crime and dangerous criminals was brought nearer to a proper balance Friday night when Federal Bureau of Investigation men under leadership of their chief, J. Edgar Hoover, arrested Alvin Karpis, notorious outlaw, in New Orleans. This man, the current "Public Enemy No. 1," is wanted in many places on charges of murder, kidnaping and robbery, being the ace quarry sought by federal officers since Dillinger and "Baby Face" Nelson, in their time No. 1 enemies, were slain.

Karpis-his real name is Raymond Karpaviozwas born in Canada, though he grew up and started his career of petty crime in Kansas. Suspected as a participant in four murders, two kidnapings and numerous robberies large and small, he drew the attention of the federal agents by the leading part he is said to have had in kidnaping first a St. Paul brewer and then six months later a St. Paul banker. And as the prisoner was removed by plane and with some secrecy from New Orleans to St. Paul without loss of time, it is to be assumed that his first answer in meticulous balancing of the account against him will be for one or both of these crimes. With the arrest of Karpis, all of those accused in the first St. Paul kidnaping, that of William A. Hamm Jr., brewer, are in custody, with one of the crew, Arthur Barker, who shared leadership of the notorious Karpis-Barker gang of gunmen with Karpis, already safe in Alcatraz for life for his complicity in the second St. Paul kidnaping, that of Banker Bremer.

The history of criminals of national importance who have gone over the dam to death or long-term imprisonment in the drive that had its greatest incentive in the kidnaping and murder of the son of Col. and Mrs. Lindbergh, however, is not the factor of greatest public interest. What the public watches and applauds is the continuing nature of the drive and the gathering in of public enemies that are wanted and the discouragement of others through fear of certain retribution growing out of episodes similar to the arrest of Karpis in New Orleans Friday evening. Our assurance that society's greatest agency of public defense against major crime continues to function effec-

tively is renewed.

There may be some peaceful and even fearful citizens who believe that if we do not hear the fanfare of pursuit there is no pursuit. But, of course, they are wrong, as almost any criminal of parts whose wrongdoings come within the jurisdiction of Bureau of Investigation will testify, whether he is alive and behind the bars or is still at large. The capture of Karpis when Karpis had been forgot by many peaceful citizens proves the rule of continuing determination. And criminals cannot help but shudder in the knowledge that a plane for Karpis' removal to St. Paul was chartered 24 hours before he was taken. With the proviso, possibly, that the engagement would not have held if Karpis had been killed in the taking. Which, "bad man" though he is, he was not. There was no resistance, which emphasizes the truth that most "bad" men who are deprived of advantage turn out to be very tame.


They "got" Karpis, just as millions of Americans knew they would a . . ne.



'He'll Just Have to Take His Medicine,' Declares Former Girl Bride of Karpis

Tulsa Waitress Told Outlaw To 'Fly His Kite' Five Years Ago.

TULSA, May 4.—(AP)—In an interview Monday Dorothy Slayman, former wife of Alvin Karpis, told the story of her marriage and life with the "public enemy No. 1." The girl diworced Karpis more than a year ago and resumed her maiden name.

"Alvin Karpis made his bed and he'll have to sleep in it. As to whether he should be penalized or not I have no comment to make. His was not my way and so we quit," she said when found working in a Tulsa restaurant.

"Why do the newspapers hound me all the time? Miss Slayman asked. "I married Alvin back in September, 1931, lived with him less than five weeks and have never seen him since that time.

"It doesn't matter whether I say he should pay the penalties for his crime or not. The law is going to convict him and hell probably the penitentiary the rest of his life. I would rather not comment on what I think should happen.

Hounded by Her Past
"All I ask is that John Public let me alone. When I got my divorce I was driven from my home and forced to quit business college. Then I thought it was all over. Now it

breaks right in my face again.
"I don't feel as if I should have to pay for something over which I had no control. Yes, I tried to reform him after he got in his first scrape. Then when he got in trouble the sec-ond time I decided that his ways weren't my ways. This was brought home forcibly to me when I was being held in West Plains, Mo., after Alvin was alleged to have been with Freddie Barker when Sheriff Kelly was shot to death.

Dorothy Slayman met Karpis when she was about 17 years old. She was visiting a friend in Tulsa when Fred-die Barker, slain by G-men in Florida police trap, and Alvin was released from the Kansas reformatory at

Karpis Was Tubercular "They came to Tulsa and a girl whose name I don't care to reveal introduced us. I either became infat-uated or felt that he needed someone I either became infat-

to take care of him.
"He had tuberculosis, never weighed over 120 pounds. The short stretch in the reformatory hadn't helped his condition. This was in April. While we were going together he disappeared and the next thing I knew he was arrested on the east side (Tulsa) for participation in the robberg of a participation in the robbery of a jewelry store in Henryetta.

"They took him to Okmulgee. A fellow who knew Alvin told me where the loot from the jewelry store was and I hitch-hiked to Henryetta and gave it back to the jeweler.

"With my aid a district judge at Okmulgee gave Alvin a bench parole. I knew he was friendly with members of the Barker gang and I prevailed upon him to take me to Chicago. "They took him to Okmulgee. A

"They are all yellow rats," he said. "They don't deserve any titles distinction or rank. If you want to know whom I regard as public enemy No. 1, I'll tell you—Old Man Politics."

Mr. Hoover said he was here on business, but he would not reveal if his agents were looking for Kar-pis' associates in this area.

The financial statement at a conference in New York last Tuesday accounted for between \$45,000 and \$50,000 of the ransom in Hauptmann's transactions. Although only about \$16,000 was in original ransom bills, it is entirely possible that the remainder alipped through the banks and got back to the United States Treasury without being detected. Not a single bill turned up outside of New York, which tends to confirm the balier that Hauptmann was operating alome. If he was part of a gang the money would probably have been circuitated elsewheir, because gangs acaster."

(Perhaps there is good reason to feet the over-expansion of the police powers of the Federal government. Certainly there is a point beyond which the states should refuse to relinquish their responsibility for the apprehension and punishment of criminals. But very few Americans, we believe, are prepared to say that the Lindbergh law and its related statutes have passed that point, or that they would prefer the feeling of helplessness with which the underworld inspired them a few years ago to the confidence they now repose in the Department of Justice. Not even recourse to plastic surgery avails our public enemies today.





U. S. Attorney Sullivan said Karpis will be arraigned tomorrow morning for the Hamm kidnaping.
