MEMORANDUM:

At 9:30 AM I called ASAC Hennrich of the Washington Field Office and inquired as to the developments in this matter. He stated that at the present time they have 37 Agents assigned to this investigation. He is holding a conference for the agents and informing them of developments so that they will be thoroughly familiar with the ramifications of the investigation. He stated that 12 Agents have arrived at the Washington Field Office from other offices in order to work on this special assignment. 25 Agents have been assigned in Washington.

I told Mr. Hennrich to request the Bureau for authority to install a technical on HARRY WHITE. He stated that presently they have physical surveillances on the following:

He stated that from the inquiries they have conducted concerning MARY PRICE, it appears that she is living in New York City at the present time. The last known address they have for her is 207 West 11th Street. He advised that HELEN TENNEY is evidently living in her apartment in Washington.

Mr. Hennrich stated that they are of the opinion that "AL" is ANATOLE B. GROMOV, Second Secretary of the Russian Embassy in Washington. He stated that he fits the description given by ELIZABETH BENTLY, but that he has an English accent and has a snagged tooth in the front of his mouth which is conspicuous and that he has been known to contact CURRIE. He stated that GROMOV is due in New York City on or about November 23rd and is to appear before the AMERICAN COMMITTEE FOR SPANISH FREEDOM at a meeting and dinner at 7:00 PM on November 23rd. Mr. Hennrich stated that the Washington Field Office has a picture of GROMOV which they are having duplicated at the Bureau and will send it to New York this afternoon/and when this picture arrives, it should be exhibited to ELIZABETH BENTLEY to determine if she can identify him. ESPIONAGE R. INVESTIGATION BY WASHINGTON FIELD HAS DEVELOPED THE FOLLOWING INDIVIDUALS ARE NO LONGER IN WASHINGTON DC. LOCKEIN CU PRESENTLY LOCATED ONE NINE RECTOR STREET NYC, J. JULIUS JOSEPH, PRESENTLY IN GERMANY, AND WILLIAM REMINGTON IN US NAVY STATIONED IN BERLIN GERMANY. SONIA GOLD HAS BEEN ABSENT FROM HER POSITION AT TREASURY DEPARTEMTN FOR TWO MONTHS ON MATERNITY LEAVE. PHYSICAL SURVELLIANCE IS BEING MAINTAINED ON THE FOLLOWING, PHAROLD GALSSER, BELA GOLD NOT WILLIAM, HUSBAND OF SONIA GOLD, JOSEPH GREGG, MAURICE HALPERN, ROBERT MILLER, VICTOR PERLO, BERNARD REDMONT, NATHAN SILVERMASTER, HELEN TENNEY, DONALD WHEELER, AND LUDWIG ULLMAN. THESE HAVE ALL BEEN IDENTIFIED. SURVELLIANCES HAVE ALSO BEEN INSTITUEDXX INSTITUTED ON RESIDENCES AND OFFICES IF XX OF HARRY WHITE, GEORGE SILVERMAN, CHARLES KRAMER, AND DUNCAN LEE. THESE SUBJECTS HAVE NOT BEEN IDENTIFIED TO DATE.
