Brandon Hole, date of birth 8/20/2001, was interviewed at 1109 North Huber Street. After being advised of the identity of the interviewing Agent and the nature of the interview, Brandon Hole provided the following information:

Brandon Hole was interviewed at 1109 North Huber Street, Indianapolis, Indiana.

Hole's father committed suicide when he was three years old. Around 12 years old, Hole became upset about his father and about life in general. Hole was home schooled but doesn't have a HS diploma. Hole has few friends,

or have any extremist views. Hole denied using any encrypted apps such as Telegram or WHATSAPP, but stated he is occasionally on 4 CHAN, although he never posts. Hole plays video games, such as WARHAMMER 40k, that has scenes of German soldiers fighting with gasmasks, but nothing else.

Hole hasn't been contacted by any unusual persons online or in person, in any attempts to recruit or radicalize him. Hole did admit that he belongs to an Internet group, "My Little Pony" that enjoys Anime related to the TV Show by the same name. Hole seemed to already know that some followers/fans of My Little Pony have been tied to White Supremacy, but denied any affiliation.

Hole made mention while laughing, that the FBI watches his Internet traffic, and that he should get a VPN.

Hole has aspirations of becoming a police officer. Hole agreed to meet with writer in the future.

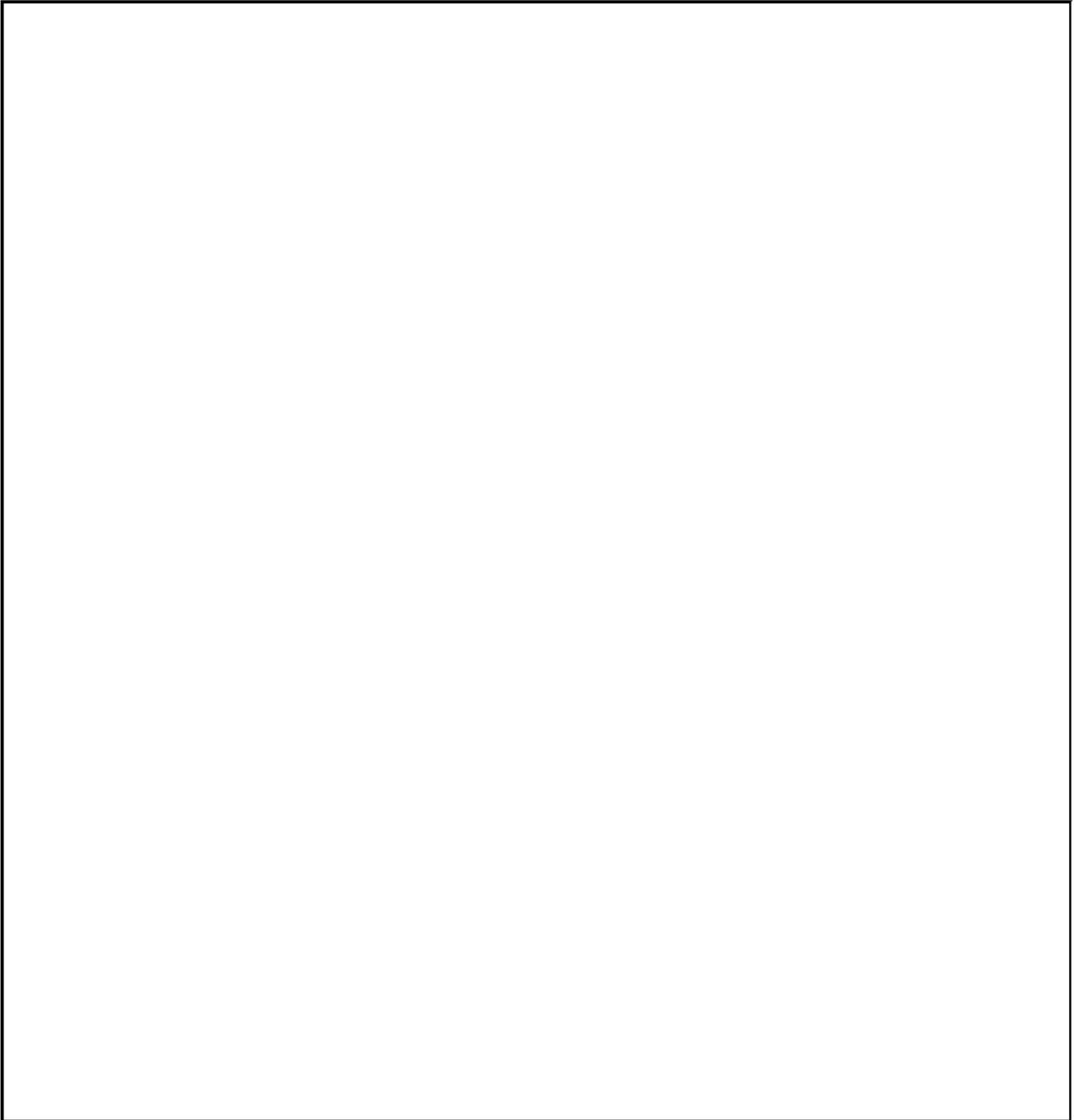

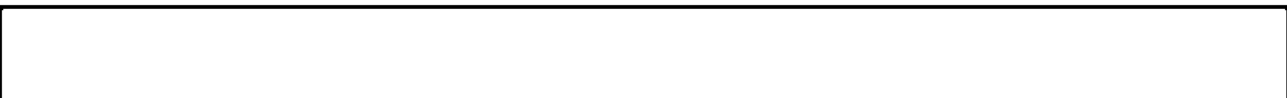
