# Defense May Seek Introduction Of All Slaying Statements

## Starkweather Counsel May Try; Move Opposed By Prosecutor

Written statements which murder defendant Charles Starkweather gave authorities concerning other crimes than the Robert Jensen death may be the subject of a court fight late this week over whether they will be admitted into evidence at his trial for the Jensen murder, The Star learned Sunday.

The second week of Starkweather's trial on first degree murder and murder while in the perpetration of a robbery charges in the death of the 17-year-old Bennet youth begins Monday in Lancaster District Court.

Co. Atty. Elmer Scheele reportedly wants to limit as much as possibly any mention at this trial of the 10 other killings in which the 19-year-old redhead has admitted involvement.

But defense attorneys T. Clement Gaughan and William F. Matschullat are said to believe that to effectively back their contention that Starkweather is "legally insane" they must have copies of the statements he gave detailing other murders introduced at this trial.

### 'Considering' Move

Asked for comment on the report Sunday, Gaughan said the defense is "considering" the attempt to have the other statements admitted, but declined to specify which crimes they would deal with.

At any rate the subject is not expected to come up until late this week or early next week, when the defense is presenting its case.

Dr. E. D. Zeman of Lincoln,

who performed the post-mortem examination of Jensen's body, will continue his testimony when court resumes at 9 a.m. Monday before Judge Harry A. Spencer. Starkweather's case is being heard by a jury of 8 women and 4 men.

### FBI Testimony

Another state's witness Monday will be FBI laboratory technician Robert Zimmers, who examined evidence in the case which was sent to the FBI's Washington, D.C., headquarters.

Scheele is expected to conclude his case by late Tuesday afternoon or early Wednesday morning, and then the defense will take over. Scheele Friday used 15 of the 28 witnesses he had said he would call.

Gaughan and Matschullat have said they will call about 15 witnesses, including the redheaded defendant himself. Gaughan said Starkweather will probably be on the witness stand "for the better part of the day."

The youth will be called, Gaughan said, after several other members of his family have testified but before 2 psychiatrists and a psychologist are called. A plea of "innocent by reason of insanity" has been entered by his attorneys for Starkweather, and Gaughan said last week that the youth was "suffering from delusion" and therefore was legally insane when he shot Jensen.

### Full 3 Weeks

Gaughan said he still believes the trial will last a full 3 weeks, which would run it until May 23.

Highlights of this week's court action will be:

1—Scheele's reading of segments of the Starkweather statement dealing with the Jensen death to the jury (although no startling new facts about the case are expected to be contained in it).

2—The testimony of County Sheriff Merle Karnopp and Lincoln Police Det. Lt. E. R. Henninger, who both have interviewed Starkweather extensively.

3—The testimony of Starkweather himself, his parents, Mr. and Mrs. Guy Starkweather of 3025 N. and 2 of his brothers, Rodney, 21, and Bobby, 14. The defendant and his family are all reportedly opposed to basing his defense on a contention of insanity.

# LETTER: 'CARIL BEAT BABY'

## Note Blames Girl In Fatally Clubbing Sister

... Starkweather Attorneys Introduce Message

Charles Starkweather's defense attorneys Monday introduced into evidence at his trial for the Robert Jensen murder a startling letter which purports to link 14-year-old Caril Fugate to the murders of her family.

The poorly-spelled letter was found on Starkweather after his capture Jan. 23 near Delta, Wyo. It states that Starkweather and Caril, his girl friend and companion on the January murder spree which claimed 9 lives in Nebraska and 1 in Wyoming.

The letter states that after Starkweather had shot Caril's step-father Marion Bartlett of 924 Belmont, following an argument, that Mrs. Bartlett (Caril's mother) knocked the gun from Starkweather's hands, but that Caril picked it up and kept her mother from coming at Starkweather with a knife.

"Betty Jean (Caril's 2-year-old half-sister) was yelling so 'I (Caril) hit her with the gun about 10 times.'"

An autopsy had showed that Mr. and Mrs. Bartlett were shot to death but that the baby girl was fatally beaten about the head with a blunt instrument.

All Not Clear

The letter does not make clear who allegedly shot Mrs. Bartlett.

After Mr. and Mrs. Bartlett and Betty Jean were killed, the letter states, "me and Chuck (Starkweather) just look (sic) at them for about 4 hours. Then we wrapped them and pulled them out in the house in back." The bodies were found in the out-buildings Jan. 27.

Caril Fugate's defense attorney, John McArthur, was in court when the letter was read. He commented "I won't believe it until she tells me... she's never even suggested such a thing!" He said he doubts the truth of the letter, which he said he had no knowledge of previous to its being introduced in court.

Starkweather had claimed in a statement scrawled on a piece of paper during his capture that he had killed all the women who died in the murder spree. But his total of 9 men victims for himself and 2 women for her was faulty, as 5 of the victims were women.

Doubts Truthfulness

In reference to this statement, McArthur said he doubts its truthfulness, and added he is sure that Caril does not even know about Starkweather's claims that she killed the women.

Confusion was added to the "who killed who" question by the introduction of a second letter, this one written in Wyoming by Starkweather to his parents, Mr. and Mrs. Guy Starkweather of 3025 N.

In this letter Starkweather claimed that Caril "had not a thing to do with the killing." But he did state that "she help me a lot."

In one place Starkweather said in the second letter that "I'm sorry for what I did in a lot of ways cause I know hurt everybody," but in another place he stated that "I'm not really sorry for what I did cause for the first time me and Caril had more (sic) fun..."

The surprise introduction by defense attorneys T. Clement Gaughan and William F. Matshcullat apparently came as a move to bolster their contention that Starkweather suffers from "delusions" and is legally insane. They have previously stated it is difficult to tell just what did happen because of the confusing and conflicting accounts Starkweather has given.

Story Changed

Starkweather, who had claimed after his capture that Caril was his hostage (she still claims this is true) but later changed his story and said she was his accomplice.

The introduction of the 2 letters by the defense came while Asst. Lincoln Police Chief Eugene Masters was on the stand as a prosecution witness. He had stated that he was given the 2 letters by two Wyoming lawmen. Gaughan, while cross-examining Masters asked the introduction of the 2 letters, and Co. Atty. Elmer Scheele did not object.

He stated during recess, however, that he would not have attempted to introduce the letters as they do not deal with the Jensen death, for which Starkweather is on trial in Lancaster District Court before Judge Harry A. Spencer.

Statement Tuesday

Scheele said Tuesday morning he will offer as evidence those parts of a 5-volume statement taken from Starkweather Feb. 1 and also parts of one taken from him Feb. 27 which deal with the Robert Jensen murder. These parts reportedly comprise about 43 pages of the 377 pages which the statements total.

No defense objection is expected to this introduction, and Gaughan and Matshcullat are expected to press later this week for introduction of all the statements.

The last of the 27 witnesses Scheele will call during the presentation of his case, Police Det. Lt. E. R. Henninger, was on the stand Monday afternoon when court was adjourned until 9 a.m. Tuesday. Henninger is expected to be on the stand for a short time Tuesday and then the defense will begin its case.

Caril had an uncle, John Hodge of Mt. Enterprise, who was Starkweather's employer when the redhead worked for the Western Newspaper Union several years ago. The defense has claimed that Starkweather suffered a head injury when struck by a piece of flying metal during his employment there.

Headaches Cited

This head injury, Gaughan has said, has resulted in continuing "serious headaches" for Starkweather ever since. The attorney said it is possible he may have suffered a brain injury or tumor, but Starkweather has refused to submit to a test to find out.

Gaughan upped his previous estimate of the number of witnesses he will call from 15 to 20. In addition to Starkweather, members of his family and doctors who are expected to back the insanity contention, Gaughan has added to the list:

Caril Fugate's defense attorney, John McArthur, was in court when the letter was read. He commented "I won't believe it until she tells me... she's never even suggested such a thing!" He said he doubts the truth of the letter, which he said he had no knowledge of previous to its being introduced in court.

Starkweather had claimed in a statement scrawled on the wall of the Gering, Neb., jail Jan. 30 that Caril killed all the women who died in the murder spree. But his total of 9 men victims for himself and 2 women for her was faulty, as 5 of the victims were women.

Doubts Truthfulness

In reference to this statement, McArthur said he doubts its truthfulness, and added he is sure that Caril does not even know about Starkweather's claims that she killed the women.

# Defense Attorneys 'Going Too Far,' Says Mrs. Starkweather

Mrs. Guy Starkweather put her head in her hands Monday in an effort to blot out the chain of testimony which pointed out the trail of murders to which her son has confessed.

But a more important worry to Mrs. Starkweather and one that made her eyes spark with anger several times during Monday's testimony was cross examination by defense attorney T. Clement Gaughan to point out the "lack of remorse" which Charles Starkweather showed after his capture and during taking of his confession statement.

"A person doesn't have to show their emotions to feel them," she explained, "and Charlie was always like that. He only showed when he was mad."

Mrs. Starkweather, who will take the stand herself in her son's defense, stated she thought the defense attorneys "are going too far" in trying to prove her son insane.

She explained that she and her husband had given the names of Charles' friends so that they could be asked to testify to his character but that defense attorneys had talked to only a few of them, and rejected these as witnesses.

"They (Gaughan and William Matschullat) told me that they would not use the boys and girls as witnesses because they were as dumb as Charlie," she said, "and did you

hear them say he was just a point or two above an idiot?" she asked irately.

One boy whom the defense attorney questioned and asked to testify, refused, she said, because the attorney wanted him to say "Charlie was a little boy . . . played little boys' games, and had queer ideas." The boy wouldn't do it, she explained, "because it just wasn't so."

Asked if she could testify to the "delusions" which Gaughan and Matschullat mentioned that Charles Starkweather had "for several years," Mrs. Starkweather said "no."

The tiny woman, holding up under the court session

by sheer will power, said she thought "it sounded more like Charlie" when the letter was read which he had written to her and her husband after his capture in Wyoming.

"There he says he is sorry," she pointed out. "And he shows he is worried about the family."

During court sessions Monday the red-haired woman held several whispered conversations with her son, but not about the trial proceedings.

"I have to get him some shoes," she explained, "he says the ones he has are too small and hurt him." She left the trial at the afternoon recess to buy them.

She added that her son also pointed out Caril Fugate

## 'Sorry—But Not Real Sorry,' Starkweather Wrote Parents

A letter which Charles Starkweather wrote to his parents shortly after his capture in Wyoming was revealed for the first time at Monday's trial sessions, introduced as evidence by Starkweather's defense attorneys.

## Uced At Trial

Sheriff Earl Heflin of Douglas and Dep. Sheriff William Romer of Casper, testified Monday. Heflin told of how he and Douglas Police Chief Robert Ainslie chased Starkweather at 115 mph and finally took him into custody about 3½ miles east of Douglas Jan. 29.

Heflin said Starkweather just suddenly stopped in the middle of the road and got out after he (Heflin) had been firing at him with a .38 pistol and a 30-30 rifle (a piece of flying glass had nicked Starkweather's ear but he was not shot). He said Starkweather told him that "I'da hit somebody headon anyhow," an apparent reference to the high-speed chase.

Gaughan asked Heflin if Starkweather at any time seemed to realize the " enormity " of the acts he was alleged to have committed. In the morning Heflin answered "no," that he did not, but he reversed himself upon further questioning by Scheele in the afternoon and said that Starkweather did seem to realize what he had done. The sheriff said Starkweather showed no remorse, but said he did not think this unusual for a killer.

## Tells Of Caril

Romer told how Caril Fugate ran up to him about 14 miles west of Douglas, where he had stopped his car when he saw 2 men (Starkweather and Joseph Sprinkle of Casper) wrestling for a rifle. He said Caril ran to him and said Starkweather had just killed a man (Merle Collison of Great Falls, Mont.) and that he (Romer) then radioed ahead for a road block to halt Starkweather, who had driven off at high speed. He also told of recovering a .22 rifle (used to kill Jensen) from the site where he came upon Starkweather.

## Other witnesses who testified Monday and a brief summary of their testimony:

Robert Zimmers, FBI ballistics expert of Washington, D. C., testified that the .22 rifle sent him for examination was the weapon from which several .22 bullets he also examined had been fired. (The gun was recovered in Wyoming, the bullets from Jensen's body.)

Louis Meyer of Bennet, brother of the slain August Meyer, identified the .22 pump rifle recovered by Romer in Wyoming as having belonged to his brother.

Elmer Shambert of Lincoln, freelance court reporter who took down Starkweather's statements, told of taking the statements and said that they were given freely, voluntarily and without the use of any threats or promises from Starkweather at the State Penitentiary.

E. R. Henninger, local police detective, also said the statements (which he witnessed) were gotten without any pressure on Starkweather.

Sheriff Merle Karnopp of Lincoln related how he found Jensen's broken wrist watch in the storm cellar east of Bennet where he was fatally shot. The watch was stopped at 9:07, he said. (Zimmers had stated that the watch stopped because of the crystal being smashed, not because it ran down.)

Harold D. Smith, former Safety Patrol captain and now Men's Reformatory superintendent, and Vernon Byler, present Safety Patrol captain, told of searching for and finding several empty .22

shell casings near the storm cellar, which were later traced to the Meyer rifle.

Dep. Sheriff William D. Johnson of Lincoln told of photos he took at the autopsy performed on Jensen's body, and of bringing back a seat cushion belonging to Jensen which was found in the car Starkweather was driving in Wyoming.

Dep. Sheriff Robert G. Anderson of Lincoln related how he searched Jensen's body at the hospital where the autopsy was performed and found his billfold, which contained a \$1 bill in a zipper compartment. (Jensen's father had earlier testified that his son had several dollars in his possession when he left home the night of Jan. 27.)

Dr. E. D. Zeman of Lincoln the pathologist who performed the autopsy, testified that he took a color slide showing the 6 bullet holes in Jensen's head near the right ear. The slide was projected on a screen for the jurors to view.

The rifle sight, specimen Q1, is the type of sight assembled originally on .22 caliber Winchester rifles of the type represented by specimen K2. The sight of specimen K2 is missing and specimen Q1 could have come from this rifle.

The bullet specimen, Q2, found four steps from the basement floor in the C. Lauer Ward home is a mutilated fragment of a caliber .22 Long Rifle bullet. Because of its mutilated condition, it was not possible to determine the type of bullet from which this fragment came. The absence of marks on the bullet's surface precludes the possibility of identifying the type or particular weapon firing the bullet from which this fragment came.

The bullet specimen, Q3, found in the door casing in the living room at the C. Lauer Ward home is also a mutilated fragment of a bullet. This specimen was likewise too mutilated to permit identification as to bullet type. There were no marks present to permit identification of the type or particular weapon firing the bullet from which this fragment came.

The cartridge case, Q4, found on the basement floor at the foot of the basement steps at the C. Lauer Ward home is a Remington caliber .22 short cartridge case. It was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 1906, serial # 600590, referred to above as spec K2.



The cartridge case, Q5, found on the sixth step from the top of the staircase at the C. Lauer Ward home is a <sup>Remington</sup> caliber .22 Long or Long Rifle cartridge case. It was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 1906, serial # 600590, referred to above as specimen K2.

The cartridge case, Q6, found on the top landing of the basement steps at the C. Lauer Ward home is a Remington caliber .22 Long or Long Rifle cartridge case. It was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 1906, serial # 600590, referred to above as specimen K2.

The cartridge case, Q7, found on the floor just south of C. Lauer Ward's head, is a Remington caliber .22 Long or Long Rifle cartridge case. It was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 1906, serial # 600590, referred to above as specimen K2.

The cartridge case, Q10, found in the northwest bedroom at the Bartlett home is a Remington caliber .22 Long or Long Rifle cartridge case. It was identified as having been fired in the caliber .22 J. C. Higgins bolt action rifle, Model 103.18, referred to above as specimen K1.

The piece of shotgun barrel, Q12, found on top of the piano in the Marion Bartlett home, is the muzzle end,  $8\frac{5}{8}$ " long, of the barrel of a .410 gauge shotgun. This barrel section was identified as having been sawed from the barrel of the .410 gauge J. Stevens shotgun, Model 59 A,

referred to above as specimen K4.

The <sup>Remington</sup> 410 gauge fired shotgun shell, Q13, found in the yard of the August Meyer farm, was identified as having been fired in the 410 gauge J. Stevens shotgun, Model 59A, referred to above as specimen K4.

The cartridge case, Q14, found in the kitchen of the August Meyer farm house, is a Remington cal. 22 Long or Long Rifle cartridge case from a round of ammunition that is unlike those rounds represented by any of the other cartridge cases examined. This cartridge case was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 62A, serial # 125936, referred to above as specimen K3.

The bullet, Q15, found in the kitchen of the August Meyer farm house is a mutilated fragment of a caliber .22 Long Rifle bullet. This specimen was too mutilated to permit identification of the type or particular weapon firing the bullet from which this fragment came.

The two pieces of shot, Q16, taken from the head of August Meyer are from a shotgun shell loaded with #6 shot. In this regard, <sup>by your office under cover of your letter dated Dec. 7<sup>th</sup>, 1968</sup> it is the same size shot as that submitted, in the Robert George Colvert, Victim, Murder case, and reported upon in Laboratory report number PC 51221 G.Y.

The bullet, Q17, removed from the head of Carol King, is the bare portion of a caliber .22 Long Rifle bullet. This bullet was identified as having been fired from the caliber .22 Winchester pump action rifle, Model 62A, serial # 125936, referred to above as K3.

The bullet, Q18, taken from the head of Robert Jensen, is the

base portion of a caliber .22 bullet. This bullet was identified as having been fired from the caliber .22 Winchester pump action rifle, Model 62A, serial # 125936, referred to above as specimen K3.

The cartridge case, Q19, found at the cave at the Carol King - Robert Jensen murder scene is a Remington caliber .22 Long or Long Rifle cartridge case. It was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 62A, serial # 125936, referred to above as specimen K3.

The cartridge case, Q20, found at the cave at the Carol King - Robert Jensen murder scene is a Remington caliber .22 Long or Long Rifle cartridge case. It was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 62A, serial # 125936, referred to above as specimen K3.

The bullet, Q21, taken from the right lung of C. Lauer Ward is the mutilated base portion of a caliber .22 bullet. Some similarities between the limited marks on this specimen and on test bullets fired from specimen K2 were noted. The similarities noted were insufficient to permit identification of specimen K2 as the particular weapon firing the bullet from which this fragment came.

The bullet, Q22, taken from the head of C. Lauer Ward is a mutilated portion of a caliber .22 Long Rifle bullet. There were, however, sufficient marks remaining on its surface for identification purposes and it was identified as having been fired from the caliber .22 Remington

pump action rifle, Model 1906, serial # 600590, referred to above as specimen K2.

The bullet, Q30, removed from the brain of Robert Jensen was submitted by the Chief of Police, Joseph T. Carroll, under cover of the letter from his office dated March 1, 1958. This bullet was identified as having been fired from the caliber .32 Winchester pump action rifle, Model 629, serial # 125936, referred to above as specimen K3.

The wrist watch, K14, belonging to Robert Jensen, bears the brand name "Broadway". When received, the time read 9:30 o'clock. The crystal, apparently broken, was missing. The case was damaged at the 11 o'clock position and the face dented at the 2 o'clock position. A clump of dirt was present at the 2 o'clock position, the presence of which would have stopped the minute hand at this point had the minute hand reached it. The sweep second hand is missing and the sweep second <sup>hand</sup> ~~pinion~~ is bent. It was concluded that this wrist watch stopped with the bending of the sweep second <sup>hand</sup> ~~pinion~~. The spring was fully wound approximately three or four hours before the watch stopped and had, when received, approximately 24 hours running time remaining on the wound spring.

The wrist watch, K15, removed from the body of Carol King, bears the brand name "Sheffield". When received, the time read 9:15 o'clock. The spring on this wrist watch was completely run down. There was no evidence of damage to this watch. In the laboratory, this watch

was fully wound and it ran without failure for 28 hrs 13.5 min keeping time accurately.

Test bullets and cartridge cases fired from specimens K1, K2 and K3 and test shotgun shells fired from specimen K4 were compared microscopically with all comparable specimens in this Laboratory's National Unidentified Ammunition File without effecting any identifications.

The serial numbers of specimens K2 and K3 were searched through the National Stolen Property Index of this Bureau but no prior record of the loss or theft of these weapons were found.

Specimens K1 through K4 functioned normally in every respect when they were test fired in the Laboratory.

Cloth matching

Q11, Q25, Q26, Q27, Q28 & Q29 strips of cloth were compared by edge contours & in some cases thread coincidence with sheet K8. As shown by attached sketches four pieces of cloth in Q11, one piece found wrapped in K8<sup>(K8B)</sup> sheet, two pieces of cloth in Q28 and three pieces in Q29 were matched to K8 sheet.

One piece of Q11, three pieces in Q25, three pieces in Q26, two pieces in Q27 and a piece of cloth found rolled up in K8 (K8C) were found to be contiguous pieces of a different sheet (not K8) and were found to comprise the major portion of one selvage edge & the wide or top hem of the sheet.

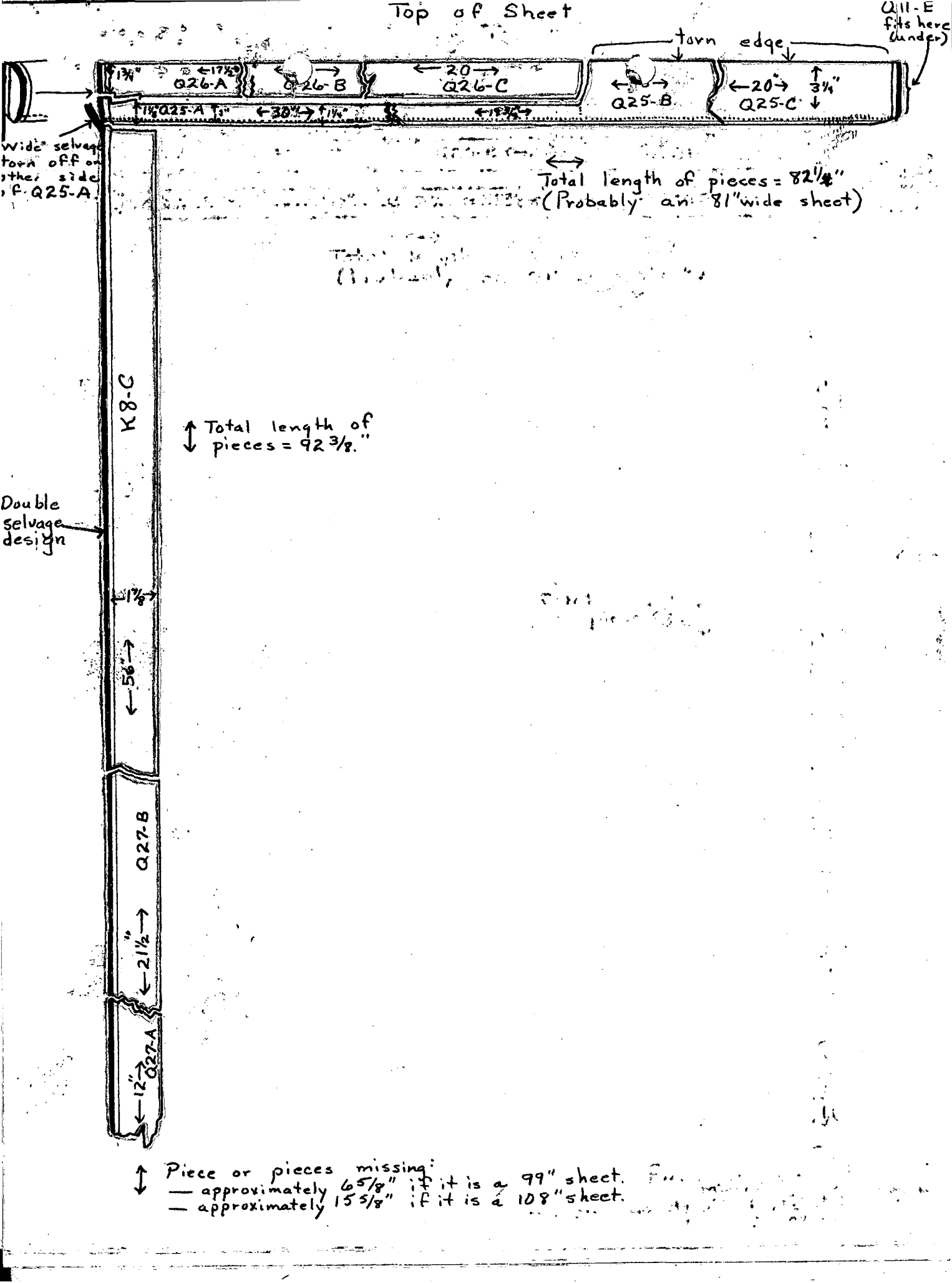

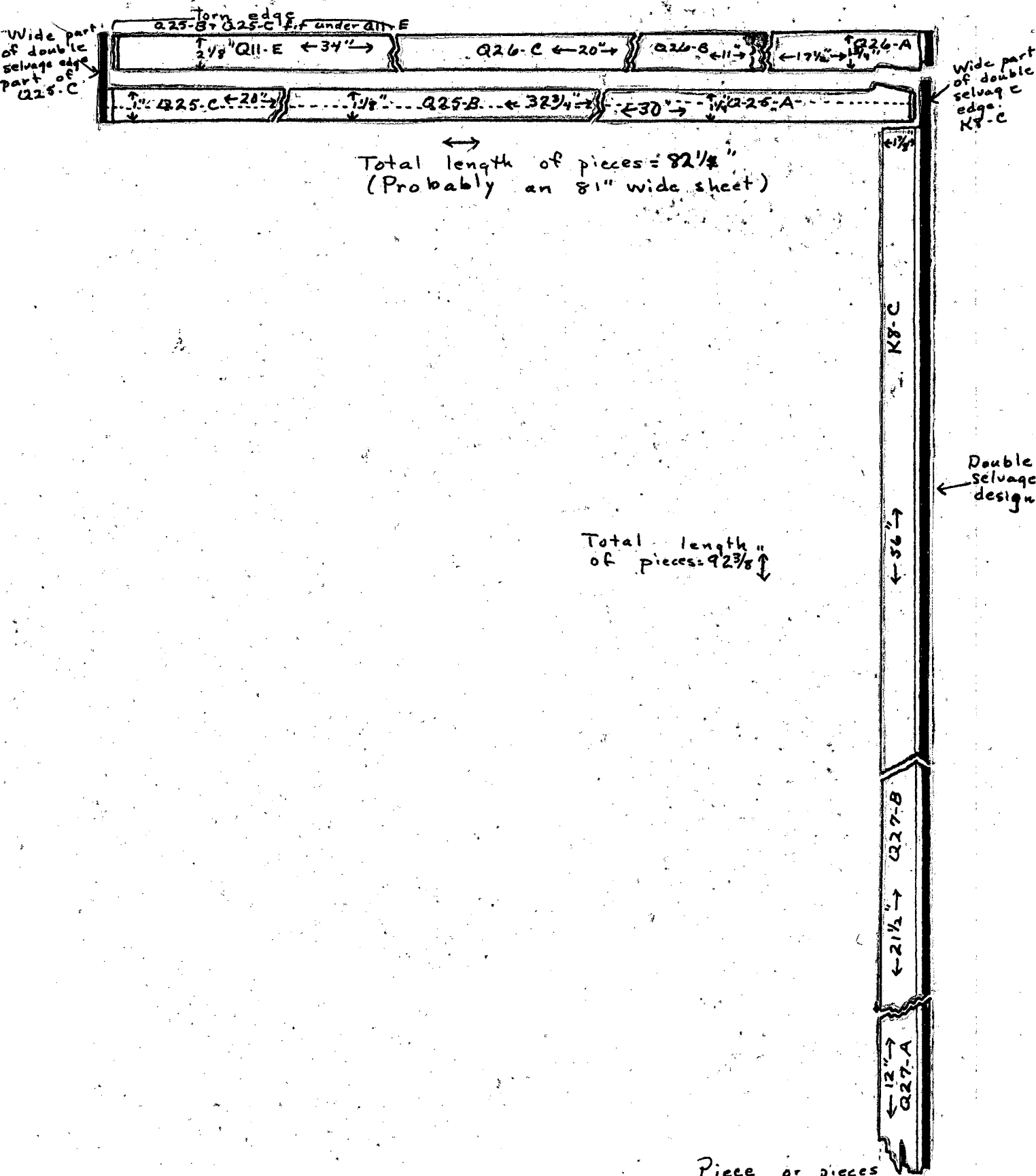

By comparisons of contours of the torn edges it was ascertained that four of the five strips of cloth in specimen Q11, the two strips of cloth in Q58, and the three strips comprising Q29 had been torn from the Bedsheet, specimen K8.

As a result of similar contours comparisons it was determined that one strip of cloth in Q11, the three strips in Q25, the three pieces of cloth in Q26, the two pieces in Q27 and a single strip found wrapped in the bedsheet, K8, did not come from K8. These strips were found to be contiguous pieces of another bedsheet and were found to comprise the major portion of one selvage edge and the entire wide or top edge of the sheet.

Human blood which was too limited in amount for grouping tests was found <sup>in spec. Q5</sup> on the left sleeve and left shoulder of the jacket, K6,

on the left rear portion of coat, K10,  
on the left leg of K17 and on the  
right sleeve of K18.\* No blood was  
found in spec. Q9, on K5, K11, K12  
and K13. The examination of K5 did not  
disclose any tissue particles or hairs  
thereon.

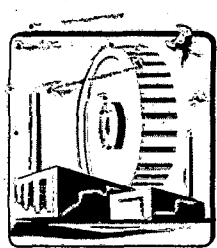

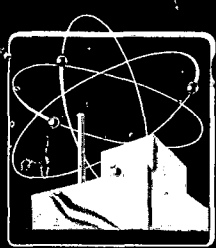
\* Preliminary chemical tests for blood were

results of these tests were positive, thereby



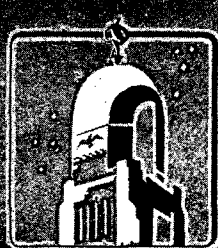
indicating the possible presence of blood on the boots. The amount of material in the stains was too limited, however, for confirmatory blood analyses.



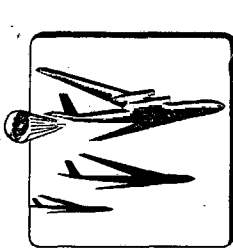

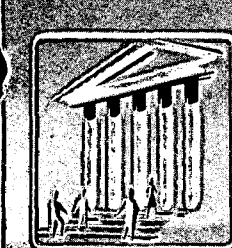



STATEMENT OF FACTS

Victims  
~~Mrs~~ About 4:30 P. M., January 27th, 1958, the body of Marion Bartlett was found in an old chicken shed at the rear of his home at 924 Belmont in this city. The body of his wife, Velda Bartlett, and his three year old daughter, Betty Jean, were found in an abandoned out-door toilet at the rear of the home. All three bodies had been wrapped in various articles of bed clothing, rags, paper, etc. It was determined through autopsies that Marion Bartlett had been shot in the head with a .22 calibre hollow point bullet. Mrs. Bartlett had also been shot with a .22 calibre hollow point bullet. The daughter, Betty Jean, had numerous skull fractures and a stab wound in the throat. All three bodies had numerous wounds and abrasions on them.

On January 28th, 1958, at approximately 12:30 P. M., the body of August Meyer, a bachelor farmer, was found at his farm home near Bennet, Nebraska, which is approximately eighteen miles southeast of Lincoln. The body was found in a small shed at the rear of his farm home, and it was determined that he had been shot while on the back porch of his home. He had been shot in the back of the head with a .410 gauge shotgun.

At approximately 4:00 P. M. on January 28th, 1958, the bodies of Carol King and Robert Jensen were found in an abandoned storm cave, which was located on abandoned school grounds one-half mile west of the August Meyer farm. Carol King had been shot

once in the head with a .22 calibre bullet. When found, her jeans and underclothing were down around her ankles. According to the autopsy report, an act of sodomy had been committed on this young girl. Robert Jensen had been shot in the head five or six times with .22 calibre bullets.

*Mrs* On January 29th, 1958, at 12:30 P. M., the bodies of C. Lauer Ward, his wife Clara Ward, and their maid Lillian Fencil were found in their home at 2843 South 24th Street, Lincoln, Nebraska. The body of Mr. Ward was found near the front door of his home, and he had been shot in the back with a .22 calibre bullet and in the head with a .22 calibre bullet. He had also supposedly been hit in the head or neck with a brass fireplace stoker. The body of his wife, Clara Ward, was found in an upstairs bedroom, lying between two beds, with her arms tied behind her and a gag in her mouth. She had been stabbed numerous times in the back. In another bedroom on the second floor of this home was found the body of the maid, Lillian Fencil. Her hands had been bound in front of her, a gag placed in her mouth, and she had been bound about the ankles. There were numerous stab wounds in her chest and abdomen, and she had been cut on the wrists and the back of her left hand. Autopsies disclosed that neither Mrs. Ward nor Lillian Fencil had been shot.

During the afternoon of January 29th, 1958, Charles R. Starkweather and [redacted] were apprehended near Douglas, Wyoming. Starkweather has admitted the shootings of all victims mentioned but denies the stabbing of Mrs. Ward and Lillian Fencil and intimates that this was done by [redacted].

Starkweather also admits the shotgun slaying of Robert George Colvert as per our letter to you of December 7th, 1957, your File No. 95-72706, Laboratory No. PC-51221GY.

#### Results of Examination:

The rifle sight, specimen Q1, is the type of sight assembled originally on .22 caliber Winchester rifles of the type represented by specimen K2. The sight of specimen K2 is missing and specimen Q1 could have come from this rifle.

The bullet specimen, Q2, found four steps from the basement floor in the C. Lauer Ward home is a mutilated fragment of a caliber .22 Long Rifle bullet. Because of its mutilated condition, it was not possible to determine the type of bullet from which this fragment came. The absence of marks on the bullet's surface precludes the possibility of identifying the type or particular weapon firing the bullet from which this fragment came.

The bullet specimen, Q3, found in the door casing in the living room at the C. Lauer Ward home is also a mutilated fragment of a bullet. This specimen was likewise too mutilated to permit identification as to bullet type. There were no marks present to permit identification of the type or particular weapon firing the bullet from which this fragment came.

The cartridge case, Q4, found on the basement floor at the foot of the basement steps at the C. Lauer Ward home is a Remington caliber .22 Short cartridge case. It was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 1906, Serial No. 600590, referred to above as specimen K2.

The cartridge case, Q5, found on the sixth step from the top of the staircase at the C. Lauer Ward home is a Remington caliber .22 Long or Long Rifle cartridge case. It was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 1906, Serial No. 600590, referred to above as specimen K2.

The cartridge case, Q6, found on the top landing of the basement steps at the C. Lauer Ward home is a Remington caliber .22 Long or Long Rifle cartridge case. It was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 1906, Serial No. 600590, referred to above as specimen K2.

The cartridge case, Q7, found on the floor just south of C. Lauer Ward's head, is a Remington caliber .22 Long or Long Rifle cartridge case. It was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 1906, Serial No. 600590, referred to above as specimen K2.

The cartridge case, Q10, found in the northwest bedroom at the Bartlett home is a Remington caliber .22 Long or Long Rifle cartridge case. It was identified as having been fired in the caliber .22 J. C. Higgins bolt action rifle, Model 103.18, referred to above as specimen K1.

The piece of shotgun barrel, Q12, found on top of the piano in the Marion Bartlett home, is the muzzle end, 8 5/8" long, of the barrel of a .410 gauge shotgun. This barrel section was identified as having been sawed from the barrel of the .410 gauge J. Stevens shotgun, Model 59A, referred to above as specimen K4.

The Remington .410 gauge fired shotgun shell, Q13, found in the yard of the August Meyer farm, was identified as having been fired in the .410 gauge J. Stevens shotgun, Model 59A, referred to above as specimen K4.

The cartridge case, Q14, found in the kitchen of the August Meyer farmhouse, is a Remington caliber .22 Long or Long Rifle cartridge case from a round of ammunition that is unlike those rounds represented by any of the other cartridge cases examined in this case. This cartridge case was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 62A, Serial No. 125936, referred to above as specimen K3.

The bullet, Q15, found in the kitchen of the August Meyer farmhouse is a mutilated fragment of a caliber .22 Long Rifle bullet. This specimen was too mutilated to permit identification of the type or particular weapon firing the bullet from which this fragment came.

The two pieces of shot, Q16, taken from the head of August Meyer are from a shotgun shell loaded with number 6 shot. In this regard, it is the same size shot as that submitted by your office under cover of your letter dated December 7, 1957, in the Robert George Colvert, Victim, Murder case and reported upon in Laboratory report number PC-51221 GY.

The bullet, Q17, removed from the head of Carol King, is the base portion of a caliber .22 Long Rifle bullet. This bullet was identified as having been fired from the caliber .22 Winchester pump action rifle, Model 62A, Serial No. 125936, referred to above as specimen K3.

The bullet, Q18, taken from the head of Robert Jensen, is the base portion of a caliber .22 bullet. This bullet was identified as having been fired from the caliber .22 Winchester pump action rifle, Model 62A, Serial No. 125936, referred to above as specimen K3.

The cartridge case, Q19, found at the cave at the Carol King - Robert Jensen murder scene is a Remington caliber .22 Long or Long Rifle cartridge case. It was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 62A, Serial No. 125936, referred to above as specimen K3.

The cartridge case, Q20, found at the cave at the Carol King - Robert Jensen murder scene is a Remington caliber .22 Long or Long Rifle cartridge case. It was identified as having been fired in the caliber .22 Winchester pump action rifle, Model 62A, Serial No. 125936, referred to above as specimen K3.

The bullet, Q21, taken from the right lung of C. Lauer Ward is the mutilated base portion of a caliber .22 bullet. Some similarities between the limited marks on this specimen and on test bullets fired from specimen K2 were noted. The similarities noted were insufficient to permit identification of specimen K2 as the particular weapon firing the bullet from which this fragment came.

The bullet, Q22, taken from the head of C. Lauer Ward is a mutilated portion of a caliber .22 Long Rifle bullet. There were, however, sufficient marks remaining on its surface for identification purposes and it was identified as having been fired from the caliber .22 Remington pump action rifle, Model 1906, Serial No. 600590, referred to above as specimen K2.

The bullet, Q30, removed from the brain of Robert Jensen was submitted by Chief of Police Joseph T. Carroll, under cover of the letter from his office dated March 1, 1958. This bullet was identified as having been fired from the caliber .22 Winchester pump action rifle, Model 62A, Serial No. 125936, referred to above as specimen K3.

The wrist watch, K14, belonging to Robert Jensen, bears the brand name "Broadway." When received, the time read 9:30 o'clock. The watch crystal, apparently broken, was missing. The case was damaged at the 11 o'clock position and the face dented at the 2 o'clock position. A clump of dirt was present at the 2 o'clock position, the presence of which would have stopped the minute hand at this point had the minute hand reached it. The sweep second hand is missing and the sweep second hand pinion is bent. It was concluded from an examination of this wrist watch that it stopped with the bending of the sweep second hand pinion. The spring was wound to within three or four hours of being fully wound.

The wrist watch, K15, removed from the body of Carol King, bears the brand name "Sheffield." When received, the time read 9:20 o'clock. The spring on this wrist watch was completely run down. There was no evidence of damage to this watch. In the Laboratory, this watch was fully wound and it ran without failure, keeping accurate time, for 28 hours 35 minutes.

Test bullets and cartridge cases fired from specimens K1, K2 and K3 and test shotgun shells fired from specimen K4 were compared with all comparable specimens in this Laboratory's National Unidentified Ammunition File without effecting any identifications.

The serial numbers of specimens K2 and K3 were searched through the National Stolen Property Index of this Bureau but no prior record of the loss or theft of these weapons was found.

Specimens K1 and K4 do not have serial numbers.

Specimens K1 through K4 functioned normally in every respect when they were test fired in the Laboratory.

By comparisons of contours of the torn edges it was ascertained that four of the five strips of cloth in specimen Q11, the two strips of cloth in Q28 and the three strips comprising Q29 had been torn from the bed sheet, specimen K8.

As a result of similar contour comparisons it was determined that one strip of cloth in Q11, the three strips in Q25, the three pieces of cloth in Q26, the two pieces of cloth in Q27 and a single strip found wrapped in the bed sheet, K8, did not come from K8. These strips were found to be contiguous pieces of another bed sheet and were found to comprise the major portion of one selvage edge and the entire wide or top edge of the sheet.

Human blood which was too limited in amount for grouping tests was found in specimen Q8, on the left sleeve and left shoulder of the jacket, K6, on the left rear portion of the coat, K10, on the left leg of K17 and on the right sleeve of K18.

Preliminary chemical tests for blood were made on a faint reddish smear present on the toe of the right boot of specimen K16 and on minute red stains appearing on the side of the heel of the left boot of K16. The results of these tests were positive, thereby indicating the possible presence of blood on the boots. The amount of material in the stains was too limited, however, for confirmatory blood analyses.

No blood was found in specimen Q9, on K5, K11, K12 and K13. The examination of K5 did not disclose any tissue particles or hairs thereon.

For purposes of record, grouping tests were made on the human blood present on specimens K8 and K19. The blood on K8 was derived from an individual belonging to International Blood Group "O." That on K19 came from a group "B" person.

No seminal stains were found on specimens K19 through K22.

It was concluded that Charles R. Starkweather, whose known handwriting is designated as K7, prepared the questioned handwriting on Q23 and the handwriting on Q24 except the three pages beginning "Im not.....," "she said care....." and "did she say that." Because of the limited amount of handwriting and unexplained characteristics, a definite conclusion was not reached whether the three pages mentioned above were written by Charles R. Starkweather, K7, or [redacted], K9. Similarities were noted in the known handwriting of [redacted] when compared with the handwriting on the page beginning "Im not....."

In answer to your request for the names of the Laboratory examiners in this case (your letter of March 12, 1958) this is to advise that Special Agent [redacted] conducted the examination for blood, hairs and fibers; Special Agent [redacted] conducted the handwriting examination and Special Agent [redacted] conducted the firearms examination.

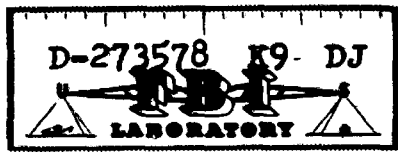

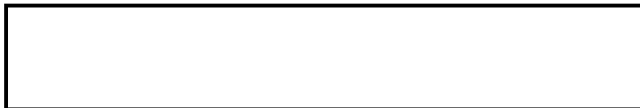

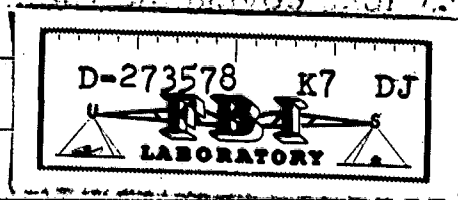

On May 12, 1958, Special Agent [REDACTED] testified at the trial of this case in Lincoln, Nebraska. His testimony was to the effect that two bullets and two cartridge cases recovered in connection with the murder of one of the victims, Robert Jensen, was fired from a .22 caliber rifle taken from Charles R. Starkweather.

# Bantam Killer To Die in Chair

LINCOLN, Neb. (AP) — Charles Starkweather, the 19-year-old who went on a homicidal orgy that took 11 lives, was ordered to pay with his own Friday.

A jury of eight women and four men found the redhaired mass killer guilty of the murder of just one of his victims, but that was enough to commit Starkweather to the electric chair.

The former garbage hauler spoke not one word in the courtroom except to whisper what appeared to be "goodbye" to his defense attorney, T. Clement Gaughan, as he was led in handcuffs out of the courtroom.

Reporters stopped him in the corridor as he was being led out on the way to the state penitentiary.

They asked him: "How do you feel, Charlie?"

"I don't think they tried me for Jensen," he said. "They tried me for the whole thing."

## KILLING RAMPAGE

By the "whole thing" he meant the rampage of killing that terrorized this community last January when he and his 14-year-old girl friend, Caril Fugate, left bodies strewn from the slums to the most exclusive residential district of Lincoln.

Attorney Gaughan was asked what he thought of the outcome.

"I presume Charlie got what he wanted," Gaughan said. "That is what he always wanted."

The defense was given 10 days in which to file a motion for a new trial.

Starkweather's execution may be delayed until next fall so that he could testify at the murder trial of Caril Fugate. His confession implicated her in the slaying of her own mother, her baby half-sister, 16-year-old Carol King, Mrs. C. Lauer Ward, and the Wards' maid in the Lauer home.

## CARIL IN HOSPITAL

Caril was being held for safe-keeping in a state mental hospital pending a ruling on whether she will be tried in district court on first-degree murder charges or in juvenile court.

Starkweather was found guilty specifically on two counts in the murder and robbery of 17-year-old Robert Jensen, whose body, along with that of the King girl, was found in a storm cave in an abandoned schoolyard.

The girl had been disrobed and

an attempt had been made to ravish her.

Starkweather looked shaken Friday for the first time during the trial. He wore a green cotton shirt open at the collar and looked sweaty. He didn't have his customary chewing gum and the smirk was gone from his face, although he managed a few wan smiles.

His tiny redhaired mother, was at his side at the defense table when the verdict was announced. Shortly after, she rose and walked hurriedly to the privacy of the judge's chambers.

Charlie's father, Guy, arrived at the courtroom seconds after the jury returned the verdict.

He said that he talked to Charles after the verdict and his son told him:

"I committed some of these crimes and if I want to make my atonement to God and be electrocuted, that's my business."

The 70-year-old Lancaster County courthouse was filled with police. They lined the corridors and the stairs as Charlie was led in a waist chain to the sheriff's car for the trip back to the penitentiary, where he will die.

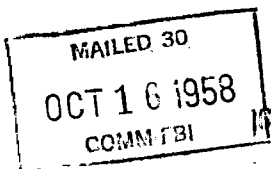

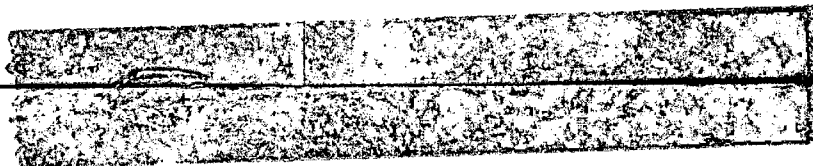
