Re Bureau letter to SAC, Atlanta 9/2/64.

Referenced communication advises the following hate organizations operating within the Chicago Division as included in this program:

American Nazi Party (Origin: Richmond)

White Youth Corps (Origin: Chicago)

Regarding the White Youth Corps it is noted confidential informants of this division have advised that the White Youth Corps in Chicago did not, in fact, exist as a organization per se but was considered rather a "level of affiliation" within the structure of the American Nazi Party at Chicago, Illinois. All operations of this unit were subsequently combined with those of the American Nazi Party and were carried on under that name only. The White Youth Corps was determined to no longer exist in any way in Chicago and no information has developed to indicate the possible reorganization of this group.

On October 12, 1964, [REDACTED]

[REDACTED] all of whom have furnished reliable information in the past, advised that the White Youth Corps no longer exists in any capacity in Chicago. To sources' knowledge the White Youth Corps does not operate as an organization in any other locale known to them. These sources further advised that as of this date no information is available to indicate possible interest in reorganizing the White Youth Corps.

In view of the above, Chicago contemplates no further inquiry regarding the White Youth Corps itself and in that the White Youth Corps is no longer in existence, it will not be considered in connection with this program.

Regarding Chicago's proposed plan to expose, disrupt and otherwise neutralize the American Nazi Party in Chicago, Illinois, the following is submitted for the Bureau's consideration:

I. Proposal -- To Increase Financial Burden  
of the American Nazi Party

Brief Resume of Current  
Economic Problems

The principal weakness in the Chicago unit of the American Nazi Party exists in their lack of funds to operate. This fact alone has forestalled all the participation of the Chicago organization in public demonstrations and other activities in that sufficient monies are not available to provide necessary bonds and/or fines should members be arrested during the course of such activity.

Further, the Chicago American Nazi Party has recently purchased a building which they utilize as a headquarters. The building is old and in dire need of repair. Mortgage payments and maintenance alone absorb the bulk of all funds which the Chicago unit collects.

Proposed Plan of Approach

In that it is the desire of the local American Nazi Party to "hold onto" their headquarters building at all costs, it is apparent that the first line of approach to increase the organization's financial burden is to direct our efforts at the headquarters building itself.

Discreet inquiry and observation has shown the building has numerous building code violations, some of

which make the building mainly uninhabitable until such violations are rectified such as electrical wiring and plumbing. It is recognized that building code authorities will allow such deficiencies to exist for a reasonable period of time and during such time habitation on the premises is permitted. Violations such as those mentioned are known to be costly to eliminate and are of the type that cannot or should not be "do-it-yourself" projects since repairs made are subject to inspection by building authorities.

In that the American Nazi Party has in the past and still levels its attacks at persons of the Jewish faith, Chicago Jewish organizations are most desirable of accumulating information which can serve to initiate an attack by these organizations against the American Nazi Party. Prominent among such organizations are the Jewish War Veterans and the Anti-Defamation League B'nai B'rith. U.S.A.

The Chicago Division, either by direct approach to established sources in these organizations, or through use of suitable pretext, can make available to appropriate officials information establishing the fact that such building code violations do exist. There is no doubt that should such information become available to proper individuals within these organizations, great pressure will be brought to bear to insist that these building code violations are corrected and the possibility strongly exists that court action may follow and fines may be levied.

As an alternative, a direct approach can be made to established contacts within the city government to bring such building code violations to the attention of appropriate authorities.

#### Anticipated Results

A penetrating analysis of the present economic situation of the American Nazi Party strongly indicates

that by firmly increasing the financial burden of this group the following results are certain:

1. American Nazi Party public activity will be held to the barest minimum due to fear of possible arrest resulting in further economic hardship.
2. Funds will not be available to bring about necessary repairs on the headquarters building.
3. Funds for the printing and distribution of literature locally for recruiting purposes would not be available.
4. Morale of the organization in Chicago, which is now at low ebb would be further lessened thus creating feelings of dissatisfaction among the membership.
5. As a direct result of items above the attractiveness of the American Nazi Party to possible recruits would be held at a minimum.

## II. Proposal -- Divide Loyalty of Membership Against Present Leaders

### Brief Resume of Leadership Problems

b7c At the present time the Chicago American Nazi Party has no established leaders. One of the members, [REDACTED] was appointed by GEORGE LINCOLN ROCKWELL, the group's national commander, however, [REDACTED] has failed to undertake the responsibilities of leadership and as a result certain dissatisfaction exists among members.

As a result of [REDACTED] failure current activities of the organization are being directed by [REDACTED] who is operating without authority of the national headquarters.

b7c Because of the inactivity and the failure of the Chicago organization to demonstrate progress the so-called "hard core" of the membership have raised numerous questions in the recent past challenging the adequacy and capability of [REDACTED] to head their organization in Chicago.

#### Proposed Plan of Approach

It is anticipated that through established sources all of whom are current members of the American Nazi Party in Chicago, feelings of discontent can be initiated. Further, communications which would indicate a thorough and substantial knowledge of the Chicago organization could be directed at the National Commander GEORGE LINCOLN ROCKWELL either anonymously or under the signature of a likely member who is known to be in disagreement with local leadership and practices.

#### Anticipated Results

By concentrating the efforts of this program in a firm but carefully concealed manner it is strongly believed that the following results will be obtained:

1. Loyalties of the membership will be divided and dissension will be created.
2. The national headquarters of the American Nazi Party will have sufficient reason to question the adequacy and capabilities of local leadership.
3. Through established sources programs proposed by those in leadership capacities can be sabotaged whereby the confidence of both the national headquarters and the local membership will be shattered.

It is recognized that the Bureau considers it vital that the functions and membership of these organizations be brought into the "public spotlight". [REDACTED]

The Bureau concurs with your comments relating to counterintelligence action directed against the headquarters building of the American Nazi Party (ANP) in Chicago. However, before initiating counterintelligence action, you should specifically advise the identities of individuals active in Jewish organizations or connected with the City Government whom you desire to alert to violations of the building code at the ANP building. If it is your intention to alert these individuals through the use of anonymous letters, you should outline the contents of such letters. If you recommend they be alerted by anonymous telephone calls, advise the pretext you intend to use. If you desire to effect your counterintelligence objectives through direct contact with established sources, advise the identity of such sources and furnish assurances they will not reveal the Bureau's interest.

Also submit drafts of the letters you propose to send to ANP Commander, George Lincoln Rockwell, ostensibly from an ANP member, critical of the conduct of Chicago leaders of the organization.

However, insure your efforts in this regard do not jeopardize the security of your informants. Advise the Bureau of any positive results of the disruptive action conducted by your informants.

a most cooperative attitude. Because of his past affiliation with the city of Chicago, he is in an excellent position to establish personal liaison with appropriate building authorities and thus preclude direct contact by Bureau agents.

Nothing is available to the Chicago Division which would preclude contact with either [REDACTED] regarding the initiation of city action against the AMP Headquarters Building.

b7c In view of the above, Bureau authority is requested to contact identified individuals and to furnish these persons with full details regarding the physical makeup of the headquarters building and its potential building violations. [REDACTED] it is suggested he be approached regarding other possible code or zoning violations that may well be applied to utilizing the building as the AMP contemplates.

The Chicago Division has continued its consideration in connection with this program to expose, disrupt and otherwise neutralize the American Nazi Party (ANP) at Chicago, Illinois. In this regard, Chicago anticipates initiation of this program by directing attention to the Headquarters Building of the ANP in Chicago, looking toward the increase of the financial burden of the ANP.

As previously noted, the ANP has and continues to level its attacks against persons of the Jewish faith. Because of this, persons within the Jewish community in Chicago have indicated their strong desire to do all that is possible to eliminate the ANP, especially in the Chicago area.

Prominent among organizations so concerned is the Anti-Defamation League, B'nai B'rith, who through [redacted] has actively engaged in efforts to disband and otherwise eliminate the ANP from the Chicago scene. [redacted] it should be known, is and has been for some years an established contact of this office. He has, on repeated occasions, furnished this Bureau with information of value in cases under investigation and has demonstrated his reliability as well as the fact that his contacts with this Bureau are always to remain in complete confidence.

[redacted] who is Jewish, has demonstrated an active interest in the affairs of the ANP at Chicago and has been most vocal in denouncing them and looking toward their elimination. [redacted] has been confidentially contacted on numerous occasions by agents of this Division relative to the investigation of the ANP and has demonstrated

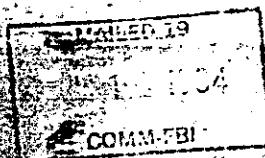

In reply to the Bureau's request that Chicago submit a detailed listing of the building code violations existing in the headquarters building of the Chicago American Nazi Party, the following appraisal of the building is submitted as taken from a [REDACTED]

"The Chicago Branch of the American Nazi Party (ANP) is currently living in and using their new headquarters located at 1314 West Ohio Street, Chicago, Illinois. From all appearances this building will be a bigger handicap to the organization than it will be a benefit. It is an old, old structure badly in need of repair and at best can be described as a fire trap. Some of the membership held high hopes that the building could be brought into decent repair, however, it is highly doubtful.

The building itself is a three story brick and frame structure painted a dull gray. The outside is badly in need of a new paint job. The building has a store in front which has not been used in some time and its windows are boarded up. You cannot enter the building through the store entrance. The only available entrances are outside stairways leading up the side and rear of the building. These stairways are narrow and very unsteady. Pieces of the stairs have broken away and have not been replaced.

The main floor of the building is divided into three general areas. The abandoned store, it is hoped, will be converted into a meeting hall. Two other smaller rooms are attached thereto, one of which the organization hopes to convert into a printing room. The other will be used for storage purposes. The floor of the store was originally made of wood, then covered with a cement-like substance on which tile was placed. The tile is rising up, breaking off and the cement is cracking. The original floor is showing through. The second floor consists of two apartments, one to the front of the building, one to the rear. Two such apartments are located on the third floor of the building. Both the second and third floors of the building are divided by a narrow hallway running from one side of the building to the other. Each of these lead to an outside porch and then to the outside stairway. Each of the apartments consist of a living room, bedroom, bath and kitchen. There are appliances of sorts in the kitchens and each of the apartments are supposedly furnished. The furniture, however, is very old, stained, dirty and so much in need of repair that it has been necessary to nail boards to certain pieces to keep them together.

The plaster on the interior of the building is in such bad shape, so patched, cracked and patched again that it gives the appearance of stucco rather than smooth wall plaster. The woodwork has been painted over so many times that layer upon layer of paint is noticeable.

The building has a basement which is of little or no use and a two car brick garage to the rear of the building. The so-called backyard is fenced. The building is located on a piece of property approximately 40 feet wide by 125 feet in length.

The electrical wiring in the building is badly in need of repair. Bathroom lights are merely light bulbs protruding from the wall and no switches are attached thereto. One must turn the light on by screwing the bulb in the socket. In other rooms the lighting is merely a drop cord hanging from the ceiling. There are no outside lights on the porches of the building.

The plumbing of the building is of principal concern. The main waste pipe is badly in need of repair and none of the bathrooms have sinks.

Most of these electrical and plumbing repairs must be made if the party proposes to continue residing in the building.

Many of the windows in the building are broken. The whole building is dirty, musty, and generally unfit for habitation."

The various specifications of the Chicago Building Code and the policy of enforcement is not known to Chicago. It is believed, however, that the above appraisal of the headquarters, coupled with personal observation of the premises by Special Agents of this office, strongly indicate the existence of numerous violations. Further, if a penetrating inspection of the headquarters can be made as a result of discreet efforts on the part of the Chicago Division, it is further believed that a number of violations evident only to building and/or fire inspectors may possibly be brought to light.

Specifically the following are noted:

- 1) The building may well have numerous fire violations based on its appearance and obvious state of ill repair. This may be especially true for proposed multiple habitation.
- 2) Outside stairways leading from building exits on the second and third floors are narrow and in need of repair.
- 3) Electrical work appears most necessary. Exposed fixtures without switches are found in the bathrooms of the building. No lighting is found on outside premises and stairways.
- 4) Plumbing appears obviously inadequate. As noted above, the main waste pipe is badly in need of repair, and no sinks are available in the bathrooms.
- 5) It has been noted that apartments mentioned above are individually heated with "space type heaters". It is suggested that

because of these conditions, fire hazards may well be in existence.

It is the above conditions that Chicago desires to confidentially bring to the attention of individuals mentioned in Chicago communication dated 11/27/64. It is anticipated that when such information is brought to the attention of these individuals, appropriate arrangements can be made to initiate action for such a building and fire inspection. Bureau authority is therefore requested to initiate action as detailed in this and previous communications.

In furtherance of Chicago's proposed plan to expose, disrupt and otherwise neutralize the American Nazi Party (ANP) in Chicago, Illinois, the following information is submitted for the Bureau's consideration in connection with previously submitted proposals.

It is noted that the membership of the Chicago ANP has recently on its own initiative undertaken certain necessary repairs to the headquarters building of that organization located at 1314 West Ohio Street, Chicago, Illinois. According to available information, [redacted]

[redacted] has undertaken a personal bank loan in an effort to satisfy the cost of such repairs. [redacted] has been said to be for all intents and purposes the principal source of income for the ANP at Chicago, Illinois.

Because of the above it is believed that it now would be an appropriate time to bring to bear additional pressure on the ANP.

In consideration of this fact it is noted for the Bureau's information that in past years the Jewish War Veterans at Chicago, Illinois, have been most vocal in their protests against the ANP. Recently, however, their opposition to this organization has not been evident. It is therefore suggested that the following letter be forwarded to the Jewish War Veterans at Chicago in an effort to direct their interest once again to the activities of the ANP in Chicago.

"Gentlemen:

"Recently my wife had occasion to ride in a Checker Cab in Chicago with a most outspoken young driver. Immediately after setting out for our home the driver engaged my wife in conversation denouncing the 'dirty Jews and Niggers' in Chicago. He proceeded to blame every ill we face today on the Negro and Jew. When my wife cautioned him that he was then speaking with a Jew, he told her in so many words that he couldn't care less. He praised the Nazi Rockwell and mentioned what appeared to be his association with Rockwell's Nazi Party. He was even so bold as to mention their headquarters at 1314 West Ohio Street.

"When my wife told me of this incident I took it upon myself to look over this stronghold of Nazism in Chicago. Gentlemen, this is an unimpressive building which could best be described as a firetrap.

"The thing that does impress me, however, is that the youth of today in this country could at all be taken with a philosophy you and I know should be dreaded. If this young man is typical of the attitude of Rockwell's followers then we must take action.

"Though a Jew myself I am not a member of your organization. You have, however, in the past well represented the things that all Americans, no matter their creed or color, hold so dear.

"Now gentlemen, I fear I must chastise you. I know that you have been vocal in your protests of the Nazis in Chicago in the past. An organization like yours can do little else but fight such a disease as this. Why then in recent months have we heard nothing from you in this regard?

"Please, gentlemen, go see for yourselves this headquarters of the Nazis. Do what you can, and now, to put them out of business. Don't fail us now. All Americans need groups like yours, not only the Jew and the Negro. I am sorry, I lack the courage to identify myself. This is even further reason why you must, must speak for me."

For the information of the Bureau, the Chicago Office has recently received information indicating that such incidents as set forth in the letter regarding a Checker Cab driver have occurred in the Chicago area. Chicago has initiated inquiry concerning this and has identified the driver in question as one [REDACTED]

b7c [REDACTED] was discharged from the Checker Cab Company as a result of several complaints similar to the above having been received from passengers.

Bureau authorization is requested to forward above letter to the Jewish War Veterans at Chicago, Illinois.

The Chicago Office has advised that the American Nazi Party (ANP) organization in that city is operating its organization and headquarters under a severe financial strain. Chicago believes that if the proper individuals could be alerted to violations of building and fire codes at the ANP Headquarters, it would further increase the organization's financial burdens because repairs would be extensive and there is a probability fines would be leveled.

LEVIED.

Two established sources of the Chicago Office are of Jewish background and have expressed an interest in the ANP which has frequently attacked persons of Jewish faith.

Both these individuals have been confidentially contacted on numerous occasions and both have demonstrated their reliability and their awareness of the fact that their associations with the Bureau must be kept in confidence. The Chicago Office recommends that these individuals be furnished details regarding building and fire code violations at ANP Headquarters in Chicago. There is no security factor involved.

## RECOMMENDATION:

That the attached letter be sent to Chicago authorizing that office to confidentially alert

to violations of building and fire code regulations at ANP Headquarters in Chicago in anticipation these individuals will inspire action by appropriate authorities.

Re the information of the Bureau, it is noted that [redacted] ANP, Chicago, Illinois, on May 7, 1965, called the Chicago Office at which time he identified himself as a lieutenant in the ANP because of which he stated he was classified as an Officer in Chicago at Chicago. [redacted] advised he wished to make a complaint that his civil rights were being violated. He explained that the ANP at Chicago had lost their former headquarters, 2124 North Damen Avenue, as a result of numerous building violations brought against their building and because of pressure put on them by the City of Chicago. He stated the ANP is currently purchasing headquarters at 1314 West Ohio Street, Chicago, Illinois, and he noted that a number of building violations exist against this structure.

[redacted] stated that as a result of the building violations brought against the structure he met with [redacted] Commissioner of Buildings, City of Chicago, who advised [redacted] that the organization could not meet in the building or be allowed to stay in the building if they did not meet proper building requirements. It is [redacted] claim that the Office of the Zoning Administrator has advised that ANP has in fact met required zoning laws.

[redacted] stated that the City of Chicago has brought a charge against him, [redacted] another member of the organization in Chicago, and against the owner of the building. The sum of \$1,000.00 is being claimed on behalf of the city because of building violations.

It was because of these facts that [redacted] claimed his civil rights are being violated in that he alleges he is being denied the right to choose his own place of residence and his right to assemble. He charged that Chicago laws are not being uniformly enforced.

For the further information of the Bureau in regard to tangible results of captioned program, it is the belief of the Chicago Division that should continued pressure be exerted by the City of Chicago against the ANP it could well serve in the future to initiate the dissolution of that organization in this area. Confidential informants have continually noted inadequate finances serve as one of the chief problems of the Chicago ANP Division. If the party at Chicago complies with directives of the city and continues to repair the dwelling in which they now maintain headquarters, the cost of such repairs may well prove prohibitive. If they decline to comply as directed, the costs of probable forthcoming fines could also work an extreme hardship on the group.

To disrupt and neutralize the American Nazi Party in Chicago, last January you confidentially alerted your source, [REDACTED] who has proven to be most cooperative and reliable in the past, to the many obvious building and fire code violations in the decrepit Chicago headquarters of this extremist organization. As a direct result, the City of Chicago has taken action against the Nazis in the form of fines and pressures to correct the violations under threat of forced eviction. The "Officer in Charge" of the Chicago Nazis has now appeared at our Chicago Office protesting his "civil rights" were being violated.

[REDACTED] who claims to be the local American Nazi Party leader, advised the Chicago Office on 5/7/65 that his organization had lost their former headquarters because of building violations and pressures by the City of Chicago, and he was now in fear the organization would be prohibited from meeting or residing at its new headquarters, which it is now in the process of purchasing, because of building violations. [REDACTED] related that Chicago had levied a \$1,000 fine on the headquarters, and the Commissioner of Buildings will not permit the Nazis to remain in the headquarters until the violations are corrected. It was the contention of the Chicago would be "Fuhrer" that his civil rights were being denied, in that he was not being allowed to choose his residence and place of assembly. He charged further that Chicago laws were not being uniformly enforced.

The Chicago Office believes this counterintelligence action may result in the eventual dissolution of the American Nazi Party in the Chicago area. The local organization is suffering from a lack of funds, and the cost of repairs to the headquarters may be prohibitive. On the other hand, if the Nazis decline to make the required repairs they will be burdened with fines and possibly denied the use of their headquarters building.

"The Allied Linoleum Store is operated by John Gilman, former executive secretary of the old Wisconsin Civil Rights Congress, reportedly a CP front.

"Milwaukee authorities said Gilman has taken part in civil rights demonstrations as well as demonstrations against the Viet Nam war.

"The linoleum store was blasted by a short pipe stuffed with explosives.

"The NAACP blast also involved a short piece of pipe filled with explosives."

b7c The legal dispute between the City of Chicago Building Department and the ANP Building, 1314 West Ohio Street, over building violations continues. Chicago Unit ANP leader [REDACTED] and ANP member [REDACTED] were jailed on this matter from 9/16 through 9/26/66.

Judge RICHARD NAPALITANO, Building Court, ruled on 12/22/66 that the building was to be closed until building violations were corrected and the premises vacated by 1/4/67. Chicago ANP sources have advised that the ANP will appeal this latter ruling in hopes of keeping control of the building.

b7c GEORGE LINCOLN ROCKWELL has a scheduled court appearance in Evanston, Illinois, on 1/30/67 stemming from his arrest [REDACTED] on 8/29/66 on a disorderly conduct charge.

On 10/31/66 [REDACTED] and three other members of the ANP were arrested by the Chicago Police Department at Kennedy High School, Chicago, on a disorderly conduct charge after they attempted to arrange a picket at this school. On 12/1/66 [REDACTED] and one other ANP member, were fined \$200 each.

b7c Chicago ANP sources have advised that court costs, fines and appeals have exhausted the financial resources of the Chicago ANP Unit, which were meager to begin with, and considerable monies need to be raised to continue their attorney fees and other court costs. The Chicago Unit phone has been disconnected for non-payment and [REDACTED] has personally gone into considerable debt to pay some of these costs. Finances have pretty much demoralized the local unit at this time.

hold regular meetings (generally weekly and on Saturday evenings) at 2237 North Western Avenue, Chicago. During early October, 1966, a three year lease was signed for building space utilized by NSRP at 2237 North Western by [REDACTED], Chicago Branch, NSRP.

[REDACTED] both active in NSRP at Chicago, were found guilty on 9/22/66 of disorderly conduct and distributing immoral and indecent anti-Negro literature on 6/25/66. [REDACTED] made bond of \$400. [REDACTED] served 30 days during 1966. Both desire to appeal convictions prior to conducting any other NSRP activities.

On 11/26/66 [REDACTED] spoke to group at NSRP Chicago headquarters with approximately 50 persons in attendance. [REDACTED] indicated he was working on appeal for [REDACTED]. With exception of meeting 11/26/66, all meetings are attended by less than 15 persons, generally seven to ten members, who are described as "hard core".

On 12/8/66 [REDACTED] was fined \$25 at Hillside, Illinois, for being in possession of a tear gas gun. [REDACTED] attorney's fee was \$500. [REDACTED] was ridiculed for having utilized a Jewish attorney to represent him.

[REDACTED] has attended only one meeting in past five weeks. Members of Chicago Branch feel [REDACTED] has lost interest and should be replaced. Interest at all time low, due to arrests of members, lack of funds and general apathy.

[REDACTED] advised that [REDACTED] was invited to return to NSRP and assume leadership as general deterioration in NSRP activities had occurred. [REDACTED] declined bid to return at this time, indicating he would reconsider if new members were obtained.

Records of Superior Court of Fulton County, Georgia, show that this Klan organization was granted a corporate charter on February 21, 1961, at Atlanta, Georgia, under the name United Klans, Knights of the Ku Klux Klan of America, Inc.

A source advised on February 27, 1961, that United Klans was formed as a result of a split in the U.S. Klans, Knights of the Ku Klux Klan, Inc. According to the source, the split resulted from a leadership dispute and United Klans has the same aims and objectives as the parent group. These are the promotion of Americanism, white supremacy and segregation of the races.

The first source and a second source advised in July, 1961, that United Klans, Knights of the Ku Klux Klan of America, Inc., merged with Alabama Knights, Knights of the Ku Klux Klan. The merged organization established headquarters in Suite 401, the Alston Building, Tuscaloosa, Alabama. The organization is directed by Robert Shelton, Imperial Wizard, and is the dominant Klan group in the South with units in several Southern cities.

On August 14, 1961, the second source advised that the organization formerly known as United Klans, Knights of the Ku Klux Klan of America, Inc., would be known in the future as United Klans of America, Inc., Knights of the Ku Klux Klan. The second source said the name was changed by a resolution adopted at the National Klavocation held July 8, 1961, at Indian Springs, Georgia.

The second source advised that at a meeting at Prattville, Alabama, on October 22, 1961, a majority of the Klaverns of the U.S. Klans, Knights of the Ku Klux Klan merged with the United Klans of America, Inc., Knights of the Ku Klux Klan.

Sources utilized in connection with above organization have furnished reliable information in the past.

Concerning the Church League of America, it is noted that an article which appeared on Page 10, Section 1B of the "Chicago Tribune", a daily newspaper of general circulation in the Chicago area, on March 13, 1967, reported on a three day symposium on International Communism held at the Sheraton-Chicago Hotel (March 10, 11 and 12, 1967), sponsored by the Church League of America, which was described in the article as a Christian oriented anti-communist group.

In an article which appeared on page 61 of the "Chicago Sun-Times", also a daily newspaper of general circulation in the Chicago area, on March 13, 1967, reporting on above-referred to international symposium on communism, sponsored by the Church League of America, the following is reflected:

"A League spokesman described it as a group of lay persons opposed to liberization of Protestant churches in America".

RICHARD NAPOLITANO, had ordered that the building was to be closed and vacated by 1/4/67, however, the local ANP unit won an appeal on this point and were permitted to remain in the building pending this appeal.

Within the past month, several members of the ANP have been in the Gage Park-Marquette Park area of Chicago attempting to gain support for their organization among the residents of this area. This is the area of several Chicago Freedom Movement-Southern Christian Leadership Conference open housing civil rights marches during the summer of 1966. The ANP members were stopped by the police and warned that if they pursued this activity they would be arrested and possibly charged with inciting a riot.

[redacted] advised during February, 1967, that the Chicago Chapter of the NSRP is without funds, has no interested members and could not maintain a "meeting place."

[redacted] stated he was all through with NSRP activities at Chicago and would not associate with any of the NSRP members because of his disillusionment with them.

[redacted] advised [redacted] that NSRP at Chicago ceases to function at the present time. The legal dispute between the City of Chicago Building Department and NSWPP Building continues. The right of the NSWPP to remain in the building at 1314 West Ohio is the subject of a current appeal.

Within the past several months members of the Chicago Division of the NSWPP have been arrested for engaging in NSWPP activities. Three members of the local unit were arrested in Louisville, Kentucky on 4/20/67, where their trial will be conducted and next scheduled appearance is 7/7/67 in Louisville. The charge in this matter was criminal syndicalism. Also 2 members of the local unit were arrested near Warrenville, Illinois, on 6/22/67, in the act of distributing NSWPP literature at the site of a proposed civil rights tent-in. This matter is pending.

Other fines and lawyer's fees continue to drain the funds of the Chicago Unit, NSWPP. Recently at a Party Officers Conference, in Arlington, Virginia, GEORGE LINCOLN ROCKWELL instructed the Chicago Unit to instigate any large scale activity until some of the current bills are cleaned up at the Chicago Headquarters.

The Chicago Branch of the NSRP is presently defunct and has been so since 3/1/67 having vacated their headquarters due to lack of funds, interest, and membership. All semblance of an organization has disappeared.

Submitted herewith in accordance with Bureau instructions regarding captioned program are statistics of the Chicago Division for the period January 1, 1968, through March 31, 1968.

## I. POTENTIAL COUNTERINTELLIGENCE ACTION

### NATIONAL SOCIALIST WHITE PEOPLES PARTY (NSWPP), aka, Chicago Unit

Since January, 1968, the Chicago Unit, NSWPP, has been without a headquarters building. The City of Chicago through its building department and the courts were successful in bringing pressure to bear on certain building violations which resulted in the closing of the building.

Subsequently, [REDACTED] the Chicago Unit, and the dominant NSWPP figure in Chicago, and [REDACTED] Secretary, NSWPP, moved to the NSWPP National headquarters in Arlington, Virginia.

b7c The local Chicago unit is held together to some degree by [REDACTED], formerly Second in Command at Chicago. [REDACTED] has an apartment at 624 May Street and party members do get together informally here from time to time.

With the closing of the NSWPP building and the departure of [REDACTED] and the coverage afforded the NSWPP by Chicago sources, there is little organization remaining.

Because of this disorganization and lack of leadership, the group's potential for disruption is lessened.

Also, recently a Chicago source has reported a splintering action against the NSWPP by one [REDACTED] a former NSWPP officer, who is disgruntled and is desirous of forming his own group with support taken from present NSWPP members and sympathizers.

(NSRP) CHICAGO BRANCH

The Chicago Branch of the NSRP have been relatively inactive since they closed their Chicago headquarters in March, 1967.

In December, 1967, Chicago NSRP members assumed complete control of the Cook County Committee of Wallace for President. All directors of the committee are NSRP members or sympathizers.

In February, 1968, National Officials of Wallace for President Committee visited Chicago with WALLACE. At this time, these officials indicated that the previously organized Cook County Committee of Wallace For President would cease to represent the WALLACE organization.

By this action, NSRP members who dominated the Cook County Committee for Wallace were reduced in importance in the overall Wallace for President group.

Despite this action, NSRP members, Chicago are devoting efforts at this time to seek WALLACE support.

[REDACTED] opened up a headquarters office in February, 1968 at 1149 West Addison, Chicago, Illinois, under the subterfuge of an advertising agency.

Through liaison with the Chicago Police Department and on action by the Chicago Police Department, the owner of the building at 1149 West Addison was apprised of the Klan operation and he has since forced [REDACTED] to vacate the premises.

Recently [REDACTED] or his representative, have contacted members of the NSWPP [REDACTED] and these [REDACTED] are also following [REDACTED] activities in this area.

[REDACTED] has done considerable speaking in the area and appears to be concentrating on opposing open housing and busing of students.

Richard J. Shelton, director of the recently opened, hippie-oriented Electric Theatre, 4612 North Clark, and a woman companion, Jacqueline Spicer, 21, of 1938 N. North Park, were charged with possession of marijuana.

Narcotics detective Jim Moran said Shelton told of his relationship to the KKK imperial wizard while being processed at Police Headquarters.

Detectives Bernard Brown and Richard Mc Kaley raided the North Park apartment on a search warrant. They said they found nine grams of marijuana-enough to roll 80 to 90 cigarettes-in a sealed envelope, a canister and a plastic box.

Shelton and Miss Spicer were scheduled to appear in Narcotics Court May 8."

## Nerarious is apt word to describe Klansmen

Termed by President Lyndon B. Johnson "a hooded society of bigots" and by Federal Bureau of Investigation Director J. Edgar Hoover "cowardly jackals," members of the Ku Klux Klan enjoy little respect from authorities.

They deserve no respect from informed and responsible citizens.

Herald-News articles this week revealing the existence of a Joliet-Lockport unit merely confirms recent reports of increased organizational and recruiting activity in northern states. The resurgence of the Klan, which was all but dead 15 years ago, began shortly after United States Supreme Court forced desegregation of schools in 1954. The activity was accelerated by passage of the Civil Rights Act of 1964.

The Klan is a haven for the totally and openly frustrated and embittered, for those who not only tolerate violence, but condone it and even commit it.

Over the years, the Klan history has been one of terror and violence. It has provided a cloak for irresponsible and bloodthirsty hoodlums to engage in crimes.

Although Klan violence has become greater in recent years through increased use of weapons, its inherent weakness is in the characteristics of the men it attracts.

Most of the leaders and members have limited education, have extremely narrow outlooks and interests, and are handicapped in making sound judgments.

Because of lack of status, they feel inadequate, discontented, frustrated and vindictive.

The Klan with its costumes, its ridiculous mysterious titles, its flamboyant ceremony, its clandestine meetings — of course — the shared hatred for the Negro, the Jew, the Catholic and the foreign born provides a refuge from the everyday world they are incapable of facing.

Within the "klaverns," the "realms" and even including the "Imperial empire," there is a constant struggle for power among the opportunistic, unscrupulous and ruthless men who vie with each other for control.

Evidence of the intrigue within the organization is the knowledge that members are quick to help with disposing of leaders through the courts or by expulsion. Such sudden changes in leadership have occurred frequently in both the Illinois and Joliet-Lockport organizations.

Law agencies are, for the most part, aware of Klan activities by penetration of the organization through informers. Men who consider themselves pillars of strength are often reduced to quivering wrecks when they find that their "secret" identity is known to law-enforcing observers and they are called in for a friendly interview.

State and local authorities are kept informed of Klan activities and Klan leaders are well aware that they are watched closely.

It is this knowledge, certainly, which has prevented instances of violence locally.

Important as law enforcement is, however, in controlling the Klan's repugnant ideology, Hoover has placed the responsibility for curbing the Klan on the public.

# Ku Klux Klan

## chapter is active in Joliet area

On the eve of the 102nd anniversary of the Invisible Empire — the Ku Klux Klan — few Will County residents are aware that a Klan is active locally and has been fomenting for the past two years.

The last anniversary celebration at Richmond, Va., just one year ago Monday, was attended by Illinois representatives. Subsequently the Joliet-Lockport klavern received its charter from Robert M. Shelton of Tuscaloosa, Ala., Imperial Wizard

of the United Klans of America, Knights of the Ku Klux Klan.

Shelton's is the largest of 14 known Klan organizations in the nation with a membership of about 10,000.

Members of the Will County unit live in Joliet, Lockport, Plainfield, Manhattan, New Lenox, Elwood, but the center of the organization is apparently in Lockport.

A recent reshuffling of top Klansmen, common in the volatile Klan setup, resulted in a Lockport resident and Caterpillar Tractor Co. employee assuming the duties.

Exalted Cyclops, headman in the local unit.

Other members are known to be employed in local industrial plants in this area.

Meetings regularly scheduled for Tuesday nights, are at the home of the Exalted Cyclops or

ings he reportedly owns in Lockport.

Mail, however, is received at Post Office Box 785 in Joliet.

Reportedly the Joliet-Lockport klavern is waiting only for a more substantial membership to come out in the open.

The Exalted Cyclops has purchased a pickup truck in the official colors of the Klan. It has a red body and white top. At the proper time, a sign, already made, will be mounted on the rear in an appeal for new members.

Although Klan activity in this area apparently is limited, due in part to a close watch by the Federal Bureau of Investigation, members have reported infiltration of meetings of the National Association for the Advancement of Colored People.

"Just to see what they're up to," according to an informant.

Discussion at local Klan meetings deals mainly with means of distributing the volume of "hate" literature available — at a price — from the Tuscaloosa headquarters.

Among the many items offered are 45 rpm records such as one featuring "Happy Fats" bemoaning the fact that federal laws threaten to make "the promised land" a haven for "niggers."

Other things, which local Klansmen have helped distribute in Chicago, include a card advising, "You have just been patronized by a member of the United Klans of America." The other side bears the message

today is becoming a popular pastime among those who believe and practice segregation.

Matchbooks promote the presidential candidacy of George Wallace, former Alabama governor and an avowed segregationist. Bumper stickers advocating a Wallace vote and vilifying President Johnson are also popular.

"Fully documented" statements label the United Nations as the agent of the "foes of our household."

A pamphlet lists the principles of the Klan, among them the following:

"Roman Catholicism teaches the union of church and state with the church controlling the state — we believe in the eternal separation of church and state."

"The press is largely controlled by the Roman Catholic priesthood and Judaism."

"We believe in law and order. Many accusations have been brought against the Klan as lawbreakers. The accusations are purely newspaper propaganda. So far we have not heard of a single instance where the Klan, by an official act, has violated any law."

"We believe in white supremacy."

"The Klan believes that America is a white man's country and should be governed by white men. Yet the Klan is not anti-Negro. It is the Negro's friend — God drew the color line and man should so let it remain; read Acts 17:26 if you please."

"We believe in limitation of foreign immigration."

"We believe that the NAACP is a subversive organization and is infiltrated with Communist ideologies and should be abolished by legal means."

"We, the Klan, will never allow our blood-bought liberties to be crucified on a Roman cross and we will not yield to the integration of white and Negro races in our schools or anywhere else."

"We will follow the teachings of the Bible and not the unwise teachings of the U. N. A. N."

Supreme Court, which is not in keeping with the Constitution of the United States of America."

Other literature notes that the early "Ku Klux Klan" . . . was successful in driving out the carpetbaggers, scalawags and Negroes who had legally usurped the public offices of the southern states."

Required reading for good Klansmen is, they say — "Blood On My Hands," the story of Robert Shelton, also available from Tuscaloosa.

Literature is available intending to prove that the American Civil Liberties Union is a "breeding ground for subversives."

The Klan finds the income tax unpopular — as do many others — but the Klan goes further. "Indict every income tax collector for being an accessory to treason," a handbill reads.

Order blanks for records and literature are found in the Fiery Cross, the Klan's monthly publication, which is jam-packed with articles along a similar vein.

The cotton robe for the ordinary Klansman costs \$11. Satin robes worn by officers are \$18. The waist tie is \$2 and the mask is \$2.

According to the constitution of the United Klans of America, the order was first organized in Pulaski, Tenn., in May 1866 as a social club. A year later, it was reorganized as a "regulative and protective" organization.

The Klan disbanded in 1872 but was resurrected in its present form in October 1915 at Atlanta, Ga., as a "historical, social patriotic, military, benevolent, ritualistic, fraternal order or society."

The anniversary date of May 6 is set by the constitution.

The United Klans of America, Knights of the Ku Klux Klan, is the largest of the Klan organizations in the United States today. There are 14 in all.

Shelton was re-elected Imperial Wizard for a three-year term at the UKA convention in Tuscaloosa in September 1967.

He is currently free on appeal bond on a conviction for contempt of Congress in September 1966. The conviction followed his failure to produce records subpoenaed by the House Committee on Un-American Activities during hearing in 1965 on Klan groups.

Shelton received a one-year sentence and a \$1,000 fine. In his appearance as a witness before the House committee, he invoked the First, Fourth, Fifth and 14th Amendments in declining to answer questions.

Members of his organization have been accused in such crimes as the shotgun murder of Lt. Col. Lemuel A. Penn on a Georgia highway in 1964 and the fatal shooting of Mrs. Viola Liuzzo near Montgomery, Ala., in 1965.

Shelton has a multitude of the Klan."

There is the pending jail sentence. There are the mounting expenses resulting from court action against various members. There is the constant threat of penetration by FBI informants.

Most of all, he is apprehensive that opportunists within the Klan will seize control if prison gates close behind him as a result of his 1966 conviction.

Shelton's organization is not the one in which Chicago policemen were found to be involved recently. That was the National Knights of the Ku Klux Klan headed by James R. Venable of Tucker, Ga.

The Shelton group with 10,000 members has gained the most from the flurry of whites seeking membership after civil rights programs were initiated by the federal government.

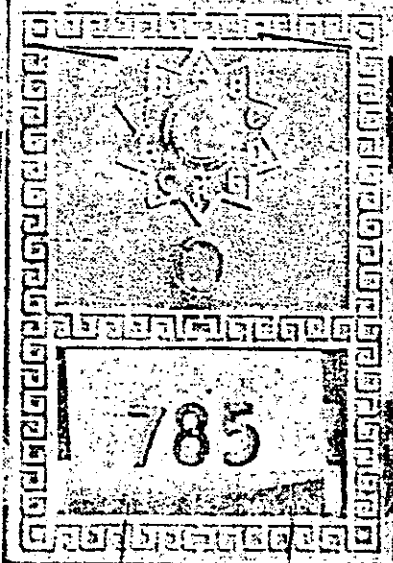
Although the Klan resurgence has brought current hard-core membership to more than 14,000 plus thousands of inactive members, supporters and sympathizers, it lacks unity of organization, according to FBI director J. Edgar Hoover.

In a 1966 article in the American Bar Association Journal, Hoover said, "The Klan represents a thoroughly repugnant ideology and force inimical to the welfare of our country, but actions by agencies of the government will not be sufficient by themselves to bring the Klan under control."

"In the final analysis, the primary responsibility for curbing the Klan rests with the public. Only an aroused and mobilized public demand for the protection of freedom under law will bring about control of the Klan and an end to its 100-year history of violence and lawlessness."

Therefore, key segments of the population . . . must join with governmental bodies in a constructive, systematic, coordinated and total effort against

And that is Hoover's wish for the KKK on its 102nd anniversary.

# On 102nd anniversary, the Klan faces troubles

The 102nd anniversary today of the Ku Klux Klan finds the organization faced with a variety of woes on both the Illinois and national level.

The former Grand Dragon of the Illinois realm now is serving a 15-year term in the Wisconsin State Penitentiary and Robert M. Shelton, Imperial Wizard of the United Klans of America, Knights of the Ku Klux Klan, is on the verge of imprisonment on federal charges.

A chartered "klavern" in the Joliet area is one of the more recent additions to the Illinois realm. Members from Joliet, Lockport, Plainfield, Manhattan, Elwood and other communities meet regularly on Tuesday nights at the home of the Exalted Cyclops, the unit's top man, in Lockport.

Headquarters for the Illinois realm is at Winthrop Harbor, where a Bill Williams now rules as Grand Dragon.

Williams succeeded to his post last fall when his predecessor, Turner H. Cheney, was sentenced to a penitentiary term. Cheney, who had plans to attend last year's Klan anniversary fete at Richmond, Va., instead found himself charged with bombing a Milwaukee liquor store, suspected by Klansmen of being a hotbed of Communism.

His conviction followed testimony by a fellow Klansman, himself accused of conspiring to assassinate the Rev. James

Groppi, Milwaukee's controversial civil rights priest.

While free on bail prior to his trial, Cheney, a demonstrative fellow, was arrested in Cook County on a charge of hiring a man to wire an explosive to an enemy's car. That charge was later dropped.

Williams, who lives on California Avenue in Chicago, now clears all applicants for membership in Klans of his realm. He and the Joliet area Exalted Cyclops were victimized last fall by a Mattoon newspaperman.

The reporter, posing as a bartender, applied to Shelton in Tuscaloosa for Klan membership. His application was referred to Williams. Subsequently the reporter found himself among the membership at a Lockport meeting.

When he detailed his experiences in a series of five articles in the Mattoon daily, it led to consternation among Klansmen, who had been assured that their identity would remain secret.

The prospective member signs an application testifying to his belief in the "tenets of the Christian religion, the maintenance of white supremacy and

the principles of pure Americanism."

Membership is open in auxiliaries for women and teenagers.

Once "naturalized" the Klansman begins immediately paying dues of \$15 a year. Of that amount, 50 cents a month is forwarded to Imperial Headquarters at Tuscaloosa and 25 cents goes to the Illinois realm.

The member, through the Kligrapp — secretary — of his Klan orders his required robe

operation. You said that all resources must be directed to a secure and strong national organization with one headquarters; that before we can establish other branch headquarters we must make Arlington strong. Frank Collin appears to have other ideas I'm afraid as he has covertly tried to establish a headquarters here by seeking financial aid from several wealthy friends of the movement. He has confided to several of us that we will never really get off the ground here in Chicago and the Midwest until we have the headquarters. He says 'When Illinois is ours'. I believe an organization can have but one head with one goal and idea at a time.

"While it is true that some good work is being done here, I have witnessed real nerve on the part of Frank, I cannot in good conscience sit idly by while you and the other leaders at Arlington are ridiculed downgraded and looked upon as 'oafs', a hindrance rather than the leaders of National Socialism.

"If Collin is such an organizational genius and administrative giant - as he claims - maybe he should be back at Arlington where you can keep an eye on him.

Chicago feels that COLLIN, who has attempted to capitalize on racial situations in Cairo, Illinois, and as far away as East St. Louis, Missouri, is the one person keeping this NSWPP activity going in the Midwest.

As a result of the publicity on subject and his attempt to carry on a rally in Hyde Park yesterday, I was called by [REDACTED] a good friend of [REDACTED] who lives in our work; and advised him to contact me for the purpose of giving me the following information.

[REDACTED] advises that Frank Collin's [REDACTED] emigrated from Germany in February 1938, as a Jew. He was sponsored for entry into this country by [REDACTED]

[REDACTED] was given a job as a stock boy at the [REDACTED] Department Store and worked at the time with [REDACTED] who struck up a friendship with him. [REDACTED] told [REDACTED] that, right after the Crystal Night affair, he together with many other Jews was hauled off to Puchau Concentration Camp; that, after being horribly mistreated, he was able through bribes and pulling of strings to get released.

When he came here he changed his name from [REDACTED] to [REDACTED] so that he would avoid any anti-Semitism. His home had been in Munich where his father had a very profitable business. His father was Jewish but his mother was non-Jewish. His father was able to liquidate his business and was allowed to take 11% of the value of his property by the Hitler government.

Prior to the entry of the U. S. to World War II, [REDACTED] was investigated by the FBI by reason of his having made a statement that "Hitler is good for the German People, but the way he was doing it was wrong."

During the war, [REDACTED] was in the service. When he got out, he looked up [REDACTED] who offered him a job in his business, making slip-covers. He took the job and subsequently, together with two others, bought the business from [REDACTED]. It was a wholesale contract business. [REDACTED] went into a retail business. [REDACTED] operating as [REDACTED] and was a customer of [REDACTED] wholesale business for a short time.

[REDACTED] told [REDACTED] in 1947 or 1948 that he was building a home in [REDACTED]. [REDACTED] had married an American girl of German-Catholic background and they had a son named [REDACTED] address, listed in the news story as [REDACTED] is the same address as [REDACTED]

[REDACTED] doesn't know whether Frank Collin is aware of the fact that one of

his grandfathers was Jewish. [redacted] also advised that [redacted] sister, [redacted] left Germany a little ahead of [redacted] and wound up in England. There she married a furrier, who was Jewish, and whose name he thought was [redacted]

[redacted] felt that if subject's partial Jewish background became known, it would prove very embarrassing to him among his Nazi friends. He feels that subject must be the son of the [redacted] as he knew as a refugee, particularly since the address given for subject is the same address as the one listed under [redacted]

Although this might make a good human interest story, it is my present inclination not to publicize subject and thereby increase the stumble-bum following he has currently.

The confidential source of the Chicago Office has furnished information which the Chicago Office has been able to document that Frank Collin's father emigrated from Germany in February, 1938, as a Jew and at the time of his naturalization, changed his name from Cohn to Collin. This information, of course, suggests an excellent counterintelligence possibility with good potential for disruptive results should it become known to NSWPP headquarters, an extremely anti-Semitic organization, that Frank Collin is of Jewish background.

the activities of Collin at least through interrogation of his associates. in an effort to determine if there was any merit in the facts as presented in my last letter. Arlington, however, has apparently decided to bury its head in the sand taking the position that the letter writer (anonymous me) is either jealous of Collin's position or trying to create a disruption for one reason or another. Neither could be further from the truth. If you only knew the true facts as they exist you would take immediate and harsh steps to remove this individual from any connection with the National Socialist Movement. How this person duped you in the first place is hard to imagine.

"I, of course, realize that an anonymous letter is a cowards way out and as such the merits of such a letter are always suspect. However, there are obvious and legitimate reasons why I will not divulge my identity at this time. I will not be put in the position of having to rely soley on my word against Frank's word -- if it came to that. I would rather give this information and hope that you people have enough interest in the future of the National Socialism to follow up on it.

"This will probably be the last letter I will write to you about Collin. If you don't act on this information, I will know you are keeping Collin hell or high water, and I will take the following facts to the newspapers and blow him right out of the water and probably National Socialism as well. Obviously I do not desire to do the latter.

Also the Chicago Division submitted an anonymous letter to the Arlington Headquarters reflecting on the previously unknown fact that FRANK COLLIN's father was Jewish.

The news media picked this up subsequently and COLLIN has been discredited and ridiculed in the press to a considerable degree.

The National Headquarters has suspended COLLIN and replaced him as Midwest Coordinator.

COLLIN has been forced to turn the local building over to the National Headquarters group because of this disclosure. It appears that the group will lose the building in the near future at any rate.

COLLIN plans to take legal action to retain the building and has announced plans to form a new party the "Nationalist Socialist Party of America."

Chicago has kept local authorities advised of the activities of this group. On April 19, 1970, officers of the Chicago Police Department arrested COLLIN and four other NSRP members. A number of weapons were seized.

#### B. United Knights of the Ku Klux Klan

A Chicago source is in a position to be alert for any information which may be used in a counterintelligence measure against this group, which is a newly formed unit. Meetings are infrequent and the group ineffective.

His Jewish blood undoes him

# City's top Nazi gets boot

BY JACK OULENEY

THE NATIONAL headquarters of the National Socialist White Peoples party—formerly the American Nazi party—has kicked out its midwest coordinator, Frank Collin, because he is part Jewish, CHICAGO TODAY has learned.

Collin refused to comment on the national party's move. He announced during a press conference yesterday that he was splitting from them because they didn't achieve the goals of "our late leader, George Lincoln Rockwell."

Collin told CHICAGO TODAY that his new organization, the National Socialist Party of America, would continue to operate out of its south side office despite claims by the national party that it owns the building.

A SOURCE in the Chicago police department told CHICAGO TODAY he has heard reports that the national group may attempt to take over by force the headquarters building at 2519 W. 71st st.

Collin said there were "treasonist people in this movement, the same people that gave Comdr. Rockwell trouble." For these reasons, he said, he was leaving the party to form his own.

However, a party spokesman, Robert Lloyd, told CHICAGO TODAY in a phone interview from Arlington, Va., that Collin had been expelled from the party June 15.

"WE DETERMINED that his father, Max Cohen, was a Jew who entered this country from Europe after World War II," Lloyd said. "As to his statements about form-

ing his own party, well, we're really not concerned with what he says or anything about him."

Another controversy between Collin and the national office revolves around the use and ownership of the Chicago headquarters.

Collin claims the building belongs to him and his members. "Monday night, some man who claimed he was from Virginia came in here and told us he was taking over," Collin said. "But we showed him papers that said the building belonged to us."

"WE TOLD him to leave, and when he didn't, we threw him out."

Lloyd says the building belongs to the National Socialist

White Peoples party, his party in Virginia.

If Collin refuses to leave, Lloyd said, "We will take action against him. O yes, legal action, to remove him."

The south side office was the scene of a bombing June 15, the same day Collin was kicked out of the Nazi party. The only damage to the structure was broken windows.

Collin claimed then the bombing was the work of members of the Students for a Democratic Society.

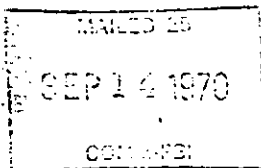

By letter dated July 27, 1956, captioned "MATTHIAS KOENL, JR., IS", [REDACTED] advised on July 17, 1956, that [REDACTED] recently had left New York for Chicago to be near MATT KOENL and that they were homosexual. Chicago files reflect that both [REDACTED] and MATT KOENL were living in New York at the same time and were perhaps living together. [REDACTED] and KOENL did reside together for a considerable period of time in Chicago.

Chicago concurs in the recommendation of Alexandria who could perhaps incorporate inferences to the above relationship with [REDACTED] in a letter.

It was the Chicago Division's feeling that in addition to the above, the Alexandria Division could arrange to have several subscriptions to "gay" magazines be taken out in KOENL's name. This literature could arrive at the NSWP Headquarters and would perhaps cause further disruption and suspicion among the officers and workers in the office.

It is the Chicago Division's thought that the proposed letter of Alexandria might indicate that all three persons recently at odds with KOENL; [REDACTED] had collaborated on writing the letter attacking KOENL as a homosexual and inept leader of National Socialism.

A case could perhaps be made describing how KOENL "purges" everyone with any ability or drive in the organization and one wonders if there is not more in the late assassination of Commander ROCKWELL than meets the eye.

warrants for several of their NSWPP attackers.

The NSWPP is attempting to wrest control of the building at 2519 West 75th Street through legal means.

Chicago is encouraging all of the above through its informants.
