United Press International (UPI) recently carried a news item noting that Christopher Caranbo was one of 65 black students who barricaded themselves at Boston University. The item noted that Caranbo's mother appeared at the barricaded building, called for her son to come out, and finally entered the building and brought him out.

Boston is requested to advise concerning this incident, furnish background information on Caranbo and his mother, advise whether this received extensive publicity, and furnish counterintelligence recommendations regarding this situation. No counterintelligence action is to be taken without Bureau authority. Handle any inquiries through established sources.

WALTHAM, Mass. (UPI) — It was a lesson well learned for Christopher A. Carambo: never underestimate the power of a woman especially — when the woman is your own mother.

Carambo was one of 65 black students at Brandeis University who for eight days have barricaded themselves in the school's communications center at Ford Hall and refused to come out. They are protesting alleged racist policies.

But Carambo's mother marched up to the barricaded building Tuesday afternoon, determined to get her son

back. She pruned on the door of the three-story brick building with her umbrella and then tried to climb in a window.

No back.

Finally in desperation and anger she called out, "Christopher Caramba, you come out of there. Come out! I haven't seen my son in a week. I don't believe in black power."

Carambo did not come out, but one of the other black students apparently relented, because soon the door opened and Mrs. Carambo went inside.

She reappeared a few minutes later -- with her son.

In view of the contents in reBulet, your recommendation to send an anonymous letter concerning [REDACTED], is being held in abeyance. If after review of [REDACTED], you are still of the opinion that counterintelligence should be aimed against [REDACTED] instead of [REDACTED], you may request Bureau authority to implement your recommendation in this regard.

Los Angeles promptly advise the Bureau and New York of the feasibility of mailing an anonymous letter to an official of the Black Panther Party (BPP) insinuating the [REDACTED] was the individual who informed the police of the fact [REDACTED] were attempting to transport firearms on a commercial aircraft. If it would not be logical for [REDACTED] to have been in possession of the information concerning [REDACTED] then no recommendation should be made that he was the police informant involved in this matter.

Los Angeles and New York take no action without obtaining prior Bureau authority.

Bulet 11/25/68, pointed out that there is a serious struggle taking place between the BPP and the US organization. The Bureau commented that the struggle has reached such proportions that it has taken on the aura of gang warfare with attendant threats of murder and reprisals.

Perhaps the Los Angeles Office would not want to consider the advisability of preparing an anonymous letter which would contain information to the effect that [REDACTED] told the Police that [REDACTED] were carrying firearms on a plane. [REDACTED] letter could be sent to an official of the BPP in Los Angeles or other individuals which Los Angeles deem advisable.

Bureau approval is hereby requested for New York and Los Angeles to place suggested counterintelligence measures into effect.

The Black Panther Party in Indianapolis continues to operate from their location at [redacted] Street, and [redacted]

Other counterintelligence measures have been to make known to the Negro community, and the other Negro organizations, any arrests of BPP members, and help them to see the kind of things the BPP is involved in. Also, arrests all over the United States of BPP members, and the type of incidents where the BPP is involved in shootings with the police, are being made known. This is being done so that the other Negro organizations are trying to help the Negro better himself and not let the BPP jeopardize the work that they have done, and this in turn is hoped will cause dissension between the BPP and the other Negro organizations. To what extent between the BPP and the other organizations has been observed, but how far it extends cannot yet be determined.

In reairtel Detroit advises that investigation of the Black Panther Party (BPP) in Detroit has failed to establish a connection between it and BPP headquarters in Oakland, California. Detroit suggests that letters addressed to independent BPP chapters throughout the country from BPP in Oakland demanding that the independent chapters submit to the authority of the Oakland headquarters and pay monthly dues will have the effect of arresting development of this organization on a national scale. San Francisco is being requested to submit its views concerning this suggestion.

Presently Detroit is attempting to develop
 the best possible means of counterintelligence action
 against the newly formed Black Panther Party (BPP) of
 Detroit. In this regard Detroit is considering mailing
 letters to respective BPP members utilizing the stationery
 of the Republic of New Africa (RNA) and pointing out in
 these letters to the recipients that the BPP is an unsavory
 organization which does not represent the interests of the
 black man.

Further, Detroit is attempting to develop ways
 of creating suspicion among Detroit leaders of the BPP with
 respect to their financial sources and loyalty to the Party.

and an attempt will be made to indicate that certain individuals are cooperating with local law enforcement officers. All concrete suggestions developed will be submitted to the Bureau for prior Bureau authority.

At the present time Detroit is awaiting results of the mailing of an anonymous letter to members of the RNA, which letter suggested that [REDACTED] is using RNA funds for his personal use. If results are determined to be favorable, Detroit will consider submitting a recommendation for circulating a similar letter to other RNA members in other cities.

2. Operations Being Effected.

3. Tangible Results.

Detroit believes that counterintelligence action taken against [REDACTED] and "The South End", Wayne State University's official School newspaper, has had favorable results, however, it is difficult to measure since public resentment against the newspaper "The South End" has grown and continues to grow rapidly. It is believed that Detroit's anonymous letters mailed to the Governor of Michigan, Board of Governors at Wayne State University, and other state officials played a major part in the reducing of "The South End" yearly allotted funds by \$10,000.00.

4. Developments of Counterintelligence Interest.

Investigation of the BPP of Detroit has failed to establish a connection with the BPP in Oakland, California, indicating that the Detroit BPP is at the present time an independent organization. Detroit
