Investigation being conducted by Milwaukee to determine identities of source grocery stores to determine amounts of contributions to BPP. It is recommended that copies of the Black Panther newspaper and copies of above newspaper article listing statements by [REDACTED] be forwarded to contributing grocery stores. It is further recommended that the Cross Lutheran Church and other churches who may be approached by the BPP concerning the Breakfast for Children Program be furnished with copies of the Black Panther newspaper and the above article in order to make them aware of the true nature of the BPP. It is further recommended that [REDACTED] be interviewed to determine the amount of disenchantment with the BPP and to determine whether they would cooperate with the FBI in providing information concerning local BPP activities and personnel.

Information contained in reMillet concerns the
Free Breakfast Program sponsored by the BPP in Milwaukee. This
communication recommended that copies of the BPP newspaper be
forwarded to contributing grocery stores. Milwaukee should
review reBulet and enclosures for assistance in determining
the type of communications to be mailed.

Upon completion of above, Milwaukee should make
specific recommendations as to the number of communications to
be mailed as well as the specific newspaper articles to be
furnished. In addition, advise the Bureau of the security
arrangements to be taken, to protect the Bureau as the source
of the documents.

Interviews should be handled under Substantive case
captions and not as counterintelligence.

For the future guidance of Milwaukee, only one
counterintelligence proposal should be submitted in each
communication.

Enclosed for the Bureau are three copies of Storm Warnings, a "right-wing pamphlet" prepared by the St. Louis Division.

BACKGROUND

The enclosed pamphlet was prepared by the St. Louis Division utilizing the terminology and illustrations of a typical "right-wing" publication. This area has been the scene of some degree of "right-wing" activity directed against local New Left groups and peace organizations. The St. Louis PD are currently investigating acts of vandalism committed by unknown persons against the St. Louis Peace Information Center.

While no real organized "right-group" group in the area has any apparent strong public support, the two communities of Hazelwood and Florissant in St. Louis County have traditionally been fertile grounds for the John Birch Society, etc... The illustrations in Storm Warnings have been culled from a patriotic flyer called The American Revelation which is printed and distributed in Hazelwood.

The purpose of Storm Warnings is to alert the reader to both the known and the relatively unknown agitators in the St. Louis area. It is sprinkled with factual inaccuracies and exaggerations in order to carry out the theme as a typical "right-winger" might write it, and also to eliminate any suspicion that any official investigating agency assisted in the preparation. It is not felt that Storm Warnings contains any information which an astute "right-winger" might not learn or guess on his own.

RECOMMENDATION

St. Louis purposes to prepare 100 copies on commercial paper and mail them anonymously from Hazelwood, Mo. to various "right-wing" organizations and individuals in the area.

The enclosed samples were prepared on Xerox machine although the 100 copies will be prepared on multilith machine.

It is anticipated that the mailing will accomplish the following desirable results:

1. It will alert the "right-wing" groups to the relatively unknown agitators in the area.
2. It may detract from the support and influence of such notables as [REDACTED] the various legitimate organizations in which they hold membership.
3. It will concentrate the public opposition against the key Communists and Militants in the area and help them to focus on "the enemy".
4. Should this pamphlet come to the attention of the New Left..(as it well may) it is felt that deciding how to deal with it and discussing the effect of it will keep the New Left in time-consuming efforts that will detract from the energy and time usually spent in plotting, recruiting and fund-raising.


Bureau authority is requested to initiate the above-described counter-intelligence project.

He now controls the Black Liberators, the Zulu's, and the Black Muslims. He does not associate with Communists because he considers them "too tame."

A New York Jew at Washington University, this Draft-Dodger and SDS Kingpin directs the student rioters, draft resisters, and campus anarchists from his "Free House" at 4487 McPherson. He goes to college on a full scholarship no less and local Reds and Pinkos are his constant companions. He wants to start a chain of hippie houses through the Midwest so he can peddle his subversive literature and narcotics.



St. Louis has suggested the anonymous mailing of a pamphlet to various organizations and individuals in the St. Louis area. This pamphlet is unidentified as to origin and contains information regarding the activities of Communist Party, New Left and BPP members in the St. Louis area. The pamphlet is phrased the same as if it was prepared by an unknown right-wing group and exposes various activities of these leaders in the St. Louis area. The suggestion if adopted would provide a good method of exposing the activities of these people to local officials, the public and each other to their detriment. We are requesting additional facts prior to considering the use of this pamphlet.

1. "I'm Talking to you, White Man", by MALCOLM X LITTLE, which appeared in the 9/12/64 issue of the "Saturday Evening Post".

2. "The Black Muslims are a Fraud", by AUBREY BARNETTE, which appeared in the 2/27/65 issue of the "Saturday Evening Post".

KELLY said that he presently has available to him several current issues of the NOI newspaper "Muhammad Speaks".

It is noted that the Bureau has given the Miami Office approval of working with [REDACTED] in preparing a TV expose of the NOI. [REDACTED] was contacted on 6/30/69, at which time he advised that because of a manpower shortage he has not been able to start preparing this program. He said that attempts are being made at the present time to hire additional employees in the News Dept. of WCKT TV and he expects sufficient personnel will be employed by the first of 8/69 to enable him to commence working on this program. He said that he is still extremely interested in the program and that as soon as sufficient personnel is available this will be the first of the documentary type programs to be handled. He said that he would estimate that this program would not be prepared and ready for showing until early in 9/69.

Miami Office does not feel that these two counter-intelligence programs will conflict. It appears that should the "Ft. Lauderdale News" prepare an article on the NOI, it would be published prior to the program by WCKT TV and could be of great assistance in the preparation of that TV expose.

Insure
understands this material is being furnished on a confidential basis and the Bureau is not to be revealed as the source.

Miami may wish to emphasize to [redacted] that the NOI publishes a newspaper filled with hate propaganda against the white race. Miami may furnish [redacted] sufficient issues of "Muhammad Speaks," the NOI newspaper, to show the provocative nature of this publication.

The NOI thrives on publicity, thus it is necessary in counterintelligence operations to aim at its weak points. Besides the NOI newspaper's emphasis on hatred, [redacted] might stress the amount of money extracted from NOI members by the leaders of the group. This would tend to hurt NOI recruiting efforts. The Bureau should be advised of the results of this operation.

Re Bureau letter to Omaha 6/27/69; and Omaha letter to Bureau, 6/30/69.

In connection with the BPP Breakfast for Children Program which operated in Des Moines, Iowa, between April, 1969, and the end of the school year, this program has not continued through the summer months and at present there is no indication that the BPP in Des Moines plans to reactivate this program after school begins in September. While this program was in existence no information was developed that the BPP in Des Moines attempted to extort food or funds for this program from local businessmen in the community. In the event this program is reactivated in September, Omaha will attempt to formulate an effective counterintelligence against same.

At present, individuals involved in the BPP in Des Moines, Iowa, are attempting to secure space to be used as BPP headquarters, their former headquarters having been condemned by the city because of the extensive damage to the headquarters caused by an explosion in April, 1969. Sources have advised that the BPP in Des Moines has all but disintegrated during the summer months and has been involved in no activities.

As for the BPP chapter in Omaha, this group has neither held regular meetings or been involved in any activity during the summer months. No counterintelligence accomplishments have been attained under captioned program since submission of referenced Omaha letter. This matter will continue to receive close attention and suggestions for counterintelligence activities against the BPP and its leadership at a future date will be submitted by separate communication.

This is to recommend that an anonymous telegram be sent to BPP headquarters from the Progressive Labor Party (PLP), which organization is engaged in a theoretical struggle with the BPP and was recently thrown out of the Students for a Democratic Society (SDS) for failure to support the BPP. The telegram will continue the strife existing between the three groups.

The BPP is planning a conference called "The National Revolutionary Conference for a United Front Against Fascism" to be held from 7/18-21/69. They are attempting to solicit white groups to participate and, subsequently, cooperate with the BPP. At a recent New Left convention, members of the SDS voted to support BPP programs, as well as the forthcoming BPP conference. Considerable argument took place prior to this vote and SDS expelled the PLP because members of that organization did not want to support the BPP. At this time there is considerable chaos within SDS and PLP.

The June 28, 1969, issue of "The Black Panther," a BPP publication, contained a telegram from SDS pointing out that the PLP was expelled from the convention, and SDS would support the BPP and its conference. It is believed that considerable disruption would take place within the BPP and SDS if an anonymous telegram was sent from a fictitious committee of the PLP. The telegram is in answer to the SDS's communication and points out the improbability of cooperation between PLP and BPP as well as BPP immorality. The telegram can be sent from a telephone pay station in Boston, Massachusetts, without fear of embarrassment to the Bureau.

RECOMMENDATION:

That the attached airtel to Boston instructing that such a telegram as described above be approved and forwarded.
