NOTE:

San Diego recommends the mailing of an anonymous letter to BPP Headquarters. This communication points out that one [REDACTED] has been associating with white girls even though he has been specifically warned by BPP leaders to cease all association with white women. This letter points out that [REDACTED] was in fact associated with a white girl and leaves the reader with the implication [REDACTED] does not believe that Negro women are good enough for him. We are authorizing this mailing. There is no chance of embarrassment to the Bureau from this counterintelligence effort. The letter will be signed [REDACTED] and will be mailed from a post office near the residence of [REDACTED] a BPP member. The mailing of this communication should have a disruptive effect on the membership of the San Diego BPP as [REDACTED] are leaders of the BPP.

"In addition, we are facing a problem which was brought to your attention sometime back. That problem concerns [redacted] keeps jiving with the white girls even though you told him to cut that stuff out. On May 22, 1969, he went to the Berkeley Memorial Day Rally at San Diego State College with one white girl and later on was seen with a second white girl by the name of [redacted]. Actually he was involved in activities which are more than mere association in that he, along with numerous other people, saw [redacted] fondling [redacted] from time to time throughout the day.

"I know he is supposed to be trying to be cooling things with the white community, or at least he says he is, but this type of thing is just helping to alienate both the white community and several of the other brothers. For example, some of the brothers are saying that [redacted] doesn't think the sisters are good enough for him and that's why he keeps trying to make the scene with the white girls.

For the information of the Bureau, on 5/22/69, [REDACTED] was observed on the campus of the San Diego State College during the Berkeley Memorial Day Rally. He was observed arriving at the Rally with an unidentified white girl. Later during the activities he was observed with a second white girl identified as [REDACTED] and was noted to be fondling [REDACTED] in various locations in front of a substantial number of individuals.

In view of the fact that [REDACTED] has been specifically warned by BPP leader DAVID HILLIARD to cease all association with white girls, Bureau authority is requested to send the following hand printed letter to HILLIARD in care of BPP Headquarters, Oakland, California:

"Dear Brother:

"As you are aware, we here in San Diego are facing daily problems concerning our aims and purposes. These problems are not being made any easier as a result of those pork chop nigger US members offing our brothers from time to time

National Headquarters requested [redacted] Chicago BPP, to investigate situation in Milwaukee.

Referenced Milwaukee teletype advised that reliable Milwaukee source advised on 6/3/69 that [redacted] Milwaukee BPP, had boarded a plane for San Francisco area to determine reason for [redacted] purge.

Los Angeles airtel advised [redacted] arrived at Los Angeles BPP Headquarters on 6/4/69 instead of National Headquarters.

[redacted] that [redacted] had contacted National Headquarters regarding non-receipt of papers. National Headquarters indicated that the \$250 for the papers had not been received.

On 5/27/69 [redacted] advised [redacted] and BPP [redacted] had purchased weapons from local sporting goods store. Same date, review of Milwaukee PD file revealed [redacted] under local indictment for forgery. Alcohol, Tobacco Tax Division notified of possible violation of firearms act.

Primary problems within Milwaukee BPP appear to be leadership and finances. Milwaukee will follow development of further struggles for leadership and financial problems in order to develop possible opportunities for counterintelligence activities. Will also closely follow purchase of weapons by BPP members and suspected members to ascertain possible violations of firearms act.

On 6/5/69, Special Agents of the Denver Office, along with officers from the Denver Police Department, raided Black Panther Party (BPP) Headquarters in Denver and apprehended [REDACTED] wanted by New Haven, Connecticut, authorities for murder and kidnaping. During the raid, at approximately 2:00 A.M., twelve BPP members were present at the headquarters.

Since the arrest [REDACTED] advised that the BPP members are extremely worried and are in fear of being arrested for harboring.

[REDACTED] a teenager and [REDACTED] has severed connections with the BPP, based mainly on the above raid. The BPP has placed the blame of informing on [REDACTED] a teenage BPP member. UACB, an anonymous telephone call will be made to BPP Headquarters to further this blame on [REDACTED]

Attached for the Bureau are two copies of a
suggested newsletter to be called, "Tuli, Inc." If
approved by the Bureau, it is contemplated that this
letter will be published monthly with publications
to be made more frequently should the newsletter appear
to be having an impact on the Black community. It will
be sent out as first class mail in sealed envelopes
which will be purchased from F. W. Woolworth or S. C.
Kearney Company so purchases cannot be traced. It will
be sent originally to approximately 75 Blacks who are
known to be educated and anti-violent. It will also
be sent to other twenty-five to one hundred Blacks.

Part of the plan will be to send a letter an-
nouncing the newsletter address [redacted] who
is [redacted] reliable in the past and has been
[redacted] He will not be
[redacted] and it is recommended
that he be kept aware of its purpose over the newsletter
leading to not distribution. If the Bureau feels this
action is acceptable but informant should be aware of its
purpose, Boston sees no reason not to keep him aware of
the project.

In the interests of economy, which should be of importance to publishers of this type of newsletter, the newsletter will be printed on both sides of each page.

The Bureau's comments and criticism are invited with respect to this proposal.

For over two years now we blacks, in Roxbury, North Dorchester, or wherever we may live in Greater Boston, have been bombarded with atrocity stories concerning black victims, with tales about lax, inefficient and corrupt police work in the black community, and in general, stories indicating unfair treatment of blacks by whites. This so called "authentic" information reaches us through the media of "Muhammad Speaks" (the Muslim newspaper) and "Rebellion News" which taken on their face value can be largely ignored as obviously prejudiced. A third community newspaper, the Bay State Banner, however, would appear to be more worthy of belief.

What has paralyzed some of us is the failure of any efforts to repudiate these stories. We have recently asked ourselves are these stories all factual? Is it true that being BLACK in Boston is this bad? We readily agree that being a member of the black minority group is no bed of roses. Being born a member of any majority group has its advantages but is being black truly as bad as the black news media portrays it? Being black, we also are aware that not all white people like us or consider us their equals. But is this generally true? On reflecting on our own personal experiences we concluded it is not.

We also agree that police work in the black areas could stand improvement. But is this because the police dislike us? Or could there be other explanations such as an overworked, unpaid police force coupled with a not overly cooperative black community. We think that to some extent this is true.

Personal investigation on our part into some of the publicized atrocities have been embarrassing to us as we have found many of the facts surrounding these appear to have been misrepresented in the three newspapers mentioned above.

We feel these papers appear to be either deliberately presenting a false picture or are failing to properly investigate the facts in the cases publicized. This is all too often true of many of our daily newspapers.

We believe that when events take place in our community in which blacks are involved and in which blacks are in the wrong the community should know the facts, and we should not blame what we look on as the establishment. When the establishment is wrong, that also should be known.

Re Omaha letter to Director 6/2/69.

From 4/13/69 through the end of the school year the Black Panther Party chapter in Des Moines, Iowa, organized a "Breakfast Program for Children" at two churches in Des Moines. This program was kicked off on 4/13/69 by the Black Panther Party with a rally at Goode Park, Des Moines, at which requests were made for donations of money and food for this program.

Once this program was instituted and publicized it received favorable comment and support from both the black and white communities; and the "Des Moines Register", a daily Des Moines, Iowa, newspaper, praised the Panthers for this program noting that when the Panthers instituted this type of program in the black community they had, in effect, achieved something the Des Moines School Board had been unable to accomplish.

It is to be noted that this acceptance of the Black Panther breakfast program in the Des Moines area is not unusual inasmuch as the Des Moines community has not looked upon the existence of the Des Moines Black Panther Party as a threat to either the black community or the Des Moines community in general. The Panthers have enjoyed favorable press comment, as well as favorable comments by [REDACTED] notwithstanding the other activities they have undertaken in Des Moines.

In view of the foregoing, it would be most difficult to undertake any kind of counterintelligence activity relative to the Black Panther Party breakfast program, and no recommendation in this regard is being submitted.

Omaha is continuing to remain alert to various activities of the Black Panther Party and the Black Association

Referenced letter pointed out that the BPP Breakfast for Children Program was well received in Des Moines and was praised by various civic organizations and the press. It is apparent that the counterintelligence program of the Omaha Office has not been effective and needs a fresh approach.

The BPP has extorted food for this program from local businessmen all over the country and most probably in Des Moines also. The children receiving the food also received "political training." In some cases they sang "Free Huey." In other cases they use BPP coloring books which show youngsters shooting policemen and contain such statements as "the pig is afraid of black children because they are brave warriors."

The Omaha Office should review its files for information of the nature set forth above in an effort to formulate an effective counterintelligence against the breakfast program.

The Bureau is presently preparing a communication with illustrative enclosures for the assistance of all offices which have a breakfast program.

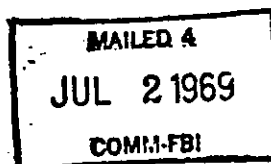

On the evening of [REDACTED] who is on the SI and AI of the NYO, was shot and seriously wounded by unknown Negro assailants in the Harlem, New York City area.

[REDACTED] remains in serious condition in the Police Ward of Bellevue Hospital in NYC. According to the NYCPD, [REDACTED] could not give any description of the assailants other than the fact that they were two male Negroes. [REDACTED] would attribute no motive to this crime but he himself was charged with the illegal possession of a firearm found upon his person. J

A review of [REDACTED] file indicates his significance as a Black extremist has appreciably diminished in the past few years and there is no indication at present that the militant organization, the American Mau Mau, which [REDACTED] once headed, is still in existence.

In general, the three leading New York City newspapers, "The New York Times", the "Post" and the "Daily News" portrayed [REDACTED] recent background in a favorable light indicating in effect that he made efforts to "keep New York City cool" by using his personal influence over the Black community during periods of racial strife, and that he may very well have been working for the New York City Mayor's office in doing so.

The Kansas City, Missouri, (KCHO), BPP Chapter's
"Breakfast For Children Program" began about mid-April, 1969.

On April 11, 1969, the "Kansas City Times", daily
KCHO newspaper, quoted Pete O'Neal, head of the KCHO BPP
Chapter as saying school children's breakfasts would be
afforded at St. Stephen Baptist Church and the Pasco Baptist
Church, KCHO; various news media, after April 14, 1969,
favorably publicized the Chapter's program of feeding hundreds
of hungry school children on school days in KCHO in cooperation
with various Negro church clergymen making their churches
available.

On April 17, 1969, [REDACTED] informed that Pete O'Neal
said his chapter fed 400 children breakfast that morning,
and that he, (O'Neal), would be interviewed and photographed
April 18, 1969, by "Time" magazine for an article on the
Chapter's breakfast program. O'Neal indicated he was instructed
by national BPP headquarters to stress in the interview the
theme, "We do not fight racism with racism. We fight racism
with solidarity."

clergymen and others, recently, in swelling the public image

innocent victims of prosecution. These sources noted the delayed process of educating the naive and many in the Negro community to the concealed and unpublicized violent doctrines of the national BPs represented by the local BP Chapter.

An article in the "Kansas City Times", April 17, 1969, related that Henry Finley, Chapter Captain, in a speech at the St. Paul School of Theology - Methodist, Kansas City, Missouri, urged financial support of the BP Chapter to fight poverty and to carry on the Chapter's free breakfast program for hungry school children.

On April 27, 1969, [REDACTED] informed that the BP Chapter sponsored a peaceful, previously publicized public indoor rally at the Gregg Community Center, Kansas City, Missouri, Saturday afternoon, April 26, 1969, for 200 to promote financial and volunteer support of the Chapter's program of feeding hundreds of "hungry" school children. The Chapter announced the Wayne Miner Housing Project as a third site for programmed feeding.

On April 7 and 28, 1969, [REDACTED] informed that Pete O'Neal and the BP Chapter began and continued to use premises at 3903 Olive, Kansas City, Missouri, as a supplemental base for operation of the Chapter's "Breakfast Program For School Children". These premises, [REDACTED] stated, were made available to the Chapter by the owner, the Methodist Inner-City Parish, 1717 East 12th, KCMO, which also had provided in February, 1969, the premises for the Chapter's headquarters, 2221-2223 Lydia, Kansas City, Missouri.

The above breakfast program of feeding hungry school children at St. Stephen and Paseo Baptist Churches, both reputable Negro churches, and at the Wayne Miner Housing Project, a leading city Negro housing project, was discontinued prior to Memorial Day, May 30, 1969, according to [REDACTED] and [REDACTED] apparently in anticipation of summer recess of public schools in KCMO, the week of June 2, 1969.

The same [REDACTED] with reliable contacts at the 3 specified feeding centers, said their contacts negate any specific indication of indoctrination of the fed hungry school children with black extremism. However, sources observed young hungry children fed by the BP breakfast program will remember, "The Black Panthers fed me."

Though diversion of some donations for the BPP's breakfast program to other BP activity or members appears probable, specific confirmation of such diversion has not been developed. Access to the Chapter's bank account has been denied. If the account becomes accessible in the future, it will be carefully analyzed.

But, given any future access to the Chapter's bank account, a recent development promises little specifics

[REDACTED] informed during the breakfast program that it was apparently financed by publicized Chapter solicitations of cash, food, and vitamin donations from various merchants, stores and suppliers, largely in the Negro community. Though some rumors of pressure tactics were received as to stated solicitations, few were indicated specifically as extortionate, all by [REDACTED]

[REDACTED] whose preliminary hearing on charges involving "robbery attempts" May 20, 1969, has been continued in a KCMO County Magistrate's Court from June 5 to June 13, 1969. The preliminary hearing is to determine any basis for binding [REDACTED] over to Circuit Court on a felony charge.

[REDACTED] stated he has gonorrhea.

[REDACTED] informed on June 12, 1969, that an application dated April 23, 1969, was approved the same date by the KCMO City Department of Health to permit the serving of food at St. Stephen's Baptist Church (in connection with the BPP Chapter's breakfast program). The permit was issued to the

church and [REDACTED] as an organization,
rather than to individual servers of food.

[REDACTED] said a city ordinance requires such permit's
issuance to the operator of any "established food service"
(regularly scheduled food service), gratis or for a consideration.

[REDACTED] said if the City Department of Health receives
a complaint or report that a food server in an "established
food service" to which a permit has been issued, is venereally
infected, a health inspector immediately contacts the person
allegedly infected to recommend medical treatment of the
venereal condition. But, no other action is possible with
regard to the ordinance on the basis that a venereal disease
is not transmittable through food handling, and since the
Health Department's permit is issued to the operator of the
"established food service", rather than to the server who
may be venereally infected.

[REDACTED] further stated it is his belief that like
permits were also issued to the Paseo Baptist Church and
to someone operating the Wayne Miner Housing Project's food
service both in connection with the BP breakfast program
but [REDACTED] has been unable to verify issuance of such permits
to date.

[REDACTED] is endeavoring through a confidential
source to determine whether a physician's report has been
rendered to the City Health Department for treatment of
Pete O'Neal, BPP Chapter head, for a venereal disease.

**BLACK PANTHER PARTY, aka
Black Panther Party for
Self Defense**

According to its official newspaper, the Black Panther Party (BPP) was started during December, 1966 in Oakland, California, to organize black people so they can take control of the life, politics, and the destiny of the black community. It was organized by Bobby George Seale, BPP Chairman, and Huey P. Newton, BPP Minister of Defense. Newton is presently serving a sentence of 2 to 15 years on a conviction of manslaughter in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther," which further describes itself as the "Black Community News Service," states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

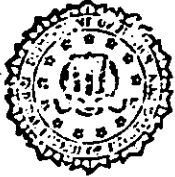
"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education, George Mason Murray, which ends with the following:

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement, "...we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman Mao Tse-tung of the People's Republic of China and feature Mao's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3106 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.

No counterintelligence programs have been effected in connection with the black nationalist groups of the Buffalo Division since submission of referenced letter.

The black nationalist movement in the Buffalo Division consists of the Nation of Islam (NOI), which maintains a mosque as MM 23 at Buffalo and an auxiliary mosque at Rochester, New York as MM 23B. The membership and the activities at MM 23 and MM 23B are stable and excellent coverage of these activities has resulted.

The only other black nationalist hate group existing in the Buffalo Division is the Rochester, New York Chapter of the Black Panther Party (BPP). Counterintelligence measures in connection with the BPP are furnished the Bureau under separate caption.

Agents having responsibility for these black nationalist groups are continually vigilant for opportunities to effect some form of counterintelligence.

For the information of the Bureau, during April, 1969, a fairly militant Buffalo group known as "Us Now", a young Negro federation taking membership from YMCAs and YWCAs and neighborhood clubs published a manifesto which

they called "Black Summer, 1969." This manifesto, directed to City and County officials, presented a number of non-negotiable demands in connection with employment, recreation, and summer educational programs for which they demanded a response by 6/1/69. The 6/1/69 ultimatum date was given extensive publicity in Buffalo Negro press and a representative of "Us Now" publicly stated that they could not accept responsibility for events in the Buffalo community if their demands were not met. Signs and wall scribbling, such as "June 1 whitey," during late April and May, 1969, appeared frequently throughout the ghetto area. Eventually the entire East Side of Buffalo was alarmed over the prospects for a racial disturbance about 6/1/69.

The Buffalo Office, in keeping with racial intelligence responsibility during 5/69, conducted a series of interviews with rank and file members of "Us Now" regarding contemplated 6/1/69 plans of this organization. In addition, a close liaison was maintained with and interviews conducted of responsible liaison sources of area civil rights organizations regarding "Us Now." As a result of extensive interviews, it is considered the "Us Now" leadership was kept off balance and liaison sources contacted, in turn, asserted themselves effectively to produce a noteworthy result as no racial disturbances occurred in the Buffalo area 6/1/69.

A concerted and continuous effort will continue in an effort to develop a productive counterintelligence program within the black nationalist organizations of the Buffalo Division.

Concerning the STOKELY CARMICHAEL expulsion letter mentioned in referenced letter, Boston has noted that the latest issue of "The Black Panther", dated 6-14-69, did not list STOKELY CARMICHAEL as Prime Minister of the BPP.

The April 3, 1969, issue of the "Somerset Messenger Gazette" contained an article captioned, "SCAP Director Charges Distortion of Statements." This article revealed that Theodore Taylor, Executive Director of SCAP, charged that remarks he made at a recent human relations workshop at Somerville High School had been misrepresented in an unsigned flyer being circulated in Somerville.

He charged certain members of the Board of Education and some faculty members with distortion and quoting his position out of context.

Taylor was first quoted in the circular with saying that Somerville schools were not doing a good job and that the students will erupt. Taylor stated he stood behind these statements.

The circular also quoted Taylor as stating, "Will you listen when they hit you with a 2x4 plank? And they are going to hit you with one.....Do you think your students believe the lies you're telling them? Do you think they are satisfied with all that stuff about the American flag? If the situation erupts in Somerville, I will use my energies to direct the students to turn on the schools."

Taylor explained this quotation by saying, "I had roughly five minutes to speak to a group of 200 people and I chose to shake them and make them aware of what I had anticipated developing in their school system." He stated that the reference to the 2x4 plank was not intended as a literal assault.

BLACK PANTHER PARTY, Also Known As
Black Panther Party for Self-Defense

According to its official newspaper, the Black Panther Party (BPP) was started during December, 1966, in Oakland, California, to organize black people so they can take control of the life, politics, and the destiny of the black community. It was organized by Bobby George Seale, BPP Chairman, and Huey P. Newton, BPP Minister of Defense. Newton is presently serving a sentence of 2 to 15 years on a conviction of manslaughter in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther," which further describes itself as the "Black Community News Service," states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education, George Mason Murray, which ends with the following:

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement, "...we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman MAO Tse-tung of the People's Republic of China and feature MAO's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3106 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.

1. Operations under consideration. All counterintelligence programs previously under consideration are being held in abeyance until such time that the leadership of the Connecticut Black Panther Party is reestablished and the Party again becomes dynamic. Situations which arise which would avail themselves to counterintelligence exploitation will be given close scrutiny by supervisory personnel and the Bureau advised.

2. Operations being effected. Per Bureau authority, copies of the 5/29/69 issue of "The Black Panther" have been distributed to [REDACTED] as authorized by referenced airtel.

The "Daily World", an east coast Communist newspaper, in the 6/3/69 issue, contained an article on the trial of the BPP defendants charged with the murder of ALEX RACKLEY, in which the newspaper quotes the [REDACTED] as stating that the police version of the homicide is a "frameup" and that the prosecutor is using biased procedures in circumventing a probable cause hearing.

On 6/3/69, this article was discussed with State's Attorney ARNOLD MARKLE, who expressed great interest in it and requested a copy of the article to show the Judge in this case. Attorney MARKLE felt sure that the judge would be interested in learning that [REDACTED] had discussed the case with reporters from the "Daily World".

On 6/4/69, a copy of the "Daily World" was delivered to the office of ARNOLD MARKLE, who assured that he would not divulge the FBI as the source of information.

It might be noted at this point that Chicago continues to regard the local BPP as the focal point for counterintelligence in this field. The letter of June 17, 1969, requests Bureau authority to attempt to publicize cartoon depictions of the BPP in a subservient position to the SDS.

Within recent weeks a relatively small, but highly vocal group of young Puerto Ricans has emerged in the Spanish speaking community, utilizing the name Young Lords. Essentially a youth or street gang in nature, it has adopted the pose of a political organization, and an affiliation with the BPP has arisen. It appears that the real nature of this group, and those associated with it, are not generally recognized by the responsible elements in the community, and the file of this group, and of those persons in and associated with it, are being reviewed with the end of developing a suitable counterintelligence program. A recommendation will be provided the Bureau in the event an effective action can be formulated.

2. & 3. Operations being Effected and Tangible Results Obtained

Chicago at present has in effect the program authorized by the Bureau May 21, 1969, to instruct selected BPP informants for use in creating a rift between the BPP and SDS. It is as yet too early to determine what, if any, effect will be forthcoming. This program additionally has become somewhat complicated by the disruption which has been created in the BPP locally by the June 4, 1969, raid of the Chicago Office on the BPP headquarters, and subsequent Chicago Police Department arrests of some sixteen BPP members, on a variety of local charges.

This program is being pursued very carefully, in light of the Bureau's observations in letter of May 21, 1969. Tangible results subsequently obtained will be provided the Bureau.

4. Developments of Counterintelligence Interest

The emergence of the Young Lords has been previously referred to. Also of interest is the disruption of the regular and normal functioning of the BPP, through effective and vigorous enforcement of criminal statutes violated by them on a local and federal level. Most recent information from BPP sources reflects the organization to be purging its ranks, in an effort to weed out infiltrators; also reflects that there may be beginning to emerge in lower levels of BPP ranks a dissatisfaction with the current leadership. This situation will be followed closely and where a counterintelligence avenue appears to offer itself, a suitable recommendation will be forthcoming.

No counterintelligence action will be taken by Chicago without Bureau approval.

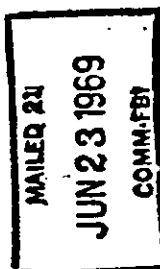

This conference will be held in Oakland, California, at BPP headquarters from 7/18 - 21/69. This conference will not only include black extremist groups, but will also include New Left organizations. The aims of the conference will be to develop a "united front against fascism."

It would be to our advantage if this conference was a failure. One of the ways it could fail would be to split the New Left and the BPP. Information has been received indicating that the BPP will allow the white groups to function only in a subordinate position. Statements of this nature have been made. One BPP speaker went so far as to tell white New Left leaders that the cooperation between the white groups must be complete and this included the "use" of the females in the white groups.

The comments and suggestions of the San Diego Office in this endeavor are solicited.

NOTE:

The San Diego Office has previously submitted and subsequently utilized caricatures of BPP members on an anonymous basis. These caricatures not only poke fun at BPP members but, they succeed in furthering a split between the BPP and other black extremist groups. We are requesting San Diego to produce, if possible, a set of caricatures which might be used to alienate New Left groups from a forthcoming BPP conference.

For the information of the Bureau, rumors have been received from time to time that the US organization is holding occasional firearms practice sessions. All efforts to verify this information through informants have, thus far, met with negative results.

Reliable information has been received, however, that members of the US organization have purchased ammunition at one of the local gun shops. On 6/5/69, an individual identified as [REDACTED] purchased 150 rounds of 9 mm ammunition, 100 rounds of .32 automatic ammunition, and 100 rounds of .38 special ammunition at a local gun shop. [REDACTED] was tentatively identified as the individual who was responsible for the shooting of BPP member [REDACTED] in Los Angeles on or about 3/14/69.

In view of the above information and the possibility that members of the US organization are in fact holding firearms practices, Bureau permission is requested concerning the following activity:

It is requested that permission be granted to handload approximately 15 rounds of .38 ammunition, 9 mm ammunition, and .32 automatic ammunition with an extreme overload of fast-burning pistol powder releasing pressure in the neighborhood of 100,000 pounds per square inch. These loads would contain hollow point bullets.

It is pointed out to the Bureau that the average weapon will sustain pressures of approximately 80,000 pounds per square inch maximum. Pressures exceeding this amount will cause severe irreparable damage to any weapon through which this ammunition is fired.

Four or five rounds of each caliber of the "special" ammunition would then be placed in a plastic bag similar to the type utilized for the wrapping bread, and abandoned directly in front of the US organization headquarters in such a manner as to make it appear that the ammunition had been lost.

A comparable bag of ammunition would be prepared and "lost" directly in front of the BPP headquarters.

It is felt that the ammunition should be found almost immediately by a member of one of the above organizations and subsequently utilized either in firearms practice or in an attempt to assassinate a member of one of the opposing groups.

It is not felt that the ammunition, if utilized in a hand gun, would cause any severe personal damage to the individual using it. It would, however, cause the weapon to be rendered completely useless on a permanent basis.

It is further indicated that by loading the shells with hollow point ammunition there will be more of a tendency for the user to save this ammunition for utilization in an assassination attempt directed either at a member of an opposing group or at a member of law enforcement. In the event such ammunition is designated for this type of use, it is pointed out that a life could be saved and possibly that of a police officer due to the fact that the overloaded ammunition would not function correctly.

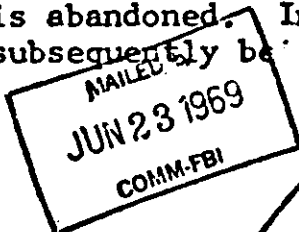

San Diego has requested permission to overload pistol and revolver ammunition so that when discharged, it would destroy the weapon. This ammunition would be placed in bags and anonymously abandoned in front of both the BPP headquarters and US headquarters in San Diego. San Diego believes that the ammunition would be found immediately by a member of one of the groups and subsequently utilized in firearms practice or assassination attempts. We are turning the suggestion down as the results cannot be assured and a loss of control would take place as soon as the ammunition is abandoned. Innocent children could pick up the bags and subsequently be injured.

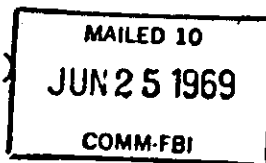
The instructions set forth in referenced Bureau letter 6/17/69 should be followed and an expulsion letter pertaining to Stokely Carmichael submitted.

The expulsion of Stokely Carmichael from the BPP would materially affect the black community. Carmichael is well thought of among many members of the black race. The BPP has a definite need for associating itself with persons having a following like Carmichael has.

Recent developments indicate a need for you to expedite the expulsion letter. In view of this and if not already done, you should submit this letter to reach the Bureau by 7/1/69. The forthcoming Revolutionary Conference being sponsored by the BPP 7/18 - 21/69 wherein white revolutionaries are being invited, could serve as one of the reasons why Carmichael is being expelled from the BPP. As you will recall Carmichael, when he took over the Student Nonviolent Coordinating Committee (SNCC), took steps to separate and release from SNCC all white workers.

The publicity given to the expulsion of Carmichael could be to the effect that Carmichael was adamant against associating with the whites whereas present BPP leaders are weakening in their antiwhite stand, therefore, a split developed and Carmichael was dismissed.

NOTE:

ReBulet instructed San Francisco to prepare, if possible, a counterintelligence letter expelling Carmichael from the BPP. San Francisco raised a question in a later communication and we are reiterating instructions set forth in Bulet 6/17/69. San Francisco advises that since Stokely Carmichael's name was not listed as an officer in the last issue of the Black Panther Party paper, he was probably dismissed already. In spite of San Francisco's observation we believe we should still carry on this action because it could be highly effective in splitting the Black Panther Party membership.

There has been no change in the status of the
Rochester Branch of the BPP since the submission of
remylet.

It has been ascertained that the Rochester Branch
subsequent to 3/1/69, when the group vacated its headquarters
at 400 Joseph Ave., had arranged to hold meetings at the
Montgomery Neighborhood Center, 10 Cady St., Rochester,
N.Y. The Center's calendar of activities for March, 1969,
reflected seven dates in March when BPP meetings had been
scheduled, however these meetings never took place, due
to failure of members to show up for the meetings. The
Rochester Branch has been described as an organization
having a hard core leadership of three members, these
being [REDACTED] *NH*

They are described as individuals who do a great deal of
talking but very little acting. The Rochester Branch,
based on numerous interviews with individuals familiar with
the local group, is ineffective and has very little following
in the Black community.

The Rochester Branch BPP has not undertaken any
activity of any type since the BPP sponsored demonstration
at Rochester Inner City School 4, in February, 1969. It
has not maintained a headquarters since 3/1/69, and member-
ship has dwindled to the three leaders mentioned above, who
have recently been more involved in personal problems of

The following counter intelligence has been utilized successfully in Detroit to create disruption and dissension within the Detroit BPP for the purpose of further reducing its effectiveness.

Informants and sources have been instructed, when feasible, to inject into their conversations with Detroit BPP members statements which could result in creating fractionalism and distrust among the general membership and between the members and the leaders. An example of this has been to be critical to a party brother of an action taken by a leader in the handling and accounting of party funds in the BPP Breakfast Program. Stress has been placed on possible diversion of such funds for the leaders personal use or gain especially when one of the leaders has expressed no interest in advising the members of how the funds have been utilized. Another opportunity to be critical of the local party leadership occurred following a Detroit PD raid and arrest of BPP individuals which occurred at local party headquarters. The criticism in this instance was the lack of security planning by local leaders to prevent a surprise raid by the police or other individuals. Further issue was made of the selection of the headquarters site, the physical set up, and how the police were able to confiscate stolen property at party headquarters. Stress was placed on the

possibility of an informant working within the local headquarters presumably one of its officers working in conjunction with the police and setting up the raid. It is to be noted that during the Detroit Police raid on local party headquarters, none of the top party leaders were arrested. Following the reported suicide of MICHAEL BAYNHAM, Minister of Defense, Detroit BPP, sources reported there were numerous rumors and stories in local BPP circles as to what actually happened to BAYNHAM. To further cloud and confuse the facts surrounding BAYNHAM's death, sources theorize he actually died at the hands of a highly placed Detroit BPP leader whom BAYNHAM had discovered stealing party funds. Another theory offered was that BAYNHAM was a suspected police informant and it was felt that his death would "shake up" the party locally causing them to clean house and fall in line with National Headquarters BPP policies. Sources advised that as a result of the implication of these actions, the Detroit BPP has been split wide open. Members are suspicious of each other; they are vitally concerned for their own safety; and as one source stated members are "looking over their shoulder" expecting bodily harm to come to them. Many members have expressed that they want out of the BPP and desire to sever their ties with the BPP.

Sources have been instructed that when they are making statements aimed at causing disruption they are to deal with issues that in no way would expose them as being informants and from which they would not be the victims of any retaliatory action by the BPP.

At the present time in Charlotte a civil suit is pending against law enforcement officials charging harassment of persons seeking to become members of the BPP and the USA has recommended no further contact with [REDACTED] associates until civil action is adjudicated. The obtaining of background data continues, however, and Charlotte will submit a proposal concerning counterintelligence operations as soon as the civil suit is adjudicated in Federal Court.

The BPP since its inception in Detroit, has experienced considerable difficulty in operating in a fluid manner. Some of the difficulty stems from its lack of qualified and capable leaders. The organization has further been hampered by a lack of direction and almost total absence of interest by the general membership. Additional complications have beset the group inasmuch as it has not had available adequate orders to operate for any reasonable length of time. Further it has suffered due to the dirth of operating capital.

Detroit proposes utilizing the following cointel technique as a disruptive measure within the Detroit BPP. The cointel would be in the form of an anonymous letter sent to a representative number of Detroit BPP leaders and members. A copy of the letter is set out below.

Dear Brothers and Sisters:

Who's next? You, me, who knows. Are you concerned? I am. How come our brothers are being murdered and arrested and our headquarters are raided by the pigs? Who tells the pigs about the location of our headquarters, our leaders, our members, and our activities? Who tells the pigs

about the travel of our leaders and other brothers who are trying to flee and hide from the pigs? How is it when we have such great security, trusted leaders and members, the pigs are still able to bust us whenever they please? How can the pigs get such privileged information enabling them to obtain search warrants so that they can "legally" vamp our headquarters? Who issues orders for the execution of our brothers? How about our brother who got it in New Haven and the "suicide shooting" of Brother Baynham in Detroit? The pigs call it "suicide" but where is the gun he killed himself with? Who's kidding who? Isn't it bad enough that we have to fight the outside pigs yet alone worry about the pigs inside our party. When you got a pig hiding in your midst you've got to find him and eliminate him before he eliminates you. Who is the pig here who has caused the murder of one of our brothers and caused all the trouble we've had here? Are the pigs local or national? And is he controlled at our local or national headquarters? We got pigs among us alright or else we wouldn't have lost Brother Baynham. Nationally our brothers are grabbed by the pigs in cities like Denver and Salt Lake City. How would the pigs know where to find one of our brothers in Salt Lake when we don't have a chapter there? Looks like the pigs are feeding each other doesn't it? Why the purge of Brother Calli and Brother Diggs here? Why is it us party members are always suspected and purged when the party control is with our leaders? Let's take a closer look at our leaders because this is where the power, money, and control is? This is where we'll find the pigs who give assistance to their brother pigs. Speaking of leaders, why not start with chief pig Hilliard. How clean is he? I want to work for the party because I'm young dedicated and believe in the cause but I don't want to die or be a "suicide" death for the pigs fat. Let's live by our motto "all power to the people not just the leaders".

It is not believed that any counterintelligence effort should ever be directed toward the uncovering of informants within an organization at the same time that this Bureau is attempting to penetrate the group with informant coverage. The benefits to be gained by the communication are not commensurate with the inherent danger of exposing a source of this Bureau. Detroit should remain alert for additional counterintelligence techniques.

(1) Operations under consideration:

Oregon, who has previously been mentioned under this caption, was, until recently, [REDACTED] ced

[REDACTED], completely mismanaged the operation of Black-fashions which resulted in its being closed recently by its benefactor who estimates that he will sustain a loss of \$20,000 for this operation.

The U.S. Postal Inspectors are currently conducting an investigation of the operation [REDACTED] for possible mail fraud violations and it appears that mail orders received by [REDACTED] from various parts of the country were never paid and the money received with these orders was embezzled [REDACTED]

Postal investigation has shown that [redacted] and his partner failed to pay for merchandise they ordered and are behind in wages owed to female Negro employees.

Portland suggests that the US Internal Revenue Service, the Oregon State Collector of State Income Tax, and the Oregon State Department of Labor be furnished with information concerning [REDACTED] and the conduct [REDACTED] looking toward an inquiry being made into possible State or Federal tax violations on the part [REDACTED] and possible violation of State labor laws.

(2) Operations being put into effect:

Portland, in conducting background investigation of known members of the BPP at Eugene and Portland, Oregon, has endeavored to make a determination as to subjects' current Selective Service status.

In this connection, it was determined that [redacted] Oregon, was in violation of Selective Service Act for failure to register for Selective Service. He was arrested at Eugene, Oregon, 5/22/69. [redacted] an active BPP a [redacted] was found to be [redacted] for failure to report for a physical examination and induction. [redacted] was taken into custody on [redacted]

PD 157-347

5/23/69 at Eugene, Oregon.

[redacted] active member of the BPP at [redacted] and mentioned above as being in possession of dynamite, was charged in a Federal complaint 5/22/69 for violation of Title 18, Section 245, U.S. Code, based on a threat [redacted] made [redacted] Oregon, which juror was [redacted]. Similar charges were brought by the Lane County District Attorney at Eugene and on 5/23/69, COX was arrested by the Lane County SO which facilitated a detailed search for dynamite at the COX residence; however, none was located.

Searches made incidental to the arrest of [redacted] produced two shotguns and ammunition, but no explosive devices were located.

All three of these men were considered as suspects in the series of bombings occurring at Eugene, Oregon, on 5/19-20/69, and being in possession of their current Selective Service status greatly aided in the conduct of the bombing investigation.

A separate investigation at Portland, Oregon, of [redacted] has determined that [redacted] is not registered for selective Service in the State of Oregon. Additional investigation is being conducted looking toward an ultimate prosecution of [redacted] for violation of the Selective Service Act.

[redacted] first came to the attention of this office when he was identified by an informant as being in possession of molotov cocktails, which led to his arrest by the Portland PD.

(3) Tangible Results of Counterintelligence:

There is attached hereto a xerox copy of an article appearing in the "Oregon Daily Emerald", the official campus newspaper at the University of Oregon, Eugene, Oregon. This article clearly sets out the disruption the arrests of [redacted] have caused within BPP circles in Eugene, Oregon.

Editor's note: The following is a statement from Howard Anderson and Ray Eaglin on supporting two University students and an LCC student who are on trial in Portland on charges of violating draft laws.

We cannot claim victory in the Pacific Northwest while sound-
ing retreat in the South. And yet it is absurd to geographically
label a cancerous society as north and south--the south being
South Africa, South America, Southeast Asia and South Eugene.
Isn't it so true and painful that the South is the Canadian border
onward.

The arrest of Bill Green, Julius Hurst and Artie Cox by the
FBI and the Eugene police department, is clearly and obviously
another attempt to suppress Black people.

The FBI and their puppet support wing of the local police
department have tried every illegal means at their disposal to
eliminate the Black Panther Party of Eugene and the nation.

Green is from Washington, D.C. and Hurst is from Portland.
Was it coincidence that the war-mongering draft boards in the

District of Columbia and in Portland simultaneously swore out
warrants to arrest these brothers? No, it was not. The order of the
day nationally is to intimidate, suppress, arrest and murder all
people who are aware, concerned and reacting to the digital
oppression that this tyrannical society continues to hammer upon
the people.

The FBI is supposed to be a super home grown spy organization.
Their mission is to protect and guard the people's rights, often
at the expense of maiming and incarcerating the people. Who is
going to protect the people from the FBI?

Mr. Hoover, the 74-year-old federal chief, still lives with his
mom. He apparently needs some fetish form of protection.
His national mandate to his cadres is to continue supporting all
forms of suppression.

The federal government kicked its way into Vietnam, Laos,

We would like to also congratulate Chief Ellsworth of Eugene

Artie Cox was said to have threatened the life of a postman. According to Dep. Dist. Attorney John Moore, the police department's Minister of Reason and Doubt, Cox threatened a postman who was a juror at a local trial of a Black man. According to Judge Rodman, this is the same juror who told the bailiff during a recess period at that trial that Cox was "a liar" when he said that he lived at an address that showed only Dennis White. Judge Rodman conferred with the postman, the prosecutor, the defense attorney, and the defendant for the purpose of declaring a possible mistrial. It was proved that Cox was not lying, but rather the United States postman, who apparently memorized his beat, was outraged at the fact that more than one Black man lived at the same address. We are sure that Judge Rodman will testify when the postman is sued for defamation of the character of Cox.

As far as threatening a person's life, Nikita Khrushchev said that he was going "to bury" this country with his bombs and missiles, and yet the FBI, the CIA and the entire police forces of this country had him in their midst and failed to apprehend and charge him for threatening the lives of an entire nation. And who is going to arrest the United States Congress for failing to legislate appropriate laws to eliminate poverty, hunger, and disease?

Then there is a third force in this blitz-krieg attack on the people: the University which pays \$47,000 a year for protection and other war games to the local police department—the same police department that protects only itself.

We are not anti-law or anti-institution. We are opposed to those people who are by law and statutes responsible for carrying out the laws presently on the books.

The basis for that opposition is that if all these laws were enforced, the FBI, the CIA and their local pawnbrokers would all be in jail—and to us that is too many lawabiding, righteous representatives of the people in jail. Peace to the people at home and abroad.

High bails, unreasonable searches and seizures, war and murder cannot stop the will of the people. Our struggle is against war, fear, ignorance and a police society. This cancerous society is not yet fit for people.

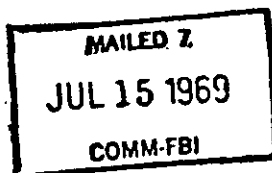

No counterintelligence accomplishments have been obtained under captioned program since submission of referenced Omaha letter.

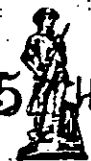

The following proposal is suggested as a means to cause the Black Panther Party (BPP) rank and file to lose confidence in the BPP National Committee and chapter leaders who support the National Committee.

It is suggested that in interviews with members of the BPP, particularly those who at least express a sincere interest in the principles set down by HUEY P. NEWTON, it be hinted that there is a possible conspiracy going on at the National Headquarters between CHARLES GARRY, BOBBY SEALE, and DAVID HILLIARD to keep NEWTON in jail. This theme could be developed further by asking if there is any truth to the rumor that NEWTON has said, "There is no Black Panther Party." Numerous approaches can be used to further the theme, the following are merely a few.

Asking whether GARRY has really kept NEWTON in jail because of legal moves he did not use to get the bail set during appeal. That this was done with the approval of SEALE and HILLIARD but only if they continued to get part of the funds from the Newton-Cleaver Defense Committee. That these funds have been channeled through GARRY's law firm and placed in a secret account in Switzerland so that when things go bad for SEALE and HILLIARD in the States they can get away.

Foreign travel of SEALE can be referred to above to lend credence to the story.

Also, it can be noted that the major theme of the BPP is free HUEY, but if HUEY were free the theme would die. And, it is easier to get funds for the party as long as HUEY is in jail.

Prior to NEWTON's conviction, BOBBY SEALE said that the sky would be red if HUEY was convicted. Question whether this was bad timing because of the intimidation involved which forced the court to convict him of something just to show the Panthers that the courts would not be intimidated. Consequently, the jury convicted NEWTON of the charge of involuntary manslaughter, when it had only talked about murder before. It could have been bad timing, or it could have been intentional. The skies did not turn red as SEALE claimed; in fact, SEALE said cool it, so the appeal would not be affected.

It could also be brought up that ELDRIDGE CLEAVER got wise to GARRY, SEALE and HILLIARD and kept his own separate loot. And when it came time to put his legal problems back in GARRY's hands, he felt he had better get out before he rotted in jail like NEWTON.

To carry off the basic proposition that the BPP leaders are trying to keep NEWTON jail, interviewing agents will necessarily have to judge the situation for themselves. An antagonistic Panther will not allow the necessary dialogue. Rank and file Panthers are usually more willing to talk if the circumstances are right. Everything depends on presentation. If the interviewee thinks he thought of the conspiracy, then the rumor is started.

It is felt where sympathy for the Panther program has grown it is usually because the intentions expressed are popular in the ghetto community, but the actual programs of the party are merely hate and violence. If the party leaders appear to be taking advantage of the ghettos also then the luster will be lost. If a rumor of this nature were to filter its way up from the rank and file of the BPP, reflecting that the party officials are stealing from the party and their "Brothers" and keeping NEWTON in fact a "political prisoner" for their own purpose, much might be done to promote greater factionalism and dissension.

It is felt that if such a rumor could be started at several chapters across the country, each rumor could lend credence to the other. It is believed that such a plan could best be put into effect following a major meeting of the party such as the United Front Conference to be held in Oakland in July, 1969.

The above recommendation is presented for the Bureau's consideration.

The ideas set forth in relet are appreciated and most timely. The method by which you propose that they be carried out cannot be adopted. The planting of ideas in the minds of members of the Black Panthers by interviewing Agents is dangerous. The FBI could easily be exposed as the source.

Los Angeles should review the ideas set forth in relet especially as they pertain to Charles Garry, Bobby Seale, and David Hilliard and prepare a specific counterintelligence proposal designed to creating a breach between the BPP and Garry. Consider such things as anonymous communications and anonymous telephone calls as well as cartoons and other logical methods of transporting your idea.

NOTE:

Los Angeles has suggested some good counterintelligence ideas. That office suggests that a breach be created between the BPP and its attorneys. The suggestion takes the form of such things as misuse of funds and conspiracy to keep Panther leader Huey Newton in jail. Los Angeles also suggests that Bureau Agents be authorized to plant these ideas within the BPP while interviewing subjects. We are pointing out to them that the ideas are good but the method cannot be authorized. That office is being instructed to consider the usual counterintelligence methods and submit a proposal.

I. Operations Under Consideration

Recently the Afro-American Society of Greater Atlanta (AASGA) under the name of "The H. Rap Brown Recreational Center" began operating a pre-school age day school at 849 Beckwith Street, Southwest, Atlanta, Georgia. Information has been developed that this was to be a joint operation entered into by the Harambee Sisters and the AASGA; however, considerable dissatisfaction in the operation of the school has developed between these two factions and it is believed from sources that as soon as some definite information is received upon which a counterintelligence program can be developed, it will be advantageous to attempt to disrupt this school through a counterintelligence operation, so as to dilute the school's effectiveness in the neighborhood in which it is operating.

II. Operations Being Effectuated

On May 18, 1969, [REDACTED]

[REDACTED] Marietta, Georgia, appeared at the first Presbyterian Church in Atlanta and [REDACTED] read a portion of JAMES FORMAN's "Black Manifesto" to the congregation. A number of well known leaders in the local Negro community have condemned the "Black Manifesto" although these leaders are not aware of the identity of the individual appearing at the church on May 18, 1969. It is anticipated that some of these leaders will be furnished with the identity of the individuals involved, which will tend to further discredit the reputation of the organizations with which they are associated.

III. Tangible Results

Based on contact with sources within the National Episcopal Church (NEC), which organization had made a grant of \$34,000 to the AASGA, this sum was recalled by the NEC, however, it has been reported that the NEC did make a grant of \$5,000 to the AASGA. The counterintelligence operation instituted in this instance resulted in a loss of \$29,000 to the AASGA.

IV. Development of Counterintelligence Interest

The recall of the \$34,000 grant by the NEC has caused the AASGA a real problem in financing their operation at the day school located in the ghetto area of Atlanta.

The above enclosures are being furnished recipient offices in view of the fact that these offices have had Black Panther Party (BPP) breakfasts for children at least on one occasion. In some offices the "Breakfast for Children" program is continuing even though school is out for the summer. It is reasonable to expect that this program will be continued by the BPP in the fall. It has given the BPP a new impetus. They have obtained excellent press coverage which has most probably recruited or lined up persons for recruitment as a result of this program.

The reasons behind this program are obvious. The BPP needs a connection with "the people." They are able to poison the minds of small children who take this hate into their homes. The food used is usually obtained as a result of semi-extortion and veiled threats. The Party uses naive thinking clergymen in their breakfast program. As a result, churches are usually locations of the breakfasts.

Effective counterintelligence can successfully disrupt the Black Panther Party in its vicious attempts to poison the minds of children through its "Breakfast for Children" program. The enclosures being furnished each office have been reproduced on unwatermarked paper and contain no identifying information. They should be reviewed for counterintelligence merit. Specific proposals will be entertained at the Bureau concerning anonymous mailings of this material and other pertinent material to persons and places involved in this program. These mailings should be considered for such people as clergymen, lay leaders of the churches involved, political leaders, and other pertinent persons. Take no specific action without prior Bureau authority.

Instant letter, due 7/6/69 is submitted early, in view of intervening holiday and weekend.

No specific counterintelligence action other than previously recommended is suggested against the Kansas City, Missouri, BPP chapter at this time.

However, a Special Agent handling BPP matters in the Kansas City Division recently suggested certain counterintelligence action. These suggestions are enumerated as follows, not as recommendations, but with comments, for the Bureau's consideration:

1. During the spring of 1969, a fracas occurred in the Inferno Lounge, Kansas City, Missouri, between a white member of the organized Italian criminal element and a member of the Kansas City, Missouri, BPP chapter, with resulting subsequent reports of ill feeling between these groups and fear of said organized criminal element by the Black Panthers.

It was suggested that adroit planting of questions by Special Agents with ghetto and criminal sources as to the reported ill feeling would cause the Black Panthers to become apprehensive and reserved, fearing retaliation from the organized criminal element.

a. A Black Panther taking off a Ku Klux Klan garment (enclosure).

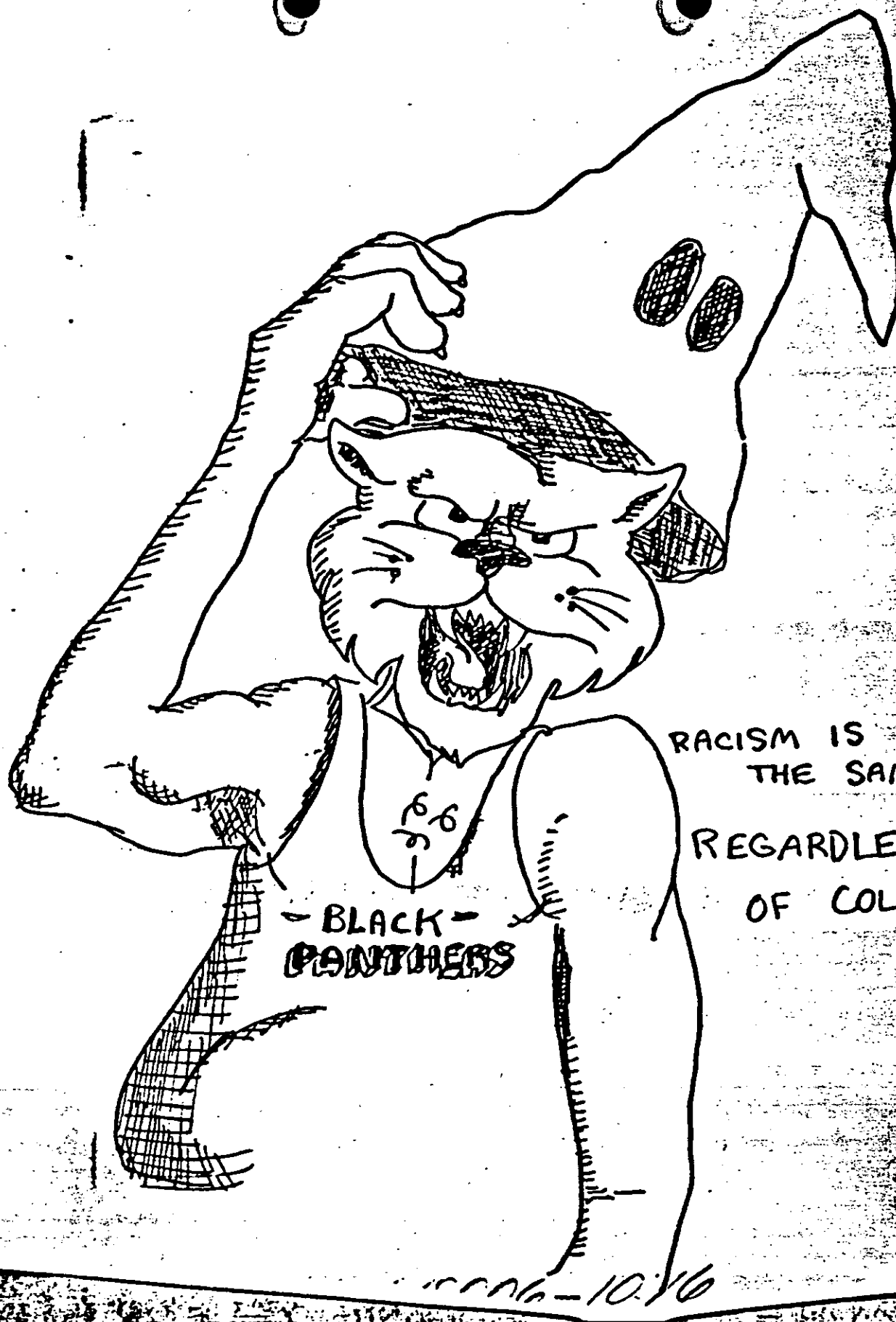

The thoughts expressed in relet were appreciated. Logical counterintelligence pitting the organized crime element and the BPP is feasible and logical but the use of informants and sources to plant questions of ill feeling between these two elements should be avoided. There are ways of bringing the desired antagonism to bear. Things such as anonymous communications whereby a Panther blamed for causing the arrest of a hoodlum or vice versa is one example. Kansas City should consider above and if feasible, submit a specific counterintelligence proposal.

Referenced letter contained a cartoon depicting a similarity between the Panthers and the Klan. This cartoon is of excellent quality and it is believed that it can be utilized with effective results. It is believed that it might be more effective if additional descriptive matter such as the initials KKK were placed on the hood. Kansas City should consider this. In addition, Kansas City should furnish the Bureau with a specific counterintelligence proposal utilizing this cartoon.

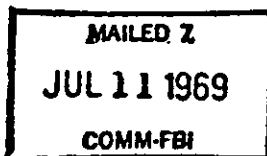

Recent arrests at Denver, Colorado, on June 5, 1969, of Black Panthers [REDACTED]

[REDACTED] for murder and kidnaping issued at New Haven, Connecticut, received extensive television and newspaper coverage at Denver and the headline on page one of the "Denver Post," daily newspaper, of June 5, 1969, related the fugitive status of these two subjects with the BPP of Denver.

It is felt this publicity portrayed the BPP in its true light with damaging effect to the BPP and a further alerting of the general public to the danger of this extremist organization.

On June 18, 1969, the "Denver Post," in a page one article reported the recovery of a cache of rifles stolen from a Denver loan shop on June 15, 1969. The article, which was accompanied by photographs of Denver police making the recovery, included statements by the Denver police that Black Panther documents were found at the scene of the recovery.

Information leading to the recovery of these weapons was furnished to the Denver Police Department by the Denver FBI Office on the night of June 17, 1969. The above items represent recent local action directly involving the Denver Office whereby counterintelligence has been used to thwart the activities and aims of the BPP.

On June 26, 1969, the "RON KARENGA" caricature was mailed at Boulder, Colorado, in commercially purchased, unmarked envelopes to the Denver Black Panther headquarters, 34th and Franklin Streets, Denver, to [REDACTED] and to [REDACTED]

[REDACTED] These three addresses have been published in recent newspaper articles at Denver.

Any information received as to results of this mailing will be submitted to the Bureau.

At the present time, the Denver Office is investigating an ITSP case in which Denver Black Panther [REDACTED] is a strong suspect. This case, which is currently carried as UNSUB; Theft of 10 Texaco Money Orders at Denver, Colorado, 3/4/69, has been designated by Bufile 87-104722, Denver file 87-13401. Investigation is being directed toward obtaining sufficient evidence on which [REDACTED] and other subjects can be charged under the Federal statute. It is to be noted that [REDACTED] is regarded as one of the more dangerous members of the BPP at Denver who has threatened police officers and is currently awaiting trial for assault on a Denver police officer. It is felt that efforts to prove criminal violations by individual Panthers, such as the ITSP case on [REDACTED] could, if successfully prosecuted, result in a weakening of the BPP organization.

The above represents the current status of counter-intelligence activity directed against the BPP at Denver.

Michigan, advised that in a union election held at Eldon Avenue Gear and Axle Plant and at the Hamtramck Assembly Plant, the LREBW candidates lost by very considerable margins to Negro moderate UAW candidates. This is viewed by [redacted] as completely neutralizing the LREBW effect on the plant, as had they lost to white candidates they would still have been able to criticize the UAW as being "racist". [redacted] stated that there has been no LREBW activity since that date at any of the Chrysler Corporation plants.

It should be noted that many of the main activists in the LREBW, including [redacted] have now redirected their activities with the National Black Economic Development Conference (NBEDC) and are presently subjects of [redacted] captioned, "National Black Economic Development Conference, ET AL; Extortion; ITAR-Conspiracy-Extortion".

Although numerous counterintelligence techniques have been considered by Detroit, it is felt that any attempts to embarrass or discredit the LRBW would merely aid the UAW in their control of workers at Chrysler Plants. In view of the fact that the Bureau must maintain a non-partisan position in regards to labor union matters and that any possible hint of Bureau support of the UAW could prove highly embarrassing, it is not felt at this time that counterintelligence techniques against the LRBW are warranted.

Should LRBW activity at local automotive plants increase, Detroit will reconsider instituting counterintelligence techniques.

The following is a 90-day progress letter submitted per instructions in Bureau airtel to Albany, et al, dated 3/4/68. The period covered in instant letter is from 4/22/69 to 7/1/69.

I. Operations Under Consideration

1. Republic of New Africa (RNA), and
National Black Economic Development Conference (NBEDC)

The RNA and NBEDC, originator of the "Black Manifesto", Detroit office of origin on both organizations, are presently the most prominent black militant groups functioning in this area. [REDACTED] local controversial, outspoken black attorney, whose RNA advocates black separatism. The factors of the NBEDC have been picketing the Federal Building, Detroit, during the first three days of July, 1969, in protest of a Federal Grand Jury who has been subpoenaing NBEDC sponsors. There have been wide spread rumors of an open rift between [REDACTED] and the demands set out in the "Black Manifesto".

On 7/2/69, protestors supporting the "Black Manifesto" picketed the Federal Building, Detroit. During the demonstration [REDACTED] appeared at the Federal Building where he publicly denounced the NBEDC as "counter-revolutionary idiocy". This situation appears to offer an opportunity to create friction between local leaders of the RNA and NBEDC. Further, for the most part, Detroit leaders of the NBEDC are local black militants.

2. Detroit Black Panther Party

Recently the Detroit Black Panther Party suffered the loss of MICHAEL BAYNHAM, local Minister of Defense. His death has been described as a suicide but because of the many unusual aspects of his death, party members locally suspect foul play. This, coupled with other internal problems of the Detroit BPP, has caused the party to halt its operations at least temporarily. Further, counter-intelligence techniques will be proposed to prevent it from becoming a significant force in Detroit.

3. Ad-Hoc Action Group, Citizens of Detroit
Black United Fund (BUF)
League of Revolutionary Black Workers (LRBW)
Student Non-Violent Coordinating Committee (SNCC)

These groups have achieved no measure of success in their attempts to act as disruptive forces in the area. BUF and SNCC are defunct and activities of the LRBW have practically ceased. Generally speaking, individuals involved with these groups have now associated themselves with NBEDC.

4. Miscellaneous - Black Nationalist Individuals

Consideration has been given to the utilization of CIA techniques on individuals functioning within the RNA and the BPP.

II. OPERATIONS BEING EFFECTED

Detroit is currently awaiting Bureau approval on a counterintelligence proposal submitted relating to the Detroit BPP. In addition, another counterintelligence technique is in the process of being prepared, which hopefully will result in creating a wide split between factions of the RNA and the NBEDC. Continuous attention is being directed to the effective use of a source at the Detroit News, a daily Detroit newspaper.

III. TANGIBLE RESULTS

The BPP in Detroit has ceased to function pending a review of its organizational problems and the selection

of new leaders. The organization was visibly shaken by the death of one of its top leaders. Other problems confronting the group have been a raid on its headquarters by the Detroit Police Department, finding adequate quarters, and the mishandling of party funds. Informants within the local party have caused immeasurable chaos, suspicion, and distrust between the members and leaders. As a result of their actions, the BPP, locally, has been rendered useless.

In addition, an intensive interview program is being conducted concerning BPP members, primarily as their activities concern possible violations of anti-riot laws. It is difficult to assess the value of these interviews although it is believed that they are very beneficial and result in limiting the activities of the various BPP members.

During the past 90-day period the following activities have been effected in addition to those above:

1) A total of eight Bureau approved cartoons have been mailed to a total of 28 individual BPP members. In addition, these cartoons were mailed to seven BPP headquarters offices and four underground newspapers throughout five field divisions.

2) A Bureau-approved anonymous telephone call was placed to [REDACTED] advising [REDACTED] that [REDACTED] named [REDACTED] as a police informer to protect his own hide.

3) Information was furnished to the Vice Detail of the San Diego Police Department concerning illegal operations at the Shalimar Restaurant, a local BPP hangout.

4) Information was confidentially furnished to the Intelligence Unit, San Diego Police Department, concerning the renting of a new meeting place by the BPP.

5) A Bureau-approved anonymous letter was sent to the San Diego Police Department concerning alleged child beating by [REDACTED]

6) A list of BPP offices, addresses, telephone numbers, and local leaders was sent to the Bureau and 17 field offices.

7) The following information, which is of counterintelligence interest and which does not require Bureau approval due to the fact that it involves a local crime, was furnished to the San Diego Police Department:

A. [REDACTED] was identified through his Swahili name as the possible killer of [REDACTED] BPP member.

B. Physical description, identifying data, and home address concerning [REDACTED] was furnished San Diego Police Department.

C. Information concerning the planned BPP caravan to Los Angeles on 4/30/69, was furnished to the San Diego Police Department. (This dissemination received prior Bureau approval).

D. San Diego Police Department Narcotics Bureau has been advised of the possession of narcotics and dangerous drugs by members of the BPP on a current and continuing basis whenever such information was received.

E. Information has been disseminated to the Intelligence Unit, San Diego Police Department, concerning pressure applied by BPP members for the solicitation of contributions which could logically result in extortion charges.

F. Information furnished to the San Diego Police Department concerning a BPP plan to kill police officers from ambush which resulted in such an attempt on 6/29/69.

G. San Diego Police Department was advised that prominent members of the black community have been listed for assassination by the BPP.

H. Background and descriptive data was furnished to the San Diego Police Department concerning [REDACTED] victim of shooting incident in San Diego, possibly by BPP members.

III.

TANGIBLE RESULTS

On 3/5/69, [REDACTED], was returned to Chino Prison to begin serving a one to five year sentence.

A felony warrant charging [REDACTED] with being a convicted felon in possession of a firearm, was obtained at Los Angeles by the San Diego office of the State Attorney General on 3/7/69.

On 3/10/69, [REDACTED] was arrested by the warrant obtained by the State Attorney General's office with the assistance of the San Diego Police Department.

At the same time the felony warrant was obtained concerning [REDACTED] a misdemeanor warrant was obtained for [REDACTED] in connection with and as the result of his purchase of the hand weapon found in [REDACTED] possession on 1/24/69.

On 1/25/69, Bureau approved anonymous telephone call was placed to [REDACTED] accusing [REDACTED] of being a "police agent." On 3/5/69, [REDACTED] along with [REDACTED] approached [REDACTED] in the presence of several other BPP members and told [REDACTED] "We know that either you, [REDACTED] is a police agent and I can prove it." [REDACTED] at this time was disturbed to the point of visible shaking and replied, "Well then it's [REDACTED]"

The Bureau approved cartoons reportedly have the BPP members "completely paranoid, shook up and afraid."

[REDACTED] has been forced to cease her association with the BPP by her parents.

[REDACTED] was forced to move out of her mother's home.

Due to the fact that [REDACTED] as himself been accused of being a police informer from several quarters, he has launched out at numerous individuals, accusing them of being informers.

On 3/19/69, [REDACTED] was expelled from the BPP after having been accused by [REDACTED] of being a police informer.

On 3/25/69 [redacted] was arrested by the San Diego Police Department on information furnished by the San Diego Office of the FBI advising of [redacted] current whereabouts.

[redacted] has been expelled from the BPP under suspicion of being a police informer.

A one hour television tape was scheduled for taping on 4/1/69 at a local television station by members of the BPP leadership. Due to the widespread dissension and suspicion within the party, however, only one individual, [redacted] appeared for the taping. As a result the scheduled television taping was called off.

On 4/4/69, there was a rally in Southcrest Park in Southeast San Diego. During this rally US members confronted BPP members and the BPP members "ran the US members off." This reportedly is a result of the receipt of cartoons by BPP members berating them and causing ill feelings toward the US members.

As a result of the above and on the same date, US members broke into a BPP political educational meeting. They stated at this time that they were looking for [redacted] and when he was not present, "roughed up" [redacted]

Concerning the distribution of the Bureau-approved cartoons, the San Francisco Division has reported that the San Diego caricatures which have arrived at various locations have surprised and angered the BPP recipients.

[redacted] as a result of the Bureau-approved anonymous telephone call to him, has joined forces with [redacted]

[redacted] has beaten up [redacted] in the BPP office in San Diego due to the fact that he suspected [redacted] of being a police informant.

On 5/16/69, members of the San Diego Police Department, Vice Squad, raided the Shalimar Restaurant as a result of the Bureau approved information furnished to that detail.

On 5/23/69 [REDACTED] vehicle was located and repossessed by EMAC.

IV.

DEVELOPMENTS OF COUNTERINTELLIGENCE INTEREST

The split between the BPP and US organization in San Diego continues to widen and to become more violent with no hope of reconciliation foreseen in the immediate future.

US appears to be emerging as the dominant group in the San Diego area and if there was a direct confrontation between the two groups at the present time, US would undoubtedly emerge as the victor.

Informants have reported on a rather frequent basis that both the BPP and US have been receiving individuals belonging to their respective organizations from out of town. These individuals, of whom it is estimated that 20 belong to the BPP and 15 belong to the US organization, are reportedly from Oakland and Los Angeles.

The photographs marked 1 through 41 depict scenes in the vicinity of the Cuyahoga County Criminal Courts Building and the Cleveland City Jail when black extremists, their followers, and interested onlookers milled around these buildings prior to the outbreak of scuffling and subsequent arrests of dissidents led by [redacted] (shown in pictures 16, 18, 10, and 30). Photos numbered 1a through 4a show activity at Collinwood High School, a predominantly white high school, after whites attacked Negro students and trouble was anticipated in retaliatory action by Negro students. Photos numbered 1b through 6b, which were taken [redacted] were taken during extremist meeting called "Week of Political Prisoners Rally." Those active in this rally were [redacted] national officer of the Republic of New Africa (photo 4b) and [redacted] representative of the Black Panther Party (individual on left in photo 6b).

Cleveland will continue to submit photos of interest such as the enclosed and the eighty photos submitted with referenced communication.

The following is a ninety day summary of activities within the New Haven Division relating to captioned program:

1. Operations Under Consideration (u)

Due to the total disruption of the Black Panther Party (BPP) as a result of the arrest of the State BPP leadership and due to the fact that other black nationalists organizations within the State remain in a dormant state, no immediately operations are under consideration.

2. Operations Being Effectuated (u)

b7C, b7D As authorized by the Bureau, New Haven will continue to furnish public source data to [REDACTED] New Haven will remain alert for those incidents or circumstances which may lead themselves to counterintelligence exploitation. ~~CONFIDENTIAL~~ (u)

3. Tangible Results

As a direct result of action taken by FBI, New Haven, and the New Haven Police Department in connection with the homicide investigation of ALEX RACKLEY, the overall effective leadership of the BPP has been seriously disrupted. In addition, the leadership of the BPP may on some future date be prosecuted under the Smith Act - Overthrow of the United States Government. In addition to the above, thirty four arrests have directly or indirectly resulted from the investigation of the RACKLEY murder. (u)

The above was the result of the finding of the body of ALEX RACKLEY, a member of the New York City BPP, in a swamp near Middlefield, Connecticut, on May 21, 1969. RACKLEY had been shot in the head and the chest with a large caliber weapon. The investigation conducted by the New Haven Police Department with FBI, New Haven, assistance developed that RACKLEY had been murdered by other BPP members who believed him to be a police informant.

b7c Nine New Haven Panthers were arrested in Connecticut and State authorities requested UFAP process against [REDACTED] a New Haven Panther, and [REDACTED] and [REDACTED] and [REDACTED] have been described as enforcers for BPP national.

b7c Information was received that [REDACTED] was being held at the BPP political jail in Chicago because he had raped a Detroit Pantherette. Based on this information, the Chicago Division raided the BPP headquarters on June 3, 1969, in an effort to locate [REDACTED] however, he could not be found. There were found a number of rifles and shotguns as a result of the search of the BPP headquarters and eight BPP members were arrested on the charge of harboring and possession of illegal weapons.

Evidence secured during the raid contained documents which indicated that the BPP has made plans to physically take over various State and local governments throughout the State of Illinois. This information has been furnished to the Department of Justice, which is considering prosecution under the Smith Act.

b7c The Denver Division, on June 5, 1969, received information from informants which resulted in the arrest at BPP headquarters at Denver of [REDACTED]

b7c [REDACTED] of Washington, D.C., a key black extremist and [REDACTED] was arrested on June 5, 1969, on the charge of theft of Government property. This arrest was brought about when information was obtained that [REDACTED] went to the residence of [REDACTED] and Special Agents in an attempt to apprehend [REDACTED] went to [REDACTED]

apartment where an M-1 rifle, ammunition and a tape recorder, bearing a sticker which indicated that it was the property of the National Science Foundation, were located. The items were confiscated and it has been determined that the rifle had previously been reported stolen from the United States Navy, Treasure Island, California.

b7C [REDACTED] was arrested by FBI Agents in Salt Lake City, Utah, on June 6, 1969.

As a result of the various raids and arrests, the FBI has acquired voluminous evidence and valuable intelligence data and has placed a burden on the National Headquarters of the EPP to provide defense funds for those arrested. The events which followed the New Haven incident has had a disruptive effect on the entire EPP leadership throughout the United States. It is worthy of note that Chairman BOBBY SEALE has publicly stated that in the recent past "40" EPP leaders have been arrested in the United States.

Boston is also aware that [REDACTED] a militant Negro on the Boston Agitator Index, is in poor financial condition. Two years ago [REDACTED] obtained a two million dollar loan from the New England Mutual Life Insurance Company of Boston to a company [REDACTED] Financial Aids and Investment Techniques (FAIT).

Through a personal contact of [REDACTED] in New England Mutual Life Insurance Company, an effort is being made to have New England Mutual Life Insurance Company demand an accounting from FAIT. If this is done there is no possibility of this being connected to the FBI and it would embarrass [REDACTED] and make his financial condition known and possibly prevent the granting of other loans [REDACTED] is seeking.

Information concerning [redacted] activities was discussed with [redacted] and he made notations for possible later use in a discrediting editorial. [redacted] said that the deadline for OEO consideration of [redacted] request for funds is 6/30/69 and he would know by that time whether the grant would be approved.

On 6/27/69 [redacted] who identified himself as a [redacted] telephonically contacted the Syracuse Resident Agency and requested information concerning [redacted]. He said OEO officials who were in the process of making a decision regarding [redacted] request for Federal funds had received reports that members of [redacted] were involved in illegal activities. [redacted] further advised that OEO was concerned about this fact inasmuch as there was a [redacted] in Syracuse [redacted] who was threatening to "rip OEO apart if [redacted] received the \$16,000 grant." [redacted] said that he felt that the newspaperman "had the ammunition to do it." 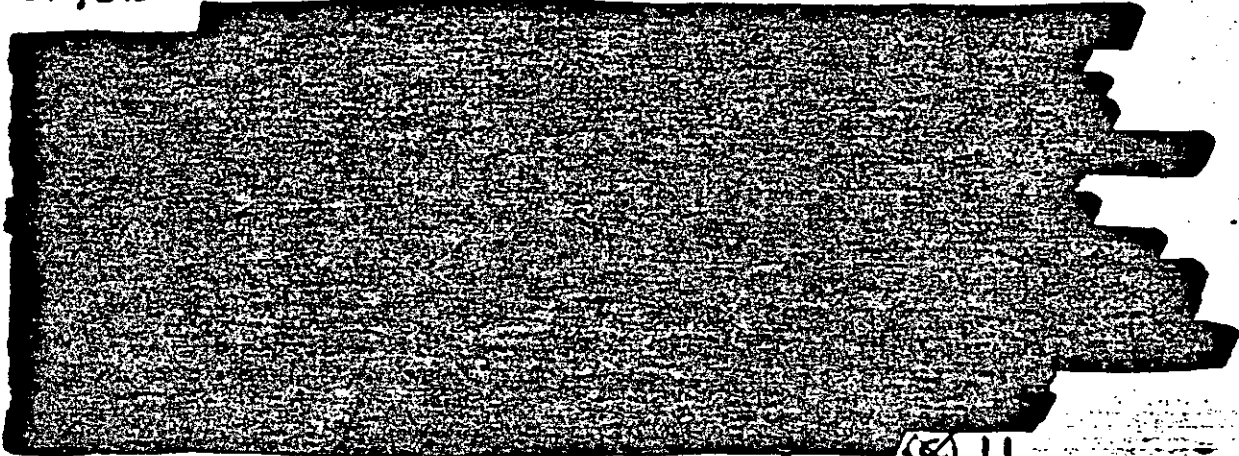

The following is a telegram which should be anonymously sent by the Boston Office by means of a pay telephone by a mature and experienced Agent.

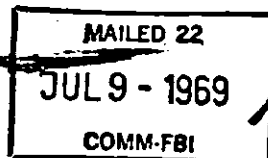

Enclosed are nine (9) glossy photographs, 8" x 10" in size, taken by Chicago as a result of the raid 6/4/69, by Chicago SA's on Chicago Black Panther Party (BPP) headquarters.

These photos are numbered one through nine on the reverse side. Photographs one through eight were taken at BPP office space, 2350 W. Madison Street, Chicago, while photograph number nine was taken in the Chicago Office. This photograph depicts all the weapons which were seized at the time of the raid.

It is recognized by Chicago, that the bulk of these photographs are not those specified by the Bureau as the type desired, i.e., sniping attacks on police, scenes of racial violence, etc.; however, such photographs are somewhat difficult to obtain. As the Bureau has been advised, Chicago has previously reviewed the material available at the Graphic Arts Unit of the Chicago Police Department, and periodically brings this review up to date.

The material which is enclosed is the best available at present to Chicago, of possible interest along these lines. The photographs are largely self-explanatory, however, it might be noted the iron bar

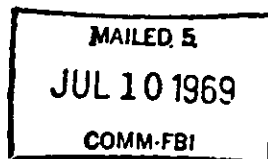

For the information of the Bureau, copies of the Black Panther Party (BPP) newspaper are being circulated in the Negro communities of Dade County. It can be anticipated, with the circulation of this newspaper, that a chapter of the BPP will eventually be organized in Miami.

[REDACTED] Sr. has been a Liaison Source of the Miami Office since November, 1964. He can best be described as a voice of moderation in the [REDACTED] of Miami and to a large degree is responsible for the [REDACTED] in Dade County.

Several weeks ago, [REDACTED] who met with President NIXON in Washington, D. C. [REDACTED] is a loyal and trusted friend of the Miami Office and was last contacted on July 8, 1969, when he was furnished a recent copy of the Black Panther newspaper.

In view of the circulation of the Black Panther newspaper in Miami, [REDACTED] contemplates the preparation of an editorial for the "Miami Times", a weekly Miami, Florida newspaper of which he is Editor, with a large circulation in the Negro communities of Dade County. [REDACTED] said he would try to exploit the propaganda that appears in the Black Panther newspaper and to point out that this is not the type of organization that is needed in Miami. [REDACTED] advised that he hopes that he can set the record straight as far as the BPP is concerned and through his editorial would probably receive "letters to the Editor" regarding the organization and whether or not a chapter is being formed in the Miami community.

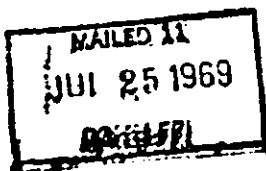

Portland submitted a general suggestion that the Bureau consider the anonymous mailing of copies of these articles to various Negro ministers and churches in cities where the BPP is active. We are advising them that this is being done in specific cities and instructing them to review Portland files to determine if such mailings are favorable in that city.

A review of the situation surrounding captioned organization discloses that the BPP appears to be in trouble, both financially and politically. The apparent causes are varied. Numerous arrests by both local police agencies and the FBI have injured not only the physical ranks of the BPP but also its image throughout the country. Its invincibility was challenged and struck down as a result of the arrests. Stokely Carmichael has resigned from the organization and has obviously taken with him a segment of Panther support. The immorality of BPP leaders David Hilliard and Bobby Seale, and the drinking of Seale, have contributed to a decline in morale within the national leadership.

The BPP from the very beginning has stressed the theme that the black man alone shall rule, no white man was to be trusted, and no white man would ever be allowed in the organization. At this time the BPP is so desperate that it is seeking alliances with white groups such as the Communist Party and the Students For a Democratic Society.

The above presents only a few of the weaknesses in the Black Panther Party throughout the country. At this time it is most imperative that we capitalize on these weaknesses. The disruption of this organization through counterintelligence should continue and even increase as the weaknesses appear. In submitting your future counterintelligence proposals, consideration should be given toward exploiting the above weaknesses and others as they appear. The full cooperation of recipient offices is needed so that the threat posed by the BPP can be eradicated.

As the BPP grew in size, and activity increased, its actions were watched by an ever increasing number of people. At that time its viciousness became apparent and its decline began. We must, therefore, concentrate our counterintelligence on the national organization in addition to the chapters. This group, like other political type organizations, depends on its public image for existence. As such, exposure can injure its image and cause disruption on a national scale.

NOTE:

The Black Panther Party is believed at this time to be in trouble. We are pointing out some of the apparent weaknesses of this group to the field offices most active in the counterintelligence program. We are instructing them to consider these weaknesses in future counterintelligence.

Succinct summary of Black Nationalist Movement
in the Indianapolis Division follows:

A. Nation of Islam (NOI)

The NOI in the Indianapolis Division has approximately 140 members at present. This figure represents no change from the date of the last letter, as no significant changes have taken place. There are two numbered mosques, number 31 in South Bend, and number 33 in Gary. In addition, there are five other temples or mosques, located in Evansville, Fort Wayne, Muncie, Indianapolis, and East Chicago, Indiana. The three largest units are South Bend, Gary and Indianapolis, with about 50, 45 and 27 members respectively.

The NOI at Muncie has about 5 or 6 members, but have lost their meeting place and have not had meetings recently. The other units with the exception of the three largest, each have about 6 members and are struggling for existence.

There has been no known proposed violence or problems caused by the NOI to date in the Indianapolis Division. There is always the possibility the NOI might cause trouble, although their potential at this time does not seem great. The leaders of all of the temples and mosques in the Indianapolis Division adhere to the teachings of ELIJAH MUHAMMAD, their leader.

B. Radical Action Project (RAP)

The Radical Action Project also known as the Black Radical Action Project is still located at 2264 North Meridian Street, in Indianapolis, Indiana. The RAP is presently at the end of their funds, not having received any funds since using up their last grant from the Episcopal Church which was not renewed. [REDACTED]

[REDACTED] are now the only persons who are at RAP Headquarters. The rest of the staff of RAP are no longer working as they do not have funds to pay them, and [REDACTED] are working without pay at present. Their primary function has been to maintain the Afro-American Bookstore which RAP operates; however, it has been losing money on a regular basis and their debts are accumulating so it will not continue to operate much longer unless funds are received.

RAP has operated within the framework of the law in the past and have attempted to establish Negro owned businesses, help Negroes to find employment, and have taken a strong stand against police brutality and harassment. They frequently complain to the police department when black persons are arrested and to date have posed no real threat of violence. The potential however exists as long as they continue to operate. It appears they may be non-existent in the near future.

C. Black Panther Party (BPP)

The BPP continues to be the most active organization in the Indianapolis area, and operates from their headquarters at 113 West 30th Street, Indianapolis, Indiana. Chairman of the BPP in Indianapolis is [REDACTED]

[REDACTED] Their membership is presently about twelve to fifteen active members at most, with [REDACTED] being the main leaders and speakers.

The BPP in Indianapolis has the most potential for violence of any of the organizations; however, to date have not actually started any trouble. The BPP recently has been attempting to start a Breakfast for School Children Program and has been looking for a new headquarters location; however, neither has been successful to date. The activities of the BPP are followed in a bi-weekly letter.

1. Operations Under Consideration

The plans under consideration at this time are to continue interviewing all members and affiliates of the black extremist groups. The interviews in the past have been very effective in most groups, with the BPP being the exception as members of the BPP will not talk with agents, except on a rare occasion. The BPP would also like to relocate their headquarters and as a counter-intelligence move when location is being considered and is known, Indianapolis will attempt to see the location is not available to them.

2. Operations Being Effected

Contact with [REDACTED] has been continued. [REDACTED] is with the Episcopal Church and has a great deal of influence in the church. The Episcopal Church in New York City in 1/68 gave a grant of about \$47,000 to the Radical Action Project in Indianapolis. [REDACTED] pondered in his own mind if the grant should have been given to RAP and if it should be renewed for another year. The matter was discussed with STEEG, and he came to the conclusion RAP should not be refinanced and used his influence to see that the Episcopal Church did not renew the grant this year.

3. Tangible Results

As a result of contact with [REDACTED] and the grant not being renewed RAP now has no funds, their staff has been let go, they are two months behind in rent, no one is receiving any salary, the membership has dwindled to

where the organization has become almost non-existent, and the bookstore is putting them farther in debt each month it is operated.

4. Developements of Counterintelligence Interest

None other than those mentioned above.

The article further stated that approximately 40 per cent of the congregation at Cross Lutheran Church were black, and that the Council members voting on the resolution to refuse permission to the BPP included blacks.

[REDACTED] noted further that the Panthers had made the announcement about use of the church facilities without authorization.

The [REDACTED] is quoted as saying that after the action by the Cross Church Council, he had gotten new information leading him to believe that the local Panther Chapter's "stress on the violent overthrow of Government is not National Black Panther policy." The [REDACTED] also indicated that if the Church Council was to find out that the local organization was not subscribing to a violent overthrow of the Government-type policy, it could certainly alter its attitude toward the matter of the breakfast.

[REDACTED]

[REDACTED] advised that a capias warrant is outstanding for [REDACTED] for failure to appear in court, and that his department has had contact with him this date. Arrangements are being made by the Police Department to have [REDACTED] appear with his lawyer as ordered in court. Their plans are to interview him re his connections with the BPP immediately following his court appearance. No definite date has been set for this appearance. [REDACTED] advised further that he had no further information concerning [REDACTED]
