

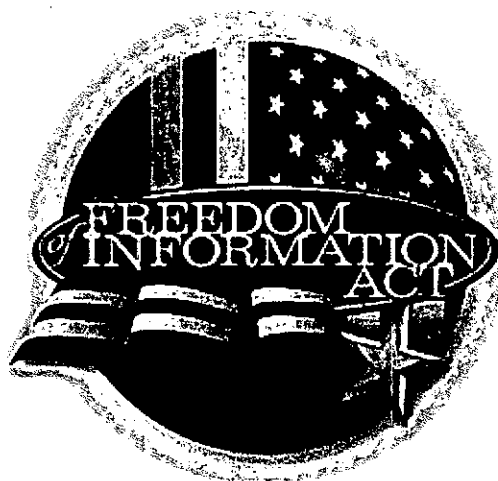

To date there have been no organizations affiliated with the New Left movement active within the Tampa Division. Continuous contact has been maintained with logical confidential sources, with established sources at universities and colleges, and with local police agencies concerning New Left organizations. During the past week, [redacted] a student at the University of South Florida (USF), presented a petition to USF for recognition of a Students for a Democratic Society (SDS) chapter at USF. In his petition he claimed that the proposed chapter would not be affiliated with the National SDS. The request for recognition was denied by the president of USF and by the Dean of Student Affairs, an established source, because they felt that any chapter of the SDS would be affiliated with the national organization whose past activities would indicate that the organization would not be acting for the betterment of USF.

The Tampa Division will closely follow the activities of [redacted] and his efforts to establish an SDS chapter at USF. Information obtained as a result of the investigation which could be used for counterintelligence purposes will be furnished to the Bureau for recommendations for Bureau approval on any proposed action.

All SAs responsible for investigation of the New Left have been alerted to the counterintelligence program and the Bureau's responsibilities in exposing, disrupting and neutralizing the activities of the New Left organizations and their members.

On 7/1/68 and every 3 months thereafter Tampa will submit to the Bureau a status letter as requested in reBulet.

As indicated in reTPlet, officials at the University of South Florida (USF), Tampa, Florida, denied the request for recognition of a chapter of the Students for a Democratic Society (SDS) at USF.

On June 19, 1968, the Dean of Men at USF indicated [redacted] a student at USF who presented the petition for recognition, had attempted to place an advertisement in the USF student publication calling for a gathering at the American building at USF on June 24, 1968. The student publication refused to accept the advertisement, and as a result, the gathering was not held. [redacted] has indicated that the gathering will be rescheduled for sometime in October,

As the Bureau has been previously advised there are no organized New Left groups in existence within the Tampa Division and there has been no campus disturbances within the past year.

As reflected in referenced Tampa letters, officials at the University of South Florida (USF), Tampa, Florida, denied a request for recognition of a chapter of the STUDENTS FOR A DEMOCRATIC SOCIETY (SDS) in May, 1968. In June, 1968, the USF student publication refused to accept an advertisement calling for an SDS gathering at the Administration Building, on June 24, 1968. [REDACTED], the student at USF, who presented the SDS petition for recognition and who attempted to place the advertisement in the student publication, has indicated that the gathering will be rescheduled for some time in October, 1968.

The files of the Tampa Office contain no subversive data or information concerning prior activity in the New Left movement on the part of [REDACTED]. [REDACTED] has completed his freshman year at USF and was honorably discharged from the [REDACTED]

The Tampa Office maintains close contact with the Vice President for Student Affairs and the Dean of Men, established sources at USF.

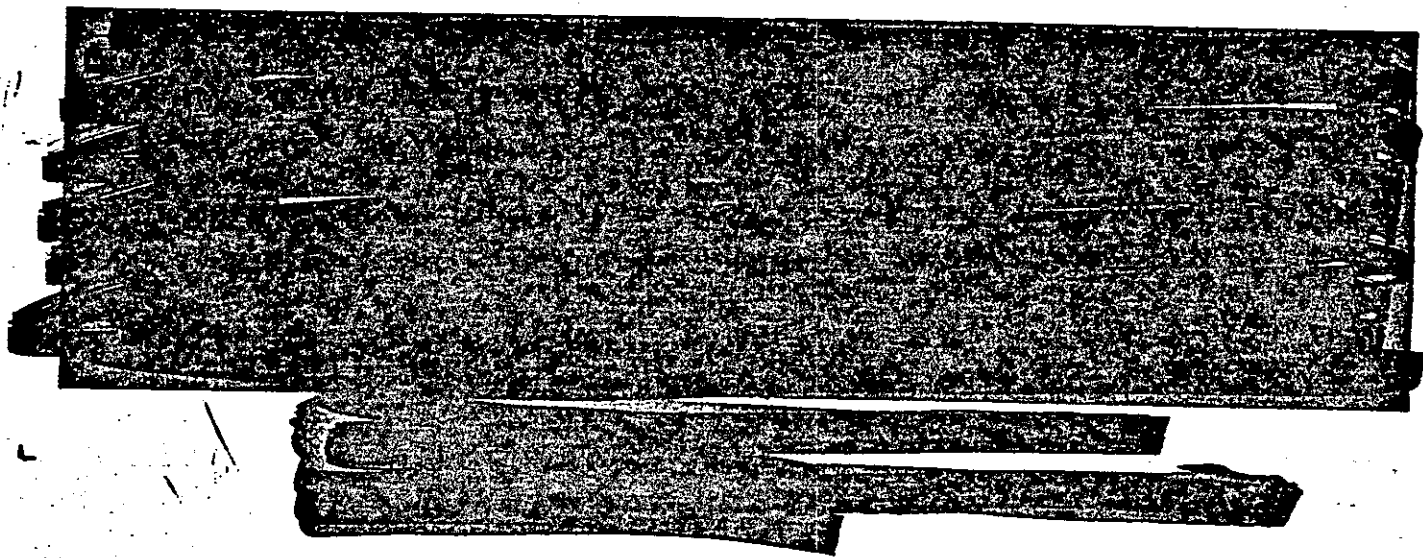

Reairtel referred to previous Bureau communications which pointed out the necessity of taking immediate action to expose, disrupt and otherwise neutralize the activities of the New Left. As part of the program, offices were instructed to remain alert for and to seek specific data depicting the depraved nature and moral looseness of the New Left. Offices were further instructed to consider ways to use the material in a vigorous and enthusiastic approach to neutralize the New Left.

Reairtel further reflected that little evidence had reached the Bureau indicating field offices were using this type of information to the best advantage.

In the past, New Left activity in the Tampa area has been either nonexistent or minimal so that there did not appear to be sufficient activity to neutralize. Recently, however, the Tampa Office has instituted investigations re students at Florida Presbyterian College, St. Petersburg, and New College, Sarasota, Fla. based upon information received to the effect that these individuals were members or associated with SDS or affiliated organizations. In addition, although there is no organized SDS or affiliated organization active on the University of South Florida (USF) campus at the present time, there does appear to be a representative number of students at USF that are in sympathy with SDS.

In view of the apparent increased interest and activity re the New Left in the Tampa area, the Tampa Office will continue to remain alert to obtain pertinent data, including photographs that could be utilized effectively in captioned program.

[REDACTED] MI, Tampa, Fla., was informed by the Tampa Office that [REDACTED] and his brother, [REDACTED], both of whom have been active in anti-war type demonstrations recently held in the Tampa area, are the sons of one [REDACTED], U. S. Army. [REDACTED] subsequently advised that [REDACTED] had been informed of his sons' activities and [REDACTED] added that the information was most appreciated inasmuch as [REDACTED] is being considered for an Attache assignment somewhere behind the Iron Curtain, and that the activities of his sons could be a source of embarrassment to [REDACTED] as well as to [REDACTED] superiors in the U. S. Army.

In connection with the above, on 5/21/69, an established source at the University of South Florida (USF), who was not cognizant of the above contact between MI and Tampa Office, advised that he had heard that the [REDACTED] boys, [REDACTED] and [REDACTED] had been warned by their father to stay away from the St. Leo College demonstration, held in St. Leo, Florida, 4/26/69. It is noted that through source coverage concerning the demonstration on 4/26/69, there was no indication that either of the [REDACTED] boys participated in the demonstration, nor was there any indication that either of these boys participated in an anti-war type demonstration held in St. Petersburg, Florida, 5/15/69. It would appear that the information furnished to MI, and which was related to [REDACTED] has had some counterintelligence value.

On 5/9/69, [REDACTED] was also advised that [REDACTED] and her brother, [REDACTED] both students at USF and both of whom have also been active in anti-war type demonstrations, are the children of one [REDACTED]

The following represents Tampa activities under captioned program since submission of re letters:

(1) Potential Counterintelligence Action

The majority of institutions of higher learning in the Tampa Division have completed their academic year 1968-69, and, while many are now in Summer Sessions, student activity in the New Left field is at a minimum, and should remain so until September 1969. Several principal New Left figures remain in the Tampa area, including [redacted] who has been active in attempting to establish an SDS chapter on the University of South Florida (USF) campus. Tampa is currently considering directing anonymous letters to parents and/or families of these New Left figures, particularly in instances in which they have become involved with the law concerning the use of drugs and narcotics. Bureau approval will, of course, be obtained prior to any such mailing.

(2) Pending Counterintelligence Action

Bureau is referred to recent correspondence in case captioned [redacted] in which the New York Office prepared a letter to be sent from Tampa anonymously to [redacted] who is an [redacted] is the father of [redacted]. Utilizing letter prepared by New York Office, which was approved by the Bureau, Tampa, on 6/24/69, mailed this letter from Tampa to [redacted]. On 9/9/69, Tampa will follow this up with mailing of a second letter to [redacted] which contains the approved SDS montage.

(1) Potential Counterintelligence Action

By Tampa airtel to Bureau, dated 10/16/69, and captioned, [redacted] a [redacted] SSA", Bufile 100-[redacted], Bureau and New York were apprised of situation re [redacted] which indicated that [redacted] may possibly be in violation of SSA by having furnished false information to his local draft board regarding his attendance at New College, Sarasota, Fla. Tampa Office has confirmed that [redacted] is no longer a student at New College and letter directed to local draft board advising that [redacted] is a full-time student at New College may have been forwarded by [redacted] and may possibly be the basis for a SSA violation. Appropriate leads were set forth for New York in above referred to Tampa airtel and upon receipt of results of these leads, Tampa Office will be in a better position to evaluate whether any counterintelligence action may be initiated relative to this situation. At the present time, however, it appears that there is some potential counterintelligence action regarding this matter.

As the New Left activity in the Tampa area increases, it is anticipated that situations may arise which will warrant consideration for counterintelligence action.

(2) Pending Counterintelligence Action

At the present time there is no pending counterintelligence action being handled by the Tampa Office.

(3) Tangible Results

Counterintelligence action has apparently been concluded relative to the case of "[REDACTED] SM-SDS", Bufile 100-[REDACTED]; and the case of "[REDACTED]", aka, SSA", Bufile 100-[REDACTED] was last known to be in the Big Sur area of California and there are no indications that he plans to return to the Sarasota, Florida area.

In connection with captioned program, Bureau authority is requested to send an identical letter to one enclosed, but which will be prepared by Tampa Office on plain, white, unwatermarked, bond paper and will be typed. The letter will be addressed to Mr. and Mrs. [redacted], which information was set forth in Cincinnati airtel to Bureau 10/31/69 captioned "SOUTHERN REGIONAL CONFERENCE OF STUDENTS FOR A DEMOCRATIC SOCIETY (SDS), FLORIDA STATE UNIVERSITY (FSU), TALLAHASSEE, FLA. 10/18/69."

It is anticipated that receipt of this letter by [redacted] mother- and father-in-law will result in serious concern by them over the safety of their daughter and grandchild, latter being [redacted] stepdaughter, and that they will express their concern to their daughter and [redacted]. Possibility exists that if such concern is expressed, [redacted] future New Left activities might be minimized. Concomitantly, it is expected that when contents of letter become known to [redacted] he will undoubtedly concern himself as to the identity of its author and whether one of his close associates is responsible for the letter.

Petersburg, Florida 4/18/70, SA of the Tampa Office observed subject in attendance and during a melee which erupted between police and demonstrators, [REDACTED] was heard to shout to some of the demonstrators that appeared to be fleeing the area, "Where are you going, brothers and sisters? Now's the time," in an effort to encourage the demonstrators to return to the area and harass the police. In view of [REDACTED] activities and ideology, he would appear to warrant attention in connection with captioned program.

Dear Mr. and Mrs. [REDACTED]

I have known your son-in-law, [REDACTED] ever since he was a student at the University of South Florida, and Chip was influential in my later participation in demonstrations against the Vietnam War and this country's Selective Service System. I subsequently met your daughter [REDACTED] and your lovely grandchild.

It is over my concern about your grandchild's future health and safety that prompts me to send this letter. During some of the demonstrations that I have participated in, I have noticed [REDACTED] frequently appears with [REDACTED] and your grandchild. During a State-wide demonstration in St. Petersburg on April 18 this year, a near riot erupted when police arrested one of the speakers. Rocks and bottles were being thrown about and the police were swinging their clubs wildly as they arrested about 15 people. During all this activity, I heard [REDACTED] yell to some of the demonstrators running away from the police, to come back to fight and like a true revolutionist, shouted, "Now is the time." I mentioned all this, Mr. and Mrs. [REDACTED] because [REDACTED] and your grandchild were in the middle of all this and could easily have been maimed. [REDACTED] did not have the sense to remove them from the area when the trouble started.

I certainly don't want to upset either of you, but I have come to the conclusion that although I agree with [REDACTED] about the war in Indo-China and am in favor of some of the social reforms that [REDACTED] advocates, I am not in favor of an overthrow of the U.S. Government as [REDACTED] is. This country may not be perfect but it is still the best one around today. It seems to me that [REDACTED] emotional immaturity and naivete about the world he lives in has caused him to involve himself so much in efforts to create his own socialist revolution that he has been a failure as a student, as a worker, and from the way he exposed your daughter and grandchild to bodily harm, on April 18, he also appears to have failed as a husband.

Please do what you can to convince [redacted] that [redacted] revolutionary activities and ideology could have a deleterious effect on the mental and physical health of both herself and your grandchild.

I have given a lot of thought to signing this letter but unfortunately because of circumstances at this time I can only identify myself as

There are a few subjects within the Tampa Division whose activities could possibly be blunted by a counterintelligence program and Tampa continues to remain alert for propitious opportunities and situations to initiate such a program against these individuals.

By letter dated 5/27/70 Bureau authority was granted to prepare and mail a letter to the mother-in-law and father-in-law of Tampa subject [REDACTED] 100-[REDACTED], TPfile 100-[REDACTED] in connection with captioned program. This letter was prepared and mailed by an SA of the Tampa Office on evening of 6/9/70. All necessary steps were taken to protect the Bureau as source of this letter.

the fact that during a recent interview by SAs of the Tampa Office with [REDACTED] (Bufile 100-[REDACTED] TPfile 100-[REDACTED]) it was disclosed that [REDACTED] reportedly wishes to cease her involvement in New Left activities.

In addition to the above, [REDACTED] name continues to appear in "The Militant" as a YSA contact in Tampa, Florida and this public source information has been displayed to interested established sources on campus of USF which campus [REDACTED] continues to visit in connection with his activities. These established sources expressed great interest in [REDACTED] affiliation with YSA and it is felt that this technique of furnishing established sources with public source type data has some counterintelligence value since undoubtedly [REDACTED] future activities on campus will be viewed with askance by USF officials.

It should be noted that concerning "The Militant", Tampa Office has also brought to the attention of established sources at USF, information which has appeared in "The Militant" concerning the activities of [REDACTED] (Bufile 100-[REDACTED]; TPfile 100-[REDACTED]), who is presently a student at USF.

Dallas letter to Tampa 10/5/70 under caption, [redacted] aka" (TPfile 100-[redacted]) reflected that inquiry with PD, postal authorities, and pretext in neighborhood of Belt Line Road, Lancaster, Texas, failed to disclose any information regarding [redacted] or any such address as [redacted]

It is noted that reBulet granted Tampa authority to direct an anonymous letter to [redacted] who is father of [redacted] and father-in-law of [redacted] (TPfile 100-[redacted]), both active YSA-Tampa members re activities of [redacted] and her husband. The envelope in which this letter was enclosed naturally did not bear any return address and since investigation at Dallas disclosed no such address as [redacted] at which address the letter was directed, it would seem that [redacted] never received TPO anonymous letter.

In connection with the above, it is further noted that on 8/17/70 a vehicle observed in front of [redacted] residence in Tampa was determined to be registered to [redacted] at address [redacted] Tampa and other investigation in cases regarding both [redacted] indicates that [redacted] now resides in the Tampa area.

In view of the above, TPO contemplates drafting another anonymous letter to [redacted] at his Tampa address and Tampa will submit this draft to Bureau for approval.

On 10/8/70, in connection with Tampa investigations re [REDACTED] (TPfile [REDACTED]) and his alleged spouse [REDACTED], aka (TPfile 100 [REDACTED]), both active YSA-Tampa members, an SA of TPO had the opportunity to observe [REDACTED] cash a check at a grocery store and subsequent inquiries disclosed that this check was an insufficient funds check and therefore in violation of local law. Tampa PD was confidentially advised of this information and as a result [REDACTED] was arrested by the Intelligence Unit, PD, Tampa, on 10/9/70 [REDACTED] posted bond for [REDACTED] and although the charge against [REDACTED] was subsequently dismissed when she made restitution, the arrest temporarily upset activities of [REDACTED] and [REDACTED] afforded IU, PD, opportunity to visually inspect apartment of [REDACTED] and [REDACTED] where arrest was made, and photographs taken of [REDACTED] in connection with arrest made available to TPO.

Since it does not appear that your proposal if implemented would achieve significant results, Bureau authority for this request is denied.

The following represents quarterly status letter for the Tampa Office in connection with captioned program during the period 1/1/71-3/31/71:

1) Potential Counterintelligence Action

Information received from reliable source indicates that YSA-Tampa has a continual problem of a meeting place for its weekly sessions. YSA-Tampa had met for many months at private residence of one of its members but when attendance at meetings increased, the group then changed its meeting place to University Fellowship Chapel (UFC), a part of campus of USF, although YSA is not a student-approved group. Access to UFC appears to be through a student caretaker at UFC. When UFC has been unavailable, YSA-Tampa has encountered difficulty in obtaining a meeting place.

In view of above, it would seem that some counter-intelligence action could be initiated concerning YSA-Tampa meeting places. One possibility which offers some potential is to address an anonymous letter to the USF student caretaker at UFC concerning unauthorized use of USF facilities by YSA-Tampa. TPO will give appropriate consideration to this potential counterintelligence action. [REC-47]

3) Tangible Results

[REDACTED] (TPfile 100-[REDACTED] Bufile 100-[REDACTED])
a New Left extremist, is no longer a student at USF and in fact has departed the Tampa area. Confidential sources at USF have advised that after [REDACTED] financial assistance from LEEP was discontinued by USF officials, he apparently did not have sufficient funds to continue at USF.

It is noted that although [REDACTED] assistance through LEEP was previously known to USF officials, the opinion of USF officials had been that any discontinuance of such assistance had to be initiated through U. S. Department of Justice, LEEP Section. Through confidential and tactful contacts by TPO with confidential sources at USF, these sources were informed that termination of [REDACTED] financial assistance had to be initiated from USF and not from USDJ. Once made aware of above, [REDACTED] removal from the New Left scene in Tampa quickly followed.
