

COUNTERINTELLIGENCE PROGRAM INTERNAL SECURITY DISRUPTION OF THE NEW LEFT

ReBulet to SAC Albany dated 5/10/68.

There are no New Left Organizations or Key Activists in the State of Alaska at the present time. Established sources have been alerted to furnish information concerning any group or individuals planning or attempting to organize activities involving civil disobedience, antiwar, antidraft, pacifist and radical groups. In addition, agents of the Anchorage Division are constantly alert to detect any indication of such activity or attempted organization.

This case is being placed in a pending inactive status and will be made active on a three months basis so this matter can be reviewed regularly to insure that in the event of future indications regarding New Left Activity in the State of Alaska, a potential counterintelligence action can be recommended to the Bureau. Any indications of New Left activity will be immediately brought to the Bureau's attention.
