Atlanta proposed to send letter indicating that Jenness had been transferred to New York, effective after the elections 11-3-70. Such letter would have little effect on the number of votes Jenness would receive and it is not deemed advisable to interfere with the an election where the candidate is 'legally' on the ballot and there is no way that this proposed action could cause disruption within the SWP.

Reurlet, 10/6/70, which enclosed a proposed anonymous letter to be sent to of the "Atlanta Constitution."

Your letter 8/31/70 indicated this action could cause considerable embarrassment to Linda Jenness and the Socialist Workers Party (SWP) since Jenness could not be a candidate for a political office in the State of Georgia if she were not a resident. Your proposed letter states she will remain in Georgia until after the election, thus much of the effect of this proposal is lost. In addition, no statement is made as to how widely the proposed transfer of Jenness and her husband to New York City has been discussed within the SWP in Atlanta, nor is there any indication as to how the publishing of this information will effect the security of your source.

It would appear that a proposed anonymous letter along these lines should hinge upon the fact that Jenness and her husband had been transferred to New York prior to the election, thus indicating that the SWP believes she has no chance of winning. Resubmit a new letter along these lines. In your cover communication answer the questions set forth above.

In this article, JENNESS admitted that she had been married but divorced and claims she is now married to DOUGLAS JENNESS, Chairman of Socialist Worker's Party in Georgia. She also stated that she doubts the necessity of legal weddings and that a legal marriage should be totally up to the individual and she said, "I don't think it is necessary."

In view of the admission by JENNESS as set forth above, it is not felt that the suggestion as set forth in Atlanta letter would be effective and therefore no further action is being taken in this matter.

As has been previously reported, EMALINDA JANE WETTER, aka Linda Jenness, who is on the Security Index list of the Atlanta Office, Priority III, recently became a candidate for the position of Governor of the State of Georgia running under the SWP.

The files of the Atlanta Office contain information that subject is also a Security Index subject of the Atlanta Ullice, Priority

J. B. STONER, National Secretary of the National States Rights Party, is also a candidate for the position of Governor of Georgia, running on the Democratic ticket.

On the evening of 6/15/70, STONER and JENNESS appeared on a local television show with other candidates for the Office of Governor of the State of Georgia. During this television show STONER and JENNESS showed animosity towards each other.

It is felt that if an anonymous letter is directed to STONER informing him of JENNESS' that he would exploit this publicly and thereby bring discredit to JENNESS and the SWP.

If the Bureau concurs with the above suggestion, a sample anonymous letter will be prepared as above and furnished the Bureau for approval.

The anonymous letter mentioned in referenced letter was mailed on 2/11/70; however, there has been no indication that receipt of same by addressee has resulted in any change of relationship or policy between Revolutionary Youth Movement and Socialist Workers Party-Young Socialist Alliance. Circumstances, however, indicate that RYM in Atlanta has so few active followers and such limited resources that they have no choice but to cooperate with the Atlanta coalition of anti-war anti-administrative groups (this cooperation effected through Atlanta Mobilization Committee to End the War in Viet Nam) to receive their share of any "credit" done for harassment of "the establishment" through demonstrations and other type activities which they could not promote on their own.

This matter will be closely followed and further recommendations will be made as circumstances warrant.

Atlanta has advised that in the past a SWP/YSA-SDS/RYM II coalition to carry on protest activities has resulted in bickering to the point that little has been done. During the past several months, Socialist Workers Party/Young Socialist Alliance and Atlanta Revolutionary Youth Movement/Students for a Democratic Society have been so uncooperative as the two largest factions in a "coalition" of Atlanta New Left and pacifist groups banded together to make a bigger and better local showing in anti-war demonstrations, that most of the demonstrations have been unsuccessful and disappointing to participants. Great Speckled Bird", Atlanta's New Left newspaper, has run several articles during the past six months which referred to "coalition" meetings as "pitiful meetings,"
pointing out that the "stupid bickering "between the two
factions made the group" a "paper coalition " of "extremely
limited usefulness" This situation was instrumental in keeping the morale in Atlanta's anti-war movement at a low ebb, as evidenced by the fact that an estimated 125 persons from the entire area participated in the anti-war demonstration in Washington, D. C., on 11/15/69, after much effort by the "coalition", which had originally chartered nine buses to carry participants and was talking about having as many as 1000 people in Washington.

However, since ARYM/SDS allegedly dropped their affiliation with SDS in late November, 1969, and became merely "RYM", they have allegedly apologized to the "coalition" for their uncooperative attitude in the past and have indicated a willingness to cooperate with the "coalition" in local anti-war activities. This was apparently evidenced in an Atlanta anti-war conference held on 1/17/70, at which RYM was well represented, and of the RYM leaders, was appointed as Co-coordinator of a forthcoming anti-war type demonstration to be held in Atlanta during

Since submission of re Atlanta letter, the qualifying fees for candiates in city elections at Atlanta, Georgia, have been subsequently lowered due to the efforts of LINDA JENNESS in her mayoralty campaign, and, in fact, any person can now qualify for city office in Atlanta without even paying the currently stipulated fee, by merely signing a poverty oath. JENNESS, who intended to use the poverty oath, was not allowed to file for the mayor's race on 9/16/69; however, she indicated she established residency in Atlanta on 9/11/68, which does not qualify her under city ordinance, although she would qualify under Georgia State law, according to "The Atlanta Constitution" newspaper, 9/17/69, issue. JENNESS told newsmen she would consult her lawyers as to further legal action, since she felt the contradiction (by the State law and city ordinance) was discriminatory because, as a qualified voter, she cannot vote for the person of her choice - herself.

Since JENNESS' political fight regrding candidates qualifying fees in Atlanta have held the political spotlight during the past several weeks, and she may now immediately begin another fight over the residency ordinance to obtain further publicity for herself and the SWP, it would appear that an effort to discredit her and the SWP would be worthy of consideration in connection with the Counterintelligence Program, therefore, it is recommended that an anonymous letter, text of which is set forth below, be directed to the "Atlanta Journal and Constitution", Atlanta, Georgia, newspaper.

"I have been following the current mayor's race in Atlanta with much interst. The squabble over qualifying fees has been especially interesting, since the question was raised and the issue fought by Linda Jenness, who does not even qualify for city office from the standpoint of residency, regardless of what the qualifying fees are. As a matter of fact, she was apparently ready to sign a poverty oath and get into the mayor's race by specifying that she has been a resident of the city since September 11, 1968, when, in fact, she actually did not come to Atlanta to live until December of 1968. It might be interesting to note that Jenness lived at 326 East 25th Street, New York City, and worked at Merit Publishers, 873 Broadway, until she was transferred to Atlanta in November of 1968, by the Socialist Workers Party.

The following information is being set forth for consideration for action in connection with this program:

LINDA JENNESS, SWP Candidate for Mayor of Atlanta in the November, 1969, election, has been enjoying much personal publicity and has obtained much publicity for the SWP in the Atlanta area through speeches and statements made to the news media, in which speeches and statements she has espoused the SWP-YSA lines as concerning poverty, the Vietnam War, the racial situation, and so forth. She has indicated at YSA meetings that she does not expect to be elected, but cannot pass up the opportunity to obtain the publicity for the SWP and the New Left Movement, according to a confidential source.

JENNESS was transferred from New York to Atlanta about December of 1968. Since candidates for the office of Mayor must have been residents of the City for at least two years, she does not qualify for a candidate in this respect, however, this is undoubtedly not known to outsiders or the press, and she has apparently indicated to the press that she is originally from Georgia, as some written accounts have so indicated (she was actually born in Oklahoma and is not known to have previously resided in Georgia).

All candidates for Mayor must pay a \$5,000 fee (to be paid during the last week of August, 1969) in order to officially qualify as a candidate and it is not expected that JENNESS or the SWP will pay this fee; however, this particular fee to qualify for office is one of the issues of JENNESS' "campaign" and she will probably continue to harvest publicity on this and other points.

By reairtel Atlanta advised that a SAC contact of the Atlanta Office who is considered to be a close friend of the Bureau, had contacted the office to advise that he is becoming increasingly concerned with the New Left as it constitutes an increasing danger to the security of the United States. He stated that a recent issue of the "Atlanta Magazine." a monthly publication of the Atlanta Chamber of Commerce. had set forth information indicating increased Trotskyite influence in the peace movement in Atlanta. Atlanta states that the Atlanta Alliance for Peace, a coalition of peace groups. is increasingly coming under the influence of the YSA and is planning a march and demonstration on 10-27-68. Atlanta recommended that be furnished, on a confidential basis, information to supplement that already known to him from public sources concerning subversive

The above authorizes Atlanta to furnish this information to consistent with the security of our investigation of these groups and our sources. addition, we are furnishing public documents that can also be furnished to him. For the information of the Bureau, investigation by the Atlanta Office has indicated that the Atlanta Alliance for Peace, which is a coalition of the Atlanta peace groups, is planning a march and demonstration in Atlanta, Georgia, on 10/27/68. Details of this are being furnished the Bureau in other communications appropriately captioned.

At a meeting of the Atlanta Alliance for Peace on the evening of 10/13/68, the plans for the demonstration and program on 10/27/68, were dictated to the group by a leader of the Young Socialist Alliance (YSA) in Atlanta, Georgia.

Informants in the Atlanta Office have indicated an increasing control of the Atlanta peace forces by the YSA. At a recent demonstration against former Vice President NIXON in Atlanta, Georgia, the YSA was in control.

Atlanta recommends that the Bureau grant authority for Atlanta to furnish on a confidential on a confidential basis information to supplement that already known to him from public sources of the influence of the YSA and other subversive groups, such as the SDS, in the tlanta peace movement. # Is It All One Way?

It will be interesting to see the New Left's reaction to Russia's crush-

ing of Czechoslovakia's infant democracy.

There are rational grounds to criticize America's conduct in Victuan. Certainly we have blundered. Certainly we have put toe much faith in the wrong people. Certainly we have relied too much on the just-around-the-corner predictions of the military.

There are even reasonable differences about the underlying question of whether America can play the role of policeman to the world.

But calm discussion is not the halimork of the New Left. Thetas is a shrill, near-pathological condemnation of their own government.

To them, our policy is not just wrong. It is evil. It is conceived in malice. It is designed to crush popular will.

There could be no more blatant outside interference with a nation's domestic affairs than the Russian bloc's invasion of Czechoslo-

Russia's reasons could not be more clearly satisfamocratic. Soviet leaders stated it bluntly: Criticism by a free press, tolerance of opposition parties, and the possibility that the ruling Communist party could be ousled by popular election were threats to all Communist nations. This liberalism had to be wiped out.

Will the partisans of the New Left now storm Russian embassies and consulates? Will they lie down in the streets to block the flow of Sovict war materiel? Will they send blood to the wounded Czecha? Will they send delegates to interview Czechoslovakia's liberal leaders and then report their findings in the capitals of the Soviet bloc nations?

Needless to say, there will be no criticis a of Communist policy within the Communist nations which executed it. It is only in democratic nations where the luxury of criticism is allowed—and frequently abused.

But what about right here?

Are the New Left idealists capable of directing their indignation against naked Communist destruction of liberty in Czechoslovakia? Or are their hatred and vehemence reserved only for American leaders?

Will they remove the blindfold of precenception enough to see that there might just be something to the proposition that communism will use any means withis its greep to enhance its power? Can they now admit there might be something to the proposition that Communist aggression is breatfable, and will not be stopped unless recisied?

Or in morality our way?

## Already Opposed

ATLANTA-In his editorial of Aug. 22 Bruce Galphin presented the question of whether the "New Left" will oppose Russian aggression in Czechoslovakia as vehemently as they have opposed U.S. aggression in Vietnam.

As far as opposition goes, the "New Left" has already soundly opposed the imperialistic and antihumanistic policies of Russia. Case in point: the Aug. 9 issue of Alloa, the weekly publication of the SDS chapter at Georgia State, which featured an editorial criticizing Russian intervention in Czechoslovakia.

It is neither startling nor unreasonable that those in the "New Left" are more enraged over America's crime against Vietnam that over Russia's crime against Czechoslovakia. Primarily, this is because these in the "New Left" are Americans and feel a direct responsibility for policies pursued by the American government. American policy has been responsible for the deaths of over a million Vietnamese and the near total destruction of that country.

Those in the "New Left," as Americans, feel a part of this crime and naturally direct their

energies lowards actions which will bring this catastrophe to an end.



Campus disruptive activities by SDS at the University of Georgia during the past year have included outdoor "scap." box" speeches on the campus attacking the administrative

policies of the University, such as labeling university regulations concerning conduct of students, on and off the campus, as an infringement of their Constitutional Rights.

SDS has also circulated a petition, claiming 1,500 student signess, calling for the University to abolish compulsory Reserve Officers' Training Corps (ROTC) training. They have stated in their outdoor speeches and in their "underground" and unauthorized SDS Newsletter that they desire to govern themselves, the ultimate objective being student power.

Commencing January 18, 1968, SDS members conducted a series of weekly "Peace Vigils" on the lawn in front of Memorial Hall, at the University. These weekly Thursday afternoon demonstrations, noon until 2:00 PM, consisted of SDS members standing on the lawn holding anti-Vietnam war signs so that they could be observed by other University students passing back and forth to classes.

From approximately 6:30 PM, April 10, 1968, until April 12, 1968, at which time a restraining order was obtained through the Clarke County Superior Court, Athens, Georgia, a group of male and female students, varying in number from 150 to 400, occupied the corridors of the Academic Building, on the campus protesting the more severe restrictions placed upon female students. Also, during the inauguration of University of Georgia President, Fred C. Davison, on May 11, 1968, there was another student demonstration at which

On May 30, 1968, shortly after was notified of his recommended suspension, approximately 40 students gathered at the office of the University President, Fred C. Davison, demanding that the decision be rescinded. students demonstrated in the building until campus police came to secure the building. Approximately eight of the demonstrators declined to leave the building and were locked in the building. The students who were locked in the building urged other students, estimated at about 60, who had gathered outside the building, to join in the protest. At 11:00 PM, when William Tate, Dean of Men, and Clarke County Sheriff, H. T. Huff, arrived to clear the building. it was found to be deserted. About ten students then began a sleep-in on the campus grounds, in front of the Academic Building, which lasted from May 30, 1968 until June 2, 1968.

The SDS Chapter meets at the Westminster House, a Presbyterian Institution operated for the benefit of University of Georgia students, at 1250 South Lumpkin Street, in Athens, Georgia. The Campus Pastor of Westminster House is the Reverend Milner S. Ball, who is also the president of the Athens Civil Liberties Union.

On May 3 - 5, 1968, the University of Georgia SDS Chapter hosted the Southern Student Organizing Committee (SSOC) Conference and Membership Convention, at the University of Georgia, Athens, Georgia. About sixty of the attendees, including SDS members, picketed in front of Fine Arts Auditorium, during the morning of May 4, 1968, while Secretary of State Dean Rusk spoke to an invited audience commemorating Law Day at the University of Georgia.

There is no SSOC Chapter at the University of Georgia, in Athens, Georgia. The only SSOC Chapter known to be in existence in Georgia, at present, is the Atlanta Chapter-at-Large which has no organization on any campus. It has no office and no officers; however, activities of the ten members from his residence at in

### STUDENTS FOR A DEMOCRATIC SOCIETY

The Students for a Democratic Society (SDS), as it is known today, came into being at a founding convention held at Port Huron, Michigan, in June, 1962. The SDS is an association of young people on the left and has a current program of protesting the draft, promoting a campaign for youth to develop a conscientious objector status, denouncing United States intervention in the war in Vietnam and to "radically transform" the university community, and provide for its complete control by students. Gus Hall, General Secretary, Communist Party, USA, when interviewed by a representative of United Press International in San Francisco, California, on May 14, 1965, described the SDS as a part of the "responsible left" which the Party has "going for us." At the June, 1965, SDS National Convention, an anti-communist provise was removed from the SDS constitution. In the October 7, 1266. Assue of "New Left Notes," the official publication of SDS, an SDS spokesman stated that there are some communists in SDS and they are welcome. The national headquarters of this erganization as of April 18, 1967, was located in Room 206, 1608 West Madison Street, Chicago, Illinois.

### SOUTHERN STUDENT ORGANIZING COMMITTEE (SSOC)

On November 1, 1966, a first source advised that the Southern Student Organizing Committee (SSOC) with head-quarters at 1703 Portland Avenue, Nashville, Tennessee, was formed on the weekend of April 3-5, 1964, to stimulate activity of Southern student groups in areas of civil rights, peace, academic freedom, civil liberties, capital punishment and unemployment. Originally, it was to be a white counterpart of the Student Nonviolent Coordinating Committee (SNCC). It has agreed to work with similar interested groups such as SNCC and Students for a Democratic Society (SDS) and Southern Conference Educational Fund, Inc. (SCEF). SSOC is a fraternal affiliate of SDS.

Beginning in the Fall of 1966, SSOC became a member-ship organization and embarked on a campaign to form local chapters on various college campuses throughout the South. SSOC publishes, October through May each year, a publication, "New South Student", which according to the above source has increasingly espoused and defended the pro-Communist and anti-United States position on domestic and foreign policy.

On September 27, 1966, a second source advised that of Nashville, Tennessee, while in attendance at a tommunist Party, USA (CPUSA) Youth Conference, Camp Webatuck, New York, September 12, 13 and 14, 1966, gave a report regarding Nashville, saying that CP personnel were concentrating on organizing rent strikes, working with SSOC and SCEF and establishing a Socialist Study Group for students. He predicted future rioting, which, he said, the CP must take advantage of. He emphasized that more CP youth must be sent South.

On August 12, 1966, a third source advised that white male, - of had been in the CP about four months.

## SOUTHERN STUDENT ORGANIZING COMMITTEE (SSOC)

On September 27, 1966, and again on June 2, 1967, the second source advised that during the Summer of 1966 the CPUSA concentrated its youth cadre in organizing projects in several cities in an effort to recruit for and strengthen local CP youth organizations. Nashville, Tennessee, was included in this project. The youth placed in charge of the Nashville project was with funds to be made available for three to five full-time organizers in Nashville. of the CP in New York, New York, a Queens College student, came to Nashville in the Summer of 1966 for this purpose. At the CPUSA Youth Conference held at Camp Webatuck, New York, September 12, 13 and 14, 1966, reported that effective liaison had been made with SSOC; that contact had also been made with black militants on Nashville Negro college campuses; and that a beginning had been made toward organizing in the Nashville Negro community. He said he thought a riot was possible in the near future in the Negro community and the CP must take advantage of same. He emphasized that some main efforts were to work with SSOC and SCEF. The masthead of the June, 1967, issue of "Southern Patriot", official publication of SCEF, lists Carol Stevens Boner and Anne Braden as Editors and lists Carl Braden as Executive Director.

The "Nashville Panner", Nashville, Tennessee, newspaper issue of May 5, 1967, reported that SSOC was preparing for the May 17, 1967, appearance of Mike Zagarell, National Youth Director, CPUSA, at Vanderbilt University; that Bill Doss, Press Agent for SSOC, on Nay 12, 1967, brought to the "Banner" office publicity material which the CP had sent to SSOC.

The April, 1967, issue, Volume IV, No. 4, of "New South Student", published each month, October through Nay, by SSOC, carried an article on page 22 entitled "CIA American Labor," by Docald Boner, a review of a book entitled, "The CIA and American Labor," authored by George Morris, Labor Editor of "The Worker," east coast Communist newspaper. Boner is described therein as an active member of the Nashville SSOC chapter.

The following is an analysis of the potential counterintelligence action against the New Left within the Atlanta Division.

The New Left movement has, in order to produce sizeable numbers of individuals for anti-Vietnam and anti-Draft demonstrations, formed an alliance with individuals generally regarded as "hippies" in Atlanta. In an effort to discourage an increase in hippies settling in Atlanta, the Atlanta Police Department has conducted a number of raids on "crash houses" where hippies have been residing, for the purpose of finding narcotics. Unfavorable publicity given to these raids has resulted in corresponding difficulties encountered by hippies to continue their existence as such. It is proposed that friendly members of the news media could be used to expose the use of narcotics and immorality by some hippies, at the same time linking them with some of the organizations receiving publicity in connection with their demonstrations. It is likely that literature of organiza-tions identified with the New Left would be found on the premises of these individuals in many cases. These individuals are in many instances photographed and interviewed by the press while they are participating in demonstrations or acts of civil disobedience. 100-449668-2

In many instances, students attempting to disrupt or take over college facilities are assumed to be, or known to be, connected with the New Left organizations by school officials. These students have, in many instances, been called before college administrative boards to determine the extent of their participation in acts disrupting operation of the college. insure the college had reliable public source material connecting these individuals with New Left organizations, and at the same time friendly news media could be used to publicize this information, which in some instances is brought out in continuing litigation attacking the authority of the college to regulate student activities.

Specific recommendations in connection with the above will be submitted when feasible.
