ReBulets dated 5/10/68 and 5/29/68.

It is to be noted that the Indianapolis Office has opened an active control file captioned as above and has exhausted every avenue that could effectively expose, disrupt and neutralize the activists of the various new left movement organizations, their leadership and adherents.

The Indianapolis Office is well aware that it is imperative that the activities of these groups be followed on a continuous basis so the Bureau can take advantage of all opportunities for counterintelligence and also inspire action in instances where circumstances warrant. In all events where informants' identity could be well protected efforts will be made to divert reliable and cooperative news media sources to activities not open to the public, such as closed executive meetings of the Students for a Democratic Society (SDS), Communist Party, etc. At the same time publicity covering their open meetings, demonstrations, etc. will remain minimal to deny the publicity they desire. For instance, [redacted] Indiana, the news media, composed of two daily newspapers and one radio station, all competent and reliable, have advised confidentially that they feel that the media is being used by the new left movement to get all the publicity they can. Therefore, the news media locally will give no or minimal coverage to routine new left activities such as speeches and peaceful demonstrations.

It is further felt that the most effective potential counterintelligence action would involve repeated interviews with new left leaders and activists and that these interviews should be open and aggressive, constantly reminding them that they are of security interest to the United States Federal Government. It is to be noted that these tactics have been successful in racial matters within the field.

It is recommended that the frequency and advisability of interviews with student leaders of the new left movement at universities be left up to the discretion of SAC authority.

It is felt that such open activities of covering obvious Bureau responsibilities of matters of internal security, regardless of the proximity of the institution of higher learning, will be a less potential of embarrassment to the Bureau than the surreptitious methods that could be used.

It is to be noted that the majority of the new left movement activities are greatly concentrated in the Indianapolis Division at Indiana University, Bloomington, Indiana, and the University of Notre Dame at South Bend, Indiana.

In view of the counterintelligence program set forth above, the Indianapolis Office feels that this could be the most direct and effective program that could be directed against the new left movement and its key activists. It is felt that having the news media interrupt the closed sessions of the new left movements and repeated interviews with the leaders and activists in the new left movement organizations would neutralize the activities of the various new left organizations, their leadership and adherents.

Indianapolis is recommending that this program be taken under consideration and will await Bureau approval.

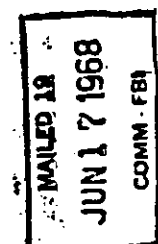
Your suggestion that efforts be made to get cooperative news media to cover closed meetings of Students for a Democratic Society (SDS) and other New Left groups could result in some disruption to the New Left movement. You should be alert for instances where this can be done. However, no counterintelligence action is to be taken without Bureau approval.

Your letter referenced Bulet 5/29/68 and listed New Left organizations and some individuals presently in the area covered by your office. A review of Bufiles fails to show a letter dated 5/29/68 concerning the Counterintelligence Program. Bulet 5/28/68 requested information concerning New Left organizations, individuals, and activities for each college in your area. If relet was intended as an answer to Bulet 5/28/68, it was not responsive to the Bureau's request and you should submit the desired information to the Bureau.

NOTE:

Bulet 5/10/68 to all offices requested that all offices make suggestions for counterintelligence action against the New Left. IP has pointed out that in some instances New Left groups hold closed meetings and that it might be possible to have friendly news media attempt to cover the meetings thereby disrupting them. In some instances this could have a disruptive effect. IP is so advised and instructed to obtain Bureau permission prior to instituting any action.

Enclosed herewith for the Bureau are the original and  
fourteen copies of an LHM dated and captioned as above.

Enclosed Letterhead Memorandum is being classified  
"confidential" since unauthorized disclosure of information,  
even in summary form, of information furnished by the two security  
informants identified below, could reasonably result in identification  
of informants of continuing value and jeopardize future effectiveness  
thereof.

Information contained in this Letterhead Memorandum was  
primarily obtained through [redacted] and [redacted]. Some of the  
information concerning IU participation in the March on Washington,  
D.C., 10/21/67, and the arrest of 35 students during the Dow incident  
10/30/67, was obtained from [redacted] who was under  
consideration for development as a [redacted] but was discontinued by the  
Bureau. He is currently in Berkeley, California, and is again  
being considered for development as a [redacted] by the San Francisco  
Division. All of the information furnished by this source concerning  
the activity at IU has been verified through other sources, so he is  
being considered as a source who has furnished reliable information in  
the past. In addition to these sources, some information was obtained

and some information verified through numerous cooperative, reliable and established sources of the Indianapolis Division at IU. All contacts at IU have been made in these matters through established sources only.

The present coverage of the New Left activities at IU primarily consist of [redacted] and [redacted]. Both of these informants are considered excellent and their coverage detail. [redacted] is able to contact most of the leaders of the New Left movement at IU at any time and is privy to much of their advanced information.

[redacted] has been developed during the past semester at IU. During this development at IU, he was elected [redacted]

[redacted] through this connection he is able to attend all of the open meetings and many of the closed meetings of the various New Left organizations at IU. He is also able to obtain information concerning their plans at IU.


This coverage has been adequate during the past year, at IU, as has been proven by the fact that the Indianapolis Division was able to furnish advanced information concerning all of the New Left activity at IU during the past year. For instance, when JAMES WEST and TED PEARSON, two members of the National Committee of the CP, came to IU to lecture at two open sessions and two closed sessions, [redacted] and [redacted], the coverage was considered quite complete. Photographs were taken, both open meetings [redacted] and symbol informants attended both open meetings. In addition to this, these CP leaders held [redacted] consultations and meetings with leaders of the New Left at IU in [redacted] meetings. [redacted] these

meetings were [REDACTED] fully reported.

A new program began at IU in March, 1968, with the organization of the AAASA, which brought forth the additional problems of racial matters on the IU Campus. This type of activity had not been prevalent before since racial problems in this community are minimal. The demands of this organization have been quite general, but since all of their demands have been granted approval by the university officials, it is believed that this activity will enlarge during the next academic year. Since this racial activity is closely aligned and coordinated with the activities of the New Left at IU, it would not be realistic to separate the two programs. Some coverage can be made by [REDACTED] sources [REDACTED], but it will be necessary to develop a Negro source in order to penetrate this organization and obtain advanced information of their activities. The development of such a source at an institute of higher learning under existing regulations is a lengthy process. In view of this, and the fact that limited manpower is available for assignments to these programs, major emphasis is being placed at the present time on development of the new Negro source necessary to the coverage of this organization. At the same time, every effort will be expended to maintain the adequate coverage existing in the New Left activities at IU during the past year.

An evaluation of potential violence on the IU Campus during the forthcoming school year could only be an estimate since it is mainly dependent upon the type of leaders who return to the IU Campus in September, 1968. From all information available, it appears that the main ringleaders of these organizations will return to IU in September, 1968. It also appears that the policies of the administrators of IU will not change and will remain permissive. In view of the probable return of leaders, the continued permissive policies of the university, and the potential addition of new leaders, the only reasonable evaluation would be that the situation at IU should enlarge in scope and violence during the forthcoming school year. Historically, since 1962, the activities of the various New Left groups at IU have grown from one small student group of approximately 15 members to the scope of the activities summarized in the enclosed Letterhead Memorandum.

The following is a summary of New Left activities at Indiana University (IU), Bloomington, Indiana, as obtained from confidential sources, who have all furnished reliable information in the past, for the period of the past year, June 1, 1967 through June 1, 1968:

I. Identity of New Left  
Organizations at IU  
-----

Indiana Central Office  
for Peace Action (ICOPA)  
-----

The ICOPA was formed at IU on June 29, 1967, by Stephen Michael Cagan, a graduate student at IU, who had formerly organized the IU Chapter of the W. E. B. DuBois Clubs of America and the IU Committee to End the War in Vietnam in 1966. The ICOPA was formed by Cagan for the purpose of acting as a central coordinating committee through which he could coordinate the activities of all the antiwar and antidraft organizations in the State of Indiana. Cagan published several issues of a newsletter for this organization during the summer of 1967, but very little was accomplished by the organization. The ICOPA became defunct when Cagan left IU in August of 1967. During the time it was organized there were approximately 12 members.

Indiana University Chapter of  
the W. E. B. DuBois Clubs of  
America (IU - DCA)  
-----

The IU - DCA was organized and registered at IU February 7, 1966, by [REDACTED] In June, 1966, this chapter was de-registered by the IU Board of Trustees since the United States Department of Justice had petitioned the Subversive Activities Control Board to declare the national W. E. B. DuBois Club as a subversive organization. The IU - DCA continued activity [REDACTED]

on a limited scale using front organizations until July 4, 1967, at which time the IU Board of Trustees approved a policy of non-registration for student groups at IU. This change in policy meant that any group of students could form any type of organization at IU without regulation or sanction by IU officials. During the summer of 1967, the IU - DCA held one meeting but became inactive since [redacted] spent most of his time with the ICOPA and there left New York City in August, 1967, to become a national officer of the W. E. B. DuBois Clubs of America in New York City. During the summer of 1967, [redacted] then secretary-treasurer of the IU - DCA, published three issues of [redacted] a newsletter for the IU - DCA. The IU - DCA was reorganized on September 20, 1967, but remained inactive as an organization for the balance of the school year, since its officers and members operated within the framework of the IU Committee to End the War in Vietnam. The IU - DCA was not reorganized and became defunct as of February 11, 1968. On April 23, 1968, the leaders of the IU - DCA joined the Ben Davis Club of the Communist Party. While the IU - DCA was actually defunct, Robert Grove, Chairman of the IU - DCA and the Ben Davis Club, used the name of the IU - DCA for the rest of the academic year, since the name of the Ben Davis Club had not been made public during this year at IU. During the summer of 1967, the IU - DCA had approximately 24 members and during the 1967-1968 academic year, the IU - DCA had approximately 16 members.

Students for a Democratic Society  
(SDS) at Indiana University

-----

The SDS at IU was inactive during the summer of 1967. This organization was reorganized and officers elected at a meeting at IU on September 22, 1967. Since membership in the SDS at IU is more of a "state of mind" membership rather than a registered card carrying membership, only a rough estimate, based on participation in activities, can be made. An estimate of students and faculty of IU participating in the SDS at IU could be made at approximately 50%. After the arrest of 35 students

during the Dow incident at IU, on October 30, 1967, the leadership of this organization became insufficient for organized activity. During the second semester of the current academic year, the SDS was run by an Executive Committee, which set the policy for the SDS at IU for all of the SDS members to join the activities and follow the programs of the IU Committee to End the War in Vietnam. Since these organizations had the same general program at IU, the students and faculty involved in the New Left movement at IU allowed the IU Committee to End the War in Vietnam, which was the strongest organization and leadership during the 1967-1968 academic year. A number of local SDS members joined in the activity of the national council meeting of the SDS held at IU December 27-31, 1967, even though this was held during a vacation period.

in Vietnam (IU - CEWV)

The IU - CEWV was inactive during the summer of 1967, since [redacted] spent most of his time with the ICOPA. The IU - CEWV was originally organized by [redacted] at IU on March 17, 1966, as a front organization for the IU - DCA, for the purpose of holding demonstrations without organizational involvement of the IU - DCA. The IU - CEWV was reorganized on September 19, 1967, and the leadership was taken over [redacted] and [redacted]. Both [redacted] and [redacted] were both characterized as having Trotskyite sympathies of the Young Socialist Alliance (YSA) and neither was connected with the IU - DCA. With this change of leadership, the orientation of the IU - CEWV shifted from the influence of the IU - DCA to the influence of the YSA. Because of its strong leadership and active organization, the IU - CEWV was able to absorb the leadership and membership of the IU - DCA and the SDS at IU into its programs of antidraft and activist activities. The IU - CEWV

stated that it had a membership of 255 members, including 154 paid members and 101 additional members on its mailing list.

Young Socialist Alliance  
(YSA) and  
Young Socialists for  
Halstead and Boutelle  
(YSHB)

-----

The YSA and YSHB have no membership nor organization such at IU, but their activities in connection with the YSHB were sponsored by the leaders of the IU - CEWV at IU during the second semester of the 1967-1968 academic year. [REDACTED] and [REDACTED] of the IU - CEWV leadership, both supported the YSHB by organizing the distribution of literature of the YSHB and the YSA on the IU Campus. They also helped organize weekly lectures on socialism, the Communist Manifesto, etc., by members of the YSA in support of the YSHB. The YSHB supports [REDACTED] for the nominee for president of the United States and [REDACTED] as a nominee for the vice president of the United States on the Socialist Workers Party (SWP) ticket during the 1968 election year.

Robert Franklin Grove, a Communist Party (CP) member, former chairman of the IU - DCA and organizer for the Ben Davis Club at IU, made a public statement in the news media on March 12, 1968, that he was organizing a para-military force akin to the Negro Deacons for Defense. He stated that this group would be called the IU Citizens Armed Militia and would bear arms publicly. The formation of this committee was based upon the ruling by IU President [REDACTED] to disarm the [REDACTED]

campus police at IU. When this decision by President Stahr was challenged publicly by the Fraternal Order of Police in Bloomington, Grove announced the formation of the IU - CAM. Grove advised the U. S. Secret Service, Indianapolis, Indiana, on March 14, 1968, that he had been misquoted by the news media and that he would not form such an organization. Sources stated that this organization had no membership and had never been completely organized by Grove.

Radical Press Club  
(RPC)

The RPC is a name of an organization used by Robert Grove and Lawrence Waxberg to register with the IU dormitories, Memorial Union, etc., to sell New Left newspapers and literature at IU. This organization has no membership nor officers and is only used by Grove and Waxberg for this purpose.

Afro, Afro-American  
Student Association  
(AAASA)

[REDACTED] a Negro militant student at IU, attempted to organize the AAASA at IU during the first semester of the 1967-1968 academic year, but was unsuccessful due to lack of interest by the approximate 500 Negro students attending IU during this year. During March, 1968, the United Klans of America (UKA) publicly announced that they would have members of the Ku Klux Klan (KKK) appear on the square in Bloomington, Indiana, to distribute literature and attempt to recruit members on March 30, 1968. This announcement caused a great deal of dissension among the Negro population of Bloomington, Indiana, which is only one per cent of the general population of this community. This also caused dissension among the approximately 500 Negro students at IU, which comprises less than two per cent of the student population

at IU. After a number of meetings, the Negro community in Bloomington, Indiana, decided that the student community was much too militant and withdrew their support. The city officials of Bloomington, Indiana, obtained a court order preventing the UKA from appearing in Bloomington on March 30, 1968. During this dissension, [REDACTED] was able to organize and gain support among the Negro students at IU for the AAASA. Even though the UKA did not appear in Bloomington on March 30, 1968, the AAASA was able to form a demonstration of about 150 Negroes to march on the home of President Stahr at IU, with general demands to hire more Negro faculty members, make efforts to obtain more Negro students, change the curricular of IU to include more courses in Negro history, etc. President Stahr met all of these general demands. The AAASA later was able to gather together about 50 Negro militants to stage a sit-in in the old stadium on the IU Campus to block the running of the "Little 500" bicycle race, May 10-12, 1968, which is publicized as the nation's greatest college weekend and is used for the purpose of obtaining money for scholarships for needy students. During this sit-in the Negroes made a militant demand to the IU officials that all of the fraternities participating in the bicycle race, which had discriminatory clauses in their constitutions, be barred from participating in the race. When they were unable to get an immediate response to their demands, the Negro militants started to cause damage to the stadium by throwing metal chairs from the stadium onto the track, driving steel stakes into the cinder track, etc. President Stahr and officials of IU immediately granted approval for the Negro demands and barred one fraternity from participating in the race.

United Anti-Racist Movement

The UARM was organized on April 19, 1968, by [REDACTED]  
[REDACTED] The purpose of UARM was to organize white students and faculty members at IU to aid the AAASA in their racial activity

When it was organized, UARM was to be run by ten member Steering Committee. After the first meeting, however, the Steering Committee was dropped and the organization was run solely by [REDACTED]. As a leader of the IU - CEWV [REDACTED] was able to use UARM as an organization for the IU - CEWV to be used in racial activities. Membership in this organization was estimated at about 50 persons.

Ben Davis Club  
(BDC)

The BDC of the CP was organized at IU on April 23, 1968, by [REDACTED] and [REDACTED] both members of the CP. The BDC was organized to replace the IU - DCA for the purpose of bringing more CP influence to the IU Campus to combat the Trotskyite influence of the new leaders of the IU - CEWV in the New Left movement at IU. The only activity of this group so late in the year was to sponsor two open meetings by [REDACTED] and [REDACTED] members of the national committee of the CP on May 21, 1968 and June 1, 1968. Since the name of the BDC had not been made public at IU during this academic year, Grove used the name of the IU - DCA publicly as the organization which sponsored West and Pearson at IU during these two meetings. The membership of this organization during its first month was estimated at five members.

Sources have advised that the above list ringleaders are not conclusive, but represent the main activists leaders on the IU campus during the past year.

III. Summary of Campus Disruptive  
Activities During the Past  
Year

June 22, 1967

After an open meeting of the SDS at IU on June 22, 1967, attended by members of the IU - DCA, a number of persons attending this meeting went to the vicinity of Kirkwood and Indiana Avenues in Bloomington, Indiana. This district is known as a "hippie hangout." The merchants in this district have complained to the police department on a number of occasions that the long-haired beatnik hippies are ruining their business. About 100 students and hippies gathered in this area and were agitated by the persons who had left the SDS meeting. The police subsequently asked these persons to move on and in the ensuing altercation, seven persons were arrested. Three of these persons were leaders and members of the IU - DCA and four of those arrested were leaders and members of the SDS at IU. All charges against these arrested persons were subsequently dropped by authorities.

October 21, 1967

On October 21, 1967, a March on Washington, D.C. was held, sponsored by the Student Mobilization Committee. The Indiana contingent to this March on Washington, D.C. was organized and coordinated by the IU - CEWV. Approximately 225 persons from IU attended this March on Washington, D.C., on October 21, 1967.

At 1:00 PM on October 30, 1967, leaders of the SDS at IU and the IU - CEWV, called an emergency meeting of their members on the campus of IU. They told the assembled members that they had discovered that the Dow Chemical Company was conducting employment interviews in the School of Business that day on the IU Campus. These leaders harangued the crowd and then led a march to the Business Building. They were advised by authorities at the building that they could not enter the interview rooms and that they had to keep the hallways clear. They were repeatedly advised by Safety Division authorities and an official of the Office of the Dean of Students that if they entered the interview room they would be arrested. About 100 demonstrators filled the hallway and at a given signal, they made a concerted rush for the door forcing their way over the police guard and entered the room. Thirty-five of these demonstrators were arrested and charged with disorderly conduct, with several of them being charged with additional charges of assault and battery and resisting arrest. As a result of these arrests, all 35 were found guilty in separate trials with several of them receiving jail sentences up to 30 days. Many of these sentences have been appealed and are still in litigation.

October 31, 1967  
-----

On October 31, 1967, Secretary of State Dean Rusk was scheduled to speak as a convocation speaker at the IU auditorium. Leaders of the IU - CEWV and the SDS at IU demanded that IU officials invite more antiwar speakers to IU convocations or they would not allow Secretary Rusk to speak. IU officials hurriedly complied with the demands of these students and stated that they had been able to book [REDACTED] an antiwar speaker for a future convocation. Since [REDACTED] name was on the list of eight approved speakers, which the students submitted to the IU officials, IU was advised that Secretary Rusk could speak. When [REDACTED]

the secretary was introduced at the convocation on October 31, 1967, he was unable to complete his talk. He was greeted with loud cries of "murderer", "liar," "killer of babies", etc. Secretary Rusk had a most difficult time finishing any one statement and at the end of one-half hour, he curtailed his speech and entered a question-and-answer session. During his speech, two attempts were made to force entry into the back stage area of the auditorium but these attempts were immediately blocked by the police. At the end of this speech, Secretary Rusk's car was brought to the side entrance of the auditorium and surrounded by a platoon of riot control state police. Behind this cordon was a very sizeable crowd carrying signs, both for and against U. S. Policy in Vietnam. The necessity of the use of this squad as a restraint to the crowd so that Secretary Rusk could depart in a normal manner was quite obvious. As his car was pulling away, one woman broke through the cordon and threw herself in front of the car. She was immediately and forcibly removed from the area by the state police. No arrests were made during this incident and neither IU officials nor participating law enforcement agencies obtained any identifying information concerning the persons involved.

He had been ordered to the center on a number of occasions in the past but each time he refused to answer questions or sign the oath. Several members of the IU - CEWV, the SDS at IU and the IU - DCA were to picket the induction center on December 7, 1967, in his support. On December 7, 1967, 26 demonstrators appeared at the armed forces induction center at Indianapolis, passed out literature

and talked to inductees, but did not block traffic or cause incidents. [REDACTED] did not show up at the center for his physical and was later arrested after his indictment by a Federal Grand Jury on charges of draft evasion. [REDACTED] has since been convicted on two charges of draft evasion in the U. S. District Court at Indianapolis, and is currently awaiting sentences on these charges. He has stated that these sentences will be appealed.

December 27-31, 1967

During the period of December 27-31, 1967, the national council meeting of the SDS was held on the IU campus.

February 19-23, 1968

During the period of February 19-23, 1968, the Central Intelligence Agency was to conduct employment interviews on the IU campus. The IU - CEWV published threats of demonstrations and stated that a number of IU - CEWV members were being asked to sign up for interviews so that they could question the CIA about their activities. In the face of this publicity and opposition, the CIA canceled its interviews at IU.

Beginning February 24, 1968, the YSHB, sponsored by the IU - CEWV, held weekly lectures at IU, each Saturday, on topics of "socialism," "communist manifesto", etc. These lectures were given by leading organizers and members of the YSA and the SDS at IU.

On March 1, 1968, a peaceful demonstration, sponsored by the IU - CEWV was held at IU protesting the Dow Chemical Company employment interviews on the IU campus that date.

On March 12, 1968, Robert Grove, supra, announced plans for the formation of a paramilitary force akin to the Negro Deacons for Defense. Grove stated that this group would be called the IU Citizens Armed Militia and would bear arms publicly.

On March 14, 1968, Grove advised a representative of the U. S. Secret Service, Indianapolis, Indiana, that he had been misquoted in the news media and was not going to form such an organization. Sources advised that Grove never succeeded in organizing this group.

March 30, 1968

On March 22, 1968, it was announced that the United Klans of America (UKA) had announced a visit of the Ku Klux Klan (KKK) at Bloomington, Indiana, on March 30, 1968, and this announcement had precipitated a great deal of activity among the local Negro community, as well as the Negro students on the campus of IU.

Robert Johnson, supra, had attempted to organize the AAASA at IU during the first semester of the 1967-1968 academic year, but was unsuccessful due to lack of interest on the part of the IU Negro students. During the ensuing meetings and discussions, the AAASA was organized and the talk became more militant. Most of the Negroes in the Bloomington community withdrew their support of the IU Negro students because they became too militant. On March 26, 1968, a court order restraining the KKK from visiting from Bloomington, Indiana, on March 30, 1968, was obtained by city officials. The AAASA had announced that they would have a counter-demonstration if the KKK appeared on March 30, 1968. Since the KKK did not come to Bloomington on March 30, 1968, the AAASA held their demonstration anyhow. About 150 Negro students gathered and held a peaceful march on the IU campus to the home of IU President Elvis J. Stahr, Jr. They presented Dr. Stahr with a list of demands, most general in nature, concerning the hiring of more faculty and staff Negro employees, efforts to obtain more Negro students at IU, change of curriculum to include more courses on Negro history, etc. The university officials quickly acceded to the Negro demands and there was no further incidents in this connection.

April 26, 1968

As part of the International Ten Days of Protest, a student strike and peace fair was held on the IU campus on April 26, 1968. This effort was coordinated by the IU - CEWV and backed by members of the IU - CEWV, the SDS at IU and the IU - DCA. Peaceful pickets appeared before the buildings containing class rooms with signs urging the students not to attend classes that day and the peace fair was held on the IU campus featuring speakers who spoke against U. S. Policy in Vietnam and the Selective Service System.

May 10-12, 1968  
-----

About 50 members of the AAASA, some dressed in motorcycle helmets and carrying garbage can lids and baseball bats began a sit-in at the Old Stadium on the IU campus on May 10, 1968. They were protesting the entry of any fraternity or sorority in the Little 500 bicycle race to be held at IU on May 11, 1968. They claimed that some of the fraternities entered in this race had discriminatory clauses in their constitutions and they demanded that these fraternities submit to them for approval in writing amendments to their constitution removing these discriminatory clauses. Officials at IU called an emergency meeting of the IU Faculty Committee in an attempt to get the representatives of all of the fraternities to comply with the Negro demands. All fraternities but one were able to comply quickly but one fraternity was unable to complete the necessary paper work. The delay of the race due to rain on May 11, 1968, allowed the university more time but there was not enough time for one fraternity to complete the required paper work to comply with the Negro demands. The Negroes, angered by the delay, started throwing metal chairs from the stadium onto the track and driving steel stakes into the cinder track, etc., on the morning of May 12, 1968. At that point, IU President Elvis Stahr demanded

that the one fraternity withdraw its entry from the race to comply with the Negro wishes. The fraternity withdrew its entry and the Negroes left the stadium. The race was held without further incident.

May 31, 1968 and  
June 1, 1968

The BDC of the CP at IU sponsored two open meetings at IU, featuring talks by James West and Ted Pearson from Chicago. They were to speak on the topic of the "roll of the CP in the 1968 elections." West was publicly billed as the labor secretary of the CP from Chicago and Ted Pearson was billed as a member of the CP and a reporter for "The Worker," an East Coast daily newspaper of the CP.

Both West and Pearson are members of the national committee of the CP. Robert Grove, supra, who arranged these talks, used the name of the IU - DCA as the sponsoring club, since the name of the BDC had not been made public at IU during the current academic year. On May 31, 1968, about 30 people attended the talks by West and Pearson. On June 1, 1968, about 25 persons attended the talks by West and Pearson. Between these two talks on the evening of May 31, 1968 and on the morning of June 1, 1968, private meetings were held by West, Pearson and members and prospective members of the BDC at IU. During the first meeting, West handed out about four applications for membership to the CP. West approved of the activities of the BDC and stated that these CP members should form a peace council at IU during the next academic year to coordinate the activities of the groups involved in antidraft and antiwar activities.

## A P P E N D I X

### W. E. B. DU BOIS CLUBS OF AMERICA (DCA)

A source advised that on October 26-27, 1963, a conference of members of the Communist Party, USA (CPUSA), including national functionaries, met in Chicago, Illinois, for the purpose of setting in motion forces for the establishment of a new national Marxist-oriented youth organization which would hunt for the most peaceful transition to socialism. The delegates were told that it would be reasonable to assume that the young socialists attracted into this new organization would eventually pass into the CP itself.

A second source has advised that the founding convention for the new youth organization was held from June 19-21, 1964, at 150 Golden Gate Avenue, San Francisco, California, at which time the name W.E.B. DuBois Clubs of America (DCA) was adopted. Approximately 500 delegates from throughout the United States attended this convention.

The second source advised in September, 1966 that Mike Zagarell, CPUSA Youth Director, stated that in Negro communities the Party still supported the plan to build "left" socialist centers and to solidify the Party base through the DCA. This source also advised in September, 1966, that Daniel Rubin, CPUSA National Organizational Secretary, stated the Party believes the DCA should have a working-class outlook and be a mass organization favorable to socialism, socialist countries and Marxism, and in April, 1967, advised that Gus Hall, CPUSA General Secretary, indicated the DCA primary emphasis should be on developing mass resistance to the draft.

A third source advised in September, 1967 that Jarvis Tyner was elected chairman of the DCA on September 10, 1967, at the Third National Convention of the DCA held in New York, New York, from September 8-10, 1967.

A fourth source advised during August, 1967 that Jarvis Tyner is a member of the National Committee of the CPUSA.

A fifth source advised on September 21, 1967, that the headquarters of the DCA is located at 34 West 17th Street, New York, New York.

INDIANA UNIVERSITY CHAPTER  
W. E. B. DU BOIS CLUBS OF AMERICA (IU-DCA)

A source advised on April 11, 1966 that the Indiana University Chapter, W. E. B. DuBois Clubs of America (IU-DCA), was officially registered at Indiana University on February 7, 1966, with 15 members.

Source advised that Gaylord King, Chairman on February 1, 1966, made application for registration, at which time he made available an official written statement to the Director of Student Activities, Indiana University, as follows: "The Indiana University Chapter is a full chapter affiliate of the national organization -- the W. E. B. DuBois Clubs of America. We can initiate our own action or decide not to carry out a particular action project of the national, but are bound by national policy. Statements of the National Executive Committee are also statements of policy for us."

The above source further advised that although Gaylord King, Chairman, applied for University recognition of the IU - DCA, Stephen Cagan was actually the organizer and secretary of this group. Cagan subsequently resigned this position from the IU - DCA in order to organize the Indiana University Committee to End the War in Vietnam.

A second source advised on May 3, 1966 that the IU - DCA sponsored the appearance at Indiana University on March 10, 1966, of Hugo Sterling Fowler, National Chairman of the W. E. B. DuBois Clubs of America. In addition, this group sponsored the appearance of Herbert Aptheker, leading CP functionary and CP theoretician, at Indiana University on May 3, 1966.



## APPENDIX

### STUDENTS FOR A DEMOCRATIC SOCIETY

The Students for a Democratic Society (SDS), as it is known today, came into being at a founding convention held at Port Huron, Michigan, in June, 1962. The SDS is an association of young people on the left and has a current program of protesting the draft, promoting a campaign for youth to develop a conscientious objector status, denouncing United States intervention in the war in Vietnam and to "radically transform" the university campus, and provide for its complete control by students. Gus Hall, General Secretary, Communist Party, USA, when interviewed by a representative of United Press International in San Francisco, California, on May 14, 1965, described the SDS as a part of the "responsible left" which the Party has "going for us." At the June, 1965, SDS National Convention, an anticommunist proviso was removed from the SDS constitution. In the October 7, 1966, issue of "New Left Notes," the official publication of SDS, an SDS spokesman stated that there are some communists in SDS and they are welcome. The national headquarters of this organization as of April 18, 1967 was located in Room 206, 1608 West Madison Street, Chicago, Illinois.

## APPENDIX

### INDIANA UNIVERSITY COMMITTEE TO END THE WAR IN VIETNAM (IU - CEWV)

A source advised on June 9, 1967, that the Indiana University Committee to End the War in Vietnam (IU-CEWV), was officially registered as a campus organization at Indiana University with 15 members on March 17, 1966, by Stephen Michael Cagan, a graduate student of Indiana University. The source stated that the constitution of this Committee filed with the University stated, "We shall be represented on the National Coordinating Committee to End the War in Vietnam (NCCEWVN) and shall work with any organizations or individuals sharing our goals. Excepting the National Coordinating Committee to End the War in Vietnam, we have no connection with any previously constituted political, religious, educational, or social group."

A second source advised on July 10, 1967 that Stephen Michael Cagan was the organizer and secretary of the Indiana University Chapter of the W. E. B. DuBois Clubs of America (IU-DCA), when registered at Indiana University on February 7, 1966. Cagan subsequently left his position as secretary of the IU-DCA in order to organize the IU-CEWV. Cagan stated that IU-CEWV will be used as a "front organization" for the IU-DCA for the purpose of holding demonstrations without organizational involvement of this organization. Activity continues at the present time.

**YOUNG SOCIALIST ALLIANCE**

The May, 1960, issue of the "Young Socialist" (YS), page 1, column 3, disclosed that during April 15-17, 1960, a national organization entitled "The Young Socialist Alliance" (YSA) was established at Philadelphia, Pennsylvania. This issue stated that this organization was formed by the nationwide supporter clubs of the publication YS.

The above issue, page 6, set forth the Founding Declaration of the YSA. This declaration stated that the YSA recognizes the Socialist Workers Party (SWP) as the only existing political leadership on class struggle principles, and that the supporters of the YS have come into basic political solidarity with the SWP on the principles of revolutionary socialism.

On March 10, 1967, a source advised that the YSA was formed during 1957, by youth of various left socialist tendencies, particularly members and followers of the SWP. The source further advised that the YSA has recently become more open about admitting that it is the youth group of the SWP and that an SWP representative has publicly stated that the YSA is the SWP's youth group.

The headquarters of the YSA are located in Rooms 532-536, 41 Union Square West, New York City.

The SWP has been designated pursuant to Executive Order 10450.

## APPENDIX

### UNITED KLANS OF AMERICA, INC. (KNIGHTS OF THE KU KLUX KLAN (UNITED KLANS))

Records of Superior Court of Fulton County, Georgia, show that this Klan organization was granted a corporate charter on February 21, 1961, at Atlanta, Georgia, under the name United Klans, Knights of the Ku Klux Klan of America, Inc.

A source advised on February 27, 1961, that United Klans was formed as a result of a split in U. S. Klans, Knights of the Ku Klux Klan, Inc. According to the source, the split resulted from a leadership dispute and the United Klans has the same aims and objectives as the parent group. These are the promotion of Americanism, white supremacy, and segregation of the races.

The first source and a second source advised in July, 1961, that United Klans, Knights of the Ku Klux Klan of America, Inc., merged with Alabama Knights, Knights of the Ku Klux Klan. The merged organization established headquarters in Suite 401, the Alston Building, Tuscaloosa, Alabama. The organization is directed by Robert Shelton, Imperial Wizard, and is the dominant Klan group in the South with units in several southern States.

On August 14, 1963, the second source advised that the organization formerly known as United Klans, Knights of the Ku Klux Klan of America, Inc., would be known in the future as United Klans of America, Inc., Knights of the Ku Klux Klan. The second source said the name was changed by a resolution adopted at the National Klonvocation held July 8, 1961, at Indian Springs, Georgia.

Second source advised that at a meeting at Prattville, Alabama, on October 22, 1961, a majority of the Klaverns of the U. S. Klans, Knights of the Ku Klux Klan, merged with the United Klans of America, Inc., Knights of the Ku Klux Klan.

MICHIANA COMMITTEE TO END THE WAR IN VIETNAM

A source advised that in late March and early April, 1967, [redacted] Chairman of the Women's Club of the Communist Party (CP) at South Bend, Indiana, at the instruction of [redacted] Chairman of the CP of Indiana, organized the April 15th Mobilization Committee to End the War in Vietnam (AMCEWV), which, as its first major endeavor, held a Peace Parley at the South Bend Public Library. The AMCEWV on April 19, 1967, changed its name to the Mobilization Committee Against the War in Vietnam (MCAWV and sponsored a Peace March held in South Bend on April 29, 1967. On May 23, 1967, the MCAWV changed its name to the Michiana Committee to End the War in Vietnam (MCEWV) and thereafter held open meetings each two weeks at the First Unitarian Church, 101 East North Shore Drive, South Bend.

The source further advised that the MCEWV, through its literature and sponsorship of demonstrations, has consistently opposed the draft and U. S. war efforts in Vietnam. [redacted], an undergraduate student at the University of Notre Dame (UND), is Chairman of the MCEWV and in April, 1967, had described himself as being to the "left" of "The Worker", an East Coast communist newspaper. Those individuals who have participated in MCEWV activities have, for the most part, been students and faculty from UND and St. Mary's College (SMC) at South Bend.

The source advised on January 8, 1968, that the CP has retained its control of the MCEWV through [redacted] Recording Secretary, [redacted] Co-corresponding Secretary, and [redacted] who regularly

None of the above sources is actually [redacted] on the University of Notre Dame (UND) campus but all are in contact with UND students and faculty members in varying degrees. [redacted] is particularly close to UND students and has access to meetings of the Campus Coalition for Peace (CCP). [redacted]

Attempts are being made through [redacted] to develop the names of several students who [redacted] feels would be amenable to contact by the FBI. Background information will be obtained and the Bureau will be requested to grant authority to contact.

The potential for violence on the UND campus during the 1968-69 school year is difficult to assess. The chief campus radical, [redacted] is no longer in the area and in any event, since he has missed induction twice, will undoubtedly either be in custody or a fugitive by the fall of 1968. [redacted] to date, has not appeared to be as dedicated an activist as [redacted] although he may find it necessary to assume such a position in order to maintain his position of leadership in the CCP.

The UND administration has proved to be somewhat receptive to student demands and to date has avoided any direct confrontation with the New Left. The more "radical" members of the UND New Left movement still complain about the immovable administration but to date they have not enjoyed the support of the student papers nor of the vast majority of students. Shortly before the end of the 1967-68 school year, some 3000 students signed petitions affirming their belief in peaceful demonstrations but decrying the actions of the demonstrators at the ROTC review on 5/7/68, in attempting to prevent the review.

To summarize, unless some violence-prone agitator comes to the front on the UND campus, it would appear that 1968-69 would have the usual anti-war, anti-draft activities and demonstrations but that they would stay within the bounds of reason with no violent acts being performed.

A confidential source who has furnished reliable information in the past advised on May 22, 1968, that the Campus Coalition for Peace (CCP) was the vehicle on the University of Notre Dame (UND) campus through which members of the "New Left" expressed their opposition to the war in Vietnam, the draft, and their general intolerance of the "establishment", including the UND administration. This is a very loosely knit organization with [redacted] a UND graduate student, being the chairman. Source was unable to estimate the membership but stated that based on the turnout at demonstrations as noted below, he would state that there were perhaps 300 students who could be considered to be adherents to the New Left philosophies of the CCP.

Source stated that in addition, [redacted] who graduated from UND on February 1, 1968, had been active in New Left activities on the UND campus both before and after his graduation. [redacted] has also been chairman of the Michiana Committee To End the War in Vietnam (MCEWV), a characterization of which is attached hereto, which, although not a campus organization, nevertheless had the participation of a number of UND students and faculty.

Dr. [REDACTED] an Assistant Professor from IUSBC, attempted to organize a group to physically block the doorways to the offices where the [REDACTED]

recruiters were located but failed. Later, the demonstrators held a rally at the UND Library where anti-Vietnam speeches were given. There were no arrests and there was no violence. Source could not state the name of the campus organization, if any, staging the demonstration but pointed out that those UND students participating had been from the "New Left" at UND. [REDACTED] was active in SDS at IUSBC.

[REDACTED] that on this same date, about 60 - 70 students from UND staged a demonstration against Herbert D. Doan, President, Dow Chemical Company, who was speaking at a symposium "Cities in Context" being held in the Center for Continuing Education (CCE) on the UND campus. The students blocked the doors of the CCE building and as those attending the symposium sought to leave the CCE building, a pushing and shoving match ensued. There was no actual violence and there were no arrests. Among those taking an active part in the demonstration had been [REDACTED] a UND graduate student. This demonstration was sponsored by the CCP.

[REDACTED] Supra, on April 26, 1968, advised that on this same date, an anti-Vietnam teach-in was held near the Law Building on the UND campus. Those in attendance ranged from 35 to 100. Among the speakers was [REDACTED]

[REDACTED] who spoke on American imperialism, militarism, nationalism, and the class system. [REDACTED] from IUSBC spoke on his opposition to the war in Vietnam. There were no arrests and there was no violence. [REDACTED] did not know the identity of the sponsoring organization.

[REDACTED] supra, advised on May 7, 1968, that on this same date, about 300 UND students and faculty demonstrated against a review of ROTC units being held on the UND campus. Some 200 of the demonstrators marched onto the review field and staged a sitdown. The ROTC units avoided the demonstrators and no confrontation occurred. Among those active in the demonstration had been [REDACTED] who had urged the demonstrators on the field to go among the ranks of the ROTC units. None had responded. The AMCEWV on April 19, 1967, changed its name to the Mobilization Committee Against the War in Vietnam (MCAWV) and sponsored a Peace March held in South Bend on April 29, 1967. On May 23, 1967, the MCAWV changed its name to the Michiana Committee to End the War in Vietnam (MCEWV) and thereafter held open meetings each two weeks at the First Unitarian Church, 101 East North Shore Drive, South Bend.

The source further advised that the MCEWV, through its literature and sponsorship of demonstrations, has consistently opposed the draft and U. S. war efforts in Vietnam. [redacted] an undergraduate student at the University of Notre Dame (UND), [redacted] 1967, had described himself as being to the "left" of "The Worker", an East Coast communist newspaper. Those individuals who have participated in MCEWV activities have, for the most part, been students, and faculty from UND and St. Mary's College (SMC) at South Bend.

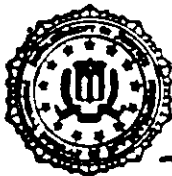

With the termination of the 1967-68 school year, the activity of the Students for a Democratic Society (SDS), at DePauw University is expected to be vastly lessened. During the school year, the primary efforts were directed toward anti-Vietnam war and school administration policies. With President Johnson's refusal to run for re-election, emphasis was increased on the draft evasion program. Basically, the SDS has greatly influenced student government to underwrite efforts to have school administration policy changed, to permit girls in men's living units and to extend curfew hours. SDS has done this with a minimal amount of out-spoken effort.

There were several sit-in type demonstrations held at the Student Union Building through the year with 20 to 25 students participating. The general consensus indicated the demonstrations were ineffectual. None of the sit-ins were disruptive or volatile.

The so-called ringleaders of the SDS' effort, which is loosely organized and quite factionless, would be identified as [REDACTED]

Approximately forty demonstrators gathered at the Memorial Center at 9:30 AM, November 14, 1967. Approximately thirty remained outside the building and approximately ten were inside. They handed out leaflets and displayed two basic photographs, 16" x 20", depicting children with burn scars. On the placard with the photographs were "Napalm Does The Job," "Napalm Kills" and etc. The leaflets in substance pointed out the fiery deaths and agonizing suffering caused by napalm and asked that interviewees examine their conscience as to whether they wanted to work for Dow.

There were two or three professors observed in the group [REDACTED] These leaflets were along the same line as the others except he did not mention the Dow Chemical Company. He requested that they examine their conscience before working for any concern engaged in the war effort.

The demonstration was quiet, peaceful, and without incident. The demonstration was disbanded at noon the same day; however, they announced they would have a similar demonstration on Friday, November 17, 1967.

The Dow Chemical Company representatives were conducting interviews for prospective employees at the Purdue Placement Center in the Memorial Center at Purdue University, West Lafayette, Indiana, on November 17, 1967. company. A group of approximately seventy demonstrators assembled at 9:30 AM on the morning of November 17, 1967, at the Memorial Center. Approximately sixty were outside the building near the entrance of the placement center handing out literature. They all moved inside the building at 10:30 AM, where they lined up on both sides of the hall leading to the placement center. By noon, there were approximately 100 demonstrators. Approximately ten carried placards with photographs of children with burn scars bearing notations such as "Somebody Made a Living Doing This," "Napalm Kills Babies" and et cetera. Others handed out literature which consisted of a mimeograph sheet of paper pointing out the mutilations caused by Napalm burns to Vietnamese children and that if they contribute to the success of Dow in any way, they must bear the responsibilities. The demonstration broke up at noon and approximately thirty of the demonstrators adjourned to Room 218 of the center, where they served coffee. All were gone by 3:00 PM. The demonstrators were careful not to obstruct halls or doorways and the protest was orderly and peaceful. The demonstration was held with the permission of the Administration, and no incidents occurred.

[REDACTED], advised on May 15, 1968, that approximately 100 Negroes who appeared to be students at Purdue University walked from the Memorial Center to the front of the Executive Building at Purdue University. Each individual was carrying a brick. The bricks were stacked in a pile in front of the Executive Building and a sign was placed against it which read "Next Time Fire." According to Buck, the reason for the demonstration was a demand for Purdue University to hire a Negro professor to teach Negro history.

A second confidential source, who has furnished reliable information in the past, advised May 15, 1968, that more than 140 Negro demonstrators holding bricks stood silently in front of the Executive Building at Purdue University for about 45 minutes. The leaders presented a list of demands to the Dean of Men and Women. The leader of this Black Student Action Committee is [REDACTED]. The petition read as follows:

Re: New Left Activity  
Purdue University  
West Lafayette, Indiana

"We demand that the University pressure its departments to recruit qualified black professors for the 1968-69 school year.

"We demand that the professors of the history department integrate their segregated, bigoted and insulting U. S. History courses.

"We demand the immediate integration of student organizations.

"We demand courses dealing with black culture.

"We demand that the black arts be incorporated into the music and art appreciation courses.

"We demand that the University compile a list of discriminatory housing and make this list public.

"We demand more than a token integration of the administration.

"We demand that the University see to it that black professors do not meet discrimination in procuring housing.

"We demand that a course dealing with distortion be instituted as a general requirement for all students. Or...the fire next time..."

In a prepared statement, Homer LaRue said the demonstration was organized because:

"the Black Student Action Committee has deemed it necessary to demonstrate the existence of racism and apathy at Purdue University.

"The Black students have been patient with the slow-moving, 'it-takes-time' attitude of the majority of the administration, faculty and students. This demonstration today is the Black students' final show of patience.

"If Purdue University does not see fit to look upon the Black student with respect, they have only themselves to blame for another Columbia or Northwestern.

"The Black student will be a student in every sense of the word, or 'The fire next time.' "

Second source further advised that Dean Roberts met with [REDACTED] and accepted the demands and advised [REDACTED] and those present that their grievances would be presented to the President of the University and his executive staff.

"Or the Fire Next Time" is the title of a recent James Baldwin novel.

No outside influence has been observed in any of the foregoing demonstrations.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

## APPENDIX

### STUDENTS FOR A DEMOCRATIC SOCIETY

The Students for a Democratic Society (SDS), as it is known today, came into being at a founding convention held at Port Huron, Michigan, in June, 1962. The SDS is an association of young people on the left and has a current program of protesting the draft, promoting a campaign for youth to develop a conscientious objector status, denouncing United States intervention in the war in Vietnam and to "radically transform" the university campus, and provide for its complete control by students. Gus Hall, General Secretary, Communist Party, USA, when interviewed by a representative of United Press International in San Francisco, California, on May 14, 1965, described the SDS as a part of the "responsible left" which the Party has "going for us." At the June, 1965, SDS National Convention, an anticommunist proviso was removed from the SDS constitution. In the October 7, 1966, issue of "New Left Notes," the official publication of SDS, an SDS spokesman stated that there are some communists in SDS and they are welcome. The national headquarters of this organization as of April 18, 1967 was located in Room 206, 1608 West Madison Street, Chicago, Illinois.

## I. FALSE ALLEGATIONS OF POLICE BRUTALITY

On 6/22/67, after an open meeting of the Students for a Democratic Society (SDS) at IU, attended by members of the IU W. E. B. DuBois Clubs of America (IU - DCA), a number of persons attending this meeting went to the vicinity of Kirkwood and Indiana Avenues in Bloomington, Indiana. This district is known as a "hippie" hangout. The merchants in this district have complained to the police department on a number of occasions that long-haired beatnik hippies are ruining their business. About 100 students and hippies gathered in this area and were agitated by persons who left the SDS meeting. The police subsequently asked these persons to move on and in the ensuing altercation, seven persons were arrested. Three of these persons were leaders and members of the IU-DCA and four of those arrested were leaders and members of the SDS at IU. Members of the police department reported that they moved into the area to advise these people about the law concerning loitering and to advise them to move on and not cause a crowd. Investigation reflected that two of the leaders of these organizations had appeared at the Bloomington Police Department about 30 minutes before this incident to inquire about the details of the loitering statute in Bloomington, Indiana. These leaders returned to the scene and deliberately taunted the police officers while haranguing the crowd to disobey the police orders. The seven persons who were later arrested in this incident charged police brutality by putting out a one-page mimeographed sheet stating

that they were misused by the police. All charges against those arrested in this incident were subsequently dropped by authorities and no actual charge of misconduct on the part of the police was ever made to the police department or the local prosecutor's office. It appeared that these charges were made by these leaders for publicity value only.

After the return from the March on Washington, D.C., October 21, 1967, many of those participating in the march publicly stated that the police and military authorities around the Pentagon were brutal in their treatment of the demonstrators. These allegations and statements, however, also appeared to be for publicity purposes only and were never made in the form of specific complaints locally.

On 10/30/67, leaders of the SDS at IU and the IU-CEWV instigated a demonstration against the Dow Chemical Company employment interviews at IU, resulting in the arrest of 35 students. During this incident, about 100 students appeared in the hallway of the Business School at IU to protest the Dow interviews. They were repeatedly warned by representatives of the Safety Division of IU and a representative of the Dean's Office at IU that they could not enter the interview rooms. They were also warned that if they did enter these rooms they would be arrested. The chairman of the SDS took a vote by show of hands of the group assembled in the hallway and this group voted to force their way through the door which was guarded by the police. Members of the group shouted, "We will walk over them" and then surged for the door, forcing their way over the Safety Division officers guarding the door. Once inside the room, they were advised that they were all under arrest. They were asked to leave with the officers for a bus outside the building which would take them to jail. Most of those arrested left quietly with the officers but about seven or eight persons remained in the room, including two women. As police officers proceeded to escort the remaining persons from the room, the two women present began screaming and the men began struggling. A general melee ensued. As one of the Negro demonstrators was taken through the door, he struck a captain of the Safety Division on the left jaw with his fist, causing a temporary partial dislocation. The demonstrator

was grabbed by uniformed officers and he swore "Yes, you son-of-a-bitch, I hit you and I'll hit you again if I can get loose." This was witnessed by a lieutenant and a sergeant of the Bloomington Police Department. Also during this incident, the Chief of Police of the Bloomington PD was kned in the groin and two other captains of the Safety Division were kicked in the stomach and on the thigh. Two of the students were injured, one with a cut on the mouth, and the other with an injured ear. Again, allegations were made of police brutality, but these allegations were more for the purpose of publicity than actual complaints. No actual complaint was made to the authorities concerning misconduct on the part of the police. The two students were sent from the jail, after booking, to the IU Health Center where they were held overnight for observatin. Authorities of the Health Center stated that neither of these students suffered any serious injury.


At the request of University officials, a faculty committee was formed to investigate this incident. They subsequently made a report to University officials. This report could only be summarized by saying that it was in support of the demonstrators and against the police authorities during the incident. In one phase of the report, the faculty members making the report stated that Captain ROBERT DILLON (NA), an investigator for the Safety Division at IU and a retired captain of the Indiana State Police, testified under oath in court concerning the arrest of one of the students who was injured. According to this faculty report, Captain DILLON made allegations which were false during his testimony in court. The Safety Division at IU replied to the faculty committee only that they did not agree with this report. The report, however, was accepted by University Officials who generally backed the students and criticized the authorities in this incident.

## II. IMMORALITY

To summarize immorality in the "New Left" is extremely difficult in that one would not know where to start. One confidential source, who has furnished reliable information in the past, stated after attending about four National Council meetings of the SDS and one National Convention of the W. E. B. DuBois Clubs of America, that free love among the New Left is

considered an acceptable thing. During one recent National Council meeting, this source slept during the night-time hours in one small room on the floor with six other people of mixed sex. During one of the First National Council meetings of the SDS held at McCormick's Creek State Park in Owen County, Indiana, delegates attending this National Council meeting lived in a communal cabin with no regard to the sexes. Among the "New Left" members in Bloomington, several houses are used for communal living. For example, 102 North Dunn Street, Bloomington, Indiana, has about four apartments, all occupied by New Left members. The actual number of people residing in these apartments at any one given time is unknown since it is not uncommon for a number of them to reside in one apartment at one time. Several sources have noted that the residence at 448 East Second Street, Bloomington, Indiana, is another residence for communal living. At this residence, among others, the



Also among the New Left members during the 1967-68 academic year, "The Spectator," a New Left weekly newspaper, was published. This newspaper was considered obscene by local authorities and some issues contained deliberate obscenities and vulgar poetry and words.

### III. ACTION BY COLLEGE ADMINISTRATORS

Since the college administrators and school officials at IU, Bloomington, Indiana, have not taken a firm stand since the Dow incident on 10/30/67, no additional comment can be made under this heading. During the Dow incident, a firm stand was taken by the Safety Division officials, and the Dean of Students office of IU, supported by the local police department. Since this incident the school administrators have generally backed the demonstrators and criticized the Dean of Students office and the police officials involved. In summary, it appears that school officials at IU have acceded to every demand made by New Left demonstrators and Negro student demonstrators during the past seven months. Under these conditions, activities of the New Left tend to increase with every victory.

On 7/6/68, IU President ELVIS J. STAHR, JR. announced that he was resigning as president of IU, effective 9/1/68. During the interim period until a new president is hired, Chancellor HERMAN B. WELLS, former president of IU for 25 years, will act as president of IU.

Due to this recent and most pertinent development, this situation is being thoroughly reviewed to attempt to evaluate the affect this will have on New Left activities at IU. Any further counterintelligence efforts in this regard will be recommended after this evaluation is completed.

#### I. FALSE ALLEGATIONS OF POLICE BRUTALITY

A review of newspaper accounts of "New Left" demonstrations at South Bend, Indiana - University of Notre Dame (UND) and Indiana University, South Bend Campus (IUSBC) - have failed to reveal any allegations, false or otherwise, concerning police brutality. New Left informants at South Bend have not furnished any information concerning false allegations of police brutality. SA [REDACTED] from independent investigations, does not recall that any New Left group or individual has made any allegations of police brutality, false or otherwise.

#### II. IMMORALITY

Concerning immoral, scurrilous and depraved actions of individuals belonging to the New Left, [REDACTED] on various dates in the past has furnished the following information:

**III. ACTION BY COLLEGE ADMINISTRATORS**

It would appear that the administrators at UND and IUSBC have taken a rather "soft" stand toward their student demonstrators. The one exception is at UND on 5/7/68, there had been a threat to seize the UND Admissions Office primarily by the UND Negro students. UND had interviewed some of the Negro students and had obtained admissions from one of them that this seizure was contemplated. This, coupled with a show of force on 5/7/68 by UND security guards, had prevented any attempt to seize the office. In this contemplated seizure, there was no known outside influence and the seizure was to be contemplated solely by UND students. Perhaps 20 students were involved. In this particular case, there was no known assistance rendered by UND faculty members nor did they have any plans to join in the seizure.

In regard to referenced letter setting forth suggestions for counterintelligence action, the Indianapolis Office has prepared an anonymous leaflet entitled "Armageddon News", the purpose of which is to expose at Indiana University (IU) the conspiracy of the New Left and to counteract the impression that Students for a Democratic Society (SDS) and other minority groups speak for the majority of students at IU. This leaflet also sets out persons active in the New Left and the names of the New Left organizations.

Other leaflets will be prepared and submitted to the Bureau for their approval which will expose officers, members, and activities of all New Left organizations at IU. It is also felt that by distributing these leaflets at IU they will help neutralize the New Left groups and will prevent any nonleftist students from being duped into joining the groups of the New Left. It is to be noted that when these leaflets are distributed on the IU campus, it will be done surreptitiously. It is to be further noted that at this time there is no known organization by the name of Armageddon on the IU campus.

make numerous arrests about the first of October, 1968.

The Indianapolis Office intends to use every opportunity to confuse and disrupt New Left activities by furnishing misinformation. By doing this when meetings or any activities are to be conducted at any certain time, they will be given wrong dates and times so as to disrupt their meetings and activities. Also, anonymous letters regarding individual's actions in the New Left will be sent to their respective parents setting out their activities on a selective basis, and these anonymous letters will be signed "A Concerned Alumni".

Enclosed is the above-described leaflet and it is requested, pending Bureau approval, that the leaflets be reproduced, and 25,000 copies be forwarded to the Indianapolis Office. It is to be noted that the reason for the request of 15,000 leaflets is the current student enrollment at IU is 28,500.

It is further requested that the artists of the appropriate section of the Bureau prepare a masthead appropriate to the newsletter which will be used on numerous occasions. It is suggested that a sketch of flames surrounding the heading "Armageddon News" might be used; however, it is being left to the sketch artists to use their own ingenuity as to what would look best for the described heading.

If the enclosed leaflet is approved by the Bureau, these leaflets will be distributed on the IU campus about the second week of September, at which time registration and other activities will have commenced on the campus.

An article appearing in the 7/30/68 issue of "National Review" describes the efforts of a group of students at Indiana University to counteract the effects of the SDS on campus. This small group, led by [redacted], an Indiana University student, successfully published a magazine called [redacted] during the [redacted]. According to the article, these students using [redacted] as a voice were instrumental in throwing an entrenched SDS out of student government. According to [redacted] his group will again use [redacted] to challenge the faculty, administration, and alumni to offer an alternative to balance the liberal "bark" previously offered on campus.

It appears that this group's approach to the New Left menace has a good deal of merit and has apparently had some success at Indiana University.

You should discreetly identify [redacted] and his associates who publish [redacted]. You should furnish your views on the possibility and desirability of Bureau's using [redacted] in this Program.

In order to get some idea of the effectiveness of their approach toward the problem of the New Left, you should also contact appropriate reliable sources. Submit the results of the above inquiry along with your evaluation of this Program.

Any suggestions which you might have as to how the Bureau may be able to encourage this type of approach on campuses throughout the Nation should also be submitted at that time. It also might be feasible, for instance, for "The Alternative" to be broadened in scope to reach other campuses and to make the same demands as are being made at Indiana University.

The Indianapolis Divisions tends to disbelieve the claims made by [redacted] in the article referred to in referenced Bureau letter. The Students for a Democratic Society (SDS) at IU backed a student political party known as the Progressive Reform Party (PRP) during the 1967-68 academic year when the former president of the SDS at IU served as student body president. He became disinterested in student politics after he received his degree and the election of officers at IU for the coming academic year was not effectively pursued by the SDS. The Conservative Student Party won the election, but it is not believed that this was due to the efforts of any one publication or organization, other than the Student Political Party.

The Indianapolis Division feels that [redacted] may be one of the many conservative students against the New Left organizations at IU, but he is unknown to the Division at this time. Indianapolis further feels that the program involving the preparation of an anonymous leaflet entitled "Amageddon News" as set forth in referenced Indianapolis letter has a great deal more potential at this time than the development of a new source during the period when most students are absent at the university. Should it appear that [redacted] may be useful to this program in the future, an investigation would be conducted by Indianapolis to determine his background and suitability to the program.

It is recommended at this time that the Bureau give serious and immediate consideration to the program set forth in referenced Indianapolis letter of 7/24/68 and advise the Indianapolis Division as soon as possible whether Bureau authority will be granted for the distribution of such anonymous leaflets as described therein.

Your proposal to prepare and distribute a throwaway attacking and exposing the New Left on the Indiana University campus has merit and could be effective. It is not deemed practical, however, to distribute the large quantity of throwaways as outlined in reletnor is it felt that it would be secure to distribute them in the manner set forth therein.

There appears to be an element of risk involved in using an outside news media in this operation since such a practice could result in embarrassment to the Bureau. Authority is not being granted, therefore, to distribute the throwaway in the manner described.

In order to carry out this project, you are authorized to distribute the leaflet anonymously to those individuals noted in relet. In this regard, you should take all necessary precautions to protect the identity of the Bureau as the leaflet's author.

As an initial mailing, the Bureau is having 200 copies of the throwaway prepared which will be forwarded to you by separate communication.

You should follow this operation closely to evaluate any results forthcoming. Thereafter, furnish your recommendations for following up this mailing with additional throwaways.

IP advises that [REDACTED], that he has been a long-time established source of the IP Office, and is known to be a person of great trust, integrity, and reliability. IP stated that it intended to have [REDACTED] distribute the throwaways on the Indiana University campus by using people [REDACTED]. IP also stated it intends to distribute some of the pamphlets to individual fraternity, sorority, and faculty members by anonymous mailings. We feel that 25,000 copies of such a throwaway is entirely too many and that taking into the Counterintelligence Program an outsider, even if he has proven reliable in the past, can possibly be a source of embarrassment to the Bureau. The suggestion does have merit and we are authorizing printing and distribution of 200 of the throwaways through anonymous mailings. It is further noted that [REDACTED], since 1964, has been trying to develop a running exchange of correspondence with the Director on sensitive issues and has attempted to meet with the Director on several occasions. His request for an autographed photograph of the Director was declined in January, 1967. He has generally been complimentary of the Bureau.

The following is the finalized program of neutralization and deterrent of the New Left at Indiana University, Bloomington, Indiana, presently under development by SA [redacted] at Bloomington, in accordance with instructions in this program. This program is set up in four phases concerning separate New Left activities and should be fully developed by the end of September, 1968. These proposed phases are as follows:

## PHASE I - CP, USA

[redacted] formed the Communist Party Club at IU [redacted] 7/23/68 and has the largest single group with growth potential in Indiana.

[redacted] was a delegate to the special convention of the CP, USA held in New York City, 7/4-7/68. While there, he stayed several nights at the apartment of [redacted]. He got drunk repeatedly and was repeatedly late to the convention. He was overheard by [redacted] stating that the CP was full of "self seekers" and that he was "going to weaken." [redacted] got angry and called [redacted] "anti-Party." Subsequently, [redacted] reported this to DANIEL RUBIN, who has mentioned it to leaders in the Midwest.

[redacted] was told to watch [redacted] but work with him. [redacted] was told to come to IU to check on [redacted] and report back to [redacted]. It was announced that [redacted], would come to IU for a public speech on 9/16/68. [redacted] is supposed to make arrangements for this speech at IU and [redacted] is to furnish transportation for [redacted] to IU. [redacted] has been instructed to try to cause a disruption of arrangements for this speech so that the speech of [redacted] can be neutralized or postponed and the blame can be placed on [redacted]. If this can be arranged, it would leave [redacted] in control of the CP Club at IU.

The brother of [REDACTED] came to Bloomington, Indiana about 8/15/68. It was reported that [REDACTED] brother saw the conditions in which [REDACTED] was living [REDACTED] his belongings and left for their home in [REDACTED]. The possibility now exists that [REDACTED] may return to IU this fall, although [REDACTED] believes he will return.

On 8/22/68 [redacted] purchased a .22 caliber revolver in Bloomington. His landlord, Mr. HAROLD FLEENER, told him that the house had been rented by [redacted] who had given the landlord an insufficient funds check for \$100 for the rent for August, 1968. [redacted] was told that since no rent had been paid during August and [redacted] had left, [redacted] would have to leave by 8/28/68. On 8/29/68 the landlord locked this house at [redacted] keeping [redacted] belongings inside until this rent and damages for this residence done by [redacted] and their friends had been paid. The basement of this house contains a mimeograph machine, typewriters, paper and literature of the CP and New Left organizations.

**PHASE II - STUDENTS FOR A DEMOCRATIC SOCIETY (SDS) AND INDIANA UNIVERSITY COMMITTEE TO END THE WAR IN VIETNAM (IU-CEWV)**

It is believed that the SDS at IU should be leaderless during the coming fall semester and its activities neutralized by the "Armageddon News," as set forth in Phase III. [REDACTED] and [REDACTED] will be in a position to furnish information necessary to disrupt any activities on the part of the SDS which might arise with possible new leadership.

The IU-CEWV will be the largest "New Left" organization in Indiana with the greatest potential. This organization will actually be run by [REDACTED] and [REDACTED]. [REDACTED] is currently vacationing at the University of California at Berkeley, Calif. He is a member of the YSA and is at Berkeley learning YSA and SWP organization, tactics, and methods. [REDACTED] will be mostly tied up with trying to organize the legal defense for [REDACTED] whose Selective Service case is currently under appeal in the U. S. District Court at Indianapolis, and the 19 appeals in the local arrests caused by the Dow incident at IU 10/30/67.

[REDACTED] is close to [REDACTED] and [REDACTED] and can furnish information sufficient to disrupt their activities. It is believed that "Armageddon News" will have a deterrent affect on membership by newly arrived students at IU in this organization. [REDACTED]

The current figurehead chairman of the IU-CEWV, [REDACTED] smokes marijuana and attempts will be made to include him and other members who smoke marijuana in Phase IV of this program.

### PHASE III - "ARMAGEDDON NEWS"

Bureau authority has been requested for the anonymous distribution of "Armageddon News" at IU with four proposed issues as needed. These issues will "expose the New Left conspiracy at IU" as follows:

Issue #1 - purpose and summary of activities of "New Left" last year

Issue #2 - activities, background and officers of the IU-CEWV

Issue #3 - activities, background and officers of the SDS

Issue #4 - CP at IU and narcotics problem.

Issues #1, 2 and 3 have been submitted to the Bureau for approval and issue #4 will be submitted when deemed needed, upon Bureau approval of this phase of the program.

In accordance with Bureau authority by Bulet dated 8/30/68 mailing distribution will be handled by the Indianapolis Division concerning issue #1 by 9/9/68. It is planned that issue #2 will be mailed by 9/16/68 and issue #3 by 9/23/68.

**PHASE IV - NARCOTICS PROBLEM at IU**

Since this problem is synonymous with the "hippie" area known as "The Strip," and the New Left, efforts are being made to coordinate police investigation with this program of neutralization and deterrent. For the past three years this problem has become increasingly worse at IU until it has become one of the largest problems of its kind in the State of Indiana. During the past year a State Police undercover agent and a Federal Narcotics Agent of the Bureau of Drug Abuse Control, tried on separate occasions to enter IU and make undercover investigations and arrests. On both occasions, lack of liaison and communication resulted in no arrests, solutions or deterrents. Strained relations developed between agencies in this matter and only local authorities were actually working on the problem.

During July and August, 1968 contacts were made with individual agencies in this matter by SA [redacted]. All agencies agreed on the depth, scope and serious nature of the problem and the need for a concentrated cooperative operation.

A conference of interested agencies involved was held on 8/29/68 at the Indiana State Police headquarters in Indianapolis, Indiana. Those present at this meeting were:

7 It was explained to this meeting that the interest of the FBI was only to coordinate whatever efforts were to be made by these four agencies to resolve the problem at IU so that it would aid a program of the FBI in regards to security investigation of "New Left" organizations. No further explanation was requested nor given. At this meeting it was agreed that:

1. Most narcotics are brought into this area by individual hippies, users and independent pushers. Professional pushers and wholesalers are few and would leave or cease operation in the area at the first sign of a concentrated "bust" by the police.
2. Long involved undercover investigations in this area in the recent past to arrest sources and pushers only have been unsuccessful and is now believed to have little potential deterrent value even if successful.
3. Individual "buys" can be made quickly and in large numbers once the majority of students return to IU for the fall registration, 9/11-14/68, since users bring a large quantity of narcotics supplies back with them on return to school.
4. A large number of arrests in a short span of time by a publicized coordinated effort by all agencies would have the greatest possibility of successful deterrent affect on the area.

As a result of this meeting, it was decided as follows:

- A. [REDACTED] and possibly one of his sources will move into "The Strip" for up to three weeks beginning 9/10/68;
- B. ISP will direct one or possibly two sources into "The Strip" during this period and ascertain the possibility of other sources. First Sgt. [REDACTED] is to study the possibility of the arrest of [REDACTED] a pusher on whom there is currently sufficient information for an arrest, to ascertain whether he can be used as a source of information or treated as an arrested subject prior to 9/10/68;
- C. Bloomington PD and Safety Division, IU, will ascertain the sources which can be directed into this area during this period and furnish information for dissemination on all known users, pushers, and possibly party locations;
- D. Another meeting will be set at a cottage on Lake Lemon, 10 miles northeast of Bloomington, for 1 PM on 9/10/68 for all participants for final instructions and dissemination of pertinent information. At this time these authorities will brief the prosecuting attorney of Monroe County and make arrangements for information necessary to him for prosecution in this matter;
- E. At the request of all agencies involved, SA [REDACTED] will coordinate the meeting on 9/10/68, after which efforts will be coordinated for cases and times locally. When combined authority is satisfied that sufficient cases have been made, joint arrests will be made at one time. It is estimated that this time will probably be in the last week of September, 1968.

F. Prosecutions will be local. The only possibility of an exception will be Federal prosecution in the event any large interstate operation or pusher from another state is uncovered. In this event, prosecution will be handled by Agent [REDACTED]. Publicity will be jointly released by the four agencies involved: U. S. Bureau of Narcotics and Dangerous Drugs, Indiana State Police, Bloomington PD, and Safety Division of IU.

It is believed that the above program will greatly neutralize the activities of the CP, USA and the "New Left" organizations at IU during the coming academic year and greatly deter many students from joining in the activities of these organizations.

Upon completion of this program, the Indianapolis Division will evaluate the program and make recommendations concerning further investigative and counterintelligence activities needed in this program at IU. This evaluation will be made by the end of October, 1968.

It is requested that the Bureau furnish the Indianapolis Division with 400 copies each of issues #2 and #3 since it is believed that the purposes of the newsletter would be better served if more than one copy of each issue could be mailed to individual fraternities, sororities and dormitories.

If you will look closely, you will find that [redacted] and [redacted] both members of the Young Socialist Alliance, pulled the strings for [redacted] to jump. These people are the "manipulators" at IU and have the greatest influence on the "New Left" through the CEWV.

Last semester [redacted] and [redacted] announced the CEWV sponsorship of a series of lectures on "Socialism" and "The Communist Manifesto." These lectures were given, in part,

by an officer of the Young Socialist Alliance, [REDACTED] a former IU student. [REDACTED] is now the State Chairman of the Socialist Workers Party's campaign and is presently running for Senator on the Socialist Workers Party ticket in the State of Indiana. What we want to know is what relationship do the topics "Socialism" and "The Communist Manifesto" have to do with a free people's rights and attempts to protest the policy of their government.

If this is the way the CEWV is to act, let's not be duped by its name. It's no longer a committee to end the war in Vietnam, no longer a forum for just dissent. It's a recruiting ground for subversion.

We all want an end to this war and we have a right to protest our government's participation therein. Ask yourself, then, what can be the true purpose of those who want to use your name and your energy for their objectives. It's surely worth your time and your effort to inquire penetratingly into organizations and causes that entreat your support.

A case in point is that the campus newspaper on 9/24/68 reported that CEWV is making plans to support the "International Days of Solidarity," planned by the Student Mobilization Committee (SMC) for the week of 10/21/68, and a large antiwar demonstration planned at IU for 10/26/68. Let's find out who we are declaring ourselves in solidarity with and what this Student Mobilization Committee really is. It wouldn't be surprising to find a considerable covey of SWP'ers behind it.

The following is an evaluation of the Cointelpro Program at Indiana University, Bloomington, Indiana, set forth in referenced airtel to the present date. Evaluation will be made for each phase mentioned in referenced airtel with a general evaluation and recommendation of the entire program.

## PHASE I - CP, USA

The Communist Party Club at Indiana University (IU) was formed by [REDACTED] on 4/23/68 and was considered the largest single group with the greatest growth potential in the State of Indiana. Among the original members of this club were [REDACTED] and [REDACTED]. It is noted that [REDACTED] was a member of this group although he was a private in the U. S. Army stationed at Fort Campbell, Kentucky. Also among the original members of this group were [REDACTED] and [REDACTED].

As previously planned, [REDACTED] was discredited by these sources to the State Chairman of the CP in South Bend, Indiana.

In connection with information set forth previously in this phase, [REDACTED] returned to Bloomington, Indiana to resume his activities on 9/4/68. On 9/5/68 he was arrested on the charge of trespass by the Bloomington Police Department in

connection with entering his former residence, which had been locked by the landlord. He was released the same day on bond.

On the morning of 9/10/68, [redacted] and [redacted] were both arrested separately on a local charge of "possession of instrument used in smoking a narcotic drug" in connection with marijuana pipes found in this residence. They were both released on bond the same date.

On 9/12/68 [redacted] furnished a voluntary signed statement to the Bloomington PD concerning some of his activities in the W. E. B. DuBois Club at IU, the Students for a Democratic Society (SDS) at IU and the CP at IU.

The above sources continued to furnish information concerning these narcotics arrests to the chairman of the CP of Indiana at South Bend, discrediting [redacted] "for the good of the party," at the same time became head of the [redacted] Defense Fund." The local newspaper carried a news item concerning the arrest of [redacted] stating that he was a delegate to the special convention of the CP in New York City 7/4/68.

[redacted] mother came to Bloomington, Indiana to offer her son legal assistance and received permission from the County Prosecutor to take her son back to New York for treatment. They both left Bloomington to return to New York.

As a first result of the above circumstances, the announced speech of [redacted] nominee of the [redacted] during the [redacted] at IU [redacted] was cancelled. Also as a direct result of the above, all activity of the CP Club at IU ceased and no further efforts were made to recruit new members.

An article on page two, section one of the "Daily Herald Telephone," a daily newspaper of Bloomington, Indiana, dated [redacted] related that the smoking pipe seized by law enforcement officials in connection with the narcotics charge against [redacted] had been ruled as inadmissible

evidence in the case by Superior Court Judge DONALD A. ROGERS. In view of this ruling, the case will be dropped. The [redacted] Defense Fund has raised only \$100 of the \$700 necessary to pay [redacted] defense attorney in this matter and, therefore, the charges would not be dropped until this balance was settled.

An article in "The Spectator," a left-wing campus newspaper at IU, dated [redacted] reflected an article entitled "An Evening with the Communists" presented by the Communist Party. This announced a meeting at IU on 11/23/68 with a panel of speakers to include the organizational secretary of the Indiana Communist Party, a Communist GI stationed at Fort Knox, and [redacted]. [redacted] stated that this announced meeting was a final attempt by the CP of Indiana to reorganize the CP Club at IU and would feature [redacted] organizational secretary of the Indiana CP, [redacted] a private in the U. S. Army at Fort Campbell, Kentucky, and [redacted].

On 11/17/68 Private [redacted] a private in the U. S. Army at Fort Campbell, Ky., was arrested with another GI at Bloomington, Indiana, on a charge of "possession of marijuana." He is still being held in lieu of a \$5,000 bond. Military authorities at Fort Campbell, Ky. also have advised the Bloomington PD that they had opened a locker belonging to Pvt. [redacted] at Ft. Campbell and discovered marijuana in the locker.

On 11/22/68 [redacted] advised that the speech by [redacted] at IU to reorganize the CP Club at IU was definitely cancelled because of the arrest of [redacted]. [redacted] advised on 11/23/68 that the CP meeting at IU which was to feature a speech by [redacted] organizational secretary of the Indiana CP, was not held.

Both of the above sources have advised that there is no further activity on the part of the CP Club at IU. [redacted] advised that [redacted] has left Bloomington to live and work in Indianapolis, Indiana. The only CP members left at Bloomington who might serve as contacts for the chairman of the Indiana CP in South Bend, Indiana, are [redacted] and [redacted].

**PHASE II - Students for a Democratic Society (SDS)  
and Indiana University Committee to End  
the War in Vietnam (IU-CEWV)**

These organizations have attempted several disruptions at IU since the beginning of the current academic year, all of which have been unorganized and spontaneous.

The SDS at IU has been unable to form a specific organization and leadership. On 11/21/68 the SDS at IU held a meeting specifically to elect officers but was unable to elect a complete slate of officers. The organization has also been unable to form any definite plans or policies for future activities. All activities of this organization during this period have been spontaneous and led by individual activists rather than any specific leadership or organizational structure.

The IU-CEWV is mainly under the organizational influence of [REDACTED]. Leadership of the IU-CEWV, however, during this period has fallen to a figurehead leader, [REDACTED] since [REDACTED] has been expending most of his efforts to organize a local chapter of the Young Socialist Alliance (YSA). At this time [REDACTED] has been unable to furnish sufficient leadership and organizational qualities for the IU-CEWV and [REDACTED] is currently looking for someone within the YSA to take over this leadership and revitalize the organization.

In all activity attempted during this period by these organizations, [REDACTED] has continually stated that they do not wish to have confrontations with the police, nor to cause violence which might result in an arrest because these organizations are currently tied up with numerous defense funds and involved in too many court actions. [REDACTED] stated specifically that most of their energies, finances, and activities are currently tied up with court actions against various members of the organizations.

The "Armageddon News" (Phase III), distributed at IU during this period, contained much of the specific background of these organizations and it is believed that this distribution was greatly responsible in limiting the number of curious students which normally follow such organizations during this period.

During the current agitation against university policy concerning CIA recruitment on the campus of IU, 12/9-13/68, these organizations have expended their greatest effort at disruption. The IU-CEWV lacked leadership outside of the YSA and its influence as an organization was minimal. The SDS and the YSA split over policy since the YSA wanted an orderly demonstration without violence or confrontation, and the SDS wanted more action. The YSA has expended their energy in obtaining signatures of students on petitions while about 15 to 20 SDS activists conducted a sit-in in Ballantine Hall outside of the room in which CIA interviews were being conducted. Action by the SDS was unplanned and spontaneous action by individual activists rather than any organizational policy or planning. On 12/12/68 one of these SDS activists threw a bottle of acid in the interview room causing more odor than damage. This action was insufficient to physically stop the interviews but orders were received from CIA headquarters for the CIA representative to discontinue the interviews and leave the campus of IU. It was noted during this period, however, that the SDS activists were unable to involve great numbers of students in this activity as they have in past years.

### PHASE III - "ARMAGEDDON NEWS"

Only the first two issues of "Armageddon News" were approved and distributed at IU, but it is felt that they did have considerable impact upon students who otherwise may have joined in the activities of these organizations. The first issue of "Armageddon News" was reprinted in its entirety on one page of one of the local daily newspapers in Bloomington, Indiana. Five thousand copies of the second issue of "Armageddon News" was reprinted and distributed by conservative organizations at IU.

It was also learned that reprints of these issues were in part reprinted by such publications as "The Firing Line," a publication of the American Legion; and in part in the "Alabama Independent," of Birmingham, Alabama, a daily paper, in the 1/27/68 issue.

In evaluating this particular phase, it is felt that while a degree of impact was effected by this publication under this program, a much greater affect could be obtained if printed on a more frequent and regular basis. If this phase of the program is to be used or continued in the future, it is suggested that Bureau authority be granted concerning the program rather than individual issues, or on a series of issues at one time so that a more frequent and regular publication and distribution can be effected.

#### PHASE IV - Narcotics Problem at IU

In addition to the narcotics arrests set forth in Phase I, [REDACTED] a narcotics pusher and participant in New Left activities at IU, was arrested by the Bloomington PD on [REDACTED] on a charge of possession of narcotics. He entered a plea of guilty to a charge of "possession of an instrument used in smoking a narcotic drug," on 12/11/68 and was sentenced to a one to five year suspended sentence, fined \$1 and costs, and placed on probation for one year.

The program under this phase as set forth in reairtel, continued with the idea that only arrests in Bloomington, Indiana would be made concerning sales of narcotics, rather than mere possession cases. The participating agencies involved in this combined operation found that investigative time was necessarily extended through November, 1968. It was also decided to coordinate the arrests in Bloomington with arrests in Indianapolis, Indiana under this program. Starting on the evening of 12/2/68 a series of 14 arrests at Bloomington, Indiana, and 17 arrests at Indianapolis, Indiana, were made under this program. Instead of small articles for each arrest appearing in the paper on an individual basis, these series of "crackdown arrests" received headline coverage in local and state papers for a one-week period. Coverage has also extended to editorials and feature articles and has been felt by local, state and federal authorities to be a great deterrent to the narcotics problem in Bloomington and Indianapolis, Indiana.

The affect of these arrests in Bloomington, Indiana was sufficient to close down activities of "the strip," an area predominantly used by "hippies" and members of the New Left near IU, for a considerable time. [REDACTED] stated that the New Left organizations have met to discuss forming a general defense fund for all persons arrested during this "crackdown" on narcotics. This is being encouraged since such a defense fund would put the New Left organizations in the position of supporting defendants in cases involving the sales of narcotics rather than cases of mere possession. This would not only tie up their funds, energy and activity for a period of time but place them in the position of condoning and backing the sale of narcotics locally. In these arrests the boyfriend of one active YSA member and the young brother of one of the active SDS members were arrested. It could, therefore, be stated in the future that backing of those arrested by a New Left defense fund would pertain solely to backing sales of narcotics rather than any political theoretical charges against members of their organizations.

#### General Evaluation

The general evaluation of this entire program would have to be considered highly successful. Under Phase I the CP Club at IU has been totally neutralized, leaving the only contacts in Bloomington for the CP confidential sources of the Bureau. Also, during September and November, 1968, two campus speeches by CP functionaries were cancelled as a result of this program. It is felt that the CP Club at IU could not recover from this action for years in the future.

Under Phases II and III, the SDS and the IU-CEWV have lost specific leadership and organization. In the past years at IU these organizations have enjoyed both leadership and organization and been able to generate large crowds for their activities. The SDS at the present time does not have a full slate of officers and has no organizational structure. All of their activities depend on individual activists and are spontaneous. Except for the leadership offered through the YSA

organization, the IU-CEWV lacks specific leadership and organizational structure. It is believed that these two phases of this program have substantially prevented large numbers of students at IU from innocently rallying to the causes of these organizations. In the area of prevention, statistics on this behalf are impossible to obtain. It is assessed, however, that neither of these organizations has been able to rally large numbers of students to their causes during this pertinent period.

Under Phase IV of this program, the concerted narcotics arrests in Bloomington, Indiana have resulted in shaking the complacency of the "hippies" and members of the New Left. The impression has been left in Bloomington that this coordinated effort by the local, state and federal police agencies involved is continuing and more arrests concerning narcotics will be made in the future. In addition to shaking the confidence of members of the New Left with this action, any defense fund for those arrested being planned by the New Left organizations would be both consuming and unpopular locally. It is also felt that since practically all of those arrested were associated with the "hippie" community, the unsavory name of narcotics has been more closely associated with the New Left individuals, organizations and activities at IU.

The only organization with a degree of organizational structure at IU is the YSA, which was formed into a local organization in September, 1968. This organization currently has 14 members and has the potential of organizational growth and activity.

#### Recommendations

Should New Left activities continue at a substantial rate at IU during the second semester of the current academic year, the following program is recommended at IU:

Phase I - Young Socialist Alliance (YSA)

Security informants within the structure of the YSA to disrupt YSA organization by a split in philosophy of the members and thereby splitting the organizational structure and officers themselves.

Phase II - "Armageddon News"

During the second semester of the current academic year, the "Armageddon News" could be published in a short, frequent series to point out specific exposés of New Left activities at IU during the second semester, as a deterrent to other students to join the activities of these organizations.

Counterintelligence action which has been taken by your office shows that you are giving a great deal of thought to this Program. Your accomplishments, as set out in relet, indicate that this Program in your office is achieving excellent results.

It is noted that the Young Socialist Alliance (YSA) has the potential of growing at Indiana University and the Bureau agrees that you should attempt to cause a split in this organization. You should consider the use of appropriate informants, anonymous mailings, and articles in the "Armageddon News" to cause friction between members of this group. All action taken must be approved by the Bureau.

The "Armageddon News" appears to have excellent potential for counterintelligence purposes. The Bureau has no objection to it being published more frequently; however, prior Bureau approval must be obtained for each issue.

Your interest in this Program and the excellent suggestions you have made concerning it are very much appreciated.

Enclosed herewith are one copy each of proof issues, Vol. II, #1 and Vol. II, #2, of the "Armageddon News."

In Indianapolis letter to Bureau dated 12/17/68 a two-phase program at Indiana University, Bloomington, Indiana, (IU), was recommended for continuance of this COINTELPRO during the second semester of the 1968-69 academic year. It is felt that the impact of this program will be far greater at the early part of the semester (i.e. mid February), so recommendations are being made with this target date.

## Phase I - YSA

[redacted] has reported successful inroads in this phase to date. His efforts to widen the factional differences in the leaders were utilized to hinder the reorganization in the second semester. On 1/14/69 an executive meeting of the YSA was held so that [redacted] Chairman, could name [redacted] of Indianapolis, as the new [redacted] for the [redacted] for the next semester. This was supposed to have taken only a few minutes to "rubber stamp" this appointment. The executive committee, comprised of three local members, including [redacted] at first refused to appoint [redacted]. He was questioned at length and other nominations were made. To the dismay of [redacted] and [redacted] this small rebellion lengthened the meeting to one and one-half hours. [redacted] was finally approved but the dissension remained heavy.

At this point several members are talking of leaving IU due to what they term "dissension and oppressive atmosphere." This brings up a drastic need for new members and new active leaders. Opposition to the organizer can seriously hamper his recruitment. This effort will continue, particularly at the beginning of the semester, keeping in mind the need to protect informant's position in the YSA

Phase II - "Armageddon News"

Vol. II, #1 (a designation used by other newsletters at IU), attacks the New Left organizations in general at IU, continuing in the vein of previous issues. If published before time of reorganization meetings, they are expected to have the affect of restricting support and new membership and seriously limit those willing to hold office.

Vol. II, #2 attacks the YSA and its leaders. It is also believed that an early distribution of this issue would throw a major roadblock in the way of recruitment, even with a full time organizer, on the IU campus.

Recommendation

In accordance with instructions set forth in relet, Phases I and II will proceed as set forth above, UACB.

It is requested the Bureau approve Volume II, #1 and #2 enclosed herewith. If approved, it is requested that each be printed by the Bureau using the masthead of previous issues. It is also requested that 3,000 copies of each issue be forwarded to Indianapolis so that they may be distributed by anonymous mailing to dormitories, fraternities, sororities and student organizations in packets of 25 - 100.

It is further requested that both issues be approved at one time and dates inserted one week apart (i.e. 2/10/69 and 2/17/69). Indianapolis should be advised as soon as possible if and when this phase can be expected.

The YSA, youth group of the Socialist Workers Party, did not want a large membership. Their chairman, organizer and "behind the scenes" manipulator, Russell Block, prefers a small organized and dedicated group. We are preparing a separate issue on this group.

Since no one organization had mass backing last semester, the big thing was coalition. All of the New Left organizations tried to get together to get a big thing going. The most popular controversy seemed to be recruitment on the campus.

In October the SDS and CEWV vented their spleen against a government recruiter and the CEWV tried to stir up trouble by joining the National Week of Solidarity - both fizzled.

As a last desperate attempt, in December they all joined together and went after the CIA recruiter. About 50 shouted to "sit-in" Ballantine Hall, but only about a dozen stayed. When their insults, bad manners and filth failed to deter the recruiter, they became petulant. Their bearded faculty leader, Professor Robert Klawitter, led them into the Faculty Lounge at night. The next morning other faculty members were appalled at the filth and destruction caused by this handful of dissidents to the lounge. Our dean berated them, only to be deluged with insults.

Finally, in a childish temper tantrum, they gathered in front of the recruiting room and threw a bottle of acid into the room, damaging the door and the floor. Then, like fugitives from decency, they fled. The CIA discontinued the interviews and left I.U. to keep from embroiling the campus in strife and turmoil. The real losers were the legitimate students who were seeking employment.

The leftist agitators proved nothing and changed no policies. They caused disruption only for the sake of disruption. Must we continue to allow them to violate the rights of others?

They have now held their national conventions over the holidays and will return with renewed vigor to try to reorganize here this semester.

Last Semester

The SDS at I.U. tried to get organized several times but most of our students would have none of them. Most students are well aware of their anarchistic beliefs, disruptive tactics, and dubious connections. Their chief agitators: [redacted] tried for mass student backing. 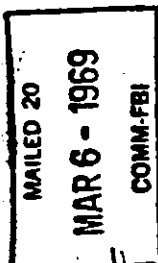

Re Indianapolis letter to Bureau dated 1/23/69.

In order to make a current evaluation of the effect of this program on the New Left at Indiana University, Bloomington, Indiana, (IU), the following is a summary of actions taken since the last evaluation, to date:

Volume II, #1, dated 3/7/69, and Volume II, #2, dated 3/14/69, issues of the "Armageddon News," were disseminated per Bureau authority. The first issue attacked the New Left in general, naming the chief activists and leaders of the New Left movement. Both the Students for a Democratic Society (SDS) at IU, and the Indiana University Committee to End the War in Vietnam (IU-CEWV) were written up with a list of their respective leaders. The second issue was devoted in its entirety to the Young Socialist Alliance (YSA) at IU, stating a list of their leaders. This issue was also directed against [redacted] who was considered the chief organizer and main influence in both the YSA and the IU-CEWV.

Following this, the "Daily Herald-Telephone," a daily newspaper in Bloomington, Indiana, carried a half-page article dated [redacted] concerning [redacted] and the [redacted]. This article specifically attacked [redacted] formation of a new student political party known as the Revolutionary Student Party, which [redacted] formed solely for the purpose of running himself as a candidate for the office of student body [redacted] at IU. This article also quoted the 3/14/69 issue of "Armageddon News."

This article pointed out that the 1968 election petition of the Socialist Workers Party (SWP), in the State of Indiana, carried [redacted] Bloomington, as chairman [redacted] [redacted], as vice chairman, and [redacted] of Bloomington, as organizer. It also quoted the "Guide to Subversive Organizations" and a current telegram from the Internal Security Division of the Department of Justice, stating that the SWP is considered a subversive organization by the Department of Justice and is still on the Attorney General's List. This article also carried [redacted] conviction on charge of [redacted] during campus [redacted] against the [redacted] and the fact that he is currently employed as a [redacted] in the [redacted]

[redacted] stated that the disruption within the YSA at Bloomington caused several of its leading members to leave IU, four of whom went to the Berkeley, California, area. Two others left the organization and the YSA was reduced to nine active members.

Both of the above sources reported that the SDS at IU was unable to gain enough support, due to their adverse publicity, to hold a meeting large enough to elect officers or form a program during the second semester of the 1968-69 academic year.

[redacted] attempt to form the Revolutionary Student Party was followed by his personal action to bring three Black Panther Party speakers to the IU campus in April, 1969 in an attempt

to stir up black students and gain support for his election. [redacted] stated that [redacted] was "shouted down" at this meeting and even the black students refused to be dominated or influenced by either [redacted] or the Black Panther Party speakers. The black students stated that they preferred to act on their own and did not wish to be dominated or influenced by New Left leaders with such adverse public image.

Also, in order to assist in this evaluation, the following are the results of actions set forth above:

In student election on 4/18/69 at IU, over 8,000 students cast votes for the office of student body president of IU. Of these, [redacted] received [redacted] votes.

Starting on 4/23/69, the IU student government began student agitation against fee increases at IU, which activity has continued to the present date. Legitimate student government leaders started this protest against a 67 per cent increase in student tuition for in-state students at IU during the current year to become effective in September, 1969. Meetings and demonstrations during this agitation brought crowds of interested students numbering up to 8,000. For lack of experience, the majority of these demonstrations and subsequent negotiating sessions with the administration were taken over and dominated by New Left leaders. All available sources, however, advised that the New Left leaders were ineffective in maintaining the momentum of the demonstrations, regardless of the popular general issue, due to the lack of organization of their groups. The New Left leaders were forced to act individually and still internal dissension kept them from any close continued coalition. The SDS, IU-CEWV and YSA could not function effectively on an organizational basis in this activity. It is felt that this fact is directly attributable to the organizational disruption, internal dissension, and adverse publicity regarding these organizations and individuals.

As a result of this, no serious incidents of violence were attributed to the white students or New Left organizations during the three and one-half weeks of student agitation. The

only two incidents of violence in which the perpetrators could be identified during this period of agitation were caused by an organized group of black students who refused cooperation and assistance of the white students. At one meeting of black students, minor damage inside Ballantine Hall and one broken main door was effected. As the black students dispersed, a small incendiary device caused a fire in the doorway of a quonset building housing an honorary student group of the ROTC. This fire was extinguished before it could do major damage. The other incident occurred on the night of May 8, 1969 when a large group of black students broke into a negotiating session between administrators, faculty members and white students, and held them all prisoners for a period of about four hours. This incident was perpetrated entirely by black students without assistance of white students or New Left leaders, and is currently being investigated by the Monroe County Grand Jury.

Sources currently advise that the SDS at IU and the IU-CEWV are organizationally defunct and ineffective. [redacted] and [redacted] leaders of the [redacted] have indicated that they will leave [redacted] the end of this [redacted] and do not expect to return. Current moves are under way by the office of the Dean of Students to place on probation some of the New Left leaders at IU. As a result of this, several are not expected to return in the fall.

It is believed that the program undertaken during the past academic year at IU in this regard has been extremely successful and has made the New Left movement very ineffective.

Since the current semester is about to end and little activity is expected during the summer session, the Indianapolis Division is making the following recommendation concerning IU, Bloomington, Indiana, in relation to this program:

No further issues of "Armageddon News" are being recommended at this time. It is felt that the appropriate audience and the need is insufficient at this time. If any of these New Left organizations give indications of reorganizing in the fall of 1969, further recommendations will be made concerning the "Armageddon News" at that time.

In relet to Bureau, it is recommended that no further issues of the "Armageddon News" be issued. It was felt that appropriate audience and the need were insufficient at this time. It was also set forth that if any of the New Left organizations give any indications of reorganizing in the Fall of 1969, further recommendations would be made concerning "Armageddon News" at that time. It was further pointed out that the New Left situation would be followed closely through appropriate sources relative to possible disruptive situation at Indiana University during the Fall semester of 1969.

At this time, the New Left situation is being followed closely through appropriate sources, and no further issues of "Armageddon News" are being recommended at this time. It is felt that an appropriate audience and the need are insufficient at this time in view of the fact that information received from appropriate sources indicates that none of the New Left organizations has officially reorganized during the Fall semester of 1969. The only organization that has official officers is the Young Socialist Alliance (YSA) and they have only five members and their activity has been kept to the minimum.

If any New Left organizations give indications of reorganizing and developing possible disruptive actions during this Fall semester of 1969, further recommendations will be made concerning the "Armageddon News" at that time. If it is felt that captioned program should be reinstituted at Indiana University, the Bureau will be advised.

In relet it was recommended that no further issues of the "Armageddon News" be issued for it was felt that appropriate audience and the need were insufficient at the time. It was also set forth that if any of the New Left gave any indications of reorganizing in the fall of 1969, further recommendations would be made concerning the "Armageddon News".

At this time the New Left situation is being followed closely through appropriate sources, and the information received indicates that none of the New Left organizations has officially reorganized during the current semester. The only organizations that have official officers are the Young Socialist Alliance (YSA), which has only seven members; and the Students Mobilization Committee (SMC) which has twenty-five members; and the activities of these organizations have been kept to a minimum.

At the present time it is felt that the captioned program should not be reactivated and closed; however, if any New Left organizations give indications of reorganizing and develop possible disruptive actions during this current semester, further recommendations will be made as to reactivating the program.

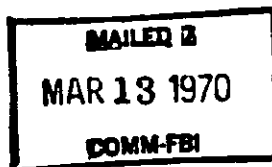

Captioned program has been under study by Indianapolis and it is noted that opportunities were not conducive on the college campuses of Indiana during the spring semester of 1970 for an appropriate and effective counterintelligence program.

Indianapolis is aware of the need to disrupt New Left organizations and activities on college campuses and agents handling such matters are continually directed to be alert for situations that can be used in this program.

At the present time, in accordance with Bureau instructions under the New Left-Violence investigation, Indianapolis is intensifying its efforts to identify individuals adhering to philosophies that advocate revolution now. It is expected that individuals under investigation in this intensification will be selectively interviewed under Bureau regulations and this will be one source of formulating an effective counterintelligence program on college campuses this fall when schools resume full schedules.

The Bureau will be appropriately informed for approval of any programs initiated by this division under captioned matter.

Indianapolis feels strongly that this is an excellent time for the Bureau to capitalize on feelings that PARKER is not serving the student body, but is furthering his own gains. It is also felt that this is an excellent time to begin a program to disenchant students toward any of the United Student Movement, Student Mobilization Committee, or Young Socialist Alliance movements on the Indiana University campus.

The enclosure was prepared with the idea to lessen PARKER's influence on the Indiana University campus and to lessen present or future effects of the Student Mobilization Committee. The enclosure is not meant to be an all inclusive program directed against the New Left as Indianapolis expects to continue with this or a similar program.

The enclosure was prepared as a throw away, or hand out, which appears to be one of the more common methods of reaching students on campus. The information set forth is not traceable to any sources of the Bureau and there is no such organization on campus known as the "Concerned Students at IU."

If the Bureau approves the distribution of the enclosed hand out, it would be mailed anonymously in packets of 25-50 to legitimate student organizations, fraternities, sororities, etc. to insure that the Bureau as source will be protected fully.

The Indianapolis Division feels also that it is imperative that if the hand out is to be effective it should appear on the Indiana University campus close to the expected time of PARKER's return (12-15-70) or at least before the Christmas recess.

Due to the appropriate time of this particular situation, the Bureau is not being requested to reprint the enclosure. It is suggested that the Indianapolis Office xerox 500 copies for distribution using commercial paper of various colors. The cost of such would be nominal.

Approval per above program is requested.

Re Indianapolis airtel to the Bureau dated 12-8-70 and Bureau airtel to Indianapolis dated 12-16-70.

Referenced communication concerned the anonymous distribution of a leaflet drawn up by the Indianapolis Division on the Indiana University (IU) campus, Bloomington, Indiana. The leaflet as approved by the Bureau was entitled "The Parker Cop Out, or More Aptly, No More Bull." The leaflet was primarily devised to take advantage of adverse feelings on the IU campus regarding the trip to North Viet Nam taken by KEITH STEPHEN PARKER (Bufile 157-17040, IP 157-2130). PARKER is presently the student body president at IU.

In addition, the leaflet was aimed at lessening any effects of the Student Mobilization Committee (SMC) on the campus and to discredit the United Student Movement which controls the student government at IU. Also the leaflet pointed out that the student government had access to student funds and had used the same to foster programs supported by the Black Panther Party (BPP) and New Left groups.

It is difficult to evaluate the effects of the leaflet distribution; however, Indianapolis feels strongly that the leaflet added to adverse feelings regarding PARKER. At the present time, PARKER's position as a student leader on the IU campus has greatly diminished to the point where he is in no real position to organize or lead. A large number of articles have been written discrediting PARKER and for the sake of brevity, these articles are not being set forth in this communication. The articles which point out dissatisfaction with PARKER as a leader and his trip to North Viet Nam have been incorporated in a current Indianapolis report dated 2-15-71 entitled "KEITH STEPHEN PARKER, RM - BPP," Bufile as set forth previously.

Following his trip to North Viet Nam, PARKER spoke to students at IU, Bloomington. His reception was far from enthusiastic. During the speech PARKER made direct reference to the Concerned Students at IU (Name devised for author of the leaflet distributed by mail). PARKER asked the students who called themselves the Concerned Students at IU to stand with no response. He mentioned that copies of the leaflet had been mailed to his parents and some acquaintances which had a derogatory effect on his character.

One of the more significant results of the reaction of the students to PARKER and the student government was the decision of the IU Board of Trustees, on 1-22-71, to abolish the fifty cent mandatory semester fee by students for support of the student government at IU.

In an article that appeared in the 1-22-71 issue of the "Daily Herald Tribune," published at Bloomington, Indiana, the following excerpts of interest appeared:

"Freedom to hear all lawful viewpoints on the Indiana University Campus became an issue this morning when the IU Board of Trustees abolished the fifty cent mandatory student government fee."

"The hassle developed when some trustees indicated displeasure with student government fees being used to help finance controversial activities such as the San Francisco Mime Troupe, Bobby Seale Weekend and the Liberation Movement Weekend."

"The abolishment of student government fees applies only to the Bloomington campus where the administration is directed to scrutinize all extra-curricular activities of the campus and recommend means whereby the most significant and meaningful programs can be continued."

It is noted that copies of the leaflet were mailed anonymously to members of the IU Board of Trustees. Indianapolis feels that this decision on the part of the Trustees deprives the United Student Movement who control the student government at IU, free access to funds, and lessens their ability to control programs fitting their purposes.

The Indianapolis Division is currently evaluating the strength of the SMC and the Young Socialist Alliance at IU in an effort to determine a program that would cause disruption among the groups. The Bureau will be requested to approve any program that Indianapolis develops.
