He stated in view of this and other information he had received about this individuals, he had placed them both in a probationary status which would prevent them from getting any annual increments until he removes them from their probationary status. He stated both have contracts and tenure with the University of South Alabama, making it extremely difficult to discharge them as it would be necessary to have a quasi public hearing and they would have to be confronted with their accusers.

He stated that he has learned that both are seeking other positions and both will leave the University of South Alabama in the reasonably near future.

The above is furnished the Bureau for its information in this program and this matter will be followed and the Bureau advised.

The Bureau concurs with your suggestion that South Alabama, be informed of the fact that two instructors at the University of South Alabama are supporting "Rearguard," an underground newspaper, and have given financial assistance to "Rearguard." Due to the sensitive nature of this matter, however, this should not be done through direct contact with by Agent personnel of your office. Instead, you should prepare an anonymous letter to advising him of the above-mentioned activity of the two instructors. This letter should include a warning from the anonymous author that if the University of South Alabama does not persuade the instructors to cease their support of "Rearguard," the author will publicly expose their activities. Assure that necessary precautions are taken to protect the identity of the Bureau as the source of this letter.

Advise the Bureau of results obtained from this counterintelligence effort.

NOTE:

Mobile has advised that if two instructors at the University of South Alabama could be caused to withdraw their support from the underground newspaper, "Rearguard," that paper would cease publication. To achieve this, Mobile suggested that the University of South Alabama be confidentially advised of the activity of these two instructors. Due to the delicate nature of this matter, this should be handled by means of an anonymous letter to the contact With him. -Mobile is being instructed to handle thi accordingly. matter

The official campus newspaper of the University of South Alabama is the "VANGUARD." It is officially sanctioned and reflects the policy of the Student Government Association and to some extent the views of the administrators of the University of South Alabama.

A small group of loosely organized students have since May, 1970 published an "underground" type newspaper known as the "REARGUARD." Its editorial policy is left of center, anti-establishment and opposes the University administration. The circularization of the May, 1970 issue was estimated at approximately 4,000 copies. The current circularization is approximately 1.000 copies.

A PSI of the Mobile Office has advised that two instructors at the University of South Alabama, and have been influential in the production of this paper and have assisted financially to its support.

Mobile feels that if these two individuals could be caused to withdraw their support from the "REARGUARD" it would fold and cease publication. This would eliminate what voice the New Left has in the Mobile area.

For this reason, Mobile suggests that information concerning the association of and and with the "REARGUARD" be confidentially furnished to University of Scutt.
