

Bureau appreciates your efforts under the Counterintelligence Program. However, Kewark should consider something different from the suggested item submitted in referenced airtel. Your submission by airtel captioned "Counterintelligence Program, Black Entionalist - Hate Groups, Racial Intelligence, Black Panther: Party (RPP), " is quite similar and more applicable for use in the RPP Counterintelligence Program. Bureau airtel 10/20/70 approved Kewark's proposal set out in Ministel 10/13/70.

Mewark report dated 9/18/70 captioned "Students for a Democratic Society, IS - SDS; Sedition" stated that no SDS activity is reported in the Newark, New Jersey, area. Bureau appreciates your efforts under the Counterintelligence Program. However, Newark should consider momething different from the suggested item submitted in referenced mirtel. Your submission by airtel captioned "Counterintelligence Program, Black Nationalist - Hate Groups, Racial Intelligence, Black Panther Party (BPP)," is quite similar and more applicable for use in the BPP Counterintelligence Program. Newark report dated 9/18/70 captioned "Students for a Democratic Society, 15 - SDS; Sedition" stated that an SDS activity is reported in the Newark, New Jersey, area. NOTE:

During the past academic year, Steven's Institute of Technology was the scene of a sit-in by a small group which agitated for a pass-fail examination system and a full time draft counselor. This engineering school has not been politically oriented in the past. Newark suggests that the President might be encouraged to take a strong stand against this type of activity if he was to receive copies of the above document which analyzes the riots that occurred in Columbia in April, 1968. The article points out how a small group of dissident Students for a Democratic Society (SDS) students was able to totally paralyze a great university. As it may help to strengthen the President's stand and since the Bureau will not be identified, it is being approved.

It is proposed, with Bureau approval, to send to President JESS H. DAVIS of Steven's Institute of Technology (SIT), Hoboken, NJ, five copies of BARRON's reprint, "Campus or Battleground? Columbia Is A Warning to All American Universities". This proposal is made in view of the recent sit—in at SIT by a very small minority of students, 10 out of 1300 undergraduates, who agitated for a pass-fail examination system and a full-time, SIT paid, draft counselor on campus.

SIT is one of the foremost engineering schools in the country and, although there is no SDS Chapter there or SDS activity noted, perhaps the reprint will alert the officials there as to what could happen at SIT if such a situation as the sit-in is given some headway.

Newark proposes writing in red ink across the top reprint the phrase, "It begins with 10 like a deadly spore and soon the whole campus is infected with an incurable affliction. Don't give in to a vocal minority that wants agitation for agitation sake".

The reprints will be mailed from Union City, N.J., which borders Hoboken, N.J., in a plain, commercially available envelope purchased in an office supply store, holographically addressed by an Agent of the Newark Office.

All precautionary measures will be taken to prevent identification of the FBI as the source of the articles.

College, Jersey City, N.J., which had SDS chapter last semester, unaware of Weatherman statement. Newark of belief same may be true in other local colleges, therefore, consideration for local mailing only.

Newark believed Weatherman statement contained enough information to depict the SDS as a dangerous on-campus element and would form the basis for a cooperative atmosphere with college officials who might be somewhat reluctant, under ordinary circumstances, to furnish names and/or other information pertaining to SDS members.

I. POTENTIAL COUNTERINTELLIGENCE ACTION

When conditions dictate, Newark plans to mail copies of BARRON's reprint, "Campus or Battleground? Columbia is a Warning to All American Universities", to university officials and/or leaders of on-campus anti-"new left" organizations.

Newark also contemplates mailing reproductions of the "Weatherman Statement" contained in the 6/18/69 issue of "New Left Notes", to college officials in this area, both to alert them and to forewarn them of SDS intenarea, and also to lay the groundwork for the TOPREV Program where necessary.

II. PENDING COUNTERINTELLIGENCE ACTION

Newark, on 9/19/69, mailed the anonymous communication to purportedly from the Students for a Democratic Society, denouncing and ridiculing the Black Panther Party.

Before the document is printed you should advise specifically the use that would be made of this document in relation to the TOPREV program.

If, however, you feel that college administrators in your area are unaware of the nature of this material or of its existence, you may prepare copies for anonymous distribution. In so doing you should take all steps necessary to protect the identity of the Bureau as their source.

NK noted that this paper is being distributed by hippies inside the buildings at Rutgers University, Newark. It is to be noted that student agitation at Rutgers University has given rise to considerable concern on the part of the State Legislature. NK suggests that this paper be transmitted by an anonymous letter to State Senator William T. Hierings who is the Chairman of the Senate Education Committee. The letter swould purportedly be from a concerned student who is offended by the obscenities being distributed at the state institution. At NK's request, the newspaper is being returned for use in this mailing.

It surpasses greatly the experimental literature distributed to the English classes at Paterson State College.







And does mouthing fragments of 19th-century ideology (Marx, Bakunin) really liberate? And is not Marcuse 40 years "older than 30," your cutoff on credibility? Incidentally, would you trust your life to a surgeon under 30-who never finished medical school?

Your irrationality makes me wonder how you were ever admitted into Columbia. You confuse rhetoric with reasoning. Assertions are not facts. Passion is no substitute for knowledge. Slogans are not solutions. Your idealism takes no brains. And when you dismiss our differences with contempt, you become contemptible.

POTENTIAL COUNTERINTELLIGENCE ACTION

Specific recommendations have been made for the distribution of a pamphlet depicting certain SDS members at Princeton University as resembling apes. It is anticipated the pamphlets will be sent to and circulated by, pro-American, anti-SDS individuals who will welcome the opportunity to ridicule these SDS members.

II. PENDING COUNTERINTELLIGENCE ACTION

Copies of an article appearing in "Barron's" Magazine, regarding the SDS uprising at Columbia University in 4/68, furnished by the Bureau, 7/29/68, were mailed anonymously to three of the Deans and the President of Rutgers University on 8/5/68.

III. TANGIBLE RESULTS

449698-31-12. "The Star Ledger" a local daily morning newspaper, issue dated 9/18/68 announced that Rutgers University policy on student demonstrations warn of immediate suspension and possible arrest. Another element of the policy adopted by Rutgers indicates that those involved in such disruptions who are not members of the academic community will be dealt with by off-campus authorities. The "Barron's" article makes note that several hundred sympathizers, including many outsiders swelled the SDS ranks at Columbia.

The attitude taken by Rutgers is similar to the proposal in the Barron's article; prging colleges to refrain from giving sanctuary to any group which advocates the initiation of physical force and that the college act mmediately and without hesitation to expel and criminally 100 FOR (94 5)

Reairtel states that 120 copies of the previously prepared pamphlets regarding the SDS at Princeton University would be sent to conservative, who would be expected to distribute them at a Conservative Club meeting scheduled 9/27/68.

It is felt that some of these pamphlets may be sent to with a handwritten anonymous note requesting her to distribute them at the Conservative Club meeting. It is not felt that a number as large as 120 should be used in this manner. It would appear that 50 would be more realistic.

It is further noted that reairtel mentions nothing of distributing the pamphlets to the various eating and debating clubs on campus. You should consider sending some of these to the above organizations as well as to other professional: societies at Princeton. Of course, all distribution should be sent anonymously with all measures being taken to protect the Bureau as their source.

On Newark's suggestion we have previously prepared a pamphlet which casts SDS in a derogatory light. The pamphlet depicts certain Princeton SDS leaders as apes. Newark has suggested that of the 150 pamphlets supplied 120 of these be sent to an outspoken conservative who would be expected to distribute them at a Conservative Club meeting at Princeton University. While the Conservative Club may make use of this among conservative people, it is felt that a greater distribution should be made of the pamphlet so that a broader cross section of the student body at Princeton will receive it.

Protesters risk Rutgers wrath

By ROBERT J. BRAUN

The Rutgers University policy on student demonstrations, a stern statement complete with warnings of immediate suspension and possible arrest, has been circulated throughout the school for "modification or endorsement," it was learned yesterday.

The distribution of the statement, generally considered more militant than previous pronouncements on student disorders, is expected to unleash a strong debate on all three major campuses of the sprawling state school.

The new policy proposal, while retaining elements of

a conciliatory policy statement released last November, warns that student failure to heed a request to cease a "disruptive" demonstration may "compound the offense and reduce the university's ability to resolve the problem internally."

In addition, the document warns that a student "could be" subjected to immediate suspension if he fails to comply with a request to stop the demonstration. The suspension would then be "subject to subsequent review."

In the past, Rutgers University disciplinarians rarely, if ever, suspended a student without a hearing by a

judicial committee made up of faculty members, students and administrators.

The apparent rationale behind the new suspension policy is reflected in another element of the new policy proposal which indicates "those involved in such disruptions who are not members of the academic community will be dealt with by off-campus authorities."

The logic goes that those students who have been suspended without a hearing can no longer be considered members of the academic community and then the local police can be asked to deal with them.

Theoretically, this means that if Rutgers stduents attempt a Columbia-like takeover of key buildings, they could be suspended immediately and subject to arrest for being trespassers.

In past practice, however, Rutgers deans have shown some patience in dealing with campus dissenters. When a group of students closed the Army Reserve Officer Training Corps headquarters last year, the Rutgers deans allowed them to hold the

building for three days until a hearing could be convened. All the students left their barricades in time to attend the hearing.

TIGHTENING UP

The new suspension-without-hearing policy, however, may be a sign of administrators' collective patience may not be so apparent in future disorders.

Although students have not yet been given the new policy statement, a few students who were told about it reacted negatively.

"It's too bad about that," one Rutgers student said. "Rutgers had a chance to show it wasn't like Columbia. They didn't have to greet returning students with that kind of policy."

Another Rutgers student expressed the feeling "the policy would not be necessary."

"There is a lack of issues on this campus. We do not even have the Institute for Defense Analysis," he said. The institute, or the IDA, is a nation-wide consortium of universities which provices specialists for government communications research. The IDA includes researchers at Princeton

and Columbia Universities.

What may be the most important aspect of the new policy is that it stipulates it could be modified by students. Such a channel for modification is not explicitly described in the statement although university Dean of Affairs Earle W. Clifford said he wants "student input of opinion on the new policy."

"We're going to want meaningful student involvement in determining this kind of polley. We do not want to have some student or group of students saying we issued a policy without their approval."

The dean further indicated that if students are given the chance to express themselves, "we will have made this university the kind of academic community which doesn't need student disruptions."

There are some Indications that the university will hold itself ready to back down from such a militant stance if the students reject it too strongly — just to show the students they do, in fact, have some voice in the regulations under which they must live.

Likewise, on other campuses throughout the state where there has been no New Left activity but where possibility exists that it might occur, Newark is also making specific assignments to review our coverage at these institutions so this office will be aware of the emergence of any New Left activity.

Newark maintains constant liaison with military intelligence groups in this area, and the suggestion of the Bureau relative to obtaining the names of military intelligence personnel recently or about to be discharged is being discussed with the various agencies looking towards the development of coverage either in this or other areas of the country. (U)

The military agencies in this area have indicated that while some of their personnel do attend college classes most personnel do find it difficult due to the uncertainty of their assignments. The military agencies advised that they will re-emphasize to any personnel attending classes that they should be alert to observe any activity and report any information coming to their attention while attending





3. Summary of Campus Disruptive Activities

The first confidential source mentioned advised on June 12, 1968 that on October-23, 1967 about 40 persons, representing the SDS chapter at Princeton University, caused the entrance to the Institute For Defense Analysis (IDA), Princeton, New Jersey, to be blocked. IDA is located adjacent to the Princeton Campus and the SDS chapter was objecting to its presence on the campus. Because the group would not disperse, it was necessary for the Princeton Police to physically remove 31 demonstrators who were charged with being disorderly persons. Both Seaton and Tarlau were in this group.

The above source also added on June 12, 1968 that the SDS chapter also participated in the picketing of job interviews by a representative of Dow Chemical Company, who was interviewing prospective employees for the company. This demonstration was orderly and no incidents occurred.

The first source also advised on June 12, 1968 that in early May, 1968 a march, sponsored by SDS on Massau Hall, Princeton University, took place. The purpose of this demonstration was to protest the school administration's inactivity on student demands. There were no incidents.



The first source stated that other than the arrests in October, 1967, there has been no violence or campus disruptive activities. This source added that there is no known outside influence on the SDS chapter and that SDS is viewed upon by most of the faculty at Princeton as a necessary evil.

In addition, SDS sponsored a march on Morven, the New Jersey governor's mansion, in April, 1968 to protest the shooting of a Negro youth in Trenton, New Jersey in rioting following the death of Martin Luther King. ("Newark Sunday News," June 23, 1968).



"One cannot help but shed a tear and feel that tugging at the heartstrings for the poor students who have joined in campus rebellions and now face revocation of state scholarships they may hold. These 'hippie' characters never had it so good yet they perform like a bunch of dimwitted idiots.

"We only have to see what was done at Columbia and earlier at Berkeley and elsewhere where student long-hairs led protests along with pseudo-intellectual agitators to know that what the state legislature is in the process of doing is right. It's about time, as many have said, to put a halt to this.

It's about time a firm line were taken by the state legislature in this matter.

"Of course, all kinds of excuses can be made for the students who rebel, but it is their decision, not that of the State of New Jersey. They're old enough to know wrong from right -- and let's not forget about the phony 'causes' Now, let's put anyone who has a state scholarship on warning not to 'go off the deep end.'

At the present time there are three universities in the Newark area that have any type of a Student for a Democratic Society (SDS) organization. They are Princeton University, Princeton, New Jersey, with approximately 150 members and perhaps 200 sympathizers; St. Peter's College, Jersey City, New Jersey, with a membership of approximately 12 students and Rutgers University which has an undetermined membership.

At Princeton, according to "The Daily Princetonian" a daily student newspaper at Princeton University in an issue dated 5/6/68, SDS is an unrivaled political force on campus, committed to gaining converts to its particular ideology. The article notes that there is now a danger that student issues and student power concept will be identified with the SDS banner.

"The Star Ledger" a daily newspaper published in Newark, M.J., issue dated 5/3/68, estimates there are approximately 4,700 students in Princeton University.

Those leaving the DELLINGER home by care to get out to the highway - 1.2 miles away. DAVID DELLINGER drives a late model blue Renault. In the summer, when the foliage is heavy on the trees to cannot observe the DELLINGER home, but in the winter, he has relatively easy visual access to the DELLINGER home and its surroundings from his own residence. The has not observed meetings or large gatherings at the DELLINGER residence.

Gardner, N.J., advised that DELLINGER's mail is delivered out of the Hampton, N.J. Post Office; however, the DELLINGER residence is closer to the Glen Gardner Post Office. Mr.

They have used the Glen Gardner Post Office to purchase stamps and to mail letters. However, he has not seen DAVID DELLINGER since late in the summer of 1967, on a Saturday. Mr.

They have pointed out that the mail box in which the mail is placed for DELLINGER at R.D. 1, Hampton, is about one mile from his residence.

Clinton, N.J. advised on 6/3/68, that this covers Empton, N.J. he stated that while he knows of DAVID DRLLINGER because of his activities with respect to such matters as peace marches in Washington which receive national press coverage, he knows of no organized activity in regard to such matters being carried out by DELLINGER in the Hampton, N.J.

In view of the above, coverage of DELLINGER at his rural, week-end residence appears impractical, in that it could not be carried out under secure donditions and would not be productive in achieving desired objectives. It is the plan of the Newark Office to again review the bank account of as well as the toll charges to the telephone at the DELLINGER residence. Contact will be maintained with and with Post Office personnel at both Glen Gardner and Hampton, N.J. It is believed that leads with respect to intensified coverage of DAVID DELLINGER while he is in the Newark area, other than from the above sources, would emanate from the sources in New York City, where he is active. In either event, it appears that DAVID DELLINGER is not engaged in any organized activity in the Newark area.

As has been previously pointed out, the DELLINGER residence is in the Western part of New Jersey, about 12 miles from the Pennsylvania border and not within normal commuting range of the employment of DELLINGER in New York, a distance of approximately 75 miles from Hampton. Under these conditions, it is considered that DELLINGER would require a place to maintain personal accourtement in New York City and not merely a place to sleep.

While it is a fact that DELLINGER has a residence in Hampton, N.J., it is also a fact that his activities in which the Bureau has an interest, are based in New York, for example, Liberation Magazine, National Mobilization Committee to End the War in Vietnam, and the Pifth Avenue Vietnam Peace Parade Committee. Further, the bank accounts for these organizations, in which DELLINGER holds officership, are located in New York City. In addition, holds officership, are located in New York City. Since the subject is, in effect spending the major portion of his time in New York, it is recommended by Newark that the New York Office be made Office of Origin in this matter.

A recommendation for inclusion of DAVID MELLINGER on the Agitator Index is going forward by separate communication. In regard to recommendations of a conterintelligence nature, the following is noted:

The report on DAVID DELLINGER dated 4/30/68, at Mewark, enclosed two copies of details of the arrest of DAVID DELLINGER marked "Obscene". Page 23 of this report sets forth information with respect to the arrest of DAVID DELLINGER on 7/11/49, on a charge of disorderly conduct, Lewd Act in a subway station men's room with one DELLINGER was 34 years of age at the time, married, anithe father of two children. It is recommended that the part of the New York Daily News and a contact of the New York Office, be made aware of the existence of this record. While, unfortunately, standards of morality among some of the New Left movement are rejected as anachfonistic, it may serve as a deterrent to some otherwise naive youths to know of the perversion of the Pied Piper of Protesters for Peace.

Bureau letter of 5/10/68 instructed all offices to submit a detailed analysis of potential counterintelligence action against New Left organizations and Key Activists within their respective territories, together with specific recommendations and necessary facts on any proposed action. This letter also instructed that offices which have investigative responsibility for Key Activists should specifically comment in the initial letter to the Bureau regarding these individuals.

Your letter of 5/27/68 fails to provide the above information, consists primarily of general observations and indicates a negative attitude. It is also noted that this letter contains proposed action against Key Activist Thomas Emmett Hayden, now residing in Chicago, but makes no mention of David Dellinger, a Key Activist of your office. Specific comment on Dellinger should have been included as instructed.

The above-requested information should be submitted by return mail and conform to the instructions contained in Bureau letter of 5/10/68. It is imperative that this Counterintelligence Program be assigned to an experienced, imaginative Agent, and it is incumbent upon you to see that it receives the proper emphasis.

Because, first, the "new left" is difficult to actually define; and second, of the complete disregard by "new left" members for moral and social laws and social amenities. It is believed that the nonconformism in dress and speech, neglect of personal cleanliness, use of obscenities (printed and uttered), publicized sexual promiscuity, experimenting with and the use of drugs, filthy chothes, shaggy hair, wearing of sandals, beads, and unusual jewelry tend to negate any attempt to hold these people up to ridicule. The American press has been doing this with no apparent effect or curtailment of "new left" activities. These individuals are apparently getting strength and more brazen in their attempts to destroy American society. as noted in the takeover recently at Columbia University, New York City, and other universities in the U.S. It is believed therefore, that they must be destroyed or neutralized from the inside. Neutralize them in the same manner they are trying to destroy and neutralize the U.S. It is Newark's opinion that this can possibly be done in two ways:

1. The U.S. Government must be convinced, through the proper departments, that it must stop subsidizing its

own destruction. Each field office should acquire the names and backgrounds of all students of the new left", who have been arrested for the very type of activity we are now trying to curtail or halt. Any Government subsidization to these individuals should be stopped.

They must be taken out of the ranks of this predominantly college-age movement; separate them and diminish their power.

2. Certain key leaders must be chosen to become the object of a counterintelligence plot to identify them as government informants. It appears that this is the only thing that could cause these individuals concern; if some of their leaders turned out to be paid informers. Attacking their morals, disrespect for the law, or patriotic disdain will not impress their followers, as it would normally to other groups, so it must be by attacking them through their own principles and beliefs. Accuse them of selling out to "imperialistic menopoly capitalism".

THOMAS EMMETT HAYDEN KEY ACTIVIST, NEWARK DIVISION

Newark believes that it might be possible to attach the stigma of informant or Government "fink" to HAYDEN because of the apparent unlimited finances at his disposal, enabling him to take numerous trips in and out of the U.S., without any job or other means of financial support. Also, the ease with which he travels to communist countries, his reception there, the privileges afforded him, and his eventual return with no actual remonstrations by this Government.

Newark suggests that after HAYDEN visits a certain city or country, that a news release, datelined Washington, D.C., be prepared noting that "according to informed Government sources", etc., certain events happened in that certain city or country which would reflect back on HAYDEN through similarity of circumstances or events. It is suggested further that these news releases be collected and when several promising items are collected, they be turned over to a representative of a cooperative news media with a suggestion that a feature

writer be given the task of writing up a story pointing out the coincidences of HAYDEN's visits to certain cities and news stories emanating from Washington, D.C., pointing to HAYDEN as the source. The connection may be spotlighted by including certain sidelights or confidential bits of information which may only be known to HAYDEN and a Bureau source.

It is realized the above will take time, but in order for the plan to be effective, it must have a solid basis and a continual indictment.
