Synopsis: Captioned matter involves a typed and handwritten death threat letter targeting captioned victims.

Enclosures: WFO evidence, one (1) white envelope approximately 4" x 9 1/2"; two (2) sheets of white paper approximately 8 1/2" x 11", with typewritten and handwritten words. For FBI Los Angeles, one copy of the two page threat letter.

Details: For information of the Bureau, and FBI Los Angeles, on 6/22/98, ABC News [redacted] received via U.S. Mail, at the ABC News office in New York City, a partially typed, partially handwritten anonymous death threat. The envelope bore a 6/16/98 postmark from Santa Clarita, California. The letter also contains handwriting which mentions the other captioned victims. FBI, WFO was notified of captioned matter on 8/6/98.

The following investigation was conducted by FBI, WFO SA [redacted]

On 8/11/98, writer telephoned [redacted] Newsweek Corporate Headquarters [redacted] concerning written death threat from the "Army of God" which was sent to ABC News [redacted] which also lists as targets ABC employees [redacted] Cokie Roberts, [redacted] [redacted] (Newsweek, Washington, D.C. Bureau), and David Brinkley. [redacted] advised that Newsweek [redacted] had been advised of the death threat. [redacted] advised that the aforementioned death threat was received by ABC News, Washington Bureau, POC: [redacted] Manager of Security [redacted]

On 8/11/98, writer telephoned [redacted] at the Washington Bureau of ABC News, concerning the aforementioned threat. [redacted] advised that he was given the threat letter by ABC [redacted] who received it via Federal Express. Mr. [redacted] could not remember the exact date the letter was received, and he stated he would try and find the original and the envelope it was mailed in. To date, the ABC News reporters have not been advised of the threat made against them. [redacted] advised that he spoke with [redacted] Director of Security, CNN [redacted] in Atlanta, GA., who advised that he had a letter also from the "Army of God".

On 8/11/98, writer telephoned [redacted] Director of Security, CNN. [redacted] advised that he had one letter (non-threatening) from the "Army of God" and also a newspaper article about the "Army of God" and abortion clinic violence. [redacted] advised that he would send writer a fax copy of both the letter and the article for comparison with the aforementioned threat letter.

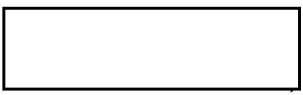

Results of Examinations:

Questioned print appearing on specimens Q2 and Q3 was prepared using an ink-jet print process. The ink-jet print process is available with numerous brand-name printers.

No watermarks, indented writing, or other physical characteristics which might provide information as to the origins of specimens Q1 through Q3 were observed during their examination.

If a subsequent search of the FBI Anonymous Letter File (ALF) results in positive findings, you will be advised in a separate report. Appropriate data will be added to the ALF for future reference.

Observations for Investigative Assistance

It is suggested that the following be considered if known, dictated writings are to be obtained for comparison with the Q1 and/or Q3 specimens: the writer should not be allowed to view questioned specimens prior to the exemplar being given. Upon completion of each exemplar it should be removed from view. Hand printing should be requested in upper and lower case letters, executed a number of times using a ball point pen, and dictated in the same wording on blank paper and envelopes similar to the questioned specimens.

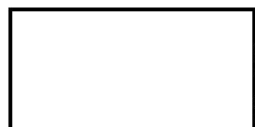
