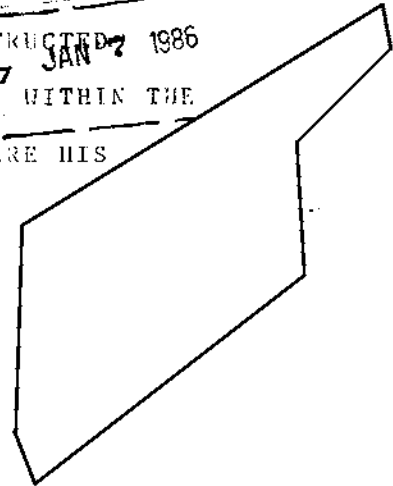
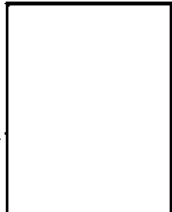

CLIENT WAS, HOWEVER HAD TELEPHONICALLY SPOKEN WITH HIS CLIENT AND HAD CONVINCED HIM TO SURRENDER TO THE FBI.

THE FOLLOWING CONVERSATION WITH [REDACTED] WPBRA, MADE INQUIRY OF NCIC AND DETERMINED THAT THE ONLY OUTSTANDING WARRANT FOR CROSBY WAS A WARRANT ISSUED BY THE DALLAS COUNTY SHERIFF OFFICE ON NOVEMBER 25, 1985, NCIC NUMBER 384869200, CHARGING CROSBY WITH FAILURE TO APPEAR RELATING TO CHARGES OF POSSESSING A CONTROLLED SUBSTANCE AND A HAND GUN. IN REFERENCED TELCALL TO DALLAS, SUPERVISOR [REDACTED] ADVISED THAT CROSBY HAD FAILED TO APPEAR IN LOCAL COURT IN DALLAS AND THAT A LOCAL WARRANT HAD BEEN ISSUED, HOWEVER TO DATE NO FEDERAL WFAP PROCESS HAD BEEN OBTAINED. [REDACTED] REQUESTED THAT HE BE KEPT APPRISED SHOULD CROSBY SURRENDER SO THAT APPROPRIATE LOCAL AUTHORITIES COULD BE NOTIFIED.

AT 3:42 P.M., CROSBY APPEARED AT THE WPBRA AND ADMITTED HIS IDENTITY AND STATED THAT HE WANTED TO SURRENDER TO THE CHARGES PENDING AGAINST HIM. IT WAS EXPLAINED TO CROSBY THAT AT THIS TIME ONLY LOCAL CHARGES WERE PENDING AND THAT NO FEDERAL WARRANT HAD BEEN ISSUED AS OF THIS DATE. IT WAS FURTHER EXPLAINED TO

CROSBY THAT HE WOULD BE RELEASED TO THE CUSTODY OF THE WEST PALM BEACH PD FOR TRANSPORTATION TO THE PALM BEACH COUNTY SHERIFF'S OFFICE (WPBSO) WHERE HE WOULD BE LOGGED IN THE LOCAL CHARGES AND AWAIT EXTRADITION TO TEXAS. PRIOR TO TRANSPORTATION COSBY WAS FINGERPRINTED AND PHOTOGRAPHED BY THE WPBRA AND BIOGRAPHICAL DATA WAS OBTAINED. AT TIME OF ARREST CROSBY APPEARED DISTRACTED, UNKEPT, AND ADMITTED A SEVERE HEROIN-COCAINE ADDICTION. CROSBY HAD "TRACK MARKS" ON BOTH ARMS AND REQUESTED MEDICAL ATTENTION FOLLOWING HIS ARREST.

WHEN CROSBY WAS RELEASED AT THE CUSTODY OF THE WEST PALM BEACH PD, THESE REQUESTS WERE RELAYED AND WEST PALM BEACH PD ADVISED THAT THEY WOULD ADVISE WPBSO RE COSBY'S DRUG ADDICTION AND MEDICAL REQUEST.

DALLAS AT DALLAS TEXAS: WILL NOTIFY APPROPRIATE LOCAL AUTHORITIES OF CROSBY'S ARREST AND THAT CROSBY WOULD BE LODGED AT THE PALM BEACH COUNTY SHERIFF'S OFFICE, WEST PALM BEACH, FL.

WILL NOTIFY MIAMI IF PRINTS AND PHOTOGRAPHS OF CROSBY ARE NEEDED BY LOCAL AUTHORITIES.
