HELENA IN AN ATTEMPT TO RAISE MONEY FOR ANTI-APARTHEID CAUSES.

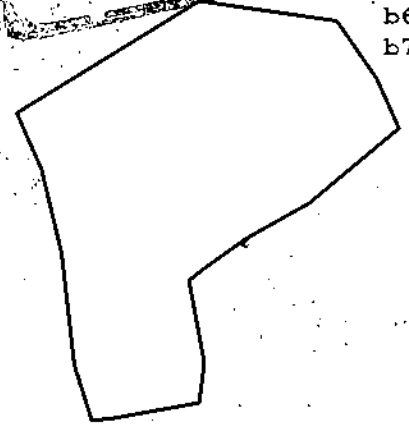
