[redacted] stated that the threat made reference to DAVID KORESH and that KORESH is "mad with you". She also made reference to the fact that KORESH is going to kill you or you are going to die. [redacted] informed the Washington Security Office, who suggested that the Federal Bureau of Investigation be contacted. [redacted] stated that only one threatening message had been received at their office.

After interviewing [redacted] it was determined that it would be impossible to identify the unknown female caller and that it was probably just a prank.

Administrative: At approximately 9:00 a.m., 06/10/2008, author was advised as to a possible threat to U.S. Congresswoman Louise M. Slaughter. Author subsequently contacted TFA [redacted] of the Buffalo Division's JTTF, who received initial complaint information. TFA [redacted] provided author with an overview of the nature of the threat, identified points of contact, and advised as to investigative steps taken.

Details: On 06/10/2008, author was advised as to an apparent threat to U.S. Congresswoman Louise M. Slaughter, 28th Congressional District of New York. Author subsequently completed an initial inquiry via interviews and review of the threatening information.

hook, the unidentified male could be heard continuing to loudly express himself. [redacted] additionally heard the caller say "you better...." prior to the call being disconnected. [redacted] stated that the voice sounded like a white male, approximately 30 to 40 years of age. [redacted] was unable to observe the caller's phone number on caller identification. On 06/10/2008, author telephonically contacted [redacted] Congressional Offices for LOUIS SLAUGHTER, at [redacted] confirmed the receipt and nature of the threatening FAX and the derogatory phone call. [redacted] stated that Congresswoman Slaughter was concerned about the reference threat. When asked by [redacted] if the Washington Police Department should be called, Congresswoman Slaughter requested that [redacted] contact the Federal Bureau of Investigation (FBI). [redacted] advised that Congresswoman Slaughter has given verbal authorization to subpoena any records that may support an investigation into the referenced threat.

[redacted] and [redacted] advised author that there have been no recently controversial pieces of legislation, nor were there any recent significant speeches/public affairs issues which would warrant the expectation of receiving the referenced threat.

FBINET/database checks for the referenced number resulted in no hits. Google search for "IslamONAZIS" resulted in 22,400 hits. [redacted]

Investigation has determined the sending FAX number to be a toll free FAX line.

In an interview conducted with Congresswoman Slaughter's Community Liaison official, [redacted] in the Niagara Falls office, it was revealed an individual named [redacted] had called their Washington office last week with an apparent issue with the Congresswoman's actions. [redacted] use of the word "treasonous" is common to that found in the threatening FAX. Additionally, [redacted] is the only caller in recent months whose call was derogatory/agitated in nature.

The following is a summary of the content of the initial call from [redacted] to the Washington office:

On the afternoon of 06/11/2008, Congresswoman Slaughter's Director of Congressional Offices, [redacted] advised author of [redacted] subsequent contact with their Washington office. The nature of the contact was conversational, as [redacted] was explained the actual facts and position of Congresswoman Slaughter's position on the matter. It was suggested by [redacted] that the matter was overheard on "The War Room with Quinn & Rose," a publically syndicated radio show broadcasted on XM/Satellite radio. [redacted] stated that [redacted] was skeptical since he had not received a response. However, [redacted] listened to the explanation and subsequently provided his contact information, as follows:

On 06/27/2008, Congresswoman LOUISE SLAUGHTER, was interviewed via telephone. After being advised as to the identity of the interviewing Agent and the nature of the interview, Congresswoman SLAUGHTER provided the following information:

Congresswoman SLAUGHTER was very concerned about the latest threatening FAX sent to her Niagara Falls Office. She was not so concerned for her own safety upon receipt of the first threatening FAX as it was not very direct in nature. However, Congresswoman SLAUGHTER was slightly concerned about the Speaker of the House, Congresswoman NANCY PELOSI, as she believed that the basis for the initial FAX was in reference to the Congressional trip to Syria that she and the Speaker took part in last year.

Congresswoman SLAUGHTER became very concerned for her own safety and welfare upon learning of the second threatening FAX. Congresswoman SLAUGHTER advised that she knew former Congressman TOM LANTOS very well and that he accompanied her and Speaker Pelosi to Syria last year. Due to her association with former Congressman TOM LANTOS, she was fully aware that he died earlier this year. Congresswoman SLAUGHTER explained that the statement in the second threatening FAX that TOM LANTOS is currently "being eaten by the earthworms" and that "LOUISE" is "not far behind," implied that she would be targeted. Congresswoman SLAUGHTER felt that this was a direct threat against her life.

[REDACTED] is not aware of any reason why the Congresswoman would be targeted this way and is not aware of any similar threats to Congresswoman Pelosi or others with similar views.


