NASA requested it be promptly notified of any information suggesting Puerto Rican Nationalist elements, or any other group or individuals, plan to interfere with or demonstrate against Cernan.

Target logical informants and sources to obtain information of pertinence concerning captioned matter. Keep FBIHQ apprised at all times and promptly submit information developed in form prepared for dissemination to NASA as well as to other interested agencies.
