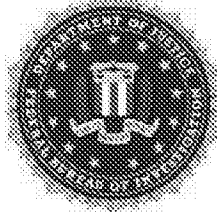

Resulting changes must then be approved by OTD's assistant director (AD) and the executive assistant director (EAD), Science and Technology Branch, as appropriate.

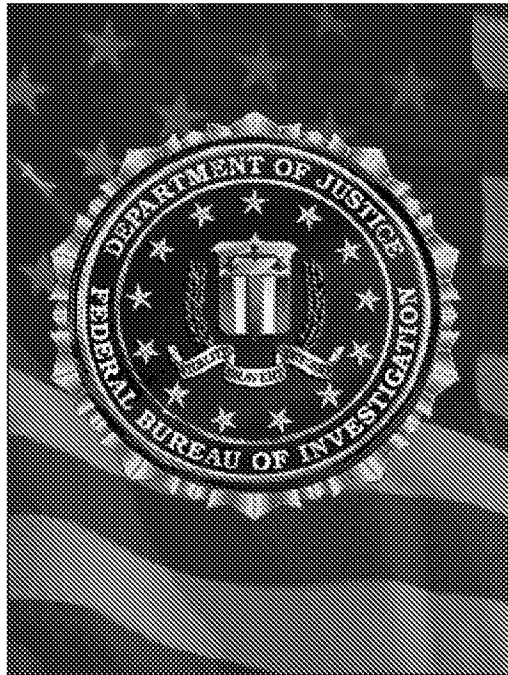
