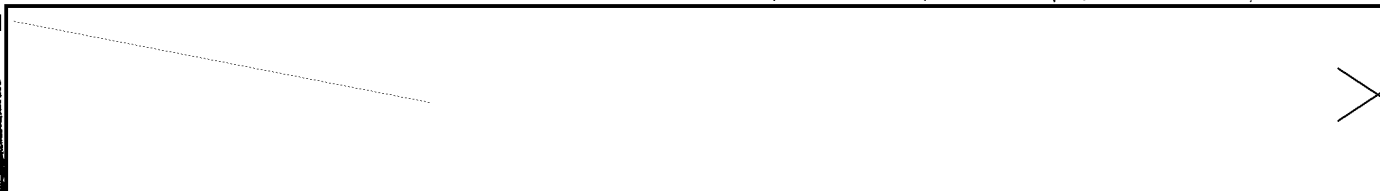

Re Los Angeles letter dated 1/12/53 concerning the possible plans for subject's return to the United States.

For consideration of the Bureau as regards the possibility of effecting subject's return to the United States, the following is set forth:

In the case of "Infiltration of the United Nations by Subversive American Citizens, IS - R" (Bufile 105-13893). AUSA, SDNY SILVIO MOLLO has requested information on any subversive Americans employed by the United Nations and it's specialized agencies. In this connection the Bureau may wish to furnish information concerning subject to AUSA MOLLO. Thereupon, AUSA MOLLO may wish to make arrangements to effect subject's return from Europe.



It is noted that subject is not a U.N. employee but rather an employee of a Specialized Agency which theoretically has autonomous being. However, it is known that [redacted] has asserted his influence in the past on these Specialized Agencies and in this matter may do so. RUC.

**SYNOPSIS OF FACTS:** T-1 advises subject not employee of State Department or any governmental agency. States subject presently a member of UNESCO Secretariat, Paris, France. Member of Department of Natural Sciences in UNESCO assigned to group entitled "Contributions to Scientific Research." T-1 [REDACTED] located Paris, France. Subject appointed to Natural Science Department of UNESCO [REDACTED] of T-2. [REDACTED] American Scientists at that time lacked confidence in subject. Prior to employment with UNESCO, alleged to have been scientific consultant of War Department in London. UNESCO staff frequently [REDACTED] Assistant to Legal Advisor of State Department does not believe extradition from France, under existing treaty, possible for violation of 18 USC, 1001.

Confidential Informant T-1 stated the November 1952 Telephone Directory for UNESCO, Paris, France, listed the subject as a member of the Natural Sciences Department of that organization, working in a division called "Contributions to Scientific Research".

Confidential Informant T-1 further advised that full and complete information, concerning the exact title of subject's position, his duties, places of employment, duties of employment and identities of superiors can be found in his personnel file located at UNESCO Headquarters in Paris, France.

Confidential Informant T-1 stated that at the time of the subject's appointment to UNESCO, [redacted] were pro-Russian, but shortly thereafter both attended a Communist-sponsored rally in Warsaw, Poland, [redacted] came back as an anti-Communist.

[redacted] argued constantly after this and finally in August of [redacted] his job with UNESCO. T-1 said it is his understanding that [redacted]

[redacted] identified previously, when questioned about [redacted] of [redacted] as a possible [redacted] commented that all the employees of the Natural Sciences Section seemed to share the same political orientation and are strongly [redacted] He added that [redacted] would have to change at least one-third of the personnel of the section and he did not know if [redacted] had the strength of character to do such a house-cleaning job. [redacted] at this time, said that MALINA was apparently doing good work [redacted] and was well liked by members of the Secretariat. He stated, however, he presumes MALINA's position is on the left since he was picked [redacted] but added he had no precise information on where MALINA stands. (S)

On November 18, 1947, [redacted] reflects that Confidential Informant T-2, previously identified, advised UNESCO concerning allegations made that MALINA was active in Communist Party affairs in California from 1938 to 1942. This is the same information already developed in this case. (S)

On April 22, 1948, [redacted] the UNESCO Secretariat in Paris, advised Confidential Informant T-2 that MALINA's [redacted]

(U) mentioned that MALINA was a Communist. After having seen these newspaper reports, [redacted] Head of the Department of Natural Sciences of the UNESCO, stated that he talked with the subject concerning the allegations and MALINA denied ever having been a member of the Communist Party, but stated he was working with [redacted] at the California Institute of Technology, and that, therefore, it may have been assumed that he was also a Communist. [redacted] further indicates that on October 16, 1950, after having received word that MALINA was to be assigned to technical assistance work for UNESCO, T-2 objected to his receiving such an assignment on the grounds that he was a security risk. To this, UNESCO Headquarters in Paris answered [redacted]

(U) [redacted], advised T-2 that every effort will be made in the future to undertake thorough preliminary consultation on high-level technical assistance appointments with the Governments of the nationals concerned, as well as reliable professional colleagues. (S)

On January 12, 1951, [redacted] shows that Confidential Informant T-2 was advised by its representative in Paris, that the technical assistance work, referred to above, [redacted]

(U) [redacted] however, was unwilling to accept the subject so the appointment was cancelled. At this time, assurance was given by [redacted] who is head of the Technical Assistance Division of the Natural Sciences Department of UNESCO, that the subject would not be appointed to any technical assistance position in the future. (S)

(U) On June 19, 1951, according to [redacted] [redacted] advised T-2 that MALINA has taken a firm anti-Communist stand but T-2 stated it did not believe it was sufficient to counteract information in the United States, and therefore, there was a very slight chance of MALINA's getting a new passport. The file shows that prior to this, on June 13, 1951, MALINA reported to [redacted] that renewal of his passport had been denied. (S)

In connection with persons falling in the latter category, the final discussion with [redacted] for UNESCO, was on September 29, 1952, and with [redacted] on October 3, 1952. In these conversations, assurance was given that MALINA's position would be abolished, but it was stated that this could not be effective until the end of June 1953. (S)

On November 4, 1952, the file shows that T-2 advised UNESCO that in light of [redacted] recent action at the UN Secretariat in New York, concerning disloyal U. S. nationals, there can be no further excuse for not terminating the employment of certain U. S. nationals over whose employment T-2 has expressed its displeasure on numerous occasions and some of whom were appointed over those objections. (S)

In this category of UNESCO employees, T-2 [redacted] FRANK J. MALINA, [redacted] T-2 warned that continued employment by these persons jeopardizes U. S. participation in UNESCO. T-2 further advised UNESCO that it will continue, on basis of sufficient advance notice, to advise on those U. S. nationals who should not be appointed. (S)

On November 6, 1952, according to [redacted] the Director General of UNESCO, advised T-2 that he felt he could not take the above action, which was requested by T-2, under existing staff regulations. (S)

Confidential Informant T-1 stated that while the Director General has the ultimate power to terminate an employee's contract, with UNESCO, [redacted]

(U) On January 28, 1953, the writer contacted [redacted] Assistant to the Legal Advisor of the State Department, and its expert on treaties. [redacted] was asked if the United States has a treaty with France, which is presently in existence and valid and which specifically contains extradition procedures of 18 USC 1001. (S)

(U) [redacted] advised that the extradition treaty of 1909 with France is still in existence and valid. He stated that Article 2, Item 9, lists Perjury and Subornation of Perjury as crimes for which a person can be extradited from France to the United States. He said that England has a similar treaty with the United States, but in the GERHARDT EISLER case, limited its interpretation of the crime of perjury under the treaty to false swearing in a judicial proceeding. (S)

(U) [redacted] said it is his opinion that the EISLER case would govern in a violation of Section 1001 and it is very unlikely that extradition would be possible. He stated that while France might give the crime of perjury, under the statute, a broader interpretation, he doubts this because of the notoriety of the EISLER case. (S)

(U) [redacted] advised that extradition, under 18 USC 1001, and similar statutes has not been attempted since the EISLER case. He stated, however, that it is the policy of the State Department not to request extradition of any person if there is more than a likelihood of it being refused. [redacted] (S)

(U) [redacted] stated that not knowing the facts of the case the agent had in mind, he could not make a positive statement, but that he is inclined to think that any extradition under 18 USC 1001 would be refused, using the EISLER case as a precedent. (S)

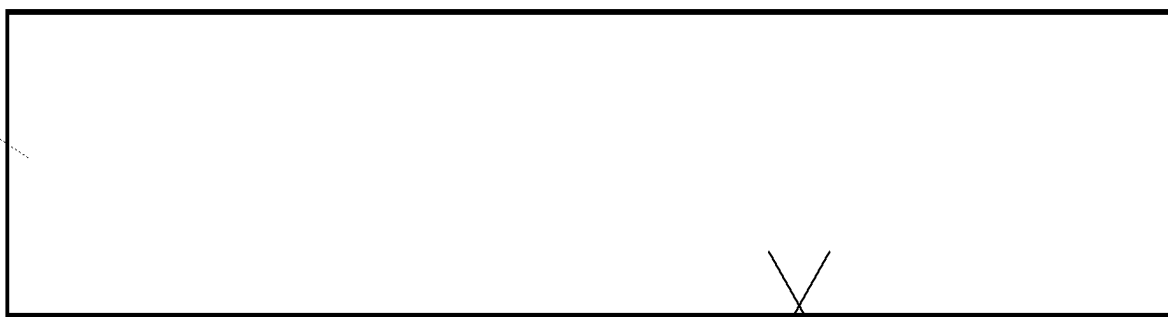

You are advised that [redacted]

[redacted] at Los Angeles, California, for a violation  
of 18 USC 1001. A warrant for his arrest was issued which  
is presently in the possession of the U.S. Marshall at Los  
Angeles, California.

Our recent investigation has, therefore, been  
directed toward ways and means of having the subject returned  
to the United States from Paris, France, for trial. In this  
connection, Assistant United States Attorney, Angus D.  
McEachen, Los Angeles, California, was contacted on January  
1953, at which time he stated that he had no plans, proposals  
or suggestions for the subject's return to the United States,  
and he had no plans for subsequent prosecution. McEachen  
stated that in the event Malina voluntarily returns to the  
United States the outstanding warrant would be served on him  
and the Department would then presumably proceed with  
prosecution.

[redacted] stated that the French Government has been very lenient in permitting Americans to remain in France without valid U.S. passports. The Department of State has attempted to have U.S. citizens who do not have valid passports returned to this country from France without success. [redacted] informed that although Malina can be requested to return to the United States, such a request would be of little value from a practical standpoint because the French will not cooperate if Malina does not desire to comply with the request. [redacted] further informed that since Malina is a native born U.S. citizen, his status as a citizen cannot be jeopardized by his continued residence outside the United States.

[redacted] next stated that the State Department has requested the United Nations Educational, Scientific and Cultural Organization in Paris to insist that Malina return to the United States in order that his passport status can be "cleared up." The American Ambassador at Paris replied to this request on January 10, 1953, to the effect that [redacted]

[redacted] believes he would be held responsible for any suggestion to Malina concerning Malina's passport status. [redacted] is of the opinion that he might be cast in a light that would seriously compromise his position as an International Civil Servant if Malina were arrested upon his return to the United States. [redacted] stands on the general position previously outlined by [redacted] on December 23, 1952, to the effect that action will promptly be taken by the United Nations in regard to United Nations employees if there is substantial evidence indicating subversive activities but administrative action cannot be arbitrarily taken on mere suspicions that are "devoid of due process."

We have also made inquiries at the U.S. Embassy in Paris, France, concerning the possibility of having the subject returned to the United States. In this connection, it was ascertained that the subject's passport was taken from him by the Embassy on June 4, 1951, and it still remains in custody of the Embassy. [redacted]

The Embassy reply to the State Department on November 6, 1952, also pointed out that the UNESCO contract of Malina's terminates on June 30, 1953.

Assistant U.S. Attorney Silvio Mollo has requested information on subversive Americans employed by the United Nations and its specialized agencies. We are furnishing Assistant U.S. Attorney Mollo with pertinent data concerning Malina.

Malina was the Chief of the Division of Contribution to Scientific Research which is one of the Natural Science Divisions [redacted]. His residence address is 89 Rue Erlanger, Paris 16, France. [redacted] who was formerly employed by UNESCO in Paris, France. On February 10, 1953, information was received that Malina had resigned his position with UNESCO.

In view of this, Malina may possibly return to the United States. In the event he does voluntarily return, it is our intention to cause his arrest at the earliest possible time.

In the event he does not voluntarily return to the United States, your comments and suggestions as to the possibility of instituting extradition proceedings under the 1909 Treaty with France will be appreciated.

[redacted] stated that the [redacted] was going to conduct some tests at the [redacted] California, and by all standards the director of the Jet Propulsion Lab should have been invited to attend. A clearance for MALINA was requested from the [redacted] Unit and according to [redacted] it was refused on the grounds that MALINA had been a member of the Communist Party in Southern California. [redacted] stated that the [redacted] whom he believed had his headquarters in Los Angeles, said that MALINA would not even be cleared to visit a [redacted] much less have access to classified material.

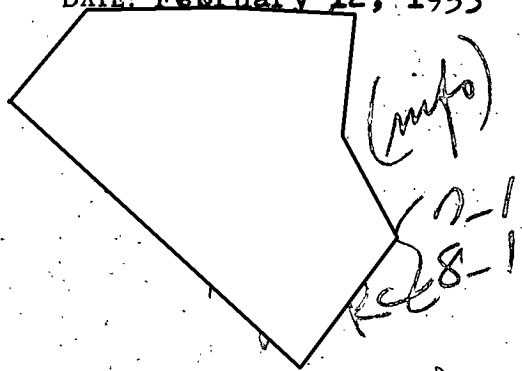

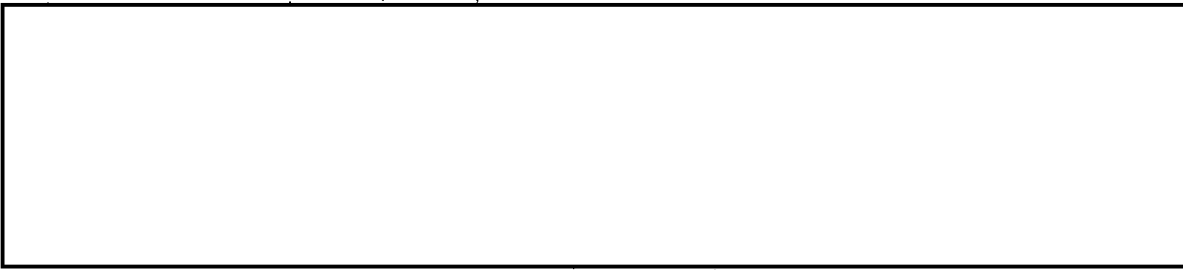

This should include Communist Party members who are known to have been in the same club or branch with the subject as well as Communist Party members not in the same club but in the Los Angeles area who might have knowledge of the subject's past Communist Party membership.

Bureau authority should, of course, be obtained prior to interviewing any present or former Communist Party member, and recommendations should be submitted to the Bureau if such interviews appear feasible. Subject was indicted on December 17, 1952, for failure to list former CP membership on a PSQ executed by him in 1944 and a warrant for his arrest was issued. On February 10, 1953, he resigned from UNESCO and he may now return to the United States. It is recommended that Bureau Agents cause his arrest if and when he enters the United States.

PURPOSE:

To recommend that the subject be arrested by Bureau Agents if and when he enters the United States.

DETAILS:

Frank Joseph Malina who was born October 2, 1912, in Brenham, Texas, received a Ph.D. Degree in Aeronautics from the California Institute of Technology in 1940. Thereafter, he was employed by the U. S. Army Air Force Jet Propulsion Research Project until 1946. Since 1947 he has been employed by UNESCO in Paris, France.

Our investigation of Malina reflected that he was a CP member in 1938-39 under the name Frank Parma. We have located copies of CP records

have secured signed statements from two former CP members indicating that Malina was also a CP member. We have also located a Personnel Security Questionnaire signed by Malina in 1944, upon which he failed to indicate that he was a former CP member.

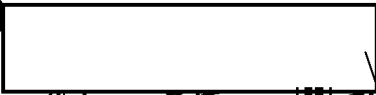

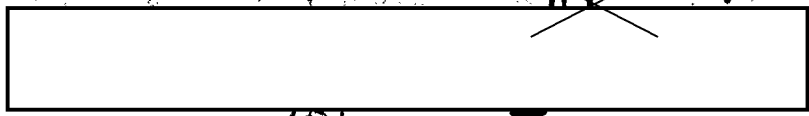

On August 7, 1952, the U. S. Attorney at Los Angeles, California, declined to prosecute the subject. We represented the case to the Criminal Division on September 12, 1952, and requested that the case be reconsidered with respect to prosecution. The Criminal Division agreed to prosecute and a [redacted] against the subject on [redacted] in Los Angeles, California, for a violation of 18 USC 1001. A warrant was issued for the subject's arrest which is presently in the possession of the U. S. Marshal at Los Angeles, California. [redacted]

Since the return of the indictment our investigation has been directed toward finding a means to bring Malina back to the United States from Paris to stand trial. [redacted] dated [redacted]

OBSERVATIONS:

Since the subject has resigned his position he may possibly return to the United States at any time. It is believed that we should take full credit for our investigative efforts and make the arrest if and when the subject returns to this country.

RECOMMENDATIONS:

If you agree, there is attached for your approval a letter directed to the Criminal Division of the Department informing of our recent investigation and of our intention to cause the subject's arrest if he enters the United States.

Also attached is a teletype to New York furnishing appropriate instructions in this matter, [redacted] to the Legat, Paris, France instructing that the Bureau should be immediately informed if subject leaves France.

SAC Letter #53-13 dated February 10, 1953, instructed all field offices to review pending cases in all classifications in order to locate instances where the office of the United States Attorney has delayed in rendering a prosecutive opinion or where prosecutive action has been delayed subsequent to indictment, issuance of an information or complaint. Separate sheets were to be prepared for each classification and the following information furnished:

- Complete title and character of case
- Bureau file number if known
- A brief resume of the delay on the part of the United States Attorney's office, and
- The reason for the delay, if known.

An original and three copies of each sheet were to be prepared.

Together with a copy of this memorandum each desk handling criminal violations is being furnished three copies of memoranda prepared by the field covering the classifications it handles. The original will be filed in the main 62- file maintained by the Bureau on the subject of "Relations With the United States Attorney's Office in Each District." Each desk should review the cases referred to in the memoranda and take such action as is necessary to bring the case to a logical conclusion at the earliest possible date. This will require writing to the Department in all instances where the delays on the part of the United States Attorney do not appear justified and consideration should be given to writing the Department in those cases where delays are apparent even though explained by reasons beyond the control of the United States Attorney. The field should be furnished with copies of any letters to the Department and all cases should be followed closely until closed.

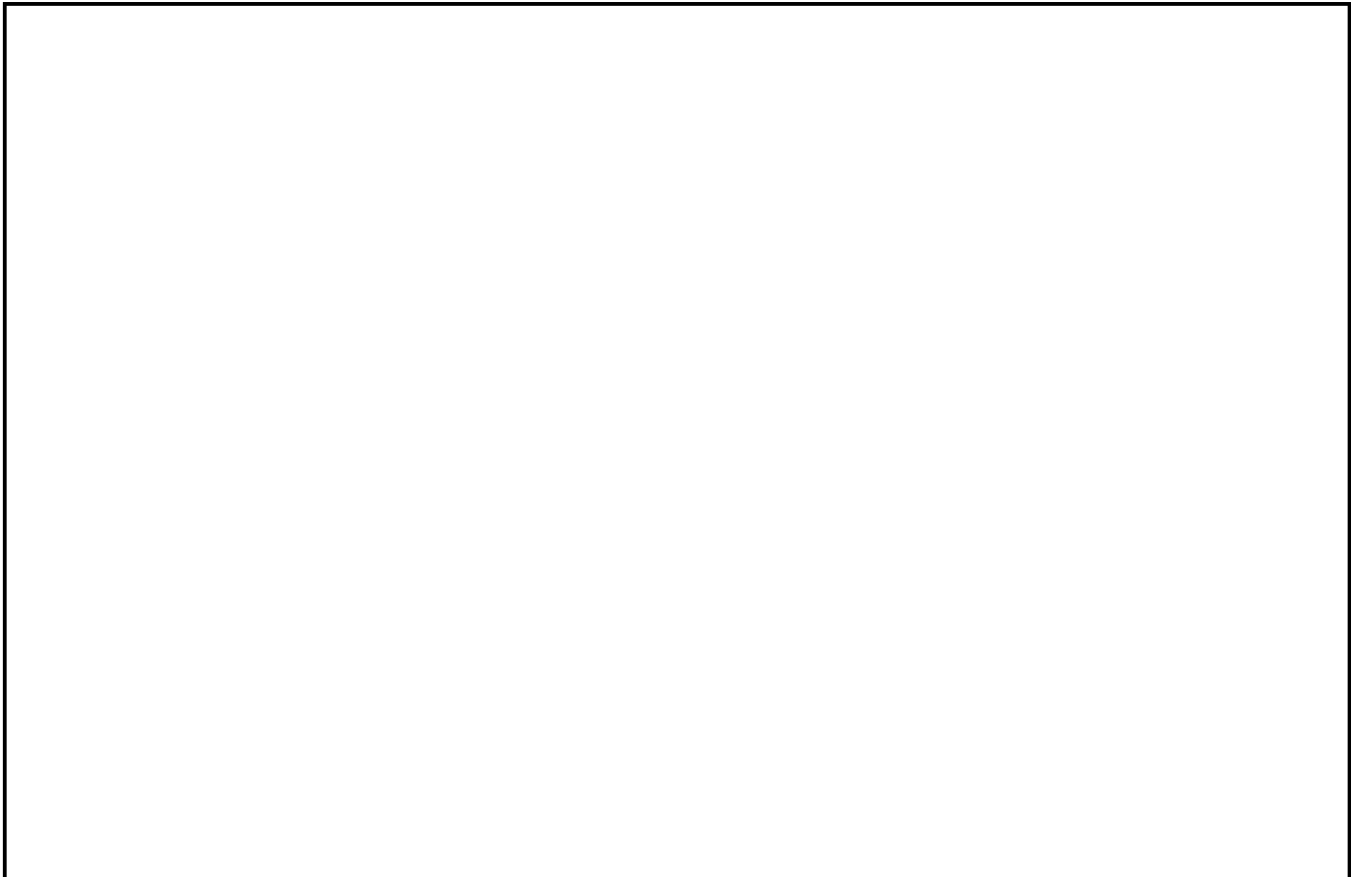

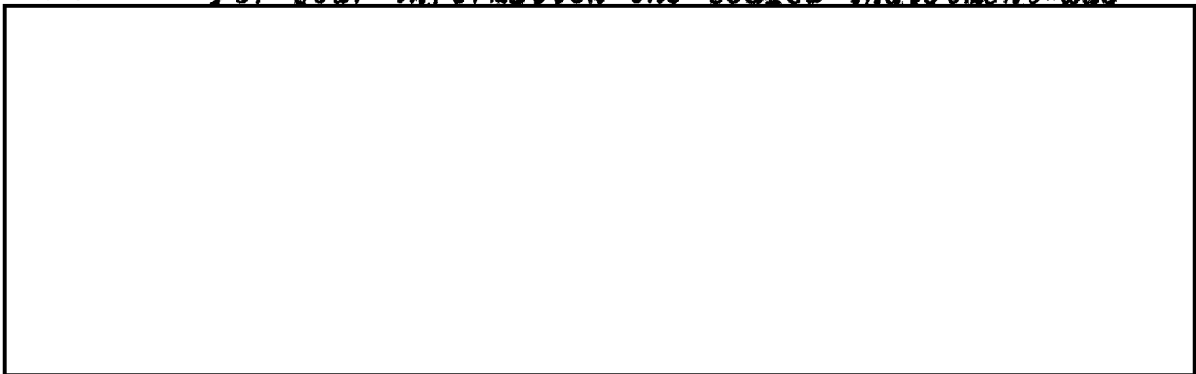

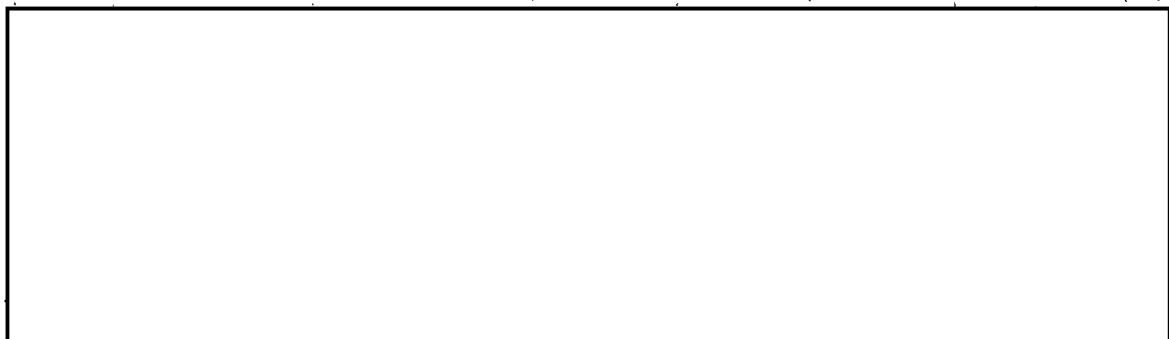

Reference is made to your memorandum of February 12, 1953, requesting my comments with respect to the possibility of instituting extradition proceedings against the subject under the 1909 Treaty with France.

It is noted that the Passport Office of the State Department has advised you that France has been very lenient in permitting Americans to remain there without valid United States passports. It is further noted that, although the subject can be requested to return to the United States since his passport has been taken from him, it is the considered opinion of the Passport Office that France would not cooperate should the subject be unwilling to comply with the request.

In view of these circumstances, it is concluded that extradition proceedings should not be instituted, since it is likely that France would refuse extradition under 18 U.S.C. 1001, using the Eisler case as a precedent. Should the subject learn of the indictment outstanding against him by reason of an unsuccessful attempt at extradition, there would be little likelihood of his returning to the United States voluntarily.

The files of this office, however, reflect the photostatic copy of a Passport application by MALINA dated April 11, 1949 which bears a photograph apparently identical with bearded photograph submitted. A photostatic copy of an undated Passport application apparently submitted in March, 1947 however bears a photograph apparently identical with the clean shaven photograph submitted. Later photographs of MALINA are not available at this time.

Reference is made to the memorandum dated March 4, 1953, from [redacted] to all Supervisors Handling Criminal Violations, entitled "Delays on the Part of United States Attorneys." Referenced memorandum referred to SAC Letter #53-13, dated February 10, 1953, which instructed the field to submit memoranda on all cases where the United States Attorney delayed rendering an opinion. Referenced memorandum directed that upon receipt of the memorandum from the field the delay should be brought to the attention of the Department.

This case was presented to the Criminal Division for an opinion as to possible prosecution on February 25, 1952. The Criminal Division referred the matter to the United States Attorney in Los Angeles and after periodic contacts with the U. S. Attorney he declined prosecution on August 7, 1952. On September 12, 1952, we requested the Criminal Division to reconsider the case. On September 25, 1952, the Criminal Division advised that the U. S. Attorney at Los Angeles had been requested to resubmit an opinion. On October 7, 1952, an additional witness was located and on October 9, 1952, the U. S. Attorney at Los Angeles advised he would authorize prosecution. The Criminal Division was appropriately informed [redacted]

[redacted] Subject is out of U.S., and trial date has not been set.

RECOMMENDATION:

Inasmuch as the Bureau has corresponded with the Department on a number of cases as above reported regarding prosecution of the subject, and inasmuch as the Department is well aware of the U. S. Attorney's delay in this case, it is recommended that the matter not be again called to the Department's attention.

[Redacted] Arizona, first knew FRANK JOSEPH MALINA during 1934-35, California Institute of Technology, Pasadena, California, and was an associate of MALINA during 1938-41 while working at the Jet Propulsion Laboratory, Pasadena, California. MALINA and associate [Redacted] endeavored to indoctrinate those employed and studying at Jet Propulsion Laboratory in Communist ideology. MALINA personally responsible for delaying progress of jet rocket by two years, according to [Redacted] aware of MALINA's Communist tendencies and beliefs but not in possession of actual proof of CP membership. [Redacted] not aware business meetings and social affairs held at home of MALINA, during 1939-41, Communist inspired. Former associates of MALINA [Redacted] forth.

DETAILS: AT TUCSON, ARIZONA

[Redacted] advised he first met FRANK JOSEPH MALINA while engaged in the study of jet rocket propulsion at the California Institute of Technology, Pasadena, California, during 1934-35. [Redacted] advised at that time MALINA was a student working directly under [Redacted] California Institute of Technology. In addition to being a student MALINA

[redacted] declared he personally was engaged as a research assistant in the aeronautical laboratory at California Institute of Technology as of 3-1-39. Their work was concerned primarily with the development of the rocket and funds were obtained through General HAP ARNOLD and the National Defense Research Council.

During late 1939 and early 1940 the California Institute of Technology built its first jet propulsion laboratory in Pasadena, California. Subject MALINA was the chief engineer at that time

MALINA worked directly [redacted] according to [redacted]

he was described by [redacted] as being an extremely good friend of MALINA.

[redacted] declared during the time he was acquainted with MALINA in the 1934-35 period, he found it extremely difficult to maintain harmonious relations with MALINA. He recalled MALINA was extremely theoretical whereas he [redacted] was practical. He never felt close or friendly towards MALINA advising they were natural-born enemies.

[redacted] declared he worked on the project engaged by the California Institute of Technology during 1934-36 at which time he relinquished his position with the jet propulsion laboratory again resuming his work during 1940-41. He recalled during this latter period one [redacted] of the Communist Party "among" the inner circle of the jet propulsion laboratory, joined their organization. He noted [redacted] was an extremely close associate of MALINA. Further, that [redacted] was the "key of Communist Party activity" and as a result probably had considerable influence on MALINA. [redacted] recalled there were a number of "bull sessions" among the inner circle of the jet propulsion laboratory regarding Communist Party ideologies. Further, that [redacted] and subject MALINA endeavored to indoctrinate those around them in Communist ideology. He declared on many occasions they attempted to indoctrinate him. [redacted] declared in 1940 he subscribed to the Daily Worker, a New York Communist publication, and was of the opinion he gave his subscription for the paper to MALINA who in turn furnished it to

[redacted] stated he attended several social affairs at the MALINA residence, 1288 Cordova Street, Pasadena, California, during 1939-41. Many of the meetings which he had at the MALINA residence were of a business nature and very little discussion, if any, was had concerning Communism and its activities. [redacted] recalled seeing a number of pamphlets, brochures, and miscellaneous literature around the MALINA residence which he felt were subversive in text but was unable to recall the names of any of the articles, magazines or pamphlets which he saw.

[redacted] recalled on or about 1938 or 1939 he was invited to the [redacted] home in Pasadena, California, on an afternoon which was apparently an indoctrination meeting. Those in attendance were as follows:

subject MALINA, and two or three unknown young men.

This residence, according to [redacted] was located north of the California Institute of Technology and about two or three blocks from the institute in the vicinity of Lake and Hill avenues. Insofar as [redacted] could recall, there were approximately eight persons in all at the "indoctrination meeting." [redacted] recalled he and [redacted] left the meeting prior to its actual beginning and prior to his leaving he "sounded off" on the subject of Communism indicating his distaste and disrespect for any Communist ideology which might be further put to him. He declared this undoubtedly served to dampen any further enthusiasm on the part of MALINA and [redacted] to indoctrinate him in Communist ideology or to further attempt to recruit him into any party activities and he was never again invited to attend any such meetings by either MALINA or [redacted]

[redacted] declared there is no doubt whatsoever in his mind that subject MALINA held up the progress of the jet rocket propulsion units by at least two years. He declared MALINA accomplished this by virtue of inserting numerous technical objections and requesting considerable unnecessary analyses which were completely unnecessary. Those individuals working on the project were unable to approach the problem from a practical point of view. [redacted] declared in his opinion there was entirely

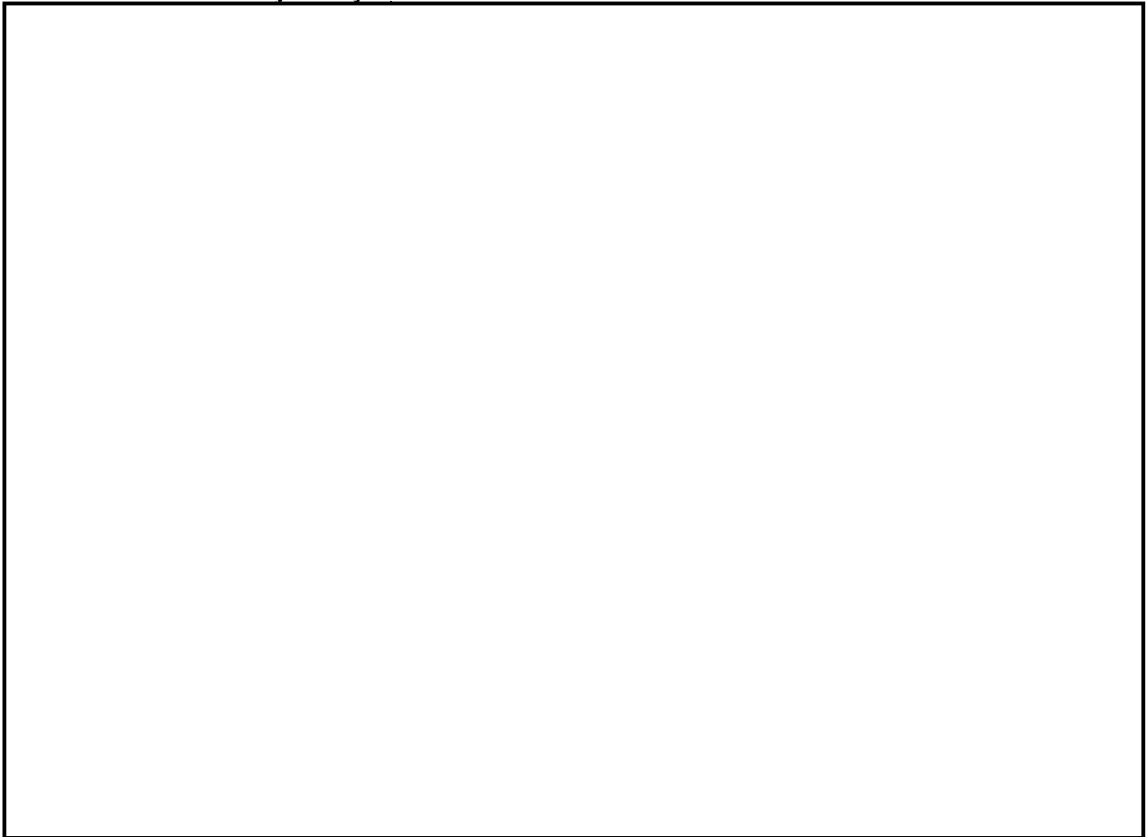

too much scientific analysis upon the part of MALINA which was in the end absolutely inconclusive.

[redacted] considered MALINA to be entirely sympathetic to the Communist cause but he had no direct positive evidence of party membership on the part of MALINA. He noted [redacted] sub-*ARIZONA* [redacted] was not nearly as sympathetic to Communist ideology as was MALINA. [redacted]

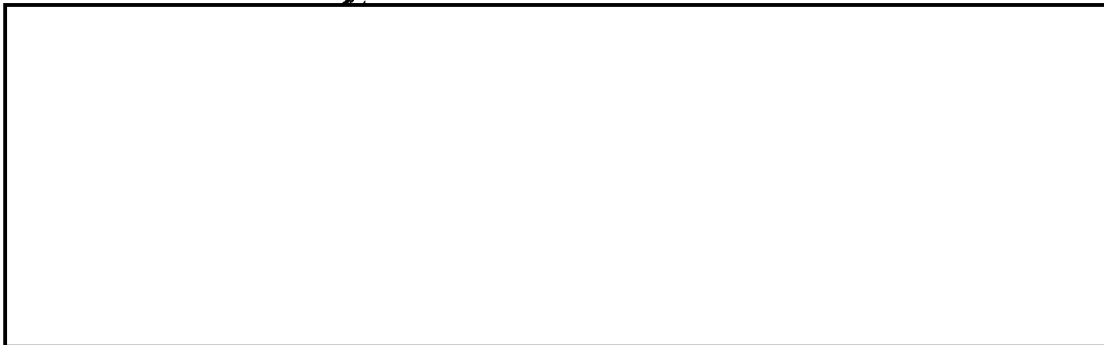
[redacted] declared he never attended any meeting at the MALINA home at 1288 Cordova Street which he regarded as entirely Communist in nature other than the meeting which occurred in the afternoon of the year 1938 which meeting was held at the home of [redacted] *ARIZONA* [redacted] advised [redacted] attended several meetings at the MALINA home for he had a natural curiosity for scientific and political theories.

[redacted] declared the following individuals were acquainted with and associates of FRANK MALINA and for that reason might possibly be able to furnish additional information concerning MALINA:

[redacted] is an American citizen who was interned during the war. He advised he knew of nothing which might reflect against the loyalty of [redacted] further, that [redacted] was an associate of MALINA during the jet propulsion laboratory days prior to the war.

[redacted] advised he last saw FRANK MALINA in 1949-50 approximately at New Years time at the home of [redacted] who was a former associate of MALINA's at the Aero-Jet Laboratory. MALINA at that time was affiliated with UNESCO.

The Communist Party has been cited by the Attorney General of the United States as being within the purview of Executive Order 9835.
