HULCHER COMPANY, INC. - VICTIM ANTI-RACKETEERING; LABOR MANAGEMENT RELATIONS ACT; OBSTRUCTION OF JUSTICE; CONSPIRACY This information was furnished to the Criminal Division which has requested that we contact the National Labor Relations Board (NLRB) Office at St. Louis, Missouri, concerning the outcome of action it is taking relative to this dispute. This will be done and results furnished to the Department for its determination as to whether or not violations of the Obstruction of Justice Statute or of the Anti-Racketeering Statute which prohibits use of violence to induce extortion / are involved. By way of background, the victim, M. L. Hulcher Company, Virden, Illinois, a water pipeline contractor, is involved in a dispute between the Pipefitters Union and the Common Laborers Union as to which has jurisdiction over unloading and stringing pipe. hourly rate paid to pipefitters is \$2.50 in excess of that paid to common laborers. 610 Memo to Mr. Belmont

He requested inquiry be made limited to a contact at the NLRB Office, St. Louis, concerning the outcome of its hearing, reasons it was given for withdrawal of the Common Laborers Union from the dispute and basis for subpoena issued to Upon receipt of results Mr. Petersen will make a determination as to whether or not there appears to be a violation of the Obstruction of Justice or Anti-Racketeering Statutes which would warrant investigation by the Bureau.

#### ACTION:
