The June 22, 1961 Rochester Times Union (City wide newspaper), carried an article "Young Man Accepted As Freedom Rider" which reflects Gordon L. Harris, 147 Summit Drive, Rochester, New York, was the first Rochester resident to be accepted for a mission as a Freedom Rider and was scheduled to leave that day. His acceptance came from the Congress of Racial Equality (CORE). *LA, 10155.*

The article read that Harris would first go to New York City for briefing; then to New Orleans, and from there to participate in a Freedom Ride into Jackson, Mississippi.

The article mentioned that Harris is a pacifist by conviction and believes in non-violent methods of achieving racial equality. He stated he was prepared for any eventuality in the South, even a long jail sentence.

Chief of Detectives M. B. Pierce, Police Department, Jackson, Mississippi, advised on June 25, 1961, that twenty Freedom Riders were arrested at the Illinois Central Railroad Depot, in Jackson, at 10:15 AM, June 25, 1961. He said the entire group had walked into the white waiting room and had refused to obey the orders of Captain [redacted] to move on. Captain [redacted] was the arresting officer and the entire group was charged with Breach of the Peace. There were no incidents in connection with the arrest, according to Chief Pierce.

Pierce said one of those arrested was [redacted] Rochester, New York, who was born [redacted] South Carolina. [redacted] indicated his occupation as a student at the University of Rochester; his marital status as [redacted] and his parents as [redacted]

Chief Pierce on June 26, 1961, said [redacted] along with other Freedom Riders, was tried in Jackson Municipal Court, Jackson, Mississippi, June 26, 1961, for violation of Section 2087.5 of the Mississippi Code. All entered pleas of guilty through their attorney.

All defendants were convicted and sentenced to four months in jail and fined \$200.00.

On July 3, 1961, Sheriff J. Robert Gilfoy, Hinds County, Jackson, Mississippi, advised that [redacted] with other convicted Freedom Riders, were transferred to the Mississippi State Prison, Parchman, Mississippi, July 3, 1961.

The August 7, 1961 edition of the Rochester Times Union reflects Gordon E. Harris, after serving 42 days of his four month sentence, was released from the State Penitentiary in Mississippi.

[redacted] Credit Bureau of Rochester, Inc., on September 14, 1961, did not locate a record identifiable with [redacted]

[redacted] Identification Division, Rochester Police Department, on September 14, 1961, said [redacted] and formerly of [redacted] and who was born [redacted] South Carolina, was arrested in Rochester, July 21, 1961, for [redacted] and March 14, 1957 for [redacted] said the [redacted] charge stemmed out of an arrest at 1:05 AM, at which time [redacted] was suspected of [redacted] in the middle of a parking lot at 575 Monroe Avenue in Rochester. [redacted] at the time, did not give a satisfactory explanation for deposit notation in a bank book in his possession and the fact that he was unemployed. The warrant was withdrawn and dismissed.

Captain [redacted] Rochester Police Department, on August 25, 1961, said that in connection with the arrest of [redacted] on March 14, 1957, [redacted] in the early hours of that day, was observed marching around a parking lot

on Monroe Avenue and [REDACTED] When asked what he was doing, he merely questioned as to what law he was breaking. When Captain [REDACTED] replied that it was odd that a person would be marching around at that time of the day [REDACTED] gave no reply. [REDACTED] said that inasmuch as no fires had been started in the area and because there was no explanation for [REDACTED] actions, he had no alternative other than to withdraw the complaint and recommend to the parents that [REDACTED] have a mental examination. [REDACTED] explained that [REDACTED] bank book contained notations of deposits, although unemployed, because of the fact that [REDACTED] parents did not live in harmony with him and therefore, at their suggestion, paid him a weekly amount to live elsewhere.

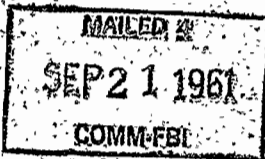

7 Episcopal Clergymen Plan Mixing Test at Sewanee Inn

Seven Episcopal clergymen, six white and one Negro, who are engaged in a "prayer pilgrimage" against segregation, arrived at the Chattanooga Municipal Airport at 9:39 a.m. today and planned immediate departure for the University of the South at Sewanee, an Episcopal institution, where they said they would try to eat at the Sewanee Inn.

The seven who came here left 15 of their group in jail at Jackson, Miss., where they were arrested yesterday for trying to integrate a bus terminal. Among them was Rev. Robert L. Pierson of Evanston, Ill., son-in-law of Gov. Nelson Rockefeller of New York.

Those arriving here were identified as Father Layton Zimmer, rector of Trinity Church, Swarthmore, Pa.; the Rev. Robert Fortna, student at the Union Theological Seminary, New York; the Rev. Robert Chapman, Negro rector of St. John's Church, Hempstead, N.Y.; the Rev. Morris Samuel, Long Beach, Calif.; the Rev. Malcolm Boyd, Detroit; Rev. Robert Hampshire of Farmingdale, N.Y.; and the Rev. Joseph Dickson, Detroit.

Father Zimmer, who acted as spokesman for the group, said he was among a group of some 50 students who transferred from the Sewanee seminary in 1953 in

city) invitation to sleep in the gymnasium. We had asked for rooms, but the school is full."

Mrs. Clara Shoemate, who operates Sewanee Inn and Claramont Restaurant under a lease from the University of the South, said in an interview before the arrival of the racially integrated group that she would not allow them to enter the restaurant.

Mrs. Shoemate has a lease on the modernistic stone building for five years. The restaurant is on the campus of the University of the South, but the school has no voice as to whom will be served.

PLAN SIT-INS

"They have been planning sit-ins at Highlander Folk School and are planning them right now for this restaurant," Mrs. Shoemate said.

"We have had two clergymen in the graduate school to try to bring in two Negro men this past August," she added. This group was not admitted for service, she said.

"The whole thing is ridiculous. We have been expecting this for a number of weeks. It took in this group, Highlander Folk School would move in on us. They tried

to do that at Claramont" (the former restaurant at Monteagle operated by Mrs. Shoemate) 10 years ago, the diminutive restaurant operator said.

Mrs. Shoemate said that she has been in business 32 years, and that Myles Horton, head of Highlander Folk School, has been trying to integrate her restaurants for most of this time.

This restaurant has a capacity of 200 persons.

Mrs. Shoemate said she had decided she would not allow the racially mixed clergymen to enter the building, but would stop them at the front door before they could enter the lobby of the inn and the restaurant. A main dining room is beyond the lobby of the inn.

A ladies' group was scheduled to have lunch in the main dining room today. It was feared that should the integrated ministers' group enter the restaurant they would seat themselves and refuse to leave upon request.

GROUP MET

The seven Episcopal priests who arrived by Delta Airlines this morning from Atlanta and Jackson, Miss., were met by a group of Negro ministers at the Lovell Field airport.

In this group was Father Robert Hunter, rector of the St. Mary the Virgin Episcopal Church in Chattanooga. He was the Negro minister struck in the face during an altercation at a stand-in demonstration at the Tivoli Theater a number of months ago. Dr. Major Jones, Stanley Methodist Church, Chattanooga, who is active in racial matters in Chattanooga, also was present. The Rev. Horace Tyler, a Negro minister who described himself as "inactive," was the third member of the welcoming delegation. The fourth and final member of the group on hand to greet the visitors was Father James Woodruff, rector of St. Anselm's Chapel, Nashville.

After the visiting clergy disembarked from the plane, their baggage was loaded into an automobile and a station wagon and driven away by the welcoming committee.

The Rev. Zimmer said the length of the group's visit to the University of the South had not been determined. He said if they were unable to integrate Sewanee Inn they might remain on the mountain for a longer period of time than they otherwise would

have. However, he refused to give any estimate as to when the group would depart.

"This place is too large and has too much overhead to be supported by the university alone," she pointed out. "We have to depend on people who come in over a big area, and who have done this for years. We have state meetings of groups, and we have large groups from such places as Nashville, Chattanooga, Murfreesboro, Tullahoma and many others. The people don't realize from what a large area we must draw our customers."

The group left the local airport in a station wagon and another automobile that had been provided for them.

JACKSON ARRESTS

The 15 clergymen held in Jackson, Miss., including Gov. Rockefeller's son-in-law, were arrested, the Associated Press reported, after they refused to obey a policeman's order to move on.

Police Capt. J. L. Ray, who has handled most of the more than 300 "freedom rider" arrests in the Mississippi capital city was summoned. He ordered the arrest of the priests on breach of peace charges after they again refused to move on.

Their trial was set for 3 p.m. today.

The 15 were participating in a prayer pilgrimage which left New Orleans Tuesday and proceeded without incident until they reached Jackson. Twenty-three white and five Negro Episcopal priests started the pilgrimage.

It was the first arrest for Pierson, 35, of New York City and Evanston, Ill. His wife is Ann Rockefeller, one of the New York governor's five children.

After a meal in jail of cornbread, peas and meat, the minister said that police had been polite and that the treatment was satisfactory.

He said he had no plans to get out of jail but hoped that "churches" around the nation will be concerned enough to come to our help.

The New York governor, asked if he planned to intercede, replied, "I know he (Pierson) wouldn't expect any special treatment or want it."

Some of the other ministers telegraphed a protest over the arrests to Atty. Gen. Robert Kennedy.

"In view of your request to American clergy to exercise leadership in these areas," the telegram said, "we urge you immediately resolve problems of interstate travel for Americans."

HEAD FOR CONVENTION

The ministers, who had spent Monday night at a Negro YMCA in New Orleans, traveled by chartered bus to Jackson where they stayed overnight at nearby Tougaloo Southern Christian College, a Negro school.

From Jackson, they had planned to continue by scheduled commercial lines to the 60th general convention of the Protestant Episcopal Church opening in Detroit Sept. 17.

Those arrested had tickets for Chattanooga, Tenn., where they had planned to visit the church's

University of The South at nearby Sewanee.

2 Episcopal Priests Denounce "Pilgrims".

Signal Mt. Rector Hits 'Mix' Tactics

SEWANEE, Tenn. — Two Episcopal priests attending a clergy conference at Dubose Center near here have denounced methods of a biracial group of "prayer pilgrims," who have vowed to demonstrate at a Sewanee restaurant, as "creating 'un-Christian confusion.'"

The Rev. Alan McMillan, Episcopal chaplain at the University of Tennessee, Knoxville, and the Rev. William T. Holt Jr., rector of St. Timothy's Episcopal Church, Signal Mountain, Tenn., were both highly critical of a seven-man delegation that appeared here about noon yesterday from Atlanta, Ga., and Jackson, Miss.

The "pilgrims" — all Episcopal clergymen — arrived at Chattanooga's Lovell Field yesterday morning and motored to Monteagle, then to Sewanee.

At Monteagle, they stopped at Dubose Conference Center, where they were welcomed and invited to lunch with a racially integrated meeting of Episcopal clergy. They refused. They were then invited to dine with Dr. Edward McCrady, vice chancellor of the University of the South, and his family. They refused. They were asked to have lunch at the dining hall of the university, and they refused.

The Rev. Layton Zimmer, rector of Trinity Episcopal Church, Swarthmore, Pa., who said he was spokesman of the "pilgrims," had stated in Chattanooga he and his companions planned to eat at Claramont Restaurant at the Sewanee Inn. This is a public facility owned by the University of the South, an Episcopal institution, but leased to Mrs. Clara Shoemate. Mrs. Shoemate stated she would not allow the group to enter, as racially mixed groups are not served.

WON'T INTERFERE

Dr. McCrady said he met with the "pilgrims" last night, and the group decided after this meeting not to "interfere" and there would "be no further demonstrations."

He said one of the "pilgrims" left yesterday, two more were leaving this morning, and the remaining four would visit during the day and leave tomorrow.

The Rev. Malcolm Boyd of Detroit denied this morning the group had eaten at a university dining hall last night.

"We have been fasting, continuing it since we arrived here," he said.

"This group (the pilgrims) is trying to make Clara a scapegoat. They were invited to eat with us."

and they said they had to go on," Father Holt said.

The Rev. McMillan agreed, and remarked:

"They sent advance notice they were coming and said this would be a normal trip. If they refused invitations to eat with integrated groups, they are doing nothing but perpetrating a situation."

"Our objection is this is not being done decently and in order. The University of the South is already officially integrated."

"I think this is not a normal testing of either the University of the South policy or the policies of the diocese of Tennessee, or public bus facilities. In coming here (Sewanee Inn and Claramont Restaurant), they could not be normal passengers needing a meal."

Father Holt said.

"We are in favor of Christians acting as Christians in the church. We are angered by people deliberately creating a situation that doesn't aid the situation (integration) as far as we can see."

Both clergymen noted that Mrs. Shoemate had in the past been in charge of the dining facilities of Dubose Center. During that period she served both white and Negro diners without objection.

Mrs. Shoemate said Highlander Folk School has tried to give trouble at restaurants she has operated on the mountain and made efforts to integrate them.

Highlander has had its charter revoked for violation of the criminal laws of Tennessee and terms of its tax-exempt charter. However, it is still in operation pending an appeal to the U.S. Supreme Court.

It was the opinion of a number of persons that the "pilgrims" did not appear at the restaurant as they said they planned to do because they had found it necessary to refuse the numerous invitations they had received to dine with integrated groups at Sewanee and Monteagle.

MEET WITH BISHOP

Father Holt pointed out he had been priest in charge of a Negro church for 7½ years and had helped get that church a full-time Negro priest.

He said both he and the Rev. Mr. McMillan had worked actively to assist in the integration of the University of Tennessee.

The "pilgrims" met with the Rt. Rev. John Vander Horst, bishop of Tennessee at Dubose during the afternoon. At mid-afternoon, they were at All Saints' Chapel on the campus of the university.

They had been offered beds in the school gymnasium, and the Rev. Mr. Zimmer had said they would sleep there. He left suddenly yesterday for Jackson, Miss., where trials of 15 other "pilgrims" were scheduled for late this afternoon.

The Rev. Mr. Zimmer was among the group of seminary students who left Sewanee as a protest against racial policies in 1953.

The university has no authority in the normal operation of Sewanee Inn and Claramont Restaurant.

Other members of the pilgrim group included the Rev. Robert Fortna, Union Theological Seminary student, New York City; the Rev. Robert Chapman, a Negro rector, St. John's Church, Hempstead, N.Y.; the Rev. Miles Samuel, Long Beach, Calif.; the Rev. Robert Hampshire, Farmingdale, N.Y.; and the Rev. Joseph Dickson, Detroit, Mich.

Praise and censure came today from Episcopal bishops for the desegregation attempt by 15 Episcopal ministers facing trial on breach of peace charges at Jackson, Miss.

The Rev. Robert L. Pierson of Evanston, Ill., and New York City, son-in-law of New York Gov. Nelson A. Rockefeller, was one of the 12 white and three Negro clergymen arrested Wednesday for trying to desegregate a Jackson bus terminal. Their trial was set for 3 p.m. today.

The Rt. Rev. Arthur C. Lightenberger of Detroit, the presiding bishop of the Episcopal Church in the U.S.A., praised the action of the 15 clergymen. He said they were "attempting to bear witness to their Christian convictions about racial matters and to make it evident to the whole country what the position of the Episcopal Church is."

Bishop Wilburn Campbell of Charleston, W. Va., head of the Episcopal diocese of West Virginia, said the "prayer pilgrimage" "deliberately and defiantly violated the known laws of municipalities and states." He said the ministers "should be prepared to take the consequences."

"Personally, I have little sympathy for them—not because of their goals and ideals, but because of their tactics," Campbell said. "You cannot achieve a moral goal by immoral actions."

On the Senate floor in Washington, Sen. John Stennis, D-Miss., and Sen. Jacob K. Javits, R-N.Y., took opposite sides on the ministers' arrest.

Stennis said the ministers "were getting a long way from their pulpits. Certainly there is nothing in the sermon on the Mount which calls on them to stir up agitation."

Javits defended the group, saying "a great moral issue was involved."

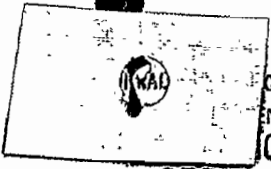

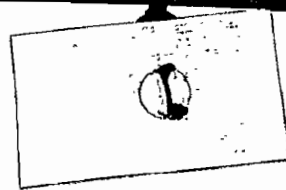

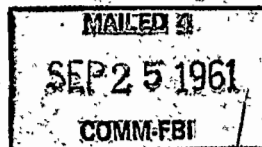

Re Memphis letter to Bureau dated 8/23/61, which reflects that among charges billed for the telephone at the office of the Student Central Committee (SCC) at 1905 Jefferson Street, Nashville, Tennessee, were charges for a call on June 9, 1961 to Louisville, Kentucky phone 585-2331, and on May 19, 1961, to Louisville phone 774-3331.

According to the August, 1961 issue of the Louisville, Kentucky Telephone Directory, phone 774-3331 is listed to the Southern Conference Educational Fund, Incorporated (SCEF), 4403 Virginia Avenue, and also to CARL BRADEN, 4403 Virginia Avenue, Louisville, Kentucky.

Inasmuch as Memphis undoubtedly has a current thumbnail sketch of the SCEF, no characterization of that organization is included.

Following is a current characterization of CARL BRADEN:

[Redacted] Louisville, Kentucky, a self-admitted former member of the Communist Party (CP), Louisville, Kentucky, in testifying on December 11 and 13, 1954, in Jefferson County, Kentucky Criminal Court, in a state sedition prosecution against CARL BRADEN, identified CARL BRADEN and his wife, ANNE BRADEN, as having been known to her as members of the CP, Louisville, Kentucky, from January, 1951, to shortly prior to the time of her testimony.

The booklet entitled "Communist Infiltration and Activities in the South", printed for the use of the Committee on Un-American Activities, House of Representatives, on pages 2667 through 2681, reports the testimony of CARL BRADEN before the sub-committee of the Committee on Un-American Activities, U.S. House of Representatives, on July 30, 1958.

BRADEN identified himself as a worker in the integration movement in the South and as a Field Secretary of the Southern Conference Education Fund (SCEF), which organization he identified as "a South-wide inter-racial organization working to bring about integration, justice and decency in the South". BRADEN also said he was Associate Editor of the newspaper of the SCEF, "The Southern Patriot", which he said "disseminates information on integration in the South and about people who are working for integration".

BRADEN testified that he was previously "unemployed as a result of harassment and prosecution resulting from... efforts to bring about integration in Louisville, Kentucky."

BRADEN declined to answer the question, "...Are you now a member of the Communist Party?" on the basis of the First Amendment, stating that the question "Has no possible pertinency to any legislation."

He declined to answer on the same grounds a question as to whether or not [redacted] was in error when she testified before the Committee on Un-American Activities that while she was a member of the CP, she knew BRADEN as a CP member.

BRADEN thereafter refused to answer other questions on the basis of invasion of rights guaranteed by the First Amendment, which he designated as freedom of speech, beliefs and associations.

The Courier-Journal, Louisville, Kentucky, a newspaper of general circulation, on February 3, 1959, reported that CARL BRADEN had been sentenced to one year in prison on a charge of contempt of Congress on February 2, 1959, in Atlanta, Georgia. The story noted that he had been convicted under this charge on January 21, 1959, and that the charge arose from his refusal to answer questions before the House Committee on Un-American Activities.

The Louisville Times, Louisville, Kentucky, a newspaper of general circulation, on February 27, 1961, reported that the U.S. Supreme Court had, on that date, affirmed the contempt of Congress conviction of BRADEN.

The Courier-Journal, on May 2, 1961, reported that CARL BRADEN had surrendered to the U.S. Marshal at Atlanta, Georgia, on May 1, 1961, to begin serving a one year prison sentence for contempt of Congress.

In connection with Louisville telephone number 585-2331, mentioned above, in connection with referenced letter, it is noted the August, 1961 issue of the Louisville, Kentucky Telephone Directory reflects this number to be listed for the Henry Clay Hotel, Louisville, Kentucky. It is noted the call to this number from the phone in the office of the Student Central Committee, Nashville, Tennessee, was made on June 9, 1961.

In this connection, the attention of the Bureau and Memphis is directed to Louisville letter to Bureau, with copies to various offices, dated June 30, 1961, entitled "Student Non-Violent Coordinating Committee - RACIAL MATTERS", which reflects that the Student Non-Violent Coordinating Committee met in Louisville, Kentucky for three days ending June 11, 1961. Meetings were held in the Henry Clay Hotel, Louisville, Kentucky. Included on the reported agenda for the meeting were policy decisions about future "Freedom Rides" and discussions of Negro efforts to desegregate recreational facilities this summer.

It would appear from the above that the call of June 9, 1961, related to the Student Non-Violent Coordinating Committee which was then meeting in Louisville, Kentucky.

Chief of Detectives M. B. Pierce, Detective Bureau, Jackson, Mississippi, advised that at 6:10 p.m. on July 7, 1961, a group of Freedom Riders were arrested at the Trailways Bus Terminal, Jackson, Mississippi by Captain [redacted] Jackson Police Department. Pierce advised that this group of Freedom Riders had arrived in Jackson by bus from Montgomery, Alabama, had entered the white waiting room of the terminal, and were ordered to move on by police officers. When they failed to obey the order of the officers, they were arrested on a charge of Breach of the Peace, and transported to the city jail, where they were booked. Pierce stated there were no incidents in connection with the above arrests.

On February 29, 1956, a second source, who has furnished reliable information in the past, advised that on that date [redacted] had contacted the Soviet Embassy in Washington, D. C., and requested that he be allowed to enter and live in the Soviet Union because [redacted] he could not expect to receive justice since [redacted] was greater than social justice in the United States.

On February 2, 1959, a third source, who has furnished reliable information in the past, made available a piece of the letterhead stationery of the Committee to Combat Racial Injustice, which reflected that [redacted]
[redacted] the Union County, North Carolina, NAACP [redacted]
[redacted] the Committee to Combat Racial Injustice.

On December 19, 1958, a fourth source, who has furnished reliable information in the past, advised that the Committee to Combat Racial Injustice was being set up in order to concern itself mainly with the racial issue involving the conviction and incarceration of two Negro youths, ages eight and ten at Monroe, North Carolina, who were convicted of kissing a white girl. This source added that this committee would concern itself with other racial incidents and intends to become a prominent organization. This same source also stated that this committee was initiated through the efforts of the Socialist Workers Party (SWP), which was the motivating force in the formation of this committee.

The SWP has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

The April 6, 1960, edition of "The New York Times" carried an article which maintained that the United States Press had made certain charges against Cuba which were not true and that the "Fair Play for Cuba Committee" was organized to tell the truth about Cuba in the interest of fair play. Among those listed as members of this committee was [redacted].

On August 10, 1960, a fifth source, who has furnished reliable information in the past, advised that on August 7, 1960, he attended a meeting at 116 University Place, New York City, at which time [redacted] was introduced as a noted Negro leader from Monroe, North Carolina, a sponsor of "Fair Play for Cuba Committee" and that [redacted] had just returned from

an extended tour of Cuba, where he observed the revolution, first hand, and participated in the July 26, 1960 celebration on the Sierra Maestra. [redacted] stated he visited Cuba to see the advancement of the Cuban Revolution and was very impressed by its success. [redacted] stated today in Cuba one does not see any racial discrimination and that the United States Government and the State Department are making a definite effort to keep Negroes out of Cuba. [redacted] stated "the progress of the revolution can be seen all over---. If this is Communism, then I vote for Communism".

Four Freedom Riders, identified in details of report, arrested at Trailways Bus Station, Shreveport, La., by Shreveport PD on 8/4/61 after refusing to leave waiting room where waiting to board Trailways Bus scheduled to depart 5:45 a.m., 8/4/61, en route to Jackson, Miss. Two other individuals, also identified in details, arrested shortly thereafter in 500 block Travis St., about one block from bus station. All charged with disturbing the peace. All tried in First Judicial District Court, Caddo Parish, Shreveport, trial starting 8/18/61, ending 8/21/61; all entered not guilty pleas; all found guilty on 8/21/61 and sentenced on 8/23/61. Sentences set forth in details. Defense attorney applied to Supreme Court of La. for writ of certiorari, prohibition mandamus. Defendants granted 10 days delay; released on bond 8/23/61, except defendant [redacted] against whom detainer placed by PD, New Orleans, La., on narcotics charge. Descriptions and identification records set forth. No incidents at time of arrest or during trial.

AT SHREVEPORT, LOUISIANA

Investigation in this case was predicated upon information furnished by [redacted] Shreveport Chapter, Congress of Racial Equality (CORE), to SA's [redacted] on August 3, 1961 [redacted] advised his organization planned to test the facilities at the Trailways Bus Station, Shreveport, as follows:

A group of seven CORE members planned to board a Trailways bus scheduled to leave Shreveport at 5:45 a.m., August 4, 1961, and to travel to Jackson, Mississippi. Prior to boarding the bus, they planned to test the facilities at the Trailway Bus Station, Shreveport, by entering the white waiting room. In addition, they were considering testing facilities at some of the towns en route from Shreveport to Jackson, although he stated he had recommended against this and no definite decision had been made in this regard and no specific towns had been decided upon.

[redacted] advised all of these individuals were Negroes and all were local Shreveport people. He stated [redacted] was to be the leader of the group. In addition, he stated there might be two additional persons in the group - [redacted] age [redacted] and another person whose identity he did not yet know. He stated these were also local Shreveport people.

[redacted] advised the group planned to go to the bus station at 5:00 or 5:15 a.m. He stated he did not plan to attend himself but that he might aid in transporting the others to the station. He said they intended to notify the police of their plans about two hours before their bus was scheduled to depart.

The following was observed at the Trailways Bus Station, Fannin and Edwards Street, Shreveport, Louisiana:

Present at the station at approximately 4:30 AM on the morning of August 4, 1961 were fifteen officers from the Caddo Parish Sheriff's Office and about ten officers from the Shreveport Police Department. Chief Deputy [redacted] Major [redacted] were in charge of the officers from the Caddo Parish Sheriff's Office and Chief of Police HARVEY TEASLEY and Major [redacted] were in charge of the officers from the Police Department. Chief TEASLEY was in charge of the overall operation and acted as spokesman for the group. Two uniformed police officers were stationed at each door to the waiting room marked white intrastate passengers.

At 5:22 AM a four-door, two-tone-blue, Oldsmobile carrying six Negroes stopped behind the bus station and discharged four Negro passengers, two of which were males. The car then pulled off with two Negro males in the vehicle. The four Negroes proceeded immediately to the west door to the station which was marked white intrastate and were temporarily engaged in conversation by the officers stationed there. Officer [redacted] spoke to one of the male Negroes who acted as spokesman for the group. This individual later identified himself as [redacted] to Chief of Police TEASLEY. After a slight pause the four then entered the waiting room and proceeded to the center of the waiting room where they were stopped by Chief TEASLEY and engaged in conversation for several minutes. During the conversation TEASLEY advised the group they were violating State and City Laws by entering this particular waiting room and requested they leave [redacted] said they wanted to wait for their bus. TEASLEY pointed out they could wait in the other waiting room; however, they indicated they desired to remain in the waiting room where they were. TEASLEY inquired as to whether they had any respect for State and City Laws and they were informed if they remained, they would be arrested. [redacted] replied he had no choice, or words to that effect, whereupon TEASLEY asked if that meant they were refusing to leave. [redacted] said it did and TEASLEY then told the group they were under arrest and they were escorted to the door through which they had entered. The time of the arrest was 5:27 AM.

They waited about two minutes for a police patrol wagon during which time Chief TEASLEY asked all of the members of the group for their names and he also asked [redacted] if they had a meeting to plan this action. [redacted] said they had. The group was then taken away in the patrol wagon.

The representatives of the Police Department and Caddo Parish Sheriff's Office remained in the Trailways Bus Terminal until the 5:45 AM bus for Jackson, Mississippi had departed. There were no other incidents at the bus station.

During the above there were approximately fifty persons in the bus station; however, most of them had luggage with them and did not appear to have much interest in the happenings and appeared to be travelers. One newspaper man and one newspaper photographer was in the station at the time of the arrest. Also in the station and observing the proceedings was [redacted] of the Louisiana State Sovereignty Commission.

Date August 11, 1961

The following was observed in and near the Trailways Bus Station, Edwards and Fannin Streets, Shreveport, Louisiana:

At 4:30 AM, there were approximately fifteen officers from the Caddo Parish Sheriff's Office, under the command of Chief Deputy Sheriff [redacted] and about ten officers from the Shreveport Police Department, under command of Chief of Police HARVEY TEASLEY. Officers from both departments were stationed at the doors to the waiting rooms and around the Station in strategic location. Also present was [redacted] Louisiana State Sovereignty Commission.

At approximately 5:22 AM, four Negroes, subsequently identified as [redacted] were observed to come to the west door of the Station where the sign over the door indicates it is for white intrastate passengers. Two uniformed officers of the Police Department blocked the door when the group attempted to enter and when [redacted] stated he wanted to enter the waiting room, one of the officers, Patrolman [redacted] advised the group they were to use the other waiting room, indicating the one on the north side of the station, whose door sign indicates it is for interstate passengers and colored intrastate passengers.

[redacted] stated they wanted to enter the waiting room to await their bus. [redacted] advised [redacted] that if the group entered that waiting room, they were liable to be arrested. [redacted] said that was all right so the officers stood aside and allowed the group of Negroes to enter.

[redacted] led the group into the waiting room and headed for the ticket window. The group was intercepted by Chief of Police HARVEY TEASLEY and other officers of the Police Department and Sheriff's Office.

The initial statements were not overheard but TEASLEY was heard to tell [redacted] within hearing of the others, that they were violating State and City Laws. [redacted] said he understood there was a Federal injunction which permitted them to use that waiting room and they desired to wait there for their bus.

TEASLEY asked [] if he had no respect for State and City Laws; [] replied he did but the group wanted to remain in the room to wait their bus.

TEASLEY told [] that he and the others should leave immediately and if they did not, they would be arrested. [] replied, "I have no choice". TEASLEY asked if that statement meant they refused to leave and [] said it did. TEASLEY then told the group they were under arrest and told them to go back out the door they had entered.

The group immediately left the Station by the same door and while waiting outside for the patrol wagon, TEASLEY interviewed each, briefly, concerning his identity. He asked [] if their action had been planned at meetings, and [] said it had. In answer to TEASLEY'S question, [] said there had been just one meeting at which their action had been planned.

The arrest was made at 5:27 AM and the group was placed in the patrol wagon at about 5:30 AM.

Police and Sheriff's Officers remained at their stations at the depot until the bus, on which the group of Negroes had intended to depart, left at about 5:45 AM, without further incident.

Date August 11, 1961

Officer [redacted] Shreveport, Louisiana Police Department, advised that on the morning of August 4, 1961 he was assigned to the west door of the white intrastate waiting room of the Trailways Bus Station located on the corner of Fannin and Edwards Streets, Shreveport, Louisiana. At about 5:25 AM two male and two female Negroes came to the entrance and started to enter the doors leading to the white intrastate waiting room. He said that he and another officer from the Shreveport Police Department advised them they were to use the other waiting room located on the north end of the building. One of the group who later identified himself to the police as [redacted] stated they wanted to enter the waiting room and wait for their bus. At the time [redacted] had a ticket in his hand. [redacted] said he then informed the group that if they went into the waiting room for white intrastate passengers they may be arrested. [redacted] remarked to the effect that was all right at which point he and the other officer stopped aside and the group of four entered the white intrastate waiting room and proceeded to the center of the room where they were stopped by Chief of Police HARVEY TEASLEY and other officers of the Police Department as well as members of the Caddo parish sheriff's office.

On August 4, 1961, Chief Deputy Sheriff [redacted] Caddo Parish Sheriff's Office, advised SA [redacted] that all six of the individuals arrested had been charged with violation of Louisiana Criminal Code, Article 103, Section 1, disturbing the peace, and their bonds were all set at \$150. The attorney representing all six individuals was JESSE STONE. [redacted] advised there were no incidents during the arrests.

On August 4, 1961, Jailer [redacted] Caddo Parish Sheriff's Office, advised that [redacted] had been released on bond provided by bondsman [redacted] on that date.

On August 4, 1961, Captain [redacted] Identification Officer, Caddo Parish Sheriff's Office, advised he had fingerprinted the six arrested persons and had found no prior arrest record for any of them on file with his department. He advised their fingerprints were being submitted to the FBI in Washington, D. C.

On August 4, 1961, Chief of Police HARVEY D. TEASLEY, Shreveport Police Department, advised he had been unable to locate any arrest record on file with his department identifiable with the six individuals arrested on that date with the exception of [redacted] on whom he found a record of two traffic arrests, one being for running a red light and the other for careless and reckless driving. He was convicted on both charges. Chief TEASLEY stated he understood [redacted] had been involved in a sit-in demonstration in Baton Rouge, Louisiana, some time ago.

On August 4, 1961, [redacted] Greater Shreveport Credit Bureau, advised she found no credit record for [redacted]. She located a credit record for [redacted] Shreveport, which had been on file since December, 1955, and reflected a satisfactory credit rating with no suits, fines, or judgments listed. No subsequent information was in the file. It could not be determined if this person is identical to [redacted].

On August 11, 1961, Chief of Police HARVEY D. TEASLEY advised that [redacted] [redacted] were released on \$150 bond each on August 10, 1961. He advised that on August 11, 1961, these individuals together with [redacted] [redacted] were arraigned in the First Judicial District Court, Caddo Parish, Shreveport, on charges of disturbing the peace at which time all six entered pleas of not guilty. Trial was set for August 18, 1961, and all six persons were continued on bond.

On August 23, 1961, Chief Deputy Sheriff [redacted] [redacted] Caddo Parish Sheriff's Office, advised that all six of the individuals arrested on August 4, 1961, had been found guilty on August 21, 1961, in District Court and that they had all been sentenced by District Judge JOHN DIXON on August 23, 1961. 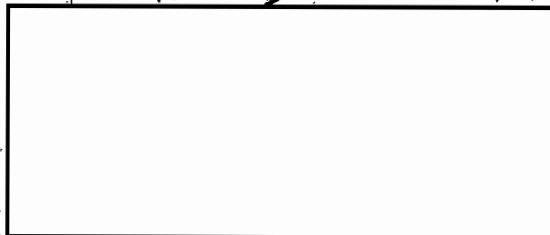

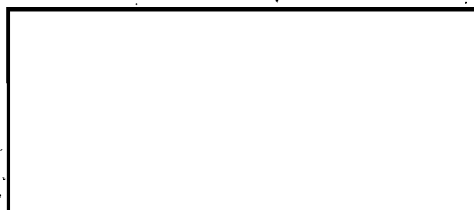

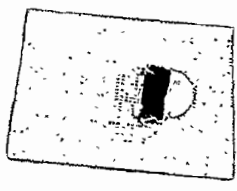

On September 3, 1961, I attended a convention held at 8751 Grand River in Detroit. There was about 35 people there, 17 of them men, and the rest women. There was 5 Negro ~~women~~ women there and 2 Negro men.

Saul Blackman gave the first talk. It concerned working with other organizations. His talk was quite brief and he mention CORE and the Trade Union Labor council. He said that he thought CORE was doing a great job and that they would support them, but he didn'T have such good words for the TULC. He said that they organized to help the men in the unions, but they have an altogether different attitude, since they formed it. He said that they are soliciting new members and that he was talking to a carpenter that works in the same shop that he does and that the man said they approached him about ~~joining~~ joining the TULC and that the sales talk they used was that they had a nice bar. Saul said that it showed just how much they planned on helping the members.

Louise, one of the Freedom Riders, gave ~~the~~ the next talk on her experiences in Jackson Mississippi when she was arrested with the other Freedom Riders. She said that 8 minutes after the bus load of Freedom Riders got in Jackson, they were arrested. They were taken to the city jail first and then were moved to the county jail. She said that they were put into maximum security, but she said that only hardened criminals are supposed to be put there, but they told them it was for there own protection. She said that the Negro and white ~~girls~~ girls were all put together and the Negro men and white men were separated. There were 13 girls to a cell and only four cots, so the rest of them ~~were~~ had to sleep on the floor and that the whole place was full of bugs.

Louise said that they served 40 days there and that during this time, the guards came one day and took nine of the Negroes (including Mary) out of the cell and no one saw them for a long time. Finally Louise saw one of the guards and asked him to give Mary her toothbrush that she had left behind and he said "to never mind because she would be coming" and then stopped in the middle of his sentence. She said they finally found out why they were taken away and it was because they were having an official inspection and they didn't want it to look overcrowded. She also mentioned that they discovered that the quarters where the desperate criminals and murderers were being held was right behind them and that all they were being fed was one biscuit and one teaspoon of whatever was being served for each meal, so they hooked up a string and passed biscuits through a ventilator to the men. One day, some one stuck his hand through the ventilator and they thought it was the prisoners so they started pushing the biscuits as fast as they could, but it turned out to be a guard. They were taken before the warden and she said that he was so mad they were afraid they were going to kill them, but instead they took their mattresses away from them and also their towels and toothbrushes. After serving their 40 days, they went to New Orleans, because they had to be back in Jackson in a few days for their trial. She said they new better than to get into any trouble, because of their coming trial, so they were minding their own business when the police picked up her, Mary and another girl. She said that they were waiting for a bus and she had \$15.00 in her pocket, but they charged them with loitering and vagrancy. They booked them, but CORE bailed them out and then the next night they were arrested again ~~for~~ and they charged them with being prostitutes

The girls that was with them had a CORE card on her person and the cops said that they were going to call in the FBI and Louise said she got so mad that she told them that she wished they would, because a FBI man rode all the way to Mississippi on the bus with them to protect them from ~~ppp~~ people like the the cops and that they would be doing her a favor if they would call them. She said after that they didn't bother them and they were released.

Mary Hamilton, A Negro Freedom Rider, gave a brief talk about the way she felt about the Freedom Riders. She said that she now thinks that things will change for the Negroes and they will be given more rights.

A boy about 19 years old stood up and talked a few minutes. He told how he belonged to a group of students called the Student Peace Unit. He said that it originated in Chicago and that they now have about 3,000 members.

There was another boy there who said his name was Bob Speck and that he was 17 years old. He's from Texas, but is not connected with News and Letters. He told how he was arrested several times in connection with integration. He said that in one jail in Texas he was beat up by the guards and that in doing this they inticed the other prisoners to beat him up and that when he got out of jail, he filed a complaint with the FBI against the Guards.

An item from the "People's World" (a West Coast weekly communist newspaper) of 7/15/61, tells of a group of Freedom Riders sponsored by the 2nd Baptist Church, Los Angeles, leaving Los Angeles on 7/12/61 for the South. The article states, "A man who wanted to make the trip but did not was WILLIAM GREEN, just discharged from the armed services. GREEN had been selected by the Congress of Racial Equality to serve as Freedom Ride coordinator in this area."

On September 25, 1961, [redacted]

[redacted] Nashville, Tennessee, advised that the various organizations sponsoring the Freedom Rides to Jackson, Mississippi, are in bad financial straits as a result of the trials, the bonds, and the fines which are having to be paid in Jackson. [redacted] stated that the attorneys for the Freedom Riders have advised them that if the cases are taken through the courts to the last court in Mississippi and from there to Federal Court, it will cost approximately one million dollars or more. He stated that they do not have this kind of money and it looks as if they will have to drop the appeals. He stated that this will mean that the fines levied on the Freedom Riders will have to be paid which, in itself, will be a severe financial strain on the various groups involved and also mean that the participants in the Freedom Rides will have to serve time in the Hines County Jail or at the State Penitentiary at Parchman, Mississippi.

[redacted] stated that he feels that there is a possibility that the State would drop the cases now that the Interstate Commerce Commission (ICC) has ruled that the bus lines have to maintain nonsegregated facilities in their terminals and that he considers this to be a victory for the Freedom Riders. He stated, however, that from a legal standpoint the State of Mississippi would not have to drop the cases and, therefore, the situation would be unchanged. He stated that they realized now that they sent too many people to Jackson, Mississippi; that they should have only used the first groups as a test case rather than having so many cases on which they would have to pay fines.

In further discussing some of the various aspects of the Freedom Riders [redacted] pointed out that efforts are being made in Nashville, Tennessee, to have Tennessee A&I State University, a Negro school, reinstate 14 of the A&I students who were dismissed from the school in May of 1961 because of their participation in the Freedom Rides. He stated that the school authorities have refused to reconsider the cases and stated that even though the students are continuing to demonstrate at the school and in Nashville, Tennessee, the demonstrations do not appear to be bearing any fruit. He stated that insofar as he knows the State school authorities will not change their stand on the issue nor will Governor Ellington. He stated that there is some hope that the fact that the ICC has ruled that the bus facilities will have to be desegregated may give the school authorities an excuse to change their ruling; however, he stated that this appears to be a dim possibility. He also stated that attorneys have been consulted relative to taking the case of these 14 students to Federal Court in an effort to have a court order issued that the school should reinstate them. He stated, however, that no effort has been made by the attorneys to actually take the case to court at this time.

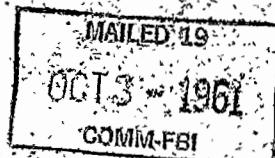

On September 7, 1961, NK T-1, who has furnished reliable information in the past, advised that telephone number [redacted] had been listed to [redacted] Newark, New Jersey, but that this telephone was disconnected on August 2, 1961.

On February 1, 1954 Newark T-2, who has furnished reliable information in the past, advised that on January 31, 1954 Paul Robeson held a musical concert at the Galilee Baptist Church, Newark, New Jersey, and that programs distributed at this concert listed the Reverend and Mrs. R. P. Means among the patrons.

In June, 1950, Newark T-3, who has furnished reliable information in the past, advised that Paul Robeson was known to him prior to 1945 as a concealed communist.

A newspaper article captioned "Carlin Asks Open Mind", which appeared in the September 5, 1954 issue of the "Evening News", a Newark, New Jersey, daily newspaper, reflects that on September 4, 1954 Reverend Raphus P. Means, Pastor of the Abyssinia Baptist Church, Newark, New Jersey, presided as chairman at a meeting of a group known as the "Citizens Committee Against Police Brutality", (CCAPB).

Newark T-4, who has furnished reliable information in the past, advised on August 31, 1954 that the "Citizens Committee Against Police Brutality" came into being on

August 30, 1954 at Newark, New Jersey, and was formed as a result of alleged brutality by members of the Newark, New Jersey Police Department during the arrest of [redacted] on August 23, 1954.

Newark T-4, mentioned previously, advised on July 1, 1955 that the CCAPB was no longer in existence. He stated further that from its inception, the CCAPB was dominated and controlled by members of the Communist Party.

On September 28, 1951 Newark T-4, mentioned previously, advised that [redacted] had been substituted as an Essex County, New Jersey freeholder candidate for [redacted] when it was realized that [redacted] had signed a Communist Party nominating petition in 1948.

A confidential source, who has furnished reliable information in the past, advised on January 7, 1957, that an application was made to Brooklyn College Faculty-Student Committee on Student Organizations for permission to organize a Eugene V. Debs Society at Brooklyn College. The purpose of the proposed organization was to further the ideas of democratic socialism, which necessarily implies opposition of all forms of totalitarianism and to treat current social, economic, and political events from a socialist point of view.

A confidential source advised on February 12, 1958, that [redacted] member of the Young Socialist League (YSL) National Executive Committee (NEC) stated during a plenum of the NEC held on February 1, 1958 and February 2, 1958, at Chicago, Illinois, that the Brooklyn College Debs Club was an area of activity of YSL members.

The March 1, 1954, issue of the "Young Socialist Challenge," published as page three of "Labor Action," an official publication of the Independent Socialist League (ISL), contained an article concerning the creation of the YSL, which pointed out that at a unity conference occurring February 12-14, 1954, at Labor Action Hall, New York, New York, a merger occurred between the Young People's Socialist League (YPSL) and the Socialist Youth League (SYL). The new organization was named the YSL.

A confidential informant on June 15, 1954, made available the minutes of the YSL's National Action Committee meeting of [redacted] which reflected that one [redacted]

[redacted] of SP (Socialist Party) [redacted] had objected to a statement appearing in "Commerce," a New York University journal, which indicated that the YPSL merged with the SYL to form the YSL. He explained that the YPSL did not merge with anyone, that it continued to exist as the youth section of the Socialist Party. He explained that a small group of the YPSL was dropped, expelled, or suspended from that organization and joined the SYL, which he characterized as the youth group of the "Trotskyite ISL." He explained that after these few former members of the YPSL joined the SYL, the SYL then proceeded to change its name for its own purposes.

On April 9, 1956, another confidential informant advised as follows:

The YSL has frequently worked in close sympathetic cooperation with the ISL toward similar objectives, although each major issue given mutual consideration is decided upon by these organizations individually. The YSL serves as an apprenticeship for the ISL, but ISL selection of members from YSL ranks is made on an individual and personal basis. In many instances YSL members are also members of the ISL,

YOUNG SOCIALIST LEAGUE (YSL) CONT'D.

The YSL and ISL utilize the same printing house in New York City and the YSL publication is printed as an insert in "Labor Action." Frequently, lecturers before the YSL are ISL members.

The September 22, 1958, issue of "Young Socialist Challenge," which appeared as page five of "Labor Action," contained an updated statement from the National Action Committee of the YSL which indicated that the YSL had been dissolved. The statement appeared under the caption "Join the Young Peoples Socialist League."

The YPSL is publicly known as the youth affiliate of the Socialist Party-Social Democratic Federation.

APPENDIX

INDEPENDENT SOCIALIST LEAGUE (ISL) FORMERLY WORKERS PARTY (WP)

The May 4, 1942, issue of "Labor Action," then an official publication of the Workers Party (WP), carried an article which reflected that the WP was formed in April, 1940, as a result of a split within the leadership of the Socialist Workers Party (SWP). The article stated that when the Hitler-Stalin Pact was signed and Poland invaded, the minority group within the SWP, in proclaiming the formation of the WP, condemned the pact as being imperialistic in nature and stated it would not support either imperialist camp.

The April 25, 1949, issue of "Labor Action" contained an account of the Fifth National Convention of the WP, held March 24-27, 1949, in New York City, which reflected the change of name of the organization from the WP to the Independent Socialist League (ISL) in order to emphasize the character of the group as a propaganda group for the spreading of socialist ideas and not as a full-fledged political party.

The July 14, 1958, issue of "Labor Action," an official publication of the ISL, contained an article captioned, "The ISL Program in Brief." The article indicated: "The ISL stands for socialist democracy and against the two systems of exploitation which now divide the world: capitalism and Stalinism. The ISL, as a Marxist movement, looks to the working class and its ever-present struggle as the basic progressive force in society. The ISL is organized to spread the ideas of socialism in the labor movement and among all other sections of the people. There can be no lasting and genuine democracy without socialism and there can be no socialism without democracy."

The September 22, 1958, issue of "Labor Action" contained an undated statement signed by the Political Committee of the ISL which indicated that the ISL had been dissolved. The statement urged former ISL members to join the Socialist Party-Social Democratic Federation.

The SWP has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

SOCIALIST YOUTH LEAGUE (SYL)

A confidential informant has advised that the Socialist Youth League (SYL) began in 1945 when several militant members of the Young People's Socialist League (YPSL), the youth organization of the Socialist Party, accepted a proposal that they become affiliated with the Workers Party. The first issue of the group's newspaper, "Youth Action for Socialism," in October, 1945, contained an article which indicated that "...Only socialism can answer youth's needs for jobs, peace, education and a fuller life...Our organization is the only national revolutionary youth group in America."

The March 1, 1954, issue of the "Young Socialist Challenge," published as page three of "Labor Action," an official publication of the Independent Socialist League, contained an article concerning the creation of the Young Socialist League (YSL) which pointed out that at a unity conference occurring February 12-14, 1954, at Labor Action Hall, New York, New York, a merger occurred between the YPSL and the SYL.
