



8chan.co is a distributor of child pornography, and a center for the gamergate movement which you have an existing case on. I had heard that they hosted it on one their image boards and when I went to confirm it, I was able to do so within minutes. They are currently receiving \$1400 in funding each month from a company called Patreon, which is essentially funding and enabling a child porn distributor. When we tried to bring this to their attention after the discovery of this, the company declined to withdraw the funding. The site has a "rule" against posting said images, but the moderators do not actually remove images, and claim that doing so would violate the 1st amendment. The owner of the claims that all images and hate speech on the site are out of his control and are protected under the 1st amendment.
