FOR INFORMATION OF LEGAT, ON DECEMBER 1, 1981, BOSTON ADVISED THAT AN INDIVIDUAL EMPLOYED AT A SENSITIVE AIRFORCE INSTALLATION IN BOSTON RECEIVED A POSTCARD ON OR ABOUT MAY 10, 1981, FROM A DR. G. BULL, WHICH CONTAINED A RETURN ADDRESS OF EAST GERMANY. THE POSTCARD REQUESTED A REPRINT OF AN ARTICLE

By teletype dated 10/8/81, [redacted] revealed information provided by OSI that [redacted] employed at the [redacted] Hanscom Air Force Base, Massachusetts, received an unsolicited postcard on 5/10/81, requesting a reprint of an article [redacted] which appeared in an edition of "Journal of Geophysical Research." The postcard was signed by Dr. G. Ball and the return address was East Germany. The subject stated that the Dr. G. Ball could be Gerald Ball, a Canadian Scientist for whom the subject did research in the late 1960's or early 1970's. Subject stated that Ball was incarcerated during the early 1970's, presumably for selling the design of a projectile, used in sounding rockets, to the French Government. (u)
