ON MAY 10, 1988, SOURCE ADVISED THAT LARRY LAMPASI, A LONG TIME COLOMBO MEMBER WAS ASSIGNED TO RICHARD FUSCO'S CREW; ANTHONY PERAINO UNDER BILLY CUTOLO, AND ANTHONY MAGLIOCCO UNDER CHUCKY RUSSO.

ON MAY 17, 1988, SOURCE ADVISED THAT JAMES CLEMENZA, NOW RESIDING IN FLORIDA, ANSWERS TO CAPO JOSEPH TOMASELLO.

THE SOURCE ALSO SAID THAT JOE "GOOCH" (LAST NAME UNKNOWN "LNU"), OWNS A FLEA MARKET IN THE SHEEPSHEAD BAY AREA AND IS A COLOMBO MEMBER UNDER JOSEPH TOMASELLO.

THE SOURCE CONFIRMED THAT VIC ORENA, JR. AND JOHN STALUPPI ARE MEMBERS OF THE COLOMBO LCN FAMILY, AND NOTED THAT DENNIS "LNU", POSSIBLY DE LUCA, IS ALSO A MEMBER UNDER VINNIE ALOI.

ON JUNE 5, 1988, SOURCE ADVISED THAT JOE TOMASELLO HAS BASICALLY BEEN PUT INTO RETIREMENT AND IS NO LONGER A CAPO. ALSO JOE "WAVERLY" CACACE IS NO LONGER A CAPO, BUT IS ASSIGNED TO HANDLE THOSE MATTERS CONCERNING THE BOSS, UNDERBOSS, AND CONSIGLIERE.

THE SOURCE IDENTIFIED PHOTOS OF JOE CACACE, PATTY ANATO, AND THE

ON AUGUST 8, 1988, SOURCE ADVISED THAT ACTING CONSIGLIERE JIMMY ANGELLINO RECENTLY ASKED THE SOURCE OF THE WHEREABOUTS OF A RELIABLE FENCE. THE SOURCE SAID ANGELLINO APPEARS TO HAVE A SUPPLY OF STOLEN JEWELRY AND NEEDS A PLACE TO GET RID OF IT. BONANNO FAMILY (NY 92-9280 SUB A)

ON JULY 5, 1988, SOURCE ADVISED THAT BOBBY PERRETTE HAS REPLACED LOUIE ATTANASIO AS CAPO IN VIEW OF ATTANASIO'S CONVICTION, AND GABE INFANTI'S CREW HAS BEEN BROKEN UP AND ITS MEMBERS PLACED IN DIFFERENT CREWS.

DURING CAPTIONED PERIOD THE SOURCE HAS PROVIDED A CONTINUOUS UPDATE OF THE COLOMBO FAMILY STRUCTURE NOTING THAT SIGNIFICANT CHANGES IN ASSIGNMENTS ARE BEING MADE ON A MONTHLY BASIS, AND THE SOURCE IS PROVIDING SINGULAR INFORMATION CURRENTLY UNAVAILABLE FROM ANY OTHER SOURCE.

SOURCE SAID THAT COLOMBO MEMBER JOHN STALUPPI WAS THE SUBJECT OF A BIG ARTICLE IN NEWSDAY ABOUT A WEEK AGO, NOTING THAT HE HAD SEVERAL LARGE AUTO DEALERSHIPS AND WAS A MAN TO BE TAKEN SERIOUSLY. THE SOURCE SAID THE ARTICLE WAS VERY FAVORABLE WHICH AMUSED MANY COLOMBO MEMBERS. THE SOURCE SAID STALUPPI WAS BROUGHT INTO THE FAMILY BECAUSE OF HIS LEGITIMATE ENTERPRISES.

ON NOVEMBER 29, 1988, SOURCE ADVISED THAT JIMMY ANGELLINO WAS RECENTLY "HIT" ON ORDERS OF JUNIOR PERSICO, BUT THERE IS NO

ON NOVEMBER 29, 1988 SOURCE ADVISED THAT THE INDIVIDUAL SHOWN IN A PHOTOGRAPH WITH ANTHONY INDUISI IS COLOMBO MEMBER VINCENT ALOI, BROTHER OF COLOMBO UNDERBOSS BENNY ALOI. THE SOURCE NOTED THAT VINNIE ALOI FREQUENTLY TRAVELS TO FLORIDA.

THE SOURCE SAID THAT COLOMBO MEMBERS JOHN SAPONERO, JOEL CACACE, AND BOBBY ZAMBARDI HAVE BEEN OUT WITH CAPO CARMINE SESSA. THE SOURCE NOTED THAT ZAMBARDI AND SAPONERO WERE ORIGINALLY IN GREG SCARPA JR.'S CREW, BUT THAT CREW HAS BEEN REORGANIZED.

THE SOURCE SAID JOHN SAPONERO HAS BEEN TO SEE ANTHONY SCARPATI IN PRISON ON SEVERAL OCCASIONS AND IS BEING USED AS A CONDUIT FROM SCARPATI TO THE COLOMBO FAMILY.

ON NOVEMBER 29, 1988, SOURCE ADVISED THAT IT WAS GAMBINO BOSS JOHN GOTTI WHO FORCED THE COLOMBO FAMILY TO APPOINT A PERMANENT HIERARCHY SO THEY COULD SIT DOWN WITH THE OTHER FAMILIES. THE SOURCE SAID THAT THE "ACTING" DESIGNATIONS ARE A FORMALITY IN VIEW OF THE INCARCERATION OF JUNIOR PERSICO, JERRY BT

He has provided detailed and specific information regarding relationships between members of the Columbo Family, identified Columbo family crews and specified their individual crew responsibilities.

The source also provided information concerning a recent meeting between key Columbo members and John Gotti and other high ranking members of the Gambino family.

Additionally, the source advised Jimmy Angellino was "hit" on orders from Junior Persico for unknown reasons.

[redacted] identified John Pate of the Columbo Family as the operator of a major bookmaking and shylocking operation. He also identified Jimmy Dunne as the killer of small time marijuana trafficker Peter Crupio.

In a teletype dated 5/10/90, the New York Field Office requested an additional [redacted] in SAC payment authority for the captioned source on a C.O.D. basis. This informant has been operated on and off for the last twenty years, and, to date, has been paid a total of [redacted]. The last [redacted] roll over request was authorized on 4/14/89. This request will bring the total authorization level for this informant to [redacted].

The captioned informant is one of the most valuable organized crime sources operated by the New York Field Office. The source is a high-ranking member of La Cosa Nostra (LCN), and as such, is privy to meetings and conversations during which criminal activity is planned. The source has also been instrumental in providing strategic intelligence concerning the hierarchy of three New York Crime "Families", which enables the New York Field Office to direct its resources accordingly.

The informant is in a unique position to provide information relating to loansharking, labor racketeering, murder, extortion and drugs, primarily concerning the Colombo Crime Family. In addition, the source regularly furnishes information with respect to the daily activities of Gambino Crime Family Boss, John Gotti, and his associates. Of particular value was information which discloses a plot to murder a Bonanno Crime Family associate for the inadvertent shooting of one of Gotti's soldiers during the assassination of Top Ten Fugitive, Constabile "Gus" Farace. The informant identified Farace's killers and provided information concerning their affiliation with the New York LCN.

Since the last roll over request, the informant's information has been used to initiate both physical and electronic surveillances. The informant also provided probable cause for a recent Title III affidavit targeting members of the Colombo Crime Family Hierarchy. In addition, the captioned source regularly reviews surveillance photographs which assists the New York Field Office in identifying members and associates of the LCN.

The Criminal Informant/Witness Security Programs Unit, Investigative Support Section, CID, has reviewed this request and concurs with ADIC, New York, and recommends approval of an additional [redacted] payment authority.
