



ABEDIN had no memory of ever using the DELL for any purpose and had no knowledge of WEINER backing-up the content of the laptop to any other data storage device or to cloud storage. ABEDIN recalled WEINER using a desktop computer when she worked at the Department of State (DoS) and later transitioning to the DELL sometime after she left DoS. ABEDIN had no idea how her email content ended up on the DELL.	
(U//FOUO) At this point in the interview, Agents displayed a document with four phone numbers listed. After reviewing the document, ABEDIN stated phone number was her current phone number. Moreover, ABEDIN has used an iPhone in association with and has done so for approximately one and a half years. Prior to that, ABEDIN believed she used a BlackBerry handset for ABEDIN recognized phone number as a phone number currently used by WEINER. ABEDIN did not recognize the phone numbers and During HILLARY CLINTON's tenure as Secretary of State, ABEDIN was issued a DoS BlackBerry and a BlackBerry where she received her clintonemail.com email content. ABEDIN could not recall the phone number associated with either device, but believed her DoS BlackBerry had a 202 area code. Occasionally, ABEDIN would forward her unclassified state.gov email to her clintonemail.com email account. ABEDIN did not recall ever backing-up a phone handset or transferring the data from one device to another when she upgraded handsets. After reviewing the email, ABEDIN stated she did not recall the specific email but it represented a "typical" communication at the time. ABEDIN thought if she received an email on the unclassified network the person sending it had handled it properly and she had no need to question the classification. When asked what ABEDIN's understanding of the parenthetical "C" located in the body of the email was, ABEDIN replied her understanding has changed with what she has read in the media. During her time at DoS, ABEDIN stated she most likely would not have noticed the marking in the email and reiterated she had no need to question classification at the time. Currently, and after reading news reports, ABEDIN knows the portion marking "C" indicates the information that follows should not be in an unclassified email.
(U// <del>FOUO)</del> ABEDIN was shown an email dated March 13, 2011, with the subject "Fw: Mashabane Call Sheet." After reviewing the email, ABEDIN stated she did not recall the specific email, but Secretary CLINTON talked to Foreign Minister MASHABANE frequently. ABEDIN had no reason to believe the email was classified and trusted the judgment and handling of classified information by her colleagues at DoS. ABEDIN did not routinely forward DoS work email outside of DoS personnel.
(U// <del>FOUO)</del> At this point in the interview, ABEDIN requested a break in the interview and Agents left the conference room where the interview was taking place.
(U// <del>FOUO)</del> Upon reconvening, ABEDIN stated she may have forwarded the foregoing email to WEINER to print at ABEDIN's residence so she could provide a hardcopy document to Secretary CLINTON when she saw her later. ABEDIN stated she did not do that regularly.
(U//FOUO) ABEDIN was shown an email dated November 26, 2010 with subject "Fw: MbZ" and an email dated November 26, 2010 with subject "Fw: UAE on Wikileaks." After reviewing the emails, ABEDIN stated she did not recall the specific email but Secretary CLINTON made calls like this frequently. ABEDIN would have no reason to believe the email was classified and trusted the judgment of the DoS employees that emailed her. ABEDIN likely forwarded the email to WEINER to print at her residence so she could provide a hardcopy document to Secretary CLINTON.
(U//FOUO) ABEDIN was shown an email dated August 7, 2009 with subject "Re:" and stated she recalled the email and the exchange. ABEDIN stated Secretary CLINTON would occasionally hand her BlackBerry to ABEDIN to reply for her. 
