[REDACTED] of North Dakota State
University, Fargo, North Dakota, on May 11, 1967, advised as
follows:

Students of North Dakota State University have
circulated two petitions on the campus for student and faculty
signatures. One petition is in support of continued participa-
tion in the Vietnamese conflict and one petition advocates
withdrawal of United States forces from Vietnam. These
petitions will be made available to Vice President Hubert H.
Humphrey when he is on the campus May 13, 1967.

The Vice President will speak to students during
the afternoon of May 13, 1967, and answer questions of the
students. The student meeting is open to the public. No
demonstrations are expected by the University.

After the student meeting, the Vice President will
attend a reception at the Elk's Club in Fargo and during the
evening, he will speak at a testimonial dinner for Governor
William L. Guy at the Fargo Memorial Auditorium.

[REDACTED], advised on May 11, 1967, no
parade permits have been requested which would be required if
any person or groups of persons were going to demonstrate by
means of a parade. His department has no information of an
impending demonstration in connection with the visit of
Vice President Hubert H. Humphrey in Fargo, however, he said
such a possibility is being considered.

[REDACTED], advised as follows on May 13, 1967:

No disturbances occurred in connection with the visit of Vice President Hubert H. Humphrey at Fargo, North Dakota, May 13, 1967. A few persons carrying placards bearing anti-Vietnam war slogans were present during some activities attended by the Vice President. Also, there were persons who carried placards bearing slogans voicing agreement with the United States policy pertaining to Vietnam.

There were no placard carriers at the airport when the Vice President arrived in Fargo, North Dakota, at about 2:30 p.m. on May 13, 1967, although several thousand persons were present.

At North Dakota State University, Fargo, North Dakota, where the Vice President spoke and answered questions of students during the afternoon, approximately twenty persons carrying anti-Vietnam war placards, along with about twenty persons carrying pro-Vietnam war signs, lined the campus street traveled by the Vice President's motorcade. After he had passed the group, the signs were put away. There were no incidents in connection with the address in the University fieldhouse when the Vice President answered questions from the students.

Three persons carried anti-Vietnam war placards for a short time outside of the Fargo Memorial Auditorium building while the Vice President attended a testimonial dinner inside for North Dakota Governor William L. Guy during the evening.

The Vice President left Fargo, North Dakota, at 10:45 p.m. May 13, 1967.



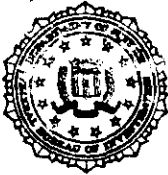

W. E. B. DU BOIS CLUBS OF AMERICA

conference of members of the Communist Party (CP), including national functionaries, met in Chicago, Illinois, for the purpose of setting in motion forces for the establishment of a new national Marxist-oriented youth organization which would hunt for the most peaceful transition to socialism. The delegates were told that it would be reasonable to assume that the young socialists attracted into this new organization would eventually pass into the CP itself. b7d

[REDACTED] the founding convention for the new youth organization was held from June 19-21, 1964, at 150 Golden Gate Avenue, San Francisco, California, at which time the name W. E. B. DuBois Clubs of America (DCA) was adopted. Approximately 500 delegates from throughout the United States attended this convention. The aims of this organization, as set forth in the preamble to its constitution, are: "It is our belief that this nation can best solve its problems in an atmosphere of peaceful coexistence, complete disarmament and true freedom for all peoples of the world, and that these solutions will be reached mainly through the united efforts of all democratic elements in our country, composed essentially of the working people allied in the unity of Negroes and other minorities with whites. We further fully recognize that the greatest threat to American democracy comes from the racist and right-wing forces in coalition with the most reactionary sections of the economic power structure, using the tool of anti-communism to divide and destroy the unified struggle of the working people."

Over the Labor Day weekend, 1965, the DCA held a conference in Chicago, Illinois, and a new slate of officers was elected to the National Executive Committee (NEC) of the DCA. Since Labor Day, 1965, identities of those serving on the NEC has varied; however, according to a third source, as of May, 1966, thirteen of the fifteen members of the NEC were members of the CP in the San Francisco Bay area.

As of July, 1966, the headquarters of the DCA was located at 180 North Wacker Drive, Chicago, Illinois.

THE REVOLUTIONARY COMMITTEE OF
THE FOURTH INTERNATIONAL

[REDACTED] that the Revolutionary Committee of the Fourth International (RCFI) was also known as the Spartacist Committee and the Spartacist Group. This source described the RCFI as being composed of former members of the Socialist Workers Party (SWP), who had split from the SWP and who were led by ~~JAMES ROBERTSON~~. [REDACTED] stated that this political unit has its main center in New York City, where it publishes "Spartacist" on a very irregular basis, but their formal meetings are held at least once a week.

[REDACTED]
FARRELL DOBBS, National Secretary of the SWP, sent a letter to all SWP branches in February, 1964, in which he advised that the expelled leader of a minority faction of the SWP, JAMES ROBERTSON, announced on February 10, 1964, that his faction would publicly criticize the SWP and had followed this with a public organ called "Spartacist" in which they attacked the SWP.

The July-August, 1964, issue of "Spartacist" in its masthead describes this publication as follows:

"... published bi-monthly by supporters of the Revolutionary Tendency expelled from the Socialist Workers Party."

This masthead sets forth that the editor of the publication is JAMES ROBERTSON, and its main address is Post Office Box 1377, General Post Office, New York, New York.

The SWP has been designated pursuant to Executive Order 10450.

"Mrs. Ethel B. Metz sat in a lawn chair inside the flow. At her feet were several paper bags and from them she distributed strips of black crepe paper that the marchers draped across their chests. A sprained ankle, bound with adhesive, prevented her from marching."

The article continued that the march commenced at approximately 4:30 p.m. and continued until approximately 5:15 p.m., followed by a silent vigil for a few minutes as they sat on the grass directed by Holtzman, who said, "Its been a very successful demonstration. Now we'll sit for a while and then go home."

The July 28, 1967 edition of the Boston Globe, a daily newspaper published in Boston, Massachusetts, contained an article by Gloria Negri, staff reporter, quoted Albert Szent-Gyorgyi, a Nobel Prize Winner, as saying, "The Government must talk to the people and make peace in Vietnam. This Government doesn't want to make peace. It just wants to destroy the people."

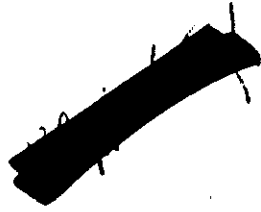

Pages H9662-H9663. Congressman Wyman, (R) New Hampshire, spoke concerning remarks made by Vice President Humphrey blaming Congress for abetting rioting. Mr. Wyman stated This is political demagoguery of the grossest kind. - - - We in the Congress just do not happen to agree that the answer to the problem of riots is more handouts. - - - The American people are afraid that the Johnson-Humphrey administration does not instruct its Attorney General and its Department of Justice to proceed full-blast against the militant inciters to riot and hatred. - - - There are ways and means for the Attorney General to deal with this sort of situation in cooperation with state enforcement authorities but the order has not gone out from the Johnson-Humphrey administration to crack down.

Pages H9751-H9757. Congressman Fraser, (D) Minnesota, commented on the address delivered by Vice President Humphrey at the convention of the League of Cities in Boston on July 31. He advised that he was concerned that some of the headlines in the newspapers and some of the television coverage gave the impression that the Vice President said the Congress is abetting riots. The Vice President did not make this charge - - -. He said to the mayors that the reluctance of the Congress to act on pending urban measures is one of the factors that abets frustration and denies to all levels of government the tools that they urgently need to do the job. - - - Indeed, a principal theme of the Vice President's speech was that the riots will be stopped and order will be restored, and that the 'malicious individuals who spark disorders will be found and prosecuted.' He included the text of the Vice President's speech with his remarks. Mr. Humphrey suggested to the League of Cities to consider establishing a special working group on community security. He stated Let's start to communicate with each other and pool our information together, - - -. I ask you to do this and have a group that can work with the Federal agencies, with the Justice Department, the FBI, and with the other law enforcement instrumentalities, as well as with the community agencies.

Ralph Humphrey Dies; Elder Brother of HHH

Ralph Humphrey, 60, elder brother of Vice President Hubert H. Humphrey, died last night in St. Barnabas Hospital in Minneapolis. He had been hospitalized three times in three months for treatment of cancer.

The Vice President, who was in Minneapolis at the time of his brother's death, is expected to stay here until funeral services are held in Huron, S.D. He has canceled an appearance before the annual American Legion convention Tuesday in Boston.

Ralph Humphrey was secretary-treasurer and general manager of H. H. Humphrey & Sons, Inc., the corporation that operates the family drug store in Huron. Hubert Humphrey is the firm's president.

Born in Granite Falls, Minn., Ralph Humphrey moved with his family to Wallace, S.D., and later to Doland, S.D., where his father operated the pharmacy in which he and Hubert worked as boys.

He attended Dakota Wesleyan University and the University of Minnesota. In 1931, during his senior year at Minnesota, he left school to work in the family drug store, which by that time was in Huron.

From 1934 to 1939 Mr. Humphrey was an administrator in the Federal Public Works Administration and the Works Progress Administration in Pierre and Aberdeen, S.D.

He then returned to the drug store, which he had managed since the death of his father in 1949.

A friend of the family in Huron recalled yesterday that Ralph and Hubert had been



Vice President with his brother, Ralph Humphrey, in 1964.

"very close" and shared many of the same interests.

"The Humphreys have never been known to be men of few words," the friend said. "Like Hubert, Ralph was outspoken, definite in his ideas, well-read and had a great interest in current events and politics."

In 1960 Ralph Humphrey traveled throughout South Dakota to raise support for his

brother's campaign for the Democratic presidential nomination. He toured the State again in 1964 when his brother was running for Vice president.

Besides the Vice President, Mr. Humphrey is survived by his wife, Harriet, his daughter, Christine Humphrey, of Huron, and two sisters, Frances Howard of Baltimore and Fern Baynes of Minneapolis.

John F. Preston, Conservation Aide

Mr. Preston worked as a forester for the U.S. Forest Service and the Hamann Paper Co. of Erie Pa., before joining the Soil and Conserva-

Deaths Elsewhere Adirondack Hermit, 84

LAKE PLACID, N.Y. (UPI)—Noah John Rondeau was buried Saturday in the Adirondack mountain country where he spent most of his life as a hermit.

Mr. Rondeau, known as the hermit of the Cold River Flow, was 84 when he died Tuesday.

Mr. Rondeau had spent more than 30 years in his hermitage, deep in the Cold River Flow area of the Adirondacks, when he came to the attention of sportsmen and conservationists in 1946. The next year he "came out" at the request of the State Conservation Department to appear at the annual sportsmen's show in New York City and he appeared at other similar events over the next few years.

Mr. Rondeau was born July 6, 1883 in the Jackson Hill section of Upper Jay, in the northern Adirondacks.

He was 30, having worked as a carpenter, barber and house painter, when he turned to the deep woods to get away from what he called the "slavery of industrialism."

"For almost 40 years I lived in the woods," he once said. "For almost 40 years I came out only occasionally for mail, for staples, for supplies, for ammunition."

"I never had a chance to learn anything formally," he said. "I was desperate to do so. I am a religious man. I have read and still read the Bible. There was the solitude which I sought in the Adirondacks."

But after leaving the woods in 1947, he never went back.

He is in Robertson, 73, the daughter of an Italian actress to star here away as leading lady. Actor George Arliss, who starred in several silent movies, in Sydney, Australia.

Nino Waellari, 70, chairman of the Finnish Seaman's Union and one of the most colorful personalities in Finnish history, died in Helsinki.

SUBJECT: REQUEST FOR USE OF BUREAU TELETYPE FACILITIES TO TRANSMIT SPEECH OF VICE PRESIDENT HUMPHREY

I just received a call from ASAC Larson of the Philadelphia Office stating he had had a telephone request from an individual identifying himself as an assistant to Vice President Humphrey who pointed out that the Vice President is scheduled to deliver a speech in Philadelphia tomorrow, 10-24-67, and wanted to have the speech sent to Philadelphia over Bureau teletype facilities.

In my memo to you of 10-10-66 I pointed out that a similar request had been made by an assistant of Vice President Humphrey's through the telephone company in Boston and I recommended at that time, and the Director approved, that he be told that since the Bureau's teletype facilities must be constantly available to send and receive urgent traffic, that it would not be possible to transmit the Vice President's speech over them. In that particular instance, a [redacted] of the telephone company in Boston had offered the use of telephone company facilities for this purpose.

RECOMMENDATION:

It is recommended that I tell ASAC Larson that he should advise Humphrey's assistant that it will not be possible to transmit the Vice President's speech over our teletype facilities in view of the urgent need for them by the Bureau, particularly in view of our heavy traffic due to the weekend demonstrations just completed. I will also suggest to Larson that he may wish to mention to Humphrey's assistant that it is understood that the telephone company in the past has offered such facilities in similar circumstances.

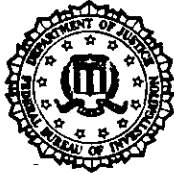

On December 4, 1967, Special Agents of the FBI observed 48 demonstrators at Midtown Plaza, Main and North Clinton Streets, Rochester, New York. The demonstration was timed to coincide with the arrival of Vice President HUBERT H. HUMPHREY at the Midtown Plaza where he made a luncheon address. The address dealt with the Model Cities Program under which, according to public sources in Rochester, New York, 63 cities are receiving Federal funds to alleviate city problems.

The demonstrators included members of Voters for Peace and Women's Strike for Peace who distributed leaflets. Members of the University of Rochester Chapter of Students for a Democratic Society (SDS) and other area college students were also observed in the demonstration. Members of FIGHT, although not participating in the demonstration, were observed in the vicinity of the demonstration distributing leaflets. The demonstration was directed against participation by the United States in the Viet Nam war.

At approximately 12:45 PM, shortly after the arrival of the Vice President at the Midtown Plaza, the demonstration was terminated and the demonstrators dispersed. No arrests were made.

A characterization of SDS appears in an attached appendix.

Women's Strike for Peace is an organization which has publicly taken a position opposing United States participation in the Viet Nam war.

An article in the July 20, 1966 edition of the "Democrat Chronicle," daily city-wide newspaper, Rochester, New York, publicly identified the formation of a group to be known as Voters for Peace. The article described the newly-formed group as favoring direct negotiations between the Saigon Government and the National Liberation Front, the political arm of the Viet Cong, preceded by an end to all United States bombing as an indication of this country's desire to negotiate.

FIGHT is publicly identified as an organization in Rochester, New York, formed to cooperate with the Industrial Areas Foundation (IAF). Its stated purpose is to organize the Negro community on a "grass roots level" to aid in the solution of problems of the Negro people.

The IAF is publicly identified as an organization with headquarters in Chicago, Illinois, and which is under the leadership of Executive Director SATEL DAVID ALINSKY. The announced purpose of the IAF is to supply leadership to the industrial communities and to study causes and solutions to problems affecting this area.

At approximately 10:00 P.M. January 4, 1968, an individual identifying himself as [redacted], telephonically contacted FBI Headquarters in Washington, D. C., to report an alleged plot to assassinate the Vice President of the United States.

[redacted] stated that he knew none of the five individuals involved by name [redacted] about five hours earlier in the evening and felt certain he could identify at least two of them if he saw them again. According to [redacted] all five individuals involved are male Negroes and were talking in general terms of killing the Vice President while "sitting around getting drunk." During the course of the conversation, [redacted] said, the five men asked him if he wanted to join them in the plot but he declined.

The two individuals that [redacted] believes he could identify are described as follows: (1) Negro male, approximately 22 years, 6 feet, 220 pounds, and wearing a mustache; (2) Negro male, approximately 25 years, 5 feet 8 inches, 130 pounds.
