

# Sen. Humphrey Backs Elected Governor, V. I. Commissioner

Senator Hubert Humphrey, looking every bit the Presidential candidate, flew into town for almost two hours yesterday, and during that short period, managed to shake at least 30 hands at the airport, confer with local Democratic leaders, drink a toast at Government House and hold an abbreviated press conference overlooking the harbor at Bluebeard's Castle.

The Minnesota Democrat emphasized that he intended to have his party's platform

carry a plank pledging both an elected governor and resident commissioner in Congress for the Virgin Islands.

"I think this is very important for you," Humphrey said at the press conference. "You don't get the same kind of dedication from an executive group (the Department of Interior) that you would from an elected legislative representative."

Talking with Government officials at Government House, Senator Humphrey commented that he was not only in favor of the proposed sea-water distillation plant for the Virgin Islands, but that "we should promote such water conversion plants on an international level."

"Atomic energy," he remarked, "is part of the answer, and as a by-product, you would get drinking water. This conversion problem is one of universal importance now."

At the press conference the Senator also commented on:

**Tax Incentives** — "I wouldn't want it to develop into an escape hatch merely to avoid tax laws in the Virgin Islands. I will oppose the Mills bill but work with Senator Murray of Montana in support of his bill. Such would give tax incentives for economic development."

**National Roads Act** — "I think it's a tragedy that the National Roads Act doesn't include the Virgin Islands. You are now on the threshold of a tremendous economic push."

**Nixon or Rockefeller** — "Both are able men and I know them well. I wouldn't want to select

a potential nominee, but I know full well what would happen to both in a national election."

**Khrushchev** — "Don't ever underestimate that man. He is tough-minded, cunning, a born propagandist, a hard worker, vital, vigorous, a pragmatist and a real tough competitor. We Americans had better get busy to face the challenge."

"The current administration," Humphrey emphasized, "has done nothing to inspire our younger people to better goals. And Khrushchev now is moving the struggle from a military to a social-economic one." (Humphrey had a private, eight-hour interview with Khrushchev in Moscow last year.)

**Red China** — I don't favor recognition of Red China. Difficulties between Red China and Russia are coming to the surface, but don't expect a breakthrough."

**Fidel Castro** — Senator Humphrey had no comment on Cuban Premier Castro or the Cuban situation in general.

The Senator left just after noon for a private plane trip to Puerto Rico, where he was scheduled to address a luncheon group.

## **'People, Peace, Progress' Needed, Says Humphrey**

CHRISTIANSTED, St. Croix, Virgin Islands, Dec. 1 — "America needs to clearly identify itself with **People, Progress** and **Peace** — this is the challenge and opportunity before us," Senator Hubert H. Humphrey told a Democratic Party rally here Tuesday night.

"Democracy is being challenged all over the world. Our task is to continuously expand and invigorate our own processes of government and to make this great nation of ours a democratic showpiece for the uncommitted areas of the world.

"In this, the second half of the 20th century, power is best defined by the words **People** and **Progress**. The balance of power for either democracy or communism lies in the great population centers of Asia, Africa, and Latin America. The people of these vast areas demand progress — economic and social progress. We dare not fail — our very freedom and survival require a victory for democratic values.

"We can be proud of our progress in recent years. Deeds are more impressive than words.

"Consider, for example, the former territories of Alaska and Hawaii. Their admission to statehood, accomplished by the two most recent Democratic Congresses, has demonstrated to the

Pages 1283-1285, Senator Humphrey, (D) Minnesota, requested to have printed in the Record a speech entitled "Disarmament in the Nuclear Age," which he delivered on December 8th at Yale University. Mr. Humphrey pointed out the importance of inspection for a peaceful world. He stated "Inspection and control recognize something about human nature. It recognizes that man is not perfect. If controls and regulations are needed in a well-organized national society, and they certainly are, they are even more important in relations among nation states. - - - Just let me list for you some of the ways we inspect each other. At the Federal level we have inspectors for a multitude of purposes: Food and drug inspectors; Coast Guard inspectors; narcotics inspectors; the Customs Service; the Secret Service; FBI agents; Civil Service investigators; and Atomic Energy inspectors."

Dak.; graduated Denver College of Pharmacy; University of Minnesota, A.B., University of Louisiana, M.A.; numerous honorary degrees; professor in political science, Macalester College, 1942-44; elected mayor of Minneapolis, 1945 & 1947; elected to U. S. Senate, 11/2/48; member and elected vice president, American Political Science Association, 1954; re-elected to U. S. Senate.

Information in Bureau Files: DATE 6-1-82 BY 7858/SA/cw/gw

Bufiles contain a great deal of information concerning Senator Humphrey. In brief, it shows that the communists in Minneapolis worked very aggressively to elect Humphrey mayor of Minneapolis in 1945. At this time, he was closely connected with known communists and communist-infiltrated organizations, however, these associations obviously were for political purposes, and he apparently used the communists for his personal gain. Following his election as mayor, he appointed an FBI National Academy graduate as Superintendent of Police; and in February, 1947, a Communist Party functionary in Minneapolis stated that the Party could no longer trust Humphrey. (62-26225-906) In later years, Humphrey led a fight to purge the communists from the Farmer-Labor Party and has been outspokenly anticommunist. Shortly after being elected mayor of Minneapolis in 1945, Humphrey called on the Director to advise that he was desirous of giving Minneapolis a clean, vigorous administration, particularly in the field of law enforcement. Investigation conducted in Nov., 1949, at request

of Department of Labor, as delegate to the 3rd Session of Iron and Steel Committee of the International Labor Organization in Geneva, Switzerland. (77-44669) In 10/50, Humphrey was the subject of a security investigation based on letter from Minneapolis citizen alleging he was a communist. Allegation not substantiated by investigation. Humphrey attended the FBI National Academy Graduation exercises 3/30/51. In April, 1956, in connection with Bertrand Russell's criticism of the Rosenberg case, the "Congressional Record" published extensive remarks by Humphrey in support of the FBI and the Government's handling of the Rosenberg case. Humphrey has professed a high regard for the Director and the Bureau on a number of occasions in recent years. We thanked him for his remarks byltr dated 4/25/56. (62-77485) Director wrote Senator Humphrey on 6/26/57 in connection with the accident involving the Senator's wife and daughter, wishing them a speedy recovery. According to the "Congressional Record," of 1/31/58, Senator Humphrey introduced a bill to increase the personnel of the FBI and to require special training of such personnel in order to provide for effective investigation of civil rights cases. (66-1731-1437) Byltr dated 5/16/58, Humphrey wrote the Director in connection with an invitation for the Director to speak at a city-wide celebration of United Nations Day. Director replied byltr 5/21/58, expressing regret that he could not comply. (94-51355-4) The Director wrote him a letter of congratulations on his election to the Senate on 11/4/48. Nov 1958.

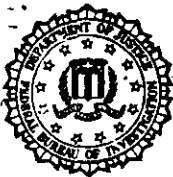



By memorandum dated 4-5-61, Senator Humphrey forwarded a letter he had received from [REDACTED] which was dated 3-29-61. The Senator's constituent advised him that he had previously written to the Director requesting the number of "card carrying" communist in the United States at nine specified dates. [REDACTED] alleged he had never received an answer to the letter he directed to the FBI and asked that Mr. Humphrey help him secure the desired data.

Bufiles indicate Senator Humphrey has previously forwarded letters from constituents which we have handled and advised him of the action taken. A thorough search of our files failed to disclose the receipt of the letter mentioned by [REDACTED]. We had one outgoing letter to him dated 7-20-44. At that time there was nothing of a derogatory nature in Bufiles concerning him. *bc*

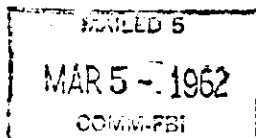

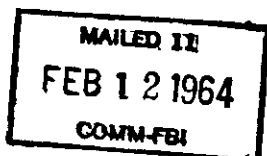

## A POSITIVE PROGRAM FOR ANTI-COMMUNISTS

Mr. HUMPHREY. Mr. President, I had been led to my attention recently a feature article in the Minneapolis Star, entitled "25 Do's and Don'ts: A Positive Program for Anti-Communists," prepared by William C. Sullivan, Assistant Director, Federal Bureau of Investigation, and originally given in a speech at the Highland Park Methodist Church, Dallas, Tex.

The editor notes that because a number of requests for this article were received, and because of recent events, several readers with good memories suggested to the Star that it reprint the article which was first printed on November 12, 1961.

I urge every American citizen to study the article carefully. Mr. Sullivan is to be commended for his constructive, thoughtful approach to the serious problem of combating communism in the United States. He does so in a most constructive, affirmative manner.

I ask unanimous consent that the article be printed at this point in the Record.

There being no objection, the article was ordered to be printed in the Record, as follows:

## TWENTY-FIVE DO'S AND DON'TS: A POSITIVE PROGRAM FOR ANTI-COMMUNISTS

(Editor's Note.—Because of a number of recent events, several readers with good memories have suggested the Star reprint the following article, which first appeared on this page November 12, 1961.)

(By William C. Sullivan, Assistant Director, Federal Bureau of Investigation, in a speech at the Highland Park Methodist Church, Dallas, Tex.)

In the battle that is now being waged between communism and the free world, our survival will depend on the strength, determination, and idealism engendered by our Judeo-Christian heritage.

In this global conflict, what is there that one can do (as a citizen or layman) in his local community to strengthen this heritage and to counter communism?

First, let us consider what one should not do:

1. Do not speak or act in any manner that would create fear, hysteria, and confusion. These are the ingredients for Communist coups in nations which have fallen under its spell," says J. Edgar Hoover, Director of the FBI.

2. Do not make false charges of communism against other citizens or sow seeds of suspicion, distrust, and alarmism.

3. Do not use, unless you are capable of accurately defining such ambiguous and misleading words and expressions as "Red," "radical," "leftist," "leftwing," "leftwing supporter," "Socialist," "collectivist," "self-

styled liberal," "rightist," "rightwing," "extremist supporter," "radical right," "reactionary," and "Fascist."

Such vague and obscure terms have nothing to contribute to a clear, intelligent, and objective understanding of difficult and complex social problems. Their use in the past has given rise to much of the current confusion in the field of communism and religion.

4. Do not confuse legitimate dissent with communism. Hoover gives this warning:

"Knowing what communism really is and how it operates will also help us to avoid the danger of confusing communism with legitimate dissent on controversial issues. Communism feeds on social ferment. On both the local and national levels, the Communist Party, U.S.A., is continually exploiting social, economic, and political grievances for its own tactical purposes. For this reason, the party line will frequently coincide with the views of many non-Communists on specific issues.

"We must not, therefore, indiscriminately label as Communists those whose opinions on a particular question may, on occasion, parallel the official party position. We must also guard against the tendency to characterize as Communists those who merely disagree with us or who advocate unorthodox or unpopular beliefs.

"When anyone is erroneously branded a Communist, it not only constitutes an injustice to the individual, but also helps communism by diffusing the strength of anti-Communist forces."

5. Do not engage in lawless vigilante action. "The job of curtailing and containing communism," Hoover admonishes, "is one for legally constituted authorities with the steadfast cooperation of every local citizen."

6. Do not contribute to bigotry, intolerance, and hatred of fellow human beings.

7. Do not violate or infringe upon any person's civil liberties.

8. Do not confuse the theological doctrine with political principles or attempt to make one serve the cause of the other.

9. Do not attribute all our social defects, difficulties, and setbacks to communism. Hoover emphasizes: "Attributing every adversity to communism is not only irrational, but contributes to hysteria and fosters groundless fears."

10. Do not fail to oppose all individuals, regardless of their ideological posture, who would subvert our social principles and traditions. Totalitarianism in any form must be rejected.

Now, let us consider what one man should and can do to reaffirm and reinforce our religious tradition and to combat communism:

1. Start with oneself. Engage regularly in self-examination as a means of better understanding, developing, and applying daily the moral and religious values of our Judeo-Christian heritage. We convince not by words but by example.

2. Study and comprehend fully our Nation's social principles, traditions, values, governmental structure, and historical goals. Relate them correctly to current local, national, and international events.

3. Elect government officials to local, State and Federal office who possess intelligence, ability and integrity.

4. Follow systematically the work and decisions of your elected representatives in government and let your views on important issues be known to them.

5. Understand Communist thought, objectives, strategy, and tactics. As Hoover points out:

"Communism is indeed, our paramount adversary, and it leans on its credo of invincibility and a concept of historical inevitability to accomplish its ends.

"The way to fight it is to study, understand it, and discover what can be done about it. This cannot be achieved by dawdling at the spring of knowledge; it can only be accomplished by dipping deeply into thoughtful, reliable, and authoritative sources of information."

6. Insist that every citizen is entitled under law to freedom of thought, expression, action, dissent, experimentation, education, and worship.

7. Join proven local institutions or establish new organizations designed to improve and strengthen the community. Participate in them regularly and effectively.

8. Eradicate the causes of communism in local communities. These include: (a) poverty, (b) disease, (c) illiteracy, (d) economic dislocation, (e) social injustices, (f) social discrimination, (g) political corruption, (h) educational inadequacies, (i) psychological maladjustments, (j) philosophical materialism, (k) religious anemia, and (l) moral decadence, personal, and social.

9. Work steadily toward better relations between races, religions, and different social groups and between labor and management.

10. Encourage in one's local community original thinking, intellectual pioneering, and moral growth.

11. Contribute to a continuous community, beginning with oneself.

12. Stimulate cultural diversity, variety, and creativity, for the unity we seek is not uniformity.

13. Help to direct individual and community thinking into constructive action replete with social vision, because it is as true today as it was centuries ago when it was stated that where there is no vision the people perish.

14. Develop and hold forth as a community goal for the young and old alike self-discipline, personal responsibility, dedication to worthy causes, loyalty to basic values, and a deep-rooted set of convictions in the inherent dignity and preciousness of every human being and the superiority of a free and open society in which every individual has an equal opportunity to achieve self-realization.

15. Recognize that while there are both permanence and change in life, there is no fixed status quo; hence, our need to understand social transitions and to control and to direct these transitions in accordance with the spiritual and moral values of the Judeo-Christian tradition.

Albuquerque is not a large city and many of our Agents are quite well-known to news reporters and Agents' presence at the airport and motel could well cause speculation by the press. We have instructed Albuquerque telephonically that Agents are not to cover Humphrey's appearances in Albuquerque.

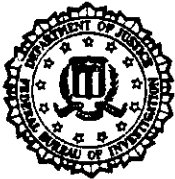

At the time of the telephone call, Vice-Presidential Candidate HUBERT H. HUMPHREY was speaking at the Terminal Building approximately seventy-five yards from the location of the lockers.
