Prior to and during his speech, a picket line outside but in the vicinity of the UW Memorial Union of 60 persons, most of them carrying signs "Get Out of Vietnam" marched and sang in orderly fashion. The participants were predominantly UW student members of Committee to End War in Vietnam [REDACTED] **b7c**

Mimeographed leaflets were also handed out urging U. S. to get out of Vietnam, issued by the UW Student Peace Center [REDACTED] who marched in the picket line. **W.S.**

Vice President HUMPHREY's theater audience consisted of NSA delegates, all of whom were courteous, orderly and there were no untoward incidents. **W.S.**

The local anti-Castro organizations in Tampa plan to band together and meet on August 27, 1965, at the Curtis Hixon Convention Hall in Tampa on the occasion of the presence of Vice President Hubert H. Humphrey. These organizations plan to station between 50 and 60 of their members outside the Convention Hall carrying placards, posters, and the Cuban flag. The inscriptions on the posters and placards will be generally favorable to United States foreign policy and will state, "We Support Johnson and Humphrey," "United States Action in Viet Nam Approved", "Viet Nam Yes; Why Not Cuba Also".

In addition the organizations plan to station approximately 10 people at the entrance doors of the convention hall in a position to distribute pamphlets and leaflets to all persons entering the hall. These pamphlets and leaflets will refer to United States foreign policy, especially with regard to United States relations with Cuba, the Dominican Republic, Viet Nam, and various Latin American countries. The pamphlets will be generally favorable toward

United States foreign policy, but will question why the United States is helping the Viet Nameese people to remain free and not helping the Cuban people to regain their freedom. Additionally, these organizations plan to station members inside the Convention Hall in the aisles leading up to the speaker's rostrum and these members will carry various posters, placards, and the Cuban flag. It is planned to have a girl named [REDACTED]

[REDACTED] proceed up the main aisle accompanied by a local Tampa [REDACTED] and present Vice President Humphrey with the Cuban flag and a leaflet similar to the ones being passed out at the doors of the hall. Mr. Triay advised that he was assigned by the organizations to relate the plan to the FBI, Tampa Police Department, and Hillsborough County Sheriff's Office. He stated that other delegations were to contact the local newspapers in Tampa, Congressman Sam Gibbons, and local business leaders. Among the anti-Castro organizations taking part in the project are the following: La Patria Libre, Alpha 66, The Second National Front of the Escambray, JURE, MRP, The CACALC, and the Professional Cuban Architect Association. b7c

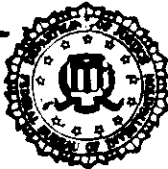

The caller stated, "Listen. I'm only going to say this once so get it straight. Humphrey is going to be shot." The caller then immediately hung up. b7c

[REDACTED] immediately telephonically contacted [REDACTED] in charge of the detail of local officers at the Moline, Illinois airport, and also contacted [REDACTED] United States Secret Service, at the Moline Airport, advising them of the receipt of this anonymous call and threat.

The Vice-President's plane arrived at the Moline, Illinois airport at 2:05 PM, and the Vice-President departed at 2:15 PM in a plane for Wilton Junction, Iowa. Vice-President Humphrey arrived back at the Moline Airport at 4:25 PM this date and departed at 4:58 PM. No incidents occurred.

[REDACTED] that a reorganizational meeting of the Lares Board was called by independentist attorney CARLOS CARRERA BENITEZ and was held on August 22, 1962, at the Darlington Hotel in Rio Piedras, Puerto Rico, with the six major pro-independence organizations, including the PARTIDO COMUNISTA PUERTORRIQUEÑO (Communist Party of Puerto Rico) (PCP) and the NATIONALIST PARTY OF PUERTO RICO (NPPR), in attendance. At this meeting the Lares Board was actually established as a permanent body to coordinate the efforts of the independence groups, its immediate purpose to begin a program of activities opposing the plebiscite recently proposed by Puerto Rico Governor LUIS MUNOZ MARIN to establish a permanent political status for Puerto Rico.

[REDACTED] the Lares Board is composed of a President, a Secretary General, two delegates from each of the member groups, and seven delegates at large. Each member group is to retain its own organizational identity and the Lares Board is to function as a coordinating body in matters of mutual agreement. No headquarters was established.

GRITO DE LARES observances were sponsored by the MESA DE LARES on September 22 and 23, 1963, at Lares, Puerto Rico, with the major independence groups participating. At this time the Second Declaration of Lares was promulgated, which in essence stated that within five years GRITO DE LARES ceremonies would be held on that spot in a free and independent Puerto Rico.

MOVIMIENTO PRO INDEPENDENCIA DE PUERTO RICO
(Puerto Rican Independence Movement) (MPIPR)

The MPIPR was organized November 23, 1959, at Ponce, Puerto Rico, according to its first Secretary General, JUAN MARI BRAS, for the avowed purpose of working for the independence of Puerto Rico. It was stated that the organization did not advocate violence but would accept anyone who believed in Puerto Rican independence regardless of his beliefs as to the use of violence provided he agreed with the MPIPR Declaration of Principles.

Since its inception, the MPIPR has had as its leader and guiding force JUAN MARI BRAS who, speaking on behalf of himself and the organization, said the MPIPR does not advocate violence as a means of obtaining independence for Puerto Rico only because he felt violence would be ineffective against the power of the United States Government. He stated that he believed in the right of the Puerto Rican people to use violence to obtain their freedom if and when the circumstances were such that they could possibly be successful in their efforts.

[REDACTED] the MPIPR Secretary of Youth, BENJAMIN ORTIZ BELAVAL, stated that although the use of arms and violence is not presently advantageous to the Puerto Rican independence movement, the right would be reserved to use arms and violence in the future.

The MPIPR has missions throughout the Island of Puerto Rico and in New York, New York; Chicago, Illinois; and Buffalo, New York. It has an estimated membership of between 1,000 and 1,300 persons according to Police of Puerto Rico.

Since its inception, MPIPR and its leaders have frequently expressed sympathy for the communist revolution in Cuba and with the Castro Government in Cuba.

The "National Guardian," a weekly New York, New York newspaper, in its issue of January 9, 1965, carried an article captioned, "SDS Calls April 17 Demonstration in Washington," in which it was indicated the SDS would sponsor a "Student March on Washington," April 17 (1965) to demand an end to United States intervention in the Vietnam war. The article continued that the SDS constitution describes it as a group of "liberals and radicals, activists and scholars, students and faculty," united to work toward a society in which "the people have control of the decisions that affect them and the resources on which they are dependent." The article continued the "SDS, in recent years, has moved away from a sectarian approach and toward the new left.

The "National Guardian" is characterized in the appendix.

On October 21, 1965, a representative of the Security Section, The Boeing Company, Seattle, advised dedicatory activities will extend throughout the day on October 30, 1965. Vice President HUMPHREY is scheduled to arrive at the Kent Space Laboratory about 10:10 AM, begin his dedicatory remarks about 10:40 AM, and will leave the area about 11:20 AM, en route to downtown Seattle for a luncheon.

On October 21, 1965, local military and appropriate law enforcement agencies, as well as Secret Service and the USA, were advised of this proposed demonstration.

After above individuals were advised of the proposed demonstration, [REDACTED] The Boeing Company, reported on October 21, 1965, information had been received from Washington, D. C., to the effect that Vice President HUMPHREY's visit had been canceled. b7c

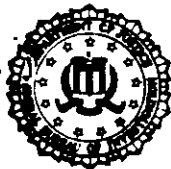

The October 20, 1965, edition of the "New Haven Journal Courier", a daily newspaper published at New Haven, Connecticut, contains an article entitled, "City Girds For Visit By Humphrey", which sets forth in part, "A tight security net will surround Vice-President Hubert H. Humphrey when he visits New Haven, Thursday (October 21, 1965) for the first of a series of regional seminars on urban problems, federal and local officials disclosed Tuesday. The Vice-President will conduct the conference for New England mayors at the Jewish Community Center, 1162 Chapel Street, at 12:30 PM. After the three hour meeting, Humphrey will attend a reception given by Mayor Richard C. Lee at the Yale Art and Architecture Building." This article also set forth, "A group of Yale students is planning to demonstrate in favor of U.S. foreign policy when Humphrey is here, it was announced Tuesday. Flyers announcing the demonstration said, 'we believe that most Yale students, no matter what their opinion of the war in Vietnam, have no sympathy with groups which feel it necessary to deny their duties as U.S. citizens in order to show their desire for a solution in Vietnam'. [REDACTED], a conference of members of the Communist Party, USA (CP, USA), including national functionaries, met in Chicago, Illinois, for the purpose of setting in motion forces for the establishment of a new national Marxist-oriented youth organization which would hunt for the most peaceful transition to socialism. The delegates to this meeting were cautioned against the germ of anti-Soviet and anti-CP ideologies. These delegates were also told that it would be reasonable to assume that the young socialists attracted into this new organization would eventually pass into the CP itself.

A second conference of over 20 persons met in Chicago on December 28-29, 1963, for the purpose of initiating a "call" to the new youth organization and planning for a founding convention to be held in June, 1964.

[REDACTED] that the Founding Convention for the new youth organization was held during the period of June 19-21, 1964, at 150 Golden Gate Avenue, San Francisco, California, at which time the name W. E. B. DuBois Clubs of America was adopted. Approximately 500 delegates from throughout the United States attended this convention. The aims of this organization, as set forth in the preamble to the constitution, are: "It is our belief that this nation can best solve its problems in an atmosphere of peaceful co-existence, complete disarmament and true freedom for all peoples of the world, and that these solutions will be reached mainly through the united efforts of all democratic elements in our country, composed essentially of the working people allied in the unity of Negroes and other minorities with whites. We further fully recognize that the greatest threat to American democracy comes from the racist and right wing forces

The constitution further states this new organization shall be a membership organization open to individuals or, if five or more people so desire, a chapter can be formed which shall in turn be guided by the policies and principles of the parent organization.

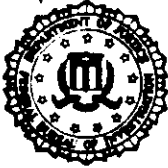

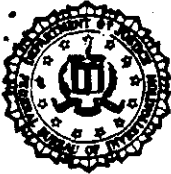
