POSSIBLE SPORTS BRIBERY, OO: LAS VEGAS

ON AUGUST 11, 1983,

CAESARS PALACE HOTEL AND CASINO, LAS VEGAS, NEVADA,

ADVISED THAT ON AUGUST 10, 1983 THE SUBJECTS WHO ARE KNOWN LAS VEGAS WAGERERS WITH LCN CONNECTIONS APPEARED AT CAESARS PALACE SPORTS BOOK AT APPROXIMATELY 12:30PM LAS VEGAS TIME AND ATTEMPTED TO BET LARGE AMOUNTS OF MONEY (IN EXCESS OF SEVERAL THOUSAND DOLLARS) ON A HORSE NAMED LEES SUN RUNNING IN THE THIRD RACE AT ARLINGTON PARK CHICAGO THAT DATE. THE SPORTS BOOK MANAGER WAS AT LUNCH AT THE TIME, HOWEVER,

RECOGNIZED THE SUBJECTS AND ONLY ALLOWED LESSER AMOUNTS OF MONEY

TO BE BET AS HE SUSPECTED A "FIX" MAY HAVE BEEN INVOLVED.

[REDACTED] ADVISED THAT THE HORSE WON THE RACE AND PAID \$39.00 TO WIN, \$13.40 TO PLACE AND \$6.80 TO SHOW. [REDACTED] STATED HE LATER DETERMINED THAT AN UNKNOWN ASSOCIATE OF [REDACTED] MADE A BET OF \$20.00 ON THE HORSE. HE STATED HE DETERMINED FURTHER THAT AT ABOUT THIS SAME TIME [REDACTED]

[REDACTED] WERE OBSERVED IN THE HOTEL. [REDACTED] STATED THAT RACING FORM INFORMATION REFLECTS THAT LEE'S SUN WAS A FOUR YEAR OLD HORSE RACING IN THIS RACE WITH THREE OTHER FOUR YEAR OLD HORSES AND SEVEN OTHER THREE YEAR OLD HORSES. THE JOCKEY IS LISTED AS [REDACTED] THE OWNER-TRAINER IS LISTED AS [REDACTED]

[REDACTED] ADVISED THAT HE WOULD ATTEMPT TO DETERMINE FROM OTHER RACEBOOKS IN THE LAS VEGAS AREA HOW MUCH ACTION THEY HAD ON THIS HORSE.

LEAD: CHICAGO DIVISION, AT CHICAGO, ILLINOIS, CONDUCT APPROPRIATE INVESTIGATION TO DETERMINE IF SPORTS BRIBERY IS INVOLVED IN THIS MATTER.
