Three fingerprints link suspect to stabbing deaths, detective testifies

Three fingerprints link 16-year-old Jose Sosa to last month's stabbing deaths of Lori Ann and Adrian Rountree in south Nashville, police detectives testified on Friday. The mother and daughter were found dead in their Creekside Drive home on April 25. Sosa, who lived next door, was arrested Wednesday night or early Thursday morning.

Police offered no motive for the killings during Friday's hearing and said there were no witnesses who had ever seen Sosa with the

victims.

"I kept asking if for any reason he had been inside the house, and he said, 'No.' " detective Marvin Rivera said. "He kept saying 'No.' "

However, detective Wil Nesbitt testified that at least one of Sosa's fingerprints was found inside the home. Two more fingerprints, one of them bloody, were found on a back door, Nesbitt said. Lori Ann Rountree, 44, received about 37 wounds that punctured her stomach, heart, liver and major arteries. Adrian, 16, had about 46 wounds to the lungs and major arteries.

Although there were signs of a struggle at the scene, police said they did not notice any wounds on Sosa on the day they found the bodies. Nesbitt also did not see any signs of a forced entry into the house, he said.

Sosa was ordered to remain in juvenile detention until a June 23 hearing, when Assistant District Attorney Jeff Burks said he will ask to have Sosa tried as an adult.

After Friday's hearing, Juan Sosa, the defendant's brother, raised his voice and began saying in Spanish that the police had no proof against his brother. Rivera told him to step outside the courtroom and then arrested him on a charge of disorderly conduct.

Juan Sosa said in an interview on Thursday that his brother was with other people when the slaying occurred and could not have done it.

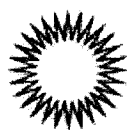

Mr. Fox, Cough Up \$300,000

John Trumbo, a sheriff in northeastern Oregon, sends Mexico's president a letter asking for funds to help pay for jailed illegal immigrants.

PENDLETON, Ore. — Out of ideas and low on cash one cold morning, the man with the biggest badge in town put his meaty fingers on a keyboard and tapped out a letter to the leader of Mexico.

"Dear Precidente [sic] Fox," it began.

"My name is John Trumbo. I am Sheriff of Umatilla County in northeastern Oregon, United States of America." Illegal immigrants "from your country" who committed crimes here, the letter said, cost Americans lots of money.

Last year, more than 360 of "your citizens" spent time in jail "at a cost of \$63 a day which equates to a request for payment of \$318,843," the letter concluded. "At this time, you will not be billed for medical, dental and transportation costs. Your prompt attention to this request will be very much appreciated."

Three months later, Trumbo reports, Vicente Fox still has not paid up. The Mexican president has issued no response, no installment payment, nada.

The silence has reverberated at the Umatilla County Justice Center, a complex of modular beige buildings set among rolling hills of wheat. Here, the influx of Mexican immigrants — many of them illegal and a portion criminal — has become an increasingly prickly issue. Trumbo's letter voiced the growing frustration of a region that has been compared to the California farmlands of the 1950s and 1960s — a place going through a transition in racial demographics.

Between 1990 and 2000, Umatilla County's Latino population, including legal and illegal immigrants, jumped 114% to 11,400 people, according to the Census Bureau. This doesn't include thousands of seasonal workers who

live here part of the year and many others who choose not to be counted.

About 70,000 people live in the county.

In towns such as Hermiston, Umatilla and Milton-Freewater, Latinos occupy entire neighborhoods, and the beginnings of "Little Mexico" commercial areas have taken hold. The neighborhoods tend to be poorer, and many residents blame Latino immigrants for the region's gang and drug problems.

Public schools have become increasingly populated by Latinos. In Milton-Freewater and Umatilla, with a combined enrollment of about 3,300, Latinos make up half of the student body. No one knows how many are children of illegal immigrants because federal law prohibits schools from asking about parents' immigration status.

Undocumented residents also have access to state and county services for drug and alcohol treatment, mental health, domestic violence and nutrition. While there's grousing about taxpayer money being used for these services, nothing ignites more anger than illegal residents who end up in the criminal justice system.

"They already broke the law once coming over here," says Pendleton resident Elaina Solomon, 49, an emigre from Honduras who works as a legal assistant. "Then they commit murders and robberies while they're here. Why should we pay for their room and board at the jail? Why should we foot the bill?"

Trumbo's letter to Fox resonated with Solomon and many other county residents even as some in the Latino community privately grumbled.

To anyone who asked, Trumbo explained:

The county has a daily jail capacity of 252 inmates but can afford staff and services for only 135. The sheriff's office should have a minimum of 27 patrol officers but can fund only nine. Between 2 a.m. and 8 a.m. each day, no patrol officer is on duty.

"When people call the police, they expect to see the police," Trumbo says. "They see it on TV all the time. But there are times when I can't send anybody because I don't have anybody because I don't have the money."

One reason, he says, is because the department spends so much of its \$6.5-million annual budget on apprehending and jailing illegal immigrants. He understands that the immigration debate is complex and he hopes the people in Washington, D.C., are working to solve the problem soon.

He has no problem with Latinos personally, he says. "Some of my best friends," Trumbo says, "are Hispanic." He just wanted to tell someone, anyone, about the situation here. Sometimes a sheriff in rural eastern Oregon can feel like his words dissolve in the wind, like a coyote's howl.

Is anyone out there listening?

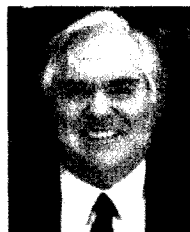

WASHINGTON - A jury Tuesday convicted a former Bush administration official of four counts of lying and obstructing justice in the first trial to be held in connection with the influence-peddling scandal of lobbyist Jack Abramoff.

On the fifth day of deliberations, the jury found David Safavian - a former chief of staff at the General Services Administration - guilty of four of five counts of lying and obstructing justice.

Safavian sat impassively as the judge read the verdict and showed no expression when the judge announced the guilty verdicts on each of four counts. Sentencing was scheduled for Oct. 12.

Each of the counts carries a maximum sentence of 5 years in jail.

Real estate and a golf trip

Safavian was charged with lying about his relationship with Abramoff and his knowledge of the lobbyist's interest in acquiring properties from GSA, the property managing agency for the federal government. He was also charged with obstructing investigators looking into a golf trip he took with Abramoff in 2002.

The trial consumed eight days of testimony about Safavian's assistance to Abramoff regarding government-owned real estate and a weeklong golfing excursion the lobbyist organized to the famed St. Andrews golf course in Scotland and London.

Safavian went on the trans-Atlantic trip while he was chief of staff at the GSA, and other participants included Rep. Bob Ney, R-Ohio, two Ney aides and Christian Coalition founder Ralph Reed. The jury found Safavian guilty of obstructing the work of the GSA inspector general and of lying to a GSA ethics official. It also convicted him of lying to the GSA's Office of Inspector General and of making a false statement to the Senate Indian Affairs Committee. He was acquitted of a charge of obstructing the committee's investigation.

First case from Abramoff scandal

This was the first trial to emerge from the scandal surrounding Abramoff, who is a former business partner of Safavian. Abramoff, who has pleaded guilty to federal crimes here and in Miami, would likely be a witness if the Justice Department assembles criminal cases against any members of Congress.

The government made its case without ever putting Abramoff on the witness stand. It relied on the testimony of the officials Safavian was accused of deceiving.

A key witness in the case was Neil Volz, a convicted partner of Abramoff's and ex-chief of staff to Ney.

Prosecutors introduced hundreds of e-mails exchanged among Safavian, Abramoff, Volz and others in 2002.

The Justice Department made a case that Safavian provided Abramoff advice and some inside information about two government properties including the Old Post Office in downtown Washington.

Prosecutors said Abramoff wanted to buy or lease part of the GSA's White Oak property in the Maryland suburbs for use by a Jewish school he had established. They also said he wanted to give an Indian tribe client a leg up on obtaining the contract to redevelop the Old Post Office in as a luxury hotel, near two restaurants Abramoff owned.

One of their 'champions' inside government

Volz testified the Abramoff team referred to Safavian as one of their "champions" inside government, who could give them insider information they couldn't get elsewhere. He said Safavian was the mastermind of some of the strategy for developing congressional pressure or action to sway GSA.

Volz said they tried to keep this maneuvering secret.

Prosecutors showed that Safavian's advice began right after he went to work at GSA and was intensely pursued in the weeks before Safavian went on the weeklong golfing expedition to Scotland in August 2002. Abramoff had arranged the trip for members of Congress and invited Safavian to come along when one of them dropped out. Safavian took the stand for two days in his own defense. He acknowledged some misjudgments and forwarding Abramoff some insider information, such as the position of other government officials on the GSA properties, but attributed these errors to his inexperience.

Basically he maintained he simply gave generally available information to an old friend who was inquiring about government property that the GSA had not even decided what to do with yet.

He said he answered all investigators' questions. Safavian said he didn't volunteer information about his advice on the two properties. Safavian said he didn't consider Abramoff was doing or seeking business with GSA because the agency wasn't letting contracts at the time.

\$3,100 check didn't cover trip costs

Safavian claimed he thought he paid all of his costs with a \$3,100 check to Abramoff on takeoff, though he acknowledged that trial testimony had shown him some elements were more expensive than he thought.

Prosecutors said the trip of nine participants cost more than \$130,000. They scoffed at the notion anyone could think \$3,100 would cover his share of chartered jet travel, \$400 and \$500-a-night hotels, \$400 rounds of golf and \$100 rounds of drinks.

GSA officials and a Senate investigator said Safavian never told them about the advice he was giving Abramoff on the two properties or details about the Scotland costs. They also said they would have wanted to hear that. The GSA officials said if they had known, they might have ruled differently on his request to go on the trip. The GSA Inspector General's office closed an investigation of the trip without taking any action against Safavian in 2003. Safavian's problems didn't begin until 2004 when investigators began looking into Abramoff's illegal conduct.

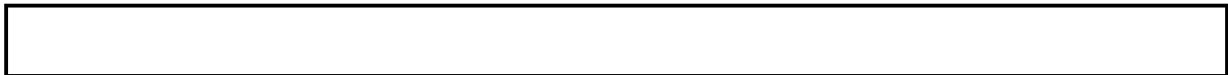

Israel is one of the world's leading weapons exporters. Deals must be cleared through the Defense Ministry, but in past years there have been a number of cases of ex-army officers negotiating deals on their own, or taking on military training missions in foreign countries without approval.

In December, an investigative report by another daily, Yediot Ahronot, alleged that **a number of private Israeli companies won contracts to provide security services to the Kurdish government in Iraq.** The report said Israelis who had served in elite military combat units were **teaching anti-terrorism methods to the Kurds.**

At the time the Defense Ministry said, **"we haven't allowed Israelis to work in Iraq, and each activity, if performed, was a private initiative, without our authorization, and is under the responsibility of the employers and the employees involved."**

b7C**isn't this quite interesting?****An Anonymous Email From An Airline Mechanic**

For reasons you will understand as you read this I can not divulge my identity.

I am an aircraft mechanic for a major airline. I work at one of our maintenance bases located at a large airport. I have discovered some information that I think you will find important.

First, I should tell you something about the "pecking order" among mechanics. It is important to my story and to the cause to which you have dedicated yourself.

Mechanics want to work on three things. The avionics, the engines, or the flight controls. The mechanics that work on these systems are considered at the top of the "pecking order".

Next come the mechanics that work on the hydraulics and air conditioning systems. Then come the ones who work on the galley and other non-essential systems. But at the very bottom of the list are the mechanics that work on the waste disposal systems.

No mechanic wants to work on the pumps, tanks, and pipes that are used to store the waste from the lavatories. But at every airport where I have worked there are always 2 or 3 mechanics that volunteer to work on the lavatory systems.

The other mechanics are happy to let them do it. Because of this you will have only 2 or 3 mechanics that work on these systems at any one airport. No one pays much attention to these guys and no mechanic socializes with another mechanic who only works on the waste systems.

Fact is, I had never even thought much about this situation until last month. Like most airlines we have reciprocal agreements with the other airlines that fly

into this airport. If they have a problem with a plane one of our mechanics will take care of it.

Likewise, if one of our planes has a problem at an airport where the other airline has a maintenance base, they will fix our plane.

One day last month I was called out from our base to work on a plane for another airline. When I got the call the dispatcher did not know what the problem was. When I got to the plane I found out that the problem was in waste disposal system. There was nothing for me to do but to crawl in and fix the problem.

When I got into the bay I realized that something was not right. There were more tanks, pumps, and pipes than should have been there. At first I assumed that the waste disposal system had been changed. It had been about 10 years since I had worked on this particular model of aircraft.

As I tried to find the problem I quickly realized the extra piping and tanks were not connected to the waste disposal system, at all. I had just discovered this when another mechanic from my company showed up. It was one of the mechanics who usually works on this particular type of plane, and I happily turned the job over to him.

As I was leaving I asked him about the extra equipment. He told me to "worry about my end of the plane and let him worry about his end!"

The next day I was on the company computer to look up a wiring schematic. While I was there I decided to look up the extra equipment I had found. To my amazement the manuals did not show any of the extra equipment I had seen with my own eyes the day before. I even tied in to the manufacturer files and still found nothing. Now I was really determined to find out what that equipment did.

The next week we had three of our planes in our main hanger for periodic inspection. There are mechanics crawling all over a plane during these inspections. I had just finished my shift and I decided to have a look at the waste system on one of our planes. With all the mechanics around I figured that no one would notice an extra one on the plane.

Sure enough, the plane I choose had the extra equipment! I began to trace the system of pipes, pumps, and tanks. I found what appeared to be the control unit for the system. It was a standard looking avionics control box but it had no markings of any kind.

I could trace the control wires from the box to the pumps and valves but there were no control circuits coming into the unit . The only wires coming into the unit was a power connection to the aircraft's main power bus. (Neill's Comment : For the non-techie that means the control unit was completely stand alone and received no data control input or output to the actual Aircraft Electrical/Electronic [Avionic] systems, only a power tap into the main aircraft power bus - a bit like

plugging in your hair dryer . There is no such installation on commercial aircraft where a major system like this is divorced from all aspects of the aircraft control systems. I know, I worked in Boeings commercial airplane flight test group for 5 years while FAA certifying the 747 and several other models.)

The system had 1 large tank and 2 smaller tanks. It was hard to tell in the cramped compartment, but it looked like the large tank could hold about 50 gallons. The tanks were connected to a fill and drain valve that passed through the fuselage just behind the drain valve for the waste system.

When I had a chance to look for this connection under the plane I found it cunningly hidden behind a panel under the panel used to access the waste drain.

I began to trace the piping from the pumps. These pipes lead to a network of small pipes that ended in the trailing edges of the wings and horizontal stabilizers.

If you look closely at the wings of a large airplane you will see a set of wires, about the size of your finger, extending from the trailing edge of the wing surfaces. These are the static discharge wicks. They are used to dissipate the static electric charge that builds up on a plane in flight.

I discovered that the pipes from this mystery system lead to every 1 out of 3 of these static discharge wicks. These wicks had been "hollowed out" to allow whatever flows through these pipes to be discharged through the fake wicks.

ChemTrails From Airliners

It was while I was on the wing that one of the managers spotted me. He ordered me out of the hanger telling me that my shift was over and I had not been authorized any overtime.

The next couple of days were very busy and I had no time to continue my investigation. Late one afternoon, two days after my discovery, I was called to replace an engine temperature sensor on a plane due to take off in two hours. I finished the job and turned in the paperwork.

About 30 minutes later I was paged to see the General Manager. When I went in his office I found that our union rep and two others who I did not know were waiting on me. He told me that a serious problem had been discovered. He said that I was being written up and suspended for turning in false paperwork.

He handed me a disciplinary form stating that I had turned in false paperwork on the engine temperature sensor I had installed a few hours before. I was floored and began to protest. I told them that this was ridiculous and that I had done this work.

The union rep spoke up at this point and recommended that we take a look at the plane to see if we could straighten it all out. I then asked who the other two men were. The GM told me that they were airline safety inspectors but would not

give me their names.

We proceeded to the plane, which should have been in the air but was parked on our maintenance ramp. We opened the engine cowling and the union rep pulled the sensor. He checked the serial number and told everyone that it was the old instrument. We then went to the parts bay and went back into the racks.

The union rep checked my report and pulled from the rack a sealed box. He opened the box and pulled out the engine temperature sensor with the serial number of the one I had installed. I was told that I was suspended for a week without pay and to leave immediately.

I sat at home the first day of my suspension wondering what the hell had happened to me. That evening I received a phone call. The voice told me "Now you know what happens to mechanics who poke around in things they shouldn't. The next time you start working on systems that are no concern of yours you will lose your job! As it is, I'm feeling generous, I believe that you'll be able to go back to work soon." CLICK.

Again, I had to pick myself from off the floor. As my mind raced, it was at this moment that I made the connection that what had happened to me must have been directly connected to my tracing the "mysterious" piping.

The next morning the General Manager called me. He said that due to my past excellent employment record that the suspension had been reduced to one day and that I should report back to work immediately. The only thing I could think of was "what are they trying to hide" and "who are 'THEY'!"

That day at work went by as if nothing had happened. None of the other mechanics mentioned the suspension and my union rep told me not to talk about it. That night I logged onto the Internet to try to find some answers.

I don't remember now how I got there but I came across a site that talked about chemically-laced contrails.

That's when it all came together. But the next morning at work I found a note inside my locked locker. It said, "Curiosity killed the cat. Don't be looking at Internet sites that are no concern of yours."

Well that's it. Now I know 'THEY' are watching me.

While I don't know what THEY are spraying, I can tell you how they are doing it. I figure they are using the "honey trucks". These are the trucks that empty the waste from the lavatory waste tanks.

The airports usually contract out this job and nobody goes near these trucks. Who wants to stand next a truck full of sh--. While these guys are emptying the waste tanks, it makes sense that they could easily be filling the tanks of the

They know the planes flight path so they probably program the control unit to start spraying some amount of time after the plane reaches a certain altitude.

The spray nozzles in the fake static wicks are so small that no one in the plane would see a thing.

God help us all.

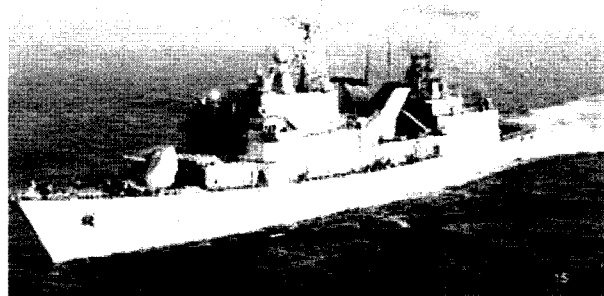
US Sinks North Korean Ship Bound for Iran

"How close were we to seeing an armed nuclear conflict?"

July 23, 2007

(Vancouver, BC) -- "How close were we to seeing an armed nuclear conflict?" That is the question being asked as Syrian nationals temporarily vacated Beirut, Lebanon and the Jordan Valley during mid July according to sources close to ACG-CIS. Many security and intelligence officials believe that this behavior may have been related to the US sinking of a North Korean ship approximately 100 nautical miles from the coast of Iran.

It was not immediately clear why, around July 10, 2007, the Syrian nationals, primarily engaged in construction, trades and agricultural occupations, should have vacated Lebanon without notice. The nationals were noticed to have returned to Beirut and the Jordan Valley by July 21, 2007.

ACG-CIS is of the opinion that the approximate 10-day absence may have been in part due to a warning system alerting the nationals to the possibility of an impending military or terror strike against Israel and other western interests in the region.

According a number of news sources, officials and clerics from Syria and Iran met during this time period reportedly to draw plans and scenarios for proposed attacks and increased activity against western interests in both the Mid East region and elsewhere. Those talks ended last week with no official announcements from any of the participants.

ACG-CIS, based upon further analysis, believe that the nationals were warned of an apparent military style strike or strikes as Hezbollah was reported to be moving missiles in civilian populated areas throughout southern Lebanon. This movement along with the involvement of the Iranian president, an adamant believer in nuclear technology and development, lead to concerns about the possibility of a military style "dirty bomb" nuclear attack or a ballistic missile attack involving nuclear weapons purchased from North Korea.

It was reported earlier this month that while the North Korean 2006 test

demonstrated the viability and reliability of North Korea's Scud- and Nodong-class systems, it left open the status of the three ballistic missile systems that the Korean People's Army (KPA) recently placed, or is placing, into service as testing on North Korea short-range missile systems has been quietly ongoing.

In reports first published by DEBKAFfile, American naval and air forces intercepted two North Korean vessels clandestinely en route for Iran with cargoes of enriched uranium and nuclear equipment in the past month. The shutdown of Pongyong's nuclear facilities has made these items surplus to North Korea's requirements and the Islamic Republic was more than willing to pay a hefty price for the goods.

On July 12, the second intercepted North Korean freighter was sunk in the Arabian Sea by torpedoes fired from a US submarine 100 miles southeast of the Iranian naval base-port of Chah Bahar. Delivery of its freight of enriched weapons-grade uranium and equipment and engines for manufacturing more fissile material including plutonium in its hold could have jump-forwarded Iran's nuclear bomb and warhead project, lopping off at least a year of work. For this Iran's rulers were ready to reportedly pay out a cool \$500 million.

A few hours earlier, President Bush received an intelligence briefing on the vessel, its freight and destination. Apparently the shipment was brought forward by several weeks to evade detection by UN nuclear inspectors scheduled to visit Pyongyang this week to verify the dismantling of its nuclear facilities.

US airplanes had been tracking the freighter and picked up signs of radioactivity, indicating the presence of nuclear materials aboard.

President Bush had the option of ordering US Marines to board the vessel or to sink it. He decided on the latter - both because the North Korean freighter was approaching an area patrolled by Iranian naval units and seizure of the vessel by American marines might have provoked a clash; secondly, it was the better choice in order to avoid exposing US troops to radioactive contamination. American naval and air units in the Persian Gulf, Middle East and seas opposite North Korea were ordered to go on a high state of readiness and the torpedo the North Korean vessel was accomplished without delay.

After the attack, US warships raced to the spot where the ship went down where they picked up three lifeboats. Most of the North Korean sailors aboard were either injured or dead. Twenty in all died in the attack. They all bore symptoms of contamination. After the episode, the area was cordoned off and underwater equipment dropped to salvage the cargo from the sunken ship.

All the parties to the incident, the United States, North Korea and Iran, have kept the incident under wraps as the situation in and around the Gulf is inflammable enough to explode into a full-blown Iranian-US clash at the slightest provocation. There was also the danger that North Korea might decide at the last moment to abort the closure of its nuclear facilities.

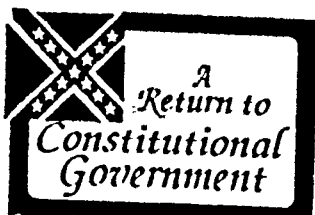
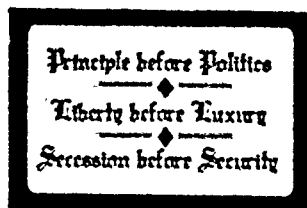
WASHINGTON — The United States is forging ahead as the world's leader in locking people up.

Population of U.S. jails and prisons has doubled to 1.2 million since 1980, catapulting the United States well ahead of South Africa, which had been the foremost jailer. The United States locks up almost five times as many, per capita as does South Africa.

The above is a typical example of Orwellian "DOUBLESPEAK". George Bush may have a clouded title to being the education president or the environmental president.

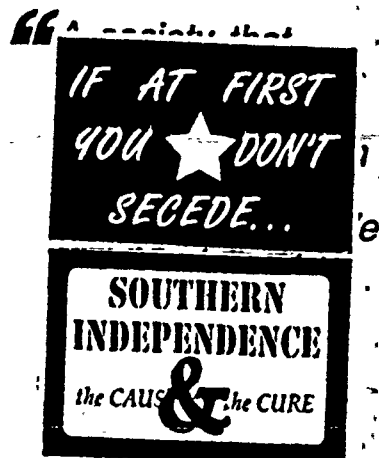
But let no one disparage his right to call himself the prison president. Curiously, this is one of the pluses of the Bush presidency you didn't see harped on at the moralistic seance the Republicans held in Houston. I don't know why, but I don't recall a single speaker bragging that under this Bush fellow we've been sending people up the river at the fastest rate in American history, that we now have an incarceration rate higher than South Africa's, an execution rate that is the envy — if that's the word — of the civilized world, and that the percentage of the American population behind bars has more than doubled since Jimmy Carter was president.

Maybe they had sense enough to know that this is not exactly the sort of thing a great nation should be congratulating itself for. But I doubt it. They must have just forgotten.

For whatever reason, Bush's speech-writers failed to insert in his acceptance oration, along with such watery promises as his tax cuts, his brilliant plan to turn Fort Dix into the largest prison in the federal system, a veritable concentration camp for 3,200 inmates that would dwarf any of the existing 57 facilities operated by the Bureau of Prisons. And none too soon, if we're to believe reports of the number of convictions likely to come out of the BCCI scandal alone.

The symbolism here is uncanny. Fort Dix, at the apex of the nation's most concentrated population center, has been the principal gateway to military service for generations of Americans. And now that the Cold War is over and Fort Dix has become redundant, now that it is no a longer key component of our schemes to make the world safe for democracy, how weird that we should put it to use to make our own world safe from ourselves.

And just imagine the boost this'll give to Bush's chances of keeping New Jersey in the Re-



publican column this year when you figure the impact on the state's economy of all the workers who'll be needed to feed and guard these prisoners who will pour into the Garden State from every corner of America. Who says Bush has been shamefully negligent in coming up with plans for a more painless conversion to a peacetime economy?

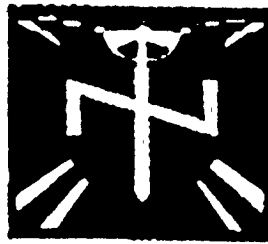

Randy and Harris retreated into the cabin to join his wife Vicki, and the surviving three children including an eight month old baby. The feds also set up a barricade some five miles away to hide their evil deeds. They reported to the press that every precaution was being taken to protect the family.

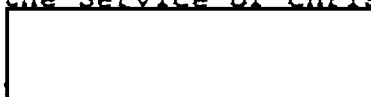

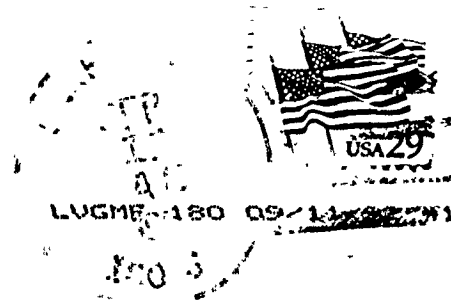

Lieutenant [redacted] is currently screening WICKSTROM's mail and advised that WICKSTROM averages between five and ten pieces of mail each day.

[redacted] a KU KLUX KLAN (KKK) member from DeKalb, Texas, for the past [redacted] years, has been visiting WICKSTROM. [redacted] DeKalb, Texas, is also corresponding with WICKSTROM.

During the months of June, July, August, and September 1992, contact was continued with Lieutenant [redacted] and his SIS office staff. WICKSTROM [redacted]

On September 28, 1992, SIS Secretary, [redacted] FCI, advised that [redacted] lives in Pennsylvania. She had recently sent WICKSTROM a Pennsylvania driver's license application. WICKSTROM filled out this application correctly and returned it to Pennsylvania. WICKSTROM will be released from Federal custody on February 6, 1993, and he is planning on returning to Pennsylvania.

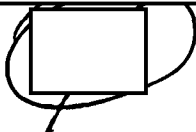
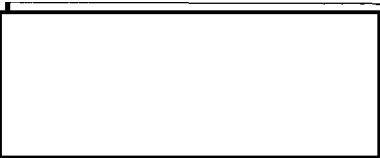

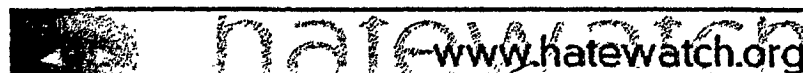

James Wickstrom

Wickstrom is a leader in the Posse Comitatus

[x]

James Wickstrom is a former tool salesman from Munising, Michigan who has become one of the most aggressive antisemitic preachers in the Christian Identity movement. The Identity movement's central tenets are that White Anglo Saxons are descended from the Ten Lost Tribes of Israel, White English and Americans (Canadians) are God's true chosen people, Jews, visible minorities, homosexuals, etc, are viewed as an abomination of the Lord, an evil to be rotted out and worthy of biblical wrath.

Wickstrom protested the Vietnam war because he did not want to fight for "Jew bankers" and later became one of the leaders of the survivalist group, the Posse Comitatus. Wickstrom also refers to himself as a minister of the Church of Christ Israel. The Posse Comitatus, when Wickstrom was leading, was a loosely affiliated group of armed Christian Identity survivalists who believed that all government power should be rooted at the county level. All other levels of government cannot be trusted and are part of an almost all encompassing international Jewish/satanic conspiracy.

In 1981 Wickstrom entered into politics and ran for the U.S Senate in Michigan where he finished third amongst five Candidates. The next year he ran for Governor of Wisconsin, and received two tenths of one percent of the total votes cast.

In 1983 the Posse Comitatus attracted nation wide attention when one of its members Gorden Kahl, and other members, engaged in a shoot-out where two federal Marshals were killed and three were wounded. Gorden escaped but was later killed in another gun battle with law enforcement in which a local sheriff was killed.

This was not to be the last legal trouble that Wickstrom and the Posse Comitatus would find themselves in. In 1983 Wickstrom was arrested when the Posse formed an illegal township consisting of around thirty mobile homes. Later that year he was convicted (18 months) for impersonating a town clerk and municipal judge. After being released on bond Wickstrom fled and in 1984 was arrested in Tulsa, Oklahoma for being a fugitive from justice and was convicted on the two counts of impersonating a public official and one count of jumping bail. He served a total of 13 and a half months.

In January 1990 Wickstrom was again in trouble with the law. He was charged with possession of \$100,000 dollars in counterfeit money, conspiracy to counterfeit, and conspiracy to buy firearm silencers. The jury could not decide on the firearms charges but Wickstrom was sentenced to 38 months in prison and three years probation for the counterfeiting charges.

Despite Wickstrom's legal problems, he continues preaching his pro-white antisemitic identity doctrines. Wickstrom can now be found online on ICQ or at the Posse Comitatus web site where he continues to preach his "sermons" of hate. For a fee you

can subscribe to Wickstrom's Intelligence Update the contents of which are so conspiracy minded and 'way out there' that if they were not so blatantly racist they would be comical.

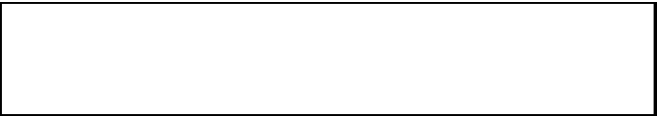

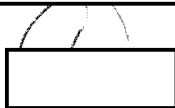

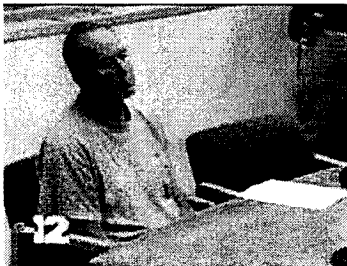

Feds raid Oklahoma home for evidence

Case involves man in custody here

Bay County - (08/04/05)-- More details are emerging about the suspect who is charged with bringing explosives and weapons to the area to target his wife and a white supremacist.

Keith Eugene Kallstrom, 55, is the man, detectives say, brought hand grenades and an assault rifle from Oklahoma to the Pinconning area earlier this week.

Today, agents from the FBI and ATF searched his home in Broken Arrow, Oklahoma, looking for firearms or anything related to them, computer or computer hardware, and any documents that relate to the Christian Identity Movement or any other terrorist organization.

According to ATF agents, they found evidence that will help in the investigation here in mid-Michigan.

Kallstrom is accused of loading his truck with camouflage clothing, rifles, clips filled with ammunition and four hand grenades. He left Oklahoma for the Pinconning area.

Investigators say he came here to get his estranged wife and take her back to Oklahoma.

His plans, according to authorities, also included killing Aryan Nation leader James Wickstrom.

According to the federal search warrant, Kallstrom allegedly said on July 5, that he would kill Wickstrom, cut off his head and place it on his mantle.

Wickstrom and Kallstrom's wife live nearby in the Gladwin County community of Rhodes.

The pair met two years ago in Essexville, while Wickstrom was preaching his hate message that whites are God's chosen people and a superior race.

Wickstrom and Kallstrom met each other 30 years ago. Kallstrom is a self-proclaimed White Supremacist preacher.

He was arrested Tuesday morning at the McDonald's restaurant near Pinconning.

The weapons and explosives were found in his pick-up.

Kallstrom will be back in court Friday afternoon, accused of violating a personal protection order filed by his wife.

According to court records, she says she feared for her life.

Supremacist who spewed hate here part of FBI terror report Thursday, April 21, 2005 By Jeff Kart Times Writer

Local law-enforcement agencies are keeping an eye on white supremacist preacher James P. Wickstrom, who recently was compared to al-Qaida leader Osama bin Laden in an FBI domestic terror report.

Wickstrom, a nationally known Christian Identity teacher, has stirred controversy in recent years for holding Bible study meetings at the Marquiss Quality Furniture Store, 644 W. Center Road in Hampton Township.

The store was gutted by fire in June; an arson investigation is ongoing.

Wickstrom had been living in the Hampton Township area and holding meetings at the store for about three years, spreading a message that whites are God's chosen people, Jews are evil and blacks and other races are inferior.

He now is reported to be living in the Pinconning area.

The owners of the furniture store, Mary and LeRoy Marquiss, plan to demolish it soon and rebuild a smaller store for a water conditioning business they've operated out of the back of the existing store for years.

"Within a few days, it will be coming down," LeRoy Marquiss said Wednesday. "We're putting up a steel building where nobody can torch it this time."

Marquiss said he does not expect Wickstrom to hold meetings at the new store.

The FBI report, obtained by ABC News, identifies 22 domestic terror organizations as the current subject of hundreds of active FBI field investigations.

Wickstrom recently has risen to prominence as the world chaplain of an Aryan Nations group based in Pennsylvania. The ABC News report says Wickstrom regularly calls for the deaths of government leaders, including the president.

For that reason, federal officials say Wickstrom's calls to action are not unlike those of bin Laden, according to ABC News.

Wickstrom also has openly called for the death of Jewish people; his previous meetings sometimes attracted more than 100 followers to the Hampton Township store.

Walt Reynolds, regional director for the FBI in Bay City, declined to comment on the domestic terror report. But Reynolds said the FBI keeps an eye on Wickstrom and his followers, and has a dialogue with the preacher.

"You've got to consider them dangerous sometimes, because you don't know," Reynolds said.

The concern is that someone may act on Wickstrom's calls for action, Reynolds said.

Wickstrom has been tied to a man who allegedly shot and killed a Michigan State Police trooper in Newaygo County in July 2003; the preacher also served time in prison in the 1990s for a counterfeiting scheme aimed at funding paramilitary organizations.

Reynolds said Wickstrom now is living in the Pinconning area, but he doesn't appear to be holding meetings. Wickstrom has a post office box in Rhodes, according to his Web site.

LeRoy Marquiss, who originally brought Wickstrom to town, said Wickstrom left the Bay City area without much explanation and he hasn't spoken to the preacher in about four months.

"What happened, I don't know," Marquiss said.

Wickstrom could not be reached for comment Wednesday by The Times.

Terry Spegel, Hampton Township supervisor, said it's "wonderful" that Wickstrom is no longer living in the township, although he noted that neither the Marquisses nor Wickstrom ever caused any trouble with the meetings in the past.

"Everybody has a right to their opinions."

A nationally known white supremacist who conducted meetings at a Hampton Township furniture store before an arsonist torched it, will preach again in mid-Michigan via the airwaves.

James P. Wickstrom is a self-avowed racist whose "Christian Identity" teachings maintain that Jews descended from Satan and white Western Europeans descended from Adam.

A tape featuring him speaking will appear on the Midland Community TV public access channel in January. No firm date is set yet.

Wickstrom lives in the Pinconning area, according to the local FBI office. He has a post office box in Rhodes.

The 90-minute prerecorded show, "The Enemy Among Us," will air four times, said Melissa J. Barnard, director of the Grace A. Dow Memorial Library, where the MCTV studios are housed.

Tapes produced outside the studio are subject to available scheduling, Barnard said, and holiday programming has filled the roster this month.

While many might find Wickstrom's views objectionable, Barnard said, the broadcast is protected through Midland's strict adherence to the First Amendment, guaranteeing free speech.

As long as programming meets the rules - in particular that the person presenting it for broadcast resides in Midland County - it will air.

Randy Gray is the Midland contact. He also submitted a video, "This is The Klan," that aired on MCTV in October.

Gray said Tuesday that Wickstrom is not conducting interviews at this time and directed reporters to a Web site Wickstrom maintains.

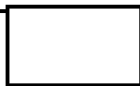
The format of "The Enemy Among Us" is similar to others that air on MCTV, Gray said, in that it features Wickstrom speaking from a pulpit.

Barnard said the subject matter is a departure for the station.

"It doesn't happen often that we have shows of a controversial nature," she said. "Much of our programming comes from nonprofit organizations, informational programs along with various performances, exercise programs, even Michael the Archangel.

"But as long as they've complied with the rules, we will air the show."

MCTV airs in Midland County and some outlying areas - including western Bay County - on Charter Communications cable Channel 3.

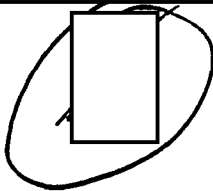

Kallstrom must provide handwriting samples in murder solicitation case
Tuesday, September 12, 2006

A federal judge has ruled that Keith E. Kallstrom, a man involved in a love triangle with his wife and hate-preacher James Wickstrom, will have to provide samples of his handwriting, but he won't have to take dictation.

U.S. District Judge David M. Lawson issued the ruling in the case of Kallstrom, who awaits trial on charges of possessing hand grenades and using the mail to solicit murder.

Kallstrom, of Broken Arrow, Okla., was arrested at the Pinconning McDonald's in August 2005 and police found four hand grenades and three loaded guns in his van.

Kallstrom allegedly was in town to track down his wife, who'd been living with white supremacist minister James Wickstrom.

Once jailed, Kallstrom allegedly contracted another inmate to kill Wickstrom, and then wrote several letters to the inmate after being relocated to a different prison.

Federal attorneys had proposed having Kallstrom take "dictation" of a statement read to him in order to determine whether Kallstrom's spellings matched those in the letters. But Lawson said that would turn a standard handwriting sample into an "intellectual exercise," and that would violate Kallstrom's right to refuse any testimony or act that could amount to self-incrimination.

Instead, Kallstrom will be ordered to copy a prepared text.

Wickstrom is a leader in the "Christian Identity" movement and lead Bible study meetings at a Hampton Township furniture store for about three years until it was gutted by an arson fire in June 2004. No arrests have been made in the case. Wickstrom was living in the Essexville area at the time and later moved to the Pinconning area.

No trial date for Kallstrom has yet been set in federal court.

[redacted] was found innocent of Possession of Hand Grenades which were found among 37 boxes of ammunition at a storage shed that belonged to [redacted] Keith. [redacted] defense was that he did not know what was in the boxes that he moved from Arkansas to Oklahoma after [redacted] got in trouble with the law in Michigan. He testified that [redacted] told him they contained only ammunition. [redacted] had further stated that he had attempted to distance himself from [redacted] because of Keith Kallstrom's white supremacist beliefs. The ammo boxes in question had been sitting in the shed for more than a year and police discovered the boxes after the property owner reported his shed had been broken into. According to prosecutors, police found a total of six grenades in the shed on November 6 and one of the grenades was detonated by bomb squad members and found to be operational. [redacted] was originally charged with knowingly possessing a firearm and, in this case, a hand grenade that was not registered to him in the Federal Register and Transfer Record. Prosecutors were not able to prove that he had the hand grenade, he knew it was explosive, it was capable of exploding, and that it was not registered to him.

MIDLAND - Randy G. Gray II has a bone to pick with American citizens, and he let the citizens of Midland know about it on Saturday afternoon.

Gray, 30, of Midland, organized a white supremacist rally on the Midland County Courthouse steps and did not hold back once he had the microphone.

"It is time for our people to have a little racial pride," he said.
"Multiculturalism and diversity is a disease. I see no diversity or multiculturalism when I look at pictures of our founding fathers. They were all white men."

Blacks, Mexicans, Jews and members of the media and Congress all drew the ire of Gray and his fellow speakers, James P. Wickstrom, Brian Holland, and Jeff Schoep, commander of the National Socialist Movement.

"Every white man, woman and child who stand up here today believes in America," Schoep said. "Throw off the shackles and stand for your people! Show some courage. I don't know how you look at your faces in the mirror every day knowing you do nothing."

Schoep also advocated pulling U.S. troops out of the Middle East and stationing them along the U.S. Mexico border with instructions to "put those illegals down" as they try to cross the border.

White plastic fencing, police tape and barriers blocked off four blocks around the Midland County Courthouse for the rally. Those attending were divided into two separate areas based on their support or opposition of the speakers' viewpoints.

Approximately 50 people filtered into the rally throughout the three hour event.

Those opposing the speakers had no problem expressing their point of view. Shouts of "Nazi" and "fascist" often interrupted the speakers.

"These people are idiots," said Sandy Laundra of Hemlock. "They are judging us and they don't know us. I came up here because I wanted to see them in their (Klu Klux Klan) white robes; I wanted to see the real thing."

Gray made headlines in 2008 when he was elected a Republican precinct delegate but was barred from assuming the post after he appeared in Ku Klux Klan regalia, protesting the election of President Barack Obama, on the streets of Midland.

No one in attendance at Saturday's rally was wearing KKK regalia.

Holland, who has a website dedicated to his run for president in 2012, directly engaged those protesting the rally.

"You are uneducated and you are unworthy," he said. "Yet you protest us for protesting against a government that is corrupt."

While speaking out against a communist America, James Wickstrom captured the attention of Bay City resident Buck Grew.

"I'm 67 years old, and I'm glad America has the freedom to let you speak your mind," he said. "I'm glad they came. When I went to school, I was taught there were three separate branches of government and they were supposed to keep each other in check. Now they're all in bed together."

Three seniors from the Midland Academy spent their afternoon at the rally, and left shaking their heads.

"Their logic is infallible," said Cameron MacCourt, 18. "I say that sarcastically. It is their right to be here, and I came because it is important to have things that challenge your own beliefs."

Nathan Phillips, 16, professed himself to be the most conservative of the group and marvelled at how different his perspective was from that of the speakers.

"They are so extreme," he said. "It's like here's me, and then Ghengis Khan and then there they are two miles away."

The three-hour rally was held peacefully, but officers from the Michigan State Police, Midland Police Department and Midland County Sheriff's Office patrolled the area in case things got out of hand.
