FOR INFORMATION OF THE BUREAU AND RECEIVING OFFICES, ON 7/22/91, AT APPROXIMATELY 11:30 P.M., PATROL UNITS OF THE MILWAUKEE, WISCONSIN POLICE DEPARTMENT ENCOUNTERED A BLACK MALE PARTIALLY CLOTHED WITH A HANDCUFF ON ONE WRIST WHO REPORTED THAT HE HAD BEEN THREATENED WITH A KNIFE AT AN APARTMENT LOCATED AT 924 NORTH 25TH STREET, APARTMENT 215, MILWAUKEE, WISCONSIN. OFFICERS RESPONDED TO THE APARTMENT AND ARRESTED JEFFREY L. DAHMER FOR ASSAULT AND AT THAT TIME DISCOVERED IN THE APARTMENT WERE NUMEROUS BODY PARTS, DECAPITATED HEADS, BOTH IN THE SINK AND IN THE REFRIGERATOR, BODY TORSOS, APPROXIMATELY 10 PAIRS OF HANDS, AND OTHER BODY PARTS DISPLAYED. AT THIS TIME, IT APPEARS ALL VICTIMS ARE ADULT MALES.

b7c AS DISCUSSED IN REFERENCED TELCAL TO SSA [REDACTED] FBIHQ, MILWAUKEE IS CONDUCTING KIDNAPPING PRELIMINARY INQUIRY TO DETERMINE IF ANY FEDERAL VIOLATIONS EXIST AND TO ACTIVELY ASSIST LOCAL AUTHORITIES. INTENSIVE INVESTIGATION BY THE

MILWAUKEE, WISCONSIN POLICE DEPARTMENT HAS DETERMINED, THROUGH COOPERATIVE INTERVIEW OF THE SUBJECT AND POLAROID PHOTOGRAPHS RECOVERED AT THE SCENE, THAT THE MAJORITY OF THE VICTIMS IN THIS MATTER WERE RESIDENTS OF THE CITY OF MILWAUKEE AND INDIVIDUALS WHO WERE ENGAGED IN A HOMOSEXUAL LIFE STYLE.

DAHMER HAS ADMITTED TO 15 HOMICIDES, THE MAJORITY OF THE VICTIMS BEING BLACK OR HISPANIC, AND STATED THAT THE RACE OF THE VICTIMS WAS UNIMPORTANT TO HIM AND THAT THE VICTIMS WERE SELECTED AS VICTIMS OF OPPORTUNITY IN THAT THEY RESIDED IN PROXIMITY TO HIS APARTMENT IN MILWAUKEE, WISCONSIN.

DAHMER HAS ADVISED THAT HIS FIRST KILLING OCCURRED WHEN HE WAS 18 YEARS OF AGE, IN 1978, WHEN HE WAS RESIDING IN THE VICINITY OF RICHFIELD, OHIO. THIS VICTIM, AS DESCRIBED BY THE SUBJECT, WAS A WHITE MALE, APPROXIMATELY 19 YEARS OF AGE, WHO WAS A HITCHHIKER PICKED UP BY THE SUBJECT AND TAKEN TO HIS RESIDENCE WHERE HOMOSEXUAL ACTS TOOK PLACE AND THE VICTIM WAS KILLED BY BEING STRUCK IN THE HEAD WITH A BAR BELL. SUBJECT STATED HE REMOVED THE BODY TO A FIELD IN THE VICINITY OF HIS RESIDENCE AND AFTER SEVERAL DAYS DISSECTED THE BODY AND DESTROYED THE EVIDENCE. SUBJECT STATED THAT AT APPROXIMATELY

19 YEARS OF AGE HE JOINED THE U.S. ARMY AND SERVED FOUR YEARS WITH THE MILITARY. HE STATED THAT HE RESIDED IN MIAMI, FLORIDA FOR ONE YEAR FOLLOWING HIS MILITARY SERVICE AND THEN RETURNED TO MILWAUKEE, WISCONSIN, WHERE HE LIVED WITH HIS

*b7c* GRANDMOTHER [REDACTED] IN WEST ALLIS, WISCONSIN. SUBJECT ADVISED THAT DURING 1984-1985 TIME PERIOD HE ENGAGED IN SEVERAL HOMICIDES IN WHICH HE WOULD APPROACH HOMOSEXUAL PROSTITUTES AND LURE THEM EITHER TO A MOTEL OR TO HIS RESIDENCE WHERE HE WOULD ENGAGE IN SEX, PROVIDE THEM WITH A DRINK THAT HAD BEEN LACED WITH SLEEPING PILLS, AND THEREAFTER KILL THEM. SUBJECT STATED THAT THE MAJORITY OF HIS VICTIMS WERE STRANGLERED WITH ONLY ONE BEING STABBED. SUBJECT ADVISED THAT IN 1986 HE MOVED TO 924 NORTH 25TH STREET, APARTMENT 215, AND ALSO AT THIS TIME OBTAINED EMPLOYMENT WITH THE AMBROSIA CHOCOLATE COMPANY IN MILWAUKEE, WISCONSIN. SUBJECT STATED THAT SEVERAL HOMICIDES OCCURRED DURING THIS TIME AND THESE WERE VICTIMS THAT HE ENCOUNTERED AT THE 219 CLUB, A HOMOSEXUAL BAR LOCATED AT 219 SOUTH 2ND STREET, MILWAUKEE, WISCONSIN, OR INDIVIDUALS HE ENCOUNTERED AT THE GRAND AVENUE MALL, A SHOPPING ARCADE LOCATED SEVERAL BLOCKS FROM HIS APARTMENT. SUBJECT HAD STATED THAT HE WAS LAID OFF

FROM THE AMBROSIA CHOCOLATE COMPANY SEVERAL MONTHS AGO AND THIS PLACED INCREASED STRESS ON HIM AND HE BEGAN MORE AGGRESSIVELY SEEKING VICTIMS AND KILLING THEM. SUBJECT STATED THAT MOST RECENTLY HE HAD BEEN ENGAGED IN BONDAGE AND HE USED SOME HANDCUFFS TO CONTROL HIS VICTIMS AND THAT ON ONE OCCASION, PREVIOUS TO HIS ARREST, A VICTIM HAD ESCAPED BUT HE WAS ABLE TO GET THE VICTIM BACK INTO HIS APARTMENT WHERE HE KILLED HIM.

DAHMER STATED THAT HE DISPOSED OF THE BODIES BY DISSECTION AND USE OF A BARREL OF HYDROCHLORIC ACID IN WHICH HE WOULD PLACE THE BODY PARTS. SUBJECT STATED THAT AS THE BODIES BROKE DOWN HE WOULD FLUSH THE REMAINS DOWN THE TOILET OR DISCARD BONE FRAGMENTS IN THE TRASH.

AN EXAMINATION OF THE SUBJECT'S APARTMENT REVEALED NUMEROUS POLAROID PHOTOGRAPHS OF VICTIMS AND AS PREVIOUSLY STATED, NUMEROUS BODY PARTS. SUBJECT ALSO HAD A 55 GALLON DRUM IN WHICH HE HAD PLACED SEVERAL TORSOS FOR AGING PRIOR TO HIS EFFECTING THE DISSECTION AND DISPOSAL OF THESE ITEMS. IN ORDER TO AVOID THE ODOR OF THE DECOMPOSING FLESH, SUBJECT HAD ATTEMPTED TO VENT HIS APARTMENT BY USE OF A FAN TO EXHAUST

THESE ODORS OUT OF THE BUILDING.

THE MILWAUKEE POLICE DEPARTMENT IS AGGRESSIVELY ATTEMPTING TO IDENTIFY THE VICTIMS THROUGH FINGERPRINTS, DENTAL RECORDS, PHOTOGRAPHIC COMPARISON OF THE POLARIDS TAKEN BY THE SUBJECT AND IDENTIFICATION FOUND AT THE SCENE.

THE FIRST VICTIM IDENTIFIED WAS A (X)OLIVER LACY, BLACK MALE, AGE 23, DOB: 6 23/68, WHO RESIDED AT 646 EAST 84TH STREET, CHICAGO, ILLINOIS(X). THIS VICTIM WAS IDENTIFIED FROM HIS PHOTO DRIVER'S LICENSE FOUND IN SUBJECT'S APARTMENT AND COMPARED TO HIS DECAPITATED HEAD FOUND IN THE SUBJECT'S REFRIGERATOR. SUBJECT INDICATED THAT LACY WILLINGLY ACCOMPANIED THE SUBJECT BACK TO MILWAUKEE, WISCONSIN VIA GREYHOUND BUS AND WAS SUBSEQUENTLY KILLED IN MILWAUKEE, WISCONSIN.

A SEARCH OF DEPARTMENT OF TRANSPORTATION RECORDS REFLECT THAT THE SUBJECT DOES NOT CURRENTLY HAVE A DRIVER'S LICENSE AND NO CARS ARE REGISTERED TO HIM. HIS LAST DRIVER'S LICENSE LISTED AN ADDRESS OF 4485 WEST GRANGER ROAD, AKRON, OHIO, AND

For information of the Bureau, subject DAHMER was arrested on July 22, 1991 by the Milwaukee, Wisconsin Police Department after a partially clad black male, with a handcuff around one wrist, reported that he had been threatened with a knife at the apartment located at 924 North 25th Street, Milwaukee, Wisconsin. Officers responded to the apartment and arrested JEFFREY L. DAHMER for assault and at that time discovered in the apartment numerous body parts, decapitated heads, hands and other body parts.

Intensive investigation by the Milwaukee Police Department, assisted by the FBI, resulted in the identification of seventeen victims who were murdered, sexually assaulted, and then dissected by subject DAHMER. In the course of the investigation, it was determined that OLIVER LACY, one of DAHMER's first victims to be identified, was a black male, age 23, date of birth June 23, 1968 who resided at 646 East 84th Street, Chicago, Illinois. DAHMER advised that he first encountered LACY in Chicago, Illinois at a gay pride parade and LACY voluntarily accompanied DAHMER back to Milwaukee, Wisconsin by a Greyhound bus and after several days in Wisconsin, was killed by DAHMER. This victim was identified by his photo drivers license found in the subject's apartment as compared to his decapitated head found in the subject's refrigerator.

Three other victims of DAHMER's homicidal assaults have been identified as former Illinois residents who were in Milwaukee visiting, or on other business and became DAHMER's victims and were simply victims of opportunity and were not transported by DAHMER across the state line.

This matter is being followed with the Milwaukee, Wisconsin Police Department and Bureau assistance has been rendered including Laboratory, NCIC, and out of state investigative leads. This matter will be presented to the United States Attorney, Milwaukee, Wisconsin for a prosecutive opinion.

A REVIEW OF THESE RECORDS REVEALED ONLY ONE THIRTY-TWO YEAR OLD FEMALE WAS REPORTED MISSING AND STILL UNACCOUNTED FOR.
