Based upon the comparison examinations conducted, these paints were determined to match in colors, textures, type and composition. Therefore, it was concluded that these paints could have originated from a common source.


The probable source of the above-described paints is a commercially available product called FLECK STONE in their Gotham Gray" color. FLECK STONE is manufactured by the PLASTI-KOTE Company, Medina, Ohio,44256, and can be found in both hardware and craft stores. The above-mentioned paints matched the Gotham Gray FLECK STONE in colors, texture, type and composition.
