The paints from the Q1 (Laboratory number 10813030), Q2 (Laboratory number 10813031) and Q1 (Laboratory number 10813032) specimens were examined microscopically, micro-chemically and instrumentally. Based upon the comparison examinations conducted, these paints were determined to match in colors, textures, type and composition. Therefore, it was concluded that these paints could have originated from a common source.

The probable source of the above-described paints is a commercially available product called FLECK STONE in their "Gotham Gray" color. FLECK STONE is manufactured by the PLASTI-KOTE Company, Medina, Ohio, 44256, and can be found in both hardware and craft stores. The above-mentioned paints matched the "Gotham Gray" FLECK STONE in colors, texture, type and composition.




