Attached Charlotte teletype advises that on 4/8/81, a letter was received at the Tri-County Newspaper, Spruce Pine, North Carolina, which was written by one [REDACTED] and mailed on 4/6/81, at Buffalo, New York. This letter contained threats to [REDACTED] and U. S. Senator Jesse Helms, North Carolina.

Charlotte has advised local North Carolina authorities and the U. S. Secret Service of the above threats. In view of the Presidential family threat contained in instant letter, it was turned over to the U. S. Secret Service for latent fingerprint examination and the U. S. Secret Service is attempting to identify [REDACTED]

On 4/17/81, FBIHQ telephonically requested WFO to advise Senator Helms of instant threats and interview him regarding [REDACTED] or other possible suspects. On 4/17/81, FBIHQ telephonically advised both Charlotte and Buffalo that captioned Congressional Assassination Statute case is also a violation of the Extortion Statute under the FBI's jurisdiction, and Buffalo as office of origin should promptly institute an extortion investigation.

AS AN EXAMPLE, HE NOTED THAT RECENTLY [REDACTED] OF HIS

For information of offices not in receipt of retels, the Kansas City Division, over the past four months, has received numerous collect calls from unsub, representing himself as the PROGRESSIVE LABOR PARTY. Kansas City Division switchboard operator refused to accept the calls, after which the caller would shout a threat before the AT&T operator could disconnect. The Kansas City Division has also received mail as indicated above, all of which is postmarked Fairfield, Iowa, with a return address of PROGRESSIVE LABOR PARTY, 300 E. Armour, Kansas City, Missouri.

Security/Assistant Manager, PARK CENTRAL HOTEL, 300 E. Armour, Kansas City, Missouri, has advised that he is aware of the letters and has contacted the United States Postal Service. He further advised that he has no suspects in this matter, nor does he have any tenants, to his knowledge, that have connections with the state of Iowa. It should be noted that the PARK CENTRAL HOTEL is a complex of two buildings which houses approximately 250 to 300 tenants.

Previous investigation by the Kansas City Division has determined that the telephone calls indicated above have originated from Fairfield, Iowa, and appropriate leads have been set forth to the Omaha Division to attempt to identify caller.

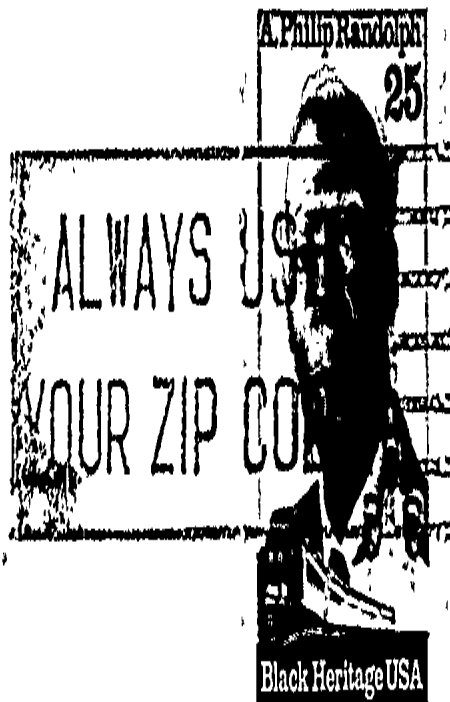
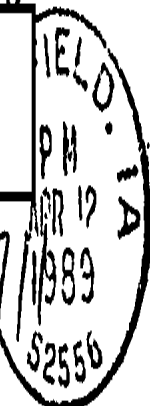

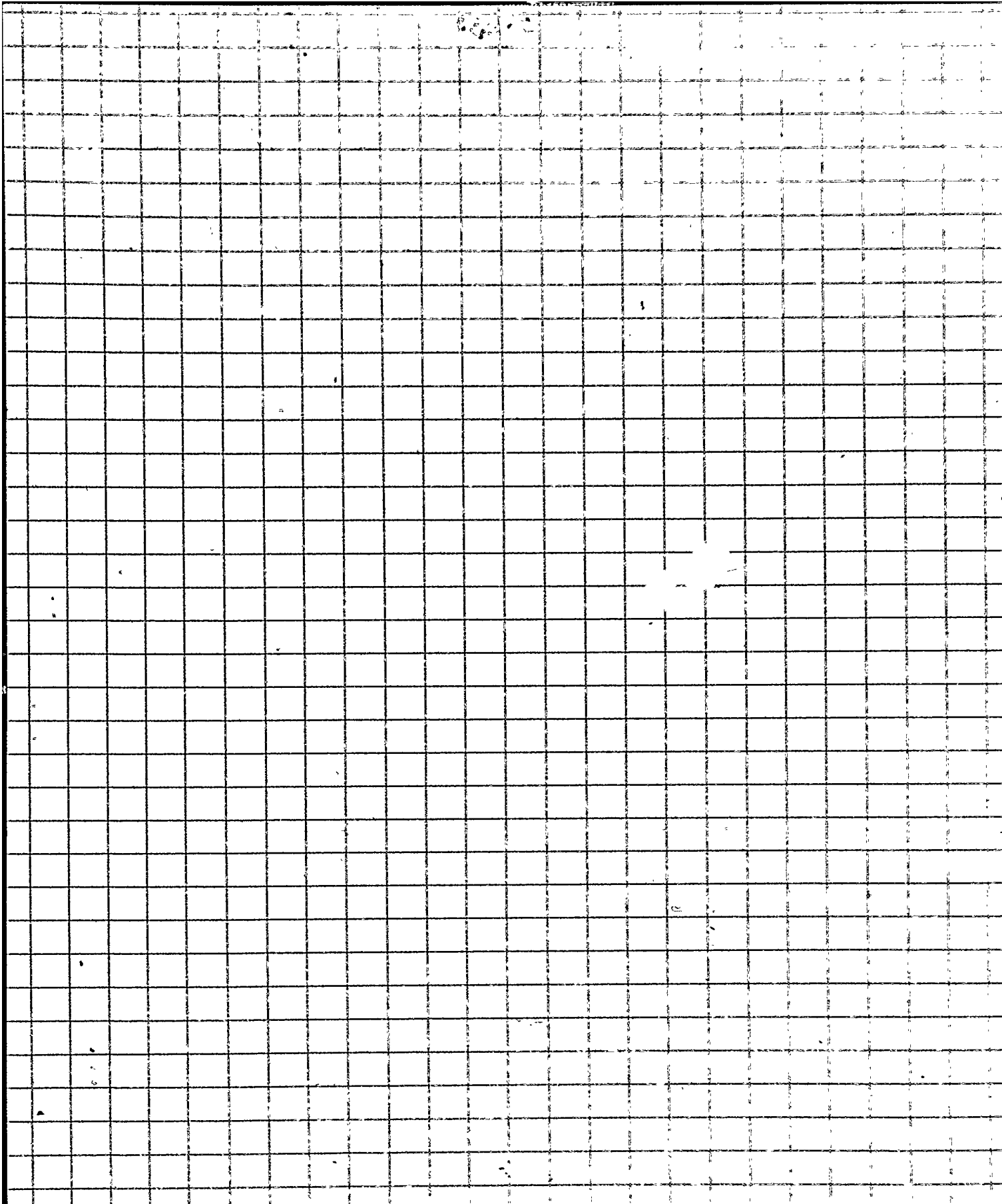

subway station, then a Black person who is a friend of the Progressive Labor Party will take photographs of Helms' remains to publish in the newspaper, "Challenge."

In the meantime the five heroes who knocked "scum of the earth" Helms onto the railway tracks will be riding on the train that ran over him and getting off at various stops to make good their escape. They will then go celebrate Helms' death.

Enclosed for the Bureau and WMFO are two copies of a report from the Psycholinguistics Center re analysis of tape of threats.

A laboratory analysis of threatening phone message was conducted by [REDACTED] of the Psycholinguistics Center, Syracuse, New York. [REDACTED] conclusion is that "there is no textual evidence that this caller has either the means or the resolve to act upon his expressively ventilative threats". He further describes the caller as possibly being a white male between the ages of 45 and 60 years and of the Jewish faith.

WCBS-AM Radio has received no similar calls from this caller or anyone purporting to represent captioned subject group. There have been no reports of any of the captioned victims receiving any further threats in any form. Los Angeles Division interviewed Reverend [REDACTED] and he reports no death threats from this group, nor has he ever heard of this group.

As there have been no further threats received from this caller or anyone representing the HOMOSEXUAL RESISTANCE UNIT to cap- victims or aforementioned radio station, and no reported assault attempts on captioned victims, and as all logical investigation has been conducted, this case is considered closed by New York.

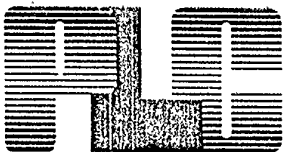

First generation copy of a tape recorded message purporting to originate from the spokesperson of the captioned organization was transmitted through the Laboratory with request for psycholinguistic examination.

Based upon the content of this communication and the associated voice characteristics, it is my judgment that the caller is a White male native of the New York metropolitan area, approximately between the ages of 45 and 60. The dialect and vocabulary are consistent with those of the Jewish faith. There is no reason to doubt the author's distaste for those of Christian persuasion or his assertions of homophilic preferences. It is likely that the caller identifies with the intellectual community and has the credentials for such membership despite the provinciality of his parochially regional dialect.

There is no textual evidence that this caller has either the means or the resolve to act upon his expressively ventilative threats. Nor is there textual support for the caller's assertions of acting as the spokesperson for an organized terrorist organization.


