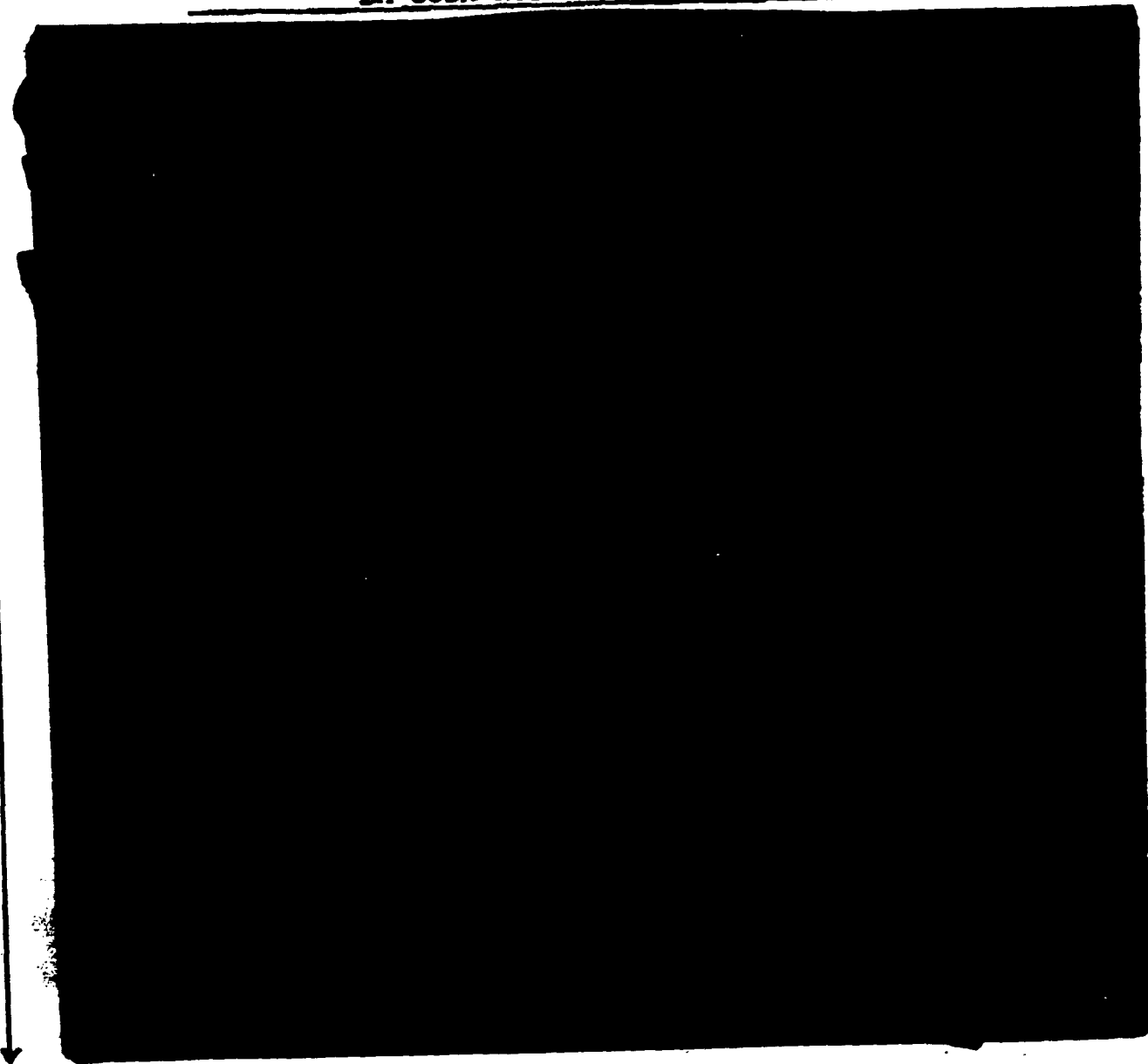

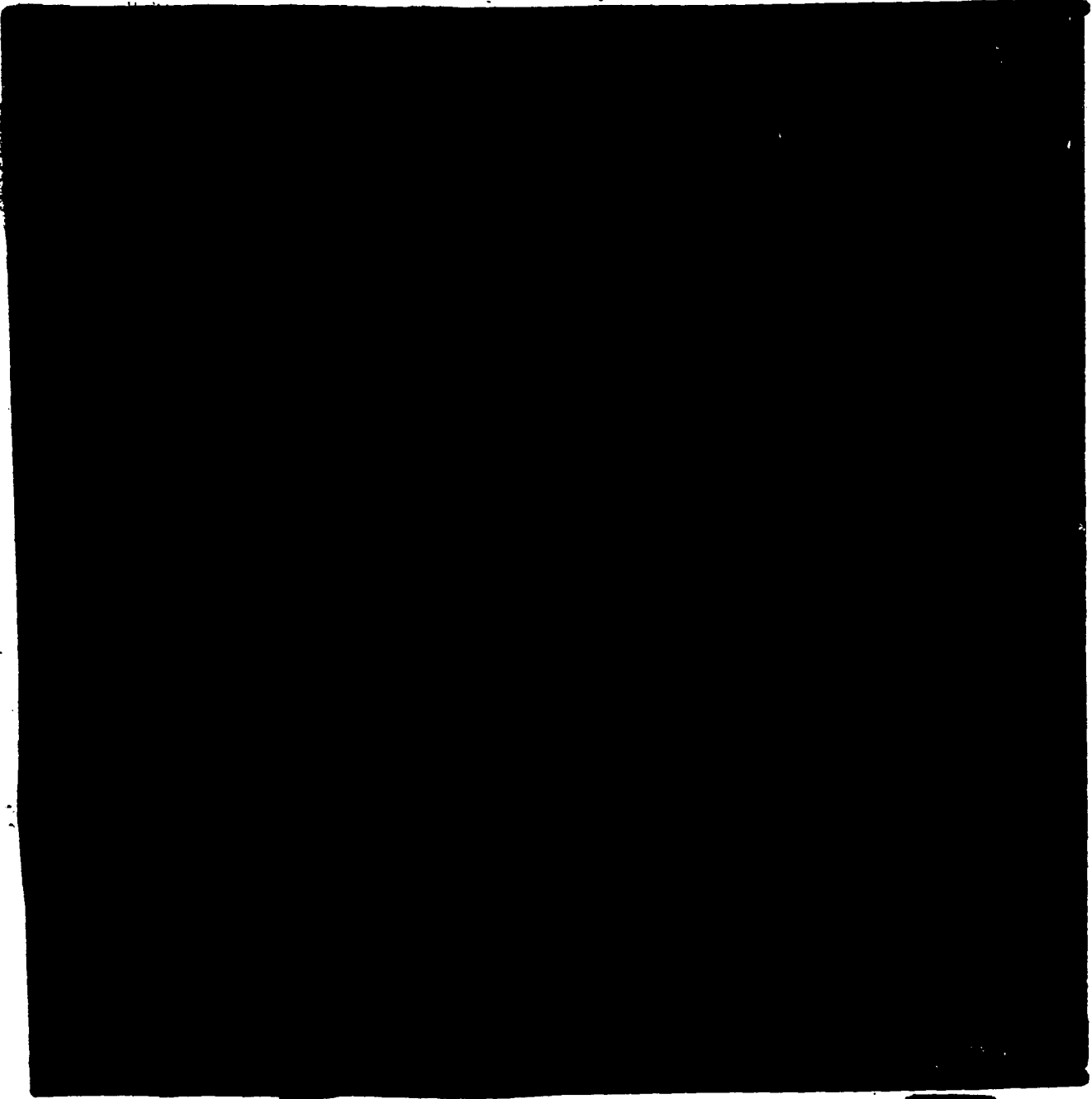

An article appearing in the "Minneapolis Star," a daily evening newspaper of general circulation published in Minneapolis, Minnesota, in its edition of May 3, 1971, notes that the rally sponsors deny that the antiwar rally is part of a "dump NIXON movement." However, it is noted that WHEELOCK WHITNEY, a Republican leader, would not endorse this rally because he considers it a "dump NIXON effort."

The article notes that a spokesman for the Bipartisan Caucus to End the War states, "We're not waiting for November, 1972." The same spokesman noted that the group wants to "persuade the political animal who holds the presidency to change his course of action before the election."

The location at which the rally will be held will seat approximately 17,000 and spokesmen of the supporting group will attempt to fill it to capacity.

The above is being furnished to the Bureau for information. Since this affair is clearly political in nature, no coverage through established sources or informants contemplated unless positive evidence received of disruptive or destructive activity being involved therewith.
