JOHN JOSEPH GOTTI was interviewed at Kings County Court House, Brooklyn, New York, at which time he was advised he did not have to make a statement, any statement he did make could be used against him in a court of law, and he had the right to consult an attorney before making any statement.

GOTTI advised he did not realize he was delinquent with his draft board inasmuch as he is married and has two children. He further advised he felt because of this and the fact he has been previously arrested he was not eligible for the Armed Forces. GOTTI stated he was willing to abide by Selective Service regulations and serve in the Armed Forces of the United States.
