THE OTHERS REFERRED TO IN THE STATE'S INDICTMENT ARE THE "WESTIES GANG", WHICH IN THIS CASE HAD AN AGREEMENT TO COMMIT ACTS OF VIOLENCE FOR THE GAMBINO'S. FOUR WESTIES, KEVIN KELLY, KENNETH SHANNON, JAMES MCELROY, AND JOSEPH SCHLERETH, WERE NAMED IN THE INDICTMENT AS THE UNINDICTED CO-CONSPIRATORS WHO SHOT O'CONNOR.

BEFORE JUSTICE GEORGE ROBERTS. AFTER HAVING HEARD ARGUMENTS OF ASSISTANT (DA) CHIEF MICHAEL CHERKASKY INCLUDING THE STATE'S INTENTION TO TRY GOTTI UNDER THE PERSISTANT FELONY OFFENDER STATUTE, WHICH CARRY A 25 YEAR TO LIFE IN PRISON PENALTY, JUDGE ROBERTS RELEASED GOTTI ON \$100,000 BOND. ADDITIONALLY, ANTHONY GUERRIERI, THE INDICTMENT STATES GATHERED INFORMATION TO ARRANGE FOR O'CONNOR ASSAULT, WAS RELEASED AFTER POSTING \$50,000. RUGGIERO WAS TAKEN INTO CUSTODY AT BEEKMAN HOSPITAL, WHERE HE UNDERGOING MEDICAL TREATMENT. THE CASE HAS BEEN ASSIGNED TO JUDGE ATLAS, MANHATTAN SUPREME COURT, WHO HAS SCHEDULED PRE-TRIAL NOTIONS FOR APRIL, 1989. THE FEDERAL BUREAU OF INVESTIGATION (FBI) HAS BEEN REQUESTED AND IS CURRENTLY IN THE PROCESS OF PROVIDING VALUABLE INTELLIGENCE TO THE INVESTIGATIONS DIVISION IN THE OFFICE OF THE MANHATTAN DISTRICT ATTORNEY TO BE UTILIZED IN THE STATE'S PROSECUTION.

Reporting Convictions:

Convictions should not be reported until the sentence has been issued. There are two exceptions to this rule. The conviction information can be submitted by itself if:

- 1. The subject becomes a fugitive after conviction but prior to sentencing.
- 2. The subject dies after conviction but prior to sentencing.

An explanation is required in the Remarks section for either of the above exceptions.

Rule 20 Situations:

The field office that obtained the process (normally the office of origin) is the office that should claim the conviction, not the office where the subject enters the plea in cases involving Rule 20 of the Federal Rules of Criminal Procedures.

Investigative Assistance or Techniques (IA/Ts) Used:

-Since more than one IA/T could have contributed to the accomplishment, each IA/T used must be rated.

-The IA/T used must be rated each time an accomplishment is claimed. (For example - if informant information was the basis for a complaint, an arrest, a recovery and a conviction and if separate FD-515s are submitted for each of the aforementioned accomplishments, the "Informant Information" block must be rated on each FD-515 even if it was the same information that contributed to all the accomplishments.)
