Mr. Neil M. Ruge, American Consul at Casablanca, Morocco, has now advised that JACK CLIFFORD WOLF was issued U. S. Passport No. 391 PS 33379 at Casablanca, Morocco, on July 10, 1953. His passport application indicates that he was born at Omaha, Nebraska, son of ADOLPH HENRY WOLF, who was also born in Omaha and who is now deceased, and of REGINA IRENA WOLF, who was born at Niobrara, Nebraska, and who is now residing in Omaha. Mr. Ruge advised that WOLF's photograph of July 10, 1953, shows him wearing a "walrus or Stalin type mustache."

Mr. Ruge also furnished a summary of information from WOLF's file with the Atlas Construction Company, including one negative and three positive prints of WOLF's photograph. Presumably, this photograph was made in 1953.

The above-mentioned summary of information on WOLF, together with the negative and two positive prints of WOLF's photograph, is being forwarded herewith to the Bureau. One print is being retained in the Madrid office.

Mr. Ruge explained that, because of the large reduction in force of Atlas Constructors, it was not possible to locate anybody who was personally acquainted with WOLF. Since, however, WOLF and one JOHN COOLEY (as reflected in the attachment to referenced Madrid letter) apparently worked together in Vienna, Austria and subsequently for Atlas Constructors in Morocco, and, therefore, may be close associates, Mr. Ruge also furnished the enclosed personal history statement relative to COOLEY. The data relative to COOLEY was secured from his personnel file with Atlas and these data include one negative and two positive prints of COOLEY's photograph which, it is also assumed, was taken in 1953.

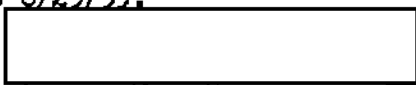
Termination physical examination record adds nothing except that he suffers from headaches and that he had day before, 29 July 1953, a slight fever, continuing through date of examination.

It seems to have contained a copy of the cable previously furnished, regarding travel authorization and expenses for Wolf and for John Cooley.

Check slip at time of assignment from personnel headquarters at Nouasseur shows his Passport No. as 104479, issued "6/15/49"

Hiring slip prepared at Nouasseur adds only the color of hair--brown--and eyes--hazel.

Transferred to Fixed Price Work (following conversion of Atlas contract from Cost Plus to one of Fixed Fee.), 31 July, 1953

(New contract, hiring slip, determination of vacation pay accrued (\$38.82), etc., adding nothing to substance of data above)

Supplussed 3 August 1953. Arranged own transportation through Wagons-Lits/Cook, being offered \$85.50 for the purpose. No unaccompanied baggage. Paris, the indicated destination, c/o American Express, 11 rue Scribe.

Document, reconciling return transportation data shows check to him for \$100.00, rather than \$85.50 as above-stated.

Second file also reflects contents of cablegram, forwarded to Atlas by USCE, 24 August 1953, which letter reflects notation that cablegram copy sent by mail to Austrian address "8/25/53".
