



- 12. That he had had an agreement with the Guisness government whereby all shi; ments to the Agricultural Rission would be labeled as "farm implements" or "used clothing," and would not be inspected by local efficials.
- 15. JUNES communicates from Guiana to San Francisco in code by short wave radio.




JONES has retreated to Quians and is apparently selling all property here and urging his people to come to the "Promised Land."
