





MENDELSOHN HAS HAD ANY CONTACT WITH THE PEOPLE'S TEMPLE (PT).

LATER ON DECEMBER 20, 1978, SAID THAT SHE HAD DISCUSSED THE MATTER WITH ANDRUS AND MENDELSOHN AND ANDRUS HAS NEVER, TO HIS KNOWLEDGE, HAD ANY CONTACT WITH THE PT. MENDELSOHN RAN FOR THE CALIFORNIA STATE SENATE IN 1976.

INITIALLY IT WAS HIS UNDERSTANDING THAT THE PT WAS SUPPORTING HIM, BUT HE LATER FOUND OUT THE PT WAS ACTUALLY SUPPORTING HIS OPPOMENT. THE ONLY DIRECT CONTACT HE HAD WITH THE PT WAS IN THE SPRING OF 1976, WHEN HE APPEARED AT THE PT IN SAN FRANCISCO ALONG WITH THE SAN FRANCISCO CHIEF OF POLICE.

MENDELSOHN IS CURRENTLY NOT IN WDC, AND HAS RETURNED TO SAN FRANCISCO FOR THE HOLIDAYS.

IN THE EVENT THE SAN FRANCISCO DIVISION FEELS INTERVIEW OF MENDELSOHN WOULD BE PRODUCTIVE AND THE SAN FRANCISCO DIVISION IS NOT AWARE OF THE SAN FRANCISCO ADDRESS OF MENDELSOHN, WASHINGTON FIELD CAN OBTAIN HIS LOCATION FROM THE DEPARTMENT OF THE INTERIOR.

A letter postmarked November 20, 1978, and directed to Attorney General Griffin Bell was received by the U.S. Department of Justice on November 28, 1978. This letter was written by a prisoner in the Bexar County Jail, San Antonio, Texas, and states as follows:

On October 16, 1978, was contacted at the Bexar County Jail, San Antonio, Texas, where he is currently incarcerated awaiting trial on a charge of murder. was advised of the official identity of the interviewing agent and the receipt of his letter addressed to the Attorney General of the United States was acknowledged.

In this letter, Mr. makes reference to information which he possessed and desired to furnish concerning an unsolved crime which allegedly occurred outside of the State of Texas. When questioned about this, Mr. stated that it concerned the Watergate breakin.

Mr. stated that he had been previously incarcerated in the Bexar County Jail in December, 1971. He stated that while so incarcerated, he was "made to agree" to participate in the breakin of the Democratic National Committee Headquarters located in the Watergate complex in Washington, D.I.

was advised that this information would be made a matter of record and furnished to the appropriate officials of the U.S. Department of Justice for whatever action they deem warranted in this matter.





stated that he had radio contact during the summer of 1978 with the first mentioned Jonestown station, operated by an individual who identified himself as ALBERT TOUCHETTE. confirmed this identity through the American Amateur Radio Call Book, which reflected the call letters as being assigned to one ALBERT TOUCHETTE, believed located in Redwood, California. stated that the three figures following the slash mark in the call letters is an indication that the station is operating portable in Guyana.

stated that he had contact with the station on one or two occasions and communicated for the most part with a female named SARA, whom he understood to be ALBERT TOUCHETTE'S sister. He furnished a copy of a "QSL" card confirming a radio conversation on April 9, 1978. He stated that prior to receiving the card, he received a letter, which is unsigned but believed to be from SARA. He furnished a copy of the letter also. Stated the conversation in April, 1978, concerned basically the same information contained in the letter.



subsequent conversation with both SARA and ALBERT approximately four months after the first one, during which he thanked them for the letter and the card. Stated that his conversations with these individuals were generally innocuous. He also overheard them on occasion during routine transmissions. He advised he can verify exact dates using his call log book if necessary; however, he believes his last contact with either individual was in approximately August, 1978. He is also in a position to furnish the originals of the card and letter if necessary.

stated that he has heard through the public news media that ALBERT TOUCHETTE has been confirmed dead; however, he has heard nothing concerning SARA. He furnished the foregoing information for whatever assistance it might be in the FBI's investigation of the incident | 144




